# Survival and residence tim es in disordered chains with bias

#### Abstract

W e present a uni ed fram ework for nst-passage time and residence tim e of random walks in nite one-dim ensional disordered biased system $s$. The derivation is based on the exact expansion of the backw ard $m$ aster equation in cum ulants. T he dependence on the in itial condition, system size, and bias strength is explicitly studied for models $w$ ith $w$ eak and strong disorders. A pplication to therm ally activated processes is also developed.

## I. IN TRODUCTION

A large num ber of physical properties of di usion and hopping transport of classical particles (or excitations) in disordered $m$ edia have been investigated by $m$ eans of
 particular interest are the e ects of the nite size and boundary conditions on the dom ain ofdi usion. T he absorbing boundary approach allows us to analyze when a process rst reaches a given threshold value [4] [ T his question arises in $m$ any situations and is equivalent to regarding the relation betw een the underlying dynam ics of random ly evolving system $s$ and the statisticsof extrem e events for such system s . T hese statistics are im portant in a variety of problem $s$ in engineering and applied physics [5్1T ${ }_{1}^{1}$. E xtrem ephenom ena are experim entally accessible and enable us to know the param eters of the stochastic dynam ics.

O ne quantity that naturally arises in this context is the tim e for which the particle survives before its absonption in the boundary sinks, i.e., the rst-passage tim e (FPT). $T$ his tim e depends on the realization of the RW, thus being a random variable. The $m$ ean rst-passage time (M FPT) is of fundam ental im portance for di usion inuenced reactions, as it $m$ easures the (reciprocal) reaction rate constant. First-passage problem s appear in a w ide range of applications $\left[\frac{[1]}{4}\right]$ and have a long history [ $\left[\frac{6}{6}\right]$. R ecently, the fact that the M FPT is exactly equal to the inverse of the associated $K$ ram ers escape rate $w$ as proved for arbitrary tim e-hom ogeneous stochastic processes $\bar{\eta}_{1}$ $F$ inite size e ects also appear when we consider unrestricted di usion (no boundary, or boundary condition

[^0]too far away), however we ask for the time spent by the di using particle in nite dom ains. This quantity is the random variable known as residence time (RT). Unlike the FPT, which reckons the lifetim e of particles that never abandoned a given dom ain, the RT involves the case when the particle can exit from and enter into the dom ain an unrestricted num ber of tim es. W e must stress that unfortunately the words residence and survival have som etim es been used as synonym s. W e distinguish these term $s$ from the fact that the particle can retum or not (absorption) to the intervalof interest. T he $m$ ean residence tim e (MRT) has im portance for di usion in uenced catalytic reactions where reactants are localized in a nite dom ain of the catalyzer di usion region. E xperim entaltechniques generally called single-m olecule spectroscopy, allow one to follow the evolution in tim e of the state of a single $m$ olecule that undergoes a confor$m$ ational change (isom erization reaction). This fact has recently been addressed by the M RT study of a single so joum in each of the states of the $m$ olecule [8]1. The im portant feature of this class of reactions is that these can be regarded as being one dim ensional. The MRT has found several other applications [19, [10 generalproblem ofRT distribution in random $m$ edia has been little discussed in the physics literature [1] [1]. O ne of our goals is to present the FPT and RT statistics in random $m$ edia in a uni ed form alism.

The e ect of bias on FPT in disordered system $s$ has received attention since the rst works on the survival fraction of particles in $m$ edia $w$ ith random ly distributed perfect tram ps [12]. W hen the bias is sw itched on (through extemal elds), the system undergoes a substantialchange in its dynam ics how ever sm all the eld is. Several results have been reported on survival probability (or related quantities) for one-dim ensional RW w ith disorder and bias. Them odels ofdisorder often regarded are the random traps and Sinai's $m$ odel. Trapping in one
dim ension is a m odelofstrong disorder that allow s exact
 discrete RW in one dim ension $w$ th asym $m$ etrical transition probabilities that full lla certain condition. In this way, in the Sinai's model the disorder is coupled with the bias strength. T he FPT problem for Sinai's model has been extensively studied [13]. In this work we consider a RW on a chain w ith site disorder in the presence of global (site independent) bias. We analyze weak and strong situations ofdisorder $\left[\left[_{1}^{1}, 1\right][]\right.$. For weak disorder all the inverse $m$ om ents of the distribution of RW hopping rates are nite, whereas all these $m$ om ents diverge if the disorder is strong.

A successful theory for FPT statistics in disordered $m$ edia is the nite e ective $m$ edium approxim ation (FEMA) [1]]. FEMA combines an exact expansion of the survivalprobability equation in a disordered m edium, $w$ ith the e ective medium approxim ation [17 ${ }_{1}^{\prime}$ ]. This schem e allows a perturbative analysis around the e ective hom ogeneous medium in the long time lim it for weak and strong disordered models. FEM A also provides a self-consistent truncation criterion. The extension ofF EM A to biased $m$ edia w as presented in $R$ ef. [1] $\left.\overline{8}_{1}^{1}\right]$, where we got perturbative expansions for sm allbias and weak disorder. In Ref. [19] , another extension ofFEM A w as carried out for periodically forced boundary conditions. In the present paper, we obtain, in the guidelines of the expansions developed in FEM A, the exact equations for M FPT and MRT and construct their solutions in the leading relevant order for sm all bias. M RT for one-dim ensional di usion in a constant eld and biased chains was analyzed in Ref. [1]]. H ow ever, we could not nd explicit expressions for thē RT distribution in disordered $m$ edia in the literature. Therefore, another goal of our work is to consider the m ixed e ects of disorder and bias in the FPT and RT distributions.

This paper presents the survival and residence tim es statistics. In Sec. II we de ne the survival and residence probabilities and construct their expressions from the conditional probability of the random walk on a chain. The random biased $m$ odel is described in Sec. 'ITIT, whereas in Sec. ${ }^{\prime} \overline{\mathrm{I}} \mathrm{V}_{1}$ the hom ogeneous (nondisordered) chain w ith bias is treated analytically. In Sec. 'Vi' we introduce the pro jection operator to average over disorder, obtaining the $m$ ain equations. The weak disordered case is analyzed in Sec. ${ }^{-}+\frac{1}{2}$ and strong disordered cases are considered in Sec. V activated processes are considered and Sec. IX, provides the concluding rem arks. T hem athem aticaldetails of the paper are condensed in two appendixes. In A ppendix 'A: the survival and residence probabilities for hom ogeneous chains are exactly calculated, in A ppendix $\bar{B}$ B' we study the Green's functions in the presence of bias, and in A ppendix 'C' we evaluate the relevant cum ulants used in Sec. II. SURVIVALAND RESIDENCE TIMES STATISTICS

The dynam ical behavior of random one-dim ensional system $s$ can be described by the one-step $m$ aster equation [1] $\left.{ }_{1}^{1}\right]$

where $\left.\mathrm{w}_{\mathrm{n}}^{+( }\right)$is the transition probability per unit time from site $n$ to $n+1\left(\begin{array}{ll}n & 1\end{array}\right) . P\left(n ; t_{j} ; t_{0}\right)$ is the conditional probability of nding the walker at site $n$ at tim et, given that it was at site $n_{0}$ at time $t_{0}(<t)$ and a particular con guration of $\mathrm{fw}_{\mathrm{n}} \mathrm{g}$. W e assum e that $\mathrm{fw}_{\mathrm{n}} \mathrm{g}$ is a set of positive independent identically distributed random variables. In this description, the disorder is m odeled by the distribution, (w), assigned to these random variables. For a given realization of $\mathrm{fw}_{\mathrm{n}} \mathrm{g}$ (quenched disorder) we get a M arkovian stochastic dynam ics. We can write Eq. In this work we consider a RW on a chain and we address the question about the survival and residence probabilities in the nite intervald $=$ [ L ; L ]. The rst is the probability, $S_{n_{0}}\left(t t_{0}\right)$, of rem aining in $D$ (w thout exiting) at tim et if the walker initially began at site $n_{0} 2$ D . The second, instead, is the probability, $R_{n_{0}}\left(t t_{0}\right)$, of nding the particle w ith in the dom ain $D$ at tim e $t$, given that it initially began at site $n_{0}$ (not necessary in D). T herefore, the residence probability is de ned by

To com pute the survival probability, we need to elim inate contributions from tra jectories retuming to the intervald after having left it. To do it wem ust nd the solution $P_{D}\left(n ; \operatorname{tn}_{0} ; t_{0}\right)$ ofEq. $[2.11)$ w ith absorbing boundaries in the interval's extrem es [ [4]. $T$ his de nition and the fact that for the survivalproblem, we only need to consider $n_{0} 2 \mathrm{D}$ allow us to work w ith a nite squarem atrix $H_{D}$ ofdim ension $N \quad N, N=2 L+1$ being the num ber of sites in D.
$T$ he presented view of the survivalproblem is adequate for chains w ith a xed num ber of sites. N evertheless, we are interested in general expressions for dom ains $w$ ith an arbitrary number N of sites and we want to work out survival and residence problem s sim ultaneously. D ue to the tim ehom ogeneous invariance of the problem sw e take $t_{0}=0$ from here and throughout the rest of the work. $W$ e now consider the ${ }_{p}$ vector function $F(t)$ whose com ponents are $\mathrm{F}_{\mathrm{n}_{0}}(\mathrm{t})=\mathrm{n}_{2 \mathrm{D}} \mathrm{P}\left(\mathrm{n} ; \mathrm{t} \mathrm{n}_{0} ; 0\right)$. The survival probability decreases monotonically in time from unity to zero. T he residence probability does not necessarily decrease to zero at in nitely long tim es. M oreover, it need not even be monotonic in time. Thus, the residence tim e density is generally not equal to the negative tim e derivative of

## III. RANDOM BIASED MODEL

In this w ork, we are interested in the interplay betw een the bias and the disorder in the transition probabilities. For this goalwe take

$w$ here $a$ and $b$ are positive constants and $f_{n} g$ are taken to be independent but identically distributed random variables $w$ ith $h_{n} i=0$. This form of jumptransitions involves an ordered biased background $w$ ith a superim posed random $m$ edium. The strength of the bias is given by the ratio betw een $a$ and $b$ and the disorder is characterized by the distribution of variables $f{ }_{n} g$. W ithout lost of generality we assum e a b and in consequence we $m$ ust to im pose the restriction $n \quad b$. This restriction guarantees the positivity of jum p probabilities $\mathrm{fw}_{\mathrm{n}} \mathrm{g}$. W e introduce the param eter forbias strength by $b=a=1$ and we take $0 \quad 1$, so that the bias eld points to the right. This election of param eters allow s us to focus our attention in the sm all bias lim it and to study the transition to the sym $m$ etric di usive behavior [2] The Laplace transform of the evolution equation for our m odel results from Eq. (2.

Though, the MFPT in the presence of strong disorder is a divergent quantity [1] $\left.{ }^{-1}\right]$. We will show in Sec. $\overline{\mathrm{V}} \mathrm{II}$ that our m odel allows us to study the transition to strong disorder in the lim it going to zero, i.e., the zero bias lim it.

## IV . NOND ISORDERED BIASED CHA IN

In the presence ofbias, the escape tim e from the nite interval increases for all initial conditions $n$, $w$ ith respect to the unbiased case, if the uctuation is large enough. This is an im portant result related to the control of the trapping process. T his fact w as reported in Ref. $\left.[1] \frac{1}{2}\right]$ where the solution of E q. The behavior of the survival probability obtained from $F E M A$ is $h \hat{S}_{n}(s) i / j \ln s j$ for a disorder of class ( $\left(\frac{1}{1}\right)$, and $h \hat{S}_{n}(\mathrm{~s}) \mathrm{i} / \mathrm{s}$, for a disorder of class ( $(\mathbf{G})$. A coordingly, both problem s have the sam e exponents despite their di erent nature.

In the residence problem, for both classes of strong disorderwe get that $\mathrm{h}_{\mathrm{n}} \mathrm{i}_{\mathrm{T}}^{\mathrm{R}} \quad 1^{1}$, and then the equation for the averaged M RT results $R_{n}(0)=1_{1}^{1} K^{0} h_{n}$ i, i.e., an unbiased equation. Therefore, the averaged M RT is not a de ned quantity for strong disorder.

## V III. THERMALLY ACTIVATED PROCESSES

Before concluding this work, we want to analyze the physicalrealization corresponding to therm ally activated processes in weakly disordered chains. ## IX . CONCLUSION S

W e have presented a uni ed fram ew ork for the FPT and RT statistics in nite disordered chains with bias. E xact equations for the quantities averaged over disorder were obtained forboth problem s and its solutions up to rst order in the bias param eter were constructed retaining the full dependence on the system 's size and the initial condition.

W e have studied the FPT and RT problem s for three m odels of disorder. For weak disorder, the inverse mom ents of the transition probabilities are nite, and we get that the bias becom es a controlparam eter for the M FPT, coupled w th the uctuation of the disorder. TheM RT is only de ned in the presence ofbias, and forw eak disorder the MRT's expressions are obtained from the nondisordered case renorm alizing the transition constants. For strong disordered cases, for which the M FPT is not dened in unbiased chains, the bias allow s us to study the divergent behavior. Am azingly, the exponents of the divergences in M FPT obtained for vanishing bias coincide $w$ ith that obtained for the averaged survival probability in the long tim e regim e. The MRT is a divergent quantity under strong disorder because the strength param eter is not present in the corresponding equation in the sm allbias lim 辻, and the M RT is not de ned for unbiased walks.

W e com plete the work w ith three appendixes. In A ppendix 'A', the derivation of survival and residence probabilities for nondisordered chains is com pletely developed. A pppendix $\bar{B}$ is is devoted to the detailed calculation of $G$ reen's function in a chain w ith bias. Exact expressions are given, which display the full dependence on the system 's size, initial condition, and bias strength. The evaluation of the relevant Terw iel's cum ulants is reported in A ppendix ${ }^{C}$
