The magnon energy and amplitude renormalization due to intraband particle-hole excitations are studied in a metallic antiferrom agnet. The change in sign of the intraband contribution with ! results in signi cant di erences between static and dynamical behaviours. For electron doping, while the coherent m agnon peak looses spectral weight and is shifted to higher energy with doping, the low energy incoherent part becom es increasingly prom inent as it narrows in width and shifts to lower energy. Im plications for spin dynam ics in the electron doped cuprate $N d_2 \times C e_x C u O_4$ are discussed. Due to an exact cancellation of two logarithm ically divergent spinuctuation processes, the AF order parameter is una ected to leading order. For hole doping, short wavelength trans- $\overline{\mathbf{x}}$) are found to be stable, verse perturbations (q > q)in plying short-range AF order with a spin correlation length =a $1 \times c$

I. IN TRODUCTION

A ntiferrom agnetism in the doped cuprates strongly depends on the type of doping. W hile the electron doped cuprate N d₂ $_{x}Ce_{x}CuO_{4}$ retains AF order up to a doping concentration of about 15%, [1{3] only 2% hole concentration destroys AF order in La₂ $_{x}Sr_{x}CuO_{4}$.

The simplest m icroscopic description of this strong doping asymmetry emerges within the t t⁰ Hubbard model, with nearest-neighbour (NN) and next-nearestneighbour (NNN) hopping terms t and t⁰, respectively. For negative t⁰ (as usually assumed for cuprates) and electron doping, the AF state is stable for a range of doping concentration, whereas the AF state become es unstable with respect to transverse perturbations in the AF order for any nite hole doping. [4,5] Recently the m agnetic phase diagram of the doped t t⁰ Hubbard model has been obtained in the t⁰ U space, showing the various regions of stability and instability with respect to both longitudinal and transverse perturbations in the AF order. [5]

The appropriate Hubbard model parameters for La_2CuO_4 , determined recently by thing the spin-wave dispersion obtained from high resolution inelastic neutron scattering studies, [6[8] indicate that U = t 8. From the additional fact that the critical electron doping concentration in Nd₂ $_xCe_xCuO_4$ is around 20%, the t⁰ U phase diagram then yields t⁰=t 0.25. [5] This value of t⁰ falls in the range 0.15 to 0.5 estimated from band structure studies, photoem ission data and neutron-scattering m easurements of high-T_c and related m aterials. [9[12]

A stable AF state of the doped t t⁰ Hubbard model provides a microscopic realization of a metallic antiferrom agnet, in which the Ferm i energy lies within a quasiparticle band. In this paper we will quantitatively study the interplay of spin uctuations and particle-hole excitations in the metallic AF, focussing on the role of the intraband particle-hole excitations on the spin excitation spectrum, magnon renorm alization, and spin- uctuation correction to the AF order parameter. These results should be particularly relevant to the electron doped cuprate Nd₂ $_{x}Ce_{x}CuO_{4}$, in which metallic conductivity resulting from electron doping suggests that the electrons are mobile, [13] and doping with Ce clearly reduces the spinsti ness constant from the value in the undoped system. [3] M etallic antiferrom agnetism has also been reported in

(BEDT TTF)₂X, [14] $V_2 \times O_3$, [15] and N iS₂ ×Se_x. [16]

The metallic antiferrom agnet is characterized by m agnon decay into intraband particle-hole excitations, and the resulting magnon damping () was studied recently in the long wavelength $\lim_{p \to \infty} it (q << 1)$. [5] In terms of the Fermi circle radius a = $\frac{1}{2} \times of the doping pockets$ form ed around (;0) and (0;), where x is the doping concentration, a new doping-dependent energy scale 4tºa was identied, the relative magnitude of which, in comparison with the magnon energy scale [2J, should] essentially determ ine the spin excitation spectrum. The im aginary part of $^{0}(q;!)$ was found to vanish for ! > $4t^{0}aq$, and increase linearly with ! for $! << 4t^{0}aq$. This im plies that the magnon spectrum should exhibit a sharp 2Jq for $2J > 4t^{0}a$ (low doping lim it), peak at ! and magnon broadening should appear with increasing doping when $2J < 4t^0a$.

In addition to the spin excitation spectrum for all q (section III), we will also study the quantum correction to sublattice magnetization (section IV), to determ ine whether long-range AF order survives in the metallic antiferrom agnet when quantum spin uctuations are included. At the one-loop level, the spin- ip process is accompanied by virtual magnon emission and absorption, and therefore we will also exam ine whether the magnon propagator (whose amplitude goes like 1=q in the AF insulator) is signi cantly renorm alized due to the intraband particle-hole excitations (section II). The consequences of magnon renorm alization on nite temperature spin dynamics and N celtem perature in electron doped cuprates are brie y discussed in section V.

We consider the t t^0 Hubbard model on a square lattice, with NN and NNN hopping terms t and t^0 connecting sites ito i+ and i+, respectively:

In the following we set t = 1. Since a particle-hole transform ation m aps the t⁰ m odel with hole (electron) doping on the t⁰ m odel with electron (hole) doping, the positive (negative) t⁰ m odel and hole (electron) doping is appropriate to study for the electron-doped compound N d₂ $_{\rm x}$ C e_xC uO ₄, for which a negative t⁰ is usually assumed.

II. M AGNON RENORMALIZATION

In this section we consider positive t^0 and hole doping, so that the results are appropriate for the electron-doped cuprates. We also consider the strong coupling lim it for analytical simplicity. To study transverse spin uctuations in the doped antiferrom agnetic state we evaluate the tim e-ordered m agnon propagator

involving the spin-lowering and spin-raising operators S_i and S_j^+ at lattice sites i and j. In the random phase approximation (RPA), we have

where $^{0}(q;!)$ is the zeroth-order, antiparallel-spin particle-hole propagator, evaluated in the brokensym m etry, H artree Fock (HF) state of the m etallic antiferrom agnet, and involves both interband and intraband excitations. We exam ine the q;! dependence of $^{0}(q;!)$, which essentially determ ines the m agnon energy and am – plitude renorm alization. We focus on the real part of [$^{0}(q;!)$] in the underdoped lim it, as its im aginary part was shown to vanish for ! > 4t⁰aq in the long wavelength lim it. [5]

The HF-level description of the metallic AF state has been discussed earlier. [5] The NNN hopping term modi es only the AF-state quasiparticle energies E_k , but not the quasiparticle amplitudes. We have $E_k = \frac{0}{k} \frac{P}{2 + \frac{2}{k}}$, for the upper and lower Hubbard bands, where $_k = 2t(\cos k_x + \cos k_y)$ and $_k^0 = 4t^0 \cos k_x \cos k_y$ are the free-ferm ion energies corresponding to the NN and NNN hopping terms. Here 2 = mU in terms of the sublattice magnetization m.

In the two-sublattice basis (labelled by A and B), the intraband contributions to the diagonal and o -diagonal m atrix elements of [0 (q;!)] are obtained as:

where P_{k}^{0} indicates that states k are below the Ferm i energy E_{F} , while states k q are above E_{F} , and q E_{k}^{0} q E_{k} is the intraband particle-hole energy di erence in the lower H ubbard band.

The above three intraband contributions can be written, in units of $(t^2 = 3)$, as $(a_q \ b_q ! = 2J)$, $(a_q + b_q ! = 2J)$, and c_q , respectively. The dimensionless coe cients $a_q; b_q; c_q$ are all functions of $!^2$ and, for $! \notin 0$, vanish quadratically with q as q ! 0 due to phase space restriction. [5] How ever, for ! / q (near the m agnon-m ode energy), they all have well de ned lim its as q ! 0.

Including the interband contributions as well, which were studied earlier for nite doping up to order x^2 , [5] [⁰(q;!)] can be written as

The term a_q^0 represents modi cations in the interband contribution due to NNN exchange energy $J^0 = 4t^{02}=U$ and nite doping, and to rst order in x, is given by

where $_{q} = (\cos q_{x} + \cos q_{y})=2$ and $_{q}^{0} = \cos q_{x} \cos q_{y})$. The scaled frequency $\frac{1}{2} = m^{2} (1+b_{q}) (!=2J)$ $f_{q} (!=2J)$, where m = 1 x, re ects the frequency-scale renorm alization due to doping and intraband excitations.

Substituting ${}^{0}(q;!)$ from Eq. (5) in Eq. (3), the RPA-level m agnon propagator is obtained as

is frequency dependent due to the intraband contribution, resulting in the m agnon amplitude renorm alization. The m agnon-m ode energies form on entum q are given by the poles at $!_q = q(!_q)$.

For $J < 8t^0$, as in the strong coupling limit, the magnon renorm alization due to b_q is negligible, and in the following we take the frequency-scale renorm alization factor $f_q = m^2 (1 + b_q)$ 1, for simplicity.

In the long-wavelength and low-doping limits (q << 1;x << 1) we have $_{q}$ 1 $q^{2}=4$, $_{q}^{0}$ 1 $q^{2}=2$, and $a_{q};b_{q};c_{q} << 1$. Substituting for a_{q}^{0} from Eq. (6) in Eq. (8), the expression for $_{q}$ (!) simplifies to

were introduced earlier as coe cients of the q² term in the interband and intraband contributions to the transverse response eigenvalue in the context of the stability analysis of the doped AF state of the t t⁰ Hubbard model. [5] From Eq. (4) which de nes a_q , b_q , and c_q , and substituting for $_{k \ q} _{k}$ 2tqa cos , and the intraband particle-hole energy di erence $E_{k \ q} = E_{k \ q}$ 4t⁰qa cos in the lim its t⁰ > Jx and q << 1, we obtain

As $_{intra}(!)$ is a function of !=q, it follows from Eq. (9) that the m agnon-m ode energy $!_q$ is proportional to q, as in the AF insulator.




FIG.1. The intraband coe cient $_{intra}(!)$ changes sign at ! = $4t^0qa$, implying that the magnon-mode softening for $!_q < 4t^0qa$ changes into magnon-mode stiening for $!_q > 4t^0qa$.

The change in sign of the intraband coe cient $_{intra}$ (!) at !=4t⁰qa = 1 (see Fig. 1) has interesting consequences on the doping dependence of the magnon-mode energy. In the static limit, $intra (0) = x=2t^0$ is positive, and the intraband contribution softens the magnon mode, eventually leading to the instability of the AF state when $_{intra} = _{inter}$. [5] H ow ever, for $! > 4t^0 qa$, the intraband coe cient intra is negative, in plying that the intraband excitation actually sti ensthe magnon-mode. Therefore, for $\sqrt[1]{2J} > 4t^0a = 4t^0 + 2 \times (underdoped)$ 2Jq is shifted $\lim it$), the coherentm agnon peak at ! q to higher energy, this shift being proportional to $x_p^2 in$ the smalldoping lim it.W ith increasing doping, when 2J < 4t⁰a, the m agnon peak is broadened due to dam ping and gets shifted to lower energy due to the change in sign of intra (!). As the magnon damping term goes as ! for ! << 4t⁰qa, [5] the magnon peak signi cantly narrows down as it shifts to low er energies with doping.

D oping sti ens the magnon mode through the interband contribution as well, by suppressing the softening due to the J^0 -induced frustration. This is clearly seen from the expression for the interband coe cient inter in Eq. (10), which increases with x.

Turning now to the magnon amplitude renormalization, by expanding the frequency-dependent energy $_{q}$ (!) near the mode energy $!_{q}$, we obtain

which is negative, and vanishes with the doping concentration as x^2 , through the x dependence of the integral. These consequences of doping, namely the stiening of the m agnon m ode and reduction in the coherent spectral weight for low doping, changing into m agnon softening and broadening with increasing doping, are con rm ed in a num erical study of the m agnon spectral function, as discussed below.

III. SPIN FLUCTUATION SPECTRUM

The spectrum of transverse spin uctuations in the doped AF state, evaluated numerically from the imaginary part of the magnon propagator +(q;!), is discussed in this section. In term softhe two complex eigenvalues n(q;!) of the 0(q;!) matrix, we obtain for the spin uctuation spectral function $A_q(!)$






FIG. 2. The magnon spectral function A_q (!) = Tr Im ⁺ (q;!) for a long wavelength mode q = (02;0), showing the shift of the coherent magnon peak to higher energy with doping, accompanied by a reduction of the magnon amplitude. With increasing doping the broad incoherent spectrum acquires strength and narrows into a peak which shifts down in energy.

In the numerical evaluation of the 0 (q;!) matrix, we have taken a grid size $dk_{\rm x}$ = $dk_{\rm y}$ = 0.01 and an in aginary term = 0.001 throughout. The spectral function $A_{\rm q}$ (!) has been recently studied for the AF insulator in the full U range from weak coupling to strong coupling, including contributions from both single-particle and collective (magnon) excitations. [17] In the following, we discuss the results in the context of cuprates, separately considering electron doping (positive t^{0} and hole doping) and hole doping (negative t^{0} and hole doping).




FIG.4. For a xed doping concentration, the magnon spectral function for di erent q shows a linear dependence of the coherent magnon peak energy $!_q$ on q.W ith decreasing q the incoherent part is compressed into a narrow peak, which competes in strength with the coherent peak.

A.Electron doping

The results for A_q (!) are shown in Figs. 2-5, which con m the characteristic features obtained in the m agnon renom alization study of section II in the sm all q lim it. W ith doping, the coherent m agnon peak shifts to higher energy with decreasing amplitude (see Fig. 1). Simultaneously, the incoherent part of the m agnon spectral function at low frequency progressively becomes narrower, shifts to lower energy and develops oscillator strength. The softening is due to the intraband contribution and the narrowing follows from the behaviour of Im ⁰ (q;!), which decreases with !.

On the other hand, for short wavelength modes, the magnon peak is seen to broaden almost immediately with doping (see Fig. 3), with no change in the peak energy. A study of the imaginary part of $^{0}(q;!)$ shows that the energy range overwhich Im $^{0}(q;!)$ is nite initially increases as $4t^{0}aq$, but then increases more rapidly with q, eventually overtaking the magnon energy. Therefore for short wavelength modes, the magnon energy falls within this range, resulting in the broadening.

The m agnon softening is seen to be m oderately q dependent. W hile the m agnon peak shifts to nearly ! 0 at x 10% for sm all q, a substantial energy gap still remains for q 1 (see Fig. 3). This interestingly shows that the instability of the AF state with respect to transverse uctuations in the order parameter strongly depends on the uctuation wavelength. W hile the AF state becomes unstable with respect to long wavelength m odes at $x = x_c$, the short wavelength m odes are still positive energy m odes, so that short-range AF order should survive.




FIG.5. The incoherent part of the magnon spectral function decreases progressively with increasing wavevector $q = (q_x; 0)$, for a xed doping concentration of x = 7%. Magnon damping and linewidth sharply decrease as q_x approaches 2:0, and for q_x 2 only the coherent magnon peak remains at low energy, with an insigni cant incoherent part at higher energy (not shown).

For a xed doping concentration, the coherent m agnon peak energy is proportional to the wavevector q in the small q lim it (see Fig. 4). For short wavelength m odes, the incoherent part decreases dram atically with increasing wavevector (see Fig. 5). M agnon damping and linewidth sharply decrease as q approaches 2:0, and for q 2 only the coherent m agnon peak remains at low energy, with an insigni cant incoherent part at higher energy.

As the doping approaches the critical concentration x_c , above which the AF state is unstable, the appearance of narrow m agnon m odes at very low energy despite their strong renorm alization due to the intraband particle-hole excitations, is a noteworthy feature of the m etallic AF state.

B.Hole doping

The strong intraband contribution renders the hom ogeneous AF state unstable for any am ount of hole doping. [4,5] This instability with respect to transverse perturbations in the AF order is signalled by the transverse response eigenvalue U $_{\rm q}$ exceeding unity for long wavelength (sm all q) m odes, indicating absence of longrange AF order, and signalling a tendency towards incommensurate ordering with wavevector di erent from Q = (;). Di erent types of hom ogeneous spiral phases, and their stability with respect to longitudinal and transverse perturbations have been studied in detail. [4]




FIG.6. The q dependence of U $_{\rm q}$ in the range 0 $\,$ q for the two eigenvalues $_{\rm q}$ of the 0 (q) m atrix for hole concentration of 5% .

However, short-range AF order appears stable, as indicated by the full q dependence of U $_q$ (see Fig. 6) for the two eigenvalues $_q$ of the 0 (q) matrix for q = (q;q) in the range $0 < q < \cdot$. The rejection symmetry about




FIG.7. The q dependence of U $_q$ for di erent hole doping concentrations x, show ing that U $_q$ drops below 1 above som e value q = q . Note that the small-q parabolic behaviour of U $_q$ is independent of doping concentration.

q = =2 is due to the location of the hole pockets around (=2; =2) in the Brillouin zone. Considering the larger eigenvalue for small q, the parabolic behaviour of U q is independent of doping concentration (see Fig. 7), as obtained earlier. [5] How ever, beyond a certain q value U q starts decreasing and eventually drops below unity at q = q. This signals the stability of the AF state with respect to transverse perturbations of wavelength shorter than = 2 =q, im plying that short-range AF order can exist in the hole doped AF upto length scale . For x 15%, the transverse response eigenvalue

 $U_q > 1$ for all q, indicating no stability for AF dom ains of any size.





FIG.8. Plot of $(q)^2$ vs. x shows a linear dependence, implying a x $^{1=2}$ dependence of the spin correlation length on hole doping concentration x.

The q dependence of U $_q$ for di erent hole doping concentrations (Fig. 7) shows that the wavevector value q where U $_q$ drops below unity increases with doping concentration x, indicating diminishing spin correlation length. The behaviour of the spin correlation length =a = $2_p = q$ with x is shown in Fig. 8, clearly showing a 1= x dependence, as seen in neutron scattering

Figure 9 shows that in aginary part Im [0 (q;!)]_{AA} on the A sublattice has a remarkably linear behaviour over a large! range. A similar behaviour for q not too small is also observed in the electron-doped case. This lowfrequency contribution in Im 0 (q;!), arising from the intraband excitations in the antiparallel-spin particle-hole propagator 0 (q;!), is suppressed to order $t^2=U^2$ due to the AF coherence factors. How ever, no such suppression is present in the parallel-spin particle-hole propagators [0 (q;!)]_{AA} or [0 (q;!)]_{BB}, where both particle and hole am plitudes (in the low er band) are of order unity. Such parallel-spin particle-hole propagators are involved in the charge density uctuations.

A lthough the AF state is unstable at the static level, the spectral function shows sharp peaks at nite frequency (see g. 10). This is due to the change in sign of the intraband coe cient $_{intra}(!)$ with increasing !, discernible from the change in curvature of the spectral function. As for the electron-doped case, the sm all-qm agnon peaks are sharp because Im $^{0}(q;!)$ vanishes at the m agnon-m ode energy, whereas at higher q the m agnon-m ode energy lies within the energy scale over which Im 0 (q;!) is nite




FIG.10. The spectral function shows sharp m agnon peaks for low q, and broadened peaks at higher q due to m agnon damping.




FIG.11. For uctuation m odes of wavelength sm aller than the domain size, (q > q = 0.9 for x = 0.05), the m agnon m odes are strongly softened, with a sm all incoherent part appearing at higher energy.

(see Fig. 9), resulting in m agnon broadening.

Figure 11 shows that there is an abrupt change in the spectral function when q crosses q 0.9 for x = 0.05 (see Figure 7). For uctuation modes of wavelength smaller than the AF domain size (q > q), the magnon modes are strongly softened by the intraband contribution, with a small incoherent part appearing at higher energy. In contrast, in the electron-doped case, the coherent part was shifted to higher energy and a weak incoherent part appeared at low energy. B oth m agnon dam ping and softening have been observed in the hole-doped cuprate La₂ $_xBa_xCuO_4$. [19]

At nite temperature T << J, the decrease in sublattice magnetization m (T) due to thermal excitation of long wavelength magnons has been studied in a highly anisotropic layered antiferrom agnet with planar exchange




FIG. 12. The long-wavelength magnon energy scale $l_q^{\text{peak}} = q$ falls linearly with the doping concentration x, in plying a corresponding decrease in the spin-wave sti ness constant and the N eel tem perature.

interaction energy J = 4t²=U, an e ective interlayer hopping t_z, [20] and an e ective anisotropy gap $_{DM}$ due to the D zyaloshinski-M origa interaction. [21] An estimate of the N eeltem perature T_N was obtained from the predominant T ln T fallo ofm (T) with T as $k_B T_N$ J= ln (l=r) for $_{DM}$ << 2Jr, and $k_B T_N$ J= ln (J= $_{DM}$) for 2Jr << $_{DM}$, where r = t_z=t is the interlayer-to-planar hopping ratio. In both cases, T_N is proportional to the long wavelength m agnon energy scale (! $_q=q)_{q!0}$ J.

Figure 2 shows that the relevant m agnon energy scale which will essentially determ ine the low tem perature spin dynam ics in the doped AF is the incoherent m agnon peak energy, which shifts to lower energy and gains spectral weight with increasing doping. The doping dependence of this m agnon energy scale $!_q^{peak} = q$ shows a nearly linear decrease with doping concentration (see Fig. 12).

This nearly linear decrease in the incoherent m agnon peak energy with doping concentration provides an explanation for the observed decrease in unison of the spin-wave sti ness constant $_{\rm s}$ and the N eel tem perature $T_{\rm N}$ with Ce doping in both Nd_{2 x}Ce_xCuO₄ and Pr_{2 x}Ce_xCuO₄. [3] A spin dilution m odel, within which a Cu²⁺ S=1/2 ion is assumed to be converted into a b-calized Cu¹⁺ S=0 ion for each added Ce ion, has been found to quantitatively describe the x-dependence of $_{\rm s}$ and $T_{\rm N}$. [2] However, the localization of the added electrons in this scenario contradicts the m etallic conductivity resulting from Ce doping.

V.SPIN-FLUCTUATION CORRECTION TO SUBLATTICE MAGNETIZATION




FIG.13. The quantum spin-uctuation correction to the electron propagator, representing a spin ip accompanied by the emission and absorption of a virtualm agnon.

Figure 13 shows the rst-order spin- uctuation correction to the electron propagator. Physically, the process 1 (2) represents a spin-" electron in state k below (above) the Ferm i energy em itting a virtual magnon with momentum Q and ipping into a spin-# electron in state

k Q above (below) the Ferm i energy, which then reabsorbs the virtual m agnon. Such spin- ip processes involve transfer of spectral weight across the Ferm i energy, and therefore result in corrections to electron densities n_{\ast} and $n_{\#}$, and hence to the sublattice m agnetization.

Considering rst the process (1) involving $E_k < E_F$ and $E_{k \ Q} > E_F$, the integrated spectral weight transferred above the Ferm i energy yields the reduction in the spin-" density on an A-sublattice site

involving the retarded part of the magnon propagator $_{R}^{+}$ (Q;). Here $a_{k}^{2}_{Q;\#}$ is the spin-# electron density on the A sublattice site, and in the strong coupling limit, is given by 1 and $_{k}^{2}_{Q}$ =4 2 for state k Q in the upper and lower band, respectively.

For the undoped antiferrom agnet, where the spin- ip process involves an interband excitation, and states k and k Q are energetically separated by the AF gap 2, this correction reduces the A-sublattice density n_* from 1 to 0.8 for the square lattice. [22] A similar process transfers spin-# spectral weight from the upper (unoccupied) band to the lower band, increasing $n_{\#}$ from 0 to 0.2, resulting in a net reduction of 0.4 in the sublattice magnetization.

In the m etallic antiferrom agnet, how ever, spin- ip processes involve the intraband excitations as well, and the small energy denom inator $E_{k_Q} = E_k = 4t^0Qa$ in the Q << 1 lim it drastically increases the spin- uctuation contribution to the particle density correction. On the other hand, the phase-space restriction on states k and k Q to lie across the Ferm i energy suppresses the intraband contribution in the long-wavelength lim it by a

factor Q. In the following, we examine the combined effect of these two features of intraband excitations on the quantum correction to sublattice magnetization.

As discussed earlier, except for a renorm alized m agnon velocity c and am plitude Z, the coherent part of the m agnon propagator for Q << 1 is qualitatively unchanged in the weak doping limit ($\overline{2}J > 4t^0a$), with Im $_{\rm R}^{+}$ (Q;!) (Z=Q) (! cQ) as for the AF insulator. Substituting in Eq. (17), we obtain

A fler doing the integral, the resulting Q integral in Eq. (18) is of the form dQ = Q, which yields a logarithmically divergent reduction in the A-sublattice density n_{*} from process (1). Similarly, the process (2) involving $E_{k} > E_{F}$ and $E_{k q} < E_{F}$, and the advanced part of the magnon propagator $A^{+}(Q;)$, transfers spectral weight below the Ferm i energy, yielding an identical logarithmically divergent enhancement to n_{*} . Remarkably, it is this exact cancellation of two logarithmically divergent contributions which is responsible for the survival of long-range AF order in the weakly (electron) doped cuprate.

VI.CONCLUSIONS

The study of spin uctuations in the t t^0 Hubbard model shows that when doped electrons (holes) are added to the bottom (top) of the upper (lower) Hubbard band, the consequent intraband particle-hole excitations strongly renorm alize the magnon propagator in the metallic AF state. The change in sign of the intraband coe cient intra (!) with ! is a key result, leading to di erences between static and dynam ical behaviours. Several features of the magnetic properties of the electron and hole doped cuprates are understandable within this m icroscopic m odel. These include: i) nite (nearly zero) critical doping concentration xc above which long-range AF order is destroyed in electron (hole) doped cuprates, ii) a linear decrease in the spin-wave sti ness constant and Neel tem perature with doping concentration, iii) m agnon broadening and softening in hole doped cuprates, iv) enhanced correlations at the dynam ical level.

However, important features of the hole-doped cuprates require further investigation. While the t t^0 Hubbard model (with negative t^0) indicates instability of the AF state and tendency towards incommensurate ordering for any nite hole doping, spin uctuations in the hole-doped cuprates are commensurate for low doping and a commensurate-incommensurate transition occurs at x 0:05. The exact mechanism responsible for the

loss of long-range AF order for x < 0.05 therefore remains unclear. Interestingly, it is in this doping regime that a magnon damping term T in La₂ $_{x}Sr_{x}CuO_{4}$ and La₂ $_{x}Ba_{x}CuO_{4}$ has been observed at nite temperature, [23,24] which accounts for the anom alous nuclear spin relaxation rate, resistivity etc.
