A ntiferrom agnetic H eisenberg m odel on an isotropic triangular lattice in the presence of m agnetic eld


W e use Schwinger boson m ean eld theory to study the antiferrom agnetic spin-1/2 H eisenberg m odel on an anisotropic triangular lattice in the presence of a uniform external magnetic eld. W e calculate the eld dependence of the spin incom mensurability in the ordered spin spiral phase, and com pare the results to the recent experiments in C s₂C uC l₄ by C oldea et al. (Phys. Rev. Lett. 86, 1335 (2001)).

The ground states of two-dimensional (2D) Heisenberg models continue to be of great interest.^{1,2} In this paper, we study the antiferrom agnetic (AF) Heisenberg model on an anisotropic triangular-lattice in the presence of an external magnetic eld along the z-axis,

In the above equation, the sum mation runs over all the lattice sites i and their neighboring sites (i+). We consider AF nearest neighbor spin-spin couplings, represented by J and J^0 as shown in Fig. 1, with both J and J⁰ 0. In the absence of the eld, this model is equivalent to a class of models recently considered by a number of authors.^{3,4,5,6} The model includes several well known lim iting cases. At J = 0, it is equivalent to 2D square lattice model, whose ground state is a twosublattice Neel phase. At $J^0 = 0$, it becomes a set of decoupled spin chains. At $J^0 = J$, it is reduced to the isotropic triangular-lattice model, where the ground state is a three-sublattice antiferrom agnet. Experim entally, thism odelm ay be relevant to the insulating phase of the layered molecular crystals, $-(BEDT-TTF)_2X$, and (BEDT-TTF)₂ RbZn (SCN)₄⁸ Our interest on thism odel is largely m otivated by recent experim ents on C s2 C uC 14. That system is a quasi 2D S = 1/2 frustrated H eisenberg antiferrom agnet.⁹ Coldea et al.¹⁰ have used the neutron scattering to study the ground state and the dynam ics of the system in high magnetic elds. A mong the observations, these authors found that the incommensurate wave vector changes as the magnetic eld increases, and the spiral spin density wave evolves into a fully saturated state.

In this paper we apply the Schwinger boson mean eld theory (MFT) to study the e ect of magnetic eld in the frustrated Heisenberg models. This method enables us to study incommensurate magnetic ordering in the quantum spin systems. The magnetic ordering is identied as the Bose condensation of the Schwinger bosons, and the incommensuration of the ordering is determined by the wave vector of the condensed Schwinger bosons. In the absence of the magnetic eld, the MFT pre-

dicts three possible ground state: a two-sublattice Neel phase, a spiral spin state, and a spin liquid phase, sim ilar to the results obtained in the high tem perature series expansions.³ In the presence of the eld, we calculate the eld dependence of the incom mensuration in the spiral phase, and com pare the results with the experim ental observation in C s₂C uC l₄ with good qualitative agreem ents.

In terms of Schwinger bosons $a_{\rm i1}$ and $a_{\rm i2}$, the spin operators are expressed as

with a local constraint at every site i given by $a_{i1}^{\gamma}a_{i1} + a_{i2}^{\gamma}a_{i2} = 1$: As a standard method, we introduce a Lagrangian multiplier eld $_{i}$ to describe the constraint. The Ham iltonian of the system then becomes

where h = B; ; = 1;2, j = i + , and A_{ij} ; = $a_i a_j a_i a_j$ is the spin singlet operator of bond (ij).

W e note that operator A_{ij}, is antisym m etric with respect to either the position (ij) or the indices (): On a bipartite lattice, a spin rotation by on one of the sublattices transform s the spin-singlet bond operators into a symmetric operator with respect to the bond indices (ij). A mean eld theory based on that transform ation has been developed by Auerbach and Arovas.¹¹ The m ethod was extended to study the frustrated lattices by many authors.¹² (For an overview of Schwinger boson theory, see Ref. The mean eld Ham iltonian may be solved using the conventional bosonic Bogliubov transform ation as well as the G reen function's method.

The mean eld Ham iltonian in Eq. (3) is diagonalized as

The mean eld Ham iltonian is solved together with the self-consistent equations for the two types of m ean elds, which are given by

In the MFT, the magnetic ordering may be identied as the Schwinger boson condensation.¹³ Below we examine the possible Schwinger boson condensation at the wave vector k = k; corresponding to the lowest energy of ↓ (k) ! 0. W e introduce a non-negative quantity,

i represents the therm odynam ic The general features of the mean eld solutions in 2D lattices are qualitatively given as below. At any nite $T, b_0 = 0. At T = 0, ifm in [! (k)] \in 0 and b_0 = 0, the$ ground state is a spin liquid, whose gap depends on the m in in alvalue of the spectra !(k). If m in [!(k)] = 0 and b₀ is nite, the Schwinger bosons are condensed to the lowest energy state, and the system possesses the magnetic long-range order. The ordering wave vector Q is determined by !(k) = 0. From the spin-spin correlations,

for h = 0; which indicates the mean eld theory does not break SU (2) sym m etry. In the therm odynam ic lim it, (N ! +1), the correlation functions are convergent except for Q = 2k;

which indicates that there exists long-range correlations with Q = 2k whence $b_0 \in 0$:

On the triangular-lattice (see Fig. 1), each site has six neighbors: a_1 ; a_2 ; $(a_1 + a_2)$. It is convenient to write the wave vector $\mathbf{k} = (k_1; k_2)$, with k_1 and k_2 the components of the vector along the directions of a₁ and a_2 ; respectively. The lattice constant a is set to be 1.

We now consider the mean eld solutions at T = 0. Let me rst discuss the solutions in the absence of the eld. At $J^0=J = 1$ (the isotropic triangular lattice), $k_0 = -3$ and $!(k) = 0, b_0$ is nite indicating a magnetic long range order with the ordering wave vector Q (2 = 3; 2 = 3). At J = 0 (the square lattice), $k_0 = -2$ and ! (k) = 0, and $b_0 > 0$ implying a Neel ordering at Q (;). The MFT in these two limiting cases is consistent with the known results. At $J^0 = 0$ (decoupled one-dimensional chains), the MFT gives $k_0 = =4$, (2k along the chains),




FIG.2: The critical eld in unit J versus the ratio $J^0=J$:

! (k) > 0, and $b_0 = 0$, suggesting a spin gap state. The 1D model is exactly soluable, and the ground state is a gapless spin liquid¹⁴, although the static sin-spin corre— between the MFT and the exact solutions is primarily due to the neglect of the topological term in the MFT. For the general values of $J^0=J$, the M FT predicts three phases at h = 0: (1). a spin liquid phase at $J^0=J < 0$:136; (2). a spin spiral state at 0:136 < $J^0=J < 1:70$; with the ordering wave vector bew teen (=2; =2) and (;);(3). an antiferrom agnet with the ordering wave vector Q = (;) at $J^0=J > 1:70$. We note that the phase diagram of the model was studied previously by using a series expansion technique, linear spin density wave and SP (N) mean eld theory etc. 3,5,6,12 In the method of series expansion, they found a Neel state persisting down to $J^0=J > 1:43$, and predicts a spiral phase at sm all ratio of $J^0=J$. These are consistent with our MFT. These authors also found a dim er phase between the Neel and spiral states. The dim er phase breaks translational invariance and is not included in the present MFT.

We now consider the solutions at $h \in 0$. In this case, the SU(2) rotational symmetry is broken, and ! (k) < $!_+$ (k). The Bose condensation criterion is given by ! (k) = ! (k) h=2 = 0:W e use the MFT to study the eld dependent incom mensurability in the spin spiralphase. The results are shown in Fig. 2, where the vector k are plotted as a function of $J^0=J$ at several values of h. The main feature is as follows. 1) $J^0=J = 1$ is a stable xed point, around which the external magnetic eld does not change the ordering wave vector; 2) At $0:136 < J^0 = J < 1$, the ordering wave vector increases slightly as the eld increases; 3) At $J^0=J > 1$, the ordering wave vector decreases as the eld increases; 4) At J⁰=J < 0:136; the spin liquid may evolve into a spiral state, and becom es fully saturated as the eld further increases.

In the presence of the magnetic eld, the spin zcomponent $< S_z > 6$ 0, and the ground state breaks the SU (2) invariance. At T = 0, the expectation value of




FIG. 3: The ratio versus the wave vector k at di erent elds are ploted. Inset: The wave vector near $J^0=J = 0.33$ at ten di erent elds are ploted. From left to right, h = 0.0;0:1; ;1:0.

 S_z is given by

where h = h = (2) is the dimensionless eld. At $h \in 0$, hS_1^z is nite, which indicates a polarized component along the eld orientation z-axis. The static transverse susceptibilities at Q = 2k are given by

for = x and y. (Q)=N decreases as the eld increases, and approaches to zero at h = 1. b_0 (k; h) can be calculated within the MFT. A special case is b_0 (k; h = 1) = 1 corresponding to hS_1^z i = 1=2, or the spin full polarization. We have calculated the critical eld B_c (de ned as the lowest eld to induce the full spin polarization) as a function of $J^0=J$. The results are plotted in Fig. 3. As we can see, B_c increases as J^0 increases for the xed J. As J^0 increases, the spin couplings are strengthened, and it requires a higher eld to polarize the spin.

Very recently, Coldea et al.¹⁰ have reported the neutron scattering experiments on the antiferrom agnet Cs₂CuCl₄ in the high magnetic eld. That system is a quasi-2D spin-1/2 quantum system in a triangularlattice as shown in Fig.1. The spin-spin couplings are anisotropic with $J^0=J = 0.33$. In the absence of the externalm agnetic eld, the spins are incom m ensurately ordered and are aligned within the plane of the triangularlattice. The latter may indicate a weak deviation from the Heisenberg model. Coldea et al. have studied the low temperature states of the system in the presence of in-plane as well as perpendicular magnetic elds. In the presence of the perpendicular elds, the states are found m agnetically ordered with the varying incom m ensuration below a critical eld, above which the system becomes fully spin polarized ferrom agnet. In the presence of the




FIG.4: The incommensuration versus the external eld at $J^0=J=0.33$.

in-plane eld, they have observed additional spin liquid phase between the incom mensurate states and the ferromagnetic phase. There have been theoretical e orts to understand their experimental results.¹⁶ In the present paper, we have only considered the Heisenberg model in a uniform magnetic eld. The predicted spin structure breaks SU (2) symmetry, and shows the spin polarization along the eld-direction. Such a spin structure is compatible with the experiments in the perpendicular eld, but incompatible with the in-plane eld. Therefore, our MFT may be of relevance to the perpendicular eld case in their experiments.

To compare with the experiments, we de ne a quantity to describe the incommensuration, which is proportional to the wave vector deviation from the Neel state, = 1=2 $Q_1=$, with Q_1 the component of the spiral wave vector along a_1 direction. In Table I, we list the experimental¹⁰ and theoretical values of at eld h = 0 and at the critical eld h = 1 for the two values of $J^0=J$. A lso listed are the values of at h = 0 calculated from the series expansion m ethod³. The agreem ents between the present M FT and the series expansion at h = 0 are very good. In Fig. 4, we plot the incommensuration relative to the N eel state as a function of the external eld for $J^0=J = 0.33$. Our mean eld results are in qualitative agreem ent with the experiments: as eld increases, also increases in the parameter space of interest. Q uantitatively, the theory predicts a weaker variation in the incommensuration than in the experiments. This discrepancy could be partly due to the neglect of the deviation of the physical system from the Heisenberg m odel in the theory.

In sum m ary, we have used a Schwinger boson m ean eld theory to study the antiferrom agnetic H eisenberg m odelon an anisotropic triangular lattice in the presence of an external m agnetic eld. W e calculate the m agnetic eld dependence of the incom m ensurability of the spin spiral phase. The theoretical results are com pared well with the recent neutron scattering experiments.
