W e study a model of phantom tethered membranes, embedded in three-dimensional space, by extensive M onte C arb simulations. The membranes have hexagonal lattice structure where each monomer is interacting with six nearest-neighbors (NN). Tethering interaction between NN, as well as curvature penalty between NN triangles are taken into account. This model is new in the sense that NN interactions are taken into account by a truncated Lennard-Jones (LJ) potential including both repulsive and attractive parts.

The main result of our study is that the system undergoes a rst order crum pling transition from low temperature at phase to high temperature crum pled phase, in contrast with early num erical results on models of tethered membranes.

I. IN TRODUCTION

Statistical mechanics of membranes is a rich subject and has been studied since about twenty years. Motivations to obtain a full understanding of the behavior of these complex systems are enforced by many experimental realizations. For recent reviews, see [1] and [2]. See also [3] form any introducing and pedagogical courses on the subject.

M em branes are two-dim ensional uctuating system s of m onom ers. A coording to their physical properties, m em – branes can be \ uid" or \tethered". F luid m em branes consist of freely m oving m onom ers, ite w ith H am iltonian depending only on the shape of m em branes. On the contrary, m onom ers in tethered m em branes are tied together by a tethering potential and their connectivity is xed. In addition, a m em brane can be self-avoiding if intersections w ith itself are forbidden. O therw ise, it is a phantom m em brane. In this paper, we focus our attention on a m odel of tethered m em branes w ith external curvature energy w ithout self-avoidance.

A ny realistic m odel should include self-avoiding interactions. But phase diagram s of phantom m em branes are rich and contribute to understand the behavior of selfavoiding m em branes [4,5]. It is now m ly established that phantom m em branes undergo crum pling transition between a at and a crum pled phase. F lat phase possesses long-range orientational order between norm als to the surfaces whereas crum pled phase is totally disordered. How ever, the nature of the crum pling transition is still puzzling. Renorm alization group (RG) calculations [6] with a Landau continuous model [7] predict a discontinuous phase transition when the dimension d of the embedding space is lower than 219, including the physical case d = 3.0 n the other hand, numerical simulations of lattice models [8[18], large d expansion [19] and calculations based on truncations [20] of the Schwinger-D yson equations are consistent with a continuous phase transition.

In this paper, we try to shed a light on this contradiction with an extensive M onte C arlo (M C) study on a model of phantom tethered membranes with bending rigidity. As it turns out, our results show that the cnum - pling transition within ourm odel is of rst order in agreement with the RG prediction.

Section II is devoted to a description of the model. Our method is described in Section III and the results are shown in Section IV.Concluding remarks are given in the last section.

II. THE MODEL

We consider a 2D lattice of m onom ers connected in hexagonalstructure, and em bedded in the physical3d euclidean space. The tethering potential between nearestneighbor (NN) m onom ers is a truncated Lennard-Jones (LJ) potential. The curvature energy is a standard norm al-norm al interaction between NN triangles. The distance between NN monomers are not allowed to be larger than an upper bound distance $R_{m ax}$. O therw ise, in absence of R_{max}, monomers are no longer e ectively tethered at high tem perature and the system becom es a gaz. In order to keep essential features of the LJ potential, R_{max} must be su ciently larger than r_0 , the NN distance corresponding to the minimum of the potential, so that R_{m ax} lies in the at asymptotic region of the potential. How ever, to have an actual tethered mem brane, R_{m ax} should not be too large as discussed above. M oreover, equilibration times increase as R_{max} increases, since NN distances are then allowed to grow more and more.

The system is described by the Hamiltonian

The rst sum is performed on pairs of NN m onomers < i; j > only, and the second one is restricted to pairs of NN triangles < ; >. Tethering interaction between

NN m onom ers labeled by i and j depends only on their distance r_{ij} in the 3d embedding space and is described by U (r_{ij}),

with $r_{ij} = kr_i$ $r_j k$, r_i and r_j being the position vectors in the 3d space. r_o is the equilibrium distance between NN m onom ers. The second term in (1) is the external curvature energy, with K the bending rigidity. The 3dvectorn is de ned as the norm alunit vector of the th triangle form ed by three NN m onom ers. Note that n is de ned for a counterclockwise oriented triangle.

The phase space of the model depends on three param – eters. We x two of them, namely (U_0 and K), and look for tem perature-dependent properties.

III.NUMERICALMETHOD

We consider a membrane of linear size L. The total number of monomers is N = L L. We choose $U_{\rm o}$ = 3 and K = 1. A more extensive study would require to explore the complete phase space, but these particular values already give interesting results. The NN distance in the ground state is taken to be the unit of distance, i.e. $r_{\rm o}$ = 1, and the upper bound R $_{\rm max}$ = 4. We use free boundary conditions, at constant pressure in our simulations.

The following algorithm was used. Starting from the ground state where m onom ers are on the hexagonal lattice sites, we heat the system to a temperature T. We equilibrate the system at variable volume. The local equilibration is done as follows: we take a m onom er and m ove it to a nearby random position in a cubic box of volume ³ around its position, in the 3d space. This position is accepted if it lowers the energy. O therw ise it is accepted with a probability according to the M etropolis algorithm. We repeat this for all m onom ers: we say we achieve one M C step/m onom er. We choose ' 0:1 to have an acceptance of the order of 50 %.

We de ne the following physical quantities – averaged total energy hE i, averaged normal vector < n >, averaged NN distance < d >, radius of gyration R_g – with the following standard de nitions

where < ::: > indicates therm all average and the sum in < d > is perform ed only on NN links.

A llthe results described below are obtained after thermalization of the system. This requires about 10^6 10^7 M C steps/m onom er, depending on the tem perature. A fter thermalization, measures are done on 10^6 - 10^7 M C steps/m onom er, depending also on the tem perature.

 $\operatorname{E}\operatorname{rror}$ bars are calculated using a standard 'jack-knife algorithm .

IV.RESULTS AND ANALYSIS

At low temperature, equilibrium con gurations are con gurations of minimum energy. This means that NN distance must be close to r_o , the minimum of the LJ potential, and that NN norm als must be parallel to minimize curvature energy. So, equilibrium states correspond to a at state, with < n > ' 1 and R_g ' L. It is an ordered phase.

At high tem perature, m axim alentropy con gurations correspond to crum pled states, where the m em brane is com pact and occupies a very sm all volum e in the em – bedding space. It is a com pletely disordered phase, with < n > = 0 and R_g L.

B etw een low and high tem peratures, a crum pling phase transition is expected. In this work, we study the nature of this transition to see whether it is continuous or not.

As a rst point, we measured hE i, < n >, < d > and R_g versus tem perature for sizes N = 16 16, N = 24 24, N = 32 32 and N = 48 48. Results are shown in gures 1,2,3 and 4.




FIG. 1. Averaged energy versus temperature, for N = 16 16,24 24,32 32 and 48 48

It turned out that equilibration times are very large for this system. So, as we were interested in critical properties, we concentrated our work on the tem perature region around the phase transition, especially for N = 48 48. Figures 1,2,3 and 4 clearly show a phase transition between a at and a crum pled phase at T ' 1:1: there is a sharp jump of hE i from the low -T at phase to the high-T crum pled phase. Note that the slope of hE i increases with size in the transition region. The order parameter < n > drops from a nite value (this value would clearly tend to 1 as T tends to zero) to a vanishing value, as expected for an order-disorder transition.




FIG.2. < n > versus T, for N = 16 16, 24 24, 32 32 and 48 48




FIG.3. Averaged NN distance < d > versus T, for N = 16 16,24 24,32 32 and 48 48

At the transition, R_g falls from a nite value dependent of the linear size L to a small value m ore or less independent of L. This corresponds to the scaling R_g L, with = 1 in the at phase and = 0 (indeed, a logarithm ic dependence) in the crum pled phase. It should be noticed that the NN distance remains nite in the crum – pled phase, which means that monomers actually still form a tethered membrane even in the high temperature phase as discussed earlier.




FIG. 4. A veraged gyration radius $R_{\rm g}$ versus T , for N = 16 16,24 24,32 32 and 48 48

The second purpose of our work was to determ ine whether the transition is continuous or not. A standard m ethod, when using num erical simulations, consists in a

nite size scaling analysis of the maximum of the specie c heat C_v . For a second-order phase transition, it is expected to grow as the linear system size. For a discontinuous transition, there are in principle discontinuities in therm odynamic quantities. However, for small systems, a discontinuous phase transition can appear to be continuous if the correlation length is greater than the linear size of the system. In that case, C_v^{max} is expected to grow as the size of the system. [21]

We measured C_v^{max} for N = 16 16, N = 24 24 and N = 32 32 using the histogram technique. [22] For these sm all sizes, energy histogram s have a single peak for all temperatures we explored around the transition (multihistogram method). They are found more or less gaussian.

In gure 5, we plot C_v^{max} versus N in logarithmic scale. Fitting these data, we obtain C_v^{max} N^x with x = 0.83 (12). This value is far from the value x = 0.5 expected for a continuous transition. It is closer to 1, the theoretical value for a rst-oder transition as discussed above. At this stage, in view of this, we conjecture that the transition is of rst order. A sseen below this conjecture is con rm ed by histogram smade for a larger size.




FIG.5. C_v^{max} versus N in logarithmic coordinates, for N = 16 16, N = 24 24 and N = 32 32. The dashed line is the best t.

In order to check further the st-order character of the transition, we increase L. For large L, if the transition is of st order, the energy histogram should show a structure of multiple peaks corresponding to the coexistence of ordered and disordered phases at the transition. The system would go back and forth between these phases resulting in a double-peak energy histogram. Taking L = 48, we indeed observed this double-peak histogram in the region T ' 1:1, as shown in gure 6. This is a very strong signal which con sthe stronger character of the crum pling transition found earlier by nite-size scaling of C_v^{max} .




FIG. 6. Normalized histogram for the energy, for N = 48 48. Double-peak structure showing the rst-order character of the phase transition

V.CONCLUSION

W e have studied the crum pling phase transition by M C simulation of a model of tethered m embranes with LJ potential energy and bending rigidity. W e have shown clearly the rst-order nature of the phase transition between at and crum pled phases, in contrast with earlier simulations using gaussian tethering interaction. Note that these early M C results $[8\{18\}$ and also analytical calculations [19,20] show a continuous phase transition form odels which do not include anharm onic excitations. W e believe that the anharm onic nature of the LJ potential used in our model to som e extend contributes to the

rst-order transition observed here. We did not vary in this work the value of bending rigidity K. Let us mention how ever that for K = 0, there is no at phase, the mem brane is crumpled at all T.

It would be interesting to include self-avoidance between non nearest-neighbors in our model. However, it seems that in that case the precise form of NN potential is irrelevant: for repulsive self-avoidance between non nearest-neighbors the membrane is always at regardless of the form of the potential between NN, even in the absence of bending rigidity. [8,9,23] This is interpreted as an elective bending rigidity induced by excluded volum e elect. This can be overcome by an attractive interaction between non nearest-neighbors in addition to the repulsive self-avoiding interaction, leading to the folding of the membrane at low T and a at phase at high T. [24] Including such repulsive and attractive interactions between non nearest-neighbors in ourm odel is a form idable task which is left for future investigations.
