The depinning transition of a driven interface in the random – eld Ising model around the upper critical dim ension

We investigate the depinning transition for driven interfaces in the random – eld Ising model for various dimensions. We consider the order parameter as a function of the control parameter (driving eld) and examine the elect of thermal actuations. Although thermal actuations drive the system away from criticality the order parameter obeys a certain scaling law for su ciently low temperatures and the corresponding exponents are determined. Our results suggest that the so-called upper critical dimension of the depinning transition is velocity to the universality class of the quenched Edward-Wilkinson equation.

I. INTRODUCTION

D riven Interfaces in quenched disordered systems display with increasing driving force a transition from a pinned interface to a moving interface (see e.g. [1] and references therein). This so-called depinning transition is caused by a competition of the driving force and the quenched disorder. The rst one tends to move the interface whereas the latter one hinders the movement. Depinning transitions are observed in a large variety of physical problems, such as uid invasion in porous materials (see, for instance, Sec. 62 in [2] and references therein), depinning of charge density waves [3, 4], in purity pinning of ux-line in type-II superconductors [5], contact lines [6] as well as in eld driven ferrom agnets, where the interface separates regions of opposite magnetizations [7].

A well established model to investigate the depinning transition in disordered ferrom agnets is the driven random – eld Ising model (RFIM) (see for instance [7, 8, 9, 10, 11]). Here, the disorder induces some e ective energy barriers which suppress the interface motion. A magnetic driving eld H reduces these energy barriers but they vanish only if the driving eld exceeds the critical value H $_{\rm C}$. The transition from the pinned to the moving interface can be described as a continuous phase transition and its velocity v is interpreted as the orderparam eter. W ithout them all uctuations (T = 0) the eld dependence of the velocity obeys the power-law behavior

$$v(h;T = 0) \qquad h \tag{1}$$

for h > 0, where h denotes the reduced driving eld $h = H = H_{\rm C}$ 1.

The depinning transition is destroyed in the presence of therm al uctuations (T>0) which may provide the energy needed to overcome local energy barriers. A lthough therm al uctuations drive the system away from criticality the order parameter obeys certain scaling laws and for su ciently low temperatures the order parameter can be described as a generalized homogenous function [12]

$$v(h;T) = v(^{1=}h; T);$$

sim ilar to usual equilibrium second order phase transitions. Setting $^{1=}$ = 1 one recovers Eq.(1) for zero tem perature. Choosing T = 1 one gets for the interface velocity at the critical eld H $_{\rm C}$

$$v(h = 0;T) T^{1=} : (3)$$

This power-law behavior was observed in two-and threedimensional simulations of the driven RFIM [12, 13] as well as in charge density waves in computer simulations and mean-eld calculations [4, 14].

Furtherm ore, therm all uctuations cause a creep motion of the interface for small driving elds (H $_{\rm c}$) characterized by an Arrhenius like behavior of the velocity [15, 16]. Recently, this creep motion was observed in experiments considering magnetic domain wall motion in thin lms composed of Co and Pt layers [17], in renormalization group calculations [18, 19] regarding the Edwards-Wilkinson equation with quenched disorder (QEW), as well as in numerical simulations of the RFIM [20].

In equilibrium physics a scaling ansatz according to Eq. (2) usually describes the orderparam eter as a function of its control param eter and of its conjugated eld. A lthough Eq. (2) can be applied to the depinning transition, i.e. the temperature is a relevant scaling eld, T is not conjugated to the order param eter. The conjugated eld would support the interface motion independent of its strength. But strong them al uctuations destroy the

interface instead to support the interface motion. Therefore, one has to interpret the value of the therm alexponent carefully. For instance, it is not clear wether the obtained values of are a characteristic feature of the whole universality class of the depinning transition or just a characteristic feature of the particular considered RFIM. This point could be important for the interpretation of experiments which naturally take place at nite temperatures.

In this paper we reinvestigate the interface dynam ics of the driven RFIM and focus our attention to higher dimensions d 3. In particular we consider the scaling behavior at the critical point and determ ine the exponents and . Our results suggest that the so-called upper critical dimension of the depinning transition of the driven RFIM is $d_{\rm c}=5$. Above this dimension the scaling behavior is characterized by the mean-eld exponents. We compare our results with those obtained from a renormalization group approach of the quenched Edward-Wilkinson equation which is expected to be in the same universality class as the driven RFIM . A sum-mary is given at the end.

II. MODEL AND SIMULATIONS

We consider the depinning transition RFIM on cubic lattices of linear size L in higher dimensions (d 3). The Hamiltonian of the RFIM is given by

where the rst term characterizes the exchange interaction of neighboring spins ($S_i = 1$). The sum is taken over all pairs of neighbored spins. The spins are coupled to a hom ogenous driving eld H as well as to a quenched random – eld h_i w ith hh_i i = 0 and hh_ih_j i / $_{ij}$. The random eld is assumed to be uniform by distributed, i.e., the probability p that the random eld at site i takes some value h_i is given by

U sing antiperiodic boundary conditions an interface is induced into the system which can be driven by the eld H (see [12] for details). A G lauber dynamics with random sequential update and heat-bath transition probabilities is applied to simulate the interface motion (see for instance [21]).

Due to this algorithm not only spins adjacent to the interface but throughout the whole system can ip with a nite probability at temperatures T>0. In general, this may cause nucleation which always starts with an isolated spin- ip. The minimum energy required for an isolated spin- ip is $E=2\left(z\,J-H\right)$ with $z=2^d$ nearest neighbors on a bcc lattice. Although the corresponding spin- ip probability $1=[1+\exp\left(E=T\right)]$ is small

for the considered tem peratures (T 0.2), isolated spinips are possible and occur. But we observed that these spin-ips are unstable in our simulations, i.e., an isolated spin will ip back in the next update step. Thus the originally induced interfaces is stable during the simulations.

The moving interface corresponds to a magnetization M which increases in time t (given in M onte Carlo step per spin). The interface velocity, which is the basic quantity in our investigations, is obtained from the time dependence of the magnetization v = hdM = dti where h::i denotes an appropriate disorder average. Starting with a at interface we performed a su ciently number of updates until the system reaches after a transient regime the steady state which is characterized by a constant average interface velocity.

As pointed out in previous works [12,13] an appropriate choice of the interface orientation is needed in order to recover that the interface m oves for arbitrarily small driving eld in the absence of disorder. An appropriate choice is to consider the interface motion along the diagonal direction of a simple cubic lattice. For d 3 an alternative is to exam ine the interface motion along the z-axis on a body-centered cubic (bcc) lattice. Since it is much more convenient to implement the latter case in higher dimensions we consider in this work bcc lattices, the more as the lattice structure usually does not a ect the universal scaling behavior.

III. D = 3




FIG. 1: Snapshot of a m oving interface at T=0 for L=128, = 1:7, and H=1:37 in d=3. In order to show the details we stretched the interface in the vertical direction by a factor 15.

In the case of the three dimensional RFIM we consider box lattices of linear size L 250.A snapshot of a moving interface in the steady state is presented in Fig.1. The obtained values of the interface velocities for T = 0




FIG. 2: Dependence of the interface velocity v on the driving eld H for a box and simple cubic (sc) lattice, respectively. The inset shows v as a function of the reduced driving eld h. The dash dotted lines are ts according to Eq. (1).

are plotted in Fig.2. As one can see v tends to zero in the vicinity of H $\,$ 1:36. Assuming that the scaling behavior of the interface motion is given by Eq.(1) one varies H $_{\rm C}$ until one gets a straight line in a log-log plot. Convincing results are obtained for H $_{\rm C}=1:357~$ 0:001 and the corresponding curve is shown in the inset of Fig.2. For lower and greater values of H $_{\rm C}$ we observe signicant curvatures in the log-log plot (not shown). In this way we estimate the error-bars in the determination of the




FIG. 3: Scaling plot of the interface velocity for d=3. The data are rescaled according to Eq. (6). The inset shows the unscaled velocities for $T=0.025\,\mathrm{n}$ with n 2 f1;2;3;4;6;8g (solid lines) in comparision to the T=0 data from Fig. 2 (dashed line).

critical eld. A regression analysis yields the value of the order parameter exponent = 0.653 - 0.026. This value agrees with = 0.66 - 0.04 which was obtained from a similar investigation [12] where the interface moves along the diagonal direction of a simple cubic lattice (see inset of Fig.2). Furthermore, both results are in agreement with = 0.60 - 0.11 [10, 11], where in d = 3 the inuence of helicoidal boundary conditions in one direction and periodic ones in the other direction parallel to the interface was investigated on a simple cubic lattice.

In order to determ ine the exponent we simulated the RFIM around the critical eld for $T=0.025\,\mathrm{n}$ with n 2 f1;2;3;4;6;8g. The obtained curves are shown in the inset of Fig. 3. A coording to Eq. (2) the interface velocity scales as

$$v(h;T) = T^{1=} v(hT^{1=};1)$$

P lotting v(h;T)T $^{1=}$ as a function of hT $^{1=}$ one varies , , and H $_{\rm c}$ until one gets a data collapse of the di erent curves. C onvincing data collapses are observed for = 0.63 $^{\circ}$ 0.06 = 2.33 $^{\circ}$ 0.2 and H $_{\rm c}$ = 1.360 $^{\circ}$ 0.01 and the corresponding curves are shown in Fig.3. The obtained values of the order param eter exponent and of the critical eld agree w ithin the error-bars w ith the values of the T = 0 analysis. Furtherm ore our results are in agreem ent w ith sim ilar investigations on a simple cubic lattice (= 0.63 $^{\circ}$ 0.07 and = 2.38 $^{\circ}$ 0.2, see [12]).

$$D=4$$

In order to determ ine the order parameter exponent of the four dimensional driven RFIM we measured the




FIG. 4: The interface velocity of the four-dimensional model at T = 0. For su ciently small elds the data obey a power law according to Eq.(1) (dotted dashed line). For the twe use only those data marked by lled symbols and we nd H $_{\text{c}}$ = 1.258 0.05 and = 0.8 0.06.




FIG. 5: Scaling plot of the interface velocity for d=4 and d=6, respectively (see inset). The data are rescaled according to Eq. (6).

interface velocity for bcc lattices of linear sizes L $\,$ 140. The obtained data for T = 0 are shown in a log-log plot in Fig.4. After a transient regime which displays a nite curvature we observe an asymptotic power-law behavior for su ciently small driving eld H . A regression analysis yields = 0.8 0.06 and H $_{\rm C}=1.258$ 0.002.

To determ ine the exponent we simulated the RFIM in the vicinity of the critical eld for T = $0.025\,\mathrm{n}$ where again n 2 f1;2;3;4;6;8g was choosen. Similar to the three dimensional case one varies the exponents as well as the critical eld until one observes a data collapse. Good results are obtained for = 0.73 0:13, = 1.72 0:27, and H $_{\rm C}$ = 1.256 0:015. The corresponding data collapse is shown in Fig.5. Again, the obtained values of and H $_{\rm C}$ con m the above presented analysis for T = 0.

$$V.D=5$$




FIG. 6: The e ective exponents $_{\rm e}$ as a function of lnh for various dimensions. The gure shows that the vedimensional exponent does not display a clear saturation as the exponent of the lower dimensions do. The data of the six-dimensional model indicate that the expected saturation value $_{\rm e}$ = 1 is reached signicantly faster as compared to d = 5 (see text). The values of the two-dimensional system are obtained from [13].

In the case of the ve-dimensional RFIM system sizes from $L=10~\rm up$ to $L=30~\rm are$ simulated. Analyzing the interface motion at $T=0~\rm we$ observe that the velocity-eld dependence can not be described by a pure power-law, i.e., Eq. (1) fails. In Fig. 6 we plotted the logarithm ic derivation of the velocity-eld dependence

$$e = \frac{0 \ln v}{0 \ln h} \tag{7}$$

which can be interpreted as an elective exponent. If the asymptotic scaling behavior obeys Eq. (1) the logarithm ic derivative tends to the value of for H ! H $_{\rm C}$. But as can be seen from Fig.6 no clear saturation takes place for d = 5 as it is observed for the three and four dimensional model. The lack of a clear saturation could be explained

by a too large large distance from the critical point, but another reason is possible too.

Signi cant deviations from a pure power law behavior Eq.(1)] occur for instance at the upper critical dim ensional d_c where the scaling behavior is governed by the mean-eld exponents modied by logarithmic corrections. The scaling behavior around dc is well understood within the renormalization group theory (see for instance [22, 23, 24]). For $d > d_c$ the stable x point of the corresponding renormalization equations is usually a trivial x point with classicalm ean-eld exponents. This trivial x point is unstable for d < dc and a di erent stable x point exists with nonclassical exponents. These exponents can be estimated by an -expansion, for instance. For $d = d_c$ both x points are identical and marginally stable. In this case the asymptotic form of the therm odynam ic functions is given by the mean-eld power-law behavior modi ed by logarithm ic corrections. Applying this approach to the depinning transition, the corresponding ansatz reads

$$v(h;T = 0) \qquad h^{MF} \ j \ln h^{B}; \qquad (8)$$

where B denotes an unknown correction exponent. It is worth to mention that in contrast to the values of the critical exponents below the upper critical dimension the above scaling behavior does not rely on approximation schemes like -or 1=n-expansions [25]. Within the renormalization group theory it is an exact result in the limit h! 0 (see e.g. [22, 26] and references therein for RG investigations and [27, 28] for measurements).




FIG. 7: The rescaled interface velocity as a function of the driving eld for d=5. In order to display the logarithm ic corrections we plot $(v=h)^{1-B}$ vs. In h [see Eq.(8)]. The solid line corresponds to the expected asymptotic scaling behavior for h! 0 [corresponding to lnh! (1)] according to Eq.(9).

The value $_{\rm M\ F}$ = 1 is reported for depinning transitions [1, 29, 30]. Thus we analyze v(h)=h as a function of jlh hj and note again that Eq. (8) describes only the leading order of the scaling behavior, i.e., we expect that the asymptotic behavior of interface velocity obeys

$$[v(h)=h]^{1=B} = const jln h j; (9)$$

Therefore, we varied in our analysis the logarithm ic cor-




FIG. 8: The scaling plot of the interface velocity v for the ve dimensional model, i.e. at the upper critical dimension. The data are rescaled according to Eqs. (10,11) using = 1:49, = 1, = 0:22, and = 0:19.

rection exponent B and the critical eld H $_{\rm C}$ until we get this expected asymptotic behavior. The best results are obtained for B = 0:40 0:09 and H $_{\rm C}$ = 1:14235 0:001 and the corresponding scaling plot is shown in Fig.7. The observed asymptotic agreement with Eq. (9) corresponds to a logarithm ically (l=jlhhj) convergence of $_{\rm C}$ to $_{\rm M\,F}$ = 1, which explains why no clear saturation of the elective exponent could be observed for h! 0 in the vedimensional model.

Sim ilar to the T=0 scaling behavior one has to modify for T>0 the scaling ansatz since no data collapse could be obtained by plotting the data according to Eq.(2). Motivated by recently performed investigations of the scaling behavior of an absorbing phase transition around the upper critical dimension [31] we assume that the scaling behavior of the order parameter obeys in leading order

$$v(h;T) = T^{1=MF} j ln T j \forall (x;1)$$

where the scaling argum ent x is given in leading order by

$$x = h T^{1= MFMF} jh T j$$
 (11)

with $_{\rm M\,F}=1$. In our analysis we use the value $_{\rm M\,F}=1.49$ obtained from the analysis of the six dimensional RFIM (see next section). Therefore, we have to vary the exponents and in order to observe a data collapse according to Eqs. (10,11). Convincing results are obtained for = 0.22 0.16, = 0.19 0.12 The corresponding data collapse is shown in Fig.8.

$$VI. D = 6$$

Above the upper critical dim ension the scaling behavior is characterized by the mean-eld exponents, i.e., in leading order the interface velocity is given by

$$v(h;T = 0)$$
 h: (12)




FIG. 9: The interface velocity as a function of the driving eld for the six-dimensional model. The dashed line corresponds to a taccording to Eq. (13). The inset displays v(h)=h as a function of the reduced driving eld h. The resulting linear behavior con m s that the deviations from the mean—eld behavior can be described by quadratic corrections.

In Fig. 9 we plot the velocity as a function of the driving eld H obtained from simulations of system sizes L 14 A s one can see the velocity does not display the expected linear behavior. It seems that a linear behavior is only given for small velocities, i.e., our data do not display the pure asymptotic behavior Eq. (12)]. This is commed by the behavior of the elective exponent Eq. (7)] which increases fast for h! 0 but the actual saturation to = 1 does not take place for the considered values of h (see Fig. 6). To observe the asymptotic behavior one has to perform simulations closer to the critical point H $_{\rm c}$ which requires to simulate larger system sizes. Unfortunately, the limited CPU powermakes this impossible.

An alternative is to take the curvature of the function v(h) into consideration and to assume that the leading corrections to the asymptotic behavior are of the form

$$v(h;T = 0) = v_1 h + v_2 h^2 + O(h^3);$$

which recovers Eq. (12) for h! 0. Fitting our data to this ansatz we get H $_{\rm C}$ = 1:1537 0:003, y = 0:2546, and v2 = 0:0895. The corresponding curve ts the simulation data quite well as one can see from Fig.9. In the inset of Fig.9 we plotted v(h)=h as a function of the reduced driving eld h. A coording to the above ansatz Eq. (13)] one gets a linear behavior, i.e., the deviations from the pure mean—eld behavior Eq. (12)] can really be described as quadratic corrections. Thus we get that our num erical data are consistent with the assum ption that the six dimensional RFIM depinning transition is characterized by the mean—eld exponent MF = 1.

Again we consider how thermal uctuations a ect the scaling behavior and analyse interface velocities obtained at dierent temperatures $T=0.025\,\mathrm{n}$ with n 2 f1;2;3;4;6;8g. Similar to the situation below the upper critical dimension we assume that the scaling behavior of the interface velocity is given by Eq.(2) where the exponents are given by mean-eld values. A convincing data collapse is obtained for $_{\mathrm{M}\,\mathrm{F}}=1.49$ 0.15 and $_{\mathrm{C}}=1.153$ 0.02 and is plotted in the inset of Fig. 5.

VII. DISCUSSION

A well established realization of interface pinning in a disordered media is the so-called quenched Edwards—Wilkinson (QEW) equation of motion which was intensively investigated in the last decade [7, 18, 19, 29, 30, 32]. It is argued that the QEW equation as well as the driven RFIM are characterized by the same critical exponents, i.e., both models belong to the same univer-




FIG. 10: The critical exponents and as a function of the dimension. The solid line corresponds to the values of an -expansion Eq. (14)].

sality class [7, 10]. Renorm alization group analyses of the quenched QEW equation [29, 30] predict, in accordance with [7], $d_c = 5$ and allow to estimate the critical exponents using an -expansion. A recently performed two-loop renormalization approach yields [30]

$$QEW = 1 \frac{1}{9} 0.040123^2 + O(^3)$$
 (14)

where denotes the distance from the upper critical dimension, i.e. = 5 d (unfortunately, no error-bars can be estimated from an -expansion). The corresponding values of the exponents as a function of the dimension are plotted in Fig. 10. The numerically determined exponents of the driven RFIM (listed in Table I) are in a fair agreement with the values of the -expansion.

For the QEW equation the temperature exponent is not known. Therefore, a direct comparison with the obtained values of the driven RFIM is not possible.

VIII. CONCLUSIONS

We studied numerically a eld driven interface in the RFIM and determ ined the order parameter exponent as well as the temperature exponent. Below the upper critical dimension $d_c=5$ the critical exponents depend on the dimension and the values of the exponents correspond to those of a two-loop renormalization group approach of the Edwards-Wilkinson equation [30]. This suggest that the depinning transition of the RFIM model belongs to the universality class of the quenched Edward-Wilkinson equation. At the upper critical dimension $d_c=5$ the scaling behavior is a ected by logarithm ical corrections. Above the upper critical dimension we ob-

serve that the scaling behavior is characterized in leading order by the corresponding mean-eld exponents.
