On the statistics of resonances and non-orthogonal eigenfunctions in a model for single-channel chaotic scattering

#### Abstract

W e describe analytical and num erical results on the statistical properties of com plex eigenvahes and the corresponding non-orthogonal eigenvectors for non-H erm itian random $m$ atriges $m$ odeling one-channel quantum -chaotic scattering in system $s$ w ith broken tim e-reversal invariance.


The statistical properties of non-orthogonal eigenvectors of large non-selfadjoint random $m$ atrices have recently been characterised in Refs.

Correlations of non-orthogonal eigenvectors are expected to determ ine dynam icalproperties ofclassicalrandom system sdescribed by nen-selfadjoint operators, such as FokkerP lanck operatons ${ }^{1 \sigma_{1}}$ for exam ple; they also play an im portant role in quantum system s: in Ref. it was observed that the statistics of non-orthogonal eigenvectors determ ines the properties of random lasing $m$ edia. $T$ his has led to an increased interest in eigenvector statistics in non-selfadjoint random $m$ atrix ensem bles (see also Ref. ${ }^{-17} \mathbf{T}_{1}$ ).

In a m odel for quantum -chaotic scattering, the com plex eigenvalues $E_{k} ; k=1 ;::: ; N$ of a random $N \quad N$ non Herm itian matrix (the so-called \e ective Ham irtonian") $\mathrm{H}_{\mathrm{N}}=\hat{\mathrm{H}} \quad \hat{\mathrm{I}}$ are used to describe generic statistical properties of resonances in quantum chaotic scattering (see Ref. $1,1,1$, and references therein): for system $s$ w ith broken tim e-reversal invariance (anti-unitary sym $m$ etry), the $m$ atrices $\hat{H}$ are random $N, N m$ atrices from the Gaussian Unitary Ensemble $w$ ith joint probability density $P(H) d H / \exp \left[(N=2) T H^{2}\right] d H$. In the lim it of large $N$, the $m$ ean eigenvalue density
( $E$ ) for such matrioes is given by the sem icircular law
$(E)=(2)^{1} P \overline{4} E^{2}$ for $E j<2$ (and zero other$w$ ise). The corresponding $m$ ean spacing betw een neigbouring eigenvalues around the point $E$ in the spectrum is given by $\quad(E)=1=\mathbb{N} \quad(E)]$.
$T$ he $H$ erm itian $m$ atriges $\hat{H}$ describe the energy-level statistics of the closed counterpart of the scattering system; the Herm itian $N \quad N$ m atrix ${ }^{\wedge}>0 \mathrm{~m}$ odels the coupling of the system to scattering continua via $M=1 ; 2$;:: open channels. It has rank M N . For our purposes it can be chosen diagonal: ${ }^{\wedge}=\operatorname{diag}(1 ; 2 ;:: ;$ м $; 0 ;:: ; 0)$. The constants $0<c<1$ param etrise the strength of the coupling to the scattering continua via a given channelc $=1$;::;; M . Here $\mathrm{c}=0$ corresponds to a closed channel c, and $c=1$ describes the so-called perfectly coupled channel. Em pirical situations correspond to the regim e of large $N$, w ith $M$ xed and $M \quad N$. Then the $w$ idths $k=2 \mathrm{Im} E_{k}$ are of the same order $1=\mathrm{N}$ as the $m$ ean spacing ( $E$ ) betw een the positions of the neighbouring resonances along the real energy axis. In this regim $e$, the resonances $m$ ay partly or considerably over-
lap and rst-orderperturbation theory valid for sm allresonance overlaps breaks,rdown. Sim ilarly, self-consistent perturbation schem est strongly overlapping resonances are inapplicable.

A detailed analytical understanding of the statistical properties of the resonances in the regin e of partialoverlap has recently been achieved for the, case of system $s$ $w$ ith broken tim e reversal invariance ${ }^{8} \mathbf{n}^{11}-1$. T hese results, based on the random $m$ atrix approach, are expected to be applicable to a broad class of quantum -chaotic system s. Indeed, the distribution of the widths $k$ derived in Ref., is in good agreem ent w th available num erical data, for quite diverse $m$ odels of quantum chaotic scattering ${ }^{11112} 12$.

M uch less is known on properties of non-orthogonal eigenvectors. Let $\mathrm{R}_{\mathrm{k}} \mathrm{i}$ and $\mathrm{hL} \mathrm{L}_{\mathrm{k}}$ jdenote the right and the left eigenvectors of the $m$ atrix $\hat{H}$ corresponding to the eigenvalue $\mathrm{E}_{\mathrm{k}} \quad \mathrm{E}_{\mathrm{k}} \quad \mathrm{i}_{\mathrm{k}}=\mathrm{E}_{\mathrm{k}} \quad \mathrm{i}_{\mathrm{k}}=2$,

where the symbols $y$ and stand for Herm titian conjugation and complex conjugation, respectively. Except for a set of $m$ easure zero, the eigenvalues are nondegenerate. In this case the eigenvectors form a complete, bi-orthogonalset. They can be norm alised to satisfy $h L_{k} R_{1} i=k l$. The most natural way to characterise the non-orthogonality ofeigenvectors is to consider statistics of the overlap $m$ atrix $O_{k l}=h L_{k} J_{1} i_{1 h} R_{1} R_{k} i$. $T$ his $m$ atrix features in two-point correlation functions in non $H$ erm itian system s, e.g. in description of the particle escape from the scattering region ( $\backslash$ norm leakage", see Ref. in $_{1}^{\prime 2}$ ).

Follow ing Ref.II, consider tw o correlation functions: a diagonalone

H ere $\mathrm{h} \quad \mathrm{H}_{\mathrm{N}}$ stands for an_ ensemble average over $\mathrm{H}_{\mathrm{N}}$. The correlation functions (2,
non-orthogonality of eigenvectors corresponding to resonances whose positions in the com plex plane are close to the com plex energies $E$, and $E_{1} ; E_{2}$. H ere ( $E$ ) stands for a two-dim ensional function of the com plex variable E.

In the context of lasing $m$ edia, the diagonal correlator (2,) characterises average excess noise factors (P eterm ann factors), and the o -diagonal correlator ${ }^{\prime}\binom{(\$)}{( }$ describes average cross correlations betw een therm, al or quantum noise em itted into di erent eigenm odes ${ }^{4}$. N ote that for any ensem ble with orthogonal eigenvectors and com plex eigenvalues $E$ (for norm al $m$ atrioes), $O(E)$ is equal to the $m$ ean density of complex eigenvalues, and the o diagonal correlator vanishes: $\mathrm{O}\left(\mathrm{E}_{1} ; \mathrm{E}_{2}\right) \quad 0$.

B oth diagonaland o -diagonaleigenvector correlators were introduced and calculated for the case of $G$ inibre's ensem ble ofnon $H$ erm titian $m$ atrices in Ref. ${ }_{1} 1 \mathbf{1}$. For the ensemble $H_{N}$ pertinent to chaotic scattering, both types of eigenvector correlators w ere found recently for the regin e ofvery strongly overlapping resonances when w idths typically $m$ uch exceed the $m$ ean separation ${ }^{2,51}$. Physically this regim e corresponds to a situation where the scattering system is coupled to the continuum via a large number M 1 of open channeld $\mathrm{l}^{8}$. In this fape the
 perturbative approxim ation valid in the lim it of large $N$, large $M$, and $\Psi_{1} E_{2} j \in 0$, provided $E_{1} ; E_{2}$ are well inside the support of the spectrum . A non-perturbative expression for the diagonal correlator $O(z)$ valid for any num ber of open channels was obtained in Ref.'I by em ploying a heuristic analytic continuation procedure. For the case of the resonance $w$ idths, this heuristic schem e is known to reproduce the exact expression-. It is thus natural to expect that this procedure is adequate in the case of eigenvector statistics, too, although this rem ains to be proven.

No non-perturbative results for the o -diagonaleigenvalue correlator $O\left(E_{1} ; \mathrm{E}_{2}\right)$ have so far been reported, to the best of our know ledge.

In the present paperw e provide exact non-perturbative expressions for both diagonal and o -diagonal eigenvector correlators valid for the case of a system w ith broken tim e-reversal invariance (anti-unitary symmetry) coupled to continuum via a single open channel $(\mathbb{M}=1)$ w ith coupling strength . The single-channel case describes pure resonant chaotic re ection. This case is $m$ ore am enable to analytical treatm ent than a general case $\left(\begin{array}{ll}\text { M } & \text { ), combining both re ection and transm is- }\end{array}\right.$ sion phenom ena. U nderstanding the single-channel case should be considered as a useful step tow ards a m ore com plete picturet ${ }^{4}$.

O ur result for the diagonal correlator is

where $\mathrm{E}=\mathrm{E}$ iY, (E); = (E) and $g=\left(+{ }^{1}\right)=(2 \quad)$ is the e ective (renorm alised) coupling strength. $T$ he result for $O$ ( $\mathbb{E}$ ) agrees w ith one

reported in Ref. $\overline{13}_{1}$ con $m$ ing the validity of the analytical continuation schem e used there. For the sake of com parison we present here also the expression for the single-channel resonance density de ned as d(E)= $\mathrm{N}^{1} \quad \mathrm{k} \quad\left(\mathrm{E} \quad \mathrm{F}_{\mathrm{f}}\right)_{\mathrm{H}_{\mathrm{N}}}$ and given by ${ }^{{ }^{18}}$ :

W e have com pared these analytical expressions, valid in the $\lim$ it $N$ ! 1 , w ith direct num erical diagonalisations of nite-dim ensionalm atrices $\mathrm{H}_{\mathrm{N}}$, see F ig. $\overline{1}_{1}^{\prime}(\mathrm{a})$. $T$ his is of interest since em pirically, the ensem ble average h $H_{N}$ 落 usually replaced by an energy average over several spectral w indow $s$, each of which $m$ ay typically contain of the order of 10 or 100 resonances, corresponding to a nite value of N. W e observe that the analytical results describe the num ericaldata well, except for sm all deviations at large values of $Y$. N um erically it is easier to com pute sm oothed averages, such as the $m$ ean num ber of eigenvalues hn ( $\mathrm{L}_{\mathrm{x}} ; \mathrm{L}_{\mathrm{y}}$ ) i inside a rectangular dom ain

in the com plex plane. $T$ hisquantity can be obtained from the $m$ ean density $d(E)$ by integration over A. Sim ilarly

one can de ne the function $O_{1}\left(\mathrm{~L}_{\mathrm{x}} ; \mathrm{L}_{\mathrm{y}}\right)$ as the integral of the diagonal correlator $O\left(E_{p}\right)$ over the sam e dom ain, obtaining $\mathrm{O}_{1}\left(\mathrm{~L}_{\mathrm{x}} ; \mathrm{L}_{\mathrm{y}}\right)=\mathrm{hN} \quad{ }^{1} \quad \mathrm{E}_{\mathrm{k}} 2 \mathrm{~A} \mathrm{O}_{\mathrm{kk}} \mathrm{i}$. N um erical versus analytical results for these tw o quantities are plotted in $F$ ig. ${ }^{\prime \prime 1} 1 l^{\prime}(\mathrm{b})$.

We have also calculated the corresponding $\operatorname{sm}$ oothed average $\mathrm{O}_{2}\left(\mathrm{~L}_{\mathrm{x}} ; \mathrm{L}_{\mathrm{y}}\right)=\mathrm{hN}{ }^{1} \quad \mathrm{E}_{\mathrm{m}} \notin \mathrm{E}_{\mathrm{n}} 2 \mathrm{~A} \mathrm{O}_{\mathrm{mn}} \mathrm{i}$, by integrating $E_{1}$ and $E_{2}$ in $(\underline{\overline{1}}$, ) over the dom ain $A$. In Fig. ${ }_{1}^{11}(c)$ we com pare this result (valid in the lim it of N ! 1 ) w ith those of num erical diagonalisations of nite $m$ atrices; the agreem ent is good already for $\mathrm{N}=32$.

W e have also found a w ay to calculate exactly the distribution $f()$ of the width of the $m$ ost narrow resonance am ong those falling in a w indow $\mathbb{E} \quad W=2 ; E+W=2]$ in the vicinity of a given point $E$ in the spectrum. A ssum ing that the m ean number $\mathrm{n}=\mathrm{W}=$ of resonances is large ( $n \quad 1$ ), but stillW 1 to preserve spectrallocality (the density of states should not change signi cantly across the spectral window ):

$T$ his distribution is of great interest in the theory of random lasing ${ }^{3 / 2}$. The functional form of the distribution was found in Ref. $m$ ents yielding Eq. (id), but w ith renorm alised e ective coupling $g$ replaced by its \weak coupling" lim it $=2$. W e see that the di erence $w$ ith exact form ula am ounts to the factor 2 in the exponent for the case of perfect coupling $=1$. In Fig. to results of num erical diagonalisations for $\mathrm{N}=128$ and $\mathrm{W}=0: 2$, corresponding to n 8:15.

In the rem ainder of this article, we outline the deriva-
 that fact that the com plex eigenvalues (resonances) $\mathrm{E}_{\mathrm{k}}$
are poles of the $M \quad M$ scattering $m$ atrix $\hat{S}(\mathbb{E})$ in the com plex energy plane. U sing the standard expression for the scattering $m$ atrix in term $s_{\text {of }}$ of the non $H$ erm itian $H$ am iltonian $H_{N}$ (see e.g. Ref. ${ }^{\prime}$ (q) the residues corresponding to these poles can be found and after som e algebraic manipulations we arrive at the follow ing relation:

This relation is valid for arbitrary $M$, but for $M>1$ it appears to be of no obvious utility, due to di culties in evaluating the ensemble average of the trace of the residues on the left-hand side. H ow ever for the case ofone single open channel the scattering $m$ atrix can be written as

In this way the problem is reduced to calculating a correlation function of characteristic polynom ials of large non $H$ erm itian $m$ atrioes. A closely related ob ject was calculated in Ref. ${ }^{1} 1 \overline{1}_{1}^{\prime}$, and we can adopt those $m$ ethods to our case. Let us brie y comment on a way of calculating the distribution Eq. (G) of the widths of the m ost narrow resonance in a given window. Instead of extracting such a quantity from the joint probability density Eq. (121) we

de ned for complex variables $z_{i}=r_{i} e^{i}$ inside the unit circle: $r_{i}=\dot{k}_{i} j \quad$ 1. For $0 \quad T \quad 1$ this formula has interpretation of the joint probability density of com plex eigenvalues $z_{i}$ for the ensem ble of $n \quad n$ subunitary $m$ atrices and is a very natural \circular" analogue of Eq. (121). . The sim ilarity is in no way a super cial one, but rather has deep roots in the theory of scattering ${ }^{1 / 7!}$. T he param eter $T$ controls the deviation of the corresponding $m$ atrices from unitarity, much in the sam $e$ way as the param eter
controls the deviation of $\mathrm{H}_{\mathrm{N}}$ from Hem iticity. M ore precisely, $T$ should be associated $w$ ith the renorm alised coupling constant $g$ via the relation $g=2=T \quad 1$. In the $\lim$ it $\mathrm{n} \quad 1$ the eigenvalues $\mathrm{z}_{\mathrm{k}}$ are situated in a narrow
vicinity of the unit circle. Their statistics is show $n^{-11^{171}}$ to be indistinguishable from that of the com plex eigenenergies E , when the latter considered locally, i.e. on the distances com parable $w$ ith the $m$ ean spacing. In particular, the distances 1 rif from the unit circle should be interpreted as the widths of the resonances.

The form of Eq. (1-5) allow s one to integrate out the phases $i$ by noticing that:

In conclusion, we presented a detailed analytical and num erical investigation of statistics of resonances and associated bi- orthogonal eigenfunctions in a random m atrix $m$ odel of single channel chaotic scattering $w$ th broken tim e-reversal invariance. Am ong challenging problem s deserving future research we w ould like to $m$ ention extending our results to the case ofm ore than one channel and to tim e-reversal invariant system $\mathrm{s}^{181}-$, as well as the problem of understanding uctuations of the nonorthogonality overlap $m$ atrix $\mathrm{O}_{\mathrm{m}} \mathrm{n}$.
