On the statistics of resonances and non-orthogonal eigenfunctions in a model for single-channel chaotic scattering

We describe analytical and numerical results on the statistical properties of complex eigenvalues and the corresponding non-orthogonal eigenvectors for non-Hermitian random matrices modeling one-channel quantum-chaotic scattering in systems with broken time-reversal invariance.

The statistical properties of non-orthogonal eigenvectors of large non-selfad joint random matrices have recently been characterised in Refs. 1,2,3,4,5.

Correlations of non-orthogonal eigenvectors are expected to determ ine dynam ical properties of classical random systems described by non-selfad joint operators, such as Fokker-Planck operators for example; they also play an important role in quantum systems: in Ref. 3 it was observed that the statistics of non-orthogonal eigenvectors determines the properties of random lasing media. This has led to an increased interest in eigenvector statistics in non-selfad joint random matrix ensembles (see also Ref. 7).

In a model for quantum -chaotic scattering, the com plex eigenvalues E_k ; k = 1; ...; N of a random N non-Hermitian matrix (the so-called \e ective Hamiltonian") $H_N = \hat{H}$ î are used to describe generic statistical properties of resonances in quantum chaotic scattering (see Ref. 8 and references therein): for system s with broken time-reversal invariance (anti-unitary sym m etry), the m atrices H are random N ces from the Gaussian Unitary Ensemble⁹ with joint probability density P (H) dH $/ \exp[(N=2)TrH^2]dH$. In the lim it of large N , the mean eigenvalue density $(\!E\!$) for such matrices is given by the sem icircular law $(E) = (2)^{1} \overline{4} \overline{E^2}$ for $E \neq 2$ (and zero otherwise). The corresponding mean spacing between neigbouring eigenvalues around the point E in the spectrum is given by $(E) = 1 = [N \quad (E)]$.

The Hermitian matrices H describe the energy-level statistics of the closed counterpart of the scattering system; the Herm itian N N matrix > 0 m odels the coupling of the system to scattering continua via M = 1;2; ::: open channels. It has rank M N . For our purposes it can be chosen diagonal: $\hat{}$ = diag($_1$; $_2$; ...; $_M$; 0; ...; 0). The constants 0 < $_{\rm c}$ < 1 param etrise the strength of the coupling to the scattering continua via a given channelc = 1; :::;M . Here c = 0 corresponds to a closed channel c_r and $c_c = 1$ describes the so-called perfectly coupled channel. Empirical situations correspond to the regime of large N, with M xed and M N . Then the widths $k = 2 \text{ Im } E_k$ are of the same order 1=N as the mean spacing (E) between the positions of the neighbouring resonances along the real energy axis. In this regime, the resonances may partly or considerably overlap and rst-orderperturbation theory valid for small resonance overlaps breaks down. Similarly, self-consistent perturbation schemes 1,2,5,6 assuming many channels and strongly overlapping resonances are inapplicable.

A detailed analytical understanding of the statistical properties of the resonances in the regin e of partial overlap has recently been achieved for the case of systems with broken time reversal invariance 8,10 . These results, based on the random matrix approach, are expected to be applicable to a broad class of quantum—chaotic systems. Indeed, the distribution of the widths $_{\rm k}$ derived in Ref. 8 is in good agreement with available numerical data for quite diverse models of quantum chaotic scattering 11,12 .

M uch less is known on properties of non-orthogonal eigenvectors. Let $\Re_k i$ and hL_k jdenote the right and the left eigenvectors of the matrix \hat{H} corresponding to the eigenvalue E_k E_k $iY_k = E_k$ $i_k = 2$,

where the symbols y and stand for Herm itian conjugation and complex conjugation, respectively. Except for a set of measure zero, the eigenvalues are nondegenerate. In this case the eigenvectors form a complete, bi-orthogonal set. They can be normalised to satisfy $hL_k R_1 i = k_1$. The most natural way to characterise the non-orthogonality of eigenvectors is to consider statistics of the overlap matrix $0_{k1} = hL_k L_1 ihR_1 R_k i$. This matrix features in two-point correlation functions in non-Herm itian systems, e.g. in description of the particle escape from the scattering region (\norm leakage", see Ref. 13).

Following Ref. 1, consider two correlation functions: a diagonal one

Here h $_{\rm H\ N}$ stands for an ensemble average over H $_{\rm N}$. The correlation functions (2,3) characterise the average

non-orthogonality of eigenvectors corresponding to resonances whose positions in the complex plane are close to the complex energies E, and E_1 ; E_2 . Here (E) stands for a two-dimensional function of the complex variable E.

In the context of lasing media, the diagonal correlator (2) characterises average excess noise factors (P eterm ann factors), and the o -diagonal correlator (3) describes average cross correlations between them alor quantum noise em itted into dierent eigenmodes 4 . Note that for any ensemble with orthogonal eigenvectors and complex eigenvalues E (for normal matrices), O(E) is equal to the mean density of complex eigenvalues, and the odiagonal correlator vanishes: O(E₁;E₂) 0.

Both diagonal and o -diagonal eigenvector correlators were introduced and calculated for the case of G in ibre's ensemble of non-Hermitian matrices in Ref. 1. For the ensemble H N pertinent to chaotic scattering, both types of eigenvector correlators were found recently for the regim e of very strongly overlapping resonances when widths typically much exceed the mean separation^{2,5}. Physically this regime corresponds to a situation where the scattering system is coupled to the continuum via a large 1 of open channels8. In this case the num ber M self-consistent Born approximation is adequate 1,2,5,6, a perturbative approximation valid in the limit of large N, large M , and ${\rm E}_1$ $E_2 j \in 0$, provided $E_1 ; E_2$ are well inside the support of the spectrum. A non-perturbative expression for the diagonal correlator O (z) valid for any number of open channels was obtained in Ref. 3 by em ploying a heuristic analytic continuation procedure. For the case of the resonance widths, this heuristic scheme is known to reproduce the exact expression⁸. It is thus natural to expect that this procedure is adequate in the case of eigenvector statistics, too, although this remains to be proven.

No non-perturbative results for the o -diagonal eigenvalue correlator O $(E_1;E_2)$ have so far been reported, to the best of our know ledge.

In the present paper we provide exact non-perturbative expressions for both diagonal and o -diagonal eigenvector correlators valid for the case of a system with broken time-reversal invariance (anti-unitary symmetry) coupled to continuum via a single open channel (M = 1) with coupling strength . The single-channel case describes pure resonant chaotic rejection. This case is more amenable to analytical treatment than a general case (M > 1), combining both rejection and transmission phenomena. Understanding the single-channel case should be considered as a useful step towards a more complete picture 15 .

Our result for the diagonal correlator is

where E = E iY, (E); = (E) and g = (+ 1) = (2) is the elective (renormalised) coupling strength. The result for O(E) agrees with one




FIG.1: Numerical () and analytical results (solid line) for (a) d(E) and O (E) as a function of Y for N = 32, and = 0.9; (b) $\ln(L_x;L_y)$ i and $O_1(L_x;L_y)$ for N = 32, L_x = 0.1, and = 0.9; (c) $O_2(L_x;L_y)$ for N = 32, L_x = 0.1, and = 0.9.

reported in Ref. 3 con m ing the validity of the analytical continuation scheme used there. For the sake of comparison we present here also the expression for the single-channel resonance density de ned as $d(E) = N^{-1}$ (E E) and given by E:

We have compared these analytical expressions, valid in the lim it N $\,!\,$ 1 , with direct numerical diagonalisations of nite-dimensional matrices H_N , see Fig. 1(a). This is of interest since empirically, the ensemble average h_{-H_N} is usually replaced by an energy average over several spectral windows, each of which may typically contain of the order of 10 or 100 resonances, corresponding to a nite value of N . We observe that the analytical results describe the numerical data well, except for small deviations at large values of Y . Numerically it is easier to compute smoothed averages, such as the mean number of eigenvalues $\ln(L_x\,;L_y)$ i inside a rectangular domain

in the complex plane. This quantity can be obtained from the mean density d(E) by integration over A. Similarly




FIG. 2: Numerical () and analytical results (solid line) for the distribution of the narrowest resonance for = 2, and = 0.1, W = 0.2, and N = 128. Here x = gn = .

one can de ne the function O_1 (L_x ; L_y) as the integral of the diagonal correlator O (E_p) over the same domain, obtaining O_1 (L_x ; L_y) = hN 1 $_{E_k \, 2\, A}$ O_{kk} i. Numerical versus analytical results for these two quantities are plotted in Fig. 1 (b).

For the o -diagonal correlator $O(E_1; E_2)$ we obtain

where $R \in E_{1;2} = E_{1;2} = E$ and it is assumed that . We have also calculated the corresponding sm oothed average $O_2(L_x;L_y) = hN^{-1}$ $E_m \in E_{n,2}A \cap n$ i, by integrating E_1 and E_2 in (7) over the domain A. In Fig. 1 (c) we compare this result (valid in the lim it of N + 1) with those of numerical diagonalisations of -1 nite matrices; the agreement is good already for N = 32.

We have also found a way to calculate exactly the distribution f () of the width of the most narrow resonance among those falling in a window $\mathbb{E} = \mathbb{W} = 2$; $\mathbb{E} + \mathbb{W} = 2$] in the vicinity of a given point \mathbb{E} in the spectrum. A ssuming that the mean number $n = \mathbb{W} = 0$ of resonances is large (n 1), but still \mathbb{W} 1 to preserve spectral locality (the density of states should not change signicantly across the spectral window):

This distribution is of great interest in the theory of random lasing³. The functional form of the distribution was found in Ref. 3 by employing plausible qualitative arguments yielding Eq. (8), but with renormalised elective coupling greplaced by its \weak coupling" limit = 2. We see that the difference with exact formula amounts to the factor 2 in the exponent for the case of perfect coupling = 1. In Fig. 2, the result (8) is compared to results of numerical diagonalisations for N = 128 and W = 0.2, corresponding to n 8:15.

In the rem ainder of this article, we outline the derivation of the results (4), (7), (8). The main idea is to use that fact that the complex eigenvalues (resonances) E_k

are poles of the M M scattering matrix \hat{S} (E) in the complex energy plane. Using the standard expression for the scattering matrix in terms of the non-Hermitian Hamiltonian H $_{\rm N}$ (see e.g. Ref. 8) the residues corresponding to these poles can be found and after some algebraic manipulations we arrive at the following relation:

This relation is valid for arbitrary M , but for M > 1 it appears to be of no obvious utility, due to diculties in evaluating the ensemble average of the trace of the residues on the left-hand side. However for the case of one single open channel the scattering matrix can be written as

which follows, up to an irrelevant \non-resonant" phase factor, from the requirement of S matrix analyticity in the upper half-plane and unitarity for real energies. Substituting Eq. (10) into Eq. (9) yields the relation:

expressing the eigenvector overlap matrix in terms of complex eigenvalues $E_k^{\ 16}$. This gives a possibility to nd the diagonal and o -diagonal correlators, Eqs. (2,3), by averaging $O_{m\ n}$ over known joint probability density of complex eigenvalues for the single-channel scattering system:

U sing this expression one may notice that

where H_N 1 stands for the non-Herm itian matrix H of the same type as H_N but of the lesser size (N 1) (N 1), and with coupling replaced by a modiled coupling $\gamma = -1$ Im E.A nalogously

where $\mathrm{H}^*_{\mathrm{N}}$ 2 is of the size (N 2) (N 2), and with coupling replaced by a modi ed coupling $\gamma=$ Im E_1 Im E_2 .

In this way the problem is reduced to calculating a correlation function of characteristic polynom ials of large non-H erm itian matrices. A closely related object was calculated in Ref. 10, and we can adopt those methods to our case. The scaling lim it N = 1 such that Im $E_{1;2} = 1;2$ = Re(E_1 = E_2) / N E_1 0 of the resulting expressions yields the form ulas Eqs. (4)-(7) above.

Let us brie y comment on a way of calculating the distribution Eq. (8) of the widths of the most narrow resonance in a given window. Instead of extracting such a quantity from the joint probability density Eq. (12) we not it more convenient to consider

de ned for com plex variables $z_i=r_ie^i$ inside the unit circle: $r_i=jz_ij-1$. For 0-T-1 this formula has interpretation of the joint probability density of com plex eigenvalues z_i for the ensemble of n-n subunitary matrices and is a very natural \circular" analogue of Eq. (12). The similarity is in noway a super-cial one, but rather has deep roots in the theory of scattering 17 . The parameter T controls the deviation of the corresponding matrices from unitarity, much in the same way as the parameter

controls the deviation of H $_{\rm N}$ from H erm iticity. M ore precisely, T should be associated with the renormalised coupling constant g via the relation g = 2=T 1. In the lim it n 1 the eigenvalues z_k are situated in a narrow

vicinity of the unit circle. Their statistics is show n^{17} to be indistinguishable from that of the complex eigenenergies E, when the latter considered locally, i.e. on the distances comparable with the mean spacing . In particular, the distances 1 $\,$ rg from the unit circle should be interpreted as the widths of the resonances.

The form of Eq. (15) allows one to integrate out the phases $_{\rm i}$ by noticing that:

where the sum mation goes over all possible permutations f g = (1; :::; n) of the set 1; :::; n (in fact in the right-hand side we dealwith the object known as \perm anent", see e.g. Ref. 19). In this way we arrive at a joint probability density of the radial coordinates only, and the distribution Eq. (8) follows after a number of integrations and the limiting procedure n 1.

In conclusion, we presented a detailed analytical and num erical investigation of statistics of resonances and associated bi-orthogonal eigenfunctions in a random matrix model of single channel chaotic scattering with broken time-reversal invariance. Among challenging problems deserving future research we would like to mention extending our results to the case of more than one channel and to time-reversal invariant system s^{18} , as well as the problem of understanding uctuations of the nonorthogonality overlap matrix 0 $_{\rm m}$ n .
