# Square{lattice $s = \frac{1}{2} \times Y$ m odel and the Jordan {W igner ferm ions: The ground{state and therm odynam ic properties

#### A bstract

U sing the 2D Jordan {W igner transform ation we reform ulate the square{lattice  $s=\frac{1}{2}$  X Y (X Z) model in term s of noninteracting spin less ferm ions and exam ine the ground{state and them odynam ic properties of this spin system. We consider the model with two types of anisotropy: the spatial anisotropy interpolating between 2D and 1D lattices and the anisotropy of the exchange interaction interpolating between isotropic X Y and Ising interactions. We compare the obtained (approximate) results with exact ones (1D limit, square{ lattice Ising model) and other approximate ones (linear spin{wave theory and exact diagonalization data for nite lattices of up to N = 36 sites supplemented by nite{size scaling}. We discuss the ground{state and thermodynamic properties in dependence on the spatial and exchange interaction anisotropies. We pay special attention to the quantum phase transition driven by the exchange interaction anisotropy as well as to the appearance/disappearance of the zero{tem perature magnetization in the quasi{1D limit.}

#### 1 Introduction

The  $s = \frac{1}{2}$  Heisenberg model on a square lattice is the well known basic model in the quantum theory of magnetism which became especially attractive after the discovery of high (tem perature superconductors [1, 2]. Much more m aterials which can be viewed as realizations of the 2D  $s = \frac{1}{2}$  Heisenberg model are known at present time. Many analytical and num erical studies analyzing therm odynam ics, spin correlations and their dynam ics for the 2D  $s = \frac{1}{2}$ Heisenberg model were performed during the last fiteen years. One of the (approximate) analytical approaches is based on the 2D Jordan (Wigner fermionization. An extension of the 1D Jordan (Wigner transform ation for higher dimensions was suggested in the late 80s [3] (see also [4, 5, 6]). Such kind of approximate treatment was applied to the square (lattice quantum spin models in several papers [3, 4, 5, 7] (for a brief review see [8]). Recently, the 2D Jordan (Wigner mapping has been used for the calculation of the magnetization curves of several 2D spin system s [9]. The reported studies [3, 4, 5, 7, 9] deal with the  $s = \frac{1}{2}$  isotropic H eisenberg or the  $s = \frac{1}{2}$  isotropic X Y m odels and the e ects of anisotropic X Y exchange interaction were not considered. A nother intriguing problem in the theory of magnetism is the in vence of the spatial anisotropy on the properties of quantum spin models between the limiting cases of a system of noninteracting chains and of a spatially isotropic 2D system. The issue of disappearing of long { range order in 1D lim it although discussed by several authors (see, for exam ple, the papers [10, 11, 12, 13] on the crossover from one to two dimensions for the  $s = \frac{1}{2}$  Heisenberg model) remains ambiguous. In this paper we consider the  $s = \frac{1}{2}$  anisotropic X Y model on a spatially anisotropic square lattice using the 2D Jordan (Wigner ferm ionization approach in order 1) to exam ine the elects of exchange interaction anisotropy and the e ects of spatial anisotropy on the ground (state and therm odynam ic properties of the spin model and 2) to gain an understanding how well this technique works comparing the approximate results with the exact ones (1D lim it, the Onsager solution for the square{lattice Ising model). To exam ine the quality of the 2D Jordan (Wigner ferm ionization scheme in the cases for which exact results are not available we perform linear spin {wave theory calculations and nite(size scaling analysis of exact diagonalization data. The 2D Jordan(Wigner ferm ionization m ay be used for a study of the dynam ic properties of 2D quantum spin system s [14] and a rst test of this approach for calculating the static quantities is strongly desirable.

There has been a great deal of theoretical work on the 2D  $s = \frac{1}{2}$  X Y model [15, 16, 17, 18, 19, 20, 21, 22, 23, 24, 25, 26]. We use the results reported in these papers in our study for comparison in due course. Thus, in Ref. [17] it was shown how the spin {wave theory can be applied to the quantum X Y H am iltonians. A lready the very early studies on square{lattice  $s = \frac{1}{2}$  isotropic X Y model indicated the long{range order in the ground state.

Later the existence of long{range order in the ground state of quantum X Y m odel on a hypercubic lattice in two and higher dimensions was proved rigorously [18]. The exact diagonalization study for the isotropic X Y m odel on nite square lattices of up to 6 6 sites supplemented by nite{size scaling was reported in Ref. [21]. The high precision quantum M onte C arlo results presented in Ref. [22] concern with both the properties at zero and nonzero temperatures. The zero{temperature properties of the square{lattice  $s = \frac{1}{2}$  anisotropic X Y model were studied via spin{wave theory and via series expansions around the Ising limit [23]. The papers [24, 25] contain the zero{temperature results of the coupled cluster method and the correlated basis function method applied on the square{lattice  $s = \frac{1}{2}$  anisotropic X Y model, respectively. The Green's{function approach was used for the calculation of the temperature dependences of the susceptibilities and species heat of the square{lattice  $s = \frac{1}{2}$  isotropic X Y model in Ref. [26]. It should be remarked that the mentioned studies refer to the spatially isotropic lattices.

This paper is organized as follows. In Section 2 we present the conventional linear spin {wave theory for the square{lattice  $s = \frac{1}{2}$  X Y model. This consideration is a straightforward generalization of Ref. [17] for the anisotropic case and is given here for easy references. In Section 3 we present the 2D Jordan {Wigner fermionization treatment of the X Y and X Z Hamiltonians. The results derived in this Section are parallel to those obtained on the basis of the spin {wave theory and resemble strongly some outcomes of the coupled cluster method and the correlated basis function method [24, 25]. In Section 4 we present the nite{size scaling analysis of the exact diagonalization data. In Section 5 we discuss the elects of anisotropies on the ground{state and thermodynamic properties of the square{lattice  $s = \frac{1}{2}$  X Y model. We compare the results of different approaches focusing on the validity of the approximate treatment based on the 2D Jordan {Wigner fermionization. Finally, we summarize our notings in Section 6. Some preliminary results of this study were announced in the conference papers [27].

## 2 The model. Linear spin {wave theory

We consider a model consisting of N = N<sub>x</sub>N<sub>y</sub> (N<sub>x</sub> = N<sub>y</sub> =  $\frac{p}{N}$ ! 1) spins  $\frac{1}{2}$  on a spatially anisotropic square lattice governed by the anisotropic X Y H am iltonian

Here J and  $J_2$  (= RJ) are the exchange interaction strengths between neighbouring sites in a row (horizontal direction) and a column (vertical direction), respectively, and the parameter controls the anisotropy of exchange interaction. Since the considered lattice is a bipartite one, the cases of ferrom agnetic and antiferrom agnetic signs of exchange interactions are related to each other by a simple spin rotation. Therefore, in what follows we assume without loss of generality the ferrom agnetic sign of the exchange interactions J and  $J_2$ , i.e.,  $J_iJ_2 < 0$ . We can recover the 1D limit putting either  $J_2 = 0$  or J = 0 arriving at a system of independent chains running in horizontal or vertical direction, respectively. The case  $J_1$  corresponds to the isotropic XY interaction, whereas the case  $J_2$  (or  $J_1$ ) corresponds to the Ising interaction. We are interested in the ground (state and them odynam is properties of spin model (2.1).

We begin with the linear spin {wave theory following the scheme developed in [17]. The conventional spin { wave analysis starts from a ferrom agnetic state fully polarized in z direction [28]. We have to deal with the X Z model rather than the X Y model. The former Ham iltonian arises from the latter one after the unitary transformation  $s^x$ !  $s^z$ ,  $s^y$ !  $s^x$ ,  $s^z$ !  $s^y$ , and hence exhibits the same thermodynamics. (Evidently, within approximate approaches in which the x, y spin components are treated dierently than the z spin components we may expect dierent results for the X Y and X Z models.) The performed rotation is also employed within the coupled cluster method [24] or correlated basis function method [25] applied to the quantum X Y model (but not for exact diagonalization computations). Thus, we consider

Let us note that the approximate treatment which starts from Eq. (2.3) has destroyed the symmetry with respect to the change to . Moreover, the consideration is valid only for 0 otherwise there exist such values of k at which the rhs. of (2.7) for tanh  $(2u_k)$  exceeds 1. Evidently, while getting (2.3) we have presumed the long range order in z direction in the spin space and this assumption becomes wrong if < 0.

## 3 2D Jordan (Wigner fermions: XY vs. XZ

An alternative approach to calculate the therm odynam ic quantities of the square{lattice  $s = \frac{1}{2} \times Y$  m odel consists in the 2D Jordan (W igner transform ation reform ulating the problem in ferm ionic language. First we introduce the annihilation and creation operators of spinless ferm ions

We adopt a mean {eld treatment of the phase factors which have appeared in the Hamiltonian (32) replacing the ferm ion occupation {number operators by their average value  $\frac{1}{2}$  and using the same gauge as in Ref. [4] (see also Refs. [3,8]). As a result we arrive at

This is the only approximate step made to derive the thermodynamic quantities of the spin model (2.1) within the 2D Jordan (Wigner fermionization approach. Further consideration requires no approximations. Next we perform the Fourier transformation

Note, that the symmetry with respect to the change to inherent in the original spin model is present in the fermionic description (3.7), (3.6).$ 

We cannot calculate the magnetization m  $^{x}$  (or m  $^{y}$ ) by averaging  $s_{i,j}^{x}$  (or  $s_{i,j}^{y}$ ) because of the invariance of the Ham iltonian (2.1) when all  $s_{i,j}^{x}$ !  $s_{i,j}^{x}$  (or all  $s_{i,j}^{y}$ !  $s_{i,j}^{y}$ ); this symmetry remains in the approximate treatment as well. m  $^{x}$  (orm  $^{y}$ ) can be obtained as a square root of the two (site correlation function of x (or y) spin components taken at sites which are at in nitely large distance. However, to our best knowledge such correlation functions have not been examined within the 2D Jordan (Wigner fermionization approach up till now.

In the second part of this Section we consider the X Z rather than the X Y Ham iltonian. We start from the Ham iltonian (22). Making use of the transformation (3.1) and adopting the mean (eld treatment of phase factors as used already for obtaining (3.3) we get the following Ham iltonian of interacting spinless fermions on a square lattice

i.e., (ferrom agnetic) long{range order (the existence of which in two dimensions is proved rigorously for = 0 at zero temperature or for = 1 at nonzero temperature) is imposed. The order parameter is  $m = m^z$  and its nonzero value m ay be expected for positive. For negative one m ay apply the unitary transformation  $s^x$ !  $s^z$ ,  $s^y$ !  $s^y$ ,  $s^z$ !  $s^x$  coming back to the m odel w ith positive. As can be seen from (3.18), (3.19), (3.16), (3.15) the sym metry with respect to the change to inherent in the spin model (2.2) is destroyed in the elaborated form ulas. Evidently, the derived results for the X Z H am iltonian in the lim it = 1 coincide with the results for the X Y H am iltonian with = 1 presented in the rst part of this Section.

It can be easily observed that in the lim it = 1 the described 2D Jordan {W igner ferm ionization approach for the square{lattice  $s = \frac{1}{2} \times Z$  model yields the mean {eld theory of the square{lattice Ising model. Really, Eq.

(3.12) for = 1 (in this case the ferm ionic representation (3.12) becomes exact since the Ising interaction of z spin components does not involve the phase factors) after decoupling (3.13) becomes

To close this Section let us note, that a m ore sophisticated treatment (i.e., a m ore complicated decoupling of the lhs. of (3.13)) of the H am iltonian (3.12) is possible (see Ref. [8] for a review of analogous studies for the isotropic H eisenberg model). However, we found that this more complicated approximation seems to be less adequate to describe the properties of the spin system.

## 4 Finite (size scaling analysis of the exact diagonalization data

In this Section we present the results of the exact diagonalization computations of the ground (state energy and the ground (state magnetization for the  $s=\frac{1}{2}$  isotropic (i.e., =0) X Y model on small spatially anisotropic (i.e., 0 R 1) lattices with periodic boundary conditions. To extrapolate the exact diagonalization data with periodic boundary conditions for 0 R 1 we use the scaling law

which contains two unknown parameters  $e_0$  (1 ) and and yields correct asymptotics in 1D and 2D limits. The same scaling law was used in [12] to extrapolate the exact diagonalization data for spatially anisotropic 2D  $s = \frac{1}{2}$  Heisenberg model. A nother scaling law which also yields correct asymptotics in 1D and 2D limits and therefore may be assumed to extrapolate the exact diagonalization data for 0 R 1,

contains three param eters  $e_0$  (1 ),  $e_2$ ,  $e_3$  to be determined from the exact diagonalization data. Bearing in m ind the 2D (to (1D crossover we should note, that the available data for  $e_3$ ) = 16; 36 square lattices cannot be completed by data for  $e_4$ ) = 25 square lattice since the latter lattice for  $e_4$ ) 0 transforms into chains of odd number of sites and the data essentially dier from those for chains of even numbers of sites. The exact diagonalization data for  $e_4$ 0 are far beyond the available computer resources. On the other hand, the lattices of  $e_4$ 0 split into 2, 3, 4 chains of 4, 6, 8 sites and the shape elects become more pronounced.

The simplest assumption for extrapolation of the exact diagonalization data for  $m^{\times 2}$  (L) for R = 1, = 0 (see, for example, [22, 31]) is as follows

We use the nite{size scaling (4.5) to extrapolate the numerical data for N = 16; 36 and for N = 8; 18; 32 lattices for 0 = 1. The nite{size scaling analysis of the available data yields incorrect prediction  $m^{\times 2}(1) < 0$  in quasi{1D limit starting from R in between 0.03 and 0.05 (see Section 5 below) that may serve as indication of a disappearance of the long{range order in 1D limit.

From [32] we know that in the 1D case R = 0,  $= 0 \times (or y)$  magnetization vanishes as

The  $\frac{1}{L}$  scaling which appears in (4.7) and (4.8) as R ! 0 (as well as in (4.6) for R = 0) when applied to accessible small systems works poorly probably because L is still too small.

To sum marize, using the data for N = 16; 36 and N = 8; 18; 32 clusters and scaling laws (4.3) and (4.5) we not e<sub>0</sub> (1) and m x<sup>2</sup> (1) (and the order parameter m =  $\frac{p}{m^{\times 2} + m^{\circ y^2}} = \frac{p}{2m^{\times 2}}$ ). We use these indings for the discussion in the next Section. Let us also remark, that the presented discourse refers to the case = 0, whereas the case of an isotropic exchange interaction  $\frac{1}{2}$ 0 was not considered.

## 5 E ects of the spatial and exchange interaction an isotropies

In this Section we discuss the results for the ground {state energy, the order parameter and the specie cheat obtained by the dierent methods illustrated in Sections 2, 3, 4. We also compare the approximate and exact results when available.

In Fig. 1 we show the ground{state energy of the square{lattice  $s=\frac{1}{2}$  X Y model obtained within various approaches in comparison with some exact results (the 1D limit and the Ising limit). As can be seen from Eq. (3.9), (3.6) the Jordan{W igner fermions for the X Y model (short{dashed curves) recover the 1D limit (R=0, R=1). In the other limit of the Ising model (=1) this approach fails (obviously except the 1D limit R=0, R=1). The Jordan{W igner fermions for X Z model (long{dashed curves) correctly reproduce the dependence  $e_0$  vs. R=1 but not the exact results for R=0. We also show the dependence  $e_0$  vs. obtained within the latter approximation (thin long{dashed curves with cusps) to demonstrate explicitly a difference in the outcomes as changes its sign. It should be remarked that the linear spin{w ave theory predictions for the ground{state energy (2.9) (dotted curves) are in a satisfactory agreement with the exact results for R=0 (except small),

coincide with the exact result for = 1 and are in a good agreement with the exact diagonalization data for = 0 (full squares).

The XZ model within the ferm ionic picture exhibits in {plane magnetization introduced by decoupling (3.13), which is determined self(consistently by Eq. (3.19). Fig. 2 shows the resulting dependence of the ground(state m agnetization m<sup>z</sup> (long{dashed curves) on for R = 1 (curves 3), R = 0.5 (curves 2), and R = 0 (curves 1). The value of  $m^z$  for R = 1 overestim at es the exact diagonalization result at = 0 (full square). Moreover, the m agnetization does not disappear in 1D limit at = 0 that contradicts the rigorous statem ent and indicates the incorrect treatm ent of strong quantum uctuations in one dim ension. The exact zero (tem perature relation between in {plane m agnetization and exchange an isotropy parameter in 1D reads m =  $\frac{1}{2}$  1  $\frac{1}{1+}$ 1 in Fig. 2). The linear spin (wave theory results (2.10) (dotted curves) are valid only for 0 as was explained in Section 2. (Therefore, within the frames of the linear spin {wave theory we cannot trace the behaviour of m z (for example, for R = 1) when decreasing to negative values.) Contrary to the ferm ionic description the linear spin {wave theory predicts smaller values of m<sup>2</sup> at = 0 in a good agreem ent with the exact diagonalization data (see the upper inset in Fig. 2). The linear spin  $\{w \text{ ave theory value of } m^z \text{ for } = 0 \text{ decreases as } R \text{ decreases and } m^z \text{ for } = 0 \text{ decreases}$ nally becomes zero at a certain small but nonzero value of R. If R! 0 the value of  $m^z$  for = 0 tends to 1 which is a manifestation of the inapplicability of the linear spin (wave theory in the 1D lim it (see the lower inset in Fig. 2 where the spin {wave theory result for R = 0 is shown).

Let us consider the dependence of the ground {state in {plane magnetization on as it issues from the ferm ionic picture in more detail. A ssume, for example, the spatially isotropic case R=1. From exact results for this model we know that for =1 the order parameter  $=\frac{1}{2}$  is directed along z axis, whereas for =+0 the order parameter is  $0 < m < \frac{1}{2}$  and it remains directed along z axis. If becomes negative (tending to 1) two possibilities are plausible: i) for in nitesimally small =0 the order parameter meturns to the x-axis and its value starts to increase (approaching  $\frac{1}{2}$  as  $\frac{1}{2}$  1); ii) the order parameter memains directed along z axis and its value decreases until a certain characteristic value of (negative)—at which meabruptly turns to x-axis and then its value starts to increase (approaching  $\frac{1}{2}$  as  $\frac{1}{2}$  1). The fermionization approach results give evidence in favour of the latter scenario. To illustrate this issue we show in Fig. 3 the ground {state energy (given by (3.18) as  $\frac{1}{2}$  1) for spatially isotropic (R=1) X Z model as a function of R=10 or R=11 and R=12 model as a function of R=12 or R=13. The probability of the deeper one) and at R=13 for R=14 (curve 2), two minima at R=15 and at R=15 or and at R=1

(curve 4), and one m in im um at m  $^z$  = 0 for  $_3$  < . (The curve m  $^z$  vs. in Fig. 2 jumps to zero value at =  $_3$ .) The proles plotted in the right panel represent the dependence of the ground (state energy for the same son the order parameter directed along x axis. From these plots we see that for < 0 the minimum in the dependence  $e_0$  vs. m  $^x$  is always deeper than the one in the dependence  $e_0$  vs. m  $^z$  and hence the x directed order parameter is favourable. However, while decreasing from positive values to negative ones the system may remain in the m etastable phase with the order parameter directed along z axis until achieves 3. This is a typical scenario of the rst{order quantum phase transition driven by the exchange interaction anisotropy . The corresponding region of metastability in the R {plane is shown in Fig. 4. The obtained issue can be compared with the predictions of other approaches. The linear spin (wave theory does not work if < 0 and thus cannot be used for this discussion. The coupled cluster method and the correlated basis function method similarly to the 2D Jordan ( W igner ferm ionization approach suggest an analogous behaviour of the ground (state energy [24, 25]. M oreover, the correlated basis function prediction for the value of = 0:36 associated with a phase transition for spatially isotropic square{lattice [25] is quite close to the estimate obtained by the fermionization approach  $_3 = 0.3528$ . An intriguing question naturally arises here: is the described scenario of a rst{order quantum phase transition inherent in the spin model or it is an artifact of the approximate approaches? This question, apparently, cannot be answered by the mentioned theories and more work is necessary to draw a de nite conclusion.

Next we pass to another interesting problem, that is, the appearance/disappearance of the long{range order at zero tem perature in quasi{1D lim it. It is known that there is no long{range order for the 1D (R = 0) isotropic ( = 0) X Y m odel and it does exist for the spatially isotropic 2D (R = 1) isotropic ( = 0) X Y m odel. If = 1 the order parameter takes its classical value  $m = \frac{1}{2}$  for all 0 R 1. Let us consider the dependence m vs. R which arises within dierent approaches. The prediction for the order parameter m z vs. R as it follows from the Jordan{W igner picture for the X Z m odel with = 0 is shown in Fig. 5 by long{dashed curve. The exact result m z = 0 for R = 0 is not reproduced. The result of the linear spin{w ave theory is shown in Fig. 5 by dotted curve. The linear spin{w ave theory does not work properly as R ! 0 yielding m z ! 1 . To m ake this explicit, we insert (2.7) into (2.10) and note that the integrand diverges at R = 0, = 0 around  $k_x = 0$ . We expand the integrand about small  $k_x$  to pick up the main contribution to the integral in the lim it R; ! 0. For = 0, R! 0 we get

For nite > 0 the order parameter m z is nite for all 0 R 1; if R = 0 the order parameter again has a logarithm ic divergence as ! 0, m  $z = \frac{1}{4^{9}} \ln z$  h nite term s; for nite R > 0 the order parameter m z is nite

1. The dotted curve in Fig. 5 for very small R reproduces the logarithm ic divergence for = 0 and the characteristic value of R at which m<sup>2</sup> becomes zero is about 7  $10^4$ . We also report the exact diagonalization data for the N = 36 lattice shown by empty squares in the main plot in Fig. 5 as well as the nite{size scaling (4.5) predictions from square and diamond shaped clusters shown by full squares and full diamonds, respectively. A coording to (4.5) m<sup>×</sup> (1)<sup>2</sup> becomes negative for R in between 0.03 and 0.04 (diamond shaped clusters) or in between 0.04 and 0.05 (square shaped clusters) (see, for example, two lower curves in the inset in Fig. 5 which refer to the square shaped clusters) that we may take as a criterion for disappearance of the long{range order as the spin system is becoming a collection of noninteracting chains.

We may summarize our indings as follows: for the spatially anisotropic  $2D = \frac{1}{2}$  isotropic (i.e., = 0) X Y (X Z) model the 2D Jordan (Wigner fermionization approach predicts long (range order for any 0 = R = 1, the linear spin (wave theory for  $R > R_c$  with  $R_c$  about  $7 = 10^4$ , the inite (size scaling data (4.5) for  $R > R_c$  with  $R_c$  in between 0.03 and 0.05. It should be remarked that the results of the performed analysis are qualitatively similar to what have been obtained for weakly coupled  $s = \frac{1}{2}$  isotropic Heisenberg chains [10, 11, 12] (see also a recent study for a 2D array of interacting two (leg  $s = \frac{1}{2}$  Heisenberg ladders [13]). Note, however, that the exact diagonalization data prediction for  $R_c$  for the X Y Ham iltonian is in between 0.03 and 0.05 whereas for the Heisenberg Ham iltonian  $R_c$  is essentially larger been in between 0.2 and 0.3 (see Fig. 2 of Ref. [12]). For both systems, i.e., the isotropic X Y model and the isotropic Heisenberg model the question about developing of the long (range order as the interchain interaction starts to increase is far from being settled and more delicate approaches are necessary to resolve this question.

Let us turn to the properties of the considered square{lattice  $s = \frac{1}{2}$  m odel at nonzero tem peratures. In Fig. 6 we show the tem perature dependence of the speci c heat for the X Y m odel (3.11) (short{dashed curves}) and X Z m odel (which follows from (3.18), (3.19)) (long{dashed curves}) in comparison with the exact results (solid curves) for R = 0 and the 0 nsager solutions (for R = 0) [3] as well as with the quantum M onte C arbo result for R = 0, R = 0] (open squares). Eq. (3.11) yields exact result in 1D limit. The noninteracting Jordan (Wigner fermions (3.7), (3.6) cannot reproduce the logarithmic singularity inherent in the spin model for R = 0 (however, recover the exact result as the square{lattice Ising model becomes a set of noninteracting Ising chains). The tem perature dependence of the speci c heat for X Z model as it follows from (3.18), (3.19) has a mean {eld character exhibiting an incorrect nite jump. A noticeable difference between the outcomes of the quantum M onte C arbo and 2D Jordan (Wigner fermionization approaches for R = 0, R = 1 is seen at low and intermediate temperatures. Recently the temperature dependence of the speci c heat for R = 0, R = 1 has been examined within the G reen's function approach [26].

The obtained temperature prole (Fig. 2 of that paper) although is in qualitative agreement with the quantum M onte Carlo data but exhibits a lower peak at a higher temperature.

In Fig. 7 we plot the tem perature dependence of the in{plane magnetization for spatially isotropic 2D (R = 1) X Z model derived within the 2D Jordan{W igner ferm ionization scheme (long{dashed curves) and the exact result for = 1 (solid curve). For R = 1, = 1 the approximate result based on the ferm ionization approach (long{dashed curve 3 in Fig. 7) is the mean{eld counterpart of the 0 nsager solution (solid curve 3 in Fig. 7). The approximate result for R = 1, = 0 (long{dashed curve 1 in Fig. 7) is incorrect since the Merm in{W agner theorem predicts m = 0 at any nite tem perature for the isotropic X Y model. For R = 0 the ferm ionization approach yields decreasing of R = 0 as tem perature increases and vanishing of R = 0 at a certain tem perature instead of the correct behaviour R = 0 for any nite tem perature.

#### 6 Summary

To sum marize, we have extended the 2D Jordan {W igner ferm ionization approach for the anisotropic square{lattice  $s = \frac{1}{2}$  X Y m odel. In our study of the ground {state properties we have concentrated on the elects of i) exchange interaction anisotropy and ii) spatial anisotropy. We have analyzed 1) the quantum phase transition driven by the exchange interaction anisotropy and 2) appearance/disappearance of the long{range order in quasi{1D limit. We have discussed these issues using different approaches: 2D Jordan {Wigner ferm ionization, linear spin {wave theory and exact diagonalization data supplemented by nite{size scaling. The study of the anisotropy driven changes extends the the earlier papers [24, 25] suggesting the rst{order quantum phase transition scenario. The study of the 2D {to{1D crossover constitutes the X Y counterpart of the problem intensively discussed within the context of the Heisenberg model ([12] and references therein). In our study of the temperature elects we have discussed to what extent the Jordan {Wigner ferm ions can reproduce the peculiarities of the special cheat for the square{lattice Ising and isotropic X Y models as well as the relation to the Merm in {Wigner theorem.}

We have found that the 2D Jordan {Wigner ferm ionization for the XY Ham iltonian works well in quasi{1D limit (especially as ! 0) for calculating both the ground {state and thermodynamic quantities. Being applied to the XZ Ham iltonian the 2D Jordan {Wigner ferm ionization gives the ground {state results similar to the linear spin {wave theory. Although both approaches reproduce the existing long {range order in two dimensions (and therefore work well as ! 1), they overestimate its elects and fail as R! 0. The temperature elects for the XZ model are poorly reproduced within the 2D Jordan {Wigner ferm ionization scheme.




Figure 1: The ground{state energy of the square{lattice  $s=\frac{1}{2}$  X Y (X Z) model: exact results (solid curves), nite{ size extrapolation (N = 16; 36) (full squares), linear spin{wave theory (dotted curves), ferm ionization approach for X Y model (short{dashed curves) and X Z model (long{dashed curves). Thin long{dashed curves with cusps in the right panels correspond to the dependence  $e_0$  vs. as it follows from (3.18), (3.19) in the limit ! 1 . The inset demonstrates size scaling (4.3) of the nite lattice data (N = 16; 36) for R = 129.8;0.6;0.4;0.2;0 (from bottom to top).




Figure 2: The zero{tem perature magnetization m  $^z$  vs. the exchange interaction anisotropy parameter—for square{lattice  $s=\frac{1}{2}$  X Z model (1: R = 0, 2: R = 0.5, 3: R = 1): exact result for R = 0 (solid curves), nite{size extrapolation result (N = 16; 36) for R = 1 (full square), linear spin{wave theory results (dotted curves) and ferm ionization approach results (long{dashed curves}). In the lower inset the spin{wave theory result for R = 0 becomes negative for less than 1:7 10  $^5$ .




Figure 3: The dependence of the ground{state energy of spatially isotropic (R = 1) s =  $\frac{1}{2}$  X Z model on the order parameter directed along z (left panel) or x (right panel) axis (obtained from (3.18) as ! 1 ) (1: = 0.2, 2: = 0.25, 3: = 0.33, 4: = 0.352).




Figure 4: Region of metastability for the square{lattice  $s = \frac{1}{2}$  X Z model as it follows from the ferm ionization approach. For all < 0 the stable phase has m z = 0, m z = 0. In the region A the phase with m z = 0 is still possible although not favourable (metastable phase), in region B the phase with m z = 0 can not exist. The solid curve which separates the regions A and B represents the dependence 3 vs. R (see explanation in the main text).




Figure 5: The order parameter for the square{lattice  $s = \frac{1}{2}$  isotropic (i.e., = 0) X Y (X Z) model as the spatial an isotropy parameter R varies from 0 to 1: exact diagonalization data for N = 36 square shaped clusters (empty squares in the main plot), exact diagonalization data completed by scaling (4.5) (square shaped clusters: full squares, diamond shaped clusters: full diamonds), linear spin (wave theory (dotted curve), ferm ionization approach (long{dashed curve}). The linear spin (wave theory result form becomes zero at R about 7 10  $^4$ . The inset demonstrates the size scaling (4.5) of square shaped clusters for R = 0.04;0.05;0.1;0.2;0.4;0.6;0.8;1 (from bottom to top; the curves for R = 0.8 and R = 1 coincide in the chosen scale).




Figure 6: The temperature dependence of the specic heat for the square{lattice  $s = \frac{1}{2} X Y$  (X Z) model: exact results (solid curves), quantum M onte C arlo result (open squares) [19], ferm ionization approach results for X Y model (short{dashed curves}) and for X Z model (long{dashed curves}). The left panels refer to the case = 0, the right panels refer to the case = 1. For R = 0 (two upper panels) the solid and short{dashed curves coincide.




Figure 7: The temperature dependence of the order parameter m  $^z$  for spatially isotropic (R = 1) s =  $\frac{1}{2}$  X Z model (1: = 0,2: = 0.5,3: = 1): exact (solid curve) and ferm ionization approach (long{dashed curves) results.
