Trap dom inated dynam ics of classical dim er m odels

We consider dynam ics of classical dimer models undergoing a phase transition to an ordered, frozen state. Relaxation processes are dominated by traps which are entropic in origin and can be traced to the locally jammed nature of the dimer states. Depending on the nature of the phase transition, critical dynam ics are characterized either by an exponential, or sub-exponential in time relaxation of the order parameter. In the latter case relaxation time scales diverge exponentially as the critical point is approached, following the Vogel-Fulcher law.

A variety of system s such as supercooled liquids, colloids, granular matter and foam s, exhibit a transition from a owing uid phase to a frozen solid phase. Jam ming due to spatial constraints in posed on the elem entary constituents of these materials has been proposed as a possible common cause of this dynamical arrest [1{3]. Model system s, such as hard spheres, have an important role to play in the investigation of such a scenario since they allow for a precise de nition of jamming [4]. They are also useful in elucidating the precise relationship between therm odynamics and dynamics in materials exhibiting a jammed phase [5].




FIG.1. (a) D in er covering of the honeycom b lattice with an elementary loop update indicated by the arrows. The num bers are the heights of the equivalent interface. (b) A n ordered, maxim ally jammed dimer covering; the equivalent interface is tilted with maximum slope.

D im er models are examples of jam med system swhich have the added advantage of being exactly solvable [6]. States of the dimerm odel are specied by placing dimers on the bonds of the lattice so that every site is covered by exactly one dimer; see Fig 1. These dimer coverings are \locally jammed" [4] as each dim er cannot move to an empty neighboring bond without violating the packing constraint. M oves that involve bops of dim ers and ad jacent em pty bonds, on the other hand, are allow ed. A n example of such a move for the hexagonal lattice involving an elementary plaquette is shown in Fig. 1a. (Stochastic dynam ics of the dim erm odel on the square lattice based on these elementary moves were considered by Henley [7].) Most states of the dim er model allow for elem entary moves; an example of one which does not is shown in Fig. 1b. The smallest change in this case involves a system spanning loop, and we call this state \m axim ally jammed". If we de ne an energy functional on the space of dim er coverings which favors the maximally jammed state, a transition into this state will occur as we lower the tem perature. The central question we address in this letter is: W hat happens to relaxation time scales of the dimer model as the transition to the maximally jammed state is approached? We will show that the relaxation is dom inated by entropy barriers and is sensitive to the therm odynam ics of the model near the phase transition point.

We consider two energy functionals. One leads to a Pokrovsky-Talapov type transition to the maximally jam m ed state [6]. The other exhibits a continuous transition to the sam e state along a m etastable line, and belongs to a di erent universality class. For both transitions we nd strong departures from the canonical critical-slowing-down scenarios [8] due to the presence of entropy barriers. Barriers can be traced directly to the non-local nature of the dynam ical moves allowed by the jammed states. For the transition that occurs along a m etastable line, tim e scales associated with critical uctuations diverge exponentially follow ing a VogelFulcherlike form. This is rem in iscent of what is observed in fragile glass form ers [9]. To our know ledge this is the rst example of a system with no quenched in disorder which exhibits this type of critical dynam ics.

a. D im er models W e consider the dim er model on the 2-d hexagonal lattice of linear size L, having $2L^2$ sites and $3L^2$ bonds, with periodic boundary conditions [10]. A useful representation of the dim er model is given by the height map which associates a discrete interface h (x;y) with every dim er covering [11]. The heights of the interface are de ned on the vertices of the dual triangular lattice. The height di erence between two nearest neighboring sites is -2 or +1 depending on whether the bond of the honeycom b lattice that separates them is occupied by a dim er or not; see F ig. 1a. D irections in which the height change is + are specied by orienting all the up pointing triangles of the dual lattice clockw ise.

The dim erm odel has an extensive entropy. The ensem -

ble of equal weighted dim er coverings maps to a rough surface with a gradient-square free energy [11]. Fluctuations of the surface are entropic in origin. A phase transition can be induced in the dim erm odelby including an energy functional which is minimized by a dim er covering corresponding to a smooth, maxim ally tilted surface which corresponds to the maxim ally jam med state shown in Fig. 1b. Here we discuss two such energy functionals.

For periodic boundary conditions the tilt vector, (xh; yh), where $x_{,y}h$ is the average height di erence in the x or y direction, has only one independent com ponent [12]. In term s of , the energy functionals can be written as:

is a dimensionless coupling that drives the transition. The entropy of the dimermodel as a function of was

calculated exactly [10,13]:

This function has a maximum at = 0 which is the equilibrium value at = 0. For nite the I model was previously considered in Ref. [14], while the K model was solved by Kasteleyn [10].

In the I m odel, with the free energy F = E S, and the energy and entropy given by Eqs. 1 and 2, there is an interesting phase transition along the m etastable line, when the order parameter is conned to the free energy well around the zero-tilt state. Namely, at $= = (8 \ 3)$ (the end-point of the m etastable line) the order parameter has a discontinuous jump from 0 to 1, characteristic of a rst-order transition. At the same time, as is approached from below, uctuations of around 0 diverge, as would be expected at a critical point. This transition was discussed in detail in Ref. [14].

By contrast, in the K model, there is a continuous variation of the equilibrium value of the order parameter, m in, with . On varying from 0 to the transition point = ln2, m in varies from 0 to 1. Apart from the shift of the free energy minimum, the uctuations also grow with increasing , and at the transition, the curvature of the free energy at its minimum goes to zero.

b. Coarse-grained dynamics Asmentioned in the introduction, the hard constraint of non-overlapping of dimers, gives rise to nonlocal dynamics. We consider Monte-Carlo dynamics based on loop updates with loops of arbitrary size; a concrete in plementation is given in Ref. [15]. Since we take periodic boundary conditions, loops with di erent winding numbers can be formed. We restrict loop updates to loops with winding numbers (0;0);(1;0) and (0;1), only. The microscopic transition rates for loop updates are given by Metropolis rules that follow from Eq.1. Given the microscopic loop dynamics, which satisfy conditions of ergodicity and detailed balance, we ask what are the coarse-grained dynamics of the order parameter, . Since the energy functions in Eq.1 depend on the global tilt only, it follows that all updates of topologically trivial loops (i.e. those with (0;0) winding number) have E = 0. Only when system spanning loops with nonzero winding numbers are updated does the energy of the state change [16]. This feature naturally leads to fast and slow processes in the M onte-C arb dynamics. On a faster time scale, non-winding loops are updated with no e ect on the overall tilt of the surface, while on a much slower time scale, winding loops are updated causing a change in the tilt of the surface.

The coarse-grained dynam ics of global tilt changes are described by a master equation, which features an unusual form for the transition rates between di erent tilt states. Nam ely, the rates of transitions from higher into lower tilt states are determined by the energy barrier alone:

here $_{\circ}$ is a constant. This follows from the observation that in order to lower the tilt and increase the energy an existing system spanning loop needs to be updated.

From detailed balance, W $_{1=L}$; =W ; $_{1=L}$ = exp[(F (1=L) F ())], we conclude that the rates of transitions to higher tilt states m ust be determ ined by the entropy:

Eq. 4 can also be argued from the following observation: to increase the tilt and lower the energy, a new system -spanning loop has to be accommodated by (typically) many rearrangements of the topologically trivial loops. Once a new system spanning loop is introduced, and a higher tilt state is reached, the entropy decreases. The form of the transition rates that we are arguing for here, was directly observed in numerical simulations of the three coloring model [17], which is a close relative of the dimermodel. The two are equivalent if, in the dimer models, a weight of 2 is attached to each loop form ed by bonds that are not covered by dimers.




FIG.2. (a) The time scales for relaxing out of di erent tilt states for the I and K models (scaled by L), for values of below the transition. (b) The tilt-tilt autocorrelation function for the two models. The full line is obtained from Eq.7 while the dashed line is a result of the saddle point evaluation of Eq.7. L was chosen to be 4096 (I) and 24 (K) to make the time scales comparable. Time is measured in units of $_{0}^{-1}$.

The rst consequence of the above form of the transition rates is that the time scale of relaxation out of a state with tilt , = $1=(W_{1=L}; + W_{+1=L};)$, is a non-decreasing function of . The exact expressions for

follow from Eqs.3 and 4, and they are plotted in Fig.2. For the I m odel the time scale increases m onotonically with [18], as in the hierarchical m odels of Palmer et al. [19], while in the K m odel an initial rise is followed by saturation beyond $_{\rm m \ in}$. Both are in sharp contrast with Langevin dynamics around the equilibrium state, for which the time to relax out of a given m acro-state decreases the further the order parameter is away from its equilibrium value. (For example, in the Ising m odel, with G lauber dynamics and in the disordered phase, the relaxation time out of a given m agnetization state decreases with increasing m agnetization.)

The exponential separation between di erent 's for all in the I m odel, and for $< m_{m in}$ in the K m odel, im plies that the dynamics are trap-like [20]. By this we

m ean that once the system decays out of state (in time) it quickly looses memory of where it came from.

To quantify the tilt dynam ics we compute the tilt-tilt autocorrelation function C (t), de ned as:

with the average taken over di erent histories of . A ssum ing trap-like dynam ics,

i.e., C (t) is an equilibrium weighted average of relaxations out of di erent states. Such an approximate m odel works very well when checked against num erical simulations of the three-coloring m odel [17].

The asymptotic decay of the autocorrelation functions obtained from Eq.7 can be extracted from a saddle point analysis of the sum and using a quadratic approximation for the entropy (Eq. 2). The autocorrelation functions obtained from the sum are compared to the saddle point solutions in Fig. 2b. The latter can be used to analyze the asymptotic form of C (t), and the dependence of the relaxation time scales on . In the limit of t! 1, and up to logarithm ic corrections in t, we nd:

showing that C (t) has an exponential decay in the K model, and a slower than exponential decay in the I model. From Eq.8 we also conclude that the relaxation times scale, , for the decay of C (t) to an arbitrary constant C_0 , diverges exponentially as ! for the I model. This is the Vogel-Fulcher type behavior observed in many fragile glass form ers. First order corrections to Eq.8 lead to an even more rapid increase of time scales, with = In diverging as Vogel-Fulcher. In the K model the corresponding time scales are exponential in (Arrhenius form) with no divergence at the transition point.




FIG.3. Barrier height, B () (dim ensionless) shown as a set of solid lines, and the quadratic approximation to the dim ensionless free energies of the I (dotted line) and K (dashed line) model; is chosen close to and L = 24. Note the logarithm ic scale for the barrier height.

The coarse grained dynamics de ned by the transition matrix elements, Eqs. 3 and 4, were argued to follow from the nonlocal loop dynam ics of the dim er m odels. From this form of the W -m atrix all the conclusions about critical dynam ics of the I and K model are derived. We have con med this picture in considerable detail in simulations of the three coloring model [21,22], which, as discussed earlier, is the loop weighted dimer model. The loop weights are not expected to a ect the qualitative features of the energy and entropy functionals. Indeed, the measured for the I and K cases of the three-coloring m odel com pare very well [21,22] to the analytical form plotted in Fig. 2. Sim ilarly, the tilt-tilt correlations show exponential decay in the K model [22] and sub-exponential decay in the I m odel [21,22] as expected from the analysis presented in this paper. The num erical evidence for Vogel-Fulcher type divergence of the relaxation time scale in the I model was reported previously [21].

The origin of the di erence in the dynam ical behavior of the I and K models can be traced back to the interplay between the free energy and the dynam ical barriers. The transition rates presented in Eqs. 3 and 4, can be interpreted in terms of a barrier B () = $e^{(S(-1=L)-S())}$ dividing the usual M etropolis rates de ned in terms of the free energy and leading to Langevin dynam ics [19]. These barriers increase exponentially with as illustrated in Fig. 3. D ynam ics of the order parameter can be view ed as relaxation in the free energy well in the presence of

these barriers (see Fig. 3).

In the I m odel the free-energy m inimum is centered at = 0 for all values of . The well gets shallower as is approached in plying that the system explores larger and larger barriers leading to a divergent relaxation time scale. In the K m odel, the m inimum itself shifts to larger values of and regions of increasing barrier heights ($_{m in}$ ' 1 in Fig. 3). The dynam ics is then com pletely dom inated by a single time scale determ ined by the barrier at $_{m in}$.

In conclusion, we have shown that classical dimermodels with loop dynamics are an interesting model system for studying glass-like dynamical arrest close to a critical point. Our analysis shows that the jammed nature of the dimer states plays a crucial role in determining the nature of relaxation processes. To quantify how this is rejected in the relaxation time scales we introduced an elective dynamical model based on the master equation for the order parameter. We expect that similar ideas can be carried over to the investigations of hard sphere system s which are of direct relevance to colloidal experiments [3].
