Low tem perature speci c heat of the heavy ferm ion superconductor PrO s<sub>4</sub>Sb<sub>12</sub>

We report the magnetic eld dependence of the low temperature specic heat of single crystals of the rst Pr-based heavy ferm ion superconductor PrO  $s_4\,Sb_{12}$ . The low temperature specic heat and the magnetic phase diagram inferred from specic heat, resistivity and magnetisation provide compelling evidence of a doublet ground state and hence superconductivity mediated by quadrupolar uctuations. This establishes PrO  $s_4\,Sb_{12}$  as a very strong contender of superconductive pairing that is neither electron-phonon nor magnetically mediated.

Superconductivity mediated by a pairing potential other than a conventional electron-phonon interaction has been the subject of a very large number of theoretical and experimental investigations over the decades. In recent years, nally, intermetallic compounds have been discovered which, together with the high- $T_{\rm c}$  cuprates, represent prime candidates for magnetically mediated pairing. Surprisingly, however, magnetically mediated pairing thus far has been considered the only serious alternative to electron-phonon mediated pairing, while excitonic and polaronic mechanisms have also been proposed.

We have recently reported the discovery of the rst Pr-based heavy ferm ion superconductor  $PrOs_4Sb_{12}$  [1], for which the nonmagnetic ground state appeared best described as a crystalline electric eld (CEF) doublet. This in turn suggested that the heavy electron liquid is of quadrupolar origin and that consequently quadrupolar uctuations mediate the superconductive pairing.  $PrOs_4Sb_{12}$  hence is a candidate for being the rst material in which neither electron-phonon normagnetic interactions mediate the pairing. However, a magnetic origin could not be completely ruled out [1] and recent low temperature specic heat measurements are reported to be consistent with a singlet CEF ground state hence questioning the hypothesis of quadrupolar pairing [2].

In order to settle the question of the ground state and thus the possibility of the rst example of quadrupolar mediated superconductive pairing dem ands de nitive establishem ent of (i) the CEF level scheme, (ii) the unconventional nature of the superconductivity, and (iii) coupling of the CEF excitations to the conduction electrons. Here we report specicheat measurements of high quality single crystals of PrOs $_4$ Sb $_{12}$  at low T and high magnetic eld. We show that the zero eld data of the single crystals and the magnetic phase diagram as established from the specicheat, resistivity and magnetisation, as well as the observation of a novel high eld ground state,

provide compelling evidence of a nonmagnetic doublet CEF ground state intimately linked to the conduction electrons. This unambiguously establishes quadrupolar uctuations as the most likely pairing mechanism. Moreover, we observe two superconducting transitions giving evidence of two distinct superconducting phases.

P revious experiments on pressed pellets of tiny single crystals of PrO  $s_4 \, \mathrm{Sb}_{12}$  [1] revealed superconductivity at  $T_c = 1.85 \, \mathrm{K}$  with an upper critical eld B  $_{c2}$  (T  $!~0) = 2.5 \, \mathrm{T}$ . The superconductivity appears to involve heavy quasiparticles with an elective mass m  $_{e}$  50 m  $_{e}$  as inferred from the jump in the specicheat at  $T_c$ , the slope of the upper critical eld B  $_{c2}$  near  $T_c$ , and the normal state electronic specicheat.

The normal state properties of PrOs<sub>4</sub>Sb<sub>12</sub> exhibit features with a single dominant energy scale of order several K. The low eld uniform susceptibility indicates a nonmagnetic groundstate, characterised by a maximum at 3 K and an enhanced zero temperature susceptibility of  $0.06 \text{ cm}^3/\text{m}$  ol. W ellabove the maximum a Curie{ Weiss law is observed with an elective moment of  $_{eff}$  = 2:97 B and a Curie {Weiss temperature CW = 16K. The electrical resistivity drops monotonically from room tem perature to T<sub>c</sub> by nearly two orders of magnitude and displays a shoulder at a temperature of order 7 K, below which a very weak T2 tem perature dependence is observed. Finally, the normal state specic heat displays a Schottky anomaly with a peak at T = 2.1 K. These data [1] were shown to be consistent with a 3 doublet ground state and  $_5$  (11K),  $_4$  (130K) and  $_1$  (313K) excited states, suggesting a quadrupolar origin of the heavy electron liquid. Nevertheless, a 1 singlet ground state and  $_5$  (6K),  $_4$  (65K) and  $_3$  (111K) excited states could not be ruled out.

P relim inary studies [3] of the low lying excitations by inelastic neutron scattering (INS) con rm the presence of a CEF level at  $0.71\,\mathrm{m}$  eV ( $8.2\,\mathrm{K}$ ) and  $11.5\,\mathrm{m}$  eV ( $133\,\mathrm{K}$ ) in excellent agreem ent with previous assignments of a  $_3$ 




FIG.1. Specic heat C=T vs. tem perature T in magnetic elds B k hl00i up to 0.5 T. The inset displays the specic heat near the superconducting transition, where the double transition can no longer be resolved at  $0.5\,\mathrm{T}$ .

ground state. Further evidence for such a ground state is also provided by recent non-linear susceptibility measurements [4]. Transverse—eld muon spin relaxation of the superconducting ux line lattice shows the absence of nodal structure [5] expected for a magnetically mediated superconducting state, and is also consistent with a quadrupolar origin of the superconductivity [6].

The high quality single crystals of PrO  $s_4\,\mathrm{Sb}_{12}$  grown from Sb ux [7], have very narrow superconducting transitions in both resistivity and susceptibility and a low residual resistivity  $_0<5$  cm . The samples naturally crystallized in a cubic shape, where the principal crystallographic axis were con med to coincide with faces of the cubes by means of Laue x-ray diraction. Powder x-ray diraction using a careful Rietveld analysis showed that the samples were single phase with the correct Proccupancy [8]. Occasional minor impurity phases were identified to be elemental Sb and Os in n-scattering studies [3]. Recently, de Haas{van Alphen oscillations were observed in single crystal samples from the same growth, providing evidence of long charge carrier mean free paths [9].

In previous studies of pressed pellets of tiny single crystals [1], C was found to be reduced by up to 50% due to inclusions of Sb ux. In the present work we measured the speci c heat of an aggregate of ve small single crystal pieces ( 10m g) all showing very well developed facets. The results were compared, where necessary, with the speci cheat of a large single crystal (  $3.55\,\mathrm{m}$  g). The aggregate of ve single crystals displayed the highest speci c heat thus far reported, while that of the single piece is reduced by 9% indicating a small quantity of Sb inclusions. We not that T and T\_c are sample independent. Moreover, we always not two distinct superconducting transitions.

The speci cheat was measured with a quasi-adiabatic heat pulse technique in a  $^4\mathrm{H\,e}$  cryostat down to 1.5 K in magnetic elds up to 14 T [10] and in a dilution refrig-

erator down to 100 m K in magnetic elds up to  $6:65\ \mathrm{T}$ [11]. Magnetic elds were applied along the principal cubic axis. W e observe an excellent quantitative agreem ent to better than a few percent in the tem perature and eld range of overlap between the two experim ental set ups, which employ dierent therm om eters and sample holders. We note that the specic heat ofm aterials with large, weakly coupled nuclear contributions as for PrOs<sub>4</sub>Sb<sub>12</sub> display quasiadiabatic them al relaxation times that easily exceed several minutes. Using a very low noise resistance bridge and automated detection electronics we were able to keep track of these extremely slow relaxation processes. Our results distinctly dier from recent work reported in reference [2]. However, we do observe data consistent with those reported in [2] when evaluating our data using the initial T versus time dependence following a heat pulse, for which nuclear contributions are still decoupled.

Shown in Fig. 1 is the speci c heat plotted as C=T versus T for low magnetic elds. W ith decreasing temperature, C=T exhibits the well-established maximum at T 2:1 K, decreases again to lower temperatures, followed by a very pronounced upturn at the lowest T. The superconducting transition at  $T_{\rm c}$  1:85 K is accompanied by a well developed anomaly in the speci c heat.

We focus rst on the normal state specic heat. For B = 0 and T >  $T_{\rm c}$  up to 10 K, C=T may be well described as a sum of three contributions (solid line): (i) an electronic part C=T = 313 m J=m olK², (ii) a phononic (cubic) part with a characteristic temperature of = 165 K and (iii) a Schottky anomaly due to CEF splitting of the Pr³H4 ground state to a 3 ground state doublet and 5 triplet with an energy separation of = 7.0 K.

In comparison to previous work we nd a slightly reduced value of . This may be related to higher sample quality and/or the di erent account of the lattice contribution, which was previously taken as the lattice specicheat of LaO  $s_4{\rm Sb}_{12}$  (  $_{\rm D}$  = 304 K). We did not use the lattice specicheat of LaO  $s_4{\rm Sb}_{12}$  here, because the lanthanide contraction suggests softer phononic rattling modes for the Pr compound than for the La compound consistent with the value of the characteristic temperature = 165 K .

We have carefully the various CEF schemes for the Schottky anomaly [11]. can be unambiguously determined from T of the Schottky anomaly and is thus not a free t parameter. In contrast, the absolute height of the anomaly depends sensitively on the number of Prions per formula unit and the degeneracy of the levels involved. The datamay only be accounted for by the 3 doublet ground state and a 5 triplet excited state, where = 7.0 K corresponds very well with the INS data [3] and the prefactor is precisely 1 Pr = fu. For other level splitting schemes the difference is in excess of a factor of two. This fully con rms the level scheme originally pro-




FIG. 2. Electronic contribution to the specic heat C=T vs. tem perature T. The solid curve shows an entropy conserving construction as explained in the text.

posed in [1]. We also note that the electronic and lattice contributions up to 10 K are essentially negligible.

Evidence for unconventional superconductivity may be seen in the specic heat anomaly (Fig. 1) in terms of two pronounced anomalies, where the upper transition coincides with the zero resistance and Meissner transition tem perature. The double transition has been observed in the aggregate of ve small single crystals and also the large single piece. It is present in all single crystalline sam ples studied to date, apart from the pressed pellets [1], which display a broad hump at the superconducting transition. In all cases for which the double transition is seen, the transition temperatures and the size of the superconducting anomalies are in very good quantitative agreem ent. This clearly rules out sample inhom ogenities as a possible cause. We further note that the double transition is also seen in the therm alexpansion of single crystals [12].

The speci c heat for B = 0 near  $T_{\rm c}$  after subtraction of the phonon and the Schottky contributions is shown as C=T vs. T in gure 2. The solid line represents an equal entropy construction showing that the two transitions are of equal height. The two superconducting transition temperatures are estimated to be  $T_{\rm cl}=1.75~{\rm K}$  and  $T_{\rm cl}=1.85~{\rm K}$ . The ratio C  $_{\rm sc}=T_{\rm c}=3$ , where C  $_{\rm sc}$  is the total height of both superconducting jumps taken together. It exceeds the weak coupling BCS value C  $_{\rm sc}=T_{\rm c}=1.43$ . Secondly, the entropy of the total superconducting anomaly compares with that of the normal state as expected [11].

The two superconducting transitions are rem in iscent of the only other stoichiom etric m etal exhibiting this type of behaviour, UPt3, which displays a complex superconducting phase diagram as a function ofm agnetic eld [13] and pressure [14]. We not that the double transition in PrOs $_4\,{\rm Sb}_{12}$  may no longer be resolved in 0.5 T, making more measurements necessary to establish the fate of the double transition in magnetic eld.




FIG.3. Specic heat C vs. temperature T in magnetic elds B k hl00i up to 14 T. The high T Schottky anomaly is rapidly suppressed up to 14 T. A pronounced anomaly, indicating an ordered state stabilized in high eld, is resolved at low T.

The specic heat C as a function of T in high magnetic elds up to 14 T is shown in Fig. 3. Data above 6:65 T could only be measured above 1:5 K. The Schottky anomaly is strongly suppressed by the magnetic eld. For T! 0 a strong increase of C is observed. Above 2T, data were not taken below 0.16 K because the weakly coupled, very large nuclear contributions could no longer be accounted for as explained above. The low T increase is consistent with the splitting of the 3 doublet ground state in a magnetic eld and additional contributions from hyper ne enhanced Zeem an splitting of the Pr nuclear levels. The observed behaviour exceeds by a large margin that reported in reference [2] and clearly refutes the main argument presented in that paper supporting a singlet ground state.

The Zeem an splitting of the 3 doublet and 5 triplet CEF levels is shown in gure 4. Here the upper doublet and the lowest triplet level cross at B = 4:5 T suggesting a possible change of ground state at this eld. Indeed, the low tem perature speci cheat at high magnetic elds displays a pronounced maximum for B > 4:5 T that shifts from T = 0.7 K for B = 5 T to T = 1 K for B = 6.65 Tand sharpens considerably. This shows the stabilisation of a new therm odynam ic ground state at high magnetic eld, driven by the Zeem an split level crossing of the 3 doublet and 5 triplet CEF. A change of ground state is also evident from two crossing points common to the C (T) curves [15], one below and one above 4T, in line with two fundam entally dierent ground states. A quantitative account of the high eld speci c heat is beyond the present work, since the hybridisation of the f-electrons with the conduction electrons can not be fully acocunted for. The existence of the high eld phase nevertheless fully con mm s the rst excited CEF triplet at = 7:0 K and is consistent with the ground state dou-




FIG. 4. (a) Zeem an splitting of the  $_3$  doublet and  $_5$  triplet CEF levels used for tting the zero eld specicheat. The doublet and triplet cross at about  $4.5\,\mathrm{T}$ , suggesting a stabilisation of a different ground state at high eld. (b) Magnetic phase diagram deduced from the specicheat C, magnetisation M and derivative of the resistivity d =dT and d=dB. The high eld phase is clearly driven by the level crossing due to the Zeem an splitting. The zero eld energy scale evident in all properties is clearly connected with the Pr $^{3+}$  3 - 5 level splitting.

The interplay of the CEF excitations with the conduction electrons is readily evident from kinks at low elds and maxima at high elds in the derivatives of the resistivity d =dT and d =dB, calculated from the raw data, and low T m agnetisation [8]. W hen combining these features with the sharp anomaly in the specic heat a unied phase diagram shown in qure 4 (b) may be constructed that also agrees with features of the magnetisation. In this phase diagram at low elds the maxima track the calculated Zeem an splitting of the 3 and the lowest 5 level. This provides a natural explanation for the energy scale of a few K at zero eld seen in the resistivity, susceptibility and specic heat. Moreover, the very low K adowaki-W oods ratio A = 2 just above  $T_c$  at zero eld [1,3] (A is the coe cient of T 2 contribution to the resistivity), is boosted to a conventional value for T ! 0 in a magnetic eld above 4T. Thus the CEF sensitively a ects the properties of the conduction electrons, even at high magnetic elds.

The origin of the high eld phase and its consistency with the doublet ground state may be reminiscent of the properties of  $PrPb_3$  [16] and  $PrFe_4Sb_{12}$  [17], both of which stabilise antiferroquadrupolar order (AFQO) at low temperatures by virtue of a Jahn-Teller distortion. For  $PrPb_3$ , the ordering temperature  $T_{AFQO}$  is shifted to higher values in magnetic eld before it collapses to zero above 7T [11], in qualitative agreement with the increase of the onset of the high eld phase in  $PrOs_4Sb_{12}$ . Them agnetic eld dependence in  $PrPb_3$  is thereby driven by the Zeem an splitting of the CEF. Although  $PrPb_3$  has a 3 doublet ground state and the rst excited state is a 4 and not 5 triplet, as for  $PrOs_4Sb_{12}$ , AFQO at high

elds is a real possibility. A possible suppression of the high eld state and qualitative analogy of the magnetic phase diagram with that of PrPb3 may therefore already provide compelling evidence of AFQO in magnetic elds in PrOs $_4$ Sb $_{12}$ , where neutron scattering experiments at high eld are required for nalproof.

In conclusion we have exam ined the speci cheat of single crystalline P rO  $s_4 Sb_{12}$  and found the data up to  $10 \, \text{K}$ and in high magnetic eld well explained by a 3 doublet ground state and 5 excited state, consistent with the previous specic heat in zero eld on pressed pellets [1]. We observe a double superconducting transition indicating two distinct superconducting phases, thereby highlighting the unconventional nature of the superconductivity. At high magnetic eld, we not that a novel groundstate is stabilised in magnetic eld. The magnetic phase diagram may tracked also by features of the electrical resistivity. Since the Zeem an splitting also rem oves uctuations related to the degeneracy of the doublet ground state, these are likely to be instrumental to the superconductive pair form ation. When taken together, the evidence presented here establishes PrOs<sub>4</sub>Sb<sub>12</sub> as very strong contender for quadrupolar superconductive pairing, i.e., neither electron-phonon nor m agnetically m edi-
