## Stock M arket Scale by A rti cial Insymmetrised Patterns

## Abstract

Large and stable indices of the world wide stock m arkets such as NYSE and S&P500 together with NASDAQ { the index representing m arkets of new trends, and W IG { the index of the local stock m arket of Eastern Europe, are considered. Due to the relation between articial insymmetrised patterns (AIP) and time series, stationary and tem porary properties of stock m arket indices are identified. By Itering extrem e events it is found that uctuations are self-similar. Snap-shots in time lead to estimates for a tem porary state of a market with respect to its history. It appears that close to a crash the AIP representation of a system becomes frozen.

1 Introduction

It is not disputed that developing ways to measure the state of nancialm arket accurately is essential, see, e.g., [1]. The purpose of this paper is to show how using a simple graphical tool we can estim ate a state of an asset. The basic idea comes from the use of visual displays. An Articial Insymmetrised Pattern, AIP in short, was introduced by Pickover in 1986 [2] to describe human voice and anim alvocalization. The method, called also Sym - m etrised D ot P attems, takes advantage of the fact that sym m etry, color and redundancy of dot patterns are useful in the visual detection and m em orization of patterns by any hum an analyst. The m ethod was successfully applied to m any di erent tim e series [3], becom ing a technique for the qualitative assessment of tim e series [4]. W ith A IP, one can graphically detect hidden patterns and structural changes in data or see sim ilarities in patterns across the tim e series being studied.

The fundam ental assumption underlying the idea of A P or any similar type propositions, like, e.g. recurrence plots [5], or ivariability diagram method [6], is that an observable time series is the representation of some dynamical process. Typically, we have interactions between m any dierent factors over time which nally sum up into a one dimensional time series. An example of such process is a stock market. The behavior of the stock market is determined by m any factors, such as the economic and political environment, investors expectations and individual trader's decisions. But eventually we deal with a single factor, namely, the price of a stock.

In the following we propose how to read A IP s if time series of indices of dierent stock markets are studied. Properties of NY SE Composite (NY SE in short) and Standard and Poors 500 (S& P 500 in short) lead us to a picture of a well developed and mature market. A young market, W arsaw Stock Exchange, which just celebrated its 11th anniversary this A pril, is a representative of so-called emerging markets. Its index is called W IG. We also

look at NASDAQ Composite (NASDAQ in short) to take inspect a market of a high volatility related to the "Internet E conom y". Som e A IP s for the listed series are presented in [7,8]. W ith this paperwem aintain that such stylized facts known for uctuations of nancial time series as (a) weak correlations between the price changes on successive trading days, (b) positive kurtosis like in a Levy noise and decay with a power law in tails for the probability distribution function of the price changes, and (c) correlations between the absolute values of the price changes, called clustering of volatility, are easily readable from dot patters, Section 3. Moreover, by extracting extrem e events we nd that uctuations could be self-sim ilar and if they are not self-sem ilar we obtain the background noise that drives the market, Section 4. Finally, by snap-shots in time we show how to estimate a state of a market with respect to its history. It appears that close to a crash, the system becom es frozen - the dependence on subsequent points is xed, Section 5.

2 A IP m ethod

The procedure is to convert a series of data fx (t)g into a collection of dots by a simple computer program :

choose the model parameters R and suitable to your needs, rescale the data to the range [0; R] using the form ula:

x (t) R

where  $x_{m in} = m in_t fx$  (t)g and  $x_{m ax} = m ax_t fx$  (t)g

Thus the low values of a series are close to 0 and high values are near R. One can say that each series is presented in its own m in-m ax scale.

mark a dot on a 2-dimensional plane using subsequent points separated by but in polar coordinates (radius, angle):

f(x(t);x(t+))g

multiply a plot symmetrically by rotating k times by angle

f(x(t);x(t+)+k)g

and/or re ecting trough m irror planes :

f(x(t); [x(t+)+k])q

The resulting representation of a series, called Arti cial Insymm etrised Pattern, provides a base in which local visual correlation can be used in detection and characterization of signi cant features of any sample data. The gallery of di erent A IP s can be found in [7,8].

Our present interest is to compare di erent series or di erent epochs in a series and therefore in all gures included here we show patterns where most of sym metries are left out | we plot di erent series on the same gure to observe lack of sym metries. For the best presentation of data we choose R to be equal to . As a result, a single dot pattern is plotted on a half of a circle of radius .W ith the rescaling R = the plots of standard series take the form presented in Fig.1. The basic set of standards consists of noises: Gaussian, white and Levy at di erent s ( represents decay of tails) and a random walk. Let us emphasize that all noises do not give di erent patterns when the distance between subsequent points is changed. The random walk depends on -with increasing the width of a curve increases. We also include a picture of a walk made from a half of points of a series to show regularity in density of a resulting curve.

Having in m ind the visual scale just shown, let us m ove to estim ates of states of stock m arkets.

3 Stylized facts by A IP

The basic quantities studied here are values of indices: W IG, NASDAQ, NYSE and S&P500 at closing. For each time series we consider a series of daily returns de ned as usual [9]:

The analyzed data com es from time span between 1st of January 1995 and 31st of December 2001 (7-year study resulting in about 1750 data points) or between 1st of January 1999 and 31 December 2001 (3-year study with about 750 data points).

The min-max scale of A  $\mathbb{P}$  is determined by extreme events. These events are located close to the circle of radius - positive tails, or at the zero - negative tails. Fig. 2 is a density A  $\mathbb{P}$  plot to compare returns of last seven years to returns of last three years. All these patterns are peaked signi cantly more than a G aussian noise. Presence of rare events squeezes the "body" of

A IPsmaking the area of the A IP plot much smaller than if the A IP plot is of a Gaussian noise. Com paring plots of Fig. 2 to the scale plots of Fig. 1 we see that plots of returns are similar to the about 1:8 in case of 7-year data and > 1:9Levy noise with in case of 3-year data. The tendency of attening of distributions can be easily veri ed by calculating kurtosis. It appears that the kurtosis for 7-year data is: W IG: 2:607, NASDAQ: 4:302, NYSE: 4:652 and S&P 500: 3:710 and if 3-year data is considered then W IG: 1:878, NASDAQ: 1:667, NYSE: 1:761 and S&P 500: 1:261. M oreover, the localization of bodies of the 7-year data is m oved from the vertical axis to the left in case of NYSE, S&P 500 and W IG and to the right when NASDAQ is considered. It is because in a scale of individual m in-m ax events at average the returns occupy rather: higher half of values (NYSE, S&P 500, W IG) or lowerhalf (NASDAQ).

Rare events lead to heavy tails in the distribution of returns [10,11]. W hat we can read from Fig. 3 is that the area where positive rare events are plotted is more densely populated in case of indices than in case when any Levy noise is considered. Therefore, we can speculate that tails of the distribution of indices decay differently from a Levy noise world.

It is interesting to com pare walks perform ed by logarithm s of indices, see Fig. 4. The 7-year data, Fig. 4 (a), shows a walk which in case of NYSE and S&P 500 is pushed to high values. NAS-DAQ's walk is rather located close to the zero.W IG's walk shows a sim ilar feature. The 3-year data, Fig. 4 (b), shows as all walks

have been shifted towards low values. Moreover, the events separated by 20 days are scattered over a half of a circle more widely than it is with 7-year walk. Thus the considered stock walks when observed in last three years are de nitely more noisy than if they are considered from the perspective of 7 years.

It is generally assumed that for probability distribution function of volatility a log-norm all distribution is a good approximation [1]. In Fig. 5 we present A IPs for volatility time series. It concludes that one-day volatility (: absolute values of returns) Fig. 5 (a), for three of four indices is rather far from being a Gaussian noise, while ve-day volatilities, especially, when = 20, Fig. 5 (b), appear to be like a Gaussian noise. The ve-day volatility is calculated as standard deviation of ve successive returns.

To observe clustering of volatility we divide series into epochs and we study where points of a considered epoch are located in a m ain body of volatility dot patterns (see subsequent plots of F ig. 6.) In particular, F ig. 6 (a) shows the whole 3-year data of oneday volatility and 5-day volatility. F ig. 6 (b) presents volatility in the rst three m onths of 1999. Notice, that volatility of W arsaw m arket is high what is di erent from volatility of the N ew York m arkets. The next snap-shots are taken at the m om ent where the opposite situation happens: a high volatility term is going on N ew York m arkets while W arsaw m arket experiences a calm tim e, F ig. 6 (c). F ig. 6 (d) shows data from a m onth before the attack of 11 Septem ber 2001 and F ig. 6 (e) - a m onth after the attack. N otice, that som e indices were not in uenced by this event. F inally, the present state of m arkets is shown on Fig. 6(f) where the data from the last m onth of a period studied is presented. All m arkets are quiet.

4 Filtering data

As the main shape of an A IP is de nitely generated by extreme events, we should ask what kind of a pattern would arise if the most exotic points were extracted from a series. On the following gures, Figs 7-10, we show results when subsequently a hundred, two-hundred and four-hundred points are extracted from the series.

In case of NYSE walk, Fig. 7(a), just after Itering a hundred points, the data separated by 20 days starts to appear as a white noise rather than a walk. However, the Itered returns, Fig. 7(b), ensures us that the noise is still non-G aussian and the peaked distribution is rm ly kept. W e interpret this feature as a selfsim ilarity. The series of S& P 500, Fig. 8(a), show s also that elim – ination of extrem e events m akes a series m ore noisy. R eturns, Fig. 8(b), when Itered subsequently, slightly m ove the center of a body what suggests that the m ax values are distant from the average value. NASDAQ walk data when Itered, Fig. 9(a), show s distinct properties. The area of low values stays dense occupied and, although m ore and m ore points are extracted, the walk arrives to high values rarely. The peaked distribution of returns is kept, however, and we observe a m ove of the m ain body dow n,

Fig. 9 (b). The walk of W IG, Fig. 10 (a), seems to be in a state between NYSE and NASDAQ | the dots of a plot rather quickly are scattered over the whole circle. However the distribution of dots is not uniform. Low values are occupied more densely. Surprisingly, the returns of W IG, Fig. 10 (b), after litering loose the positive kurtosis and become similar to a Gaussian noise.

## 5 C rashes

By study larger values of like = 50;100 we can observe how the system arrives to its m inim al and m axim al values, see F ig. 11.Notice that W IG and NASDAQ m axim a are separated dots, m inim a are densely occupied. Moreover, these walks are squeezed along the horizontal axis. Hence large values are followed by strong drops. This feature does not appear for plots of NYSE and S&P 500.W e know that during the period we studied NAS-DAQ experienced the crash. It was in April of 2000. At the sam e tim e huge drops were noticed on W arsaw stock m arket. Is it possible that this event can be recognized by A IP s? C an we learn in advance about an approaching crash from dot patterns?

Fig. 12 presents plots for series of data taken before the crashes. NASDAQ and W IG plots consist of data of two years before A pril 2000 (M arch values are the last data included). For NYSE and S&P 500 we consider data of two years before 0 ctober 87 crash (September is the last data included). A lthough data on Fig. 12 (a) and Fig. 12 (b) are plotted with increasing delay between

points, namely = 10;20;50;100, the resulting plots look both di erently and similarly. They are similar to each other because there is no visible in uence of (despite squeezing the body). Markets look like being frozen | driven by som e determ inistic rule. Moreover, the points of the top of walks are distributed loosely while the lowest values are densely occupied. P lotting snap-shots of last 60 days, we see that in the last days there are ights rather not walks to high values, see Fig. 13.

In the period that we studied one more crash took place. At the end of August 1998, S&P 500 lost 6:79%. That crash was di erent from others discussed so far, because is was a crash of con dence. It was caused by events in A sia and Russia. Again, when plotting A IPs from data before the crash we see that the markets are frozen, Fig 14. The W arsaw market behaves very noisy at that time. It looks like W IG experienced a crash earlier.

6 Sum m ary

W e found that visualization of the econom ic data by the A IP m ethod is particularly useful in getting into relations between m arkets. In particular:

(1) The stylized facts of returns of nancial time series: lack of correlations in daily returns, positive kurtosis of probabability density function of returns with tails that are dierent from both G aussian and any Levy noise, and clustering of volatility are easily readable from A IP s. By dierentiating these features we can compare markets.

(2) Filtering out the extrem e events we can learn about fractal properties of the data or un-hide the background noise that drives uctuations.

(3) M oreover, as the A IP m ethod keeps points in the time order, we can also easily nd nonstationary features of markets. By taking snap-shots in time we can estimate a market state with respect to its history. Especially this property seems to be im – portant in recognizing the ill condition of a market such as an imminent crash.

W ealth of observations together with sim plicity of use make the graphical method presented in this paper worth to be taken into account. For example, due to observations that are derived only because of using A IPs, we are not surprised by the opinion that eastern Europe markets are driven by di erent logic than other markets, [12].
