# M artensitic transition and m agnetoresistance in a Cu-A L-M n shape m em ory alloy. In uence of ageing.

We have studied the e ect of ageing within the miscibility gap on the electric, magnetic and them odynam ic properties of a non-stoichiom etric Heusler Cu-AlMn shape-mem ory alloy, which undergoes a martensitic transition from a bcc-based (-phase) towards a close-packed structure (M - phase). Negative magnetoresistance which shows an almost linear dependence on the square of magnetization with dienent slopes in the M - and -phases, was observed. This magnetoresistive e ect has been associated with the existence of Mn-rich clusters with the Cu<sub>2</sub>A Mn-structure. The e ect of an applied magnetic eld on the martensitic transition has also been studied. The entropy change between the - and M -phases shows negligible dependence on the magnetic eld but it decreases signi cantly with annealing tim e within the miscibility gap. Such a decrease is due to the increasing amount of Cu<sub>2</sub>M nA l-rich domains that do not transform martensitically.

I. IN TRODUCTION

The shape-m em ory e ect [1] is characteristic of certain alloys (the so-called shape-m em ory alloys), which exhibit a martensitic transition (MT) from an ordered bcc-phase (-phase) towards a close-packed low-tem perature phase (M -phase). This e ect is related to unique therm on echanical properties such as the ability to recover from large perm anent deform ations produced in the M -phase by the reverse transition when tem perature is increased. During the nineties a great deal of interest has been devoted to the study and developm ent of m agnetic shapem em ory m aterials. This interest ism ostly due to the possibility of a magnetic control of the shape-m em ory e ect, which has been made evident in the ferrom agnetic Ni-M n-G a alloy close to the Heusler com position N 1/2 M nG a [2]. Furtherm ore, these materials have been shown to exhibit unexpected pretransitional behaviour [3].

The present paper deals with the study of the Cu-A LM n alloy. This Hume-Rothery material [4] shares a number of features with the N i-M n-G a alloy system. It displays the same high-temperature crystallographic structure, a martensitic transformation with associated shape-memory e ect and interesting magnetic properties. For Cu-A LM n, however, the martensitic transition occurs in a composition region far from the Heusler stoichiom etry. For this composition range, the -phase is only stable at high temperatures, but can be retained at low-temperature by means of suitable cooling. During this cooling the system develops an ordered L  $2_1$  structure (F m 3m , H eusler sym m etry) in two successive disorderorder transitions: A2 (Im 3m )! B2 (P m 3m ) at  $T_{c1}$  and B2! L2<sub>1</sub> at  $T_{c2}$  [5]. Upon further cooling it undergoes a m artensitic transition at a tem perature which is strongly com position dependent. This transition has a di usionless nature which ensures that the atom ic distribution of the L2<sub>1</sub> phase is inherited by the M -phase. It is worth noting that this feature is com m on to all Cu-based shapem em ory m aterials [6].

M agnetic properties arise from localized m agnetic m oments at Mn-atoms as occurs in the Ni-Mn-Ga system [7]. These magnetic moments are coupled through an oscillating e ective interaction (RKKY interaction). AL-CHEMI (Atom Location by Channelling Enhanced Microanalysis) experiments [8] have shown that Mn atoms are located preferentially in one of the four distinguishable fcc sublattices of the  $L2_1$  structure (the 4b sites in Wycko notation). For this con guration, ferrom agnetic coupling is dom inant and close to the  $Cu_2AM$  n com position the system is ferrom agnetic. However, for nonstoichiom etric alloys the 4b sites are not fully occupied by M n-atom s and this results in m agnetic disorder, which gives rise to di erent magnetic behaviour depending on the tem perature range [9, 10]. M agnetic clustering has been suggested to be at the origin of the magnetoresistive properties recently reported in Cu-A HM n m elt-spun ribbons [11, 12]. An interesting feature is the fact that a phase separation between  $Cu_3A$  l-rich and  $Cu_2AM$  nrich phases may occur below the  $L2_1$  ordering line. It is therefore expected that the magnetic and structural properties of the system are sensitive to the temperature history of the material (i.e., ageing). In particular, isotherm all annealing at a temperature within the miscibility gap will result in the growth of magnetic clusters. The existence of a miscibility gap was not reported for the  $Cu_3Al! Cu_2AM$  n pseudobinary composition line [13] and later con med for Cu-rich system s with a com – position that slightly deviates from this line [14]. Interestingly, this composition range includes that for which Cu-AlM n displays a martensitic transition. Recently, it has been theoretically shown [15] that the in uence of magnetic degrees of freedom on con gurational phase stability is at the origin of this phase separation.

The present paper is aim ed at experim entally studying the in uence of magnetism on the martensitic transform ation in Cu-A HM n. Since the magnetic properties of this material are expected to be sensitive to ageing, this e ect will be studied. In particular, we focus on the study of magnetotransport and magnetic properties through the martensitic transition of bulk samples. The results will contribute to gain a deeper understanding of the magnetoelastic interplay, which will be studied at di erent levels of coupling.

The paper is organized as follows. In section II, the experimental details are outlined. Section III deals with the experimental results, which are discussed in section IV .

## II. EXPERIMENTALDETAILS

Measurements were performed on a Cu-AHM n polycrystal (grain size 100 m) prepared by melting pure elements (99.99% purity). The nom inal composition of the studied alloy is Cu; 22.8 at% Al; 9.0 at % Mn. From the ingot, rectangular specimens (approximately 12 4 mm<sup>2</sup> and 0.01 mm thick for resistance measurements or 0.5 mm for calorim etric and magnetic measurements) were rst cut with a low-speed diam ond saw and mechanically polished down to the desired thickness. All sam ples were annealed for 10 m in at 1080 K and quenched in a mixture of ice and water. This fast cooling avoids precipitation of equilibrium phases, but enables the two ordering transitions to the B  $_2$  and L  $2_1$  structures to take place ( $T_{B_2}$  = 849 K and  $T_{L2_1}$  = 795 K [5]). The nom inal martensitic transition temperature of as-quenched samples is  $T_M = 157$ 1 K.For the studied composition the structure of the M -phase is 18R [16]. This structure is monoclinic but it is usually described by a larger (approxim ately orthorhom bic) unit cell containing 18 close-packed atom ic planes along the c-axis [17].


P hase separation between  $Cu_3A$  l-rich and  $Cu_2A$  M nrich dom ains occurs under very slow cooling from high tem perature. In the as-quenched specimens phase separation can be induced by means of post annealing within them isobility gap. This process takes place at slow rates so that it is completely negligible at room temperature (even on a month time scale). In all cases, ageing consist in annealing at a temperature  $T_a = 473$  K for selected times. We chose this temperature because it is located slightly below the limit of them is cibility gap for the studied composition. A ctually, above 525 K no phase separation was detected, while 50 K below, the magnitude of the observed e ects is similar, but they occur on a longer time scale.

Four kind of measurements were performed: electrical resistance under applied m agnetic eld, m agnetization, ac-susceptibility and calorim etry. Electrical resistance was measured from 5 K up to 300 K using an ac four-probe m ethod. For m agnetization m easurem ents a SQUD magnetometer was used. For calorimetric measurements a highly sensitive and fast response (around 20 s time constant) calorimeter, which was speci cally designed for the study of solid-solid phase transitions, was utilized [18]. Calorim etric, magnetization and acsusceptibility runs were perform ed through the martensitic transition in the range from 100 K to room temperature. Calorim etric measurements were carried out at a rate of 0.5 K/m in, and pairs of data (calorim etric output and tem perature) were recorded every 2 seconds. A c-susceptibility m easurem ents were perform ed at a frequency f = 66 H z.

### III. RESULTS




FIG.1: Magnetoresistance M R versus magnetic eld H at selected temperatures and for dierent annealing times at  $T_{\rm a}=~473~{\rm K}$  .

Electrical resistance measurements were carried out by rst cooling the sample down to 5 K and then increasing the tem perature in steps up to 300 K. At each plateau, the resistance R was measured at di erent values of the magnetic eld H at intervals of 3450 e from 0 to 10 kOe, and at 2100 Oe intervals within the range from 10 to 50 kOe. The magnetoresistance MR, dened as the relative change of R with H, is computed as: M R = [R(T;H) R(T;H = 0)] = R(T;H = 0). In Fig.1, M R is plotted as a function of H at selected tem peratures for samples subjected to increasing annealing tim es at T<sub>a</sub>. In all cases, the alloy exhibits negative m agnetoresistance, i.e., the resistance decreases as m agnetic eld increases and the magnitude of the change is higher at low temperature. Actually, the maximum MR, of about 7%, was obtained at T ' 10 K and H = 50 kO e for the as-quenched specimen. Overall, the e ect of ageing is to reduce the MR at high elds. However, at low elds a small increase is observed, which is associated with the material becoming magnetically softer. For instance, the M R at T = 300 K and H = 10 kO e increases from a practically null value for the as-quenched state to 0:5% for the long-term annealed state.


FIG.2: Electrical resistance R versus temperature T at selected values of the magnetic eld H for an as-quenched sam – ple and for a sam ple annealed 300m in at  $T_{\rm a}\,=\,473$  K .

An interesting feature concerns the in uence of the martensitic transition on the M R. This e ect is better revealed by plotting the change of R with T across the M T at selected values of H. This is shown in Fig. 2 for an as-quenched sample and for a sample aged for 300 m in. The curves obtained are equivalent to those obtained directly by measuring R versus T under con-

tinuous heating at di erent constant values of H [20]. The large change in resistance in the tem perature range between 150 K and 175 K for the as-quenched sample and between 175 K and 200 K for the annealed sample is due to the occurrence of the M T.W e will take the tem perature di erence T between the maximum and the minimum of the R versus T curves as an estimation of the spread in temperature of the transition (di erence in the starting and nishing transition temperatures). The corresponding change in resistance will be denoted by R. Regardless of the ageing in uence, the e ect of the magnetic eld is mainly to decrease the resistance of the M -phase (the resistance in the -phase decreases by a lower amount), which leads to a reduction in R as the eld is increased. In addition, T is reduced when the eld increases (in the as-quenched system this reduction amounts to 6 K for an applied eld of 50 kO e).






FIG.4: M agnetoresistance M R as a function of the square of the m agnetization. Solid sym bols correspond to the M -phase and open sym bols, to the -phase. Results for an as-quenched and a long-term aged ( $t_a = 300 \text{ m in}$ ) specimen are shown.

In order to characterize the magnetic response of the system we carried out magnetization (M) and acsusceptibility () measurements through the martensitic transition. These measurements were undertaken on samples subjected to increasing annealing times at  $T_a$ . Figure 3(a) shows M versus T curves at selected values of the magnetic eld. Figure 3(b) shows magnetization versus H =T curves. It is interesting to correlate the magnetization with the behaviour of the magnetoresistance. Figure 4 shows the M R as a function of the square of

m agnetization M  $^2$  for as-quenched and long-term aged specimens. For each sample, alldata for the phase scale on a single curve, while data for the M -phase scale on another curve. In the as-quenched state, the two scaling curves are approximately linear, while remarkable deviations from linearity are evident in the annealed system, particularly for high values of M . M oreover, in the annealed state, the scaling (in both - and M -phases) is not as good as in the as-quenched state.


FIG.5: M agnetization change M at the martensitic transition versus magnetic eld H at selected annealing times at  $T_a=473$  K. The inset shows the saturation value of M as a function of annealing time (the dashed line is a guide to the eye).

A s illustrated in Fig. 3 (a), m agnetization curves show a signi cant change M at the MT (M is estimated as the magnetization di erence at the transition temperature between extrapolations of the linear behaviour of M versus T curves well above and well below the transition). Fig.5 gives M versus H after di erent annealing times at T<sub>a</sub>. In the as-quenched state, M saturates for a value of H close to 20 kO e; the eld needed to reach saturation decreases with increasing annealing time. In all cases, for these values of the eld, the magnetization itself is far from having reached saturation. M oreover, the saturation value of M (M  $_{\rm sat}$ ) is strongly dependent on the annealing time. A ctually, it decreases with  $t_{\rm a}$  as shown in the inset of Fig. 5, reaching, within error, a constant value for  $t_{\rm a} > 150$  m in.

As the M T is rst order, any change of the tem perature  $T_M$  induced by the applied magnetic eld H should





be accounted for by the C lausius-C lapeyron equation




FIG.7: Entropy change between M – and –phases as a function of ageing tim e at  $T_a$  = 473 K.The solid line corresponds to an exponential decay tted function and serves as a visual guide.

where S is the entropy di erence between M - and phases. We measured S using calorimetry after different annealing times. In Fig. 6, we present therm al curves obtained during heating runs for di erent annealing times. These curves show the characteristic noisy structure which is common to many martensitic transitions [21, 22]. Such a noisy structure is enhanced in the as-quenched state. As the annealing time increases, the transform ation rst becom es sm oother and broader, and shifts towards lower tem peratures. However, for times longer than 90 m in therm al curves partially recover the original noisy character and the transform ation shifts towards higher tem peratures. The entropy change is determ ined by a num eric integration of the therm ogram s [23]. The value obtained for the as-quenched system (1.27)0.02 J/Kmol) is consistent with that reported in [24]. The dependence of S on  $t_a$  is depicted in Fig. 7. The gure reveals that S (absolute value) decreases when the annealing time at T<sub>a</sub> increases, reaching (as occurs with M  $_{sat}$ ) a constant value for  $t_a > 150$  m in. The relative decrease of S is about 30%, much sm aller than the relative decrease M sat, which is estimated to be approxim ately 90% .

It is then interesting to compare the values of the derivative  $dT_M = dH$  in the as-quenched and long-term annealed states using equation 1. For the as-quenched system, a value of (8 0:4) mK/kOe is obtained, while


this value reduces to (1:10 0:05) m K /kO e after 300 m in of annealing. The reduction is mainly related to the decrease of M  $_{\rm sat}$  with ageing. Actually, the derivative dT\_M =dH provides a good quanti cation of the dependence of the structural transition temperature on a magnetic eld under the assumption that S is independent of H . Such an assumption is based on the fact that the entropy di erence between the open and close-packed phases originates from the change of the corresponding vibrational spectrum, as occurs in non-m agnetic Cu-based shape-m em ory alloys [25].

A possible magnetic contribution to S can be evaluated from the magnetization vs. temperature curves. A ctually, at a given temperature T, the change of entropy of the system with the magnetic eld H is given by:

has been used. Therefore, application of a magnetic eld modi es the entropy change between both the M - and -phases according to:




FIG.8: Change in the entropy di erence between  $A = M = 10^{-1}$  and M phases S, as a function of the magnetic eld H after di erent annealing times at  $T_a = 473$  K.

<u>0 M</u> 0 T where and are the derivatives of the m agnetization with respect to the tem perature in the M and -phases. The preceding integral was calculated num erically from the magnetization curves above following the procedure given in [26]. Results are plotted in Fig.8 as a function of H for di erent annealing times. This quantity is always negative, which means that the e ect of the eld is to increase the absolute value of S. However, the increase is very small, and represents, in all cases, less than 1% of the total entropy change. It can therefore be considered negligible for practical purposes. It is, how ever, interesting to com pare this entropy di erence with that reported in a N i51:5M n22:7G a25:8 polycrys-4 10 <sup>3</sup> talline alloy [27]. In that case a value of S J/K mol is estimated at H = 0.9 T. This value is com parable with the value reported here for the Cu-A lM n system . Notice that for the Ni-Mn-Ga system, the change in MT tem perature with magnetic eld is also very weak [25].




FIG.9: Evolution of the real part of the ac magnetic susceptibility with annealing times at  $T_a = 473$  K. The inset shows a detailed view of the temperature region where the martensitic transition takes place. Both heating (solid line) and cooling (dashed line) runs are displayed, revealing the transform ation hysteresis. For clarity, the curves have been m agni ed by a factor that is indicated on each curve.

An additional, com plem entary magnetic characterization of the studied system consisted of measuring the ac magnetic susceptibility as a function of the ageing time  $t_a$ . The evolution of the real part of the ac-susceptibility is displayed in Fig. 9. In the as-quenched state, the magnetic susceptibility is small and show sa low-tem perature

peak associated with the appearence of a glassy magnetic phase. The martensitic transition can be detected on this curve as a very small jump between 160 K and 170 K. The inset of the gure shows a detailed view of the region where the M T takes place. In this case, heating and cooling runs are presented so that the transform ation hysteresis is revealed.

As ageing time is increased, the susceptibility peak m oves tow ands higher tem peratures and becomes simultaneously higher and broader. Besides, the evolution of the m artensitic transition tem perature with  $t_a$  follows that of the evolution determ ined from the calorim etric m easurem entspresented above. For annealing times  $t_a > 60$  m in the anomalies associated with the freezing tem – perature and them artensitic (jump) phases overlap. This fact gives rise to a susceptibility that decreases abruptly at an intermediate tem perature ( 150 K) as tem perature is reduced. With further annealing, the shape of the susceptibility curves remains unchanged, but the value of decreases at high tem peratures indicating that the system becomes more and more ferrom agnetic.

### IV. DISCUSSION

In this paper, we have reported results showing the existence of magnetoresistive e ects in bulk polycrystalline Cu-AlMn samples. Magnetoresistive behaviour had already been observed in -phasemelt-spun ribbons of sim ilar composition [14]. In the present paper, the investigation has been extended to the bulk system and to the study of magnetoresistance in the martensitic phase. In both - and M -phases, the observed magnetoresistance

is typical of heterogeneous alloys [28] where m agnetoresistance originates from the spin-dependent scattering of conduction electrons on ferrom agnetic clusters em bedded in a metallic non-magnetic matrix [29]. In the studied system, the ferrom agnetic clusters are due to the tendency of M n-atom s to increase their number of thirdorder neighbours of the same species within the basic bcc-lattice. At present there is substantial experim ental evidence of the existence of these clusters [13, 14]. X -ray experim ents [5] have dem onstrated that quenched sam ples exhibit an L2<sub>1</sub> structure. In this structure, the M natom s are preferentially located on the 4b sites (W ycko notation) of the cubic unit cell of the F m 3m structure. However, the distribution of M n atom s in this sublattice is not completely random . Actually, there are indications of the existence of correlations among the positions of the M n-atom swithin the sublattice [9]. W hile clusters are not strictly well de ned in this case, their in uence on transport and m agnetic properties of the system has to be considered. In particular, they are responsible for the superparam agnetic behaviour of the studied alloy system, as shown in [10]. The clustering tendency is enhanced by ageing within the miscibility gap. A ctually, the in uence of ageing on the magnetic properties of Cu-A HM n shows up by the remarkable e ect that ageing has on the M R curves; a decrease in the magnitude of M R at low tem peratures and a slight increase at high tem peratures

have been observed (see Fig. 1). These modi cations are due to an increase in the magnetic softening which takes place after short annealing times. This is clearly a sign of the increase of the ferrom agnetic character of the system owing to the growth of magnetic clusters. Such an increase is con med by magnetization and susceptibility measurements.

The scaling of M R with M  $^2$  was found to be dierent in both the - and M -phases. This e ect mainly arises from the di erent behaviour of the magnetization in the two phases. A ctually, the M vs. H = T curves also show a tendency to group into two di erent fam ilies corresponding to the - and M -phases, respectively. In the as-quenched state, the M R shows a fairly good linear dependence on M  $^2$  for both the - and M - phases. This is the expected behaviour in the absence of magnetic interaction between m agnetic clusters [30]. However, at high elds the curves for the M -phase show a clear tendency to deviate from linear behaviour. A sim ilar deviation has previously been observed in heterogeneous alloys and it has been attributed to the progressive eld alignment of the disordered spins at the boundaries of the magnetic clusters, which causes a large variation of the M R com pared with the corresponding change in magnetization [31]. Such an increase in the slope of the M R vs. M  $^2$ curves is usually associated with the existence of high values of the high eld susceptibility, as is the case of the as-quenched and short-term annealed samples [see m aqnetization curves in Fig. 3(b)]. A fter long time annealing, ferrom agnetism is responsible for the loss of linearity in the M R versus M  $^2$  curves. Actually, the formation of large ferrom agnetic clusters whose magnetization saturates at relatively low elds (see Fig. 3(b)) leads to a

large change of the totalm agnetization of the sam ple and a sm all variation of M R at low elds, since the latter originates from the moment alignment of the sm all clusters and/or the spins at the boundaries of the ferrom agnetic regions, which occurs at higher elds. Consequently, M R vs. M<sup>2</sup> shows a quasi-constant regime that corresponds to the range of elds in which the magnetic saturation of large ferrom agnetic clusters takes place (see Fig. 4) and a subsequent quasi-linear behaviour due to the magnetoresistance associated with sm all clusters and boundary spins.

A noticeable e ect of the magnetic eld on the martensitic transition is the reduction of the tem perature range T in which the transition occurs. A qualitatively com parable e ect has been reported in the case of the ferrom agnetic N i2M nG a [2], but in this m aterial the reduction is much greater; for that alloy the transition range reduces from about 10 K without an applied magnetic eld to less than 2 K for an applied eld of 10 kOe. In shape-m em ory alloys, the transform ation is acknow edged to be therm oelastic, which means that the system needs to be continously cooled down (or heated up) in order to increase the transform ed fraction of the new phase. The transition is not completed until the tem perature is lowered (increased) below (above) a certain value. The free-energy di erence between both phases provides the driving force for the transition. Such a driving force is proportional to the tem perature di erence between equilibrium and the actual temperature to a rst approximation [32]. The path followed by the system is an optim alpath in which accomm odation of the transform ation elastic strain is alm ost accom plished. Therefore, T represents a reasonable measure of the stored elastic energy during the forward transform ation [23]. From this point of view, a decrease in T re ects a low er value

of this stored elastic energy. We argue that the physical m echanism behind this e ect is that the magnetic eld around magnetic clusters breaks the degeneracy of the low-tem peraturem artensitic phase thus favouring the nucleation of these variants with the magnetization easyaxis in the direction of the eld. In Cu-A LM n, approxim ately orthorhom bic martensitic domains, with the caxis oriented along the magnetic eld, are expected to have maximum nucleation probability. In the N i-M n-G a alloy such an interpretation is corroborated by the fact that magnetic and mechanical energies required to induce a single variant martensitic structure from a polyvariant crystal are com parable [33].

An interesting result concerns the magnetization jump occurring at the martensitic transition. This jump is positive (increase of the magnetization in the forward transition from the -to the M-phase) in the as-quenched state even for small elds. However, for su ciently long annealing time, when the sam ple behaves ferrom agnetically, this jump is negative for small values of the eld and becomes positive above a certain critical eld close to the value for which M saturates. This is related to a high magnetic anisotropy of the martensitic phase. For elds larger than the critical eld, reorientation of martensitic variants enables the Zeem an energy to be minimized and the jump again becomes positive.

The behaviour of magnetic susceptibility provides further understanding of the origin of the interplay between magnetic and structural degrees of freedom. In the asquenched state, the temperature dependence of the acsusceptibility is that which is expected for a system with magnetic clusters. Below a freezing temperature (maximum of the versus T curve) the large m agnetic m om ents of L 21-clusters are frozen along the m agnetic easy axis. W hen the ageing time is increased, the peak associated with the occurrence of the frozen m agnetic phase shifts tow ards higher tem peratures and becom es broader. This is a consequence of the sensitivity of the susceptibility to the size and shape distribution of the magnetic clusters. For annealing times longer than 100 m in the behaviour of the susceptibility is that expected for a ferrom agnetic system : it is quite constant in both M - and - phases. In the tem perature range where the M T takes place, the increase in the ferrom agnetic correlation among clusters explains the evolution of the shape of the hysteresis cycle of the M T with an increase of ageing time. For short ageing times, increases at the M T (forward transition) due to the tendency of the magnetic moments to freeze. In contrast, when the system becom es ferrom agnetic, the behaviour of at the transition is dom inated by the magnetic anisotropy which is larger in the M - than in the -phase.

From a general view point, the results discussed above must be considered as evidence of the coupling between magnetic and structural degrees of freedom occurring at a mesoscopic scale, that is at the length scale of the magnetic/m artensitic dom ains. The coupling also exists at a microscopic level (spin-phonon coupling) which is made clear by the estim ated (through C lausius-C lapeyron equation) change of  $T_M$  with H. This coupling is how ever very weak and is related to the smallm agnetic contribution to the entropy di erence between the - and M -phases. The obtained value is comparable to that estim ated for ferrom agnetic N i-M n-G a, but is considerably smaller than the value ( 0:1 K /kO e) reported for ferrous m artensitic alloys [34]. C onsistently, it has been show n that application of a magnetic eld does not signi cantly 8

modify the phonon branches in N i-M n-G a [35].

At this point, it is worth noticing that the strong inuence of ageing on the entropy di erence between – and M -phases may not be related to an increase in the magnetic contribution to the entropy. This e ect must be simply ascribed to the fact that M n-rich regions do not transform martensitically. The important change of S takes place within the ageing time interval during which the system becomes ferrom agnetic. Notice that simultaneously the magnetization change at the transition reaches its saturation value. Therefore, any further evolution of the magnetic properties (as, for instance, revealed by ac-susceptibility measurements) of the system are originated by short-range reordering processes.

To conclude, the results presented prove the existence of both m agnetoresistive and m agnetoelastic properties in a non-stoichiom etric H eusler Cu-A HM n alloy with a M n content of 9 at% and with shape-m em ory properties. The occurrence of a m artensitic transition has enabled the study of the e ect of the crystallographic structural change on the above m entioned properties. The m agnetoresistive behaviour has been shown to be di erent for the two structures. With regards to m agnetoelastic coupling, it has been found that it m ainly occurs at a m esoscopic level between m artensitic dom ains and m agnetic clusters.
