## A diabatic transfer of electrons in coupled quantum dots

We investigate the in uence of dissipation on one{ and two{qubit rotations in coupled sem iconductor quantum dots, using a (pseudo) spin{boson model with adiabatically varying parameters. For weak dissipation, we solve a master equation, compare with direct perturbation theory, and derive an expression for the 'delity loss' during a simple operation that adiabatically moves an electron between two coupled dots. We discuss the possibility of visualizing coherent quantum oscillations in electron 'pump' currents, com bining quantum adiabaticity and C oulom b blockade. In two{qubit spin{swap operations where the role of interm ediate charge states has been discussed recently, we apply our form alism to calculate the delity loss due to charge tunneling between two dots.

## I. IN TRODUCTION

The control of quantum superpositions in coupled electronic systems has been suggested as a possible way to realize quantum logic gates in semiconductor structures. An example are coupled quantum dots<sup>15</sup>, where C oulomb interactions between electrons can be exploited<sup>68</sup> to de ne very smalle ective H ilbert spaces such as that of two tunnel-splitted ground states, separated by a large energy gap from the remaining many-particle states<sup>9</sup><sup>11</sup>.

If parameters of the Hamiltonian (like the tunnelcoupling between dots) are slowly changed as a function of time, adiabatic control of the state vector<sup>12</sup>, swap operations<sup>13</sup>, and the controlled transfer from an initial to a nal state<sup>14</sup> become possible. In addition, by coupling such a system to external electronic reservoirs, one can pump electrons through the system in a controlled, adiabatic manner which in principle can serve as a 'read out' of the state vector in form of an electric current. In the simplest case, this can be achieved through a simultaneous variation of two parameters as a function of time.

B oth adiabatic control of rotations or swaps, and coherent pumping of electrons evidentally are very sensitive to decoherence. The coupling to dissipative degrees of freedom such as phonons disturbs the coherent timeevolution and therefore leads to a loss of control over the desired superposition. D ecoherence and dissipation in quantum XOR gate operations have been discussed recently by Thorwart and H anggil<sup>15</sup> in a powerfulnum erical scheme. They found that properties like gate delities are very sensitive to the dissipative bath coupling constant, but only weakly depend on temperature.

In this article, we quantitatively investigate the role of dissipation for one-and two-qubit adiabatic 'rotations' of an electron between two coupled quantum dots. For the electron charge one-qubit, we discuss a 'quantum electron pum p' for dots which are coupled to external leads (electron reservoirs). In our scheme, decoherence is mainly due to absorption of bosons in excitations of the instantaneous ground state which leads to an exponential tem – perature dependence. For a sinusoidal pulse, we use an exact solution and perturbation theory in the phonon coupling to predict how quantum mechanical oscillations between the dots can be made visible in a 'read out' electronic current, similar to the experiment by Nakam ura et al. in a superconducting C coper pair box<sup>16</sup> and the recent electron spin resonance scheme for dots by Engel and Loss<sup>17</sup>.

First, we compare results for both weak and strong coupling to the bosons and derive an analytic expression for the in uence of the bath on the delity of the operation. Second, we investigate two-qubit swap operations in spin-based two-electron quantum dots. These spin qubits sensitively depend on charge decoherence due to interm ediate states where charge has tunneled between the dots. P iezoelectric phonons coupled to the electron charge incoherently m ix states in the singlet sector and lead to a loss of delity of the swap operation.

A diabatic transfer and pumping of charges through small metallic islands or semiconductor quantum dots<sup>18</sup><sup>(21</sup> has already been demonstrated experimentally. Furthermore, in the strong C oulom b blockade regime of coupled quantum dots, the non-adiabatic coupling to A C ekls in photo-assisted transport<sup>9,22</sup><sup>(24</sup> has been established in experiments<sup>25</sup><sup>(27</sup>. In the opposite regime of weak C oulom b correlations, experiments in open dots<sup>28</sup> have demonstrated the feasability of an 'adiabatic quantum electron pump'. These systems can be described as non-interacting mesoscopic scatterers<sup>29</sup><sup>(33</sup>.

A combination of strong C oulomb blockade and the adiabatic control of the wave function in a triple quantum dot has been suggested recently<sup>34</sup>. Furthermore, in superconducting Josephson junction qubits<sup>35</sup>, adiabatic quantum computation with C coperpairs<sup>36</sup> and adiabatic controlled-NOT gates for quantum computation have been proposed by A verin<sup>37</sup>.

The decoherence properties of adiabatic one- and twoqubit operations are closely related to the dissipative Landau-Zenerproblem (see, e.g., the review<sup>38</sup> for further references). In time-dependent operations, decoherence rates in general become time-dependent them selves and therewith usually involve the whole (or a large part) of the spectrum of frequencies in the elective spectral density (!) of the bosonic bath. As we show below, adiabatic pulses can be chosen such that qubit rotations run at a constant energy gap to the excited state whereby dissipation is due to (! = =~), i.e., one boson frequency only. This can be used to extract (!) from the pump current by using a series of pulses with di erent

A suppression of (!) at certain frequencies  $! = !_0$ has been predicted in free-standing phonon cavities' due to symmetry and geometrical con nement<sup>39</sup>. Here, we demonstrate that a Rabi' rotation pulse tuned to constant energy di erence (t) = ~!\_0 e ectively 'switches o' the decoherence in such systems, at least within second order in the coupling constant. Consequently, this de nes a one-dimensional decoherence-free manifold' (curve) on the adiabatic groundstate energy surface of the system, which might be of interest for adiabatic quantum computation schemes suggested recently<sup>40</sup>.

The paper is organized as follows: in section II, we discuss one-qubit rotations, introduce the time-dependent spin-boson m odel, and describe the adiabatic transfer of an electron between quantum dots with and without dissipation. In section III, we derive a perturbative, analytical expression for the one-qubit delity, compare with the strong-coupling case, and suggest a scheme to extract quantum oscillations as a 'read out' electron pump current. In section IV, we turn to spin-qubit swaps and charge decoherence for the gate discussed recently by Schliem ann, Loss, and M acD onald. Finally, section V is a short conclusion.

#### II. ONE-QUBIT ROTATIONS

A diabatic transfer in a two-level system consists in the rotation of a chosen initial state jini into a nal state jouti by an adiabatic variation of system parameters. The simplest example is a spin  $\frac{1}{2}$  in a slowly rotating magnetic eld.




FIG.1: Left: D ouble dot with time-dependent energy level di erence "(t) = "L (t) "R (t) and tunnel matrix element  $T_c$  (t), connected to electron reservoirs. R ight: Surface of the lower energy eigenvalue " of the two-level H am iltonian  $H_0^{(1)}$  (t), Eq. (1). To adiabatically transfer an electron from the left to the right dot, " and  $T_c$  are varied as a function of time as in Eq. (2), corresponding to the curve on the " surface.

U sing the analogy with adiabatic steering in atom ic three-level systems, the possibility of adiabatic pumping of electrons through triple quantum dots has been suggested recently<sup>34</sup>, using a suitable 'design' of instantaneous energies through two time-dependent tunnel couplings. Here, we consider the transfer of an electron through a double quantum dot via quasi-stationary adiabatic eigenstates. This 'charge qubit'<sup>8</sup>, Fig. (1) left, is de ned by two electron states jLi and R i with a time-dependent energy di erence "(t) = "L (t) "R (t) and coupled by a tunnel matrix element T<sub>c</sub>(t), as described by

the tim e-dependent H am iltonian

with  $_z := j_Lih_L j$   $\Re$  ihR j and  $_x := j_Lih_R j + \beta_R ih_L j$ . Experimental control of (constant) " and  $T_c$  has been demonstrated in double quantum dots<sup>1,3{5</sup>.

The initial state is an additional electron in the left dot with an energy "L well below the chem ical potential of the left lead, the nalstate is an additional electron in the right dot which then (keeping  $T_c = 0$ ) is lifted above the chem ical potential of the right lead. Such a transfer cycle of the open system (coupled to electron reservoirs) in the C oulom b blockade regime requires a H ilbert space H <sup>(3)</sup> spanned by three states jli, jLi, and  $\Re i^{9,10}$ . Here, the two basis states jLi =  $\Re + 1$ ; M i and  $\Re i = \Re$ ; M + 1i describe one additional electron in the left (right) dot above a ground state jDi =  $\Re$ ; M i (Empty state').

For the rem ainder of this section, we only consider the rst part of the transfer cycle, i.e., the dynam ics of the double dot isolated from the leads, and turn to the full transfer cycle including tunneling to and from the leads in section IIIC.

#### A. Coherent A diabatic Transfer

An adiabatic transfer from left to right requires the simultaneous change of at least two parameters such as

This corresponds to a change of "(t) with a simultaneous switching of the tunnel coupling  $T_c$  (t) between the dots. The precise form of the pulse, Eq.(2), is not important and has been chosen for convenience here.

The instantaneous, hybridized eigenstates of the iso-




FIG. 2: Inversion h <sub>z</sub>i for transfer from left (h <sub>z</sub>i = 1) to right (h <sub>z</sub>i = 1) in a two-level system, Eq. (1). Inset: timedependent tunnel matrix element  $T_c$  (t) and energy splitting "(t), Eq. (2). Energies (times) are in units of the amplitude  $T_c$  (~= $T_c$ ) in Eq. (2); the other parameters are  $t_0 = 25$ ,  $= = (2t_0)$ , = 10, " $_0 = 0.1$ , " $_1 = 1$ . The adiabatic approximation Eq. (4) is shown as dotted line.

The eigenvalues " =  $\frac{1}{2}$  of the coupled system represent two energy surfaces over the T<sub>c</sub>-" plane, the lower of which (ground state) is shown in Fig. 1a. The pulse Eq. (2) corresponds to a curve on the " surface. The corresponding change of the 'inversion' h<sub>z</sub> i<sub>t</sub> is obtained from a numerical integration of the (coherent) equation of motion for the density matrix of the system. The result is shown in Fig. 2, together with the form of the pulses Eq. (2).

In accordance with the adiabatic theorem, the initial groundstate j i of the system is rotated into the instantaneous superposition j i of j i and R i, Eq. (3), if the rotation is Slow', i.e., ;  ${}^{1};t_{0}{}^{1} = \sim$ . In this case, the time enters as a parameter into the state j i which is used to calculate the approximate expectation value

which excellently reproduces the overall form of the numerically obtained h  $_z i_t$ . The form Eq. (4) corresponds to C risp's solution for the adiabatic following of an atom in a near resonance light pulse<sup>41,42</sup>.

The exact solution exhibits the expected Rabioscillations with frequency (t)=~ around the adiabatic value, which are strongest when the tunnel coupling is fully switched on. Due to Landau-Zener tunneling from the adiabatic ground state j i to the excited state j+ i, there is always a nite albeit small probability P<sub>L</sub> for the electron to remain in the left dot, i.e., the excited state after the rotation.  $P_L$  can be made exponentially small for large enough level splitting and slow pulses, but depends on the exact pulse shape "(t);  $T_c$  (t).

#### B. Electron-Boson Coupling

The adiabatic rotation discussed above is an idealization and valid only for a two-level system completely isolated from its environment. In sem iconductor quantum dots, the coupling to low-energy bosonic excitations of the surrounding electron system, to photons, and to phonons leads to deviations from the coherent timeevolution. These excitations are characterized by an effective spectral density

of modes Q with frequency  $!_{Q}$  and constants  $g_{Q}$  coupling to the electron charge in the dot. In this paper, we only consider the coupling of phonons to the charge density which has been found to be dom inant coupling mechanism in double quantum dots<sup>3,5</sup>. O ther coupling mechanism s like inelastic spin- ip scattering<sup>11</sup> lead to additional dephasing channels, so that our results can only be considered as a lower bound on dephasing. On the other hand, the tim e-dependent spin-boson H am iltonian (~ = 1 throughout)

employed here (and derived in Appendix A) is of sucient general form for our results being transferable to sim ilar dissipative one-qubit rotations in other two-level system s.

The function (!) can be calculated explicitly if one assumes sharply peaked electron densities of negligeable width around the dot centers  $r_{\rm L\,=R}$ , having a distance d and zero extension into the z (growth) direction. For bulk piezo-electric phonons, one obtains^{10}

where g is a dimensionless coupling constant and  $!_d = c=d$ , with c the velocity of the phonon m ode. In general, a nite extension 1 of the electron densities in lateral or grow th direction leads to a form factor that cuts o phonons with frequencies ! & l=c (phonon bottleneck').

A microscopic determination of (!) would require (apart from details of the microscopic electron-phonon interaction potential) exact know ledge of the many-body electron density in the dots. We argue that the assumption of relatively sharply localized positions between which the additional electron tunnels is justimed by the strong intra-dot electron-electron repulsion<sup>43</sup>. The origin of the oscillatory form of Eq.  $(7)^{10}$  lies in the double-slit like scattering of the phonons (waves with wave vector Q) at the electron charge that is delocalized between the two dots.

In the spin-boson problem, one often assumes a parametrized form of the spectral density  $^{44}$ ,

where  $!_{\rm c}$  is a high-frequency cut-o . Notice that the ohm ic case s=1 describes the microscopic form  $_{\rm pz}$  (!), Eq. (7), in the lim it  $!_{\rm d}=!$  ! 0. However, phonons interacting with the dot through other coupling mechanisms s like the deform ation potential coupling, surface acoustic waves^{45}, or Rayleigh-Lamb waves in con ned geom etnies^{39}, lead to other form s of the spectral density

(!). Throughout the discussion of the one-qubit dynam – ics, we will assume the simple ohm ic form, Eq.(8) with s = 1, and return to the form Eq. (7) in the discussion of the two-qubit in section IV.

## C. Equations of M otion in P resence of D issipation

The coupling to the bosonic bath introduces decoherence and in general (exceptions are discussed below) leads to a loss of delity of the adiabatic rotation, i.e. even for very slow and adiabatic pulses "(t);  $T_c$ (t), the transfer from the left to the right state remains in perfect with the nal expectation value h <sub>z</sub> i considerably deviating from 1. During the rotation, the pure adiabatic state decays into a mixture.

W e solve for the reduced density matrix (t) of the twolevel system coupled to external electron reservoirs<sup>9,10,46</sup>. D i erent techniques can be applied for weak boson coupling (perturbation theory) and strong boson coupling (polaron transformations or path integral in N IBA' approximation<sup>38,47</sup>). In general, to obtain the solution for im e-dependent spin-boson problem s even num erically is a non-trivial task<sup>38</sup>.

From the Liouville-von N eum ann equation, the diagonalelem ents of (t) are easily obtained as

where we have included the coupling to the electron reservoirs (see Fig. 1) with the tunnel rates (j = L; R)

where  $f_j$  is the Ferm i distribution in lead j and  $_j$  the rate for tunneling between dot j and lead j.

The equations for the o -diagonal elements  $_{RL}(t) = _{LR}(t) = hLj(t)$  R i can be obtained only approximatively by performing a perturbation expansion in either g or T<sub>c</sub>:

#### 1. Born-Markov Approximation

In the rst approach, one starts from the basis of the hybridized states j i and considers the term  $\hat{V} \coloneqq \frac{1}{2}\hat{A}_z$  in the H am iltonian Eq.(6) as a weak perturbation. If " and T<sub>c</sub> were constant, one could easily de ne an interaction picture with respect to H<sub>0</sub>  $\coloneqq$  H  $\hat{V}$  and proceed in the standard way, i.e. second order perturbation theory and tracing out of the bosonic degrees of freedom s. However, when "(t) and T<sub>c</sub> (t) become a function of time, the time-evolution of the unperturbed system in general can not be written down analytically which makes the evaluation of the electron-boson term s very tedious.

Here, we use an adiabatic approximation by regarding the timet in "(t) and  $T_c(t)$  as a parameter for the derivation of the incoherent (electron-boson) part of the master equation for  $_{LR}(t)$ . We neglect memory elects of the bosonic system and derive  $_{LR}(t)$  up to second order in  $\hat{\nabla}$  (Born-Markov approximation). The bosonic environment enters solely via the correlation function of the operator  $\hat{A}$ , Eq. (6), in the interaction picture, K (t) = hA (t)A (0) i which yields

One should also keep in m ind that within our adiabatic approximation, these rates are time-dependent through the time-dependence of "(t),  $T_c(t)$ , and = (t) =

## 2. Polaron Transform ation

O ne can derive an equation for the o -diagonal  $_{LR}$  (t) in a second, alternative approach by performing a unitary polaron transform ation of the original H am iltonian. This method basically is a perturbation theory in the tunnel-coupling T<sub>c</sub> and suitable for strong coupling to the bosonic bath. The unitary transform ation

## D. Dissipative A diabatic Transfer

In order to discuss the e ect of dissipation on the adiabatic transfer, we now num erically evaluate and com pare the equations of motion for the density matrix (t) in both the perturbative and the polaron transform ation approach. Here, we consider a closed two-level system without coupling to external electron reservoirs  $(_{\rm L} = _{\rm R} = 0)$  and comment on the bpen'system case ('quantum pump') below. The boson spectral density  $(!) = s_{\pm 1}(!), Eq. (8), always has ohm ic form.$ 

First, the strong coupling equations Eq. (9) and Eq. (19) can be condensed into a closed equation for  $h_z i_t$  as




FIG. 3: Two-level system as in Fig. (2), but with (weak) dissipation at nite tem peratures T. C om parison between the strong coupling polaron transform ation (PT) solution and the perturbative solution is made.

This single integro-di erential equation<sup>38</sup> can be solved by standard num erical techniques. Results from both the perturbative approach, Eq.(13) and Eq.(9), and the polaron transform ation, Eq.(21) are shown in Fig.(3) for the weak coupling regime (g = 0.01), where the same form of pulses Eq.(2) as in the coherent case, Fig.(2), has been chosen.

We rst checked in a separate calculation that the inuence of the imaginary parts Imf g, Eq. (B1), on the solution of the master equation Eq. (13) is negligible. The perturbative inclusion of dissipation at low temperatures leads to the expected, sm all change of the tim eevolution of h<sub>z</sub>i, with h<sub>z</sub>i saturating slightly above the 1 of the coherent case. This means that value h  $_z$ i = in the dissipative case, the one-qubit rotation, i.e. the transfer of the electron from left to right, is never com plete even if the rotation is perform ed adiabatically. W e will derive an analytic expression for this loss of delty in presence of dissipation in section III.

In comparison to the perturbative approach, the polaron transform ation approach breaks down at weak couplings g and low temperatures where it predicts inversions below 1 towards the end of the rotation. This breakdown if well-known from the static case  $(T_{c}, "$ xed). On the other hand, the results from the polaron approach agree fairly well with the perturbative results at higher tem peratures, as can be clearly infered from Fig. (3) which again is consistent with the spin-boson dynamics for xed  $T_{\rm c}$  and ".

#### III. FIDELITY OF ONE-QUBIT SWAP

The previous discussion has shown that the adiabatic transfer remains incom plete in the presence of dissipation, i.e. h<sub>z</sub>i can considerably deviate from its nondissipative value 1 in the perfectly adiabatic case where no Landau-Zener transitions occur. Our aim in this sec-

tion is to analyze how the deviation

depends on temperature, boson spectral density (!), and the duration of the swap operation. Intuitively, it is clear that for too long swap duration, inelastic transitions to the excited levelw illhave su cient time to destroy the coherent transfer. On the other hand, if the swap operation proceeds too fast, Landau-Zener transitions become e stronger and again lead to deviations h<sub>z</sub>i > 0. This means that for any given inelastic rate <sub>in</sub> there should be an optimal swap duration such that these two competing processes balance each other.

O ne problem in quantifying this argument is that in naturally is time-dependent itself. Silvestrini and Stodolsky nevertheless have suggested<sup>49</sup> to extract decoherence rates in experiments by performing an adiabatic sweep and determining the maximum sweep duration for which the inversion is still successfull. How ever, their modelofa B loch equation (with in as a constant parameter) is too simple in order to make detailed quantitative predictions here.

In the following, we calculate the deviation h $_{\rm z}\,i_{\rm t}$  for both weak and strong electron-boson coupling and derive analytic expressions that allow to quantify the arguments above. The main physical idea in this discussion is the introduction of curves (ellipses in the "-T\_c plane) where the excitation energies

remain constant as a function of time and consequently, dissipation is determined by a constant boson spectral density ().

## A. Transfer R ate: Exact Solution for R abi R otation and W eak D issipation

In the weak coupling case, we follow Griffoni and Hanggi<sup>38</sup> and perform a unitary transformation of the original Ham iltonian (6) to a Ham iltonian H = UHU <sup>1</sup>,

Elliptic' pulses  $(T_c(t);"(t))$ , Eq. (23), are de ned by curves on the "-surface (Fig. 1) with constant energy di erence to the excited state "  $_+$ . For the particular sinusoidal form




FIG.4: Inversion change h  $_{z}i_{f}$  after time t<sub>f</sub> = = for sinusoidal pulses Eq.(27) as obtained from the master equation, Eq.(13). Dotted curves correspond to the analytical prediction, Eq. (31).

Results for the inversion change  $h_z i_f$  from the ideal value  $h_z i_f = 1$  as a function of the pulse frequency for a half-period sweep (duration  $t_f = =$ ) are shown in Fig. (4). We compare the results from the (weak-coupling) master equation, Eq.(13), and the analytical

prediction Eq.(31). The agreem ent between the num erical and the analytical prediction (dotted lines), is extrem ely good for sm all coupling constants (g = 10<sup>3</sup>), but deviations become estrong at sm all where the sim ple second order perturbation theory becomes worse. The 1= dependence of the dissipative contribution to h<sub>z</sub> i<sub>f</sub> is clearly visible at sm all , indicating that for too long pulse duration the electron swap remains incom plete due to incoherent dissipation. On the other hand, if the pulse duration is too short (larger ), the oscillatory coherent contribution from h<sub>z</sub> i<sub>f</sub><sup>R abi</sup> dom inates.

O ne should bear in m ind, how ever, that Eq. (31) is an approximation that only holds in the limit of an in nitely slow adiabatic change, i.e.  $t_f = = ! \ 1$ . In fact, for any nite pulse duration  $t_f < 1$ , even in the limit of zero temperature T = 0, Eq. (26) yields

which shows that there is a small, but nite probability for inelastic processes during transitions from j i to j+ i even at zero temperature, in agreement with<sup>38</sup>. These processes are due to the spontaneous emission of bosons which occur during Landau-Zener transitions from j i to j+ i with a nite probability as long as t<sub>f</sub> is nite.

#### B. Transfer R ate: C rossover for Strong C oupling

For strong electron-boson coupling constants g, we used Eq. (21) to extract the nal inversion h  $_z i_f$  after the tim e t = t<sub>f</sub> for the pulse Eq.(2). An interesting observation can be made in the tem perature behavior of h  $_z i_f$ : for couplings g. 2, a tem perature increase leads to an increase of h  $_z i_f$ , which is as in the weak coupling case. However, above g & 2, the tem perature dependence changes in that larger tem peratures T lead to sm aller values of h  $_z i_f$ . In fact, for large coupling constants g, the system tends to remain localized in the left dot state  $J_i$  and no tunneling to the right state R i occurs. In this regime, higher tem peratures destroy the localization and lead to sm aller h  $_z i_f$ . This behavior again is consistent with the borderline g = 2 ( = 1)<sup>44</sup> in the dissipative two-level dynam ics<sup>50</sup> for static parameters " and T<sub>c</sub>.

# C. A diabatic Q uantum P um ping in O pen D ouble D ots

In the rem ainder of this section, we discuss how results for the closed double dot system, and in particular the coherent and incoherent inversion swap deviation h  $_{z}i_{f}$  like the one for the Rabi rotation, Eq. (31), relate to electron transport in a double dot system coupled to external leads. Here, we only consider the weak dissipation case.




FIG.5: Inversion  $h_z$  i for strong electron-boson coupling after application of the pulse  $T_c$  (t) and "(t), Eq. (2), as in Figs. (2) and (3). Clearly visible is the crossover at g 2 where the tem perature dependence changes.




FIG. 6: A diabatic scheme for cycling electrons from left to right through a double quantum dot with energy level di erence "(t) = "L (t) "<sub>R</sub> (t). Left and right energy levels are assumed to change symmetrically with respect to " = 0.

The main idea is to apply tim e-dependent pulses such that the quantum mechanical time evolution of the twolevel system is well separated from a merely classical' decharging and charging process. One com plete cycle of such an operation is sketched in Fig. 6. The cycle starts with an additional electron in the left dot and an adiabatic rotation of the parameters  $("(t); T_c(t))$  such as, e.g., in Eq. (27) or in Eq. (2), cf. Fig. 6 a-b. This com pletely quantum -m echanical part of the cycle is perform ed in the 'save haven' of the Coulom b- and the Pauli-blockade<sup>51</sup>, ie, with the left and right energy levels of the two dots wellbelow the chemical potentials of the leads (which are assumed identical here for simplicity). The cycle continues with closed tunnel barrier  $T_c = 0$  and increasing " $_{\rm R}$  (t) (Fig. 6 c); the two dots then are still in a superposition of the left and the right state. The subsequent lifting of the right level above the chem ical potential of the right lead (Fig. 6 d) constitutes a measurement of that superposition (collapse of the wave-function): the electron is either in the right dot (with a high probability 1  $\frac{1}{2}$  h<sub>z</sub> i<sub>f</sub>) and tunnels out, or the electron is in the left dot (and nothing happens because the left level is still below and the system is Coulom b blocked).

If the tunnel rates  $_{\rm R}$ ;  $_{\rm L}$  to the right and left leads are su ciently larger than the inverse of the cyle duration  $t_{\rm cycle}$ ,

the decharging of the right dot and the re-charging of the left dot from the left lead is fast enough to bring the system back into its initial state with one additional electron on the left dot. In this case, the precise value of R; L, and the precise shape of the "(t)-pulse for  $t_f < t < t_{cycle}$  has no e ect on the total charge transfered within one cycle. Then, since the probability to transfer one electron from the left to the right in one cycle is given

ows from left to right. Note that the leads essentially act as classical measurement devices of the quantum – mechanical time-evolution between the two dots. Measuring the current hIi as a function of the pulse length  $t_f =$  = then o ers a scheme to make quantum mechanical oscillations such as those predicted in Eq. (31) visible in the electronic current, similar to the recent experiment by Nakamura et al. in a superconducting Cooper pair box<sup>16</sup>.

#### D. D iscussion

The Rabipulse', Eq. (27), keeps the energy di erence to the excited state j+ i constant throughout the adiabatic rotation. In this case, it follows that the dissipative contribution to h<sub>z</sub> i<sub>f</sub>, Eq.(31), is due to (! = =~), i.e., one xed boson frequency only. Furtherm ore, the analytic result, Eq.(31), in principle allows to extract the value of the phonon spectral density, (), for Rabi'pulses at xed energy di erence .

A nother in portant observation is the fact that the rotation remains dissipation-free if is chosen to coincide with a zero of (!). This de ness a decoherence-freem anifold' in the parameter space of the system. Zeroes in (!) at certain frequencies  $! = !_0$  have been predicted<sup>39</sup> in free-standing, two-dimensional phonon cavities (slabs). In fact, the control of vibrational properties of quantum dot qubits has been suggested<sup>3</sup>, and considerable progress has been made in the fabrication of nanostructures that are only partly suspended or even freestanding<sup>52</sup><sup>{54</sup></sup>. In a thin-plate cavity model<sup>39</sup>, the zeroes in (!) are due to symmetry and geometrical connement both for deformation potential and piezoacoustic phonon scattering in second order of the coupling constant g. This means that within a phonon cavity, the dissipative contribution to  $h_z i_f$ , Eq. (31), can be Switched o ' if is tuned to the energy ~!\_0 of a decoupled phonon mode.

For GaAs slabs of width 1 m, this energy has been predicted to be of the order  $\sim !_0$ 10 eV. An energy = 10 eV corresponds to  $k_{\rm B}T$ 100mK such that the tem peratures shown in Fig. 4 are attainable in current experiments. A typical pulse frequency =2 =  $0:01 = 2 \sim \text{then would correspond to } 24 \text{ MHz}$ , the corresponding current being of the order hIi e =2 4pA . Furtherm ore, we mention that the weak coupling regime withg 0:01 0:05 seems to be justi ed to describe recent experim ents on phonon coupling in double quantum  $dots^{3,5}$ .

## IV. SPIN-QUBIT SWAPAND DECOHERENCE IN TWO-QUBITS

In this section, we apply our form alism to spin-qubit swaps and charge decoherence in two-qubit operations. These requires larger H ilbert spaces and can be realized by two electrons on a double dot. Loss and D iV incenzo have introduced a detailed scheme for quantum com putation' with spin-states of coupled single-electron quantum dots<sup>6</sup>. Dephasing of spin degrees of freedom due to spin-orbit coupling or the coupling to nuclear spins is expected to be m uch weaker than dephasing of charge degrees of freedom. N evertheless, spin and charge become e coupled during switching operations whereby charge dephasing also e ects spin-based qubits<sup>6,7</sup>.

Here, we consider a speci c two-qubit swap operation as discussed recently by Schliem ann, Loss and M acD onald: two electrons with spin are localized on two coupled quantum dots A and B, giving rise to a basis of six states. D uring the operation charge decoherence occurs for interm ediate states that get involved in the swap operation when charge is tunneling between the dots. P iezoelectric phonons then couple to the electron charge and incoherently m ix states in the singlet sector which leads to a loss of delity of the swap operation. As in the previous section, we only consider the coupling of phonons to the charge density which yields a low er bound for dephasing.

## A. Two-Qubit Ham iltonian

The four basis vectors with the two electrons on di erent dots are the spin singlet and triplets

This operation leads out of the subspace spanf  $\beta_1$  i;  $\mathbf{J}^0$  ig since it involves interm ediate doubly occupied states in spanf  $\mathbf{j}_1$  i;  $\mathbf{\mathfrak{R}}$  ig (= spanf  $\beta_2$  i;  $\beta_3$  ig) which altogether de ne a four-dimensional H ilbert space, H <sup>(4)</sup>, in which the two-qubit swap takes place. To be more speci c<sup>7</sup>, we use a basis of H <sup>(4)</sup> as given by the three singlets  $\beta_j$  i and the triplet  $\mathbf{J}^0$  i,

The coherent part of the time evolution of the  $_{ij}$ (t) is obtained trivially from the Liouville equation, using the H am iltonian H  $_0^{(2)}$ (t), Eq. (40). The non-trivial part are the additional term s due to the electron-phonon coupling. A system atic perturbation theory in the latter starts from the four adiabatic eigenstates of the unperturbed H am iltonian H  $_0^{(2)}$ (t), Eq. (40).

Here, we restrict ourselves to the case of sm all tunnel coupling,

where inelastic transitions are determ ined by the dynamics in the subspace spanned by the states  $\frac{1}{2}$  i and  $\frac{1}{3}$  i and admixtures from jli through the hybridization between jli and  $\frac{1}{2}$  i can be neglected. This case is particularily interesting since the (adiabatic) energy di erence 2X between  $\frac{1}{2}$  i and  $\frac{1}{3}$  i rem ains constant throughout the operation. As we show below, if 2X coincides with a zero  $\sim !_0$  of the boson spectral density, the operation is again dissipation-less in second order of the electron-boson coupling.




FIG. 7: Expectation value 1 hfj (t) fi for a two-electron double dot qubit swap from initial state ji to nal state jfi, Eq. (38), as a function of time (in units of  $U_{\rm H} = -$ ,  $U_{\rm H}$ : on-site C oulom b repulsion). The corresponding dephasing times (g > 0) are (from top to bottom) <sup>1</sup> = 84, <sup>1</sup> = 169 and <sup>1</sup> = 635. Inset: hij (t) ji and hfj (t) fi for vanishing phonon coupling g = 0.

In Fig. (7), we show results of a numerical evaluation of the two-electron m aster equation. The spectral density  $_{pz}$  (!), Eq. (7), was used to obtain the rates, Eq. (45), for di erent coupling strengths g and energies ~! d (! d = c=d, with c the speed of sound and d the dot center distance). U sing  $U_{\rm H} = 1$  as energy scale, our results coincide with those of Schliem ann et al. for g = 0 with a pulse of the form  $^{13}$

cf. Eq. (38). Even in absence of dissipation, the nonadiabacity of the operation results in a nite value of hfj (t) jfiafter the swap<sup>13</sup>. The electron-phonon in-1 teraction acts when charge between the dots is moved during the opening of the tunneling barrier. Consequently, the two states 2i and Bi become mixed incoherently, leading to a nite, irreversible occupation probablity of the energetic low er state Bi even after the pulse operation. W e m ention that the data shown here correspond to a worst case scenario where the inelastic rate , Eq. (45), is essentially determined by a large energy di erence 2X between 1/2i and Biwhich enters into ( = 2X). Then, spontaneous em ission of phonons occuring during the slow swap (cf. Eq. (43)) leads to a gX. In this case, even relatively dephasing rate small values of g (g . 0:05 in experiments on lateral dots<sup>3,10</sup>) can lead to a considerable delity loss of the operation.

O n the other hand, our results also dem onstrate that a complete suppression (at least to low est order in g), sim ilar to the one-qubit case discussed above, is theoretically possible for the two-qubit swap in phonon cavities. If is tuned to the energy  $\sim !_0$  of a decoupled phonon m ode, the inelastic rates, Eq. (45), can be 'switched o ' and the operation again is dissipationless'.

#### V. CONCLUSION

In conclusion, we have studied adiabatic quantum state rotations in coupled quantum dots in presence of dissipation. For the one-qubit case, we suggested a scheme to extract quantum oscillations in the inversion change h  $_z i_f$  from the average pump current through the dots, Eq. (34). The analytic result, Eq.(31), furtherm ore allows to extract the value of the phonon spectral density, (), for Rabi'-pulses at xed energy di erence .

For the two-qubit case, we have quanti ed the e ect of dissipation on a swap operation, where states in the singlet sector are incoherently mixed. A lthough we have only considered the case of sm all tunnel coupling between the dots, as in the one-qubit case we have found that twoqubit rotations can be performed such that dissipation is due to (! = = -), i.e., one xed boson frequency only. If is chosen to coincide with a zero of (!) as in freestanding phonon cavities, this de nes a blecoherence-free m anifold' in the parameter space of the system.
