G round-state properties of a dilute Bose-Ferm im ixture

We investigate the properties of a dilute boson-ferm ion mixture at zero temperature. The ground-state energy of the system is calculated to second order in the Bose-Ferm i coupling constant. The Green's function form alism is applied to obtain results for the elect of Bose-Ferm i interactions on the spectrum of phonon excitations, the momentum distribution, the condensate fraction and the super uid density of the bosonic component. A quantitative discussion of these elects is presented in the case of mixtures with attractive interspecies interaction.

I. IN TRODUCTION

Recent experim ental achievem ents in the trapping and cooling of mixtures of bosonic and fermionic atoms have attracted much attention on the physics of dilute Bose-Ferm im ixtures in the quantum degenerate regim e. Stable Bose-Einstein condensates (BEC) imm ersed in a degenerate Fermi gas have been realized with ⁷Li in ⁶Li [1], ²³Na in ⁶Li [2] and very recently with ⁸⁷Rb in ⁴⁰K [3]. In particular, the ${}^{87}\text{Rb}{}^{-40}\text{K}$ m ixture appears to be highly interesting because of the large and negative interspecies scattering length which favours the stability of the mixture. Current theoretical investigations of dilute Bose-Ferm im ixtures have mainly addressed the determ ination of the density proles of the two components in trapped systems [4], the problem of stability and phase separation [5,6] and the BEC-induced interaction between ferm ions [7]. The e ect of boson-ferm ion interactions on the phonon excitation spectrum has been investigated in Refs. [8] and [9]. Further, perturbation theory has been applied to the calculation of the groundstate energy in the regime of high ferm ion concentration by A lbus et al. [11], whereas the opposite regime of low ferm ion concentration has been investigated long ago by Saam [10].

In the present paper we consider a homogeneous dilute mixture of a normal Fermigas and a Bose-Einstein condensed gas at zero temperature. We calculate the ground-state energy of the system to second order in the Bose-Ferm i coupling constant, interpolating between the high and low ferm ion concentration regimes, and obtain results for the dispersion of phonon excitations, including corrections to the sound velocity and Landau damping. In addition to these results, we focus on the e ect of boson-ferm ion interactions on the momentum distribution of the bosonic component, on the depletion of the condensate state and on the super uid density. We nd that the boson momentum distribution can be strongly a ected by the ferm ions, resulting in a suppression of the occupation of low momentum states and in a long tail at large m om enta. W e also point out the possible

occurrence of striking features caused by the Bose-Ferm i coupling, such as the increase of the condensate fraction compared to the pure bosonic case and the super uid density becoming smaller than the condensate fraction.

The structure of the paper is as follows. In Sec. II we introduce the basic H am iltonian of the system within the B ogoliubov approximation. In Sec. II A we calculate the ground-state energy by direct use of perturbation theory. In Secs. II B-D we introduce the G reen's function formalism which we apply to calculate the elementary excitation energies, the momentum distribution, the condensate fraction and the super uid density of the bosonic component. In Sec. III we comment on the stability of the mixture against phase separation and we present numerical results obtained for specic congurations of mixtures with attractive Bose-Fermicoupling. Finally, in Sec. IV we draw our conclusions.

II. THEORY

We consider a stable hom ogeneous mixture of a Bose gas and a spin-polarized Fermigas. The Hamiltonian of the system can be written as the sum

of the pure ferm ionic (H $_{\rm F}$) and bosonic (H $_{\rm B}$) H am iltonian, and of the interaction term (H $_{\rm int}$) which accounts for the coupling between the two species. If one neglects p-w ave interactions in the spin-polarized Ferm i gas, H $_{\rm F}$ corresponds to the H am iltonian of a free gas

where b_k , b_k^Y are the annihilation and creation operators of ferm ions and $\ _k^F = h^2 k^2 = 2 m_F$ is the energy of a free particle of m ass m $_F$. The pure bosonic component is described instead by the Bogoliubov H am iltonian

written in terms of the quasi-particle annihilation and creation operators $_k$, $_k^y$. These operators are related to the bosonic particle operators a_k , a_k^y through the well-known canonical transform ation

where $_{k}^{B}=h^{2}k^{2}$ =2m $_{B}$ is the free particle energy, n_{0} is the condensate density and $g_{BB}=4$ h^{2} a= m_{B} is the coupling constant between bosons xed by the mass m_{B} and the s-wave scattering length a which we assume positive. The constant term

is the ground-state energy of a dilute B ose gas expressed in terms of the gas parameter $n_{\rm B}$ a^3 , with $n_{\rm B}=N_{\rm B}=\!\!V$ the total density of bosons. Result (6) includes the zeropoint motion of the elementary excitations. Finally, the H am iltonian

describes the interaction between ferm ions and bosons through the coupling constant $g_{B\,F}=2~h^2b\text{-m}_R$, which can be either positive or negative depending on whether the interactions are repulsive or attractive. The coupling constant $g_{B\,F}$ is xed by the reduced mass $m_R=m_B\,m_F=(m_B+m_F)$ and by the modulus of the boson-ferm ion s-wave scattering length b. The constant term in the above equation corresponds to the mean-eld interaction energy, the second term describes the coupling between density uctuations in the two species. Within the Bogoliubov approximation the bosonic density uctuation operator can be written as a linear combination of quasi-particle operators

By using the above expression for $\ _{k}^{B}$, the total H am iltonian (1) takes the form

The H am iltonian (10) is treated in perturbation theory. Wew rite H = H $_0$ + H $_{\rm int}$, where H $_0$ = H $_{\rm F}$ + H $_{\rm B}$ is the unperturbed H am iltonian which is diagonal in the ferm ionic particle operators and in the bosonic elementary excitation operators, and

is the perturbation term . Since we make use of the pseudopotential approximation for both the boson-boson and the boson-ferm ion interatom ic potential, the present approach is valid if both gas parameters are small, i.e. if $n_{\rm B} \; a^3 - 1$ and $n_{\rm F} \; b^3 - 1$.

A . G round-state energy

The unperturbed ground-state energy can be readily calculated from the H $_{

where E $_{\rm B}$ is given by (6) and $_{\rm F}$ = $h^2\,k_{\rm F}^2$ =2m $_{\rm F}$ = h^2 (6 $^2\,n_{\rm F}$) $^{2=3}$ =2m $_{\rm F}$ is the Ferm i energy, $k_{\rm F}$ being the Ferm i wave-vector. The mean-eld term E $^{(1)}$ = $g_{\rm B\,F}\,N_{\rm B}\,n_{\rm F}$ provides the rst order correction to E $_0$. To second order in $g_{\rm B\,F}$ one obtains the result

where jni are the excited states of the unperturbed system with energy E $_{\rm n}$. The rst term in the above equation arises from E $^{(1)}$ due to the renormalization of the bpson-ferm ion scattering length $g_{\rm B\,F}$! $g_{\rm B\,F}$ + $g_{\rm B\,F}^2$ 1=V $_k$ $2m_{\rm R}$ = h^2k^2 . The second term is the standard result of second order perturbation theory. By directly calculating the matrix elements of the interaction H am iltonian H $_{\rm int}$, one nds the following result for the ground-state energy

where $n_{\rm q}^{\rm F}=(k_{\rm F}-q)$ is the momentum distribution of the Ferm i gas. We notice that the renormalization of the boson-ferm ion scattering length is crucial in order to cancel the ultraviolet divergence in the integral over the wave-vector k. The dependence on the relevant param eters become sclearer by expressing the integrals over wave-vectors in units of $k_{\rm F}$. Result (14) takes the form




FIG. 1. D im ensionless function A (w;) Eq. (16)] as a function of for the value w = 1 of the mass ratio.

In the above expression $w=m_B=m_F$ is the mass ratio and $=2=(k_{F-B})^2$ is a dimensionless parameter xed by the product of the Ferm i wave-vector k_F and the Bose healing length $_B=1=\frac{9}{8}\frac{1}{n_0a}$. In Fig. 1 we show the dependence of the function A (w;) on the parameter for a xed value w=1 of the mass ratio. Two regimes are worth studying at this point. The regime $k_{F-B}=1$ (1) corresponds to a system where the Ferm ienergy is much larger than the chemical potential of the bosons $_F=g_{B,B}n_0$ (we assume w'=1). In this regime, expression (16) can be simplied as it depends only on the mass ratio w:A(w; -1)=1 (w), where




FIG.2. Dim ensionless functions A_1 (w) Eq. (17)] (solid line) and A_2 (w) Eq. (19)] (dashed line).

In contrast to result (18), B ose-B ose interactions are important if $k_{\rm F-B}$ 1 and the second order correction depends explicitly on the B ose gas parameter. Result (20) has been 1st derived by Saam [10] for a dilute mixture with a = b. The dependence of A_1 and A_2 on the mass ratio w is presented in Fig. 2.

B.Phonon spectrum

In this subsection we calculate the e ect of ferm ions on the dispersion of the bosonic phonon branch. To this aim it is convenient to use the G reen's function form alism. The bosonic quasi-particle G reen's function is de ned as

where T (:::) is the time ordered product. Perturbation theory provides us with a precise recipe for calculating the G reen's function D (k;t) to a given order in H $_{\rm int}$

The real and imaginary part of the ferm ionic response function $^{\rm F}_0$ give rise respectively to a frequency shift and a damping of the quasi-particle. We are interested in the collective modes of the boson system which correspond to low momenta $!_k = g_{\rm B\ B} \ n_0$ and $k = k_{\rm F}$. In the regime $k_{\rm F} \ _{\rm B} = 1$ the ferm ionic density-density response function can be approximated by [12]

In the above expression the real part in the square bracket gives the correction to the Bogoliubov sound velocity $c_B = g_{BB} n_0 = m_B$, and the imaginary part gives the Landau dam ping of the phonon excitation due to collisions with the ferm ions. We notice that the correction to the sound velocity (second term in the square bracket) can be rewritten as N $(0)g_{BF}^2 = 2g_{BB}$, with N (0) = $m_F k_F = (2^{-2}h^2)$ being the density of states at the Ferm i surface. The stability condition requiring that the realpart of the excitation energy be positive, corresponds to the linear stability condition N (0) $g_{BF}^2 = g_{BB} < 1$ (see Sec. III). In the regime k_F B 1 the Bogoliubov phonon becomes soft when approaching the condition where the system phase separates. In the opposite regim e 1, the imaginary part of $\begin{bmatrix} F \\ 0 \end{bmatrix}$ vanishes at low m om enta and the renormalized velocity of sound of the undam ped phonon mode becom es

The dispersion of phonons in dilute m ixtures has also been discussed by Y ip [8] under more general conditions using a numerical approach. He also predicts a shift towards lower frequencies with Landau damping for $k_{\rm F\ B}$ 1, and towards higher frequencies with no damping for $k_{\rm F\ B}$ 1.

Thee ect of the Bose-Ferm i interaction on them om entum distribution of the bosons can be readily obtained by applying the perturbative approach to the bosonic single-particle G reen's function

By integrating n_k^B overm om enta one obtains the fraction of atom s which are scattered out of the condensate due to interaction. The quantum depletion of the condensate is given by

The rst term in the above equation corresponds to the B ogoliubov depletion present also in a pure bosonic system which is due to interaction e ects among the bosons. The second term accounts instead for boson-ferm ion scattering processes. The condensate fraction is obtained from the dierence N $_0$ =N $_B$ = 1 N 0 =N $_B$. By writing the integrals over wave-vectors in units of $k_{\rm F}$, result (36) reads




FIG. 3. D im ensionless function B (w;) Eq. (38)] as a function of for the value w = 1 of the mass ratio.

The dependence of the function B on the parameter is shown in Fig. 3 for the mass ratio w=1. In the regime $k_{\rm F\ B}$ 1 (1) the quantum depletion due to scattering processes with the fermions becomes independent of the Bose-Bose coupling constant and one nds




FIG. 4. D im ensionless functions B_1 (w) Eq. (41)] (solid line) and B_2 (w) Eq. (41)] (dashed line).

In Fig. 4 we plot the functions B_1 and B_2 of the mass ratio w. We notice that, while B_1 is always positive, B_2 is positive for small values of w and becomes large and negative when m_B m_F . Thus, if the fermions are light enough compared to the bosons, their e ect in the regime k_F B 1 is to enhance the occupation of the condensate state resulting in a decrease of the quantum depletion. Of course, when B_2 is negative, result (42) is valid only if the second term is small compared to the rst one.

A nother quantity of interest is the momentum distribution of the bosons given by eq. (35). For a pure system the momentum distribution is given by the well-known Bogoliubov result

which has been written in units of the inverse healing length $x=k_B$. At small momenta x=1, the momentum distribution is dominated by the quantum uctuations of phonons which give rise to the infrared divergence n_k^B ; $j_{ure}=1=8x$. At large momenta x=1, one nds instead the algebraic decay n_k^B ; $j_{ure}=1=4x^4$. The important question arises concerning the e ect of the fermionic component on n_k^B . In units of the inverse healing length result (35) reads

In a m ixture there are two characteristic wavenum bers in the problem: $_{\rm B}^{-1}$ and $k_{\rm F}$. The structure of the distribution is consequently richer and depends on how $_{\rm B}^{-1}$ com pares with $k_{\rm F}$. Nevertheless very interesting conclusions can be drawn in the two limits k $_{\rm B}^{-1}$; $k_{\rm F}$ and k $_{\rm B}^{-1}$; $k_{\rm F}$. At low momenta (k $_{\rm B}^{-1}$; $k_{\rm F}$) the elect

of the Bose-Ferm i coupling is to enhance the occupation of the condensate by stimulating scattering of particles from $k \in 0$ states into the condensate. The contribution to the momentum distribution is thus negative and reduces the coe cient of the 1=x divergent term

Notice that the modulus of the Bose-Fermi contribution can be written as N $(0)g_{B\,F}^2=2g_{B\,B}$ f $(2w^-)$ [see com-ment after Eq. (29)]. Phase stability of the mixture requires that in any case N $(0)g_{B\,F}^2=g_{B\,B}<1$. Since moreover 0<f (t) <1 for all t >0, we conclude that the Bose-Fermi term is always less, in modulus, than the Bose-Bose one and thus Eq. (45) is well de ned. It is also worth noticing that in the regime $k_{F\,B}$ 1 the function f ! 1 and n_k^B (c=g)= $\frac{1}{8}$ x, where c is the renormalized sound velocity from Eq. (29).

At large m om enta (k $_{\rm B}^{\rm 1}$; $k_{\rm F}$) the Bose-Ferm i coupling provides instead further depletion of the condensate and one $\rm nds$




FIG. 5. Dim ensionless function C (w;) [Eq. (55)] as a function of for the value w = 1 of the mass ratio.

In the regime $k_{F\ B}$ ~1 the shape of n_k^B can be very dierent compared to the pure case. In fact, the cut-om omentum increases from $_B^{-1}$ to k_F and them omentum distribution acquires a long tail at large momenta (see Fig. 5). The elect of the Bose-Fermi interaction on the momentum distribution and condensate fraction of the bosons has been calculated using variational methods in the hypermetted-chain scheme for the strongly correlated liquid $^3{\rm He}-^4{\rm He}$ mixture [13]. However, weak elects are found due to the low $^3{\rm He}$ concentration attainable in stable mixtures.

D . Super uid density

An important aspect of Bose-Ferm im ixtures concerns their super uid behavior. In a pure bosonic system at zero temperature the density of the normal component vanishes, $_{\rm n}$ = 0, and the system is completely superuid. In a Bose-Ferm imixture the normal density does not vanish and can be written as $_{\rm n}$ = m $_{\rm F}$ n in terms of the elective mass m $_{\rm F}$ of the fermionic particles. In the absence of Bose-Ferm i coupling, the elective mass coincides with the bare mass of the fermions, m $_{\rm F}$ = m $_{\rm F}$, and the normal density of the mixture coincides with

the mass density of the ferm ionic component. Interaction e ects dress the ferm ions resulting in an e ective mass larger than the bare mass. A well known exam ple is provided by liquid ${}^{3}\mathrm{H}\,\mathrm{e}^{-4}\mathrm{H}\,\mathrm{e}$ solutions, where due to the strong correlations the e ective mass of ³He atoms is $m_F = m_F ' 2:3 [14]$. An equivalent way of interpreting the excess of normal density in Bose-Fermin ixtures is to write $_{n}$ = m $_{F}$ n $_{F}$ + $_{n}^{B}$, where $_{n}^{B}$ is the contribution arising from the excitation of bosonic quasi-particles due to the Bose-Ferm i coupling. In Fig. 5 we show the dependence of the above function on the param eter =2=($k_{\rm F}$ $_{\rm B}$) 2 for the value w = 1 of the m ass ratio. In the regime $k_{\rm F}$ $_{\rm B}$ 1 the function C becomes independent of the param eter and result (54) takes the form




FIG. 6. D im ensionless functions C_1 (w) Eq. (58)] (solid line) and C_2 (w) Eq. (59)] (dashed line).

Result (58-59) is in agreement with the $\,$ nding of Ref. [10] where the ferm ion elective mass has been calculated for $k_{\rm F-B}-1$ in the case of equal scattering lengths a = b. In Fig. 6 we show both C $_1$ and C $_2$ as a function of the mass ratio.

III. NUM ERICAL RESULTS

In deriving the above results we have been completely general. In this section instead, we look at their implications on actual physical systems and we discuss more quantitatively the striking consequences of the presence of fermions on the Bose-Einstein condensate which we have pointed out.

First of all we have to spend a few words on phase stability. The obvious requirement for all of the above to be valid is that bosons and ferm ions mix in the rst place. According to the ndings of ref. [5] one has to separately analyze two cases: attractive Bose-Fermi interaction, i.e. $g_{B\,F} < 0$, and repulsive one, i.e. $g_{B\,F} > 0$. The former case is simpler, as the only requirement is that arising from linear stability: N $(0)g_{B\,F}^2 = g_{B\,B} < 1$, where N $(0) = m_F k_F = (2^{-2}h^2)$ is the density of states at the Fermi surface. This condition is an upper limit on the fermionic density irrespective of the bosonic one

If instead $g_{B\,F}$ is greater than zero, while the ferm ionic density cannot in any case be larger than $n_{F\,\mu m\,a\,x}$, yet for every $n_F~<~n_{F\,\mu m\,a\,x}$ there is a critical $n_{B\,;c}\,(n_F\,)$ at which the system phase separates anyway. The function $n_{B\,;c}\,(n_F\,)$ is non trivial, and one has to check speci cally for a given pair of elements and densities whether the system is stable or not.

For this reason it is certainly easier to observe importante ects in a mixture where $g_{\rm B\ F}$ is negative, as one can reach higher densities without running into problem s. On the other hand, since our calculations are to order $g_{\rm B\ F}^2$ all e ects computed here are identical for both signs of $g_{\rm B\ F}$.

A m ixture with negative $g_{B\,F}$, and supposingly large b, is already available experimentally. This is the 40 K $^{.97}$ Rb m ixture recently reported in ref. [3]. According to the authors b= 300 (100)a_0 in units of the Bohr radius.

W e consider a m ixture of $^{87}\text{R}\,b$ and $^{40}\text{K}\,$ w ith densities $n_B=n_F=3$ 1^{10} cm 3 . For the scattering lengths we use a =110a_0 and b=300a_0, and the mass ratio is w=2.175. The value of the parameter k_F $_B$ is 3.9.




FIG .7. Boson m om entum distribution of a ^{87}Rb ^{-40}K m ixture (solid line). The m om entum distribution of a pure system (short dashed) and the Bose-Ferm icontribution (long dashed) are also shown. In the gure as in the text x stands for k $_{\rm B}$.




FIG. 8. Condensate depletion and normal uid fraction of a $^{87}\text{Rb}-^{40}\text{K}$ m ixture as a function of the ferm ion density. The total condensate depletion is shown with the solid line. The Bogoliubov and the ferm ion depletion are shown respectively with the horizontal short-dashed line and the long-dashed line. The dotted line corresponds instead to the normal uid fraction.

In Fig. 7 we show results for the boson momentum distribution of the mixture, obtained from Eq. (44) with the parameters given above, compared with the one of a pure system [eq. (43)]. The total value of the quantum depletion is 3% for this conguration and the Bose-Bose and Bose-Fermicontributions are 1% and 2% respectively (see Fig. 8). We see a large elect due to boson-fermion interactions. The momentum distribution at low momenta is depressed while at large momenta is considerably enhanced and a tail appears which extends to very large momenta.

In Fig. 8 we report results on the dependence of the condensate depletion and normal uid fraction as a function of the ferm ion density $n_{\rm F}$. The boson density has been xed to 3 $\,^{10}$ cm 3 . W ith the above values of the parameters the system becomes unstable at a ferm ion density of 5.2 $\,^{10}$ cm 3 . W e see that, by increasing the ferm ion density, both the condensate depletion and the normal uid fraction increase. The prediction for ferm ion densities close to the instability threshold gives N $^{0}\!\!=\!\!N_B$ 4% and $^{B}_{n}$ = $_{B}$ 2% .




FIG.9. Condensate depletion (solid line) and normal uid fraction (dotted line) of a hypothetical m ixture with mass ratio m $_{\rm B}$ =m $_{\rm F}=0.1$ as a function of the ferm ion density.

In Fig. 9 we show the condensate depletion and the norm al uid fraction of a hypotheticalm ixture with m ass ratio m $_{\rm B}$ =m $_{\rm F}$ = 0.1. We also assume $g_{\rm B\,F}$ < 0 and we have xed the scattering lengths to a = 100a $_{\rm 0}$ and b = 50a $_{\rm 0}$, and the boson density to $n_{\rm B}$ = 3 $\,10^{\circ}$ cm 3 . Such system becomes unstable for $n_{\rm F}$ 1.0 $\,10^{\circ}$ cm 3 . We see that an increase of $n_{\rm F}$ is followed by an increase of both the condensate depletion and the norm al uid fraction. However, at the fermion density $n_{\rm F}$ 2 $\,10^{\circ}$ cm 3 , the norm al uid fraction becomes larger than the condensate depletion. This e ect has been rst discussed in cons

nection with disordered dilute Bose gases by Huang and Meng [16] and very recently has been explicitly proved in a Bose gas with quenched impurities using quantum Monte-Carlo techniques [17]. It is striking that the same elect is found for Bose-Ferm imixtures in regimes of high ferm ion concentration when m $_{\rm F}$ m $_{\rm B}$.




FIG.10. Condensate depletion and normal uid fraction of a hypothetical m ixture with mass ratio m $_{\rm B}$ =m $_{\rm F}$ = 20 as a function of the ferm ion density. The line codes used are the same as for Fig. 8.

Finally, in Fig. 10 we present results of the condensate depletion and normal uid fraction of a dierent hypothetical mixture with mass ratio m $_{\rm B}$ =m $_{\rm F}$ = 20. We assume again an attractive Bose-Fermi coupling (g $_{\rm B\,F}$ < 0) and we use the following parameters: a = 100a0, b = 150a0 and n $_{\rm B}$ = 3 $\,1^{\rm to}$ cm $^{\rm 3}$. The mixture becomes unstable for n $_{\rm F}$ 2:3 $\,1^{\rm to}$ cm $^{\rm 3}$. In this case we see a dierent striking behavior: for low fermion concentration the elect of the Bose-Fermi coupling is to stimulate the occupation of the condensate, resulting in a quantum depletion smaller than in the pure case.

Due to the smallness of the e ects, the interest of the results reported in Figs. 9 and 10 is to show that they can actually occur in realistic mixtures, though it might be dicult to observe them with present techniques.

IV.CONCLUSIONS

We have studied the properties of a dilute Bose-Ferm i mixture at zero temperature using a perturbation approach. We have investigated both equilibrium properties, such as the ground-state energy, the boson momentum distribution and the normal uid fraction, and dynam ic properties such as the dispersion law and dam ping of phonon excitations. The system is very rich. By varying the mass ratio, the densities and the scattering lengths of the two components one can obtain very dierent regim es where striking e ects due to boson-ferm ion interactions can occurr. These include: the strong suppression of the boson m om entum distribution at low momenta, localization e ects exhibited by the super uid density which becomes smaller than the condensate fraction and stimulated scattering of bosons into the condensate.
