## A bsence of F irst-order T ransition and T ri-critical P oint in the D ynam ic P hase D iagram of a Spatially Extended B istable System in an O scillating F ield

It has been well established that spatially extended, bistable systems that are driven by an oscillating eld exhibit a nonequilibrium dynamic phase transition (DPT). The DPT occurs when the eld frequency is on the order of the inverse of an intrinsic lifetim e associated with the transitions between the two stable states in a static eld of the same magnitude as the amplitude of the oscillating eld. The DPT is continuous and belongs to the same universality class as the equilibrium phase transition of the Ising model in zero eld [G.Komiss et al., Phys. Rev. E 63, 016120 (2001); H.Fujisaka et al., Phys. Rev. E 63, 036109 (2001)]. However, it has previously been claim ed that the DPT becomes discontinuous at temperatures below a tricritical point M. A charyya, Phys. Rev. E 59, 218 (1999)]. This claim was based on observations in dynamic M onte Carlo simulations of a multipeaked probability density for the dynam ic order parameter and negative values of the fourthorder cum ulant ratio. Both phenom ena can be characteristic of discontinuous phase transitions. Here we use classical nucleation theory for the decay of metastable phases, together with data from large-scale dynam ic M onte C arlo simulations of a two-dimensional kinetic Ising ferrom agnet, to show that these observations in this case are merely nite-size e ects. For su ciently sm all systems and low temperatures, the continuous DPT is replaced, not by a discontinuous phase transition, but by a crossover to stochastic resonance. In the in nite-system limit the stochastic-resonance regime vanishes, and the continuous DPT should persist for all nonzero tem peratures.

#### I. IN TRODUCTION

M etastability and hysteresis are exhibited by num erous natural and arti cial system s that are driven away from therm odynam ic equilibrium by an external \ ekd." In the absence of such a ekd, and below some critical temperature or analogous control parameter, a large class of such system spossess two equivalent, symmetry-broken ordered phases. The external eld selects one of these ordered phases as the global, stable minimum in the multidimensional freeenergy landscape. The other ordered phase becomes metastable, separated from the basin of attraction of the stable phase by a free-energy barrier. If the system is initially prepared in the metastable phase and therm all uctuations are present, the system eventually (possibly after an extrem ely long time) escapes from the metastable free-energy well and approaches stable equilibrium. In the present paper we consider the response of a spatially extended, bistable system driven by an external eld which is periodic in time. In particular, we focus on the nite-size e ects of the periodic system response.

Ferrom agnets are perhaps the most commonly known systems that exhibit metastability and hysteresis. In this paper we therefore use magnetic language, in which the order parameter is the system magnetization m, and its conjugate eld is the external magnetic eld H. A nalogous interpretations, e.g., using the terms \polarization" and \electric eld" for ferroelectric systems, \coverage" and \electrochem ical potential" for adsorbate system s, etc., are straightforward [1].

The dynamic response under an oscillating external eld can be viewed as a competition between two time scales: the half-period  $t_{1=2}$  of the external eld (proportional to the inverse driving frequency) and the average metastable lifetime h i of the system (the mean time spent in the metastable well) after a sudden eld reversal. For low driving

frequencies, the tim e-dependent magnetization oscillates about zero in synchrony with the external eld (symmetric dynam ic phase). For high frequencies, however, the magnetization does not have time to switch sign during one half-period, and it oscillates about one or the other of its degenerate zero- eld values (asym metric dynamic phase). This symmetry breaking and the corresponding dynamic phase transition (DPT) between the symmetric and the asymmetric limit cycles of the system magnetization have attracted considerable attention over the last decade. It was rst observed during numerical integration of the mean-eld equation of motion for the magnetization of a ferrom agnet in an oscillating eld [2, 3]. Since then it has been the focus of investigation in num erous M onte C arlo simulations of kinetic Ising systems [1, 4, 5, 6, 7, 8, 9, 10, 11, 12, 13, 14], further mean-eld studies [5, 7, 8, 15, 16], and most recently in analytic studies of a bistable tim e-dependent G inzburg-Landau (TDGL) model [17]. The DPT may also have been experimentally observed in Co on Cu (001) ultrathin magnetic Ims [18, 19, 20] and recently in num erical studies of fully frustrated Josephson-junction arrays [21] and an isotropic H eisenberg m odels [22]. The results of these studies agree that there exists a genuine continuous phase transition between the symmetric and asymmetric dynam ic phases, at least in some region of the param eter space spanned by tem perature, eld, and half-period. Finite-size scaling studies of data from dynamic M onte Carlo sin ulations [1, 12, 14], as well as analytic arguments [17] have dem onstrated that this far-from -equilibrium phase transition belongs to the sam e universality class as the equilibrium Ising model in zero eld. This result is consistent with previous symmetry [23] and renorm alization group [24] argum ents [25].

In their original paper on the DPT in a mean-eld model [2], Tom e and de O liveira reported that the continuous (second-order) phase transition observed at high tem peratures appeared to change at a tricritical point (TCP) to a discontinuous (rst-order) transition for low tem peratures. Such a TCP was also reported in later mean-eld work [5]. However, an analytical and num erical mean-eld study by Zimmer [16] makes a strong case that the claims for a TCP in the mean-eld case is based on a misinterpretation of e ects of critical slow ing-down at the DPT. Sim ilar claims, that in some region of the dynamic phase diagram spatially extended kinetic Ising models exhibit a rst-order transition and consequently have a TCP separating lines of second-order and rst-order dynam ic phase transitions, have also been made on the basis of dynam ic M onte C arlb studies [9, 26, 27]. For recent reviews on the DPT, see Refs. [26, 27].

The purpose of the present paper is to clear up the remaining confusion about the interpretation of simulation results for the DPT in spatially extended kinetic Ising models, in particular in the low-tem perature regime where a rst-order transition and a TCP have been claimed to exist [9, 26, 27]. Those conclusions were essentially based on data for a single system size, and we here demonstrate how proper consideration of rather subtle nite-size e ects leads to a di erent picture. The implication of our theoretical arguments and M onte C arb simulations presented in this paper is that in an in nitely large system a continuous DPT should persist down to arbitrarily low tem peratures. How ever, in any nite system for su ciently low frequencies, the DPT gives way to a transient regime of stochastic resonance (SR) [28] at a size-dependent temperature. It is this size-dependent crossover temperature, which has previously been m isinterpreted as a TCP.

The rest of this paper is organized as follows. In Sec. II we summarize the theoretical framework needed to understand the underlying metastable decay mechanisms and their consequences for the DPT. This underscores again the importance of the interplay of various time-and length scales in metastable systems [1, 10, 11, 29, 30, 31]. In Sec. III we extend our preliminary numerical work [32], supporting our theoretical arguments by large-scale M onte C arlo simulations of a two-dimensional kinetic Ising ferror agnet in an oscillating edd. Our conclusions are summarized in Sec. IV, and derivations of analytic approximations for quantities of interest in the stochastic-resonance regime are given in Appendix A and Appendix B.

## II. M ETA STABLE DECAY MODES AND PERIODIC RESPONSE IN FINITE SYSTEMS

The appropriate dynamic order parameter in the presence of an oscillating external eld is the period-averaged m agnetization,  $Q = \frac{1}{2t_{1-2}}$  m (t) dt [2]. It takes a nonzero value in the asymmetric dynamic phase, while it vanishes in the symmetric phase. The transition occurs when the half-period  $t_{1-2}$  and the underlying metastable lifetime h (T; H) i become comparable. Them etastable lifetime depends on the temperature T and the eld amplitude H. For su ciently large systems (see quantitative statements below) the system escapes from them etastable phase through the nucleation of m any droplets [nulti-droplet (MD) regime [29, 30]]. Consequently, the time-dependent system magnetization is self-averaging. If h (T; H) i  $t_{1-2}$ , the magnetization follows the external eld in each half-period. The system relaxes to a symmetric limit cycle, and the order-parameter probability density P (Q) is sharply peaked about Q = 0.0 n the other hand, for h (T; H) i  $t_{1-2}$  the magnetization does not have enough time to switch within a single half-period, and it relaxes to an asymmetric limit cycle (with occasionalswitches between the two equivalent asymmetric dynamic phases). Consequently, P (Q) becomes bim odal with sharp peaks near Q = 1. This breaking of the symmetry of the limit cycle and the associated DPT have been carefully analyzed [1, 12, 14] with nite-size scaling techniques

borrowed from equilibrium critical phenom ena [3, 34]. In terms of the dimensionless halfperiod,  $t_{1=2}=h$  (T;H)i, the DPT occurs at a critical value  $_{\rm c}$  O (1). The nite-size scaling analysis of the M onte C arlo data also indicates that this far-from -equilibrium phase transition belongs to the same universality class as the equilibrium Ising m odel in zero eld. Supporting these numerical studies, recent analytic results within a coarse-grained TDGL m odel [17] indicate that the behavior of the stochastic variable Q is governed by the elective H am iltonian H  $_{\rm e} = aQ^2 + Q^4$ , where  $a/(c_{\rm c})$ . A coording to standard arguments from the theory of critical phenomena, this result leads directly to the conclusion that the DPT belongs to the universality class of the zero eld Ising m odel in equilibrium [35], in agreement with the simulation results.

For any nite system, how ever, the m etastable decay m ode changes to the nucleation and grow th of a single droplet at su ciently low temperatures [single-droplet (SD) regime [29, 30]]. Due to the stochastic nature of the nucleation of a single droplet, the corresponding response in the presence of an oscillating eld is di erent: the system exhibits [9, 11, 31] stochastic resonance [28].

The crossover from the underlying M D to SD decay can be understood by using standard nucleation theory applied to the ferrom agnetic kinetic Ising m odel (in general dimension d and with ferrom agnetic coupling constant J) [29, 30]. Below the critical temperature, following a single, instantaneous eld reversal, the average time between nucleation events (the nucleation time) in a system of linear size L is obtained as

$$t_n = L^d I(T; H)^{\perp}; \qquad (1)$$

where I(T; H) is the tem perature- and eld-dependent nucleation rate per unit volum e. It can be expressed in terms of the free energy F(T; H) of the critical droplet as

where F (T;H) and the prefactor C (T;H) can be obtained from nucleation theory to various degrees of approximation, depending on T and H [30]. The temperature T is given in energy units by setting the Boltzmann constant  $k_B = 1$  in Eq. (2). The other characteristic time scale is the grow th time  $t_g$ . It is dened as the time it takes for a supercritical droplet to grow to llhalf the system volume. A ssum ing a time-independent radial grow th velocity v(T;H),

where  $_{d}$  (T) is a dimension-and temperature-dependent shape factor (between and 4 for d= 2 and between 4 = 3 and 8 for d= 3) [30].

For  $t_n$   $t_g$  many droplets nucleate while those nucleated shortly after the eld reversal are still growing. In this, the MD, regime the lifetime is independent of the system size. An order-of-magnitude estimate of the metastable lifetime h (T;H) i can be obtained [30] by equating the volume  $R_0^d$  reached by a droplet that grows for this amount of time,  $R_0^d$  (vh i)<sup>d</sup>, with the volume inside which on average a single nucleation event occurs during the same time,  $R_0^d$  (h iI)<sup>1</sup> (R<sub>0</sub> can be regarded as the typical droplet separation). The result is h i / (v<sup>d</sup>I)<sup>1=(d+1)</sup>.

For  $t_n$   $t_g$  the rst droplet to nucleate eventually lls the system on its own. In this regime the lifetime depends strongly on the system size and approximately equals  $t_n [Eq. (1)]$ .

The above two decay modes characterize the MD and SD regime, respectively. The crossover between the two regimes de nes the dynamic spinodal (DSP) [30] and can be estimated by equating  $t_n$  and  $t_g$ . (In terms of the underlying length scales, this corresponds to the situation in which the mean droplet separation  $R_0 = vh$  i becomes comparable to the system size L.) This yields an implicit equation for the temperature corresponding to the DSP as a function L and H,




FIG.1: M etastable decay m odes and crossovers in the dynam ic phase diagram for the two-dimensional kinetic Ising ferrom agnet in a square-wave oscillating eld with am plitude H = 2.0J. The dashed curve is the dynam ic spinodal (D SP)  $T_{D SP}$  (L), separating the underlying multi-droplet (M D) from the single-droplet (SD) regime. The solid curves correspond to T (L) Eq. (6)], the crossover to the dynam ic \frozen" state for various halfperiods  $t_{1=2}$ , indicated by arrows [in units of M onte C arb steps per spin (M C SS)]. The horizontal dotted line indicates the tem perature T = 0.216J, at which the dynam ic phase transition (D P T) occurs in the large system -size lim it for  $t_{1=2} = 500$  M C SS. A long this horizontal line, for  $L^> O$  ( $10^3$ ) the m etastable lifetime is system -size independent, and its value is comparable to the xed halfperiod.

For d= 2, analytic approximations [36] are known for v(T;H) [37],  $_2$ (T), and C (T;H) [38, 39]. The corresponding estimate for  $T_{DSP}$  as a function of L at H = 2.0J, obtained by numerically solving Eq. (4), is shown as a dashed curve in Fig. 1. The resulting curve  $T_{DSP}$  (L) turns out to be quite insensitive for the precise values used in the approximation [36]. In the large-system limit  $T_{DSP}$  approaches zero logarithm ically with increasing L. The existence of the DSP implies that in the presence of an oscillating eld, reducing T at xed half-period  $t_{1=2}$  and eld amplitude H results in drastically di erent behaviors for \small" and \large" system s.

Upon reducing the temperature for su ciently large L, the L-independent m etastable lifetime h (T;H) is becomes comparable to the xed half-period  $t_{1=2}$  at a temperature above the one at which the underlying decay mode would cross over to the SD mode. The horizontal line in Fig. 1 corresponds to the temperature where h (T;H) i  $t_{=2} =$

500 M C SS.N earthis line, the system exhibits a continuous D P T [1, 12, 14]. Further low ering the tem perature has no e ect on the behavior of the dynam ic order parameter Q, since the system is already locked into one of its sym metry-broken dynam ic phases, where P (Q) is sharply peaked near 1. From Fig.1 it is clear that, in order to observe the D P T in a nite system for a given value of  $t_{1=2}$ , one has to employ a su ciently large system [e.g., L > O (10<sup>3</sup>) for  $t_{1=2} = 500 \text{ M C SS}$  or L<sup>></sup>O (10<sup>2</sup>) for  $t_{1=2} = 50 \text{ M C SS}$ . In general, the larger  $t_{1=2}$  is, the larger system s one needs in order to observe the L! 1 behavior. This example illustrates that it is essential to keep in m ind the nite-size implications of the crossover between the M D and SD decay mechanism s.

U pon reducing the tem perature for sm aller L, the crossover from the M D to the SD regime occurs at a tem perature well above that at which the in nite-system DPT would occur. In the SD regime the switching is stochastic [30]. The system will then exhibit stochastic resonance, and the order-parameter distribution P (Q) will indeed possess multiple peaks, leading to a negative fourth-order cumulant [9]. Low ering the tem perature still further reduces the probability that the magnetization switches during a nite number of periods, and the system becomes e ectively forzen." The crossover to this frozen phase is approximately marked by the curve along which the probability is 1/2 that the magnetization does not switch during a half-period in which it is opposite to the direction of a single droplet, which is a Poisson process. Thus, the probability that the magnetization does not change sign during a half-period in which it started o opposite to the eld is

Setting  $P_{not} = 1=2$  leads again to an implicit equation for the corresponding crossover temperature,

$$T = \frac{h}{d \ln L + \ln \frac{1}{c (T ; H) \ln 2} t_{1=2}} \frac{L}{[2 d (T)]^{1-d} v (T ; H)} i;$$

Estimates of T at H = 2.0J for three di erent values of  $t_{1=2}$ , obtained by numerically solving Eq. (6) [36], are shown in Fig. 1 as solid curves. Since  $P_{not}$  changes rapidly between zero and unity as T is reduced, the specie cout-o value of  $P_{not} = 1=2$ , used to de ne T here, is not essential. For each value of  $t_{1=2}$ , the curves representing  $T_{DSP}$  and T form the border of a wedge-shaped region in which SR is observed (see Fig. 1). This is the regime where the dynam ic order parameter is indeed characterized by a multi-peaked probability density and a negative fourth-order cumulant [9]. However, the above theoretical arguments in ply that the SR behavior is a nite-size e ect. We therefore conclude that the otherwise sound simulation results that A charyya obtained in the stochastic regime [9], were misinterpreted by him as signs of a rst-order DPT.

To sum marize the periodic response for the ferrom agnetic Ising model, for an in nite (or su ciently large) system, the system undergoes a continuous DPT when the the half-period becomes comparable with the metastable lifetime. Crossing the dynamic phase boundary (Fig. 1) by changing the temperature, for xed and low frequencies (long half-periods), the metastable lifetime becomes comparable to the half-period at appropriately low temperatures, thus the DPT occurs at a low temperature (horizontal dotted line in Fig. 1). For nite and too small systems, how ever, the underlying decay mode crosses over to the SD regime before the DPT occurs (crossing the dashed curve from above in Fig. 1). Then the system exhibits SR in the wedge-shape region, until practically no switching occurs during any nite observation time (frozen state). As we show next, careful analysis of simulation results for system s of di erent sizes reveals that the signatures attributed to a rst-order DPT in Ref. [9] indeed disappear in the L! 1 limit, as predicted by the theoretical arguments presented above.

#### III. SIM ULATION RESULTS AND FINITE-SIZE EFFECTS

To model spatially extended bistable system swe performed dynamic M onte C arb simulations of a two-dimensional kinetic Ising ferrom agnet below its equilibrium critical temperature. This simple model has, for example, been shown to be appropriate for describing magnetization dynamics in highly an isotropic single-dom ain nanoparticles and uniaxial thin lm s [18, 19, 20, 40]. Despite its simplicity, it is believed to capture the generic features of periodically driven, spatially extended bistable system s. The system, which is de ned on a two-dimensional square lattice of linear size L, is described by the H am iltonian

where  $s_i = 1$  is the state of the ith spin, J > 0 is the ferrom agnetic coupling constant,  $h_{i;ji}$  runs over all nearestneighborpairs, and H (t) is an oscillating, spatially uniform applied edd. We use a square-wave edd with amplitude H. This has obvious computational advantages over a sinusoidal edd, while it does not change the universal characteristics of the system response [14]. The dynam ic used is the single-spin- ip G lauber algorithm with updates at random ly chosen sites [33, 41]. At temperature T, each attempted spin ip from  $s_i$  to  $s_i$  is accepted with probability

where E<sub>i</sub> is the energy change that would result from the accepted ip. We give the tem perature T in energy units by setting the Boltzm ann constant  $k_B = 1$  in Eq. (8). For the largest system sizes (L 1024) we implemented a scalable massively parallel version of this dynamic [42, 43], rst proposed by Lubachevsky [44].

The dynam ic order param eter [2] is the period-averaged m agnetization

where m (t) = L<sup>2</sup>  $P_{isi}(t)$ . The beginning of the period is chosen at a time when H (t) changes sign. In particular, we compute both types of period averages, staring at the instant when H (t) changes from +H to H, and also starting when it changes from H to +H. B oth observations are included in the order-parameter histogram s with equal weight. This simplest form of phase averaging is su cient to produce a symmetric distribution for Q, in particular in the stochastic regime.

Large-scale sinulations and nite-size scaling studies of the DPT have been recently performed with both sinusoidal [1, 12] and square-wave [14] elds. The results imply that the system undergoes a continuous phase transition as the half-period  $t_{1=2}$  becomes comparable to the average metastable lifetime h (T;H)i. Recall that the lifetime becomes independent of the system size for large systems. The critical exponents for the dynamic order parameter and its uctuations at the DPT are consistent with those of the two-dimensional equilibrium Ising transition [1, 12, 14, 17]. In those studies, the temperature and the eld amplitude were held xed, resulting in a xed lifetime h (T;H)i. The DPT was approached by tuning the half-period  $t_{1=2}$  of the oscillating eld so that it became comparable to h (T;H)i. An advantage of this approach is that if the smallest system is already in the MD regime, all the larger ones are, as well. Thus, one does not have to deal with subtle crossovers corresponding to the di erent underlying decay modes (SD vs MD). In the present study, we keep  $t_{1=2}$  xed and tune the metastable lifetime by varying the temperature T. The motivation for this is to closely parallel the study by A charyya [9], and to show that ignoring the nite-size e ects and the resulting crossovers, one can easily misinterpret the stochastic-resonance behavior in the stochastic regime as indicating a rst-order transition.




FIG.2: M agnetization time series m (t) (solid curves) and norm alized applied eld H (t)=H (dashed curves) with H = 2.0J and  $t_{1=2} = 50 \text{ M C SS}$ , shown for a \small" system with L = 16 at di erent temperatures. (a) T = 0.3J, dynam ically disordered phase. (b) T = 0.4J, stochastic resonance. (c) T = 0.35J, dynam ically \frozen" state.




FIG. 3: M agnetization time series m (t) (solid curves) and norm alized applied eld H (t)=H (dashed curves) with H = 2.0J and  $t_{1=2} = 50 \text{ M} \text{ C} \text{ SS}$ , shown for a \large" system with L = 180 at di erent tem peratures. (a) T = 0.5J, dynam ically disordered phase. (b) T = 0.375J near the DPT. (c) T = 0.34J dynam ically ordered phase.

Tracing the magnetization time series m (t) already rejects the major qualitative differences between the responses for \small and \large system s, as shown in Figs. 2 and 3, respectively. For su ciently small L, as the temperature is reduced, the system enters the stochastic regime, characterized by occasional random switches Fig. 2 (b)], before becoming completely \frozen "Fig. 2 (c)]. For large L, the system undergoes a DPT characterized by the slow wandering of the period-averaged magnetization Fig. 3 (b)] on its way to perform ing an asymmetric limit cycle in the dynam ically ordered phase at still lower temperatures Fig. 3 (c)].

We perform ed simulations on system sizes ranging from L=16 to 2048, choosing various eld am plitudes H and half-periods  $t_{1=2}$  that were kept xed while the temperature T was varied. The time unit used is one M onte C arlo step per spin M CSS], i.e., one random \sweep" of the L L lattice. The lengths of the nuns were  $10^3$  full periods of the oscillating eld for  $t_{1=2} = 500$  M C SS and  $10^4$  full periods for all the other values of  $t_{1=2}$ . M easuring the period-averaged m agnetization Q after each half-period, we constructed averages of the norm of the order parameter, hig j<sub>L</sub>. We further calculated the fourth-order cum ulant ratio,

$$U_{\rm L} = 1 - \frac{hQ^4 \dot{I}_{\rm L}}{3hQ^2 \dot{I}_{\rm L}^2}; \qquad (10)$$

which typically provides a strong indication of the nature of any underlying phase transition [33]. For a continuous transition,  $U_L$  changes monotonically from 0 to 2=3 as one tunes the system from the symmetric (disordered) to the symmetry-broken (ordered) phase. On the other hand, for a rst-order transition,  $U_L$  develops a minimum, whose location corresponds to the transition point. We also constructed histograms of Q, representing the order-parameter distribution P (Q). In the stochastic regime, we in addition measured the residence times  $t_r$  and constructed their probability distribution  $P_r(t_r)$ , the residence-time distribution (rtd). Here  $t_r$  is dened as the time spent in one of the two \wells" of the underlying system free energy between two consecutive switching events. It is measured as the time elapsed between two consecutive zero-crossings of m (t). The residence times and their distribution are useful to characterize the system in the stochastic SD regime.

K eeping H and  $t_{1=2}$  xed, we perform ed simulations measuring hD ji and  $U_L$  as functions of T for a series of system sizes. Here we present the results for four di erent pairs of values of H and  $t_{1=2}$ . Figures 4, 5, 6, and 7 show the results for H = 2.0J and  $t_{1=2}$ = 50 M C SS, H = 2.0J and  $t_{1=2}$ = 50 M C SS, H = 2.0J and  $t_{1=2}$ = 20 M C SS, and for H = 3.0J and  $t_{1=2}$ = 20 M C SS, respectively. As indicated by these gures, the notings in all these cases are qualitatively the sam e. For the purpose of discussion, we use F ig. 4, corresponding to H = 2.0J and  $t_{1=2}$ = 50 M C SS.

## A. Sm all system s




FIG.4: Dependence of the system response on T and L for H = 2.0J and  $t_{1=2} = 50 \text{ M CSS}$ . (a) M etastable dynam ic phase diagram analogous to Fig.1. The dimensional line corresponds to T = 0.349J, where in the M D regime h (T; H) i  $t_{z=2} = 50 \text{ M CSS}$ . (b) The dynam ic order parameter hjp ji, shown vs T for L between 16 and 1024. Note that the dip to negative values disappears as L increases beyond 128.

Even for relatively small systems,  $L = 16\{128, at su ciently high tem peratures the underlying m etastable decay m ode is M D, as illustrated in the phase diagram in Fig.4(a). Then the system m agnetization m (t) follows a symmetric lim it cycle [see Fig.2(a)]. Consequently, the order-parameter distribution P (Q) is sharply peaked about zero [Fig.8(a)], yielding hD ji_L 0 up to nite-size e ects, as shown in Fig.4(b). Correspondingly, the fourth-order cum ulant <math>U_L$  is close to 0, as shown in Fig.4(c).

As the tem perature is low ered beneath  $T_{DSP}$  (L), the underlying decay mode crosses over to the SD regime, and the magnetization switching becomes stochastic as shown in Fig. 2 (b). The order-parameter distribution then has three




FIG.5: Dependence of the system response on T and L for H = 2.0J and  $t_{1=2} = 500 \text{ M C SS}$ . (a) M etastable dynam ic phase diagram analogous to Fig.1. The di erent curves have the same interpretations as in that gure. The horizontal line corresponds to T = 0.216J, where in the M D regime h (T; H) i  $t_{r=2} = 500 \text{ M C SS}$ . (b) The dynam ic order parameter hD ji, shown vs T for L between 64 and 2048. (c) The fourth-order cum ulant ratio  $U_L$ , shown vs T for L between 64 and 2048. Note that the dip to negative values gradually disappears with increasing L.




FIG.6: Dependence of the system response on T and L for H = 1.8J and  $t_{1=2} = 20 \text{ M CSS}$ . (a) M etastable dynam ic phase diagram analogous to Fig.1. The dimensional line corresponds to T = 0.592J, where in the M D regime h (T; H) i  $t_{2=2} = 20 \text{ M CSS}$ . (b) The dynam ic order parameter hD ji, shown vs T for L between 16 and 1024. Note that the dip to negative values disappears as L increases beyond 64.




FIG.7: Dependence of the system response on T and L for H = 3.0J and  $t_{1=2} = 20 \text{ M CSS}$ . (a) M etastable dynam ic phase diagram analogous to Fig.1. The dimensional line corresponds to T = 0.193J, where in the M D regime h (T; H) i  $t_{2=2} = 20 \text{ M CSS}$ . (b) The dynam ic order parameter h $j_{2}$  ji, shown vs T for L between 16 and 1024. Note that the dip to negative values disappears with increasing L.




FIG.8: H istogram s representing P (Q) in a small system (L = 16 with H = 2.0J and  $t_{1=2} = 50 \text{ M C SS}$ ) for di erent tem peratures.

peaks: two extremely narrow peaks near Q = 1 and a rather wide one centered at Q = 0 [see Fig.8(b) and (c)]. The peaks near 1 represent the periods during which the magnetization does not switch, while the peak centered on zero represents the periods during which it switches at least once. The large width of this central peak is the result of the square-wave shape of the applied eld, which results in an exponential probability density for the switching process. A sinusoidal eld would yield a distribution more sharply peaked about zero, since, in that case, the switching alm ost always occurs when the external eld assumes its maximum magnitude [9, 10, 11, 31]. The generic feature in the stochastic regime, regardless of the shape of the driving eld, is the multiple-peak structure. For the square-wave eld used in this paper one can obtain (see Appendix A) an analytic approximation for P (Q) in the regime where  $t_{1=2}$  t<sub>g</sub> [Fig.10(a)]

Equation (11) for P (Q) is compared with simulation data in Fig. 10(b) for a system with L = 32 at H = 2.0J and T = 0.34J, for which h (T; H)  $i_L$  = 233 M CSS. (The subscript L in h (T; H)  $i_L$  is included as a reminder that the metastable lifetime depends on L in the SD regime.) The half-period is  $t_{1=2}$  = 500 M CSS  $t_g$ . This comparison contains no tting parameters: the average metastable lifetime of the underlying metastable decay, h (T; H)  $i_L$ , was measured in single eld-reversal simulations, and its value was used to determ ine the scaled half-period, =  $t_{1=2}$ =h i. Instead of the delta-functions with amplitude e =2, the nite value e = (2 Q) was used to make the correspondence with the nite bin-size Q, employed to build the histogram for Q. In the stochastic regime the cumulant U L becomes negative, reaching a minimum at some temperature, as shown for the smaller values of L in Fig. 4 (c).




FIG.9: H istogram s representing P (Q) in a large system (L=180 with H = 2.0J and  $t_{1=2}$  = 50 M C SS) for di erent tem peratures.

A quantity often used to detect stochastic resonance, is the rtd,  $P_r(t_r)$  [11, 28, 31, 45, 46], the probability density for the residence times  $t_r$  between zero-crossings of the magnetization. This quantity is shown in Fig. 11 for a system with L= 32 at H = 2.0J and T = 0.34J, for which h (T;H) $i_L$  = 233 M CSS. The half-period is  $t_{1=2}$  = 500 M CSS  $t_g$ . The data are shown together with an analytic approximation ( $t_{1=2}$   $t_g$ ), which is derived in Appendix B

The analytic form contains as a parameter the average lifetime h (T;H) $i_L$ , which was measured in independent eldreversal simulations. Thus, as for the order-parameter distribution above, not thing parameters are involved in the comparison between the simulation data and the analytical form. The generic feature of the rtd is the structure of the peaks, which are centered at odd multiples of the half-period (i.e., at  $(2n 1)t_{F=2}$ ; n = 1;2;:::), with exponentially decaying heights, as has also been observed in simulations with a sinusoidally varying eld [9, 11, 31]. This behavior is characteristic of systems undergoing stochastic resonance [28, 45, 46].

In the phase diagram shown in Fig. 4(a), the weak-noise stochastic-resonance [28] behavior described here occurs in the wedge-shaped region between the two crossover curves,  $T_{DSP}$  (L) and T (L), as already discussed in Sec. II. A nalogous behavior was discussed in detail in Ref. [31] for the case of a sinusoidal driving eld.

As T is low ered further for the small system, the average m etastable lifetim e quickly increases, and the probability of not switching during a half-period,  $P_{not}(t_{1=2};L;T;H)$ , approaches unity. As discussed in Sec. II, the crossover temperature T (L) corresponds to  $P_{not} = 1=2$ . Consequently, switching events become mare, and the central peak in P (Q) essentially disappears, heaving only the two sharp peaks near 1 [see Fig. 8 (d)]. At the same time,  $U_L$  again become espositive [see Fig. 4 (c)]. Signi cantly below T (L), switching will never be observed during a nite number of periods, and the system is completely \frozen" into one of its two m etastable wells [see Fig. 2 (c)]. This yields hip ji 1 and  $U_L$  2=3, as shown in Fig. 4 (b) and (c), respectively.

### B. Large system s

For larger system s  $[L^> O (10^2)$  for  $t_{1=2} = 50 \text{ M C SS}$ , at high tem peratures the system is deeply in the M D regime Fig 4(a)], where the lifetime is independent of L. Here, h (T; H) is significantly smaller than  $t_{1=2}$ . The limit cycle of the magnetization is symmetric [Fig. 3(a)], and the uctuations in Q are Gaussian and centered about zero [Fig. 9(a)]




FIG. 10: Order-parameter statistics for H = 2.0J, T = 0.34J, and L = 32, which yield  $h(T; H)i_L = 233$  MCSS, with  $t_{1=2} = 500$  MCSS. These are the same parameters as for Fig. 11. For these parameters the system is in the stochastic regime, and  $t_g$  is negligible compared to  $t_{1=2}$  and  $h(T; H)i_L$ . (a) A short segment of the magnetization time series. The interpretation of the line types is the same as in Fig. 2. (b) C om parison of the simulated (histogram) and the analytic [solid curve, Eq. (11)] order-parameter distributions.




FIG.11: C on parison of the simulated and the analytic [Eq. (12)] residence-time distributions,  $P_r(t_r)$  in the stochastic regime where  $t_g = t_{1=2}$ . Shown for a small system with L = 32 at H = 2.0J and T = 0.34J, where h (T; H)  $i_L$  = 233 M CSS. The half-period,  $t_{1=2}$  = 500 M CSS, is much longer than the growth time. (a) Shown on a linear scale. (b) The same as (a), using a linear-log scale to emphasize the smaller peaks and the exponential dependence of the peak heights on  $t_r$ .

and (b)]. In this regime, both hQ  $j_{L}$  0 and  $U_{L}$  0, up to nite-size e ects Fig. 4(b) and (c)]. Upon lowering the tem perature, the underlying decay mode remains MD, but the lifetime increases and eventually becomes comparable with the half-period. This happens well before T reaches  $T_{DSP}$  (L). When h (T; H) i becomes approximately equal to  $t_{1=2}$ , the system undergoes a genuine continuous phase transition, the DPT [1, 12, 14]. The system magnetization performs a slow \wandering" motion Fig. 3(b)], and the distribution for Q widens significantly Fig. 9(c)]. Below the transition, P (Q) becomes bim odal Fig. 9(d)], hQ  $j_{L}$  0 (1) Fig. 4(b)], and  $U_{L}$  approaches its ordered-phase value 2=3 without exhibiting negative values or a minimum Fig. 4(c)]. Also,  $U_{L}$  for dimensional large values of L intersect at the tem perature corresponding to the DPT Figs. 4(c), 5(c), 6(c), and 7(c)], as expected for a continuous phase transition [33]. Detailed nite-size-scaling analysis of M onte C arb simulations for system s that are large enough that the underlying m etastable decay mode is MD, are found in Refs. [1, 12, 14].

As T is reduced further, the underlying decay mode crosses over to the SD regime at  $T_{DSP}$  (L). This leads to extrem ely large metastable average lifetimes, such that  $P_{not}$  approaches unity. However, this has no e ect on the observables: below the DPT, the system is already performing asymmetric limit cycles, connect to one of its metastable wells [Fig.3 (c)].

## C. Comparison

From the above discussion for small and large system s, it is clear that the qualitative behavior observed as the temperature is varied depends strongly on the eld am plitude, the half-period, and the system size. For example, for H = 2.0J and  $t_{1=2} = 50 \text{ MC}$  SS one must employ  $L^{>}$  O  $(10^2)$  in order for the underlying metastable decay mode to become M D, so that the DPT is observed [Fig. 4 (c)]. For the same eld am plitude and  $t_{1=2} = 500 \text{ MC}$  SS one needs  $L^{>}$  O  $(10^3)$  to achieve the same e ect [Fig. 5 (c)]. For larger and larger half-periods, the \in nite"-system DPT (h (T; H) i  $t_{1=2}$ ) occurs at low er and low er tem peratures. How ever, at these low tem peratures, it takes exponentially large system s to be in the M D regime, as seen from Eq. (4). By increasing  $t_{1=2}$ , one therefore quickly reaches the limit of any available computational resources.

#### IV. SUMMARY AND CONCLUSION

We addressed the nite-size e ects of the periodic response of spatially extended bistable systems by studying the two-dimensional kinetic Ising model in an oscillating external eld. The intimate connection between the underlying metastable decay modes and the periodic response of spatially extended bistable systems has been stated and demonstrated several times [1, 10, 11, 12, 14, 31]. On the other hand, it has been claimed repeatedly [9, 26, 27] that for large enough periods (low-frequency regime), the dynam ic phase transition (DPT) becomes rst-order. In the present study we focused explicitly on demonstrating that any signatures resembling a rst-order transition at lower tem peratures are merely nite-size e ects that disappear as L is increased su ciently.

F irst, we reviewed the basics of the well-known theory of hom ogeneous nucleation. Understanding the relevant timeand length scales and the various decay modes [multi-droplet (MD) and single-droplet (SD)] in metastable decay, one can estimate the important system -size dependent crossovers for the periodic response. Next we presented extensive new simulation results indicating that no rst-order transition exists for any frequency, and consequently, there can be no tri-critical point separating lines of rst-order and continuous dynamic phase transitions. The behavior, correctly observed in Ref. [9] but misinterpreted as indicating the existence of a rst-order DPT, is due to the stochastic nature of the underlying single-droplet metastable decay. In this regime the system exhibits stochastic resonance. How ever, this behavior does not survive in the large-system limit with xed eld amplitude.

# APPENDIX A: ANALYTIC APPROX IM ATION FOR THE ORDER PARAMETER DISTRIBUTION IN THE STOCHASTIC REGIME

In the stochastic regime, for large  $t_{1=2}$ , we can neglect the growth time after the nucleation of the critical droplet and approximate the switching process by instantaneous switching of m(t) between 1 [Fig. 10(a)]. Then, knowing that the nucleation of a critical droplet is a Poisson process (i.e., the probability density of the switching time is exponential) with rate h i<sup>1</sup>, we can calculate the probability density function (pdf) for the dynam ic order parameter P(Q). It is important to recall that in the denition of Q we included both types of averaging: averaging over a period when the driving eld starts with negative value and also when it starts with a positive value in the rst half-period. Here we show the calculation of the form er case P (Q). The calculation for the latter is identical and at the end one simply has to add them together with weight 1=2, resembling the way the histogram was collected: P (Q) = P (Q) + P\_+ (Q) = 2.




FIG.12: Schematic plots for constructing the probability density P (Q) when the driving eld is negative in the rst halfperiod. Dashed and solid lines represent the driving eld and the magnetization, respectively. The switching times  $t_1$  and  $t_2$ , possibly occurring in the rst and second half-period, respectively, are measured from the beginning of their respective half-periods.

W hen the driving eld is negative in the rst half-period, there are ve mutually distinct scenarios as illustrated on the schematic plots in Fig. 12 (a-e). In cases (a), (b), and (c) the value of the magnetization m (t) is + 1 at the beginning of the period, while in cases (d) and (e) it is 1. Since we are interested in the stationary distribution of Q, rst we have to nd the stationary probabilities  $p_1^+$  ( $p_1$ ) that the magnetization has the value + 1 (1) at the beginning of a period. After a quick look at the ve cases above Fig. 12 (a-e), one can write down a set of

for  $p_n^+$  and  $p_n$ , the probabilities that the m agnetization is + 1 and -1 at the beginning of the nth period, respectively. In Eq. (A1) we used the de nition  $= t_{1=2} = h$  i. From these equations one can easily obtain the stationary-state (xed-point) values  $p_1^+ = 1 = (1 + e)$  and  $p_1^- = e = (1 + e)$ . Now for each case (a-e), we consider the conditional probability density of Q (conditional on the value of the magnetization at the beginning of the period). In case (a) Q = 1 with probability e , i.e., that the magnetization does not switch in the rst half-period, yielding a deltafunction contribution e 1) to the full pdf. In case (b) the magnetization switches at t in the rst half-Q period and does not switch back in the second, resulting in  $Q = (t_1$  $t_{r=2}$ )= $t_{1=2}$ . The contribution to the pdf is  $t_{1=2} = t_{1=2} i_{t_1}$ , where  $h:::i_{t_1}$  is an averaging over the exponentially distributed switching time  $t_1$ . e h (O **(**t In case (c) the magnetization switches twice, at  $t_1$  in the rst half-period and at  $t_2$  in the second one, resulting in  $Q = (t_1)$  $t_{1=2}$ . The contribution to the pdf is h (Q  $(t_2 t_2)=t_{1=2})i_{t_1,t_2}$ , where h:: $i_{t_1,t_2}$  is an averaging over the exponentially distributed switching times t1 and t2, occurring independently in the rst and second half-period (and m easured from the beginning of their respective half-periods). In case (d) the initial value of the magnetization is 1 and it does not switch in the second half-period, yielding e (Q + 1). The symmetrized (\phase-averaged") dynamic order-parameter becomes considerably simpler and easier to compare with measured histograms

## APPENDIX B:RESIDENCE-TIME DISTRIBUTION AND ITS ANALYTIC APPROXIMATION IN THE STOCHASTIC REGIME

In the stochastic-resonance limit, where h i is not much smaller than  $t_{1=2}$ , while both are much larger than  $t_g$ , we can obtain an analytic form for the rtd  $P_r(t_r)$ . The derivation follows that given for a sinusoidally oscillating eld in the Appendix of Ref. [31]. However, the present case is simpler since the probability that a switching event has not occurred within a time t after the eld has changed its sign to become opposite to the magnetization direction,  $P_{not}(t;L;T;H)$ , is a simple exponential, exp(t=h(T;H)i\_i) [see Eq. (5)]. As a consequence, all the integrals that have to be evaluated numerically in the sinusoidal case, can here be trivially calculated analytically. Provided the magnetization switched in a period (say period n=1) at time  $t_1$  (measured from the instant the driving eld changed sign), the next magnetization switching occurring in the nth period at  $t_2$  (also measured from the instant the driving

eld changed sign) results in a residence tim e  $t_r = (2n \quad 1)t_{r=2}$   $t_r + t_2$ , where  $t_1$  and  $t_2$  are exponentially distributed variables. The form all expression for the rtd then can be written as
