Quantum Chaos Triggered by Precursors of a Quantum Phase Transition: The Dicke Model

We consider the Dicke Hamiltonian, a simple quantum {optical model which exhibits a zero { tem perature quantum phase transition. We present numerical results demonstrating that at this transition the system changes from being quasi-integrable to quantum chaotic. By deriving an exact solution in the thermodynamic limit we relate this phenomenon to a localisation {delocalisation transition in which a macroscopic superposition is generated. We also describe the classical analogues of this behaviour.

At zero tem perature, systems of N interacting particles can exhibit a quantum phase transition (QPT) as a function of a coupling parameter in the limit that N ! 1 . How do the precursors of such a transition inuence quantum chaotic (and non-chaotic) behaviour of the same system for nite N ?

One of the most direct indicators of the emergence of quantum chaos is the change in energy level spacing statistics from Poissonian to being described by the Gaussian ensembles of Random Matrix Theory. Although this change-over has been observed in many systems [1, 2, 3, 4], only in a comparatively few, isolated cases has the onset of quantum chaos been correlated with the presence of a QPT. Important examples include spin glass shards, which have recently been used in modeling the onset of chaos in quantum computers [5], the Lipkin model [6], the interacting boson model [7], and the three{dimensional Anderson model [8, 9], where the change in level statistics occurs at the metal{insulator (localisation{delocalisation) transition found in disordered electronic systems.

In this Letter we consider the D icke H am iltonian (D H) [10], a quantum -optical model describing the interaction of N two-level atom s with a number of bosonic modes. We demonstrate that a crossover between Poisson and Wigner (D yson statistics in this model for nite N is intimately connected to a mean-eld type superradiance OPT.

The simplicity and generality of the D icke Ham iltonian have a orded it appeal both for the investigation of quantum chaos, and as a model for phase transitions at a critical coupling $_{\rm C}$ induced by the interaction with light. The level statistics for nite N have revealed the existence of quantum chaos in certain isolated regimes of the model [11, 12]. On the other hand, the QPT aspect for N ! 1 has been discussed in the context of superradiance [13, 14], and recently for exciton condensation [15]. Here, we derive an exact solution for all eigenstates, eigenvalues and critical exponents in the thermodynam ic limit, and show that above the critical point = $_{\rm C}$ the ground-state wavefunction bifurcates into a macroscopic superposition for any N < 1 . Our numerical results indicate that a localisation-delocalisation transition for

N ! 1 underlies the cross-over between Poissonian and W igner level{spacing distributions for nite N . Furtherm ore, we use an exact H olstein-P rim ako transform ation to derive the classical lim it of the model for arbitrary N and nd a transition at = $_{\rm c}$ from regular to chaotic trajectories. The latter are delocalised around two xed points in phase space which we conjecture constitute the classical analogue of the macroscopic superposition. The emergence of this state in the Dicke model is related to a conserved parity which becomes spontaneously broken in the thermodynamic lim it.

W e consider the single (m ode D icke H am iltonian (D H)

where J_z , J are the usual angular momentum operators for a pseudo{spin of length j=N=2, and a, a^y are the bosonic operators of the eld. The atomic level{splitting is given by $!_0$, ! is the eld frequency, and

is the atom { eld coupling. C rucially, we have not made the rotating{wave approximation (RWA), as this would render the model integrable and destroy the phenomena that we describe here [12]. There is a conserved parity associated with the DH, which is given by = exp i $a^ya + J_z + j$, such that [H;] = 0. The eigenvalues of are 1 and, unless stated, we shall work exclusively in the positive parity subspace.

We begin by discussing the properties of the system in the thermodynamic limit N; j! 1. In this lim it the system becomes integrable for all , and we can derive e ective Hamiltonians to describe the system exactly in each of its two phases. We employ a procedure sim ilar to Hillery and M lodinow's analysis of the RW A Ham iltonian [16], and introduce the Holstein { Prim ako representation of the angular momentum operators, $J_+ = b^{y^2} 2j b^y b$, $J_- = 2j b^y b$ b, $J_z =$ b^yb j, where b and b^y are bosonic operators [17]. Making these substitutions allow sus to write the DH as a two-mode Hamiltonian. Below the phase transition, we proceed to the therm odynam ic lim it by expanding the square roots and neglecting terms with powers of j in the denominator. This yields the e ective Hamiltonian $H^{(1)} = !_0b^yb + !a^ya + a^y + a^y + b^y$




FIG.1: Excitation energies " of the DH in the therm odynam ic lim it. Inset: scaled ground{state energy, $E_{\rm G}$ = j, in the therm odynam ic lim it (solid line) and at various nite values of j = 1=2;1;3=2;3;5 (dashed lines). The Ham iltonian is on scaled resonance! = !0 = 1.

bi{linear H am iltonian m ay then be diagonalised to give H $^{(1)}$ = $^{(1)}c^y$ c + $^{(1)}c^y$ c₊ c₊ $^{(1)}c^y$ c₊ c₊ j!₀, where $^{(1)}$ are the excitation energies of the low {coupling phase, and are given by

The energy "⁽¹⁾ is real only for $paralle{1.10} = 2 = c$, which locates the phase transition. We derive an elective Ham iltonian above c by rst displacing each oscillator mode in the Holstein {Primako DH by a quantity proportional to $paralle{1.10}$, and then neglecting terms as above. With an appropriate choice of displacements, this process also yields a bi{linear Ham iltonian, which may be diagonalised to a form similar to H (1), but with dierent vacuum and excitation energies, the latter of which are given by

The excitation energy $\mathbf{w}^{(2)}$ of this second Ham iltonian H $^{(2)}$ is real only above the phase transition. There are two independent choices of displacements, each of which yield a dierente ective Ham iltonian above $_{\text{c}}$. This is a consequence of the fact that at the QPT the symmetry is spontaneously broken.

In Fig. 1 we plot as a function of coupling the behaviour of the excitation energies and the ground-state energy, which is itself continuous but possesses a discontinuity in its second derivative at $_{\rm c}$. Below the phase transition the ground-state is composed of an empty eld with all the atoms unexcited and hence $hJ_zi_G=j=1$




FIG. 2: Plots of nearest{neighbour distributions P(S) for the Dicke Hamiltonian, for dierent couplings and pseudo{spin j. Also plotted are the universal Poissonian (dots) to Wigner (dashes) distributions.

and $ha^yai_G=j=0$. Above $_c$, the eld is macroscopically occupied, $ha^yai_G=j=2$ $_c^4$ $_c^4=(!)^2$, and the atom s acquire a macroscopic inversion, $hJ_zi_G=j=$ $_c^2=$ $_c^2$. At the phase transition, the excitation energy " vanishes as j $_cf$ and the characteristic length scale $l=1=^p$ " diverges as j $_cj$, with exponents given by =1=4, z=2 on resonance.

To investigate the level statistics of the system, we numerically diagonalise the Ham iltonian in the basis fini jj;m ig, where $a^{y}ajni=njni$, and jj;m i are the Dicke states, J_{z} jj;m $i=b^{y}b$ j jj;m i=m jj;m i. We restrict ourselves to the positive parity subspace by considering only states with n+m+j even. We then unfold the resulting energy spectrum to rid it of secular variation, form the level spacings $S_{n}=E_{n+1}$ E_{n} , and then construct the nearest{neighbour distribution function P (S). Finally, we normalise the results for comparison with the universal ensembles of R andom Matrix Theory. In the following, we shall use the term \quasi-integrable" to denote systems exhibiting Poissonian level statistics, and reserve \integrable" for systems possessing exact solutions.

Figure 2 shows the P (S) distributions obtained for the D H at various values of the coupling, and for various values of j. At low j the P (S) clearly do not correspond to any of the universal ensembles. This is most keenly observed in the j=1=2 case (identical to the RabiHam iltonian [18]), where the spectrum is of \picketfence" character [19], characteristic of one-dimensional systems or harmonic oscillators [20]. For couplings less than the critical value, < _c, we see that as we increase j, the P (S) approaches ever closer the Poissonian distribution, P_P (S) = exp (S). At and above _c the spectrum is seen to converge onto the W igner distribution P_W (S) = S=2 exp P_V S²=4, characteristic of quantum




FIG .3: Nearest{neighbour spacing $S_n=E_{n+1}$ E_n vs. eigenvalue number n plot for j=5 with =8 c. Horizontal crosses: results for the integrable ! 1 Ham iltonian. Inset: j=5 results with =4 c and =6 c.

chaos. This demonstrates that the precursors of the QPT in this model lead to a cross{over from quasi{integrable to quantum chaotic behaviour at $_{\rm G}$.

A further transition between integrable and chaotic behaviour is observed in the sequence of level spacings S_n . The ! 1 lim it of the Ham iltonian is integable for $\frac{2^{-2}}{1+2}$ m², arbitrary j, having eigen-energies $E_{nm} = \frac{!}{!}n$ where n = 0;1;2;...; + j. As is increased from $_{\text{c}}$ to approach this \lim it with j xed, the spectrum reverts from W igner-like to integrable. However, it does not follow the usual transition sequence, but rather through a sequence illustrated by Fig. 3. The spectrum becomes very regular at low energy, where it approximates the integrable! 1 results closely. Outside the regular region the spectrum is well described by the Wigner sum ise, and the energy-scale over which the change between the two regimes occurs is seen to be surprisingly narrow. As coupling is increased, the size of the low-energy integrable window increases, until it eventually engulfs the whole spectrum as ! 1.




FIG. 4: The modulus of the ground-state wavefunction (x;y) of the Dicke H am iltonian in the abstract x-y representation for nite j = 5, at couplings of = $_{\rm C}$ = 0.4, 1.0, 1.2, 1.4. B lack corresponds to M axj j and white corresponds to zero.

We now proceed to consider the wavefunctions of the system by introducing an abstract position { m om entum representation for each of the boson modes $\frac{p}{2}$ a^y + a; p_x $\frac{1}{2} \frac{T}{2} a^y$ a, and y $\stackrel{p}{\underset{1}{}_{1}} \stackrel{p}{\underset{2}{}_{0}} b^{y}$ b. In this representa- $\frac{1}{2!}$ by + b; py tion the action of the parity operator corresponds to rotation by about the origin. The ground state of the system on scaled resonance for j = 5 is plotted for different couplings in Fig. 4. These wavefunctions were obtained by diagonalising the Hamiltonian in the same basis as was used to calculate P (S) and representing the im; ji by products of harm onic osbasis vectors ini cillator eigenfunctions. For the non-interacting system (= 0), the wavefunction is a product of two indepen-

dent Gaussians. As the coupling increases, the two modes start m ixing, leading to a stretching of the single {peaked wavefunction. A round the critical coupling (wavefunction bifurcates to become a double { peaked function, and with further increases in coupling the two lobes at (x_0 ; y_0) m ove away from each other in their respective quadrants of the x y plane. Since x_0 and y_0 are of the order of j, for large j the ground state evolves into a superposition of two macroscopically distinguishable parts, which may be considered as a \Schrodinger's cat". The form ation of this state constitutes a delocalisation of the ground-state wavefunction, which is also observed in the excited states. This localisation-delocalisation transition is consistent with the transition between Poisson and W igner distributions in the spectrum [21]. The suppression of chaos at low j is then seen to be due to the fact that for low jonly a few excitations are permitted in the b-m ode. This restricts the extent of the wavefunction in the y-direction, inhibiting delocalisation, and yielding the non-generic P (S) seen in Fig. 2. It should be noted that an actual spontaneous symmetry {breaking transition occurs above c in the j! 1 lim it which removes the two lobes so far from one another that they cease to overlap and thus can be considered independently. This breaks the sym m etry of the model, allowing us to obtain the earlier exact results by using an e ective H am iltonian for each lobe. These Ham iltonians are identical in form, have identical spectra, thus demonstrating that in the therm odynam ic lim it, each energy level in the high { coupling phase is doubly degenerate and the macroscopic superposition is broken in half.

Finally, this position representation allows us to study the classical analogues of this QPT and the accompanying onset of chaos in a very natural way. By setting




FIG.5: Typical classical phase space projections ($p_x = p_y = 0$) for the classical Dicke H am iltonian of Eq. (4) with = c = 1.0, 1.06, 1.2, 1.6, for $j = 30.0, ! = !_0 = 1$. Initial conditions were x(0) = y(0) = 1, $p_x(0) = p_y(0) = 0$. The abrupt change to complex motion is observed above = c

the commutators $[x;p_x]$ and $[y;p_y]$ to zero, the classical H am iltonian corresponding to Eq. (1) is seen to be

Space limitations here only allow us to point out two signi cant features. Firstly, below c there is only one $x = y = p_x = p_y = 0.$ At = c this situation changes abruptly and two new xed points appear at $(x;y) = (x_{cl}; y_{cl})$ with $p_x = p_y = 0$, where x_{cl} and y_{cl} are approximately equal to the centres of the wavefunction lobes x_0 ; y_0 for large j. Secondly, param etric plots of typical trajectories obtained from Eq. (4) (Fig. 5) demonstrate that the system undergoes a rapid change at = c from a very sim ple quasi-periodic m otion to intricate chaotic behaviour, in agreem ent with the results of the quantum model. Note that the correspondence between this classical system and the original quantum one is signi cantly greater than previous sem iclassical treatments [22], and that this holds for any j, not just for j! 1.

W e mention that larger system sizes are required to check if there exists a critical level statistics of our model at $_{\rm C}$ [9], and that an exam ination of the exceptional points [6] of this model may yield further insight. Future work also includes a study of related models to determ ine the generality of the features described here.

In sum mary, we have seen that the P (S) distribution of the DH at nite N changes from being Poissonian to W igner at approximately $_{\rm C}$, indicating the emergence of quantum chaos. The ground-state wavefunction bifurcates at this point, forming a macroscopic superposition.

The underlying quantum phase transition is re ected in the classical model derived here by the appearance of two new xed points at c, where a transition between regular and chaotic trajectories occurs.
