Spin Di usion in Double-Exchange M anganites

The theoretical study of spin di usion in double-exchange m agnets by m eans of dynam icalm eaneld theory is presented. We demonstrate that the spin-di usion coe cient becomes independent of the H und's coupling J_H in the range of parameters $J_H S = W = T$, W being the bandwidth, relevant to colossal m agnetoresistive m anganites in the m etallic part of their phase diagram. Our study reveals a close correspondence as well as some counterintuitive di erences between the results on B ethe and hypercubic lattices. Our results are in accord with neutron scattering data and with previous theoretical work for high tem peratures.

Spin di usion dom inates the low -!, low -k excitation spectrum of a magnet in its param agnetic state and contains in portant inform ation about the spin dynam ics. In the past, spin di usion was studied intensively in Heisenberg systems and, recently, has been investigated both theoretically and experim entally for strongly-correlated itinerant m agnets.^{1,2,3} T he current grow th of interest in spintronics requires understanding how local spins relax through their interactions mediated by itinerant charge carriers rather than through their direct interactions with each other.⁴ Am ong such systems are the colossalm agnetoresistive (CMR) manganites which are ferrom agnetic m etals in a large part of their phase diagram .⁵ R ecent system atic neutron scattering experim ents on the ferrom agnetic CMR materials revealed a peak centered at ! = 0associated with the spin di usion. This peak was also seen below the ordering tem perature indicating electronic inhom openeity with regions having low er T_c 's.

In this Letter we present a comprehensive, selfconsistent, m icroscopic calculation of spin di usion applying dynamical mean- eld theory (DMFT) to the double-exchange (DE) model. We demonstrate that the spin-di usion coe cient D_s is related to the local singleparticle G reen's function and can be evaluated as a function of doping and temperature. Our results agree quantitatively with neutron scattering data on m anganites for a range of doping concentrations. Thus, our approach creates a fram ework for the self-consistent study of diffusive spin dynamics in m any real m aterials, including m agnetically doped sem iconductors.

Following the general hydrodynamic arguments of Ref. 6, we write the generalized susceptibility of a paramagnet for low energies and long wavelengths as

which through the uctuation-dissipation theorem gives the neutron-scattering dynam ical structure factor $S(q;!)' 2[n_B(!)+1]Im(q;!)$, where (q) is the static susceptibility at wave-vector q and $n_B(!) = [e^{!=T} \quad 1]^1$. We take $h = k_B = 1$ throughout this paper. Further, the generalized susceptibility can be related to the spin

current-current correlation function using the dispersion relations⁷ and the continuity equation $@S (r;t)=@t = r_i j_i (r;t):$

where $_{ij}(q;!) = i dte^{i!t} (t)h[j^{\gamma}(q;t);j_{j}(q;0)]i$ is the retarded current-current correlation function⁸, $j_{i}(q;t)$ is the ith component of the spin current for the -spin projection, i = 1:::d, d is the dimensionality, and a is the lattice constant. We use the isotropy of the spins above T_{c} and assume the isotropy of real space to suppress the indices in $_{ij}(q;!) = (q;!) _{ij}. Com$ bining Eqs. (1) and (2) in the q;! ! 0 limit, we write the Einstein relation between the spin-di usion coe cient and the spin conductivity $_{s}$ (which in general is distinct from the particle conductivity) as

where = (q = 0). These expressions are general and do not depend on the m icroscopic m odel.

We now consider the DE model with Ham iltonian

where t is the nearest-neighbor kinetic energy, J_H is the H und's coupling between the local M n³⁺ S = 3=2 spin and the electronic spin s = c^y ^ c =2, and ^ are the P auli matrices. To describe the multitude of phases in m anganites requires that the orbital, phonon, or Jahn-Teller terms be included in the above model.⁹ How-ever, the magnetic properties of these materials in the m etallic part of their phase diagram, such as the magnetic transition tem perature,^{10,11,12} are quantitatively well described by the model in Eq. (4). Therefore, such a model m ust be also capable of describing spin di usion in these system s.¹³ R egardless of modi cations of the DE model

needed to describe a particular real system, elucidating the dynam ic properties of this basic model of stronglycorrelated itinerant magnets is an important task on its own.

W ithin the DE model there is no direct interaction between the local spins. Thus, the total on-site spin $S_1^{tot} = S_1 + s_1 \operatorname{com} m$ utes with the exchange part of Eq. (4) and the spin current can be expressed in term sofelectronic operators only:¹⁴ $j_i(q) = \sum_{\substack{P \\ k}} v_k^i c_k^y$, $^{\wedge} c_{k-q}$; =2, where $v_k^i = r^{i} r_k$ and $r_k = 2t \int_{i=1}^d \operatorname{cosk}_i a$. This is simply another way of saying that electrons mediate the magnetic relaxation processes in an itinerant system .

The physical situation relevant to manganites corresponds to strong H und's coupling $J_H S = W$. Since the characteristic relaxation time for the electronic spin is short and the spin relaxation is essentially local, perturbative approaches to the spin di usion¹⁵ are inapplicable. Therefore, we employ DMFT, which takes into account the local dynamics in strongly-correlated system s and has been successfully applied to a number of problem s.^{16,17} U sing DMFT also simplifies our problem significantly because the higher-order diagrams in the current-current correlation function of Eq. (3), often referred to as vertex corrections, are identically zero within this approach.¹⁶

Thus, to evaluate the spin-di usion coe cient we apply the standard M atsubara form alism to Eq. (3) using the above de nition of the spin current:

where k and are the internal momentum and frequency of the <code>bubble"</code> diagram, respectively. Here $v_k^i = 2t \sin k_{ia}, A_k$ () = (1=)Im G_k () is the electronic spectral function, n () = [e^{())=T} + 1]¹ is the Ferm i function, and is the chemical potential.

The DMFT imposes a special form of the G reen's function in which the self-energy is k-independent and is dened from a self-consistency condition speci ed below. W ithin the DMFT parameters of the model are rescaled such that $t = t \frac{p}{z}$ is nite as the dimensionality d! 1, where $z = 2d_{pis}$ the number of nearest neighbors.¹⁶ In the following $\frac{1}{2}$ 2t is set to unity. Generally, the d = 1 lim it is well de ned for Bethe and hypercubic lattice geom etries. W hile the sem icircular electronic density of states (DOS) of the Bethe lattice is convenient for calculations, the Bethe lattice itself lacks the translational invariance and inversion symmetry implicitly used to obtain Eq. (5). Thus, it is in portant to determ ine whether the results on the Bethe lattice are equivalent to the results on the hypercubic lattice, which is free from such de ciencies. Since many problem s have been studied using the Bethe lattice,¹⁶ this com parison will have an even broader signi cance for the DMFT in general.

We brie y sketch here the DMFT equations for the DE model^{10,18} Since the self-energy is local, one can phange ${}_{R}G_{k}(E)$) $G_{"}(E) = E$ " $(E_{k})^{1}$, and ${}_{k}$) $d"_{0}(")$, where " = " ${}_{k}$, and ${}_{0}^{B}$ (") = $\frac{1}{2}$ " ${}_{E}$ =

and $\frac{H}{0}$ (") = exp ($\frac{n^2}{2}$)=^p — are the bare DOS's for Bethe and hypercubic lattices, respectively. The properties of the system are obtained from the local Green's function:

where the self-energy is de ned from (E) = g_1^{1} (E) g^{1} (E), reminiscent of the Dyson equation, where g_0^{1} (E) is the \W eiss" function containing the dynamic in uence of the environment on a given local site. The solution of the single-site problem provides a relation between g_0 (E) and (E).^{10,16} In the param agnetic state and in the quasiclassical limit S 1, such a relation is particularly simple:¹⁰ (E) = (J_H S)^2 g_0 (E), which yields

Together with Eq. (6), this gives a self-consistent condition for (E) or g(E).




FIG.1: Interacting DOSN (!) for several values of J_H S for the Bethe (solid lines) and hypercubic (dashed lines) lattices.

We now compare the Bethe and hypercubic solution for the single-particle properties. Fig. 1 shows the evolution of the interacting DOSN(!) = (1 =)Img(!) for several values of J_H S. The band splits as J_H increases and both lattice geom etries exhibit the sam e qualitative behavior. Since the hypercubic DOS is expected to have in-gap states, one may ask whether the metal-insulator transition is well de ned for a half-lled band. We nd that the band splitting in the Bethe and hypercubic lattices happens at the same critical value $(J_H S)_c = 1 = 2$. At the transition, the imaginary part of the self-energy at ! = 0 vanishes and the real part diverges. As a result, N (! = 0) is exactly zero for $J_H > J_H^c$ and the metal-insulator transition for the half- lled band in the hypercubic geometry is well de ned.¹⁹ At smallenergies, N (!) / e $(J_{H}S)^{4}=!^{2}$ vanishes quite abruptly.²⁰ In contrast, the \outer" tails of the upper and low er bands behave very sim ilar to the \bare" G aussian form . Note that

for $J_{\rm H}$ S $\,>\,$ 1, the form of N (!) for each subband is rather in sensitive to the further increase of $J_{\rm H}$.

We now rewrite Eq. (5) for the spin-di usion coe cient within the DMFT:

where b = Im () and $\hat{A}() = \frac{d''_{0}(")A_{*}() \text{ with}}{\sqrt{0}(")}$ being the \current" POS de ned from the transformation sin² k_ia) $d''_{0}(")$.²¹ For the hypercubic lattice $\overset{H}{0}(") = \overset{H}{0}(")=2$ while for the Bethe lattice $\overset{A}{0}(") = (2 \quad "^{2}) \overset{B}{0}(")=3$. To obtain Eq. (8) we used the relation $A_{*}()^{2} = [1=b \quad (e=0)]A_{*}()=2$. Since the spin conductivity is proportional to the correlation function of two spin currents, each scaling as t $1=\frac{1}{2}$, the prefactor in Eq. (8) contains 1=z. This means that dD_s is nite as d! 1, sin ilar to the particle conductivity²²

In the m anganites, the C unie tem perature T_c is m uch sm aller than either the H und's coupling or the bandwidth, in agreement with D M FT and M onte C arb calculations for the D E m odel.^{10,23} Therefore, all realistic tem – peratures are m uch sm aller than the bandwidth T W and the derivative of the Ferm i-function in the integrand of Eq. (8) should be replaced by a -function at the chemical potential. Then, com bining Eq. (8) with the speci c form of the D O S's for the B ethe and hypercubic lattices, one arrives at:




FIG.2: D_s z=a² versus n for several J_H S for the Bethe (solid lines) and hypercubic (dashed lines) lattices.

where $g^0 = Reg(), g^{00} = Img(), and f =$ Re (). Thus, the spin-di usion coe cient is expressed through the local electronic G reen's function and self-energy only. Fig. 2 presents D_s as a function of the electronic concentration n for several J_H S. As n varies from 0 to 1, the chemical potential sweeps from ! = 1 to ! = 0 in Fig. 1. The results are very sim ilar in both geom etries and become independent of $J_H S$ as $J_H S ! 1$ with the maximum located at n = 0.5. In the limit $J_H S$ 1. Eq. (9) yields a num erical value for this maximum in D_{s} z=a²: 5=6 (= 0.265) and 0.292 for the Bethe and hypercubic case, respectively. This dem onstrates a close quantitative correspondence between the results in the Bethe and hypercubic lattices, which justi es the use of the form er despite the concerns outlined earlier. An interesting feature appears in the results for the hypercubic lattice as n! 0. Instead of vanishing, the spin-di usion coe cient tends to a nite lim it D_s $z=a^2 = 1=4 (J_H S)^2$, shown by circles in Fig. 2.24

In the high-tem perature lim it T $J_H S$ 1 Eq. (8) yields the result D_s 1=T obtained previously using a Tchebyche bounds (TB) form alism $\stackrel{25}{\cdot}$ N um erically, $(D_s^{DMFT}=D_s^{TB})_{Bethe} = 40^{2} = 9^{3=2} = 1:13$ agree very closely as well.

It is interesting to analyze our results in the context of CMR m aterials. The superexchange (SE) interaction

is often discussed⁵ as necessary to correct the DE m odel. W ithin DMFT, the SE coupling J^{SE} must scale as 1=z. Combining this with the result of Ref. 1 one nds that D_s^{SE} / $1=z^{3=2}$ is suppressed in comparison with the DE result D_s / 1=z. This also serves as a dem onstration that the DE model cannot be simply reduced to an e ective H eisenberg m odel. In a reald = 3 m aterial the role of SE is further reduced by the sm allness of J_{ij}^{SE} $t^2 = J_H S in$ com parison with the kinetic energy xt. Therefore, the DE must dom inate the spin di usion and one can expect our results to be valid not only for the metallic part of the CMR phase diagram (x = 0.22:0.5 for La_{1 x} Ca_xO₃, n = 1 x in Fig. 2) but also for the ferrom agnetic insulating phase $(x \quad 0.22)^{26}$ Of course, in the lim it x ! 0 DE will dim inish and the SE will dom inate. Also, the critical scaling in the mixed phase 0 < x < 0.12 (with a m ixture of antiferrom agnetic and ferrom agnetic orders) can be strongly modi ed.²⁷ These cases require separate consideration. At x 0:5 charge ordering prevents the DE mechanism from being operative.




FIG.3: $D_s =a^2$ as a function of x. Experimental values of D_s are from Fig. 5 of Ref.3, e^{xp} is described in the text, theoretical results are from Eq. (9) for $J_H S$ 1.

A system atic neutron scattering study of the metallic manganites recently focused on spin di usion.³ The width of the observed peak in S(q;!) centered at ! = $0 \text{ scales as } q^2$, where = $2D_s$. Experimental results taken at $T^{exp}(x)$ ' 1:1 $T_{c}(x)$, where $T_{c}(x)$ is the Curie tem perature for a given hole concentration x, give 30 m eVA². To compare our results to ex-= 15 periments we use z = 6 and a = 3.87 A. But keep in mind that spin di usion persists below the transition point and that, at least for the experim entally accessible wave-vectors, the correlation length saturates at about 20 A. This implies that local magnetic correlations are suppressed by electronic inhomogeneities, which are probably associated with the local charge ordering.³ So for simplicity, we take the susceptibility in the Curie form $e^{xp} = S^{0}(S^{0} + 1)=3T$, where $S^{0}(x) = S + (1 - x)=2$ is an average on-site spin and $T = T^{exp}(x)$ is known from Ref. 3. Fig. 3 shows the theoretical data for $D_s = a^2$ for J_H S 1 from Eq. (9) as a function of x together with

experimental $D_s^{exp} = a^2$. We note here, that the theoretical curves in Fig. 3 are virtually independent of the actual value of J_H S for J_H S > 1. This gure demonstrates a remarkable agreement between the experimental and theoretical results, which contains no thing parameters. Further improvement of the agreement can be sought, for example, from taking into account the second e_{σ} band which would experimental ectively reduce $J_H = W$.¹³

Since various other experiments also indicate the presence of local inhom ogeneities in CMR system s_r^{28} we propose the following analysis. As q decreases, long-range magnetic correlations must dominate (q) and the magnetic correlation length must eventually exceed the size of the local polaronic distortions. So at a xed tem perature close to $T_c, \stackrel{exp}{}(q)$ will increase and there will be a system atic decrease in the observed value of D_s^{exp} 1= . This set of measurements would provide further information about magnetic correlations within the inhom ogeneities in CMR system s.

In conclusion, we have presented a self-consistent study of the spin-di usion in the double-exchange magnets within the fram ework of DM FT. This non-perturbative approach allows us to calculate the spin-di usion coe cient at any temperature down to a transition point. A good agreement with the experiments in the ferrom agnetic CM R manganites and earlier work is found. A ltogether, this provides a new insight into the dynamics of strongly-correlated itinerant magnets.
