Interrupted coarsening in a driven kinetically constrained Ising chain

We introduce a driven version of the 1D kinetically constrained spin chain [21]. In its original undriven version, this model shows a nom abus coarsening following a quench to a low tem perature, with an equilibration time that diverges as $\exp(1=T^2)$ for T ! 0. We show that driving of constant rate __ interrupts coarsening and stabilises the chain in a state analogous to that of a coarsening chain of age 1=_. We present an analytical theory for this steady state, and demonstrate it to be in excellent agreement with our simulation results.

I. IN TRODUCTION

G lassy system s relax very slow by at low tem peratures. They therefore remain out of equilibrium for long times and exhibit ageing [6]: the time-scale for response to an external perturbation (or for the decay of correlations) increases with the \waiting time" t_w since the system was quenched to the low tem perature, and thus eventually far exceeds the experimental time-scale. Time translational invariance is lost.

As a result of this dynam ical sluggishness, glassy systems are highly susceptible to steady external driving, even when the driving rate _ is small. (One exam ple of _ is shear rate in a rheological system .) Typically, such driving interrupts ageing and restores a tim etranslationally invariant (steady) non-equilibrium state in which the time-scale de ned by the inverse driving rate plays a role analogous to the waiting time t_w of the ageing regime [14]. This scenario was rst investigated in the context of neural networks [19,11] and has subsequently been reproduced in the di usion of a particle in a random potential [20,32]; in driven mode-coupling equations of the mean eld p-spin model [5]; and in a driven version of Bouchaud's trap m odel [25,29,31]. The results of the latter two studies were separately exploited to propose a general fram ework for the study of \soft glassy materials" [16,9,8,22,26] in which intrinsic rheological ageing is interrupted by driving (shear straining) and loading (shear stress) [9].

In this paper, we introduce a driven version of another glassy model: the 1D Ising chain with an asymmetric kinetic constraint. The original undriven model (introduced by Jackle and E isinger [21]) shows anom alous slow coarsening (\ageing") following a quench to a low tem – perature T 1, with an ergodic time that diverges as

 $\exp(\operatorname{const}=T^2)$ for T ! 0, as solved exactly by Sollich and Evans [30]. Particularly attractive features of the model are i) that its glassiness emerges as a direct result of the dynam ical constraint (w ithout the need for any underlying assumption of quenched disorder) and ii) that it contains explicit spatial interactions while being simple enough to allow analytical progress. In what follows, our

central result will be that steady driving interrupts coarsening and stabilises the chain at an apparent age 0 (1=_), consistently with the scenario described above.

Ageing and driven glassy systems in general violate the equilibrium uctuation dissipation theorem (FDT) [27]. Remarkably, however, in the ageing limit t_w ! 1 of many mean-eld [13,12] and some non-mean-eld [23,3,24,28] models, a non-trivial modi ed FDT emerges and de ness a non-equilibrium temperature T_e [15]. Cugliandolo et al. [15] proposed that an equivalent temperature should apply in the driven limit _! 0, and that T_e (_! 0) and T_e (t_w ! 1) should coincide. To date, how ever, the evidence [5,4] for this is rather limited. An added motivation for the present paper, therefore, is that the model de ned here can be used (in future work [2]) to test this scenario further via com parison of its FDT predictions with those of the undriven model [10].

The paper is structured as follows. In section II we sum marise the results of [30] for the coarsening dynamics of the undriven chain. We then de ne the novel driving rules in section III. We present simulation and analytical results for the steadily driven chain in sections IV and V respectively, demonstrating that driving of rate _ halts coarsening at an elective age 1=. We sum marise and give an outbook for future work in section VI.

II.COARSENING IN THE UNDRIVEN MODEL

The model consists of a chain of L Ising spins $s_i \ 2 \ 0; 1$ (l < i L) in a uniform eld of unit magnitude, which is oriented such that a spin's energy $E_i (s_i) = s_i$. Periodic boundary conditions apply: the left neighbor of s_1 is s_L . The dynamics are subject to the following constraint: at any time, only those spins whose left neighbor is up are allowed to ip. For these \mobile" spins, the rate of down-ips is 1 while the rate of up-ips is

= exp(1=T). The equilibrium distribution is unaffected by this constraint: detailed balance is obeyed and the static distribution is the trivial one prescribed by the H am iltonian H = $\sum_{i=1}^{L} s_i$. In contrast, the dynam ics are rendered very slow at low temperatures, for which

the equilibrium concentration of up spins (that facilitate the dynamics) c = = (1 +) is small.

In this section we review [30], which solved exactly the relaxation of a chain prepared at a low temperature T 1 via rapid quench at time $t_w = 0$ from a high initial temperature $T_i = 1$. At any time t_w during the relaxation, the authors of [30] described the system 's state using the concept of \dom ains". As shown by the vertical lines in

(in which the 0 spins are represented by \ "for clarity) a dom ain is de ned as an up-spin, and all the down-spins separating it from the next up-spin to the left.

In mediately after the quench, the average domain length d 1=c=0 (1). The system then relaxes towards the low temperature's equilibrium state in which d=0 (1=), and thus in which, in the lim it ! 0, there is zero probability of nding an up spin in any nite length of chain. Hence, in this lim it (! 0 at xed chain length) the dow n- ipping of spins is irreversible, and the relaxation com prises a coarsening process in which adjacent dom ains progressively coalesce with one another.

The mechanism for this coalescence is as follows. Consider, at some time after quench, a domain of length d 1= together with its left-bounding up-spin. For the purposes of the present argument, we assume that the left-bounding spin is \clamped" and consider how the right-bounding up-spin relaxes. Because of the constraint, before the relaxation can occur a facilitating upspin has to be generated im mediately to the left of this spin, via a propagation of the up state rightwards from the left-bounding up-spin. The relaxation is thus im peded by an energy barrier, the height of which is the maximal number of spins that are ever up within the (original) dom ain at any instant during this relaxation process. A central result of [30] is that for dom ain lengths $2^{n-1} < d$ 2^n this barrier scales as n, leading to a relaxation time-scale 0 (ⁿ).

Hence in the limit ! 0 the dynamics comprise well separated stages, the nth of which has time-scale ⁿ and results in domains of index n being destroyed by coalescence with their right neighbors. In logarithm ic time, $_{\rm w}$ = log t_w = log = T log(t_w), the nth stage collapses to the point $_{\rm w}$ = n. The average domain size d thus exhibits step-wise increases at successive integer values of $_{\rm w}$, as seen in gure 1 of [30].

W ithin this coarsening regime (d 1=), the full domain length distribution P (d) can be calculated using an exact independent interval treatment [7] which states that no correlations can build up in the length of adjacent domains provided none are present in the initial state. At stage n the distribution obeys [30]

in which the rescaled time = tⁿ can take any positive value > 0 in the limit ! 0. Equation 1 describes the coalescence of the \active" domains of length d⁰ 2[°] with neighboring domains of length d d⁰. Its initial condition is the domain length distribution at the end of stage n 1 of the dynamics, denoted P_n (d) = P (d; ! 0). U sing generating functions it can be shown that

in which $P_n^{act}(d)$ is the active part of the distribution (zero for $d > 2^n$) and in which... denotes a series of convolutions of increasing order. Equation 2 holds only for $d > 2^n$: all active domains (d 2^n) disappear in the n^{th} stage.

The weight of the distribution shifts to larger d at each stage of coarsening. See gure 2 of [30]. A scaling limit is approached for large stage number n: the re-scaled distribution P'_n (x = d=2ⁿ ¹) = 2ⁿ ¹P_n (d) converges to the limit P'_{age} (x) which obeys, for x > 2, the scaling counterpart of equation 2:

In [30] the exact solution for $P_{age}(x)$ was shown (via the re-sum m ed Laplace transform of 3) to be

III. DEFINITION OF THE DRIVEN MODEL

In this section we incorporate non-H am iltonian driving into the m odel. As a prelim inary step, though, we redene the relaxational dynam ics slightly, extending state space such that each spin $s_i 2 = 1;0;1$ and re-de ning the H am iltonian $H = \prod_{i=1}^{L} j_{i}j_{i}j_{i}$. The uniform eld has thus been replaced by a potential well for each spin, with a m inim um at $s_i = 0$. As before the dynam ics are constrained: only those spins for which the left neighbor has a value 1 or 1 are allowed to j_{i} via the usual therm all processes in which the transition rate for $s_i : 1! = 0$ and for $s_i : 1! = 0$ is 1, and for $s_i : 0! = 1$ is .

So far, of course, the model can be exactly mapped onto the original one by a trivial relabelling $s_i = 1$!

 $s_i = 1$ and re-scaling ! = 2.0 urm otivation for introducing the 1 state is to make a bose analogy with glassy rheologicalm odels [31,17,18] in which a local state of high energy (here $\dot{p}_i j = 1$) can have either positive or negative local stress (here $\dot{p}_i j = +1$, $\dot{p}_i j = 1$). If we de ne a global stress $= \frac{1}{L} \prod_{i=1}^{L} s_i$, the 1 state allows a state of m acroscopically zero stress, which still has internal local stresses (som e positive, som e negative) and a non-zero rate of internal dynam ical rearrangem ents.

W e now incorporate steady driving into this three state version. Loosely this m in ics, in a stochastic way, the standard rheological experiment of applying shear strain of constant rate _. To do this, we impose a ip rate of _ for s_i : 1! 0 and _ for s_i : 0! 1. This is additional to the constrained rates de ned above and free of the kinetic constraint. The driving rates ! for this extended m odel can therefore be sum m arised as follow s:

in which periodic boundary conditions in pose $s_0 = s_L$.

This stochastic straining clearly tends to increase the global stress, as required intuitively. We note, though, that our stochastic rules only make sense for _ 0. For negative _we would rede ne the driven contribution to the rates as equal to j_for the transition $s_i :1 ! 0$ and j_for $s_i :0 ! 1$. The model is in this sense singular at _= 0.

IV.SIM ULATION RESULTS FOR THE STEADILY SHEARED MODEL

We simulated the driven chain using a waiting time Monte Carlo technique combined with a binary search algorithm for locating the mobile spins, following [30]. For each run we initialised the chain either in equilibrium (with = 0) at a low temperature T = 1= log 1, or by quenching to T from T = 1. For the quenched case, we then let the system relax according to the undriven rules (= 0) until a start-up time t_s, when we set _ to the non-zero, constant value of interest. Equilibrium initialisation formally corresponds to a quenched chain subsequently allowed to relax until $t_s = 1$, and in this case we applied the non-zero _ from the start of the simulation. In order to explore the hypothesis that driving restores a steady state analogous to the state of a coarsening chain of age $t_w = 1 = _{r} we$ chose values of $1 = _{r}$ corresponding to the waiting tim es studied in [30] for the undriven chain. Speci cally, therefore, we are interested in the low temperature limit in which ! 0, _! 0, at

xed values of $= \log () = \log () = T \log (1=)$ that are large compared to 1 (weak driving), but small enough that the system remains far from equilibrium. (To avoid possible confusion we note that becomes large as _becomes small, since _= with 1. A lthough this is at rst sight a counter intuitive way to characterise the shear rate, we chose this particular de nition for as the closest possible analogy that of w for the undriven chain.)

In each run wem on itored the stress and total energy E as functions of time t_w . Results for the quenched initial condition with start-up time $t_s = 0$ are shown in gure 1, for = 0:01 and various values of . As becomes larger (_smaller) we can make the following observations. At early times, E and have time evolutions that are independent of _, and that (we have checked) are the same as those of an undriven chain. In contrast, after a crossover at time 0 (1=_), E and approach steady-state values. We have checked by repeating the simulation for the di erent initial conditions described above that these steady values do not depend upon the initial state or (for the quenched case) the start-up time t_s. For the rem ainder of the paper, we shall be concerned only with the ultim ate steady state, and not the kinetics of its form ation.

The steady state stress is re-plotted in gure 2 as a function of (which increases with _) for various sm all values of 1. (In rheological parlance, (_) is the ow curve.) It appears to be approaching a step-like function as tem perature is tracked towards zero, com prising plateaux separated by jum p-w ise discontinuities at integer values of .




FIG.1. Stress (solid lines) and energy E (dashed lines) vs. scaled time $_{\rm W}$ = log(t $_{\rm W}$)=log() following a quench at time t $_{\rm W}$ = 0, with driving commenced also at t $_{\rm s}$ = 0; for all curves = 0.01. The parameter log_=log has values 0.5 (), 1.0 (2) 1.5 (3) 2.0 (4) and 2.5 (5). Each curve was obtained from a single run for a chain of length L = 2^{16} .

For all the steady states studied, we found the concentration of 1 spins to be sm all (O ()), and hence that (to within such corrections) the stress, the energy, and the




FIG.2. Steady state ow curves plotted on a log scale vs. = log _= log . Simulation results for three values of = exp(l=T) are shown, obtained from a single run for a spin chain of length L = 2^{16} . Bold line: theoretical prediction for T ! 0.

concentration of + 1 spins coincide (consistently with the results of gure 1). Using the usual dom ain description (in which for de niteness we neglect the 1 spins, taking only 1 spins to constitute the dom ain boundaries), we have then = 1=d where d is the average dom ain length.

We note the striking similarity between the dependence of logd upon scaled waiting time $_{W} = T \log t_{W}$ in the coarsening chain (gure 1 of [30]), and the dependence of log = logd upon the scaled driving rate = T log(1=_) in the steadily driven chain (gure 2 of this paper). This already gives us a strong indication that the steady state of a chain driven at rate _ is analogous to the state of a coarsening chain of age $t_{W} = 1=_{-}$.

This hypothesis is con med by our simulation data for the full dom ain length distribution P (d) on the developing plateaux of the ow curves. In particular, we nd that the distribution for the steadily driven chain at a given is closely analogous to that of a coarsening chain for w = . For a given (or w), both display a discontinuity at the same (w) dependent cuto and have very sim ilar averages. Both shift abruptly to larger values of d as (,) crosses successive integers, but are unchanged as (w) is swept between integers. In order to maintain the closest notational analogy with [30], we denote by P_n (d) the distribution P (d) in the lim it of small for values of such that n 1< < n.Our results for P_n (d) for = 0.5; 1:5; 2:5, corresponding to n = 1;2;3, are shown in gure 3 and are, as just noted, very sim ilar to the counterpart results of gure 2 of [30] for the coarsening chain.

In the coarsening chain, the discontinuous shift of P(d) as $_{\rm w}$ crosses successive integers arose from the waiting time crossing the time-scales for successive coarsening stages. Likewise in the driven chain it arises from the

inverse driving rate crossing these same time-scales. (See the theory section V for more details.)

These simulation results therefore show that (consistently with the phenomenology of other driven glassy models) driving interrupts coarsening and stabilises the chain in a state that is strikingly analogous to that of a coarsening chain of apparent age 0 $(1=_)$.




FIG.3. Dom ain length distributions P_n (d) on the plateau = n 1=2 of the ow-curves. Open symbols and lines: theoretical results for n = 1 (squares), 2 (diam onds), 3 (triangles). Full symbols: simulation results for a chain of length L = 2^{16} and = 10^{-4} (n = 1;2) and = 10^{-3} (n = 3). Inset: scaled predictions $2^{n-1}P_n$ (d = $2^{n-1}x$) vs. x for n = 1;:::;16.

V.THEORY

We now present a theory aim ed at calculating the steady-state distribution P_n (d) just de ned. We assume from the outset that no correlations exist between the lengths of adjacent domains. We also assume (consistently with our above remarks) that the concentration of 1 spins is negligible. We will return to justify these assumptions in more detail at the end of this section.

Consider, then, a chain with an O (1) population of +1 spins and a complementary O (1) population of 0 spins. In the absence of driving, the only process a ecting the chain would be the coarsening described above, with dow n-ipping of 1 spins occurring irreversibly (for xed chain length and ! 0), and the average domain length increasing as domains of length $2^{n-1} < d = 2^n$ are destroyed on a time-scale O ($^{n-1}$) by coalescence with their right neighbors.

In the steadily driven chain, this coarsening process is balanced by intra-dom ain driven up- ipping of spins $s_i : 0 ! 1$. For the nite dom ain lengths to which we shall restrict ourselves, this driven dom ain intersection occurs on a time-scale 0 (1=_) 0 (). For a non-integer value of such that n 1 < < n, this time-scale sits between the time-scales $(n \ 1)$ and n for the

adjacent coarsening stages n $1 \text{ and } n \pmod{\text{min}}$, and separates from them in the limit ! 0.

On this driving time-scale, therefore, any domain of index n^0 n 1 (present either as a rem nant of the initial condition, or as a result of a driven up- ip 0 ! 1within an existing domain of length $d > 2^{n-1}$ a distance d 2^{n-1} from the domain boundary) must relax innitely quickly. We thus expect $\lim_{t \to 0} P_n(d) = 0$ for 2ⁿ 1 such dom ain lengths d d. This de nes the cut-o length d_c observed in the simulation data above. Domains labelled by $n^0 > n = 1$, i.e. of length $d > d_r$, on the other hand, coarsen in nitely slow ly on the driving tim e-scale: the only dynam ical processes that can a ect these \long" dom ains are those initiated by driven upip of an intra-dom ain 0 spin. This up- ip can occur at

a distance that is either d_c or > d_c from either end, giving 4 separate cases:

A .If the original long dom ain was longer than 2gH 1, and if the up- ip occurred at a distance of at least d_c + 1 from both ends, we see creation of two shorter dom ains that are still both \long" in the sense that d > d_c:

(For de niteness all the diagram s in this section assume an arbitrary cuto value $d_c = 4$.)

Considering the chain as a whole, such processes lead to the destruction of domains of length d > $2d_c + 1$ at a rate

D. If the original dom ain was of length d 2d both the sub-dom ains could be short (d d). For this class as a whole (i.e. averaging over the position of the up- ipped spin) there are two subclasses of possible outcom e, which by symmetry each occurs with a probability one half. First, the freshly ipped up-spin could relax before the rightbounding spin of the original dom ain and we would see no net change. A liternatively, we could see

C om bining all these processes we get an evolution equation $\mathfrak{G}_t P_n(d) = :::$ for the \long" domains $d > d_c$, which we set equal to zero (steady state) and solve num erically using an iterative procedure. The solutions for n = 1; 2; 3 for which $d_c = 1; 2; 4$ respectively are marked as open symbols gure 3 and give excellent agreement with the simulation results. We also used these solutions to calculate the stress, = 1=d. As expected, this exhibits discontinuous jumps at integer values of as the driving tim e-scale crosses successive coarsening tim e-scales and P (d) shifts discontinuously to larger d. It is marked as the solid line in gure 2 and again agrees excellently with the simulation data.

As $d_c \ ! \ 1$, a scaling lim it $d_c P(d) = P(x = d=d_c)$ is approached. See the inset of gure 3; and gure 4. Taking the lim it $d_c \ ! \ 1$ at xed $x = d=d_c$ in the steady state equation just derived, we not that this scaling state must obey the equation

W e note for use below that the function f(x) (thus dened) is discontinuous at x = 1, and the rst derivative $g^{(1)}(x)$ of g is likewise discontinuous at x = 2. In principle, equation 11 contains all the information needed to calculate P analytically. For the counterpart state $P_{age}(x)$ in the undriven chain, the closed expression (equation 4) was found [30] as the self-consistent solution of a simple algebraic relation between the Laplace transform sG and H of $\mathbb{P}_{age}(x)$ and $\mathbb{P}_{age}(x)$ (2 x) respectively. The corresponding transform of equation 11 for the driven case is a complicated di erential relation between G, H, G $^{(1)}$ and H $^{(1)}$, and we have been unable nd a self-consistent analytic solution. How ever our num ericalresults (see gure 4) dem on strate that P(x) is (as expected) very sim ilar to its undriven counterpart $P_{age}(x)$: both have a unit Heaviside discontinuity at x = 1 and show sim ilar decay for x > 1. A lthough the discontinuity in the st derivative $\mathbb{P}_{age}^{(1)}(x)$ at x = 2 (strongly apparent in the dashed curve of gure 4) is less noticeable in the solid curve for the driven state P, it is revealed by num erical di erentiation in the inset of gure 4.

It was shown in [30] that the ageing scaling distribution P_{age} has a nite discontinuity in its kth derivative at x = k + 1 for all integer k 0. We have already seen num erically that the driven scaling distribution shares the discontinuities for k = 0;1. We shall now outline an analytical argum ent which can be used to show that in fact the driven distribution shares all of these discontinuities. We con neourselves to k 1 since our analysis has already captured the discontinuity in P itself at x = 1. D i erentiating equation 11 once we get

$$g(x) \mathcal{P}^{(1)}(x) = g^{(1)}(x) \mathcal{P}^{(x)} + \mathcal{P}^{(x)} + \mathcal{P}^{(1+x)}$$
$$Z_{2}^{(1)} dx^{0} f(x^{0}) \mathcal{P}^{(1)}(x - x^{0}): \qquad (12)$$

On the right hand side (RHS) of this expression, $g^{(1)}(x)$ is discontinuous at x = 2 (as noted above), while the integral over the in nite discontinuity ($x = x^0 = 1$) of the di erential $P^{(1)}(x = x^0)$ in the last term 's integrand gives (3 x)f(x = 1), which is discontinuous at x = 2. All other terms on the RHS are continuous for all x > 1. Hence P⁽¹⁾(x) has a nite discontinuity at x = 2. By performing successive di erentiations, we can extend this argument to arbitrarily high k: $P^{(k)}(x)$ has a nite discontinuity at x = k + 1 for all k 0.




FIG.4. Scaling distribution P'(x) for the driven chain (solid line) and $P'_{age}(x)$ for the coarsening chain (dashed line). Inset: derivative dP'=dx for the driven distribution, showing a slight discontinuity (too sm all to be discernible in the undifferentiated data of the main gure) at x = 2.

O ur central result can therefore be sum marised as follows. We have shown that a steadily driven chain approaches a scaling state in the limit of small _. We have shown that this scaling state is strikingly analogous to the counterpart scaling state of a coarsening chain of age $t_w = 1=$. In particular, both states have a unit H eaviside discontinuity at x = 1, and (m ore generally) a nite discontinuity in P'^(k)(x) at x = k + 1.

D espite the striking qualitative sim ilarities in the distributions P'(x) and $P'_{age}(x)$, there are obvious quantitative discrepancies. This is not inconsistent with the

phenom enology of other glassy models: the ageing state of Bouchaud's trap model [25], for example, is analogous but not identical to its steadily driven counterpart [31]. It is nonetheless instructive to consider the origin of the discrepancies. An obvious candidate is our introduction in the driven model of the 1 spin state. However, in steady state the population of such spins is sm all. Indeed, we have checked that dom ain distributions produced by driven simulations without the 1 state agree with those that include the 1 state to within O().

The discrepancies must therefore be of dynam ical origin. During coarsening, the only process is domain coalescence. Therefore inform ation can only propagate up the distribution (to largerd). In this way the scaling lim it $P'_{age}(x)$ is completely determ ined by $P(x^0)$ for $x^0 < x$, as seen in equation 3. In contrast, in the driven chain P'(x)is connected to all $x^0 ! 1$, since driven domain intersection acts on domains of all lengths; see equation 11. Furtherm ore, in the ageing chain the domain lengths set the dynam ical rates only via the coarsening tim e-scales ⁿ. In contrast, the driving dynam ics are further sensi-

tive to dom ain length through the additional feature that a longer dom ain is more likely to be intersected.

The most apparent dierence between $\mathbb{P}_{age}(x)$ and P(x) is the much smaller discontinuity in P(1)(x) at x = 2. This can be explained as follows. The discontinuity in $\mathcal{P}^{(1)}(x)$ arises from an interplay between the discontinuity in $g^{(1)}(x)$ at x = 2 and in f(x) at x = 1(recall equation 12). Physically, g(x) is the rate at which dom ains of scaling length x are destroyed. This is discontinuous because driven intersection of a dom ain of scaled length x < 2 can produce two active domains (scaling length < 1), whereas only one can be active for x > 2. Sim ilarly, the discontinuous part of $f(x^0)$ results from the production of dom ains of length x via aided coalescence (process D above) which can only occur for x < 2. These two e ects are of comparable (not identical) m agnitude but opposite sign resulting in only a sm all discontinuity in $\mathbb{P}^{(1)}(x)$. In contrast, the discontinuity in $\mathbb{P}_{age}^{(1)}(x)$ arises from a single process, the origin of which can be seen from equation 3. The second term on the RHS describes the production of dom ains of length x via coalescence of an active domain of length x^0 with a right neighbor of x^{0} . However if $x = x^{0}$ is itself active, the right length x neighbor can relax before the x^0 dom ain, resulting in a dom ain of length > x. The rate of producing dom ains of length x is thus reduced, as encoded in third term on the RHS. The cuto in the active distribution at x = 2m eans that the derivative of this term is discontinuous at x = 4.W hen transferred to the next coarsening stage (encoded in the LHS of the equation), this discontinuity appears in $P_{age}^{(1)}(2)$. The higher convolutions not show n in equation 3 are sm ooth enough not to a ect this argument.

We nally return to justify our two assumptions:

rstly, that the population of 1 spins is negligible in the steady state. As noted above, we have already numerically observed this population to be 0 () (sm all); we are now in a position to show this theoretically, as follows. Over a time-scale < 1=_, the only mechanism in which 1 spins can be created involves propagation of the facilitating state (1 or 1), via constrained therm al activation, to within a distance $d < d_c$ to the right of one of the existing facilitating spins. Denoting by $_{c}$ (d) the time-scale on which dom ains of length d coarsen, the time-scale upon which a 1 spin is created at a distance d from an existing facilitator is $_{c}(d) = .$ Once created, such a spin will relax back to the 0 state on a tim e-scale $_{\rm c}$ (d). Hence in the steady state, the population of 1 states must be O (), which is indeed small in the lim it considered here.

Our second assumption was that of \independent intervals". This was used in [30] for the coarsening process of the undriven chain, and in that case is provably exact. We have not been able to prove its strict validity for this driven case. However, our simulation results show that the relevant correlation function $C = \prod_{j=0}^{n} (d_j \quad hdi) (d_{j+1} \quad hdi) = \prod_{j=0}^{n} (d_j \quad hdi)^2$ (in which hdi)² (in which d_j is the length of jth dom ain from the left hand end of the chain, and n is the total num ber of dom ains) is not greater than 10³ in any of the steady states considered; the assumption therefore is likely to be reasonable. Note that our num erical observation of a non-zero correlation function could still be consistent with the independent interval approximation being exact in the limit ! 0 at xed . Indeed, we have observed that, as is tracked dow nwards, the num erical value of the correlation function gets sm aller.

VI.SUM MARY AND OUTLOOK

W e have incorporated driving dynam ics into the kinetically constrained spin chain of [21], and presented sim – ulation results showing that the coarsening dynam ics of the undriven chain (as solved in [30]) are interrupted by steady driving. Consistent with the broader glassy literature [14,19,11,20,32,5,29,31] we have found that steady driving stabilises the chain at an apparent age set by the inverse driving rate. W e have presented a theory for this steady state, demonstrating it to be in excellent agreem ent with our simulation results. W e have shown that a scaling state is approached at small $_$, and that this scaling state has very sim ilar properties to its counterpart scaling state reached at long tim es in the coarsening chain.

We now outlook some possible directions for future work. Above, we focused on a chain which is steadily driven at a constant rate _. We also noted the loose analogy of this driving scenario to that of constant shear

rate in a rheological system . In the spirit of this rheological connection, we can identify possible analogues of two other standard rheological tests { step strain and step stress { which it would be interesting to investigate further. For a step strain of size 0 we promote, at the time t_w of strain application, a fraction $_0$ of 1 spins (chosen random ly) according to s_i : 1! 0 and of 0 spins (again chosen random ly) $s_i: 0 ! 1. W e do this without regard$ to the kinetic constraint. For all other times the system m erely relaxes under its undriven constrained dynam ics. (Note that the step at t_w is just the \impulsive lim it" of the above steady shear case: dt = 0, with dt ! 0and $_!$ 1.) For a step stress of size $_0$, we apply the sam e dynam ics just de ned for the step strain up until the time t_w^+ . (We can merely rename 0 by 0 because 1.) Fort> t, we implement the spring constant" kthe \constant" strain-rate dynam ics de ned above, but with $_$ continuously adjusted to ensure that $_0$ remains (on average) a constant.

A s noted in the introduction, it would also be interesting to study FDT in the driven steady state (at constant _) to see if any e ective tem perature em erges, and (if so) whether it coincides with any e ective FDT tem perature of a coarsening chain of age $t_w = 1=$. This is the subject of a forthcom ing publication [2].
