Low temperature properties of a quantum particle coupled to dissipative environments

We study the dynam ics of a quantum particle coupled to dissipative (ohm ic) environments, such as an electron liquid. For certain choices of couplings, the properties of the particle can be described in terms of an electron mass. A particular case is the three dimensional dirty electron liquid. In other environments, like the one described by the Caldeira-Leggett model, the electron mass diverges at low temperatures, and quantum elects are strongly suppressed. For interactions within this class, arbitrarily weak potentials lead to localized solutions. Particles bound to external potentials, or moving in closed orbits, can show a rst order transition, between strongly and weakly localized regimes.

I. IN TRODUCTION

The suppression of quantum e ects by dissipative environments is a subject of current debate. It is known that in certain cases, like a quantum particle tunneling in a two level system [1] or in a periodic potential[2], whose coupling to the environment can be described by the Caldeira-Leggett model[3], quantum e ects can be almost completely suppressed at low temperatures. On the other hand, perturbative calculations for the dephasing rate of electrons in a dirty Ferm i liquid suggest that dephasing becomes irrelevant at low temperatures[4, 5]. Recent experiments[6], see also[7], have increased the interest in this topic, and a variety of theoretical analyses, with di erent conclusions, have followed [8, 9, 10, 11, 12, 13, 14].

The simplest situation where the elect of the dissipation can be studied is that of a single particle interacting with an external environment. A particular case is the Caldeira-Leggett model, where a specic choice of environm ent and coupling is made. This model has been extensively studied, and it is known that the di usion of the particle at long times cannot be expressed in terms of a nite e ective mass. In the following, we analyze related m odels which describe environm ents such as a dirty electron liquid. The results can be useful in understanding the quantum properties of external particles, such as protons or m uons, at surfaces or inside m etals[15, 16, 17]. In addition, the m odels studied here provide the sim plest exam ples where the e ects of the environm ent on quantum e ects can be studied in the strong coupling, non perturbative, regim e.

The next section describes the general features of the model. The method of calculation is discussed next. Section IV presents the results for a particle moving in free space. Section V includes extensions for particles local-

ized around external potentials, or moving in bound orbits. A comparison with perturbation theory is presented in Section VI. The main conclusions of the present work are discussed in section VI.

II. THE MODEL

A convenient scheme to treat the problem of a particle interacting with an external environment is to integrate out the environment, and to analyze the resulting dynam - ics of the particle using the path integral formulation of quantum mechanics. The e ect of the environment is to induce a retarded interaction among di erent positions X(); $X(^{0})$ along a given path. The coupling to a given environment is de ned as ohm ic if this interaction decays as $(^{0})^{2}$ at long times. In this case, the dynamics of the particle in the classical limit, $h^{2}=M ! 0$, where M is the mass of the particle, can be described in terms of a macroscopic friction coe cient, which is nite as the velocity of the particle approaches zero (see below).

The electronic charge uctuations [18]:

where \hat{X} is the coordinate of the particle, $\langle x \rangle$ describes the charge uctuations of the electrons, and the V is the coupling potential. The induced retarded putential can be written as:

and that xes the long time behavior of the retarded interaction, eq.(2), which decays as $(^{0})^{2}$. Finally, we can write for the elective action of the particle [18, 19]:

The function F is determined by the coupling between the particle and the electronic charge uctuations.

The Caldeira-Leggett model can also be written in the form given in eq.(4), where the function F is F / \mathbf{x} () $\mathbf{x}^{0}(^{0})\mathbf{f}$, and is the macroscopic friction coe cient. O ther generalizations of the Caldeira-Leggett model, used in relation to Coulomb blockade, include higher order terms in the collective coordinate [20, 21], associated with higher order tunneling processes. These terms typically involvem any di erent times as well. The derivation of eq.(4), using second order perturbation theory, leads to non linear terms which couple the coordinates at two di erent times only.

In general, we can write the function F as:

where is a dimensionless constant and l is a length scale typical of the uctuations in the environment. We assume, without loss of generality, that f(0) = 0 and $f^{0}(0) = 1$. At high temperatures, where $l_{T} = \frac{1}{h^{2} = (M T)}$ l, the motion of the particle is determined by $\lim_{u \ge 0} F(u) = \hat{f}f^{0}(0)$. In this limit, eq.(4) is equivalent to the Caldeira-Leggett model with a friction coe cient $= =1^{2}$.

In the following, we will assume that the response function of the environment is that of a dirty (di usive) electron liquid, and the external particle couples to the charge uctuations via a screened C oulom b potential. Then:

where F(q) is the Fourier transform of $F X() X^{0}(^{0})$. In the calculation of F we have included the full selfconsistent screened C oulom b

potential. The expressions in eqs.(6) determ ine the the function F in eq.(4) for distances greater than the m ean free path, l. At shorter distances, we will choose a regularization consistent with the expected asymptotic regime. Finally, we will compare the results with two other choices of the retarded interaction: i) the one appropriate for the Caldeira-Leggett model, and ii) a retarded interaction which decays exponentially beyond a certain length, 1[22]. The retarded actions to be considered, expressed in terms of the function f given in eq.(5), are:

C om bining eq.(5) and eqs.(7), the macroscopic friction coe cient is, in all cases, $= =1^2$. For the dirty electron gas, $\hat{1}^{D} = (D)$. This value can change if the particle is coupled to di erent electronic reservoirs. For a clean electron gas, can be written in term s of the phaseshifts induced by the presence of the particle on the electrons at the Ferm i level[28]. In the following, we will treat as a variable which can take arbitrary values.

III. THE CALCULATION

A. Perturbative expansion.

The action described in eq.(4) can be solved exactly when the retarded interaction is given by the Caldeira-Leggett m odel. In this case, the action depends quadratically on the spatial coordinate, X (). In the following, we will assume that is the imaginary time.

In general, one can write the expansion:

The case where only the n = 1 term in the sum in eq.(8) is non zero corresponds to the C aldeira-Leggett m odel. O ne can write a perturbative expansion for the corrections due to the n > 1 term s. Typical diagram s are given in Fig.[1]. It is easy to show that all $_n$; n > 1 acquire logarithm ic corrections. In Renorm alization G roup term s, they are all m arginal. In this respect, the m odel differs from standard m odels in statistical mechanics, where usually only quartic term s need to be considered. If we only consider the quartic term, $_2$, the logarithm ic divergence of the perturbative series lead to the scaling equations (see Fig.[1]):

where $l = log(_{0} =)$, $_{0}$ is the initial high energy (short time) cuto needed to regularize eq.(4), and is the effective cuto. A scaling approach following eq.(10) is, how ever, im practical, because one should consider an innite set of coupled equations, including all the couplings.

B. Large N approxim ation.

The non linear term s in the action in eq.(8) are greatly simplied when the number of components N of the vector X is large. In order to have a consistent theory, we must rescale the argument u of the function f(u) in eq.(5) so that f(u) = N f(u=N), where u is proportional to $\Re() \propto 3^{0}({}^{0})f$. In terms of the diagram matic expansion sketched in Fig.[1], we need only to consider closed loop diagrams, like those in Fig.[2]. These diagram s can be sum m ed using standard large-N techniques in statistical mechanics[23, 24, 25], leading to the equations:




FIG.1: Some simple diagram s which renormalize the values of $_1$ and $_2$ in eq.(8). The propagators are proportional to $_1$ ¹. Indices denote components of the vector X.




FIG. 2: Sketch of the selfconsistent solution of closed loop diagram s which leads to eqs.(11).

C. Variational ansatz.

The large-N expansion described in the previous subsection can be alternatively formulated as a variational approximation to the action in eq.(4). We use the ansatz:

where () is a function to be determined from the minimization of hS $S_0 i_0 + F_0$. The subscript 0 m eans averaging with respect to S_0 , and F_0 is the free energy associated to S_0 .

The function () satis es the equation:




FIG.3: Sim plest diagram which gives a vertex correction to the variational scheme discussed in the text.

D. Vertex corrections.

For the physically relevant class of N = 2;3, the above approximations neglect vertex corrections, like those shown in Fig.[3]. In the next section, we will analyze them, and argue that they do not change qualitetively the solutions.

Eqs. (16) and (17) are equivalent to eqs.(11). The advantage of the variational formulation is that it can be extended to nite values of N. The expectation values to be calculated are of the type:

IV. RESULTS.FREE PARTICLE

A. Param eters of the model.

Eqs. (11) can be solved selfconsistently. The model has two dimensionless parameters, the value of , dened in eqs.(5,7), and the ratio $h^2 = (M \ l^2 \ _0)$, where $_0$ is the cuto in the spectrum of the environment, which we will assume to be nite. Note, however, that, for most physical quantities, the lim it $h^2 = (M \ l^2 \ _0) ! 0$ is well dened. The scaling given in eq.(13) allow sus to set M = 1 and l = 1.

B. A sym ptotic analysis.

We rst analyze the selfenergy correction due to the environment, (!) in eq.(11). At very short times, $0 = 0^{-1}$, the environment cannot in uence the particle, and () = 0. For times 0 such that G () is small, \hat{X} () \hat{X} (0^{-1})² l². Then:

In this regime, the behavior of the system is indistinguishable from that of an e ective Caldeira-Leggett m odel, and:

This approximation is valid provided that G() \hat{f} . This contraint sets a maximum time, 1 (M $\hat{f}e$)=, beyond which the di usion of the particle cannot be described by eqs.(21). For 1, (!) acquires a contribution:

where a a term arising from times longer than $_1$, $_1$ (!), has to be added.

 $_{_1}$ (!) is determ ined by $\lim_{u \ge 1} f(u)$ in eqs.(7). If $_{_1}$ (!) goes to zero faster than $!^2$ as ! ! 0, then G () / . Hence, we can check if the asumption that G () / . Leads to a self consistent solution. We insert this ansatz into the expression of $_{_1}$ (). At long times, we have:

where c is a constant. If $f^0[G()]$ decays faster than G()¹, then $\lim_{l \neq 0} (l)^1$ (l) goes to zero faster than l^2 .

This equation describes the propagation of a quantum particle with elective mass M $_{\rm eff}$ $\,$ M e .

In terms of the action in eq.(4), the previous analysis allows us to describe the dynamics of the quantum particle in terms of a renorm alized e ective m ass when the function which de nes the coupling to the environm ent is such that:

This is the case when the environment is a three dimensional dirty electron liquid, or for a short range kernel, see eqs.(7). It is interesting to note that, for nite dimensions N, eq.(18) implies that $F = X() = X(^0)^2$ never decays faster than $X() = X(^0)^N$.

C. Vertex corrections.

The scheme used here neglects vertex corrections. D iagram s such as the one shown in Fig.[3] give a contribution, vertex () to (), and can change the above results if they decay at long times more slow ly than ³. The diagram in Fig.[3] goes as:

If G () and f is such that eq.(25) is satis ed, then vertex () decays faster than ³ at long times, and the correction from the diagram in Fig.[3] does not change the results described above. It is easy to show that the same is also valid form one complicated vertex diagram s. This analysis leads us to conjecture that, when the dynam ics of the particle can be described in terms of an e ective m ass, vertex corrections are irrelevant.

D. Simple actions.

The previous analysis allows us to study the simple case where F (X) = $_n \not X \not J^n$. The case n = 1 corresponds to the Caldeira-Leggett model. For n > 1, we can make the ansatz lim $_{! 1}$ G () / $a_n \log^n$ (). Then,

This correlation function implies that the particle is never localized, although it can di usem one slow ly than for the Caldeira-Leggett model. The elective mass diverges at low temperatures. The case n = 1=2 corresponds to the one dimensional dirty electron gas, described in eq.(7).

E. Num erical results.

W e have solved iteratively eqs.(11) for di erent choices of the environment. The resulting correlation function G () is shown in Figure [4] for the cases:

The dimensionless parameters in the three cases are = 2 and $h^2 = (M l^2_{0}) = 0.05$. The units are such that M = 1 and l = 1. The macroscopic friction coe – cient, = $=l^2$ is the same in the three cases. It is clear that the spatial dependence of the retarded interaction induces signi cant di erences in the long time dynam – ics of the particle, although look the same at su ciently high tem peratures, where the mass, and the macroscopic friction coe cient are the only relevant parameters.

For the C aldeira-Leggett m odel, G () increases logarithm ically at long times. The e ects of the three dimensional dirty electron gas can be described in terms of an e ective m ass, which, for the parameters used here, is about two orders of m agnitude larger than the bare m ass. The two dimensional dirty electron gas is a m arginal case, and the numerical results, like those shown in Fig.[6], suggest that G () / , with 0 < < 1, and / 1 g¹, where g is the conductance.

The e ective mass, when the environment is described by the dirty three dimensional liquid, as function of the strength coupling, is shown in Fig.5]. The numerical results support the exponential dependence on discussed in the preceding subsection.




FIG. 4: Time dependence of the propagator G (), for $h^2 = (M \ l^2) = 1, l = 1$ and = 2 for the three cases described in eq.(31).




FIG.5: Dots: E ective mass of a particle interacting with a dirty three dimensional electron liquid, as function of the strength of the interaction, . The fullline is a to a function of the type M =M $_{\rm eff}$ = (c_1 + c_2)e c_3 .

V. RESULTS.LOCALIZED SOLUTIONS

A. Local attractive potential.

An external potential, V, acting on the particle can be described, using the path integral form ulation, by adding




FIG. 6: Log-log plots of G () vs. for an action which describes a two dimensional dirty electron liquid, eq.(7). From top to bottom : = 1;2;4;6.

a term to the action in eq.(4):

This term leads to new nonlinear e ects. We can extend the large-N or variational scheme described earlier by using the approximate action:

where is a variational parameter. This ansatz, in the absence of dissipation, is equivalent to the use of a variational set of gaussian wavefunctions in order to probe the existence of bound states of the potential V (%). It is well known that this method can be used to study the existence of localized solutions for arbitrarily small potentials in one dimension, while a threshold is required for the existence of a bound state in three dimensions.

We now analyze the full action, given by eqs.(4) and (32) using the variational ansatz given by eqs.(15) and (33). We will focus on the possible existence of localized solutions, characterized by a nite value of , in the limit of a very weak potential V (X). Then, $l^2 = (M l^2)$, and the Fourier transform of G () is:

where $_{=0}(!)$ is the self energy calculated when = 0. We now write the external potential as V (X) = V (u), where $u = \frac{1}{3} x^2$. The self consistency equation for is:

The expectation value in the rhs. of this equation is to be calculated using the variational action, eqs. (15) and (33). This calculation is similar to that perform ed in eq.(18). We are interested in the limit when $G_1 = l^2$. Then, for localized potentials:

The value = = can be interpreted as a gap in the spectrum of the excitations of the particle.

If the dynamics of the particle $q can be described in term s of an elective mass, <math>G_1 / h^2 = (M_{eff})$. Then, eqs.(35) and (36), lead to:

This equation has solutions for arbitrarily weak potentials only if N = 1, that is, if the particle moves in one dimension, in agreement with standard quantum mechanics.

B. Closed orbits.

W e can use the previous method to analyze the motion of the particle when it moves around closed circular loops. W hen the loop is threaded by a magnetic ux, this geometry can be used to analyze quantum interference e ects [14, 26]. The trajectory of the particle can be described in terms of an angle, and $\frac{1}{3}$ () j = R, where R is the radius of the orbit. The action in eq.(4) describes a one dimensional non linear sigm a model with long range interactions. The case when only quadratic terms are kept in the expansion in eq.(8) has been extensively discussed in the literature [27, 28]. The large-N extension of this model can be analyzed using standard techniques [29, 30]. The constraint can be incorporated by means of a Lagrange multiplier, (), whose uctuations can be neglected in the large-N limit. This term in the action is given by eq. (33), and we can apply a similar scheme to that discussed in the previous subsection. The value of R^2 gives the new energy scale which describes the dynam ics of the particle around a closed loop. A lternatively, R^2 can be interpreted as an inverse correlation




FIG.7: First order transition obtained for $_0 = (h^2 = M l^2) = 1$. The parameters are M = 1 and l = 1, and $f(u) = e^{u}$ in eq.(5). Full curve: = 6. Dotted curve, = 8. Broken curve: = 10.




FIG.8: Sketch of the transition discussed in the text.

tim e[29]. This approach describes well the phase transition of the model when the retarded interaction decays as $^{2+}$ [29, 30].

The dynam ics of the particle, using the full action eq.(8), is determined by G_1 , for R l. The value of is given by the solution of:

For the Caldeira-Leggett model, this equation leads to $/ e^{(R^2)=h}$, as R=l ! 1, in agreement with previous calculations[26, 31]. If the motion of the particle can be described in terms of an electrive mass, $R^2 = h^2 = (M_{eff}R^2)$, also in agreement with earlier work[26].

C. First order phase transition.

The results discussed in the previous subsections are valid if the high energy cuto of the bath, $_0$, is much larger than the energy scale $h^2 = (M \ l^2)$. When these scales become comparable, we nd a rst order phase transition, as function of or R between two regimes:

i) The particle moves away from the region $x \le 1$ at times shorter than 0^{-1} , and, for longer times, it di uses like a free particle.

ii) The particle is trapped inside the region $\Re j < 1$ for all times.

This transition is analogous to that described recently in the two dimensional non linear sigma model[32, 33, 34]. The transition takes place between two disordered phases, and it does not violate the M erm in-W agner theorem, which can also be form ulated for the model studied here. The phase diagram is sketched in Fig.[8]. There is a line of rst order transitions, which ends at a critical point. The discontinuity at the phase transition increases as the minimum in the function F(X) becomes deeper and m ore localized around X = 0.

The existence of a critical point, shown in Fig.[8], in – plies the existence of physical quantities with anom abus decay in the time dom ain. Following the results in [33], we conjecture that the energy-energy correlations will show power law correlations in time [35].

VI. COMPARISON W ITH PERTURBATION THEORY

It is instructive to compare the results presented in the previous sections with a perturbative calculation, which is the scheme most widely used when studying dephasing [4, 5, 10]. We consider a particle in free space. The unperturbed states are plane waves, characterized by a momentum k, and an energy $_{k} = \frac{3}{2} \frac{1}{2} = M$. The inverse lifetime of this state, when the coupling to the environm ent is described by the action in eq.(4), is:

in eq.(4). The two terms in the r.h.s. of eq.(40) describe the emission and absorption of quanta by the environment.

For the case of a dirty electron gas studied earlier, $1 = (\dot{q}_1 \dot{f} D)$, where is the density of states, F (q) and D is the diusion coe cient [26]. The integral in eq.(40) is convergent, except in one dim ension. W e can de ne selfconsistently a dephasing lifetim e[4, 5, 10] w here contributions from low energy transitions are suppressed. Then, when 💡 T,we nd:

q. where $l_{\rm T} = h^2 = (M \ {\rm T})$. There are logarithm ic corrections for D = 1, which arise from the divergence in the integral in eq.(40).

W e can also calculate the real part of the self energy, which, at zero tem perature, is:

Quantities associated to the derivatives of the real part of the self energy, like the e ective m ass renorm alization and the quasiparticle residue:

are divergent as $\tilde{k} ! 0$, for D = 1,2.

Eq.(41) suggests that quantum e ects are still im portant at zero tem perature. This interpretation, how ever, is not consistent with the non perturbative results for D = 1;2 (see subsections IVD and IVE). In both cases, we nd that G () increases more slow ly than , so that the energy scale for the A haronov-B ohm oscillations in a closed orbit acquire an anom alous R dependence (see IVB). We can infer an e ective \dephasing time", from the scale at which G () reaches its asymptotic unconventional behavior. In both cases, this scale / $(h^2 = M l^2)^{-1}$, where l is the mean free path in the environment. The unperturbed case is recovered when 1! 1.

The Caldeira-Leggett model leads to F (q) ⁰⁰(q), and, for $_{K}$ T, $\lim_{T \to 0} _{K}$ (T) $\frac{h}{M}$. This result is consistent with the non perturbative, analysis of the model, which suggests that quantum e ects are strongly suppressed, even at zero tem perature.

VII. CONCLUSIONS

W e have analyzed the low energy properties of a quantum particle interacting with dissipative environments, characterized by an ohm ic response. By means of a large-N, or variational approxim ation, and num erical calculations, we have estimated time correlations which characterize the dynam ics of the particle. Our method allows us to treat both the weak coupling lim it, and the Caldeira-Leggett m odel, where the coupling to the environm ent strongly suppresses the quantum properties of the particle. The retarded interactions induced by the coupling to the environm ent are described by a function, $F \neq (1) \neq (1)^2$, which depends on the type of environm ent, eq.(4). For a particle propagating freely, we characterize the dynam ics of the particle by the correla-h⁰) = $X() X(^0)$ tion function G (

We nd that ohm ic environments can be divided into two broad classes (even if they all give rise to the same m acroscopic dissipative equations of m otion):

i) If $\lim_{u \ge 1} F^0(u)$ decays faster than u^{-1} , the behavior of the particle can be described in terms of an elective mass, M $_{eff}$. At long times, G () / M $_{eff}$. We have estimated the renormalization of the bare mass, which depends exponentially on the coupling. Environments with these features are the clean and dirty three dim ensional electron liquids, and the short range kernel where $F(u) / 1 e^{u=1}$.

ii) If $\lim_{u \le 1} F^0(u)$ decays more slow ly that u^{-1} , the e ective mass of the particle becom es in nite at zero tem perature. At long times, G() / log(). This is the behavior of the Caldeira-Leggett m odel (=1), and the one dimensional dirty electron gas (= 1=2).

The two dimensional dirty electron gas is an intermediate case. Our results are consistent with a power law dependence, G() / , with 0 < < 1, and / 1 g 1 , where g is the conductance.

W e have also considered the properties of a particle in an external potential, or moving around a closed ring. We nd di erent qualitative behavior corresponding to the same two cases discused above:

i) If $\lim_{u \ge 1} F^{0}(u)$ decays faster than u^{-1} , a localized potential must exceed a threshold strength before localized solutions are possible. The energy scale which characterize the quantum properties of the particle is $h^2 = (M_{eff} R^2)$, for R l, where l is a length scale which describes the range of the uctuations in the environment. A model characterized by a function F which uctuates between zero and a nite value as u ! 1 can be included in this class[28].

ii) If $\lim_{u \ge 1} F^0(u)$ decays more slow ly that u^{-1} , a localized solution exists for arbitrarily weak con ning potentials. The characteristic energy scale which de nes the quantum properties around a ring decays, for R l, as $e^{c(R=1)^2}$, where c and are constants.

In some cases, there is a rst order phase transition,

as function of the strength of the potential, or the size of the orbit, between a weakly and a strongly localized solution.

Sum m arizing, we nd that di erent ohm ic environm ents can in uence the quantum properties of an external particle in di erent ways: couplings with long range spatial interactions, such as in the C aldeira-Leggett m odel, strongly suppress quantum e ects, while the effects of less singular couplings can be qualitatively understood within perturbation theory.
