Equilibrium Correlation Functions of the Spin-Boson M odel with Sub-Ohm ic Bath

The spin-boson model is studied by means of ow equations for Ham iltonians. Our truncation scheme includes all coupling terms which are linear in the bosonic operators. Starting with the canonical generator $_{\rm c} = [{\rm H}_0; {\rm H}]$ with H $_0$ resembling the non-interacting bosonic bath, the ow equations exhibit a universal attractor for the Ham iltonian ow. This allows to calculate equilibrium correlation functions for super-Ohm ic, Ohm ic and sub-Ohm ic baths within a uniform fram ework including nite bias.

The spin-boson model, consisting of a spin-1/2-system coupled to a bath of non-interacting harm onic oscillators, is the simplest non-trivial model that captures the essential in uence of dissipation on a quantum mechanical system [1, 2]. The physical behavior of the system is determined by the low-energy modes of the bosonic bath. M odeling the interaction such that one recovers the classical phenom enological equation of motion with a frictional force proportional to the velocity, one speaks of 0 hm ic dissipation. At zero tem perature the system then undergoes a continuous transition from delocalization to localization at a critical interaction strength. If the low-energy modes are suppressed or enhanced relative to the 0 hm ic bath one speaks of super-0 hm ic or sub-0 hm ic dissipation. For super-0 hm ic dissipation, the e ect of the bath on the system is generally that of renormalizing the system parameters. For sub-Ohm ic baths, the system has the tendency to localize.

Physical systems mostly exhibit super-Ohmic or Ohmic dissipation. Obvious realizations for sub-Ohmic baths are not known and the only known results are valid for high-tem peratures and small time scales [2]. They are e.g obtained using M onte C arb simulations [3]. The lack of results for long time scales at zero tem perature is mainly due to technical di culties since the sub-Ohmic coupling represents a relevant perturbation in the language of the renorm alization group [4].

W ith the upcoming interest in quantum computing based on solid state qubits, investigations on di erent types of dissipative system s have emerged [5, 6, 7] and there are e.g. suggestions to model 1=f noise found in recent experiments [8] by a limiting sub-0 hm ic bath [9]. The widespread believe that there is total suppression of quantum tunneling at zero temperature for any sub-0 hm ic bath independent of the coupling strength would pose a serious problem to quantum computing within a solid-state matrix due to 1=f noise. But results based on the ow equation approach [10] and on exact mathematical techniques [11] indicate that there is a rst orderphase-transition from delocalization to localization at some nite coupling constant. To our know ledge, spectral properties which are valid on all energy scales have not been presented yet.

In this letter, we will investigate the spin-boson m odel by means of ow equations [12] since this approach is not con ned to any particular bath type. We are thus able to treat all environments on the same footing. O ne crucial di erence to prior works on the m ethod applied to the spin-boson m odel [13] is, that we allow all coupling terms which are linear in the bosonic bath operators to be generated. Furtherm ore, we set up ow equations that exhibit universal asymptotic behavior which assures a system atic decoupled last. In view of the manipulation of qubits, we also treat the spin-boson m odel with nite bias. This gives rise to distinguished bosonic m odes and it will also be necessary to vary the unitary representation of the initial H am iltonian.

W e start our discussion with the re ection-symmetric modelwhere the initial H am iltonian is given by

$$H = \frac{1}{2} z + ! b^{y}b + x \frac{x}{2}(b + b^{y}) :$$

Notice that sum mation over the bath modes is implied throughout this work. The objective is to evaluate the equilibrium correlation function C (t) = hf $_x$ (t); $_x$ gi=2.

The scale of the isolated system shall be given by $_0 = (1 = 0)$. The coupling constants x are as usual param etrized in terms of the spectral coupling function J(!) $(x)^2$ (! !) = 2 K^{1 s}!^sf(!=!_c) with the coupling strength , the bath cuto !_c and the cuto function f(x). The di erent bath types are characterized by s, where s = 1 stands for 0 hm ic baths and s > 1 and s < 1 for super- and sub-0 hm ic baths, respectively. N on-0 hm ic baths also give rise to an additional energy scale K .

The Ham iltonian is now subjected to a series of innitesim altransform ations which can be written in di erential form as @.H = [;H], `denoting the ow parameter and resembling the square of the inverse energy scale which is being decoupled [12]. The anti-Herm itian generator is rst chosen to be canonical, i.e. $_{c} = [H_{0};H]$ [12], with H₀ = ! b^yb. This leads to the trivial xed point H am iltonian H (' = 1) = H₀. But _c generates a new coupling term which is linear in the bosonic operators and given by H_{new} = i $_{y}\frac{y}{2}$ (b b). This term is included in the ow of the H am iltonian and also contributes to the canonical generator.

M oreover, the commutator [c;H] contains coupling term swhich are bilinear in the bosonic operators. These term s are not included in the H am iltonian ow explicitly, but we truncate the Ham iltonian after coupling terms linear in the bosonic operators. Yet, we consider bilinear coupling term s adequately by introducing a new term to the generator. Doing so, we are guided by the exact solution of the dissipative harm onic oscillator via ow equations [13]. The additional term of the generator is given by $n_{ew} = ; o(b + b^{y})(b \circ b^{y}), where the pa$ ram eters ; • are to be chosen such that the bilinear term s are not being generated. This cancellation cannot be done exactly, but we will neglect operators which are norm all ordered with respect to the ground-state of the one-particle H am iltonian H $p = \frac{1}{2} z$ and the bath H am iltonian H $_0$, respectively. The parameters $; \circ$ for \Leftrightarrow are then given by (; = 0)

The renorm alization of the bath modes ! vanishes in the therm odynam ic lim it and will be neglected. For the tunnel-matrix element we obtain the ow equation $\emptyset_{\gamma} = 2! \times y$. The ow of the coupling constants is described by the following non-linear di erential equations:

In order to calculate correlation functions the observable has to be subjected to the sam e sequence of in nitesimal transform ations as the H am iltonian. The truncated ow of the observable shallbe given by $_x$ (') = h^x (') $_x + _z ^z$ (') (b + b^y). The ow equations $@`_x = [; _x]$ are closed according to the sam e norm all ordering scheme as above and thus read




FIG. 1: The spectral function C(!) for $J(!) = 2 K^{1 s} !^{s} !^{s} (!_{c} !)$ with $= 0:1, !_{c} = 0 = 10, K = 0 = 1$, and = 0 for various bath type s.

Characteristic for dissipative system s is that the oneparticle parameter h^x ! 0 for '! 1, i.e. the spectral weight of the system dissipates into the bath [13]. The correlation function C (t) = $\binom{N_1}{0}$ d! e^{i! t}C (!) is then determined by the spectral function C (!) = (^z (' = 1))² (! !) which is obtained by numerical integration of the ow equations. In Fig. 1, C (!) is shown for various bath type s. The parameters of the spectral coupling function J (!) are chosen as = 0:1, !_c = 0 = 10, K = 0 = 1. The spectral functions yield the correct low – energy behavior C (!) / !^s for != 0 1 which clearly

shows the non-perturbative nature of our approach. We will come back to this point later.

For the numerical in plan entation of the ow equations, we amployed a linear energy spacing, which allows for an easy evaluation of the principal value integral arising from $; \circ$ of Eq. (1), and the sharp cuto function $f(x) = (1 \quad x)$. The results for low energies do not depend on the speci c choice of f(x) nor on the energy discretization. For larger ! c a logarithm ic energy spacing is needed which yields equivalent results.




FIG. 2: The spectral function S(!) for $J(!) = 2 K^{1 s} !^{s} !^{s} (!_{c} !)$ with $!_{c} = 0 = 10$, K = 0 = 1, = 0, Ohm ic bath s = 1 (left hand side) and sub-Ohm ic bath s = 0.8 (right hand side) for various coupling strength .

In Fig. 2, the norm alized spectral function S (!) / C (!)=!^s is shown for various coupling strength where ! = denotes the maximum of C (!), i.e.

 $_{0}(_{0}=!_{c})^{=(1)}$ for 0 hm ic baths. The parameters of J(!) are chosen as $!_{c}=_{0}=10$, K = $_{0}=1$, s = 1 (left hand side) and s = 0.8 (right hand side), respectively. The transition from coherent to incoherent tunneling occurs at the coupling strength where the resonance at ! = disappears. We obtain > 0.4 for an 0 hm ic bath and 0.3 for a sub-0 hm ic bath with s = 0.8.

O ur truncation scheme is valid for small and intermediate coupling strengths $^{<}$ 0.4, and for O hm ic baths our approach yields results sim ilar to those obtained by C osti and K ie er by means of the numerical renormalization group (NRG) [14]. But since NRG is based on the mapping of the spin-boson model onto the anisotropic K ondo model it cannot be used for sub-O hm ic baths.

W e will discuss our approach in more detail, now. W e have chosen the diagonal H am iltonian to be $H_0 =$! b^yb. This choice indicates that (`) ! 0 as `! 1, i.e. the xed point H am iltonian is scale-independent and thus universal. W ith no asymptotic scale present, the ow equations will system atically rst decouple highenergy modes and nally low-energy modes. This decoupling procedure is passed on to the observable ow,

i.e. the spectral function C (!) is rst determ ined at high energies and the trivial low-frequency behavior of the system is calculated at last. Moreover, the spectral function around the resonance ! is determ ined by the stable ow of interm ediate ' ()², away from the asymptotic regime of decoupling quasi-degenerate states. A nother advantage of letting the tunnel-matrix element renorm alize to zero is that the xed point H am iltonian H₀ possesses the correct spectrum, consisting of a non-degenerate ground-state and a gapless continuum.

The ow equations can num erically be integrated only up to ' $(!)^2$ with ! denoting the linear energy spacing. Determ ining the asymptotic behavior will thus specify the spectral function C (!) in the low – energy regime which is not accessible by num erical integration. A rst approximation for the asymptotic ow is given by ^x ^y, which is consistent with (2). Introducing the '-dependent spectral coupling function J (!; ') $({}^{y}$ ('))² (! !), the asymptotic ow equations are solved by the ansatz (') ! a' ¹⁼² and J (!; ') ! '¹⁼² J (! '). This leads to the following nonlocal di erential equation for J (y) with y ! ':

where t = 1 $4_0^{\kappa_1} dy^0 J(y^0)$ and the boundary condition $a = 4_0^{\kappa_1} dyy J(y)$.

The asymptotic behavior of the observable ow is described by a similar ansatz, i.e. $h^{x}(`) ! b^{\cdot 1=4} s^{0}=4$ and S(!;`) $y(`)^{z}(`) (! !)! \cdot^{1=4} s^{0}=4$ S(!``). The non-local di erential equation for S(y) is similar to the one for J(y) [16]. De ning the '-dependent spectral function C(!;`) (^z(`))² (! !), we obtain for ' being in the asymptotic regime C(!) C(!;`) = ! $^{s^{0}}$ I(y)

with

For an initial spectral coupling function $J(!) / !^{s}$, the num erical analysis yields s s° independent of the coupling strength. The asymptotic scale-invariant ow thus induces the correct long-time behavior of the correlation function C (!).

There are two criteria for the assessm ent of the quality of the results. One $_{R_1}^{is}$ the norm alization of the spectral function C (!), i.e. $_0$ d!C (!) = 1. The second is the Shiba relation $\lim_{!! 0} C$ (!)=! $s = 2 K^{1} s {R_1 \atop 0} C$ (!)=! [15]. The numerical results show that the spectral sum rule is fulled within less than 0.1 s relative error. The interpretation of the Shiba relation is not as obvious. From (3) we form ally obtain $\lim_{!} \frac{R_1^0}{Y} C$ (!)=! s = 1 (0), which is not de ned since the term $_{y}^{-1} dyS (y)=y^{1+s^0} diverges for y ! 0. But this is not the correct result because the proper order how to perform the limites is rst `! 1 and then !! 0. The fact that the asymptotic and the therm odynamic limit do, in general, not commute is well-known [12, 13].$

Perform ing the lim its correctly, the left and right hand side of the Shiba relation can be determ ined. This yields satisfactory results with relative errors of around 10% for < 0.2 and > 0.8. For larger and lowers the relation still holds with a maximal relative error of around 30%. A pproximation schemes like N IBA or numericalmethods based on M onte C arb cannot be used to verify the Shiba relation since they fail to predict the correct long-time behavior. Results from NRG [14] for the O hm ic bath have a maximal relative error of around 10%.

A pplying an external bias, the H am iltonian ow as well as the operator ow is not con ned to one or two basic interaction terms anymore. In this case, we allow all coupling terms which are linear in the bosonic operators with real coe cients to be generated. The full truncated H am iltonian thus reads

$$H = \frac{1}{2}x + \frac{1}{2}z + \frac{1}{2}b^{y}b + \frac{1}{2}x + \frac{y}{2}p ;$$

with x $(b + b^y)$ and p i(b b^y). Notice that summation over j = e;x;z with e 1 is implied from now on.

In the above representation, the considered equilibrium correlation function is de ned by C (t) = hf $_z$ (t); $_z$ gi=2. The extended truncated observable ow is thus given by

$$_{z}(') = h^{j}(')_{j} + j^{j}(')x_{y}^{y}(')p$$
;

where e(') = 0 for all '. It is important that the constant term h^e is generated which indicates re ectionsymmetry breaking, i.e. $h_z i = h^e ('=1)$ h^e. Hence,




FIG. 3: The spectral function C(!) for $J(!) = 2 K^{1 s} !^{s} !^{s} (!_{c} !)$ with $= 0:1, !_{c} = 0 = 10, K = 0 = 1$, and sub-O hm ic bath s = 0:3 for various bias . At ! = 0 there are -peaks with weight $(h^{e})^{2}$ (Indent).

it contributes to the spectral function C (!) via a function at ! = 0 with weight $(h^e)^2$.

In principle, each unitary equivalent initial H am iltonian would yield the same physical result. M atters change as soon as approximations are involved since the neglected terms become dierently important depending on the representation of the initial H am iltonian. Investigating the system with nite bias we thus introduce another parameter which indicates an initial shift of the bosonic operators, i.e. b $\frac{1}{2!}$. We choose

such that the sum rule h_z^2 (')i = 1 is fulled best for all '. We also diagonalize the initial Ham iltonian with respect to the two-dimensional Hilbert space before we apply the ow equations.

To set up the ow equations for the extended m odel, we proceed in the same way as in the case of the symmetric one. Only, the norm all ordering procedure now has to be de ned with respect to distinguished, '-dependent m odes b + =2 with

where the one-particle expectation values are evaluated with respect to the elective one-particle H am iltonian $H^{p} = \frac{1}{2} x + \frac{1}{2} x \text{ with } 0 = + e^{-x} = ! y^{-x} = !$ and $0 = e^{-x} = ! x^{-y} = !$. The distinguished modes are derived by quadratic completion and suitable factorization, see Ref. [17] for details and extensions.

In Fig. 3, the spectral function C (!) for initial coupling J (!) with = 0.1, $!_c = _0 = 10$, $K = _0 = 1$, and sub-0 hm ic bath s = 0.8 is shown for various bias . The initial shift of the bosonic operators is taken to be $= _0$. This yields a spontaneous breaking of the reection symmetry which is favorable for the system ow as well as for the observable ow. In the indent, the expectation value h $_z i = h^e$ is shown. Similar results are obtained for super-0 hm ic and 0 hm ic baths.

In sum mary, we have established a ow equation scheme which yields reliable results for a large regime of the parameter space of the spin-boson model with essentially new results for sub-0 hm ic baths and nite bias. Moreover, we are not con ned to speci c cuto functions which might be crucial in view of environments based on a structured bath [18].
