# The Eigenvalue Analysis of the Density Matrix of 4D Spin Glasses Supports Replica Symmetry Breaking

W e present a general and powerful num erical method useful to study the density matrix of spin models. We apply the method to nite dimensional spin glasses, and we analyze in detail the four dimensional E dwards-Anderson model with G aussian quenched random couplings. Our results clearly support the existence of replica symmetry breaking in the therm odynamical limit.

### I. IN TRODUCTION

Replica Symmetry Breaking (RSB)<sup>1</sup> was introduced more than twenty years ago<sup>2</sup> as a crucial tool to describe the low temperature phase of spin glasses<sup>3</sup>. One can see replicas as an extension of Statistical M echanics that can be very useful when studying com plex systems, such as structural glasses<sup>4</sup> or spin glasses<sup>3</sup>, where the ergodicity breaking in the low temperature phase cannot be described with the help of an in nitesim al external constant m agnetic eld.

If on one side there is little doubt<sup>5</sup> left about the correctness of the RSB description of the low temperature phase of the mean eld models, on the other side the controversy<sup>6,7,8,9</sup> regarding its applicability to nite dimensional system s such as realistic, physical spin glasses, is alive and in good health.

Unfortunately, we are only starting to guess how to address the question of the existence of RSB in real spin glasses from a truly experimental point of view<sup>10</sup>: because of that, and because of the inherent very high com plexity of the relevant analytic com putations, most of the recent progresses are coming from numerical simulations.

The output data of numerical simulations are never as reliable as analytic (and, even better, rigorous) results. So if on one side the results of numerical simulations of four dimensional spin glasses<sup>8,11</sup> support the RSB scenario (as indeed happens for the three dimensionalm odel<sup>8</sup>) on the other side one can argue that these indications could turn out to be fallacious on larger lattices, on longer time scales, at lower temperatures... (see for example 12 for a typical criticism to typical numerical simulations).

It is clear that new approaches to this important issue are precious: Sinova, Canright, Castillo and MacDonald<sup>13</sup> have recently proposed such a new tool, that can allow a better study of spin glasses. They have noticed that the spin-spin correlation matrix h<sub>i</sub> ji (that we will discuss in better detail in the next section) shares the main properties of a quantum mechanical density matrix<sup>14</sup>: it enjoys positivity, herm iticity and has unit trace (notice that our normalization di ers from theirs, see reversal sym m etry is broken, and thus one should expect at least one non vanishing eigenvalue of the density m atrix in the therm odynam ical lim it, due to the extended character of the eigenvector related with the sym m etry breaking<sup>14</sup>. W hat is new is the claim <sup>13</sup> that the presence of RSB is equivalent to the existence of m ore than one non vanishing eigenvalues in the therm odynam ic lim it. Thus arm ed the authors of 13 undertook the study of the Edwards-Anderson m odel with G aussian couplings in four dimensions, were they found results that they judged inconsistent with the detection of RSB on lattices of linear size up to 6 (i.e. of volum e up to 6<sup>4</sup>).

The e orts of 13 were limited to such small lattice sizes, because the memory and the numerical e ort required in their approach grows as  $L^{2D}$  (in the following L will be the lattice linear dimension, and D the space dimensionality). It is clear that their simulation strategy and data analysis can sometimes go wrong, as it is evidenced by its failure<sup>15</sup> in the analysis of the R andom Field Ising model. In that case, only turning to the standard numerical strategy<sup>8</sup>, that focuses on the Parisi order parameter function, P (q), they could establish<sup>15</sup> the (plausible) absence of RSB in this model.

Here we present a num erical strategy for the study of the density matrix of spin glass with a cost of the order  $L^D$ . We propose a more convenient data analysis, given the expected behavior of the density of eigenvalues of the density matrix in the therm odynamic limit (see next section and reference 16). In this way we have been able to study the E dwards-Anderson model with G aussian couplings on lattices of volum e up to 8<sup>4</sup>, at the sam e tem peratures as in 13. We obtain results that support an R SB scenario<sup>8</sup>. Very interesting information about the density matrix in a R SB scenario can also be obtained through mean eld calculations<sup>16</sup>. Moreover the num ericalapproach that we have developed here can be applied to any spin model.

W hen completing this manuscript, a note reporting another e cient approach to the density matrix spectral problem has appeared<sup>17</sup>. In this work Hukushim a and Iba dealwith the four dimensional spin glass model with binary (rather than Gaussian like in our case) cou $10^4$ , reaching the same conclusion that we present here, i.e. arguing for the presence of RSB in the in nite volume limit (they also discuss an interesting method for studying tem perature chaos).

The layout of the rest of this paper is as follows. In section II we de ne the model and the associated density matrix, discussing its basic properties and the num erical approach of 13. Our own strategy is presented in subsection IIA, and a working example is analyzed in subsection IIB, where the (replica symmetric) ferrom agnetic Ising model in four dimensions is analyzed. Our num erical simulations of the Edwards-Anderson model in 4 dimensions are described in section III. Our results are presented and discussed in section IV. Finally, we present our conclusions in section V.

### II. THE MODEL AND ITS DENSITY MATRIX

We consider the four dimensional Edwards-Anderson spin glass in a periodic box of side L. The N elementary spins can take binary values, i = 1, and they are dened on the vertices of a single hyper-cubic lattice of size  $V = L^{D}$ . We consider a rst neighbor interaction:

The quenched couplings,  $J_{ijj} = J_{jji}$ , are drawn from a symmetric probability distribution function of zero average and variance  $J^2$ . It is custom any to take J as unit of tem perature, and then to set J = 1: this is what we do. Two popular choices are the one of a binary probability distribution  $J_{ijj} = 1$  or to take J G aussian distributed. Here, we draw the quenched random couplings from a G aussian distribution (also in order to allow a direct comparison with the work of 13). For all the relevant observables one rst compute the therm all average on a single realization of the couplings (sam ple), hereafter denoted by h:::, and later the average with respect to the couplings is perform ed (we denote this disorder average by an over-line). The model (1) undergoes a spin glass transition<sup>18</sup> at  $T_c = 1.80$  0.01.

The average over the couplings  $J_{i;j}$  induces a (trivial) gauge invariance<sup>19</sup> in the model. If one chooses a generic binary value for each lattice site, i = 1, disorder averaged quantities are invariant under the transform ation

Now let  $_{i}$  be a random num ber that takes the probability  $\frac{1}{2}$  the values 1. If one considers the spin-spin correlation function, the sym m etry (3) yields the disappointing result that

(that is true since this relation is valid for every value of

attention to this quantity. Reference 13 w isely suggested to bok at the correlation function of a single sample as a matrix,  $c_{i,j}$ . We dene here  $c_{i,j}$  as

(notice the di erence in the factor L <sup>D</sup> with the definition of references 13,15). The gauge transformation (3) acts on the matrix  $c_{i;j}$  as an unitary transformation. Therefore, contrary to the individual elements of  $c_{i;j}$  itself, the spectrum of  $c_{i;j}$  does not become trivial after the disorder average. It is easy to check<sup>13</sup> that  $c_{i;j}$  is symmetric, positive de nite, and has trace equal to one, just like a quantum mechanical density matrix. Thus the corresponding eigenvalues, 1 1 2 :::: N 0; verify

Following 14 the authors of 13 have argued that in the param agnetic phase all the k are of order  $\frac{1}{N}$ , and thus vanish in the therm odynam ical lim it. On the other hand in the spin glass phase time reversal symmetry is broken, which implies some non local ordering pattern for the spins (unfortunately only known by the spins them selves), and hence at least one eigenvalue, 1 should remain of order one when N ! 1 . They also claim ed that presence of RSB is equivalent to more than one eigenvalue being of order O (N  $^{0}$ ) when N ! 1 . Furtherm ore they stated that each non vanishing eigenvalue corresponds to a pair of pure states: the correspondence to a pair of pure states is because of the global 1 symmetry of the Ham iltonian (1) and of the matrix ci; Notice that this might be a clue for the solution of the form idable problem of de ning pure states in a nite volum e system 7,8. The fact that the presence of more than one extensive eigenvalue (of order  $O(N^0)$ ) when N ! 1 is equivalent to RSB is true in the mean eld picture, as can be veried in a mean eld analytic computation at the rst step ofRSB<sup>16</sup>.

C om bining perturbation theory and droplets ideas it was also possible to tell<sup>13</sup> that in a non RSB scenario the second eigenvalue should not decay slower than

where the droplet exponent in four dimensions is<sup>20</sup> =  $0.6(0.3. \text{ A ctually when the lattice size is larger than the correlation length (which m ight not be the case in the achievable numerical simulations<sup>12</sup>), they expect a much faster decay.$ 

U sing the parallel tem pering optim ized M onte C arlo schem  $e^{21}$ , the authors of 13 calculated the m atrix  $c_{i;j}$ , (a computational task of the order  $L^{2D}$ , since the lack of translational invariance prevents the use of the Fast Fourier transform). They eventually diagonalized the m atrix. W hen comparing results for di event disorder

 $_{\rm k}$ , that they tried to characterize by their m ean and typical value. They found that the m ean and the typical value of the second eigenvalue were decreasing as a function of lattice size in a double logarithm ic plot for lattices up to  $6^4$  (see gure 7 of the second of references 13). Because of that they argued about the absence of RSB in the model.

# A. An E ective Approach to the Study of the Density M atrix

Studying the spin-spin correlation function  $c_{i;j}$  by analyzing the usual density of states  $g_u$

would not work: because of the constraint (6) in the N ! 1 limit  $g_u$  () is a normalized distribution function with support in the [0;1] interval with mean value 0. In other words, this de nition implies that in presence of a generic nite number of extensive eigenvalues for large volumes  $g_u$  () = (), which does not contain much information.

In our case we cannot weight all the eigenvalues with the same weight: to consider a sensible indicator we can decide to use as weight  $_k$  itself, and to de ne the modi ed density of states of the matrix  $c_{i_{ij}}$ :

It is natural to expect g() to converge in the N ! 1 lim it to a function containing a continuous part, plus a delta function at = 0 (because a num ber of order O (N) of eigenvalues will be of order O (N<sup>-1</sup>)). A calculation at one step of RSB<sup>16</sup> tells us that this is indeed the case. Moreover in the one step calculation the continuous part do not show any gap, and it covers all the interval between = 0 and =  $q_{EA}$ , the E dwards-Anderson order parameter (see also gure 1 of the second of reference 13). Therefore, from the point of view of checking Replica Symmetry B reaking, to concentrate on the behavior of individual eigenvalues does not book the best strategy. Instead, as it is custom ary when analyzing density of states<sup>22</sup>, one can start by considering the moments for a single disorder realization,  $g_J$  ():

O urm ain observation is that we can compute the trace of the r-th power of the matrix c, using r real replicas (independent system s, with the same realizations of quenched replicas  $a_1$  and  $a_j$ :

Then it is easy to show that

Thus, for instance, the (disconnected) spin glass susceptibility is  $_{SG} = N \ Trc^2$ . In this language the relationship between non vanishing eigenvalues and the phase transition from the paramagnetic to the spin glass phase is very direct.

It is now very easy to suggest a num erical strategy of order  $L^D$ : make the M onte C arb simulation in parallel for a discrete number of replicas, and use them to calculate the appropriate number of m on ents of  $g_J$  (). Then use this information to extract the largest eigenvalues of the matrix c. Unfortunately standard methods for extracting the probability density from its moments<sup>22</sup> use orthogonal polynom ials. C learly, given the limited numerical accuracy that we can expect to obtain for the Trc<sup>r</sup>, the use of orthogonality methods is out of the question. We have instead used a cruder method. We de ne a cost function

and m inim ize it, using the values of the  $_{\rm k}$  at the m inim um as an approximation to the eigenvalues. This m ethod can be checked on small lattices, using the direct computation of c and its eigenvalues. It turns out (see subsection IIB and section IV) that it is extremely precise for the rst eigenvalue, 1, but that already for the second eigenvalue, 2 the systematic error is at the 10% levelusing 12 replicas. Fortunately we can do better than setting 2 2. Let us de ne a (further) m odi ed density of states in which we do not include the rst eigenvalue

where we have denoted by  $_{\rm r}$  the subtracted traces. The right hand side of equation (15) can be accurately calculated using the cost function, and contains all the information that we need.

O ne could still worry about the bias induced by our use of the cost function to obtain  $_1$ . This can be easily controlled, because, since the eigenvalues of the matrix

a situation where we can expect that r is clearly and substantially larger than r+1. On the other hand, if the bias on 1 is , it will a ect r of a quantity of the order of ( $r r^{r}_1$ ). Therefore, a bias dom inated subtracted trace will be characterized by successive moments of g()being very sim ilar (see subsection IIB).

Let us conclude this subsection by discussing the different scenarios that could describe the scaling of the subtracted traces, in the L ! 1 lim it. For a standard replica sym metric model, such as the usual ferrom agnetic Ising model, we expect  $r_{r+1} = O(L \frac{rD}{r+1})$ . In a RSB scenario we expect that for L ! 1  $r_{r+1}$  tends to a nite value (and that nite volume corrections due to the eigenvalues that create the () in g() are of the form O(L rD), while iother nite size corrections due to critical uctuations may not decay so fast). Finally, in a droplet scenario, if one assumes that the subtracted traces are controlled by 2, then equation (7) in plies that

with = 0:6{0.8 in four dimensions (recall that this is an upper bound in the decay of  $_2$ ). The only way out from this scaling behavior in a droplet picture would be to assume that a number of the order L ( > 0) of eigenvalues is of order L : we are not aware of any argum ent<sup>13</sup> that would in ply the existence of a divergent number of critical eigenvalues in a droplet picture.

# B. A Simple Example: the Ferrom agnetic Ising M odel

As a rst check we have studied the ferrom agnetic Ising m odel in four dimensions. Here the H am iltonian has the same form than in (1), but with  $J_{i;j} = 1$ . We have studied the system at  $T = 0.5T_c$ , to prove the deep broken phase with sm all correlation length (the critical tem perature is here<sup>23</sup>  $T_c = 6.68025 - 0.00004$ )). We have simulated in parallel (in this case without parallel tem pering, but with an usual heat-bath updating scheme) twelve replicas of lattices of linear size L = 3;4;6 and 8, for 3  $10^5$  M onte C arlo steps, starting from a fully ordered state.

In this simple case the density matrix  $c_{i;j}$  can be very easily diagonalized. The correlation function  $h_{i j}$  i depends only on the distance between the two spins,  $\mathbf{x}_i \quad \mathbf{x}_j$ , and thus the eigenvectors are proportional to exp [ $\mathbf{x} \quad \mathbf{x}$ ], where the wave-vectors  $\mathbf{\tilde{k}}$  verify the usual quantization rules on a periodic box. It is straightforward to show that the corresponding eigenvalues are

and, given the ferrom agnetic character of the interaction, the largest eigenvalue corresponds to  $\tilde{K}$  = 0 (the m agnetization, M ):




FIG.1: Cost function (13) estimate of the largest eigenvalue of the density matrix, as a function of the number of calculated moments (see equation (15)), for the four dimensional Ising model at T =  $0.5T_c$ , in a L = 4 lattice. The horizontal lines correspond to hM <sup>2</sup> i plus or m inus one standard deviation.




FIG.2: As in gure 1 but for a L = 8 lattice.

In gures 1 and 2 we compare our estimate of  $_1$  for the L = 4 and L = 8 lattices, as obtained from the magnetization (the horizontal band is hM <sup>2</sup> i plus/m inus an standard deviation), and from the cost function (13). As both gures show, 12 replicas are surely enough to obtain agreement within errors, which in this case are particularly sm all.

Having gained con dence in our procedure we can now check evolution of the subtracted traces with increasing lattice size (gures 3 and 4). The two values are very small, decreasing with the lattice size and almost (but not completely) compatible with zero. One should notice that  $_3$  and  $_2$  are compatibles within errors for all lattice sizes (we will see in section IV that in the spin glass case the situation is very di erent): in the ferrom agnetic case the real  $_3$  and  $_2$  are so sm all that they




FIG. 3: The subtracted trace, 2, as a function of the lattice size, for the four dimensional ferrom agnetic Ising model.




FIG.4: As in gure 3 but for 3.

previous subsection. One might ask how come that we were able to resolve such an small bias, given the comparatively large errors reported in gures 1 and 2: this is due to the strong statistical correlations between  $Tr(c^{r})$  and our estimate for  $\frac{r}{1}$ .

# III. THE MONTE CARLO SIMULATION

W e have studied by num erical simulations the four dimensional Edwards-Anderson spin glass with quenched random G aussian couplings (1). We have simulated 12 real replicas in parallel using a heath bath algorithm and P arallel Tem pering<sup>21</sup>, on lattices of volume  $3^4$ ,  $4^4$ ,  $6^4$  and  $8^4$ . The ratio between full lattice heat bath sweeps and parallel tem pering tem perature swap attempt was one to one. For all lattice sizes the largest tem perature was  $T_{m ax} = 2:7$  and the lowest tem perature  $T_{m in} = 0.8$  (see table I for details of the num erical simulation). The prob-

60% level. For each replica we have m easured the perm anence histogram at each tem perature, and we checked its atness. We controlled therm alization by checking that there was no residual tem poral evolution in the B inder cum ulant and in  $Trc^{12}$ .

The main scope of the simulation has been to obtain  $\operatorname{Trc}^r$ , for r = 2; :::;12, using equation (11). There is an aw fully large number of equivalent ways of forming the trace  $q^{a_1/a_2}q^{a_2/a_3}:::q^{a_r/a_1}$  when one may choose the replica labels  $a_i$  out of twelve possible values. One needs to nd a comprom isebetween loosing statistics and wasting too much time in a given disorder realization (the disorder average is the critical factor controlling statistical error). Our comprom ise has been the following: given the special in portance of this observable<sup>8</sup> we have calculated the  $\frac{12(12\ 1)}{2}$  possible overlaps  $q^{a_1/a_2}$ , and we have computed  $\operatorname{Tr}(c^2)$  using all the 66 quantities. For traces of higher order we have considered on ly twelve contributions of the form  $q^{i_ri+1}q^{i+1;i+2}:::q^{i+r;i}$ , for i = 1;2;:::;12 (the sum s are understood modulo 12).




FIG.5: The B inder cum ulant as a function of tem perature, for the 4D E dwards-Anderson m odel on lattices of linear size L = 3, 4, 6 and 8.

In addition to the  $Tr(c^{r})$  we have measured the B inder cum ulant (see gure 5) We have also measured a second adim ensional operator

that we show in gure 6.

The theory of nite size scaling<sup>24</sup> predicts that adim ensional quantities close to criticality are functions of  $L^{1=}$  (T T<sub>c</sub>), where is the therm alcritical exponent (in D = 4 one nds<sup>11</sup> = 1.0 0.01)). The crossing points signals the spin glass transition at T<sub>c</sub> = 1.8 with similar accuracy for both the cum ulants that we have considered. At the lowest tem perature that we have reached the L = 6 and L = 8 lattices seem to be far enough from






FIG.6: As in gure 5, but for the B $_3$  cum ulant.

#### IV. NUMERICAL RESULTS

To compare our results with the ones of 13 we will specialize here to T = 1.0. We start by checking on small lattice sizes (see in gure 7 the L = 4 data) the cost function procedure. In this case the estimate of  $_1$  that one can obtain by using the cost function can be compared directly with the result obtained by diagonalization of c: we nd a fair agreem ent. For larger lattices we can only check the convergence of  $_r$  as a function of the number of m om ents (see gure 8). A gain, the convergence boks fast enough for our purposes. We show in gure 9 the probability distribution of  $_1$ . The low eigenvalues tail is basically lattice size independent.

We show our results for  $_2$  and  $_3$  in gure 10 and gure 11, respectively.  $_2$  is a factor of 10 larger than  $_3$ : our data are not bias dom inated (see subsections IIA and IIB). The fact that the data point for  $_3$  in the L = 8 lattice is above the L = 6 one and at two standard uctuations from compatibility may be due either to a strong uctuation, or to a rst glim pse of bias e ects. If one sticks to the bias hypothesis, the e ect on  $_2$  can be (very conservatively) estim ated as the di erence of the




FIG.7: D isorder averaged cost function (13) estimate of the largest eigenvalue of the density matrix, as a function of the number of calculated moments (see equation (15)), for the four dimensional Edwards-Anderson spin glass at T = 1.0, on a L = 4 lattice. The horizontal lines correspond to a numerical diagonalization of the matrix  $c_{i,j}$  plus or minus a standard deviation.




FIG. 8: D isorder averaged  $_2$  for the four dimensional Edwards-Anderson spin glass at T = 1:0 as a function of the number of computed moments, on di erent lattice sizes.

L = 6 and L = 8 data points corresponding to  $_3$ . This di erence is well covered by the error in the L = 8 data point for  $_2$ .

A fier the above considerations we can now proceed to the in nite volume extrapolation. In gure 12 we plot the data for 2 as a function of L<sup>D</sup>. It is evident that, letting aside the L = 3 data, a linear t is appropriate. The extrapolation to in nite L is de nitely di erent from zero:

In gure 13 we plot the data as they should scale accord-




FIG. 9: Probability distribution of the largest eigenvalue as calculated in the four dimensional Edwards-Anderson spin glass at T = 1.0, for lattices of linear size L = 4, 6 and 8. The binning in the L = 8 lattice was reduced by a factor of two, due to the sm aller number of sam ples.




FIG. 10: D isorder averaged subtracted trace  $_2$  for the four dimensional Edwards-Anderson spin glass at temperature T = 1.0 as a function of the lattice size.

equation (16) yields a very high value of  $^2$ =dof either when we include the L = 3 data or when we exclude them (we use = 0:6, the lowest possible value<sup>20</sup>):

## V. CONCLUSIONS

W e have proposed and used a new num erical approach to the study of the density matrix in spin glasses. The original idea of 13, namely to introduce the density matrix in the spin glasses context, allow s to make interesting calculations<sup>16</sup>, and m ight even prove useful to the deni-




FIG.12: D isorder averaged  $_2$  as a function of L <sup>D</sup> for the four dimensional Edwards-Anderson spin glass at T = 1:0. The dashed line is for a linear best t, excluding the L = 3 data.

O ur m ethod is a further step beyond the useful approach of of 13. The technology we have developed can be safely applied to the study of di erent spin m odels. The m ain limitation of our approach is not related with the use of the density m atrix, but with the extrem e di - culty in them alizing large lattices deep in the spin glass phase. Should an e cient M onte C arb algorithm be discovered, ourm ethod would be in m ediately available, because the computational burden grows only as  $L^{D}$ . Very recently, another optimized m ethod has been proposed by H ukushim a and  $1ba^{17}$ . U sing their m ethod they were able to study  $10^4$  lattices, using binary rather than G aussian couplings (which strongly speeds up the sim ulation).

U sing our approach we have been able to show that the density matrix approach for the fourd in ensional Edwards Anderson model with Gaussian couplings in lattices up to L = 8, and temperatures down to T = 1.0




FIG.13: D isorder averaged 2, as a function of L<sup>2</sup> for the four dimensional Edwards-Anderson spin glass at T = 1:0. The droplet exponent is chosen at its lower bound, = 0:6. The dashed (dotted) line is for a linear best t, excluding (including) the L = 3 data point.

predicted by the alternative droplet model. In this respect, the results are in full agreement with the availables studies<sup>8</sup> of the Parisi order parameter, and with the recent results of 17. A word of caution is in order: the (postulated) in possibility of getting them odynamic data in the reachable lattices sizes<sup>12</sup>, a ects equally to the P (q) approach and to the density matrix approach. However our data for adimensional quantities, such as the B inder or B<sub>3</sub> cumulant, seem very hard to reconcile with the possibility of a purely nite volume e ect.
