Free energy of multicom ponent em bryo form ation

This publication continues description presented in [1] taking into account all de nitions and facts from [1].

Due to the compact character of the embryo of the liquid phase one can consider it in the state of the internal equilibrium .

In the capillarity approximation the free energy of the embryo consists of the volume part and of the surface part. The surface part $F_{\rm S}$ has the form

 $F_S = S$;

where is the surface tension, S is the square of the surface. In the capillarity approximation it is supposed that the surface tension is the surface tension of the plane surface.

The volume part F_V of the free energy F has the form

where i are the numbers of the molecules of the dimension of the points inside the embryo, b_i are the excesses of the chemical potentials in the bulk phase calculated from the saturated case, index i has the values 1; ::;m for the components in the embryo. The set f ig of the numbers of the dimension of the molecules varies separately in the elementary act of interaction.

The bulk phase is considered in the fram es of the capillarity approximation as the hom ogeneous solution.

For F one can get

Gibbs-Duhem equations

For $b_{\rm i}$ one can com e in fram es of the standard theory of solutions to the following equations

where there is the molecule number density of the saturated vapor of the given concentration in the denominator. The concentrations $_{\rm i}$ of the component i

form the vector . They satis es to $P_{i i} = 1$. In the further considerations we shall use the de nition form dimensional vector or form 1 dimensional vector without any special notations.

A coording to the therm odynam ic de nitions of the activity coe cients fi

The parts of the chemical potential which depend on these coe cients are the regular functions in the limit situations. This property extracts the activity coe cients.

The activity coe cients satisfy the equations analogous to the G lbbs-D uhem one \$X\$

simply due to the chosen function dependencies. This is the consequence of the expression for the di erential of the free energy

To full the further considerations we have to notice the following very in portant fact, which will be called as the principle of the correspondence. The G ibbs-D uhem equation has to be written in the same geometrical construction as the approximation for the free energy. The problem of the construction of the G ibbs-D uhem equation is connected with the concrete approximation in which the free energy is written. In the capillarity approximation the surface tension is taken as the surface tension of the plane surface. This point has the principal signicance. For the spherical embryo the square of the surface is connected with the number of the embryo. For the plane lime aquare of the surface is the independent parameter. So, in the G ibbs-D uhem equation it has to be considered as the independent one. So, the dice emerging the free energy can be written as

The last equation is rather naive one and is gotten with account of the G ibbs-D uhem equation for the whole embryo which doesn't satisfy to the mentioned principle of the correspondence. Certainly, it is impossible to believe that one can not di erentiate the surface tension on the concentration.

The last equation is presented as far as it accumulates the phenom enological rule of W iken ski and Renninger which forbid to di erentiate the surface tension in the expression for the saddle point. The connection with the geom etrical aspects of the approximation has not been established earlier. Now we see that this is really the paradox and this paradox is the consequence of the approximation for the free energy.

Note that when the microscopic corrections due to the curvature are taken into account, the Gibbs-Duhem equation must be also corrected in the corresponding terms due to the changed geometry.

The physical reason for the W ilem ski-R enninger paradox

The physical reason of the W iken skiR enninger paradox is existence of the surface layer with the changed concentration. The di erence of this concentration from the bulk value compensates the variations of the surface tension. In some naivem odelone can say that it is protable for them olecules of some component to move to the surface layer to decrease the surface tension. Certainly, they will move until the moment of some stability when the further variation of the concentration will not lead to decrease of the surface tension, i.e. when the derivative of the surface is equal to zero. Stress again that this qualitative picture is rather naive, but it will open the way to construct the capillarity m odel with the surface excesses which will be done later.

The di erence in the sets of the independent variables in the determ ination of the saddle point and in the G ibbs-D uhem equation.

Here some certain disadvantages of the mentioned model will be presented. The G ibbs-D uhem equation was derived with account that the chemical potentials are not connected with the number of the molecules of the components in the embryo. But this connection exists and can be taken into account. This account leads to the two di erent approaches.

Neglect this dependence, i.e. put $(0 \ _{i}=0 \ _{j}) = i_{j}$, and get

A loo there appears the certain di culty connected with the absence of the connection between the concentrations and the num bers of the m olecules in the embryo (the integralde nition of the concentration is only som e approximation). As a result one can propose the capillarity m odel with the surface excesses of components

The excesses of the com ponents

To give more justimed value of the free energy one can use the formalism of the G ibbs method of the dividing surfaces. The formalism prescribes to put on the considered surface the excesses γ_1 (consider the surface of tension) of the molecules of component i.

Then the concentration can be de ned as

Due to concrete form of the activity coe cients the rst term goes to zero and X

The last relation forms the system of m 1 equations. Then all excesses are de ned with one arbitrary constant. This constant can be xed if the distance between the considered surface and the equin olecular surface is known. It is natural to consider the surface of tension as the basic surface as far as the tension is prescribed only to this surface.

On the level of the di erentiates one can get

All channels are the straight lines, they start at the origin of the coordinates of the num ber of the m olecules in the embryo and don't cross. The independent consideration of every channel is possible.

For the characteristics of the saddle point one can get

The mentioned property is the concrete realization of the principle of the "unique curvature": All surface characteristics and the G ibbs-D uhem equation must be referred to one and the same surface.
