Param agnetic State of D egenerate D ouble Exchange M odel: a N on-Local C PA A pproach

Abstract

The o-diagonal disorder caused by random spin orientations in the paramagnetic (PM) state of the double exchange (DE) model is described by using the coherent-potential-approximation (CPA), which is combined with the variationalm ean – eld approach for the C urie tem perature $(T_{\rm C})$. O ur C PA approach is essentially non-local and based on the perturbation theory expansion for the T-m atrix with respect to the uctuations of hoppings from the "m ean values" speci ed by m atrix elem ents of the self energy, so that in the rst order it becom es identical to the DE theory by de Gennes. The secondorder e ects, considered in the present work, can be viewed as an extension of this theory. They are not negligible, and lead to a substantial reduction of T_C in the one-orbital case. Even m ore dram atic changes are expected in the case of orbital degeneracy, when each site of the cubic lattice is represented by two e_{α} orbitals, which also specify the form of interatom ic transfer integrals. Particularly, the existence of two Van Hove singularities in the spectrum of degenerate DE model (one of which is expected near the Ferm i level in the 30% -doped LaM nO₃) may lead to the branching of CPA solutions, when the G reen function and the self energy become double-valued functions in certain region of the complex plane. Such a behavior can be interpreted as an intrinsic inhomogeneity of the PM state, which consists of two phases characterized by di erent electronic densities. The phase separation occurs below certain transition temperature, $T_{\rm P}$, and naturally explains the appearance of several magnetic transition points, which are frequently seen in manganites. We discuss possible in plications of our theory to the experimental situation in manganites, as well as possible extensions which needs to be done in order to clarify its credibility.

The nature of param agnetic (PM) state in perovskite m anganese oxides (the m anganites) is one of the fundam ental questions, the answer to which is directly related with understanding of the phenom enon of colossalm agnetoresistance.

There is no doubts that any theoreticalm odel form anganites should include (at least, as one of the main ingredients) the double exchange (DE) physics, which enforces the atom ic H und's rule and penalizes the hoppings of polarized e_g electrons to the sites with the opposite direction of the localized t_{2g} spins.¹³ If the spins are treated classically, the corresponding H am iltonian is given, in the local coordinate fram e speci ed by the directions $e_i = (\cos_i \sin_i; \sin_i; \cos_i)$ of the spin magnetic m om ents, by⁴

where t_{ij} are the bare transfer integrals between sites i and j (which can be either scalars or 2 2 m atrices depending on how the orbital degeneracy of the e_g states is treated in the model), and $_{ij}=\cos\frac{1}{2}\cos\frac{1}{2}+\sin\frac{1}{2}\sin\frac{1}{2}e^{i(-i-j)}$ describes their modulations caused by the deviation from the ferrom agnetic (FM) alignment in the pair i-j.

The form of H am iltonian (1) in plies that the spin magnetic moments are saturated (due to the strong H und's rule coupling) and the spin disorder corresponding to the PM state is in fact an orientational spin disorder. Despite an apparent sim plicity of the DE H am iltonian (1), the description of this orientational spin disorder is not an easy task and so far there were only few theoreticalm odel, which were based on rather severe (and presum ably unsatisfactory) approxim ations.

The rst one was proposed by de G ennes more than forty years ago.³ In his theory, all $_{ij}$ are replaced by an averaged value , so that the spin disorder enters the model only as a renorm alization (narrowing) of the e_g -bandwidth. The e ect is not particularly strong and the fully disordered PM state corresponds to $=\frac{2}{3}$. A generalization of this theory to the case of quantum spins was given by K ubo and O hata.⁵ The same idea was exploited recently in a number of theories aim ing to study the behavior of orbital degrees of freedom at elevated tem perature,⁶ but based on the same kind of sim plications for the spin disorder and its e ects on the kinetic energy.

A nother direction, which features more recent activity, is the single-site dynam icalm eaneld theory (DMFT, see Ref. 7 for a review) for the FM K ondo lattice model.^{8;9} The model itself can be viewed as a prototype of the DE H am iltonian (1) before projecting out the minority-spin states in the local coordinate fram e.⁴ If the localized t_{2g} spins are treated classically (that is typically the case), this method is similar to the disordered localm on ent approach proposed by G yor y et al.,¹⁰ and based on the coherent-potential-approxim ation (CPA) for the electronic structure of the disordered state.¹¹

Now it is almost generally accepted that both approaches are inadequate as they fail to explain not even all, but a certain number of observations in manganites of a principal character such as the absolute value and the doping dependence of the Curie temperature (T_c),¹² the insulating behavior above T_c,¹³ and a rich magnetic phase diagram along the temperature axis, which typically show a number of magnetic phase transitions¹⁴ and the phase coexistence^{15{17} in certain temperature interval. Therefore, it is clear that the theory must be revised.

Then, there are two possible ways to precede. One is to modernize the model itself by including additional ingredients such as the Jahn-Teller distortion,¹⁸ the Coulomb correlations,^{6;19} and the disorder e ects caused by the chemical substitution.²⁰ A nother possibility is to stick to the basic concept of the DE physics and try to formulate a more advanced theory of the spin disorder described by the Hamiltonian (1), which would go beyond the simple scaling theory by de Gennes³ as well as the single-site approximation inherent to DM FT.^{8;9}

An attention to the second direction was drawn recently by Varm a^{21} Them ain challenge to the theoretical description of the orientational spin disorder in the DE system s comes from the fact that it enters the Ham iltonian (1) as an o -diagonal disorder of interatom ic transfer integrals, which presents a serious and not well investigated problem. In the present work we try to investigate some possibilities along this line by employing a non-local CPA approach.

W hat do we expect?

- 1. It was realized very recently that many aspects of seemingly complicated lowtem perature behavior of the doped manganites (the rich magnetic phase diagram, optical properties, etc.) can be understood from the view point of DE physics, if the latter is considered in the combination with the realistic electronic structure for the it inerant e_a electrons and takes into account the strong dependence of this electronic structure on the magnetic ordering (see, e.g., Ref. 22 and references therein). If this scenario is correct and can be extended to the high-tem perature regime (that is still a big question), there should be som ething peculiar in the electronic structure of the disordered PM state, which can be linked to the unique properties of manganites. In order to gain insight into this problem, let us start with the DE picture by de Gennes, and consider it in the combination with the correct form of the transfer integrals between two e_a orbitals on the cubic lattice.²³ Then, the properties of the PM state should be directly related with details of the electronic structure of the FM state, which is shown in Fig. 1 and connected with the PM electronic structure by the scaling transform ation. This electronic structure is indeed very peculiar because of two Van Hove singularities at the (; ;0) and (0; ;0) points of the Brillouin zone, which are responsible for two kinks of density of states at 1. It is also interesting to note that the rst singularity appears near the Ferm i surface when the hole concentration is close to 0:3, i.e. in the most interesting regime from the view point of colossal magnetoresistance.²⁴ Such a behavior was discussed by D zero, G or kov and K resin²⁵. They also argued that this singularity can contribute to the T $^{3=2}$ dependence of the speci c heat in the FM state. If so, what is the possible role of these singularities in the case of the spin disorder? Note that apart from the single-site approximation, all recent DMFT calculations^{8;9} employed a model sem i-circular density of states, and therefore could not address this problem.
- 2. There are many anticipations in the literature that there is some hidden degree of freedom which controls the properties of perovskite manganites. A typical example is the picture of orbital disorder proposed in Ref. 19 in connection with the anom abus behavior of the optical conductivity in the FM state of perovskite manganites. A c-cording to this picture, the large on-site C oulomb interaction gives rise to the orbital polarization at each site of the system. The local orbital polarizations remain even

in the cubic FM phase, but without the long-range ordering. In the present work we will show that, in principle, by considering non-local e ects in the fram ework of pure D E model, one may have an alternative scenario, when there is a certain degree of freedom which does control the properties of manganites. However, contrary to the orbital polarization, this parameter is essentially non-local and attached to the bond of the D E system rather than to the site.

3. There were m any debated about the phase separation in perovskite m anganites,^{26,27} and according to some scenarios this e ect plays an important role also at elevated tem peratures, being actually the main trigger behind phenom enon of the colos-sal m agnetoresistance.²⁰ The problem was intensively studied num erically, using the M onte C arlo techniques.^{20,27} If this is indeed the case, what does it m ean on the language of analytical solutions of the D E m odel (or its re nem ents)? P resum ably, the only possibility to have two (and m ore) phases at the same time is to adm it that the self energy (and the G reen function) of the m odel can be a multi-valued function in certain region of the complex plane. Such a behavior of non-linear CPA equations was considered as one of the m ain troublem akers in the past,^{28,29} but m ay have som e physical explanation in the light of new ly proposed ideas of phase separation.

The rest of the paper is organized as follows. In Sec. II we brie y review the main ideas of the variational mean-eld approach. In Sec. III we describe general ideas of the non-local CPA to the problem of orientational spin disorder in the DE systems. In Sec. IV we consider the CPA solution for the PM phase of the one-orbital model and evaluate the Curie tem perature. We will argue that two seem ingly dient approaches to the problem of spin disorder in the DE model, one of which was proposed by de Gennes³ and the other one is based on the DM FT^{8;9}, have a common basis and can be regarded as CPA-type approaches, but supplemented with dient types of approximations. In Sec. V we consider more realistic two-orbital case for the e_g electrons and argue that it is qualitatively dienent from the behavior of one-orbital model. Particularly, the CPA self-energy becomes the double-valued function in certain region of the DE model. In Sec. VI we summarize the main results of our work, discuss possible connections with the experimental behavior of perovskite manganites as well as possible extensions.

II. CALCULATION OF THERMAL AVERAGES

In order to proceed with the nite tem perature description of the DE systems we adopt the variational mean-eld approach. $^{3;5;30}$ N am ely, we assume that the therm al (or orientational) average of any physical quantity is given in terms of the single spin orientation distribution function, which depends only on the angle between the local spin and an elective molecular eld ,

while all correlations between di erent spins are neglected.³¹ In the case of PM \pm M transition, the eld can be chosen as = (0;0;).

The rst complication comes from the fact that the DE H am iltonian (1) is formulated in the local coordinate frame, in which the spin quantization axes at dierent sites are specied by the dierent direction fe_ig. Therefore, we should clarify the meaning of orientational averaging in the local coordinate fram e^{32} From our point of view, it is logical that in order to calculate the therm all averages associated with an arbitrary chosen site 0, the global coordinate fram e should be specied by the direction $e_0 = (\cos_0 \sin_0; \sin_0 \sin_0; \cos_0)$, so that at each instant the spin moment at the site 0 is aligned along the z-direction. The averaging over all possible directions e_0 of the global coordinate fram e in the molecular eld can be performed as the second step.

Then, corresponding distribution function at the site 0 is given by Eq. (2). The distribution functions at other sites can be constructed as follows. The transformation to the coordinate frame associated with the site 0 is given by the matrix:

In the new coordinates, the i-th moment has the direction $e_i^0 = R^0 e_i$ (cos ${}_i^0 \sin {}_i^0 \sin {}_i^0 \sin {}_i^0 \sin {}_i^0 \cos {}_i^0$), and the eld becomes ${}^0 = R^0 = (\cos {}_0 \sin {}_0; \sin {}_0 \sin {}_0; \cos {}_0)$.

Obviously, while ⁰ and e_i^0 depend on ₀ and ₀, the new distribution function $p_i(e_i^0)/\exp({}^0 + \frac{1}{2})$ { does not, and up to this stage the transformation to the new coordinate frame was only the change of the notations. In order to obtain the total distribution function $P_i(e_i^0)$ for if 0, formulated in the local coordinates of the site 0 and taking into account the motion of e_0 in the molecular eld $p_i(e_i^0)$ should be averaged over e_0 with the weight $p_0(e_0)$:

The form of Eq. (3) in plies that the directions of magnetic moments are not correlated (in the spirit of the mean-eld approach) and the averaging over e_0 can be performed independently for di erent sites of the system. For the analysis the PM state and the magnetic transition temperature, it is su cient to consider the small-lim it. Then, Eq. (3) becomes:

where E_D (T;) is the electron free energy (or the double exchange energy):

calculated in terms of the (orientationally averaged) integrated density of states $\overline{n}(z;)$. $f_T(z) = [exp(\frac{z}{k_n T})+1]^1$ is the Ferm i-D irac function (being the chem ical potential).

The best approximation for the molecular eld is that which minimizes the free energy (6). A ssuming that the transition to the FM state is continuous (of the second order), 33 T_c can be found from equation:

In practice, the derivative $(^{2}E_{D} (T;)=(^{2} near = 0 can be calculated using the variational properties of <math>\overline{n}(z;)$ in CPA and the L byd form ula.^{34,35}

III.NON-LOCAL CPA FOR THE DOUBLE EXCHANGE MODEL

In this section we discuss some general aspects of the non-local CPA to the problem of orientational spin disorder in the DE m odel speci ed by the H am iltonian (1). We attempt to describe the disordered system in an average by introducing an elective energy-dependent H am iltonian,

where $_{ij}$ is the non-local part of the selfenergy, which is restricted by the nearest neighbors; and $_{ii}$ is the local (site-diagonal) part. The non-local formulation of CPA is essential because in the low-temperature lim it \overline{H}_{ij} should be replaced by the conventional kinetic term in which $_{ij}$ plays a role of the bare transfer integral t_{ij} . Therefore, $_{ij}$ cannot be om itted. On the other hand, $_{ii}$ will be needed in order to formulate a closed system of CPA equations.

We require the elective Hamiltonian (9) to preserve the cubic symmetry of the system and be translationally invariant. The rst requirement has a dimensional form depending on the degeneracy of the problem and the symmetry properties of basis orbitals, and will be considered separately for the one-orbital and degenerate DE models. In any case, using the symmetry properties, all matrix elements of the self energy f_{ii}; _{ij}g on the cubic lattice can be expressed through f₀₀; ₀₁g for one of the dimens (for example, 0-1 in Fig. 2). Then, the Hamiltonian (9) can be Fourier transformed to the reciprocal space,

where the integration goes over the $\,$ rst B rillouin zone with the volum e $\,_{\rm B\,Z}$.

Unfortunately, the non-local form of the Ham iltonian (9) in the combination with the translational invariance do not necessarily guaranty the full lm ent of causality principle, that is the single-particle G reen function should be analytic in the upper half of com plex energy plane and satisfy a certain number of physical requirem ents.^{28;29;36{38} This is still a largely unresolved problem, despite num erous e orts over decades. We do not have a general solution to it either. W hat we try to do here is simply to investigate the behavior of this particular m odel and try to answer the question whether it is physical or not. Note also that neither dynam ical cluster approxim ation³⁷ nor cellular DM FT m ethod³⁸, for which the causality can be rigorously proven, can be easily applied to the problem of o -diagonal disorder.

The calculations near V an H ove singularities in the case of degenerate D E m odel requires very accurate integration in the reciprocal space. In the present work we used the m esh consisting of 374660 nonequivalent q-points and corresponding to 258 258 258 divisions of the reciprocal lattice vectors.

In order to formulate the CPA equations we consider only site-diagonal and nearestneighbor elements of \overline{G}_{ij} . Again, using the symmetry properties they can be expressed through \overline{fG}_{00} ; $\overline{G}_{01}g$. In addition, there is a simple relation between \overline{G}_{00} and \overline{G}_{01} for given $_{00}$ and $_{01}$:

which follows from the de nition of the G reen function (10) and the H am iltonian (9).³⁹ U sing this identity, some matrix elements of the G reen function can be easily excluded from CPA equations.

In order to obtain the closed system of CPA equations which connects f $_{00}$; $_{01}$ g with $\overline{fG}_{00}; \overline{G}_{01}$ g we construct the T-m atrix.³⁴

and require the average of scattering due to the uctuations $\mathbf{H} = \mathbf{H} \quad \mathbf{H}$ to vanish on every site and every bond of the system, i.e.,^{11;34}

The hat-symbols in Eq. (12) means that all the quantities are in nite matrices in the real space and the matrix multiplications in ply also sum mation over the intermediate sites. Note that our approach is different from the so-called cluster-CPA $^{28;29;36;40}$ because the matrix operations in Eq. (12) are not conned within a nite cluster (the dimer, in our case). We believe that our approach is more logical and more consistent with the requirements

of the cubic symmetry and the translational invariance of the system, because all dimers are equivalent and should equally contribute to the averaged T-matrix. This equivalence is articially broken in the cluster-CPA approach, which takes into account the contributions of only those atom swhich are conned within the cluster. However, our approach also causes some additional diculties, because the non-local uctuations fit tend to couple an in nite number of sites in Eq. (12). Therefore, for the practical purposes we restrict ourselves by the perturbation theory expansion up to the second order of fit:

A swewill show, the rst term in this expansion corresponds to the approximation considered by de Gennes,³ and the next term is the rst correction to this approximation. In order to evaluate the matrix elements \overline{T}_{00} (z) and \overline{T}_{01} (z) in the approximation given by Eq. (14) it is necessary to consider the interactions conned within the twelve-atom cluster shown in Fig. 2 (obviously, an additional term in the perturbation theory expansion for the T-matrix would require a bigger cluster). All such contributions are listed in Table I.

IV.ONE-ORBITAL DOUBLE EXCHANGE MODEL

In the one-orbital case, the e ective DE Ham iltonian takes the following form, in the reciprocal space:

where $_{00}(z)$ and $_{01}(z)$ are C-numbers, $c = \cos q$, and all energies throughout in this section are in units of the e ective transfer integral t_0 , which is related with the e_g -bandwidth W in the FM state as $t_0 = W = 12$. Elements of the G reen function, $\overline{G}_{00}(z)$ and $\overline{G}_{01}(z)$, are obtained from Eq. (10). In subsequent derivations we will retain both $\overline{G}_{00}(z)$ and $\overline{G}_{01}(z)$, but only for the sake of convenience of the notations, because form ally $\overline{G}_{01}(z)$ can be expressed through $\overline{G}_{00}(z)$ using identity (11).

The self-consistent CPA equations are obtained from the conditions $\overline{T}_{00}(z) = \overline{T}_{01}(z) = 0$. In the local coordinate fram e associated with the site 0, $e_0^0 = (0;0;1)$ and all contributions to $T_{00}(z)$ and $T_{01}(z)$ shown in Table I should be averaged over the directions of magnetic m on ents of remaining sites of the cluster with probability functions given by Eq. (4). This is a tedious, but rather straightforward procedure. In order to calculate the therm all averages, it is useful to remember identities listed in Ref. 41. We drop here all details and, just for reader's convenience, list in Appendix A the averaged values for all contributions shown in Table I without the derivation, so that every step can be easily checked. We also introduce short notations for the self energies: $_{00} _{0}$ and $_{01} _{2=3+} _{1}$, and for the G reen function: $\overline{G}_{00} _{00}$ and $\overline{G}_{01} _{01} _{01}$. Then, the CPA equations $\overline{T}_{00}(z)=0$ and $\overline{T}_{01}(z)=0$ can be written in the form (for = 0 and 1, respectively):

These equations should be solved self-consistently in combination with the de nition (10) for the Green function. Dierent elements of $\overline{G}_{ij}(z)$ and $_{ij}(z)$ obtained in such a manner for the PM state (=0) are shown in Fig. 3. We note the following:

- 1. both $\overline{G}_{ij}(z)$ and $_{ij}(z)$ are analytic in the upper half of the complex plane;
- 2. Im \overline{G}_{00} (z) 0 in the upper half plane;
- 3. the (num erically obtained) integrated density of states lies in the interval 0 \overline{n} () 1 and takes all values within this interval as the function of them ical potential , meaning that our system is well de ned for all physical values of the electronic density.

We believe that for our purposes, the fullment of these three causality principles is quite su cient and some additional requirements do not necessary apply here.⁴² Note also that in the one-orbital case there is only one CPA solution in the complex energy plane.

In rst order expansion for the T-m atrix with respect to H (thereafter all quantities corresponding to such approximation will be denoted by tilde), we naturally reproduce parameters of the DE model by Gennes: ${}^{3} {}^{\circ}_{0} = {}^{-}_{1} = {}^{\circ}_{0} = 0$ and ${}^{-}_{1} = 2 = 45$. The corresponding elements of the G reen function are also shown in Fig.3. A lthough the second-order approach gives rise to the large matrix elements of the self energy, the elements of the G reen function obtained in the rst and second order with respect to H are surprisingly close (apart from a broadening in the second-order approach, caused by the imaginary part of the self energy), m eaning that there is a good deal of cancellations of di erent contributions to \overline{G}_{00} and \overline{G}_{01} .

However, it is not true for the Curie tem peratures. W hile in the rst order T_c is solely determ ined by \overline{G}_{00} , in the second-order it explicitly depends on both \overline{G}_{00} and m atrix elements of the self energy, which m ake signi cant di erence from the canonical behavior.³

Indeed, T_c can be obtained from Eq. (8). In order to evaluate the DE energy, we start with the PM solution (=0) and include all contributions of the rst order of ² as a perturbation. Employing variational properties of the averaged integrated density of states,^{34;35} \overline{n} (z;) can be found using the L byd form ula:

where $_0$, $_1$, g_0 , and g_1 correspond to the PM state.⁴³ M oreover, $g_1(z)$ can be expressed through $g_0(z)$ using identity (11). Then, the DE energy takes the form: $E_D(T;)' E_D(T; 0) + D(T)^2$, where

In the rst order with respect to H (corresponding to the choice ~ $_0 = ~_1 = ~_0 = 0$ and $~_1 = 2=45$) and after replacing $f_T(z)$ by (z), D'(T) can be expressed through the DE energy of the PM state: D'= $\frac{1}{15}$ E'_D (PM). Taking into account that E'_D (PM) = $\frac{2}{3}$ E_D (FM), we arrive at the well known expression obtained by de G ennes: $^3 k_B T_C = \frac{4}{15}$ E_D (FM), where E_D (FM) is the DE energy of the fully polarized FM state.

The results of calculations are shown in Fig. 4.⁴⁴ A more accurate treatment of H in the expression for the T-matrix signi cantly reduces T_c (up to 20% in the second-order approach). The values T_c ' 0.20t₀ and 0.17t₀ obtained correspondingly at \overline{n} = 0.5 and \overline{n} = 0.25 are substantially reduced in comparison with the (bcal) DM FT approach.⁴⁵ W e also note a good agreement with the results by A lonso et al.,³⁰ who used similar variationalmean-led approach supplemented with the moments-method for computing the averaged density of states in the one-orbital DE model. Using the value W 4eV obtained in bands structure calculations for the FM state,²² T_c can be roughly estimated as T_c 800K. The upper bound, corresponding to \overline{n} = 0.5, exceeds the experimental data by factor two. T_c can be further reduced by taking into consideration the antiferrom agnetic (AFM) superexchange (SE) interactions between the localized spins^{3;30;46;47} and spatial spin correlations. For example, according to recent M onte C and simulations, the latter can reduce T_c up to 0.12t₀ 460K at \overline{n} = 0.5.⁴⁸

V.DEGENERATE DOUBLE EXCHANGE MODEL FOR THE e_q ELECTRONS

In this section we consider a more realistic example of the double exchange model involving two e_g orbitals, which have the following order: jli $jk^2 y^2i$ and jli $\beta z^2 r^2i$. Then all quantities, such as the transfer integrals t_{ij} , the averaged G reen function $\overline{G}_{ij}(z)$, and the self energy $_{ij}(z)$ become 2 2 matrices in the basis of these orbitals (thereafter, the bold symbols will be reserved for such matrix notations). The DE model is form ulated in the same way as in the one-orbital case. Namely, modulations of the transfer integrals are described by Eq. (1) with the complex multipliers $_{ij}$. W hat important is the peculiar form of the t_{ij} matrices on the cubic lattice, given in terms of Slater-K oster integrals of the d type.²³ For example, for the 0–1 and 0–2 bonds parallel to the z-axis (see Fig. 2) these matrices have the form :

In the other words, the hoppings along the z-direction are allowed only between the $3z^2 r^2$ orbitals. Throughout in this section, the absolute values of the parameter (dd)= W = 6 0:7eV will be used as the energy unit.

The remaining matrix elements in the xy-plane can be obtained by 90 rotations of the 0-1 bond around the x- and y-axes. Corresponding transformations of the e_g orbitals are given by:

W e rem ind these sym m etry properties as an introduction to the analysis of the selfenergy in the case of the spin disorder, which obeys very sim ilar sym m etry constraints. N am ely, since the cubic sym m etry is not destroyed by the disorder, the $x^2 y^2$ and $3z^2 r^2$ orbitals belong to the same representation of the point sym m etry group. Therefore, the site-diagonal part of the selfenergy (as well as of the G reen function) will be both diagonal and degenerate with respect to the orbital indices, i.e.:

where ${}^{11}_{00} = {}^{22}_{00}$. On the other hand, the matrix elements associated with the bond 0-1 should transform to them selves according to the tetragonal (C_{4v}) symmetry. Since the $x^2 y^2$ and $3z^2 r^2$ orbitals belong to dimensions of the C_{4v} group (a_{1g} and b_{2g}, respectively), the corresponding non-local part of the self energy has the form :

Note that ${}^{11}_{01}(z)$ is not necessarily zero. The identity $t^{11}_{01} = 0$, which holds for the transfer integrals, rejects the hidden symmetry of the ordered FM state. However, there is no reason to expect that the same identity will be preserved in the case of the spin disorder. Moreover, as we will show below, the condition ${}^{11}_{01}(z) \neq 0$ is indispensable in order to formulate the closed system of CPA equations.

Thus, in the case of the orbital degeneracy, there are three independent m atrix elements of the selfenergy: $\frac{11}{00}(z) = \frac{22}{00}(z)$, $\frac{11}{01}(z)$ and $\frac{22}{01}(z)$. In comparison with the one-orbital case we gain an additional non-local parameter, which m ay control the properties of disordered DE systems, even in the case of the strictly imposed cubic symmetry.

The matrix elements of the self energy in the xy-plane can be obtained using the transform ations (20) and (21), which yield:

The orientationally averaged G reen function can be then obtained from Eq. (10). Similar to the self energy, all matrix elements of the G reen function can be expressed through \overline{G}_{00}^{11} , \overline{G}_{01}^{11} , and \overline{G}_{01}^{22} , using the symmetry properties (22) and (23). In addition, they satisfy the matrix equation (11), from which one can easily exclude one of the matrix elements.

The self-consistent CPA equations are obtained from the conditions (13). We drop here all details and present only the nalresult (some intermediate expressions for therm all averages of di erent contributions listed in Table I are given in Appendix B). We also introduce short notations for the self-energy: $\frac{11}{00} = \frac{22}{00} = 0$, $\frac{11}{01} = 1$, and $\frac{22}{01} = 2=3+2$; and for the G reen functions: $\overline{G}_{00}^{11} = 0$, $\overline{G}_{01}^{11} = 0$, 1, and $\overline{G}_{01}^{22} = 0$. Then, the CPA equations can be presented in the form (15) with = 0, 1, and 2 corresponding to the conditions T_{00}^{11} (z)= 0, T_{01}^{11} (z)= 0, and T_{01}^{22} (z)= 0, respectively. Using the second-order expression for the T-m atrix { Eq. (14), one can obtain the following expressions for the coe cients and :

A.CPA solution for the param agnetic phase

In this section we consider CPA solutions for the PM phase of the degenerate DE m odel, and argue that the situation is qualitatively di erent from the one-orbitalm odel, even in the case of cubic symmetry.

Let us not consider the limit jzj! 1. In this case, the matrix elements of the G reen function have the following asymptotic behavior:⁴⁹ g₀(z)! $\frac{1}{z}$, g₁(z)! $\frac{A}{z^2}$, and g₂(z)! $\frac{B}{z^2}$; and the CPA solution in the second order of $\frac{1}{z}$ can be easily obtained analytically from Eqs. (24)–(26) as $_0(z)!$ $\frac{1}{6z}$, $_1(z)!$ $\frac{2B}{3z^2}$, and $_2(z)!$ $\frac{7B}{54z^2}$. It is a single-valued solution and in this sense the situation is similar to the one-orbital case. The analysis is supported by num erical calculations for large but nite jzj and represents a typical behavior when Im (z) 0:75 (Fig. 5). The Van H ove singularities are smeared due to the large in aginary part of z and the self energy (Fig. 6).

However, when we start to approach the real axis, the situation changes dram atically. In the rst calculations of such type we x Im (z) and solve CPA equations by moving along the real axis and each time starting with the self-consistent self energy obtained for the previous value of Re(z). Then, in certain region of the complex plane we obtain two di erent solutions, depending on whether we move in the positive or negative direction of Re(z). A typical hysteresis loop corresponding to Im (z)= 0:7 is shown in Figs. 5 and 6.

The behavior is related with the existence of two Van Hove singularities at the (0; ;0) and (; ;0) points of the Brillouin zone, which are responsible for some sort of instability in the system. The singularities become increasingly important when z approaches the real axis. The positions of these singularities depend on matrix elements of the self energy, and given by Re($\frac{11}{00}$ 3 $\frac{11}{01}$ + $\frac{22}{01}$) and Re($\frac{11}{00}$ + $\frac{11}{01}$ 3 $\frac{22}{01}$), respectively. Therefore, by choosing di erent starting points for the self energy, the singularities can be shifted either 'to the right' or 'to the left' (Fig. 6). Since the CPA equations are non-linear, this may stabilize two di erent solutions.

A more complete picture can be obtained from Fig. 7, where we plot $\operatorname{Re}\begin{pmatrix} 22 \\ 01 \end{pmatrix}$ $\begin{pmatrix} 11 \\ 01 \end{pmatrix}$ in the complex plane.⁵⁰ D epending on the location in the complex plane, the CPA equations (15) are again converged to either the same or two di erent solutions. The double-valued behavior of $\operatorname{Re}\begin{pmatrix} 22 \\ 01 \end{pmatrix}$ $\begin{pmatrix} 11 \\ 01 \end{pmatrix}$ typically occurs within the shaded area. Note that this area is the result of num erical calculations which depend on the choice of the starting point. We do not exclude here the possibility that our result m ay be incomplete and that with a better choice of the starting conditions the double-valued area m ay be enlarged.

O ur analysis is limited by Im (z) 0.5. Further attempts to approach the real axis were conjugated with serious di culties: the topology of solutions becomes increasingly complicated and may include several additional branches, some of which are presumably unphysical. At the present stage we do not have a clear strategy of how to deal with this problem. Of course, formally the situation can be regarded as the violation of causality principles.^{28,29} N evertheless, we would like to believe that the double-valued behavior of the G reen function and the self energy obtained for Im (z) 0.5 does have a physical meaning and is not an artifact of the model analysis. That is because of the follow ing reasons:

1. for both solutions, the G reen function satis as the inequality ${\rm Im}\;\overline{G}_{00}^{11}$ 0;

2. the system is well de ned in the whole interval of densities 0 \overline{n} () 1 (corresponding

to the doping range 0 x 1 or the position of the chemical potential 1) if and only if to take into account the superposition of the two solutions. Conversely, by considering only one of the solutions (and disregarding the other one as unphysical), the density will exhibit a nite jump (a discontinuity) at certain value of , and the system will be unde ned within the discontinuity range. Presum ably, the discontinuity of the electronic density would present even m ore unphysical behavior than the fact of the existence of two CPA solutions.

3. In some sense the appearance of two CPA solutions ts well into the logic of our work. As it was discussed before, the non-local part of the self energy in the degenerate case is characterized by two di erent matrix elements and, in comparison with the one-orbital case, acquires an additional degree of freedom (which may be related with some non-local order parameter attached to the bond of the system). At the same time, the positions of Van H ove singularities, which control the behavior of non-linear CPA equations, depend on these matrix elements. Therefore, the appearance of several CPA solutions seem s to be natural.

Note that Im (z) 0.5 corresponds to the position of the rst M atsubara pole for $k_B T$ 0.159. Taking into account the realistic value of the parameter (dd)' 0.7eV²² it roughly corresponds to T 1200K, which can be regarded as the lowest estimate for the tem perature for which our analysis is strictly justimed.

Below we discuss possible physical consequences of the existence of two CPA solutions in the PM state. Our scenario is based on the following observations (see Fig. 7):

- 1. The existence of the branch-point (B in Fig. 7), which form s two physical branches of CPA solutions in certain area of the complex plane. The requirement in plies that there is a continuous path around the branch-point, which connects the points located on two di erent branches.
- 2. Both branches of the (multi-valued) G reen function and the self energy are analytic (perhaps except the branch-point itself and the branch-edges). The requirem ent allows us to use the standard theorem s of the contour integration: for example, the contour integral around the branch-point does not depend on the form of the contour, etc.

Strictly speaking, the second requirement is a postulate which is solely based on results of numerical calculations and at the present stage we do not have a general proof for it. A ssume, it is correct. Then, the physical interpretation of the multi-valued behavior becomes rather straightforward and two CPA solutions can be linked to two PM phases (with di erent densities) corresponding to the same chemical potential . The situation has many things in common with the phenomenon of inhomogeneous phase separation, which was intensively discussed form anganites.^{26;27} The new aspect in our case is that both phases are paramagnetic. The position of the branch-point itself can be related with the temperature, below which the PM state becomes intrinsicly inhom ogeneous.

 ${\tt B}$. energy integration and appearance of two param agnetic phases

In this section we discuss some aspects of the energy integration in the complex plane, related with the existence of two CPA-branches. Let us consider the integral:

where X () is a physical quantity, which can be the density of e_g electrons, the double exchange energy or the change of either of them, and X (z) has the same topology in the complex plane as the self energy shown in Fig. 7. Then, the behavior of the integral (30) will depend on the position of the chemical potential with respect to the double-valued area. Generally, we should consider three possibilities (see Fig. 8 for notations):

- 1. < $_1$. In this case there is only one CPA solution and the integral (30) can be evaluated by using the standard techniques (see, e.g., Ref. 51 and references therein).
- 2. 1 2. In this case the integral (30) takes two values for each value of the chem ical potential : $X_1()$, if the integrand is solely con ned within one branch; and $X_2()=X_1()+X()$, if it is extended to the second branch. The discontinuity X() is given by the contour integral C₁ around the branch-point. It is important here that we do not try to de ne X(z) as a single-valued function by introducing the branch-cuts, which by itself is largely arbitrary procedure.²⁸ Instead, we treat both branches on an equal footing, which inevitably leads to the multi-valued behavior of X(). This integral (30) can be replaced by the contour integral C₂ spreading in the single-valued area plus residues calculated at M atsubara poles $z_n = +i k_B T (2n+1)$:

In order to calculate X₁ and X₂, the M atsubara poles should lie on the rst and second branches of X (z), respectively.⁵²

3. > 2. In this case the integration along the real axis shall be combined with the discontinuity X given by the contour integral C 1. The integration can be replaced by Eq. (31). In this case, all M atsubara poles lie on the single branch. Therefore, X () is a single-valued function.

As an illustration, we show in Fig. 9 the behavior of the averaged density as the function of . For T = 0.24, corresponding to Im (z_0)' 0:754, which is slightly above the branch-point, the rst M atsubara pole falls beyond the double-valued area and \overline{n} () shows a norm all behavior when for each value of there is only one value of the electronic density. For sm aller T, \overline{n} () may take two di erent values for the same . This fact can be interpreted as the coexistence of two di erent phases. Such a behavior typically occurs in the interval 1:4 0:8, which may also depend on the tem perature. As it was mentioned before, any single phase fails to de ne the electronic density in the whole interval 0 \overline{n} () 1 because of the discontinuity of \overline{n} (). For example, for T = 0.23 one of the phases is not de ned in the interval 0:34 \overline{n} 0:38, corresponding to the discontinuity at = 1.25, and the other one - for 0:46 \overline{n} 0:66 corresponding to = 0:80. The problem can be resolved only by considering the combination of these two phases for which \overline{n} is de ned everywhere in the interval 0 \overline{n} () 1.

 T_P 0.23 (about 1800K), roughly corresponding to the position of the branch-point, can be regarded as the transition temperature to the two-phase state (a point of PM phase separation).

C.phase coexistence

In this section we brie y consider the problem of phase coexistence using a sem iquantitative theory of non-interactive pseudoalby. Namely, we assume that the free energy of the mixed param agnetic state is given by

Then, the equilibrium concentration, which minimizes the free energy (32) is given by $y = [\exp(\frac{E_D}{k_B T}) + 1]^{-1}$. The difference of the DE energies $E_D = E_D^{(2)} E_D^{(1)}$ can be calculated using the denition (7) and the formula (31) for the contour integration. Since the contour C_2 is conned within the single-valued area, E_D is given by the difference of residues at a limited number of M atsubara poles:

Some details of these calculations can be found in Appendix C. The discontinuity of the electronic density $n = n^{-(2)} \overline{n}^{(1)}$ can be calculated in a similar way.

Results of these calculations are shown in Fig. 10. Particularly, the equilibrium alloy concentration y is close to 0.5, meaning that the difference $E_{\rm D}$ is small and the main contribution to the free energy comes from the entropy term. The electronic density $h\overline{n}i = (1 \ y)\overline{n}^{(1)} + y\overline{n}^{(2)}$ averaged simultaneously over the spin orientations and the alloy concentrations shows a discontinuity at the edges of the two-phase region, meaning that the system is not defined. This behavior is unphysical and caused by the non-interactive approach to the problem of phase coexistence. The averaged densities range, for which two PM phases may coexist is typically 0.3-0.7 and depends on the temperature.

D.Curie tem perature

The Curie temperature can be obtained from Eq. (18). In the case of degenerate DE model, the function D (T) is given by: 53

Results of these calculations are shown in Fig. 11. For < 1, the magnetic transition temperature appears to be lower than the point of PM phase separation (T_P). Taking into account that T_P ' 0.23 and using results of Fig. 10, < 1 roughly corresponds to the densities $h\overline{n}i$ <0.5. In this region, T_C should be calculated independently for two di erent phases. The calculations can be done using Eq. (31). Not surprisingly that di erent phases

are characterized by di erent T_c 's. Therefore, for the degenerate DE model we expect the existence of two magnetic transition points. W ith the cooling down of the sample, the transition to the FM state takes place rst in one of the phases, characterized by lower density (the hole-rich phase). Then, within the interval $T_c^{(1)} < T < T_c^{(2)}$, the FM phase continues to coexist with the PM phase, persisting in the hole-de cient part of the sample. Taking into account that (dd) 0:7eV, the di erence of two transition temperatures, which depend on , can be evaluated as $0 < T_c^{(2)} - T_c^{(1)} < 650$ K. Finally, for $T < T_c^{(1)}$ the system exhibits the proper FM order established in both phases.

Formally, the opposite scenario when the phase separation occurs below the magnetic transition temperature is also possible, and according to Fig.11 m ay take place when > 1 (mi 0.5). However, the quantitative description of this situation is beyond the small-limit, considered in the present work.

VI.CONCLUDING REMARKS

We have applied a non-local CPA approach to the problem of orientational spin disorder in the double exchange systems, which was supplemented by a mean-eld theory for the analysis of magnetic transition temperature. Our CPA approach is based on the perturbation theory expansion for the T-matrix with respect to uctuations of hoppings from the mean value of the DE H am iltonian specied by the matrix elements of the (non-local) self energy, so that in the lowest (rst) order it automatically recovers the main results of the DE theory by de G ennes (the bandwidth narrowing in the PM state, expression for the C urie temperature, etc.).³ O ur main focus was on the correction of this theory by higher-order e ects with respect to the uctuations, which were included up to the second order and treated in the real space.

In the one-orbital case, it led to a substantial reduction of T_c (up to 20%). Nevertheless, the obtained value of T_c was largely overestim ated in comparison with results of M onte C arbo calculations,⁴⁸ due to limitations inherent to the m ean-eld approach. Therefore, a sensible description of spatial spin correlations, beyond the m ean-eld approximation, presents a very important direction for the improvement of our m odel.

It appeared, however, that even on the level of mean-eld theories the situation is far from being fully investigated, especially if one takes into account the elects of orbital degeneracy and details of realistic electronic structure for the e_g electrons in the cubic perovskite structure. Particularly, two Van Hove singularities at the (;;0) and (0;;0) points of the Brillouin zone m ay contribute to the properties of DE systems not only in the ordered FM state,²⁵ but also in the case of the spin disorder, above the magnetic transition temperature. The singularities lead to the branching of CPA solutions for the PM state, so that for certain values of the chemical potential the system consists of two PM phases with two di erent densities. In such a situation, the PM state becom es intrinsicly inhom ogeneous, that also determ ines details of the phase transition to the FM state with the decrease of the tem perature. The magnetic transition is characterized by the existence of two transition points, and rst takes place in one of the phase takes place at yet another temperature, which can be signi cantly lower than the rst one. Both magnetic transitions are continuous (of the second order). However, they occur separately in two di erent phases which already exist in the PM region, i.e. above the rst magnetic transition point. 54

How is this scenario consistent with the experim ental behavior of perovskite m anganites? It is true that there is no clear experimental evidence supporting the existence of an individual tem perature of the PM $\,$ phase separation, $T_{\rm P}$, and the intrinsic inhom ogeneity of the PM phase (unless it is caused by external factors such as the chem ical and structural inhom ogeneities and the grain boundaries).⁵⁵ In this sense our result can be regarded as the prediction. On the other hand, the phase coexistence below $T_{\rm C}$ is rather common, and was observed in a number of experiments.^{15{17} In addition, our result naturally explains the appearance of several m agnetic transition points in perovskite m anganites. Yet, a clear di erence is that experim entally one (or som etim es both) m agnetic transitions are antiferrom agnetic (typically either to the A - or CE - type AFM state), and the situation when two consecutive transitions go to the FM state is not realized in practice.²⁴ P resum ably, the di erence is caused by the limitation of our analysis by the PM and FM states, while in reality for $h\overline{n}$ i< 0.7 (i.e. when several magnetic transition points are expected) the form ation of the (A-, CE-, and C-type) AFM structures seems to be more natural. From this point of view, results of our work present mainly an academ ical interest: we pointed out at the principal possibility of the existence of several magnetic transition tem peratures for the DE system s, however the type of the ordered state considered at the low temperature was not su ciently general. 56

Finally, we would like to discuss brie y som e possible extensions of our model.

- 1. As it was already mentioned, any realistic description of the phase diagram of perovskite manganites would be incomplete without the (A-, CE-, and C-type) AFM structures. The minimal model which captures the behavior of doped manganites at the low temperature is the double exchange combined with the isotropic AFM SE interaction between the localized spins (J^S). So, the magnetic phase diagram at T = 0 can be understood in terms of the anisotropy of interatom ic DE interactions, caused by the anisotropy of magnetic ordering and operating in the background of isotropic AFM SE interactions.²² In this picture, the SE interactions were needed to shift the reference point simultaneously in allbonds in the direction of the AFM coupling, while the variety of the phase diagram itself is described by the anisotropy of the DE interactions. However, similar shift is not applicable for the magnetic transition temperature, or may not be the major elect of the SE interactions. For example, the shift of the Curie temperature by J^S , T_C ! $T_C = 2jJ^S j^{47}$ will also a local the mesh of M atsubara poles in Eq. (31). It will require the careful analysis of the topology of CPA solutions near the real axis, which will present the main obstacle for such calculations.
- 2. Our main results regarding the nontrivial topology of the CPA solutions for the PM state have been based on the second order of the perturbation theory expansion for the T-m atrix. Since the e ect was so dram atic, it naturally rises the question about importance of the higher-order term s. It seems to be a very important problem for the future analysis.
- 3. The main e ect discussed in this work is based on the existence of Van Hove singularities in the density of states of degenerate DE model. However, the exact position of

these singularities, or even the fact of their existence in realistic compounds depend on m any other factors, such as the M n (3d)-O (2p) hybridization, the cation and structural disorder, the purity of sample, etc. All these factors m ay signi cantly alter conclusions of our work, if one try to apply them to realistic compounds.




FIG.1. Tight-binding density of states and the dispersion of two e_g bands in the ferrom agnetic state (in units of dd transfer integral). The dotted line shows the positions of the Ferm i level as a function of hole-concentration x, which is related with the integrated density of states as x=1 n. Note the existence of two Van Hove singularities at (;;0) and (0;;0), responsible for the kinks of density of states at 1. The rst singularity is located near the Ferm i level when x' 0:3 (shown by arrow).




FIG.2. A tom ic sites which will contribute to the orientational average of the T-m atrix for the dim er 0-1, when T (z) is given by the second-order perturbation theory expression { Eq. (14).




FIG.3. Behavior of matrix elements of the G reen function and the self energy along the real axis in the one-orbital double exchange model (in units of transfer integral t_0). The same results, but using the rst-order expression for the T-matrix with respect to the uctuations H are shown by dotted line.




FIG.4. Curie tem perature T_C (in units of t_0) of the one-orbital double exchange model obtained using the rst-and second-order expression for the T-matrix with respect to the uctuations H as a function of averaged electronic density.




FIG.5. Behavior of matrix elements of the self energy in the param agnetic state of degenerate double exchange. For Im (z) 0:75 there is only one solution, while for Im (z) < 0:75 one can obtain two self-consistent CPA solutions in certain interval of Re(z) by starting the iterations with the self energy obtained for the previous value of Re(z) and moving either in the positive or negative direction of the real axis (shown as a hysteresis).





FIG.6. In aginary part of the G reen function (the local density of states) for the param agnetic state of degenerate double exchange m odel. See Fig.5 for description.




FIG.8. Energy integration for the degenerate double exchange model. (a): The integral along the real axis plus the discontinuity given by the contour integral C_1 around the branch-point B. (b): An equivalent expression in terms of the contour integral C_2 spreading in the single-valued area of the complex plane and residues calculated at M atsubara poles. The latter contributions are di erent for two di erent branches, that is equivalent to the discontinuity term in the scheme (a).





FIG.9. A veraged electronic density as a function of chem ical potential for the param agnetic state of degenerate double exchange model. For T $0.23, \overline{n}$ () may take two dimensions for the same chem ical potential which correspond to two dimensions shown in Fig.5.




FIG.11. Main transition temperatures for the degenerate double exchange model (in units of dd -integral). T_P is the transition temperature to the two-phase paramagnetic state. The shaded area shows the approximate range of the chemical potentials () when the paramagnetic state becomes intrinsicly inhomogeneous. $T_c^{(1)}$ and $T_c^{(2)}$ are the Curie temperatures for two dimensions of the chemical potentials.
