Synapse e ciency diverges due to synaptic pruning follow ing over-grow th

In the developm ent of the brain, it is known that synapses are pruned follow ing over-grow th. This pruning follow ing over-grow th seems to be a universal phenom enon that occurs in alm ost all areas { visual cortex, m otor area, association area, and so on. It has been shown num erically that the synapse e ciency is increased by system atic deletion. We discuss the synapse e ciency to evaluate the e ect of pruning follow ing over-grow th, and analytically show that the synapse e ciency diverges as O (jlog c) at the lim it where connecting rate c is extrem ely sm all. Under a xed synapse num ber criterion, the optim al connecting rate, which m axim ize m em ory perform ance, exists.

I. IN TRODUCTION

In this paper, we analytically discuss synapse e ciency to evaluate e ects of pruning following over-growth during brain development, within the fram ework of autocorrelation-type associative memory.

Because this pruning following over-grow th seem stobe a universal phenom enon that occurs in almost all areas { visual cortex, m otor area, association area, and so on [1, 2, 3, 4, 5, 6, 7, 8, 9, 10] { we discuss the meaning of its function from a universal view point rather than in terms of particular properties in each area. Of course, to discuss this phenom enon as a universal property of a neural network model, we need to choose an appropriate model.

Arti cial neural network models are roughly classi ed into two types: feed forward models and recurrent models. Various learning rules are applied to the architectures of these models, and correlation learning corresponding to the Hebb rule can be considered a prototype of any other learning rules. For instance, correlation learning can be regarded as a st-order approxim ation of the orthogonal projection m atrix, because the orthogonal projection matrix can be expanded by correlation m atrices [11]. In this respect, we can naturally regard a correlation-type associative m em ory m odel as one prototype of the neural network models of the brain. For example, Am it et al. discussed the function of the column of anterior ventral tem poral cortex by means of a model based on correlation-type associative memory model [12, 13]. A lso, Som polinsky discussed the e ect of dilution. He assumed that the capacity is proportional to the num ber of rem aining bonds, and pointed out that

a synapse e ciency of diluted network, which is storage capacity per a connecting rate, is higher than a full connected network's one [14]. Chechik et al. discussed the signi cance of the function of the pruning following over-growth on the basis of a correlation-type associative m em ory m odel [15]. They pointed out that a m em ory perform ance, which is stored pattern num berper synapse num ber, is m axim ized by system atic deletion that cuts synapses that are lightly weighted. However, while it is qualitatively obvious that synapse e ciency and m em ory perform ance are increased by a system atic deletion, we also need to consider the increase of synapse e ciency quantitatively.

In this paper, we quantitatively compare the e ectiveness of system atic deletion to that with random deletion on the basis of an auto-correlation-type associative m em ory model. In this model, one neuron is connected to other neurons with a proportion of c, where c is called the connecting rate. System atic deletion is considered as a kind of nonlinear correlation learning [16]. At the lim it where the num ber of neurons N is extrem ely large, it is known that random deletion and nonlinear correlation learning can be transform ed into correlation learning with synaptic noise [14, 16]. These two types of deletion, systematic and random, are strongly related to multiplicative synaptic noise. First, we investigated the dependence of storage capacity on multiplicative synaptic noise. At the lim it where multiplicative synaptic noise is extrem ely large, we show that storage capacity is inversely proportional to the variance of the multiplicative synaptic noise. From this result, we analytically derive that the synapse e ciency in the case of system atic deletion diverges as 0 (jlog cj) at the lim it where the connecting rate c is extrem ely sm all. W e also show that the synapse e ciency in the case of system atic deletion becom es 2 jlog cjtim es as large as that of random deletion.

In addition to such the xed neuron number criterion

as the synapse e ciency, a xed synapse number criterion could be discussed. At the synaptic growth stage, it is natural to assume that metabolic energy resources are restricted. W hen metabolic energy resources are limited, it is also important that the e ect of synaptic pruning is discussed under limited synapse number. Under this criterion, the optim al connecting rate, which maxim ize mem ory performance, exists. These optim al connecting rates are in agreement with the computer simulation results given by Chechik et al [15].

II. M O D E L

Som polinsky discussed the e ects of synaptic noise and nonlinear synapse by m eans of the replica m ethod [14]. However, sym m etry of the synaptic connections $J_{ij} = J_{ji}$ is required in the replica m ethod since the existence of the L japunov function is necessary. Therefore, there w as a problem that the sym m etry regarding synaptic noise had to be assumed in the Som polinsky theory. To avoid this problem, O kada et al. discussed additive synaptic noise, multiplicative synaptic noise, random synaptic consistent signal-to-noise analysis (SC SNA) [16]. They showed that additive synaptic noise, random synaptic deletion, nonlinear synapse can be transform ed into m ultiplicative synaptic noise.

Here, we discuss the synchronous dynam ics as,

where F is the response function, x_i is the output activity of neuron i, and h is the threshold of each neuron. Every component i in a memorized pattern is an independent random variable,

and the generated patterns are called sparse pattern with bias a (1 < a < 1). We have determ ined that the ring rate of states in the retrieval phase is the same for each memorized pattern [17, 18]. In this case, threshold h can be determ ined as,

The ring rate becomes f = (1 + a)=2 at the bias a.

A dditive synaptic noise, multiplicative synaptic noise, random synaptic deletion, and nonlinear synapse can be introduced by synaptic connections in the follow ing m anner.

In the case of additive synaptic noise, synaptic connections are constituted as,

where $_{ij}$ is the additive synaptic noise. The symmetric additive synaptic noise $_{ij}$ and $_{ji}$ are generated according to the probability,

where 2_A is the absolute strength of the additive synaptic noise. The parameter ${}_A$ is assumed to be 0 (1). This means that the synaptic connection J_{ij} is 0 (1= P N). It is useful to de ne the parameter ${}_A$ as

which measures the relative strength of the noise and we call the parameter 2_A the variance of the additive synaptic noise. Therefore, we de ne the probability to generate the additive synaptic noise $_{ij}$ as

In the case of multiplicative synaptic noise, synaptic connections are constituted as,

where $"_{ij}$ is multiplicative synaptic noise. The symmetric multiplicative noise $"_{ij}$ and $"_{ji}$ are generated according to the probability,

where $\frac{2}{M}$ is the variance of the multiplicative synaptic noise.

In the model of random synaptic deletion, synaptic connections are constituted as,

where c_{ij} is a cut coe cient. The synapse that is cut is represented by the cut coe cient $c_{ij} = 0$. In the case of symmetric random deletion, the cut coe cients c_{ij} and c_{ji} are generated according to the probability,

where c is the connecting rate.

In the model of nonlinear synapse, synaptic connections are constituted as,

where p = N. The nonlinear synapse is introduced by applying the nonlinear function f(x) to the conventional Hebbian connection matrix T_{ij} .

A. System atic deletion by nonlinear synapse




FIG.2: M in im al value deletion.

Chechik et al. pointed out that a memory performance, which is a storage pattern number per a synapse number, is maximized by systematic deletion that cuts synapses that are lightly weighted [12, 13, 15]. Such a systematic deletion can be represented by the nonlinear function f(x) for a nonlinear synapse. In accordance with Chechik et al., we discuss three types of nonlinear functions (Figs.1, 2, and 3). Fig.1 shows clipped modication that is discussed generally as




FIG.3:Compressed deletion.

Chechik et al. also obtained the nonlinear functions shown in Figs2 and 3 by applying the follow ing optim ization principles [15, 19]. In order to evaluate the elect of synaptic pruning on the network's retrieval perform ance, Chechik et al. study its elect on the signal-to-noise ratio (S/N) of the internal eld h $_{j6\,i}$ J_{ij}x_j + h [15]. The S/N is calculated by analyzing the moments of the internal eld and was given as


where z has standard norm all distribution, i.e., $E[z^2] = V[z] = 1$ and D z is G aussian measure de ned as

and E;V denote the operators to calculate the expectation and the variance for the random variables $_i$ (i = 1; ;N; = 1; ;N), respectively. The (f(z);z) denotes the correlation coe cient. Chechik et al. considered the piecew ise linear function like follow ing nonlinear functions. In order to nd the best nonlinear function f(z), we should maxim ize (f(z);z), which is invariant to scaling. Namely, the best nonlinear function f(x) is obtained by maxim izing E [zf(z)] under the condition that E [f(z)²] is constant. Let be the Lagrange multiplier, it is su cient to solve

for som e constant c_0 . Since the synaptic connection before acting the nonlinear function T_{ij} obeys a Gaussian distribution N (0;1), Eq.(13) is averaged over all of the synaptic connections.

Thus, the nonlinear function shown in Fig.2,

is also obtained. The deletion by this nonlinear function is called m inim al value deletion. Sim ilarly, by adding the condition that the total strength of synaptic connection D z jf (z) j is constant, the nonlinear function

; N), respectively. The function is called compressed deletion. We discuss system atic deletion by using these three types of nonlinear functions $f_1(z;t); f_2(z;t)$ and $f_3(z;t)$ given by Chechik et al [15].

III. RESULTS

In this section, the results concerning the multiplicative synaptic noise, the random deletion, and the nonlinear synapse are shown, at the limit where the e ect of these deletions is extremely large.

The SC SNA starts from the xed-point equations for the dynam ics of an N-neuron network as Eq.(1). The results of the SC SNA for the sym m etric additive synaptic noise are sum m arized by the following order-parameter equations (see Appendix A):

where < in>plies averaging over the target pattern, m is the overlap between the 1st m em ory pattern 1 and the equilibrium state x is de ned as

note that generality is kept even if the overlap was de ned by only the 1st m em ory pattern, q is E dwards-Anderson order-parameter, U is a kind of the susceptibility, which m easures sensitivity of neuron output with respect to the external input, Y (z;) is elective response function, ² is the variance of the noise. We set the output function F (x) = sgn(x) a in the following sections, where domain of the x variable is F (x) = 1 a when x 0, otherwise F (x) = 1 a.

A coording to 0 kada et al. [16], the sym m etric additive synaptic noise, the sym m etric random deletion, and the nonlinear synapse can be transform ed into the sym m etric m ultiplicative synaptic noise as follows (see A ppendix B): the additive synaptic noise is




FIG. 4: Overlaps in the random deletion network. The curves represent the theoritical results. The dots represent simulation results with N = 3000 and f = 0:1 for the connecting rate c = 0:1, c = 0:3, and c = 1:0.

In the following sections, symmetries of the additive synaptic noise, the multiplicative synaptic noise and random deletion are assumed . Storage capacity can be obtained by solving the order-parameter equations.

Figure 4 shows m () curves in the random deletion network with the number of neurons N $\,=\,$ 3000 and the

ring rate f = 0:1 for the connecting rate c = 0:1, c = 0:3, and c = 1:0. It can be con med that the theoretical results of the SC SNA are in good agreement with the computer simulation results from Fig.4. Since it is known that theoretical results obtained by means of the SC SNA are generally in good agreement with the results obtained through the computer simulations using various models that include synaptic noise, we treat the results by means of the SC SNA only [16, 20, 21, 22, 23, 24, 25, 26].

Through the relationships of Eqs.(26)-(30), the sym – metric additive synaptic noise, the symmetric random deletion, and the nonlinear synapse can be discussed in terms of the symmetric multiplicative synaptic noise. Therefore, rst of all, we deal with the multiplicative synaptic noise.

A. Multiplicative synaptic noise




FIG.5: Dependence of storage capacity $_{\rm c}$ on the multiplicative synaptic noise $_{\rm M}^2$ at the ring rate f = 0.5. C om parison of asymptote and the results from the SC SNA.

Figure 5 shows the dependence of storage capacity on the multiplicative synaptic noise. As it is clear from Fig.5, storage capacity $_{\rm c}$ is inversely proportional to the variance of the multiplicative synaptic noise $^2_{\rm M}$, when the multiplicative synaptic noise is extremely large. Stor-




FIG. 6: Dependence of storage capacity $_{\rm c}$ on the multiplicative synaptic noise $_{\rm M}^2$. It can be con rm ed that the order of the asymptote does not depend on the ring rate.

age capacity _c asymptotically approaches

(see Appendix C). In the sparse limit where the ring rate is extremely small, it is known that storage capacity becomes $_{c}$ ' 1=(fjlogfj) [18, 20, 28, 29, 30].

Figure 5 shows the results from the SC SNA and the asymptote at the ring rate f = 0.5. Figure 6 shows the results from the SC SNA at various ring rates. It can be con rm ed that the order of the asymptote $O\left(\frac{1}{\frac{2}{M}}\right)$ does not depend on the ring rate from Fig.6.

B. Random deletion

Next, we discuss the asymptote of the random deletion. The random deletion with the connecting rate c can be transformed into the multiplicative synaptic noise by Eq.(27). Hence, at the lim it where the connecting rate c is extremely small, storage capacity becomes




FIG.7: Dependence of the synapse e ciency S_{eff} on the random deletion with the connecting rate c at the ring rate f = 0.5. C om parison of asym ptote and the results from the SC SNA.




FIG.8: Dependence of the synapse e ciency S_{eff} on the random deletion with the connecting rate c at various ring rates. It can be con med that the order of the asymptote does not depend on the ring rate.

according to the asymptote of the multiplicative synaptic noise in Eq.(31). In the random deletion, the synapse e ciency S_{eff} , which is storage capacity per the connecting rate [14, 16], i.e., storage capacity per the input of one neuron, and de ned as

approaches a constant value as

according to Eq.(32) at the lim it where the connecting rate c is extremely small.

Figure 7 shows the result from the SC SNA and the asymptote at the ring rate f = 0.5. Figure 8 shows the results from the SC SNA at various ring rates. It can be con med that the order of the asymptote, 0 (1) with respect to c, does not depend on the ring rate from Fig.8.

C. System atic D eletion

1. C lipped synapse

Synapses within the range t < z < t are pruned by the nonlinear function of Eq.(14).

The connection rate c of the synaptic deletion in Eq.(13) is given by, $\frac{7}{7}$




FIG.9: Dependence of the synapse e ciency S_{eff} with the clipped synapse on the connecting rate c at f = 0.5. C om parison of the results from the SC SNA and asymptote.




FIG.10: Dependence of the synapse e ciency S_{eff} with the clipped synapse on the ring rate f. It can be con med that the order of the asymptote does not depend on the ring rate.

Figure 9 shows the results from the SCSNA and the asymptote at the ring rate f = 0.5. Figure 10 shows the results from the SCSNA at various ring rates. It can be con rm ed that the order of the asymptote 0 (log c) does not depend on the ring rate from Fig.10.

2. M in im al value deletion

In a similar way, the equivalent multiplicative synaptic noise $^2_{\rm M}$ of the system atic deletion of Eq.(18) is obtained as follows,




FIG.11: Dependence of the synapse e ciency S_{eff} with the minimal value deletion on the connecting rate c at time f = 0.5. C om parison of the results from the SC SNA and the asymptote.




FIG. 12: Dependence of the synapse e ciency S_{eff} with the minimal value deletion on the ring rate f. It can be con rming that the order of the asymptote does not depend on the ring rate.

ure 12 shows the results from the SC SNA at various ring rates. It can be con med that the order of the asymptote does not depend on the ring rate from Fig.12.

3. Compressed deletion

Again, in the sim ilar way,

The equivalent multiplicative synaptic noise $^2_{M}$ of the system atic deletion of Eq.(19) is given by

for x 1. In order for the rst term and the second term of Eq.(51) to be same order, the asymptotic expansion equation has taken the approximation of 0 (t³) and 0 (t⁵) respectively. The equivalent multiplicative synaptic noise in the case of system atic deletion becomes double that of the clipped synapse of Eq.(38) and the minimal value deletion of Eq.(48). Therefore, at the limit where the equivalent connecting rate c is extremely small, storage capacity $_{\rm c}$ and the synapse e ciency S_{eff} can be obtained through Eqs.(31)C (48), and (39) as follows,




FIG.13: Dependence of the synapse e ciency $S_{\rm eff}$ with the compressed deletion on the connecting rate c at f = 0.5. C om parison of the results from the SC SNA and the asymptote.




FIG.14: Dependence of the synapse e ciency $S_{\rm eff}$ with the compressed deletion on the ring rate f. It can be comming that the order of the asymptote does not depend on the ring rate.

respectively. Figure 13 shows the results from the SC-SNA and the asymptote at the ring rate f = 0.5. Figure 14 shows the results by the SC SNA at various ring rates. It can be con med that the order of the asymptote 0 (log c) does not depend on the ring rate from Fig.14.




FIG.15: Comparison of the synapse e ciency with the random deletion and that with the system atic deletion at the ring rate f = 0.5.

Figure 15 shows the dependence of the synapse e – ciency S_{eff} on the connecting rate c obtained by m eans of the SC SNA. Table I shows the asymptote of storage capacity with the random deletion and the systematic deletion. Hence, when using m inimal value deletion as the simplest from of systematic deletion we found that the synapse e ciency in the case of systematic deletion becomes

thus we have shown analytically that the synapse efciency in the case of systematic deletion diverges as 0 (jlogc) at the limit where the connecting rate c is

extrem ely sm all, and have shown that the synapse efciency in the case of the system atic deletion becomes 2 jlog cjtim es as large as that of the random deletion.

IV. THE MEMORY PERFORMANCE UNDER LIM ITED METABOLIC ENERGY RESOURCES

Until the previous section, we have discussed the e ect of synaptic pruning by evaluating the synapse e ciency which is the memory capacity nom alized by connecting rate c. W hen the connecting rate is c, the synapse number per one neuron decreases to cN. Therefore, the synapse e ciency means the capacity per the input of one neuron. In the discussion by the synapse e ciency, the synapse number decreases when the connecting rate is sm all.

In addition to such the xed neuron number criterion, a xed synapse number criterion could be discussed. At the synaptic growth stage, it is natural to assume that metabolic energy resources are restricted. When metabolic energy resources are limited, it is also important that the e ect of synaptic pruning is discussed under limited synapse number. Chechik et al. discussed the memorized pattern number per one synapse under a xed synapse number criterion [15]D They pointed out

the existence of an optim al connecting rate under the

xed synapse number criterion and suggested an explanation of synaptic pruning as follows: synaptic pruning following over-growth can improve performance of a network with limited synaptic resources. The synapse number is N² in the full connected case c = 1. We consider the larger network with M (> N) neurons. The synapse number in the lager networks with the connecting rate c becomes cM². We can introduce the xed synapse number criterion by considering a larger network which has M neurons, i.e.,




FIG.16: Memory performance c^{p} connections with dierent number of neurons but the same total number of synapses as a function of the connecting rate c in the case of clipped synapse (the solid line), minimal value deletion (the dotted line), and compressed deletion (the dashed line).

We de ne the coe cient c=casm em ory performance. We discuss the e ect of synaptic pruning by the memory perform ance. Under lim ited m etabolic energy resources, the optim al strategy is the maxim ization of the memory perform ance. Chechik et al. showed the existence of the optim alconnecting rate which maxim izem em ory performance [15]. The memory performance can be calculated by normalising the capacity, which is given by solving the porder-param eter equations, with \overline{c} . Figure 16 shows the dependence of the m em ory perform ance on the connecting rate in three types of pruning. It is con med that there are the optim al values which m axim ized the m em ory perform ance by each deletions. The optim alconnecting rates of clipped synapse, m in im al value deletion, and com pressed deletion are c = 0.036; 0.038; 0.084, respectively. This interesting fact m ay imply that the m em ory perform ance is improved without heavy pruning. These optim al values agree with the computer simulation results given by Chechik et al [15].

V. CONCLUSION

We have analytically discussed the synapse e ciency, which we regarded as the auto-correlation-type associative memory, to evaluate the e ect of the pruning following over-growth. Although Chechik et al. pointed out that the synapse e ciency is increased by the system atic deletion, this is qualitatively obvious and the increase in the synapse e ciency should also be discussed quantitatively. At the limit where the multiplicative synaptic noise is extremely large, storage capacity $_{\rm C}$ is inversely as the variance of the multiplicative synaptic noise $_{\rm M}^2$. From this result, we analytically obtained that the synapse e ciency in the case of the system atic deletion diverges as O (jlog c) at the limit where the connecting rate c is extremely small.

On the other hand, it is natural to assume that m etabolic energy resources are restricted at the synaptic growth stage. W hen m etabolic energy resources are lim ited, i.e., synapse number is lim ited, the optim al connecting rate, which m axim ize m em ory perform ance, exists. These optim al values are in agreement with the results given by Chechik et al [15].

In the correlation learning, which can be considered a prototype of any other learning rules, various properties can be analyzed quantitatively. The asymptote of synapse e ciency in the model with another learning rule can be discussed in a similar way. As our future work, we plan to further discuss these properties while taking into account various considerations regarding related physiological know ledge.
