The origin of spurious velocities in lattice Boltzm ann

Stationary droplets simulated by multi-phase lattice Boltzm ann m ethods lead to spurious velocities around them. In this article I report the origin of these spurious velocities for one example and show how they can be avoided.

1. Introduction




Fig. 1. (a) Spurious currents for a drop where the longest velocity vector corresponds to a lattice velocity of 3:4 10 4 . The density of the matrix is = 0:931 and the density of the drop is = 1:013. (b) The chem ical potential and the spurious di usion currents for the same drop. The longest velocity vector corresponds to a lattice velocity of 2:4 10 4 . The values of vary between 1:298 10 3 and 1:181 10 3 .

Im agine a stationary droplet in quiescent conditions. For a real system there are, of course, no velocities. Yet when this simple system is simulated with a lattice Boltzm ann method you will nd a ow - eld around the drop. Even if you start with a no ow initial condition this velocity eld will develop. An example of these velocities in shown in Figure 1 (a). These velocities are know as \spurious velocities".

The magnitude of the velocities depends on the details of the method, the radius of the drop, the surface tension and the viscosity. There have been several studies^{1;2;3} of di erent methods that tell us about the dependence of the spurious velocities on these parameters. In the past the focus of the work has been on reducing the magnitude of these velocities but to the best of my know ledge no good understanding of their origin has been reached. In this article I will explain why we see these spurious velocities at all and how, and at what cost, they can be avoided.

I will rst introduce a simple lattice Boltzm ann m ethod for m odel B dynam ics and show the perfect approach to equilibrium which is free of any spurious currents. Then I extend this m odel to include hydrodynam ics and we will see that spurious currents suddenly appear. A simple exam ination shows why there should not be any spurious currents according to the continuum equations and I point out the term s through which discretization errors drive the spurious currents. I introduced a therm odynam ically consistent discretization of these term s which leads to a lattice Boltzm ann m ethod that is free of spurious currents.

2. Lattice Boltzm ann for M odel B

M odel B is a model describing the behavior of binary alloys. W e will consider a mixture of, say, A and B atom s. The system is characterized by the order parameter

which represents the di erence in the densities of the two components, i.e. = 1 represents pure A and = 1 represents pure B. The dynam ics of this conserved order parameter is then given by

where D is a di usion coe cient and is the chemical potential. The system is described by the free energy F. For simplicity we will consider a Landau Free energy expansion around the critical point which is given by

To simulate this equation we use a BGK lattice Boltzm ann m ethod given by

where the relaxation time may depend on and the set of discrete velocities fv_igw ill be determined later. The behavior of the model will be determined by the moments of the equilibrium distribution g_i^0 . We name these moments

A Taylor expansion to second order in the derivatives gives

We now take the $rst m om ent(_i)$ of this expansion and obtain as the equation of motion for the order parameter

We have two independent ways to ensure that this equation be equivalent to (1). Either we choose F = 0; M = 1, = D + 0.5 or alternatively F = Dr and M = 0: Note that the r $\theta_t F$ term is now third order. In two dimensions we can implement both of these approaches with a small velocity set of ve velocities $fv_ig = f(0;0); (1;0); (0;1); (0; 1)g$.

Both approaches behave equivalently, as expected, but they di er in the ranges of stability as will be discussed elsewhere⁴. Both im plem entations of this sim ple di usive lattice Boltzm ann algorithm are free from spurious currents. We conclude that hydrodynam ics is required to see spurious currents.

3. M odel H { binary uids

In order to simulate binary uids we have to introduce a uid velocity which will convect the order parameter . This uid velocity will obey the N avier-Stokes equation which is coupled to the order parameter through a therm odynamics pressure tensor P^c. We will denote the uid density as . The equations of motion art⁴

where the pressure is p = T, is the viscosity and d the number of spatial dimensions. The pressure tensor P^{c} is dened as

We can implement these continuum equations using lattice Boltzmann.W ith (3) we now de ne $_{i}g_{i} = .By imposing _{i}g_{i}^{0}v_{i} = u + F and _{i}g_{i}^{0}v_{i}v_{i} = M + uu we obtain the required order parameter equation (7) with either of the previous choices for F and M. The Navier-Stokes equations are obtained with a usual one-component lattice Boltzmann method which is coupled to the order parameter equation through a body force of r P^c.$

Doing this leads to the well known spurious velocities as shown in Figure 1.We see that there are not only spurious currents but also the chem ical potential is no longer constant. Since the implementation of a simple model B did not lead to

the spurious velocities it is reasonable to assume that the implementation of the additional lattice Boltzmann equation for the total density and the momentum is the reason for the occurrence of the spurious velocities. Why should the continuous equations in equilibrium be consistent with a quiescent drop without spurious velocities? This is because the two driving term srDr and rP^{c} are related through

This means that a constant chem ical potential will lead to zero driving force in both equations.

When we now use this know ledge and replace the driving force $r P^{c}$ with r we not that the spurious velocities vanish to machine precision. The density of the order-parameter in the surrounding uid is = 0.933 and the density in the drop is = 1.015 (cfF igure 1). The size of the maximum velocity is now 5.610⁻¹⁶. The chem ical potential has the value of = 1.2103 10⁻³ and variations are sm aller than 2 10⁻¹⁵. So why do the spurious velocities appear in the rst place? This is because the discretizations of $r P^{c}$ and r are very di erent. We conclude that the di erent discretizations of the driving forces for the order parameter and m om entum equations are the origin of spurious velocities for lattice Boltzm ann.

There is, how ever, a caveat. The term r in its discrete form is not a divergence of a scalar eld which means that momentum is now only approximately conserved. To be able to see the absence of spurious velocities I included a tiny correction term in the de nition of the momentum that ensures that the total momentum of the system does not change. Also my implementation of the algorithm turned out to be unstable so I added a small amount of numerical viscosity by multiplying a velocity by (1 0:001) and adding 0.00025 times the velocity of the four nearest neighbors. This rendered the simulations stable.

4. Conclusions

I proved that spurious velocities in one particular lattice Boltzm ann im plem entation are caused by non-compatible discretizations of the driving forces for the order-parameter and momentum equations. The dimension discretization errors for the Forces compete and drive the spurious currents. I believe that the same argument holds for all lattice Boltzm ann methods that exhibit spurious velocities. These spurious velocities can be avoided by ensuring that the discretizations of the driving forces are compatible.
