Quasi-Particle States with Topological Quantum Numbers in the Mixed State of d-wave Superconductors

A bstract

We investigate the extended quasi-particle states in the mixed state of d-wave superconductors on the basis of the Bogoliubov-de G ennes equation. We prove that the quasi-particle eigen-states can be classi ed in terms of new topological quantum numbers which are related to the topological nature of the non-trivial phases of the quasi-particles. Num erical results for the quasi-particle eigen-states reveal the crossover behavior from gapless to gapped states as the ux density B increases. In the strong eld region quantum oscillations appear in the excitation energy of the quasi-particles.

1 Introduction

The quasi-particles in the mixed state of d-wave superconductors has attracted much attention in connection with the peculiar low-energy excitations under a magnetic eld in high- T_c cuprates [1, 2, 3, 4, 5, 6, 7, 8, 9, 10, 11]. In this paper we investigate the extended quasi-particle states in extremely type-II d-wave superconductors on the basis of the Bogoliubov-de Gennes (BdG) equation, focusing on the topological nature of the quasi-particles. It is well-known that the order parameter has a non-trivial phase in the presence of vortices, that is, the phase (r) is a multi-valued function satisfying the relation, r r (r) = 2 (r R_i) e_z , in the mixed state where vortices (k e_z) are located at R_1 ; R_2 ; $_{\rm N}$;RT hen, the BdG equation contains a multi-valued function, which makes the equation intractable. Anderson noticed that the phase (r) in the BdG equation can be eliminated in terms of a singular phase transform ation, by which the BdG equation is transformed into the one containing r (r) [7]. This is an important observation, because r (r) is a single-valued function, that is, the transform ed BdG equation includes only single-valued functions. However, it turns out, as shown in this paper, that the topological character of the system is not fully incorporated into the wave functions by this transform ation. One should note that a superconductor containing vortices m ay be considered as a multi-connected system. Then, the quasi-particles m oving around vortices show the AB e ect [11]. From this fact one understands that the wave functions of the quasi-particles should be path-dependent single-valued functions in the presence of vortices.

In this paper we clarify the topological character of the non-trivial phases of the wave functions satisfying the BdG equation and show that the quasi-particle eigen-states have a hidden" quantum number which is related to the hom otopy class of the classical orbits of the quasi-particles. We also develop a theoretical scheme for solving approximately the BdG equation in the eld region $H_{c1} = H_{c2}$, correcting the incom plete treatments for the topological singularity of (r) in previous works. Numerical solutions for the extended quasi-particle states in d-wave superconductors are brie y presented. It is shown that the gapless quasi-particle state changes to a gapped one with increasing the ux density. In the strong eld region quantum oscillations appear in the excitation energy.

2 Form ulation

Consider the BdG equation for a d_{xy} -wave superconductor,

with fA; Bg $\frac{1}{2}$ (AB + BA) [3]. In eq.(3) (r) is the phase of the gap function (r) and the second term is added for recovering the U (1)-sym m etry [12, 13]. In this paper we investigate the extended quasi-particle states outside the vortex cores in the eld region H_{c1} H H_{c2}, so that we may approximate the gap function as

neglecting the spatial dependence of the gap am plitude. In the case where N vortices (k z-axis) are located at R_1 ; N; in the xy plane, the phase in eq.(3) is dependent on the vortex positions, i.e., (r) = (r; R_1 ; N; Rand is a multi-valued function satisfying the relation,

To express the BdG equation in terms of only single-valued functions, removing the multi-valued function (r), Anderson proposed a transformation for the wave functions u and v in eq.(1) as follows [7],

This transform ation has been utilized by several authors for studying the low energy excitations in the mixed state of d-wave superconductors [9, 10]. On the other hand, Franz and Tesanovic pointed out that the phase can be eliminated also by the transform ation, $u ! e^{i_e}u ; v ! e^{i_h}v$, if $_e + _h = [8, 14]$. The phase factor e^i in eq.(1) can really be excluded from the BdG equation by these transform ations, but we claim that these manipulations should not be considered as the transform ations. Let us suppose that the wave functions in the N-vortex state, u (r); v (r), are expressed as

when the non-trivial phases in the wave functions are explicitly extracted. In eq.(7) is assumed to be a half and integer, namely, $= \frac{1}{2}$; $\frac{3}{2}$; . Note that the phases in eq.(7) satisfy the Franz-Tesanovic condition mentioned above ($_{e} + _{h} =$) and eq.(7) is also reduced to the Anderson's transform ation (6) for $= \frac{1}{2}$ if eq.(7) is considered as the transform ation, (u; v)! (u; v). Hence, it is clear that the phase factor eⁱ is eliminated in the equation for u; v. The new equation for u and v contains explicitly a number, so that the energy eigenvalues explicitly depend on . Furtherm ore, it turns out from the calculations show n later that the energy eigen-states can be classified in terms of . From these results one can interpret as a quantum number specifying the quasi-particle eigen-states in the N-vortex state. Then, a set of quantum numbers in eq.(7) is expressed as = (n;), where n denotes symbolically the other quantum numbers.

To be convinced of our statement, let us now study the topological character of the wave functions. We introduce the operator P (C) which moves a function along a path C [15]. Let us take a closed path C_i around the ith vortex at R_i for C. Suppose that C_i does not include any other vortices inside it (see Fig.1). Then, the operation of P (C_i) on the phase (r) induces the shift,

Suppose that the wave functions, u (r) and v (r), have non-trivial phases, u (r) and v (r), i.e., u (r) = v (r) $e^{i^{u}(r)}$ and v (r) = v (r) $e^{i^{v}(r)}$. Since u (r) and v (r) should be single-valued functions, we have in general

we obtain eq.(7). We can also show that the gap equation expressed in term softhe wave functions (7) yields

(r) for the phase of the order parameter (see Appendix A). Note that eq.(7) holds for N = 1, i.e., the single vortex state. As is well-known, the wave functions in the 2D single vortex state are expressed as

where (r;) is the polar coordinates [16], which indicates that the phase (r) is expressed in terms of the geometrical angle , i.e., (r) = , in this state and then (= $\frac{1}{2};\frac{3}{2};$) accords with the quantum number for the 2D angularm om entum, though in general is a topological one. Thus, our conjecture (7) is consistent with the well-known result in the single vortex state. Note that is still a rigorous quantum number in the system with a curved vortex, in which the angularm om entum is not conserved.

Let us now study the BdG equation (1), using eq.(7). In the present d-wave case we must be careful about the order of di erentiations in eq.(3), because $Q_x Q_y$ (r) $\in Q_y Q_x$ (r) in the vortex state [17]. To avoid the ambiguity in the order of di erentiations we symmetrize the di erential operations in eq.(3) as $Q_x Q_y e^{i(r)}$! $f Q_x; Q_y ge^{i(r)}$. Then, substitution of eq.(7) into eq.(1) yields

To perform explicit calculations we introduce an approximation in the following. We investigate the region $H_{c1} = H_{c2}$ in the extrem ely-type II superconductors of 1, i.e., L. In this eld region one can assume the relation, d_{L} , where d is the lattice constant of the ux-line-lattice. The spatial-dependent ux density in this region, B (r), can be split into the average value, B_{av} , and the deviation from it, B (r), i.e., B (r) = $B_{av} + B$ (r). Since the lattice constant d is much shorter than the London penetration depth L in this eld region, the vortex currents owing around vortices are heavily overlapped and, as a result, canceled out, which indicates the relation, j B (r) j β_{av} j. Consequently, the spatial-dependent term

B (r) is neglected in the 0th order approximation, B (r) B_{av} . In this paper we con ne ourselves to the lowest order approximation. Then, in this approximation we have the relation from the M axwell equation as follows,

where s(r) is the local super unid density. Since s(r) const. $\neq 0$ outside the vortex cores, one can assume $v_s' = 0$ in the present approximation. Then, noting eq.(18), we not the approximate relation,

where the vector potential A₀ (r) is related to the average ux density as B_{av} = r A₀ (r). Since A₀ (r) = (0;Bx;0) with B = $\beta_{av}j$ in the Landau gauge (B < H), we arrive at the explicit expression for the non-trivial phase as

Let us now solve the BdG equation, using the above approximation. Under the approximation eq.(16) can be rewritten in the 2D case as follows,

with p = ih@. Note that Q and P satisfy the commutation relation, [Q; P] = ih. Thus, the BdG equation is expressed in terms of only Herm it ian operators and is gauge-invariant. we remark that symmetrizing the dimension operations in eq.(3) is essential for obtaining the above physically-acceptable results. Now let us $q = \frac{1}{2}(a - a^y)$ and $P = \frac{h}{2}(a + a^y)$, noting the above commutation relation for Q and P. Then, eq.(25) is rewritten as

where ki is the kth Landau level, i.e., $a_{ki} = \frac{p_{kk}}{kk}$ li and $a_{ki} = \frac{p_{k+1}}{k+1}$ li. It is seen that the o -diagonal components in eq.(29) induce the m ixing between the Landau levels, that is, the Landau levels are not the eigen-states in the present d-wave case. Eq.(29) also indicates that the quasi-particle eigen-states in the m ixed state of 2D d-wave superconductors can be classified in terms of two quantum numbers, namely , which has the topological origin, and n, which is reduced to the Landau-level index in the norm al state ($_0$! 0). The quantum number is a rigorous quantum number in the m ixed state of type II superconductors, which is independent of approximations used in this paper. From the above results we nally obtain the coupled equations for the coe cients, n_{k}^{k} , as

3 Num erical results and discussions

Let us now present numerical solutions of eqs.(31) and (32) obtained by a numerical diagonalization m ethod. Fig.2 shows the positive energy eigen-values for the quantum numbers, $=\frac{1}{2};\frac{3}{2};\frac{5}{2}$. The parameter values in these calculations are chosen as "_F = 200 m eV, $_0 = 10$ m eV, and the free electron m ass m_e is assumed in the cyclotron frequency, i.e., $!_c = \frac{eB}{m_{e^c}}$. As seen in this gure, we have two quasi-particle eigen-states with nearly-zero eigen-values. These states appears in the case of h!_c = $_0$ in our calculations. The existence of the zero-energy state has been predicted in the approximate calculations in ref.[7]. These zero-energy states are form ed mainly by the quasi-particles lying in the nodal directions in the k-space. It is also seen that the two or four consecutive levels have close eigen-values in the low energy region. This result comes from that the state with index k does not couple with that with k + `of` 2 or` 4, as seen in eqs.(31) and (32). In Fig.3 we plot the energy eigen-values in the $=\frac{1}{2}$ band for three values of B. Note that the relation h!_c 0 holds in these cases, since h!_c 12m eV 0 for B = 10 T in the present choice of the parameter values. Then, the energy levels are essentially the same in this eld region, except that the dispersion becomes steeper as B increases.

To investigate the crossover behavior due to the variation of the ux density B from h! c n to $_0$ we calculate the lowest excitation energy as a function of B, choosing a small value for $_0$. Fig.4 h!_c shows the B-dependence of E_n with n = 1; $= \frac{1}{2}$ in the case of $_0 = 2 \text{ m eV}$. In this choice of the parameter values we nd h! $_{c} = _{0}$ for B ' 16T. As seen in this gure, the lowest energy eigen-state has zero-energy in the weak eld region of h!_c 0, but it abruptly changes to a gapped state above som e value of B, which indicates that the quasi-particle eigen-states acquire a full energy-gap in the strong eld region, though the symmetry of the gap function is the same as in the Meissner state. This result may be intuitively understood in the following way. The quasi-particles lying in the nodal directions with p_x pr cannot turn by the e ect of a weak Lorentz force when the pair-potential barrier is high. Then, in the weak led region the quasi-particle states in the nodal directions are expected to be gapless. However, in the strong eld region where the Lorentz force is strong enough, i.e., h! c 0. the quasi-particles in the nodal directions can run through the pair-potential barrier. In order to excite the quasi-particles going through the barrier of the pair-potential we need a nite excitation energy, which leads to a nite energy gap. It has been proved in the GL limit, in which the Landau-level splitting is completely neglected, that the dxy-component is induced in the m ixed state of $d_{x^2 y^2}$ -wave superconductors [19], which also creates fully-gapped quasi-particle states. However, the origin of the energy gap in the GL lim it is completely di erent from that in the present theory.

This result seems consistent with the experimental observation for the thermal conductivity in the mixed state [6]. In the strong eld region of $h_{c} > 0$, namely B > 16T in the present case, the lowest excitation energy shows oscillatory behavior in the B-dependence, as seen in Fig.4. These oscillations reject the eld dependence of the diagonal components of eq.(29), that is, they are the quantum oscillations which lead to the de Haas-van A lphen e ect. Thus, our theory for the extended quasi-particles in the mixed state of d-wave superconductors can describes the crossover behavior from the gapless phase in the weak eld region to the gapped phase showing the quantum oscillations in the strong eld region.

In summary we investigated the extended quasi-particle states of d-wave superconductors in the eld region, H_{c1} H H_{c2}, on the basis of the BdG equation. We found new topological quantum numbers which classify the quasi-particle eigen-states in the mixed state of type-II superconductors. The phase of a qausi-particle should be path-dependent in the presence of vortices, which is essentially the same as in a multi-connected system showing the Ahamnov-Bohm e ect. Hence, one understands that the quantum numbers carrying information about the hom otopy class of the orbit of the quasi-particle appear in the mixed state of type II superconductors. We also presented num erical solutions of the BdG equation in the eld region, H_{c1} H H_{c2}. It was shown that the quasi-particle states show the crossover behavior from gappless to gapped states as the ux density increases. In the strong eld region of h!_c > $_0$ the quantum oscillations appear in the excitation energy.

A Appendix

In this Appendix we derive the gap equation in the present d_{xy} -superconductors. The gap function in unconventional superconductors has generally the form ,

- [13] We assume that the BdG equation (1) is invariant under a trivial phase transformation, (r) ! (r) + (r), u (r) ! u (r) $e^{\frac{1}{2}i (r)}$, v (r) ! v (r) $e^{\frac{1}{2}i (r)}$, with (r) being a single-valued function.
- [14] In order to merely eliminate the phase factor in the BdG equation arbitrary functions are allowed for $_{e}$ (r) and $_{h}$ (r) as far as the condition $_{e}$ + $_{h}$ = is full led. In the Franz-Tesanovic transform ation the special phases are chosen for $_{e}$ and $_{h}$ as $_{e}$ (r) = $_{A}$ (r) and $_{h}$ (r) = $_{B}$ (r), where $_{A}$ (r) ($_{B}$ (r)) is the non-trivial phase coming from the vortices on the A-sublattice (B-sublattice) [8]. The wave functions derived in ref.[8], using the Franz-Tesanovic transform ation, does not show the correct AB e ect in the N-vortex state.
