# Instability of the rhodium magnetic moment as origin of the metamagnetic phase transition in -FeRh

Based on ab initio total energy calculations we show that two magnetic states of rhodium atoms together with competing ferrom agnetic and antiferrom agnetic exchange interactions are responsible for a temperature induced metamagnetic phase transition, which experimentally is observed for stoichiometric FeRh. Taking into account the results of previous and new ly performed rst-principles calculations we present a spin-based model, which allows to reproduce this rst-order metamagnetic transition by means of Monte Carlo simulations. Further inclusion of spacial variation of exchange parameters leads to a realistic description of the experimental magneto-volume e ects in -FeRh.

I. IN TRODUCTION




FIG.1: Left: Type II antiferrom agnetic ground state structure with a nonm agnetic R h atom at the center and Fe atom s with m om ents of 3:3  $_{\rm B}$  at the corner site. Right: Ferrom agnetic structure with Fe m om ents of 3:2  $_{\rm B}$  at the corners and R h m om ent of 0:9  $_{\rm B}$  at the center site.

In 1938 Fallot<sup>1,2</sup> discovered that ordered bcc Fe<sub>50</sub>Rh<sub>50</sub> undergoes a rst order m etam agnetic transition from an antiferrom agnetic (AF) ground state to a ferrom agnetic (FM ) phase with increasing tem perature. This transition occurs at T<sub>m</sub> 320 K and is accompanied by a volume increase of about 1%  $.^{3,4}$  The Curie tem perature  $T_{C}$  of the FM phase is of the order of 670 K.<sup>4,5</sup> In contradiction to the rst hypothesis of Fallot and H orcart,<sup>2</sup> X -ray di raction measurements showed that the transition is isostructural.<sup>6</sup> From Mossbauer and neutron di raction m easurem ents one knows that the FM phase has collinear magnetic moments of 3:2  $_{\rm B}$  per Fe atom and 0:9  $_{\rm B}$  per Rh atom .<sup>7</sup> At low tem peratures an AF-II spin structure is found with Fe m oments of 3:3  $_{\rm B}$  and with vanishing Rhm om ents (see Figure 1).<sup>8,9</sup> Application of hydrostatic pressure suppresses the FM phase, i.e. for a critical pressure of 60 kbar the system in m ediately transform s from the AF to the param agnetic (PM ) phase.

An early explanation for this behavior was based on the phenom enological exchange inversion model<sup>10</sup> by Kittel (which originally was designed to explain metam agnetic transitions in other materials like Cr-modied  $M n_2 Sb$  with a layered magnetic structure). In this model the exchange parameter varies linearly with the lattice constant and changes sign for a critical value a<sub>c</sub>. However, experimental ndings like the rather large entropy change  $^{3,4,11,12,13}$  at  $T_m$  , which is of the order of S(T<sub>m</sub>) 12:5 19:7 Jkg<sup>1</sup>K<sup>1</sup>, as well as elastic properties could not correctly be described.<sup>13</sup> Tu et al.<sup>14</sup> used a di erent approach by considering the large difference of the low-tem perature specic heat constants, , of the AF and the FM phases: M easurements sug-59  $62:5m J kg^{1} K^{2}$  is about four to gest that FM six times larger than  $_{\rm AF}$  10:5 16m J kg  $^{1}$  K  $^{2}$   $.^{14,15}$ Based on these observations, Tu et al. explained the transition by a change in entropy of the band electrons between the AF and the FM phases. An estimation of the free energy shows that these contributions have the right order of magnitude to explain the AF (FM transition, if one assum es that the electronic densities of states

at the Ferm i level do not vary considerably from low tem peratures up to the transition. However, since the FM phase cannot be stabilized at low tem peratures for stoichiom etric FeRh, FM has been measured in slightly more iron-rich alloys. W ith respect to the strong sensitivity of the magnetic phase diagram to small departures from stoichiom etry,<sup>16</sup> one may doubt that the low temperature specic heat can be considered to be independent of concentration.<sup>17,18</sup> A further drawback considering the explanation of Tu et al. arises from the fact that adding 5% Iridium boosts AF by alm ost an order of magnitude to a value of  $A_F = 101 \text{ m Jkg}^{-1} \text{ K}^{-2}$ : The compound Fe49:5Rh45:5Ir5 also undergoes a m etam agnetic transition with  $T_m$  shifted to higher tem peratures.<sup>3</sup> Since the relation between  $_{AF}$  and  $_{FM}$  is reversed in this material, the previously sketched explanation cannot be applied to this case.

In 1992 M onuzzi and M arcus perform ed ab initio calculations using spin polarized density functional theory (DFT) in the fram ework of the local density approxim ation (LDA) and the augmented spherical wave (ASW) form alism  $.^{18,20,21}$  They calculated the total energy of FeRh as a function of volume for di erent m agnetic structures. They found that the AF-II spin structure is the ground state, whereas the FM structure is another stable

solution with higher energy and a larger volum e. For the moments they obtained  $_{Fe} = 2.98 _{B}$ ,  $_{Rh} = 1.02 _{B}$  (AF phase) and  $_{Fe} = 3.15 _{B}$  (FM phase), in agreement with experimental results.

In this work, we present further ab initio total energy calculations of stoichiom etric -FeRh using the ASW form alism and the generalized gradient approximation (GGA).<sup>22</sup> The corresponding code also allows to evaluate noncollinear alignment of spins (see Ref. 23 and references therein). For many cases LDA gives a reasonable description of the ground state properties of solids. How ever, in som e cases it predicts the w rong ground state as e.g. for iron<sup>24</sup>. For Fe, the hcp structure is found to be 10 m Ry lower in energy than the bcc phase. Because FeRh has also a bcc ground state lattice structure (unlike pure Rh), it is necessary to go beyond LDA by using GGA.W e have considered di erent possible m agnetic ground state structures presented in section II. Based then on the speci c energetic order of resulting energy versus volum e curves, we discuss a new mechanism for the tem perature driven m etam agnetic transition in FeRh. In contrast to prior explanations, our model does not rely on ground state properties or low tem perature data alone. Instead, we propose that therm al excitations at nite tem peratures are the driving force for the transition. This is demonstrated in section III on the basis of M onte C arlo simulations of an Ising-type spin m odel, showing that a competition between AF Fe-Fe exchangeinteractions and a nonm agnetic R h state on the one hand and FM Fe-Rh interactions on the other is su cient to explain the metam agnetic transition of FeRh. Inclusion of spatial degrees of freedom (section IV) by adding pair potentials and assuming a linear variation of the exchange parameter with the lattice parameter proves that this model explanation is in accordance with the ab initio data and leads furtherm ore to a nearly quantitative description of experim ental details.




FIG. 2: Total energy and magnetic moment versus atom ic volume as obtained by ab initio calculations (present work).

# II. AB IN IT IO TOTAL ENERGY CALCULATIONS

W e have perform ed ab initio calculations by using the ASW -method<sup>26</sup> and GGA. Relativistic e ects are included in the scalar relativistic approximation. The basiswave functions of Fe and Rh atom s include spd and f states which are su cient to obtain the correct magnetic behavior of -iron. We assume that the AF like spin structure can best be described by a spin-spiral (Ref. 23) with wave vector (0:5;0:5;0:5) in units of 2 = a. As rst step, we optimized the volume of the AF-II state with equal A SA -radii for both types of atom s. For the resulting equilibrium volume, the total energy is then m in im ized with respect to the ratio of the ASA-spheres leading to  $r_{Rh}=r_{Fe}=1:15$ . In order to investigate the inuence of the Rhm om ent in the FM phase we have also used the xed spin m om ent m ethod<sup>23</sup> to restrict m  $_{Rh}$  to zero. Table I contains the calculated equilibrium properties for AF-II and FM phases which are in fair agreem ent with previous calculations. Com pared to previous nonrelativistic A SW LDA calculations (Monuzziet al.<sup>18</sup>), we obtain equilibrium volum eswhich are about 1-2% larger, being typical for GGA. In contrast to the cases of pure iron<sup>27</sup> and FeN i Invar alloys<sup>28</sup>, the magnetic energy differences are only slightly in uenced by the gradient corrections. A lso, no evidence was found that a noncollinear structure could be lower in energy than the previously found collinear AF and FM spin arrangem ents. With respect to the density of states at the Ferm i level our results com pare better with results of Szajek et al.<sup>25</sup> than with results of Ref. 18. Since the latter results were obtained by using LDA ASW (with a spd basis), we conclude that the density of states at the Ferm i level is very sensitive to com putational details. The values obtained for the bulk m oduli,  $B_{AF}$  and  $B_{FM}$ , are lower com pared to those of Ref. 18 (where  $B_{AF} > B_{FM}$  was obtained in contrast to  $B_{FM} > B_{AF}$  in Ref. 25).

The calculated total energy curves are shown in Fig.2. The large energetic di erence between the usual FM phase and the hypothetic FM phase with zero rhodium moment implies that a nite Rh moment plays an important role for the stability of the FM phase. It seems unlikely that a magnetic eld at the Rh sites induced by the surrounding iron atom s is responsible for the appearance of a Rhm om ent in the FM phase, as was proposed in previous discussions. However, a strong ferromagnetic exchange interaction between the Rh and the iron atom s that overrides an antiferrom agnetic exchange between next nearest neighbor iron sites, would explain how the existence of a Rh m om ent can help to stabilize the FM phase. We have evidence as shown in the following sections, that a competition between a low lying nonmagnetic Rh state and another one with higher energy and nite m om ent (w hich can bene t from exchange with ferrom agnetic iron neighbors) is the main reason for the m etam agnetic transition.

#### III. A SPIN-ANALOGOUS MODEL

In order to con m our hypothesis we have constructed a model being suitable for an exam ination of the metamagnetic transition at nite tem peratures. The sim plest way to do this is by means of M onte Carlo simulations with a localized spin model. To keep the model tractable, we neglect spin wave excitations and restrict ourselves to Ising spins. This is justi ed because the transition takes place between two ordered structures and both phases have collinear spin structures. For a description of the nonm agnetic R h state in addition to the m agnetic Fe and Rh states, we chose a spin-1 Ising model, where the spin variables can take the values  $S_i = 1;0;+1$ . The spins are located on a bcc lattice with nearest and next nearest neighbor interactions. Depending on their positions, we distinguish between Fe or Rh sites, where each type occupies a simple cubic sublattice, corresponding to an ordered equiatom ic alloy. The interaction param eters depend then on the type of sites involved. This situation can be described by the following Hamiltonian,

W ithout the assumption of di erent types of atoms, Hamiltonian (1) is also known as the Blume-Capel model.<sup>29,30</sup> The rst term separates the nonmagnetic

 $S_i = 0$  and the magnetic  $S_i = -1$  states. For Fe we choose a large positive value in order to suppress the  $S_i = 0$  state. For R h we choose a negative value leading to a nonmagnetic ground state. The second term contains the exchange param eters Jik which depend only on the type of atom s located at the sites i and k. In the case of ordered equiatom ic FeRh, we have only three different parameters:  $J_{\rm FeFe}^{nnn}$  ,  $J_{\rm FeR\,h}^{nn}$  and  $J_{R\,hR\,h}^{nnn}$  . The  $\;$  rst one is chosen to be negative in order to accomplish an AF ground state. The second is taken to be large and posit ive as outlined in the previous section. The third one, for the sake of sim plicity, is set equal to zero. The choice for  $J_{FeFe}^{nnn}$  is xed by the Neelten perature  $T_N$  of the AF phase assuming that no transition to a FM phase takes place.  $T_N$  can be determined from the P-T phase diagram by extrapolating the transition line between AF and PM phases (occurring at pressures larger than 6GPa) to zero pressure.  $J_{\rm FeR\,h}^{nn}$  and D  $_{\rm R\,h}$  have been chosen to yield realistic values for  $T_{\rm C}\,$  and  $T_{\rm m}$  , respectively. The values of param eters used in the simulations are given in Table II.

## A. Details of com putation

The evaluation of therm odynam ic properties of (1) is done on the basis of M onte C arb simulations according to the M etropolis schem e<sup>31</sup> using a sequential update. Interesting quantities like m agnetization orm agnetic m om ent are computed and sum m ed up every 10 to 20 lattice sweeps, which ensures that the evaluated lattice con gurations are su ciently uncorrelated. Furtherm ore, we discard the rst 20 000 lattice sweeps in order to allow the system to reach therm al equilibrium before com puting averages. In order to speed this up, we have also used the nal con guration of the last run to initialize the simulation for the next tem perature. Simulations which involve a phase transition are perform ed twice, with increasing and decreasing tem peratures, in order to assure that therm al equilibrium has been reached.

The computed AF and FM phases are metastable, i.e. they are separated by a large energy barrier, which arises from the fact that in the transition states a considerable amount of FM domains have to be created in the AF phase and vice versa. So the standard algorithm is unlikely to overcom e this barrier and as a result the metamagnetic transition might not be seen at all. Instead the phases have to be overheated or undercooled before transforming, which results in a large hysteresis or irreversible behavior which makes it di cult to obtain reliable inform ation about the transition point. Therefore, it is necessary to modify the algorithm in order to allow for a direct jump to the other phase by circum venting the energy barrier with a global update step, where all spins will be updated at once. This algorithm ideally connects equilibrium con gurations of the AF phase directly with equilibrium con gurations of the FM phase while ensuring that the entropy di erence between the states is correctly reproduced. This can be done by choosing a unique mapping between lattice con gurations of the AF and FM phases, respectively. Or, more general, the selection probability of a speci c target con guration must be the same as the selection probability of the previous start con guration in the backward direction.

Since it is a priori not clear how equilibrium con gurations will look like at nite temperatures, we simply use an update scheme which connects the ground state con gurations of both phases and thus works at least at low temperatures. In the vicinity of the transition temperature, this algorithm might not reproduce equilibrium states for the trial con guration, because nature and am ount of excitations are presumably di erent in both phases. Since o -equilibrium means that most of the trial states are too high in energy, the probability that the trial state is by chance close enough to an equilibrium state to be accepted, decreases for larger system sizes.

In order to obtain a trial con guration, we divide the system into Rh and Fe sublattices. The Fe sublattice is again divided into two sublattices according to spin up and spin down positions (see Fig. 1). For each of these sublattices, it is decided random by (with probability 1=2), whether the corresponding sublattice is ipped as a whole. For the Rh sublattice another random num ber decides whether the spin values  $S_i 2 f 1;0;+1q$  are rotated clockwise or counter-clockwise (i.e. 1 becomes 0, 0 becom es + 1, + 1 becom es 1, or vice versa). So, each trial con guration is chosen with the same probability. A fterwards the energy dierence H between the present and the previous con guration is computed and the new con guration is accepted with probability m in  $(\exp(H = k_B T); 1)$  assuring detailed balance. This global update step is perform ed after each com plete lattice sweep.

W e perform ed for each tem perature between 100000 and 1000000 (around  $T_m$ ) lattice sweeps for di erent linear system sizes L = 6 to 16. How ever, our globalupdate schem e does only show a m etam agnetic transition w ithin reasonable simulation times up to a system size of L = 10. Looking for a di erent way to determ ine the transition point which would also work for larger system sizes, we estim ate the free energy by integrating the speci c heat,

In the computation we t the simulated results for the speci c heat divided by temperature, C=T, and the internal energy E with 10th order polynom ials, which can




FIG.3: AF order parameter (diamonds) and magnetization (circles) as a function of temperature. The magnetization is obtained by multiplying the spin values with a value of 3:0  $_{\rm B}$  for Fe and 1:0  $_{\rm B}$  for Rh before averaging. The simulated system size is L = 10.

be integrated analytically. For the system characterized by the H am iltonian (1), we neglect the entropy contribution at zero tem perature S (0), since the ground state spin structure in both phases is nondegenerate except for system s with spin inversion symmetry. Furtherm ore, concerning the estimation of the free energy nite size e ects are not expected to a ect the results, since phase transitions are not encountered during these simulations. For the rest of the calculations a comparison of the results for smaller and larger system s sizes (as can be seen in the upcoming gures) reveals that the main issues of this paper are also not a ected by the restricted system sizes.

## B. Computational results




FIG.4: M ean m agnetic m om ent of the R h atom s.

The order parameter of the AF phase is the staggered magnetization for the AF-II spin structure, i.e. the sum (of the absolute values) of the staggered m agnetizations of the two simple cubic sublattices that constitute the bcc lattice structure. The staggered m agnetization of a sim ple cubic (NaCl) lattice is de ned as sum of spins multiplied with a sign which alternates depending on whether the corresponding spin occupies a Na or a Clposition. The order parameter of the FM phase is given by the magnetization of the lattice. The variation of both order param eters with tem perature is shown in Fig. 3 for a system of size L = 10. At low tem peratures the staggered m agnetization approaches a m axim um value of 0:5 due to the fact that the Rh sublattice has no moment (Fig. 4) and therefore does not contribute to the sum. At  $T_m = 268 K$  the staggered magnetization abruptly drops to zero, whereas magnetic moment and magneti-

zation increase close to their saturation values. Above  $T_{\rm C}$  = 610K ferrom agnetism breaks down and the system becom es param agnetic. At the same time, the average m om ent of the R h atom s falls down to a value of 0.2  $_{\rm B}$ . This is also the reason, why the decrease in the m agnetization appears unusually sharp. From the data, a phase transition of second as well as of rst order seems to be possible. A coordingly, it is known that for negative values of D the B lum e-C apelm odel can show both kinds of phase transitions separated by a tricritical point in the T -D-plane. $^{32,33,34}$  H ence in order to safely determ ine the nature of this phase transition further calculations are necessary.




FIG.5: Speci c heat as a function of tem perature for the FM and the AF phases (L = 16) and for simulations on smaller lattices using the global MC step (L = 10). Inset: The speci c heat of the AF and FM phase between 0 and 500 K. C learly visible is a Schottky-type enhancement below 300 K in the FM phase, which is responsible for the metam agnetic transition. The sharp peak around 270 K corresponds to the metam agnetic transition, which is observed in the small system due to the global MC step.

A close look at the speci c heat (Fig. 5) helps to explain the occurrence of a metam agnetic transition. At rst sight it seems as if the specic heats of FM and AF phases do not di er very much below 350K. Above this tem perature the specic heat of the AF phase increases m ore rapidly with tem perature until around 570K the overheated AF phase is not stable anymore in the sim ulations and transforms to the FM phase. However, the inset shows that starting around 100K the speci cheat of the FM phase is enhanced com pared to the AF heat. W e explain this enhancem ent by a Schottky-type anom aly which adds up to the excitations from spin ips. Schottky anomalies are observed in systems with two levels separated by a sm all energy barrier. In fact a crossover from magnetic to nonmagnetic Rh atom s is conform with this picture. In the FM phase the Rh atom s have a mom ent being ferrom agnetically aligned to the Fem om ents, because the loss of the moment would correspond to an energy loss of eight times the exchange constant. This amount is diminished by the energy gain due to the  $D_{Rh}$  $J_{FeR\,h}^{nn}$  but larger than term, which is smaller than 8  $J_{FeRh}^{nn}$  , since the ground state is otherw ise not antiferrom agnetic. Increasing uctuations of the magnetization of the Fe sublattice cause this energy di erence to de-




FIG.6: Free energy of the FM and AF phases obtained by integrating C=T, with the transition point at  $T_{\rm m}~=~266\,K$  .

crease and nally lead to a breakdown of the average Rh m om ent at  $T_{\rm C}$ . In the AF phase m agnetic Rh atoms can be excited at the expense of the energy D $_{\rm Rh}$ . There is, however, no gain in energy due to the exchange interaction, since the contributions from the AF Fe atoms cancel at the Rh site. This corresponds to a much larger energy di erence between m agnetic and nonm agnetic Rh states com pared to the FM phase and does not lead to an appreciable contribution to the speci c heat.

This view is further supported by a comparison of the free energy of both phases shown in Fig. 6: The curves intersect at T 266K, which is in excellent agreem ent with the simulated  $T_m = 268 \text{ K}$ . This accuracy could be achieved, because the data for the speci c heat obtained from the simulations have only little spread and the tted curves interpolate the data points perfectly. From the di erence between the internal energies of both phases at the transition point, the entropy jump at  $T_m$  is determined to  $S(T_m) = 52 J K g^1 K^1$ , which is only 30 to 45% of the experimental values (but of the right order of m agnitude). But, one has to bear in m ind that with the choice of an Ising model we neglected the possibility of non-collinearm om ents. For the Rhm om ents this can only occur in the FM phase, and would therefore contribute to  $S(T_m)$ . A second point is that the weight of the  $S_i = 0$  state is the same as for each magnetic state  $S_i = 1$ . This is a natural choice for the spin-1 Ising model; but for the real system this is somehow arbitrary, because we have no inform ation about the electronic origin of both Rh states.

#### IV. AN EXTENDED MODEL

Since the simple spin Ham iltonian (1) can reproduce a metam agnetic transition as observed in -FeRh, it remains an interesting question whether other outstanding properties of this alloy, as the large volume increase at  $T_m$ , can also be explained. Furthermore, it has still to be proven whether our spin analogy is a good approximation to the ab initio results in the sense that it has comparable low temperature properties. In order to check this we have to extend (1) for a description of elastic and magneto-volume properties:

For V  $(r_{ik})$  we use simple pair potentials of the Lennard-Jones type:

Since in general the lattice structure of a Lennard-Jones system is closely packed, two di erent pair potentials for nearest and next-nearest neighbors have to be used in order to stabilize the bcc structure. The potentials, how - ever, do neither distinguish between di erent atom types nor between the di erent spin states, as has been done in previous simulations of related m aterials like Fe-N i Invar or Y (M n<sub>x</sub> A l<sub>1</sub> x )<sub>2</sub>.<sup>35,36</sup> The use of Lennard-Jones potentials is far from being optim um form etals, but has num erical advantages that enable us to speed up the calculations substantially. It is then su cient to choose the

param eters so that basic elastic properties like low tem perature lattice constant, bulk modulus or therm al expansion are reproduced.

A nother change com pared to (1) is that the exchange param eter is now taken to be a function of interatom ic distance. For sim plicity, we assume a linear distance dependence:

$$J_{ik}(r_{ik}) = J_{ik} + \frac{QJ_{ik}}{Qr}r_{ik}$$
 (5)

The values for  $J_{\rm ik}$  which we take in the extended calculations are roughly the same as in Table II. The relation between the derivatives of  $J_{\rm FeR\,h}^{nn}$  and  $J_{\rm FeFe}^{nnn}$  with respect to the interatom ic distance was determ ined by the relation of the pressure derivatives of the Curie and Neel tem – peratures, respectively, which have been obtained from the experimental phase diagram by assuming a linear dependence between  $\ell J_{\rm ik}$ = $\ell r$  and  $\ell T_{\rm C,N}$ = $\ell p$ . The absolute values have been adapted to reproduce the volume j jump at  $T_{\rm m}$ . An exchange interaction of this form has also been used to describe m agneto-volum e e ects in Fe-N i Invar. $^{37,38,39}$  In this case, the derivative of the exchange constant  $\ell J_{\rm ik}$ = $\ell r$  was a factor of 2 to 20 larger than in the present work. The values of parameters are sum marized in Table III.

## A. Details of com putation

For the evaluation of Hamiltonian (3) we use a textbook isotherm al-isobaric M onte Carlo m ethod (e.g. Ref. 40) consisting of alternating spin and position updates for each atom and a global volum e update step after nishing each lattice sweep. This algorithm has been used by the the authors in previous calculations and is explained in detail in the corresponding references. 35,36,41 In order to simulate the metam agnetic transition, an additionalglobalspin update step has to be introduced. W e use the same algorithm as described in the last section for the spin system in connection with a simultaneous volum e adaption. Since the latter reduces the acceptance probability considerably, the global update scheme has to be repeated several thousands of times. It is not practicable to use a new spin con guration for each trial step, because the evaluation of the energy is comparatively




FIG. 7: Internal energy and m om ent as a function of the atom ic volume obtained for H am iltonian (3) at T = 4K. The simulations have been performed for xed spin structures as well as for a freely relaxed spin system.

time consuming. On the other hand, the new energy after solely rescaling the volume can be calculated very quickly, since due to the use of Lennard-Jones potentials the energy can be written as a function of integral pow – ers of the lattice parameter. Therefore, we choose a trial spin con guration as described before and compute the new energy. Then we attempt a previously xed number N of M etropolis steps, each with a new ly chosen volume. If one step is accepted, we continue with the original spin con guration as trial system (and so on) until N steps have been m ade. Since the number of trial steps N has been previously xed, detailed balance is still valid.

We have performed simulations with system sizes of L = 6 to 12. A direct metamagnetic transition could only be seen for system sizes up to L = 8. The simulation time ranged from 120000 up to 1000000 lattice sweeps around  $T_m$  with values from 1000 to 10000 for N . As before we estimated G ibbs' free energy for zero pressure by integrating the speci c heat according to Eq. (2).

## B. Computational results

For a comparison of our model properties with the results of ab initio calculations, we calculated in isochoric simulations the energy as a function of the volume at low temperatures for dierent xed spin structures (Fig. 7). Here, we cooled a system of size L = 16 exponentially down from 100K down to 4K. We ind good agreement with the results of Fig. 2 in the sense that the order of magnetic phases is similar. A lthough the ab initio to-




FIG.8: AF order parameter (diamonds) and magnetization (circles) as a function of temperature as obtained for the extended model H am iltonian (3). The system size is L = 8.




FIG. 9: Mean magnetic moment of the Rh atoms for the extended model (L = 8).

talenergy di erences are som ew hat larger, this indicates that our model H am iltonian (3) is a qualitatively correct description of the mechanism s leading to a metam agnetic transition in FeR h.

As in the simple model without volume-dependent terms, we nd an abrupt increase of the magnetization in combination with a discontinuous decrease for the staggered magnetization with increasing temperature (Fig. 8). Consequently the mean moment at the Rh sites (Fig. 9) also raises sharply around the metam – agnetic transition temperature of  $T_m = 322$  K. A round the Curie temperature T = 720 K the magnetization decreases more smoothly than for the simple model. This may be due to the enhancement of the ective exchange




FIG. 10: Volume per atom plotted over temperature as obtained for the AF and FM phases (L = 12) and by our simulations with the global update scheme (L = 8).




FIG.11: A diabatic bulk m odulus as a function oftem perature for the AF and FM phases (L = 12) and with the global update scheme (L = 8). The latter data, which show the m etam agnetic transition, reveal a very large softening of the lattice around  $T_{\rm m}$ .

parameter given by Eq. (5) which is caused by the lattice expansion.

As expected from the low temperature calculations, the volume of the AF phase is smaller than the volume of the FM phase throughout the stability range (Fig.10). For the freely uctuating system a volume jump of 0.8% occurs at  $T_{\rm m}$ . Below  $T_{\rm C}$  the volume expansion is reduced in the FM phase, which is in qualitative agreement with experiment  $^{4,42}$ .

The bulk modulus  $B_S$  of the AF phase is about 6% larger than the FM bulk modulus throughout the stabil-




FIG.12: Specic heat for the extended m odel as a function of tem perature for FM and the AF phases (L = 12) and for simulations on smaller lattices using the global M C step (L = 8). The relationship between the specic heats of AF and FM phases below 400 K is shown in the inset.

ity range (Fig. 11). Around  $T_{\rm m}$  and  $T_{\rm C}$  we nd a considerable weakening of the material which is caused by the magneto-volum e anom alies. The values for  ${\rm B}_{\rm S}$  at low tem peratures can be estim ated m ore accurately by using a polynomial t to the E-V curves in Fig. 7. We nd  $B_{S} = 231 \text{ GPa}$  for the AF phase and  $B_{S} = 217 \text{ GPa}$  for the FM phase. These values are in good agreem ent with results of isobaric calculations shown in Fig. 11. Com pared with the results of ab initio calculations (Table I) the absolute values are too large, whereas these calculations do not give a unanim ous prediction for the sign and the magnitude of the dierence  $B_{\rm S}$  (with respect to the magnetic structures). Experimental measurements<sup>4</sup> of Young modulus suggest that the bulk modulus of the AF phase should in fact be lower than in the FM phase. The modulus of the AF phase, however, has only been estim ated in the vicinity of  $T_{\rm m}$  , where a weakening of the m aterial (as a precursor of the transition) is present (as in our simulations).

The specic heats obtained for the extended model (Fig. 12) resemble the ndings for the spin-only H am iltonian (1), except that now additional contributions due to atom ic displacements are included. This shows that the proposed explanation of the metam agnetic transition is still valid. Since the H am iltonian (3) does not contain any kinetic terms, the low temperature value of the specic cheat is only half of the D ulong-Petit lim it of 3R, where R is the kinetic gas constant.

#### C. Estim ation of G ibbs free energy

The calculation of G ibbs free energy G for the model with classical motion (3) is more complicated than in the




FIG.13: D i erences of internal energies and G ibbs free energies for FM and AF phases obtained by integrating  $C_p=T$ . The transition point is  $T_m = 324 \, \text{K}$ . The experimental data have been obtained by integrating over the hysteresis loop for di erent temperatures.<sup>17</sup>

spin-only case (1). First of all absolute values of G cannot be given, since the speci c heat at zero tem perature is nite and the resulting entropy would diverge. But since the limit for T ! 0 of  $C_p$  is 1.5 R and hence the sam e for allm agnetic structures, di erences of free energies can be computed. In contrast to the previous section, the entropy contribution at zero tem perature S(0)must be considered. As before a contribution from the magnetic system can be neglected, while we have to account for the di erences in the elastic properties of FM and the AF phases. Since we only need the entropy at zero tem perature, we choose an ensemble of harm onic oscillators as an approximation for our spatial degrees of freedom, neglecting the anharm onicity of the potentials and the coupling of the oscillators. Dierentiating the free energy obtained from the logarithm of the partition function leads then to a simple expression for the entropy di erence,

$$S = \frac{3}{2}N k_B \ln (k_{AF} = k_{FM});$$
 (6)

where  $k_{AF}$  and  $k_{FM}$  are the force constants of the harmonic potentials which are estimated from the curvature of the ground state energy (versus lattice parameter) curve. For the entropy di erence we obtain then: S(0) = 9:17 Jkg<sup>-1</sup> K<sup>-1</sup>. Taking this into account, we achieve again a rather good value for  $T_m$ . From the differences of internal energies at  $T_m$  we obtain for the entropy jump at the transition  $S(T_m) = 15:9 Jkg^{-1} K^{-1}$ , which is within the range of experimental results. Com – parison of the calculated free energy with experimental values for G shows excellent agreement. The experimental values have been obtained by a graphical integration of the magnetic eld expressed as a function of the m easured m agnetization.<sup>17</sup> Extrapolation of experim ental values to zero tem perature shows that the energy di erence E (0) between the AF and FM phases ism uch better described by ourm odelparam eters than by ab initio results, since the latter show that E is one order of m agnitude too large. This discrepancy has already been noticed by M oruzzi and M arcus<sup>20</sup> who relate this to the om ission of zero point energy corrections in their total energy calculations.

## V. CONCLUSIONS

W epropose on the basis of new ab initio results a mechanism for the metam agnetic transition in FeRh at nite tem peratures. In contrast to previous explanations, our model does not rely on a large di erence between the low temperature specic heat constants of both phases. These are expected to be sensitive to external in uences as both experim entalm easurem ents and band structure calculations suggest, so that it seems im plausible that a constant contribution of the given magnitude might survive up to room temperature. Instead, we propose that the existence of two magnetic states of Rh atom s connected with competing FM Fe-Rh and AF Fe-Fe exchange interactions are at the origin of the m etam agnetic transition. The magneto-volume e ects can simply be explained on the basis of distance dependent exchange parameters. The applicability of this mechanism to the Fe-Rh problem has been veried by M onte Carlo m odel calculations, showing that a metam agnetic transition of the desired kind does in fact occur and, by extending the model, magneto-volume e ects and other experimental properties can be su ciently well described.

As we have pointed out, our explanation is in agreem ent with existing experim ental data. How ever, a further check of our model would be a comparison with (non-existing) speci c heat data from above  $T_C$  down to very low tem peratures for both, the AF and FM phases. From this one could then estim ate the magnetic contribution by subtracting the lattice part within the Debye approximation, the electronic part and the contribution by the anham onicity of the potentials.43,44 So far, the specic heat has only been determ ined in the range from 100K to 500K and only for the nearly stoichiom etric Rh-rich alloy.<sup>45,46</sup> System atic measurements on the Ferich side with a FM ground state and m easurem ents under pressure, suppressing the metam agnetic transition would yield information whether a Schottky-type excitation plays an important role, which should show up around 200K in the magnetic contribution to the speci c heat of ferrom agnetic sam ples.

M onte C arlo simulations with applied pressure are left for future work, since with increasing pressure and hence increasing  $T_m$  a reliable estimation of the transition tem – perature is rather di cult and requires an improvement of the global MC step. First tests, how ever, show ed that the location of the phase boundaries under pressure is in

su cient agreem ent with experim entaldata for pressures below 20 kbar and above 40 kbar, where the m etam agnetic transition is com pletely suppressed. The tricritical point, if one exists, should be located som ewhere between 20 kbar and 40 kbar for the param eters used here.
