A bstract. We apply statistical mechanics to an inverse problem of linear mapping to investigate the physics of the irreversible compression. We use the replica symmetry breaking (RSB) technique with a toy model to demonstrate the Shannon's result. The rate distortion function, which is widely known as the theoretical limit of the compression with a delity criterion, is derived using the Parisi one step RSB scheme. The bound can not be achieved in the sparsely-connected systems, where suboptim al solutions dominate the capacity.

Statistical physics and inform ation science m ay have been expected to be directed tow ards com m on objectives since Shannon form ulated an inform ation theory based on the concept of entropy. However, envisaging how this actually happened would have been di cult. The situation has greatly been changed since the eld of disordered statistical system s was m aturely established [1]. The areas where these relations are particularly strong are Shannon's theory [2] and the replica theory on classical spin system s with quenched disorder [3]. Triggered by the work of Sourlas [4], these links have recently been exam ined in the area of error corrections [5, 6], network inform ation theory [7], and turbo decoding [8]. Recent results of these topics are mostly derived using the replica trick.

However, the research in the cross-disciplinary eld so far can be categorized as a so-called 'zero distortion' decoding scheme in terms of information theory: the system requires perfect reproduction of the input alphabets [2]. Here, the same spin glass techniques should be useful to describe the physics of systems with a delity criterion; i.e., a certain degree of information distortion is assumed when reproducing the alphabets. This framework is called the rate distortion theory [9, 10]. Though processing information requires regarding the concept of distortions practically, where input alphabets are mostly represented by continuous variables, statistical physics only employs a few approaches based on highly modi ed perceptrons [11].

In this paper, we introduce a simpli ed model that achieves the optim ality, only using parity checks like the Gallager's code [12]. We, then, can easily see how inform ation distortion can be handled by the concepts of statistical physics. More speci cally, we study the inverse problem of a Sourlas-type decoding problem by using the fram ework of replica sym metry breaking (RSB) of diluted disordered systems [13]. A coording to our analysis, this toy model provides an optim al com pression scheme for an arbitrary distortion level, though the encoding procedure remains an NP-com plete problem without any practical encoders at the moment.

The paper is organized as follows. We rst review the concept of the rate distortion theory as well as the main results related to our purpose. We then introduce

a toy model. Finally we obtain consistent results with information theory. Detailed derivations will be reported elsewhere.




Figure 1. Rate distortion encoder and decoder

We start by de ning the concepts of the rate distortion theory and stating the simplest version of the main result. Let J be a discrete random variable with alphabet J.A ssume that we have a source that produces a sequence  $J_1; J_2; M$ , where each symbol is random by drawn from a distribution. We will assume that the alphabet is nit. Throughout this paper we use vector notation to represent sequences for convenience of explanation:  $J = (J_1; J_2; M)^T J_2 J^M$ . Here, the encoder describes the source sequence  $J \ge J^M$  by a codeword  $f = f(J) \ge X^N$ . The decoder represents J by an estimate  $\hat{J} = g() \ge J^M$ , as illustrated in Figure 1. Note that M represents the length of a source sequence, while N represents the length of a codew ord. In this case, the rate is defined by R = N = M. Note that the relation N < M always holds when a compression is considered; therefore, R < 1 also holds.

A distortion function is a mapping d : J  $\hat{J}$  ! R<sup>+</sup> from the set of source alphabet-reproduction alphabet pairs into the set of non-negative real numbers. Intuitively, the distortion  $d(J;\hat{J})$  is a measure of the cost of representing the symbol J by the symbol  $\hat{J}$ . This de nition is quite general. In most cases, however, the reproduction alphabet  $\hat{J}$  is the same as the source alphabet J. Hereafter, we set  $\hat{J} = J$  and the following distortion measure is adopted as the delity criterion; the H amming distortion is given by

$$d(J;\hat{J}) = \begin{pmatrix} 0 & \text{for } J = \hat{J} \\ 1 & \text{for } J \notin \hat{J} \end{pmatrix}$$

which results in a probable error distortion, since the relation  $E[d(J; \hat{J})] = P[J \in \hat{J}]$ holds, where E[] represents the expectation and P[] the probability of its argument. The distortion measure is so far dened on a symbol-by-symbol basis. We extend the denition to sequences. The distortion between sequences  $J_{i}\hat{J}^{2} = J^{M}$  is dened by  $d(J; \hat{J}) = (I=M) \int_{j=1}^{M} d(J_{j}; \hat{J}_{j})$ . Therefore, the distortion for a sequence is the average distortion per symbol of the elements of the sequence. The distortion associated with the code is dened as  $D = E[d(J; \hat{J})]$ , where the expectation is with respect to the probability distribution on J. A rate distortion pair (R; D) should be achievable if a sequence of rate distortion codes (f;g) exist with  $E[d(J; \hat{J})] = D$  in the limit M ! 1. Moreover, the closure of the set of achievable rate distortion pairs is called the rate distortion region for a source. Finally, we can dene a function to describe the boundary; the rate distortion function R (D) is the inmum of rates R, so that (R;D) is in the rate distortion region of the source for a given distortion D.

As in [7], we restrict ourselves to a binary source J with a Hamming distortion measure for simplicity. We assume that binary alphabets are drawn random ly, i.e., the source is not biased to nule out the possiblity of compression due to redundancy. We now not the description rate R (D) required to describe the source with an expected proportion of errors less than or equal to D. In this simpli ed case, according to Shannon, the boundary can be written as follows; the rate distortion function for a binary source with Hamming distortion is given by

$$R(D) = \begin{cases} 1 & h_2(D) & \text{for } 0 & D & 1=2 \\ 0 & \text{for } 1=2 < D \end{cases};$$

where  $h_2$  ( ) represents the binary entropy function.

Next we introduce a simpli ed model for the bosy compression. We use the inverse problem of Sourlas-type decoding to realize the optim alencoding scheme [4], a variation of which has recently been investigated by inform ation theorists [14]. As in the previous paragraphs, we assume that binary alphabets are drawn random by from a non-biased source and that the H am m ing distortion measure is selected for the delity criterion.

We take the Boolean representation of the binary alphabet J, i.e., we set J = f0;1g. We also set X = f0;1g to represent the codewords throughout the rest of this paper. Let J be an M -bit source sequence, an N-bit codeword, and  $\hat{J}$  an M-bit reproduction sequence. Here, the encoding problem can be written as follows. Given a distortion D and a random ly-constructed Boolean matrix A of dimensionality M N, we nd the N-bit codeword sequence , which satis es

$$\hat{J} = A \quad (m \text{ od } 2); \tag{3}$$

where the delity criterion  $D = E[d(J; \hat{J})]$  holds, according to every M -bit source sequence J. Note that we applied modulo 2 arithmetics for the additive operations in (3). In our framework, decoding will just be a linear mapping  $\hat{J} = A$ , while encoding remains an NP-complete problem.

K abashim a and Saad recently expanded on the work of Sourlas, which focused on the zero-rate limit, to an arbitrary-rate case [5]. We follow their construction of the matrix A, so we can treat non-trivial situations. Let the Boolean matrix A be characterized by K ones per row and C per column. The nite, and usually small, numbers K and C de ne a particular code. The rate of our codes can be set to an arbitrary value by selecting the combination of K and C. We also use K and C as control parameters to de ne the rate R = K = C. If the value of K is small, i.e., the relation K N holds, the Boolean matrix A results in a very sparse matrix. By contrast, when we consider densely constructed cases, K must be extensively big and have a value of O (N). We can also assume that K is not O (1) but K N holds.

The similarity between codes of this type and Ising spin systems was rst. pointed out by Sourlas, who formulated the mapping of a code onto an Ising spin system Hamiltonian in the context of error correction [4]. To facilitate the current investigation, we rst m ap the problem to that of an Ising m odel with nite connectivity following Sourlasfin ethod. We use the Ising representation f1; 1g of the alphabet J and X rather than the Boolean one f0;1g; the elements of the source J and the codeword sequences are rewritten in Ising values, and the reproduction sequence  $\hat{J}$  is generated by taking products of the relevant binary codew ord sequence elements in the Ising representation  $\hat{J} = \int_{i_{2S}(\cdot)} S_i$ . Here, we denote the set of codeword indexes i that participate in the message index by  $S() = fi \dot{a}_i = 1g$ with  $A = (a_i)$ . Therefore, chosen is correspond to the ones per row, producing a Ising version of  $\hat{J}$ . Note that the additive operation in the Boolean representation is translated into the multiplication in the Ising one. Hereafter, we set  $J_{1j}$ ,  $J_{1j}$  = 1 while we do not change the notations for sim plicity. As we use statistical-mechanics techniques, we consider the source and codew ord-sequence dimensionality (M) and N,

respectively) to be in nite, keeping the rate R = N = M nite. To explore the system 's capabilities, we exam ine the H am iltonian:

with

where we have introduced the dynam ical variable  $S_i$  to nd the optim all value of i, and G [S jJ ] denotes the local connectivity of a random hypergraph neighboring the message bit J [15]. In addition, we now introduce the connectivity tensor G satisfying the relation:

for any congutation of S. Elements of the connectivity tensor  $G_{\text{Hi}_1; ;i_K i}$  take the value one if the corresponding indices of codew ord bits are chosen (i.e., if all corresponding indices of the matrix A are one) and zero otherwise; C ones per i index represent the system's degree of connectivity.

For calculating the partition function Z (J) =  $Tr_{fSg} \exp[$  H (S jJ)], we apply the replica m ethod following the calculation of K abashim a and Saad [5]. To calculate replica free energy, we have to calculate the annealed average of the n-th power of the partition function by preparing n replicas. Here we introduce the inverse tem perature

, which can be interpreted as a measure of the system's sensitivity to distortions. A lthough larger values of seem to be preferable to realize smaller reproduction errors, taking the limit ! 1 fails to provide the optimal solution. This is a direct consequence of the sytem's irreversibility. As we see in the following calculation, the optimal value of is naturally determined when the consistency of the replica symmetry breaking scheme is considered [13, 3]. We use integral representations of the Dirac function to enforce the restriction, C bonds per index, on G [16]:

where ; ; ; represent replica indices, and the average over J is taken with respect to the probability distribution:

as we consider the non-biased source sequences for sim plicity. A ssum ing the replica symmetry, we use a di erent representation for the order parameters and the related

conjugate variables [16]:

where  $q = [(K \quad 1) \mathbb{N} \subset \frac{1}{2}^{=K}$  and  $\hat{q} = [(K \quad 1)!]^{1=K} \mathbb{N} \subset ]^{(K \quad 1)=K}$  are normalization constants, and (x) and (x) represent probability distributions related to the integration variables. Here idenotes the number of related replica indices. Throughout this paper, integrals with unspecied limits denote integrals over the range of ( 1;+1). We then obtain an expression for the free energy per source bit expressed in terms of the probability distributions (x) and (x):

where h ii denotes the average over quenched random ness of J, and also G. The saddle point equations with respect to probability distributions provide a set of relations between (x) and  $(\hat{x})$ :

By using the result obtained for the free energy, we can easily perform further straightforward calculations to nd all the other observable therm odynamical quantities, including internal energy:

which records reproduction errors. Therefore, in terms of the considered replica symmetric ansatz, a complete solution of the problem seems to be easily obtainable; unfortunately, it is not.

This set of equations (13) and (14) m ay be solved num erically for general , K, and C. How ever, there exists an analytical solution of this equations. We rst consider this case. Two dom inant solutions emerge that correspond to the param agnetic and

the spin glass phases. The param agnetic solution, which is also valid for general , K, and C, is in the form of (x) = (x) and  $^{-} = (x)$ ; it has the lowest possible free energy per bit  $f_{PARA} = 1$ , although its entropy  $s_{ARA} = (R - 1) \ln 2$  is positive only for R - 1. It means that the true solution must be somewhere beyond the replica symmetric ansatz. As a rst step, which is called the one step replica symmetry breaking (RSB), n replicas are usually divided into n=m groups, each containing m replicas. Pathological aspects due to the replica symmetry may be avoided making use of the new ly-de ned freedom m. A ctually, this one step RSB scheme is considered to provide the exact solutions when the random energy model lim it is considered [17], while our analysis is not restricted to this case so far.

The spin glass solution can be calculated for both the replica symmetric and the one step RSB ansatz. The former reduces to the paramagnetic solution  $(f_{RS} = f_{PARA})$ , which is unphysical for R < 1, while the latter yields  $_{1RSB}(x) = (x)$ ,  $^{}_{1RSB}(x) = (x)$ ,  $^{$ 

non-negative replica symmetric entropy

$$s_{RS} = \ln \cosh_{q} + R \ln 2 = 0; \qquad (16)$$

with a free energy

$$f_{1RSB} = \frac{1}{g} \ln \cosh g \frac{R}{g} \ln 2 : \qquad (17)$$

The simple expression (17) is derived analytically without using any approximations. However, the stability of the solution must be taken into account when considering the validity.

Since the target bit of the estimation in this model is  $J_{hi_1}$ ;  $J_{k_1}$  i and its estimator the product  $S_{i_1}$   $J_{k_1}$ , 3 performance measure for the information corruption could be the perbond energy e. A coording to the one step RSB framework, the lowest free energy can be calculated from the probability distributions  $I_{RSB}$  (x) and  $I_{RSB}$  (x) satisfying the saddle point equations (13) and (14) at the characteristic inverse temperature g, when the replica symmetric entropy  $s_{RS}$  disappears. Therefore,  $f_{IRSB}$  equals  $e_{IRSB}$ . Let the Hamming distortion be our delity criterion. The distortion D associated with this code is given by the fraction of the free energies that arise in the spin glass phase:



Here, we substitute the spin glass solutions into the expression, making use of the fact that the replica symmetric entropy  $s_{RS}$  disappears at a consistent  $_g$ , which is determined by (16). Using (16) and (18), simple algebra gives the relation between the rate R = N = M and the distortion D in the form

$$R = 1 \quad h_2 (D);$$

which coincides with the rate distortion function in the Shannon's theorem. We do not de ne any non-linear mappings in the decoding stage but we implicitly do in the encoding stage. This situation is due to the duality between channel coding and lossy compression; the channel capacity can be achieved using linear encoders. Furtherm ore, we do not observe any rst-order jumps between analytical solutions. Recently, we have seen that many approaches to the family of codes, characterized by the linear encoding operations, result in a quite di erent picture; the optim alboundary is constructed in the random energy model limit and is well captured by the concept of a rst-order jump. Our analysis of this model, viewed as a kind of inverse problem, provides an exception.

W e will now investigate the possibility of the other solutions satisfying (13) and (14) in the case of nite K and C. Since the saddle point equations appear di cult for analytical arguments, we resort to numerical evaluations representing the probability distributions  $_{1RSB}(x)$  and  $_{1RSB}(x)$  by up to  $10^5$  bin models and carrying out the integrations by using M onte C arlo methods. Note that the characteristic inverse temperature  $_g$  is also evaluated numerically by using (12) and (15). We extly calculate the entropy numerically, following the basic relation  $f = e^{-1}$  s. Then we choose the proper value of which provides s = 0. We set K = 2 and selected various values of C to demonstrate the performance of stable solutions. The numerical results obtained by the one step RSB senario show suboptim al properties [Figure 2]. This strongly implies that the analytical solution is not the only stable solution. Furthermore, there has been recent works on the one-step RSB solution of the model considered in this paper. The stability of the solution is well examined for some value of K and C [18].

In this paper two points should be noted. Firstly, we do not the consistency between the Shannon's rate distortion theory and the Parisi's one step RSB scheme. Secondly, we con m that the analytical solution, which is consistent with the Shannon's result, can not be stable in the sparsely-connected systems. In case of sparse models, one might data polynom inal-time algorithm which calculates the suboptim al solutions,

providing a practical method of lossy compression. We are currently working on the veri cation.
