# W hat are the elem entary excitations of the BCS m odel in the canonical ensem ble?

We have found the elementary excitations of the exactly solvable BCS model for a xed number of particles. These turn out to have a peculiar dispersion relation, some of them with no counterpart in the Bogoliubov picture, and unusual counting properties related to an old conjecture made by G audin. We give an algorithm to count the number of excitations for each excited state and a graphical interpretation in terms of paths and Young diagrams. For large systems the excitations are described by an elective G audin model, which accounts for the nite size corrections to BCS.

### I. IN TRODUCTION

The paradigm atic m odel to study the superconducting properties of metals<sup>1</sup> and nuclef is the pairing m odel proposed by Bardeen, Cooper and Schrie er. The ground state (GS) and excitations of the BCS model are well known in the grand canonical (g.c.) ensemble, and explain the behavior of system s with large number of particles. However for small systems, such as nuclei or nanograins, one is forced to work with a xed number of particles, where the g.c. BCS wave function, including its projected version, are not adecuate. The problem is due to the strong pairing uctuations, which a mean

eld approach cannot deal with properly. An alternative approach is provided by exact num ericalm ethods, as the DM RG<sup>3</sup>, but their com plexity som ehow obscures the Physics behind. Fortunately enough the reduced BCS model, characterized by a unique pairing coupling g, is exactly solvable, as was shown by Richardson<sup>4</sup>. This exact solution has been recently used in connection with superconducting nanograins<sup>5</sup> (see Ref. 6 for a review).

M ost of the exact studies dealw ith the G S and the excited states that are obtained by breaking C ooper pairs. H owever one m ust also consider the promotion of pairs to higher energy levels (bosonic pair-hole excitations). This paper focus on the later type of excitations since the form er ones can be easily included into our form alism. W e shall indicate the peculiar dynam ics and the unusual counting properties exhibited by the excitations of the exactly solvable BCS model, some of them with no analogue in the standard picture of Bogoliubov quasiparticles. These features account for the exact nite size corrections to the therm odynam ic lim it, obtained from the standard BCS treatment.

In Section II we introduce the superconducting system described by R ichardson and G audin m odels, and we present here our conjecture about what represents their elementary excitations. Section III is devoted to classify the excited states according to what will be interpreted as elementary excitations in Section IV. In this respect a diagram atic representation of the excited states turns out to be very useful. The therm odynam ic limit of our theory is presented in Section IV, which con im sour conjecture about the elementary excitations. A comparison with the BCS theory is also presented. Finally, Section V contains our conclusions.

### II. RICHARDSON AND GAUDIN MODELS

Let us consider a ferm ionic system with N single particle energy levels. The reduced BCS H am iltonian decouples the levels which are singly occupied and one is left with those that are either empty, jDi (hole) or doubly occupied,  $b_j^v$  jDi (pair) with an energy "j ( $b_j^v = c_{j;t}^v c_{j;}^v$  is a hard core boson operator that creates a pair of two tim ereversal states). We shall suppose that the singly occupied levels have been rem oved. Since the latter decouple, their e ect can be considered easily by adding their free energy "j to the total energy. The com plete system will be treated elsewhere. The reduced BCS H am iltonian reads,

where G is a dimensionful coupling constant. The standard model employed to study nanograins is given by the choice " $_j = d(2j \ N \ 1)$ , where d = !=N is the single particle energy level spacing and !=2 is the Debye energy<sup>6</sup>. The coupling G can be written as G = gd, where g is dimensionless. The value of the bulk BCS gap,  $_{BCS}$ , of the equally space model is given by  $_{BCS} = =2$ , where  $= !=\sinh(1=g)$ .

The eigenstates of (1) with M pairs are given by  $^4$

where the parameters fE  $g_{=1}^{M}$  satisfy the Richardson equations




FIG.1: Real part of E  $\,$  for the equally space model with M = N = 2 = 20 pairs and N  $_{\rm G}$  = 0;1;2 excitations.

The total energy of the state (2) reads  $E = {P \atop M}_{=1} E$ . The number of solutions of Richardson Eqs. (3) is given by the binomial coe cient  $C_M^N = {N \atop M}$ , and coincides with the dimension of the Hilbert space,  $H_M^N$ , of states with M pairs distributed into N di erent levels. Then it is natural to label Richardson states by a set of integers  $I = fj_1; \dots; j_M$  g corresponding to the value that the pair energies E take at g = 0, i.e. some of the "j's.

The BCS model can be mapped into a spin system which at  $g \ 1$  has SU (2) symmetry. Based on this fact G audin<sup>7</sup> made the conjecture that given a solution fE  $(g)g_{=1}^{M}$  of Eqs. (3), and taking the limit  $g \ 1$ , a subset of them, say fE  $(1)g_{=1}^{N_{G}}$ , remain nite and satisfy the equations

while the remaining M N<sub>G</sub> roots tend to in nity and satisfy Eqs. (3) with all "j's set to zero. The number N<sub>G</sub> of nite roots takes values from 0 to M. The number of solutions of Eqs. (4) is given by  $d_{N_G} = C_{N_G}^N - C_{N_G}^{N-7}$ . Therefore in the large g limit the  $C_M^N$  R ichardson's solutions would be classified in terms of N<sub>G</sub> according to Table I. Consistency is guaranteed by the equation  $C_M^N = \frac{M}{N_G = 0} d_{N_G}$ .

We show in this paper that G audin nite energies represent the elementary excitations of the superconducting system in the canonical ensemble. Their peculiar dispersion relations and the unusual counting properties will




FIG.2: Position of the M = 20 pairs of the states of g.1 at g = 1.5. The arcs  $I_1$  (19 pairs) and  $I_2$  (18 pairs) are a slight m odi cation of the GS arc  $I_0$  (20 pairs).

account for the nite size corrections to the mean-eld BCS treatement of superconductivity.

This result is motivated by the excitation energy for large values of g, namely,  $E_{exc} = E_{GS} = g! N_G [l = (N_G = 1)=N]$ , and the gap  $g! \cdot T$  hus, in the large N lim it the excitation energy goes as  $E_{exc} = N_G \cdot W$  hich allow s us to think of the state as a set of N<sub>G</sub> elementary excitations contributing each with an energy to the total energy.

In Section IV we extend this result for the whole range of g. In the meanwhile next Section is devoted to the proof of G audin's conjecture given in Table I. We also obtain a form ula which gives the number of nite G audin energies N<sub>G</sub> for a given R ichardson con guration I, and therefore the number of elementary excitations.

## III. CLASSIFICATION OF EXCITED STATES

### A. Sim ple exam ples

Let us st consider the simplest examples given by the excited states with one and two energies remaining

nite, i.e.  $N_G = 1$  and 2. Representatives of these, together with the GS are shown in Fig.1, which depicts to the real part of the energies, and in Fig.2, which shows the distribution of the energies in the com plex plane for g = 1.5 and a system with M = 20 pairs at half lling, i.e. N = 2M. As a general feature we see that for small g all parameters E are real, and as g grows some of them collapse and become com plex conjugate pairs, which share their real part (this corresponds to two curves merging into a single one in Fig.1). Fig.2 shows how the energies E arrange them selves into an arc which opens up to in nity as g ! 1.

The state of Fig. 1a corresponds to the GS of the system, and it is labelled by  $I_0 = f1;2;:::;M$  g, which at g = 0 is identical to the Ferm i state (FS). As  $g \mid 1$

all the roots become complex and scape to in nity. According to Table I, this is the only state where this may happen, hence N<sub>G</sub> ( $I_0$ ) = 0.

The lowest excited state  $I_1 = f1; :::; M$  1; M + 1g is shown in Fig. 1b. The last root  $E_M$ , which is equal to  $"_{M+1}$  at g = 0, stays nite as g ! 1, while the remaining M 1 roots go to in nity, thus  $N_G$  ( $I_1$ ) = 1. All the states with  $N_G = 1$  can be obtained from the FS by: 1) promoting the nearest pair below the Fermi level (FL) into one of the N M empty levels above it, or 2) moving the nearest hole above the FL into one of the M occupied levels below it. The state  $I_1$  can be obtained in both ways. Hence the number of  $N_G = 1$  excited states is  $d_1 = (N M) + M 1$ .

The state of Fig. 1c,  $I_2 = f1; \dots; M = 2; M; M + 2g$ , has  $N_G$  (I<sub>2</sub>) = 2. All the states with  $N_G$  = 2 can be obtained in three di erent ways from the FS:1) moving the two pairs just below the FL into the N M empty levels  $(C_2^{N-M} \text{ states}), 2)$  moving the two holes just above the FL into the M occupied levels ( $C_2^{M}$  states), or 3) m oving one of the M 1 pairs in the FS, except the closest to the FL, into one of the N M 1 vacancies above the FL, except the closest to the FL ((N  $\,$  M 1) (M 1) states). The state with two holes just below and two pairs just above the FL is generated by the rules 1 and 2, thus the number of states is the expected one,  $d_2 = C_2^{N M} + C_2^{M} + (N)$ 1) (M 1) 1. This М example shows that the value of N  $_{\rm G}\,$  for a generic state depends dram atically on the arrangem ent of holes and pairs around the FL.

## B. $N_G$ (I) form ula

W e now turn to the evaluation of N<sub>G</sub> (I) for a general state. O ne naively expects that this form ula should be given by the sum of pairs, N<sub>p</sub>, and holes, N<sub>h</sub>, above and below the FL respectively, i.e. N<sub>G</sub> (I) = N<sub>p</sub> + N<sub>h</sub>. In fact N<sub>p</sub> = N<sub>h</sub> since every pair above the FL comes from a hole below it. However this ansatz does not always work as we have already seen above. For example, according to this form ula, the state I<sub>1</sub> of Fig. 1b would have 2 instead of N<sub>G</sub> = 1, while the state I<sub>2</sub> of g.1chas N<sub>G</sub> = 2, which is the correct value.

Let us introduce for convenience the occupation representation of the states I, where a pair, a hole and the FL are depicted as ; and j respectively. In the cases discussed above we obtain:  $I_0 =$ j j  $I_1 =$  $_2$  = , and I j W e have found an algorithm to compute  $N_{G}$  (I). G iven an integer ` 0, let us split I into three disjoint sets, I =  $A \in [B \in [C , where A \cdot contains the lowest M]$ ' levels, B , the next 2 ` levels and C  $\cdot$  the rem aining NМ ones. For ' = 0, the set  $B_0$  is empty, and  $A_0$  (resp.  $C_0$ ) contains all the levels below (resp. above) the FL, while for ' 1 the set B, contains the nearest ' levels above and below the FL.As an example, let us choose a state of the form  $I_3 =$

Let us de ne the num ber of pairs and holes for each set, i.e. N  $_{p=h}^{X}$  (X = A ;B ;C ). The algorithm giving N  $_{G}$  (I) is

Applying this form ula to I<sub>3</sub> one gets fN<sub>G</sub> (I<sub>3</sub>; ')g<sup>4</sup><sub>i=0</sub> = f4;5;4;3;4g and thus, N<sub>G</sub> (I<sub>3</sub>) = 3. The value of '<sub>1</sub>, which m inim izes N<sub>G</sub> (I; '), is given in this case by 3 (in general '<sub>1</sub> is not equal to N<sub>G</sub> (I)). The result of this form ula is bounded, N<sub>p</sub> N<sub>G</sub> 2N<sub>p</sub>, and therefore any state with a nite N<sub>p</sub> would contain a nite number of G audin energies. The uncorrelated counting form ula proposed earlier coincides with the case '<sub>1</sub> = 0, since N<sub>G</sub> (I;0) = N<sub>p</sub> + N<sub>h</sub> (notice that N<sub>h</sub> = N<sub>h</sub><sup>A<sub>0</sub></sup> and N<sub>p</sub> = N<sub>p</sub><sup>C<sub>0</sub></sup>).

The physicalm echanism underlying Eq. (5) is the collective behavior of the holes and pairs that occupy the 'I closest levels to the FL. In a certain sense, 'I measures the range of correlation involved in the creation of the elementary excitations out of an initial pair-hole con guration. How ever, this correlation can be lifted introducing a shifted Ferm ilevelFL ('I) de ned by moving the FL an am ount of 'I levels dow nwards (resp. upwards) whenever N  $_{\rm p}^{\rm B}$ ' is low er or equal (resp. greater) than N  $_{\rm h}^{\rm B}$ '. This new Ferm ilevel de nes a new Ferm i state out of which the excited state with N  $_{\rm G}$  nite energies is obtained by the creation of uncorrelated pairs above and holes below the FL ('I). This construction provides a pathw ay to the g.c. form ulation as discussed later.

The form ula presented here allow sus to prove G audin's conjecture by looking for all the states with a given N<sub>G</sub>, and noting out that its number corresponds to  $q_{t_G}$  as stated in Table I, the same way we already did with those with N<sub>G</sub> = 1 and 2.

### C. Young diagram s representation

The correlated behavior of the excitations is made m ore explicit by a pictorial representation of the states. The idea is to associate to every set I a path  $_{\rm I}$  with N links on the square lattice  $Z^2$ , starting at the origin (0;0). This is achieved by associating a horizontal link directed to the right, to every hole , and a vertical link directed upwards, to every pair . The map starts from the lowest energy level and ends at the highest one. For example the path associated to the Fermi <sup>N</sup> і<sup>M</sup> М state  $I_0 =$ is a polygonal line joining the points (0;0) ! (0;M) ! (N M;M). If I describes a state with M pairs and N energy levels, then the path  $_{T}$  ends at the point (N M; M). The number of these sort of paths is  $C_M^N$ , which is precisely the dimension of the H ilbert space  $H_{M}^{N}$ <sup>8</sup>.





FIG.3: a) The path and Young diagram of  $I_3$ . b) Realpart of E for  $I_3$ . For g large enough there is a real root (1) and a com plex root (2).

with the num erical results shown in Fig. 3b. M oreover, Fig. 3a illustrates the fact that any state I gives rise to a Young diagram (YD) YI, whose boundary is form ed by the links which belong either to  $I_{I_0}$  , but not to both. The YD of the Ferm i state is by construction empty, i.e.  $Y_{I_0} =$ . These YD's capture the basic properties of the excitations. First of all,  $N_{G}$  (I), given by Eq. (5), coincides with the number of squares on the longest SW -NE diagonal on  $Y_{I}$  (see Fig. 3a). This fact provides a geom etrical m eaning to N  $_{\rm G}$  (I) and leads to a com binatorial proof of G audin's conjecture, which can be stated as follows:  $d_{N_G}$  is the number of YD 's, Y<sub>I</sub>, associated to the paths  $_{\rm I}$ , which have N  $_{\rm G}$  squares on their longest SW -NE diagonal. The proof of this conjecture uses the m ethods of R ef.  $8^9$ . This result serves to classify the excitations in term s of YD's. For example the states with  $N_G = 1$  and 2 discussed above correspond to the YD's shown in Fig. 4.





A nother properties of these diagram s are: i) the pairhole transform ation of the states induces a transposition of their associated YD's, ii) the main NW -SE diagonal on a YD coincides with the FL (see Fig. 3a), and ii) the number of boxes of  $Y_I$  is the excitation energy of I (in units of 2d) at g = 0 for the equally space model.

## IV. THERMODYNAM IC LIM IT

As we explained in the previous Section, by increasing g, M  $N_G$  of the energies E become complex and arrange them selves into an arc which escape to in nity for large g, while the remaining  $N_G$  stay nite with their positions barely modil ed (see Figs. 1b, c and 2).

Following the procedure presented in Refs.7,10,11,12 we take the large N limit keeping M = N, g and N<sub>G</sub> nite. In this limit the arc formed by the energies in the com – plex plain becomes dense, and allows for a continuous formulation. In particular, the GS corresponds to an arc  $I_0$  in the complex energy plane, which in the g ! 1 limit goes to in nity.

Excited states contain nite energies in addition to the arc. A given nite root E can be either real or com plex. In the form er case we shall call it a 1-string. In the latter case E is also a root, which together with E form a 2-string (an example of such states can be seen in Fig. 3b). There are also 3-strings form ed by one real root and two com plex ones, having approximately the same real part, and so on. In general fE  $g_{=1}^{N_{c}}$  is a combination of strings with several lengths. The remaining M N<sub>G</sub> roots condense into an arc I, which is a slight perturbation of the GS arc I<sub>0</sub>. In Fig. 2 we depict I<sub>0</sub> and I for the two excited states I<sub>1</sub> and I<sub>2</sub> shown in Figs. 1b,c.

Taking into account these considerations, and using the methods of Refs. 7,11 one can show in the large N lim it that the excitation energy of a Richardson state I is given by

where  $"_0$  is twice the chemical potential, and the energies E satisfy the modil ed G audin equations

with R(E) =  $p (E - r_0)^2 + 2$ . As g ! 1 one has g! and Eqs. (7) become Eqs. (4).




FIG. 5: Excitation energies  $E_{exc} = E_{GS}$  14d for M = 20 pairs at half lling. There are 44 = 13+ 26+ 5 states corresponding to  $N_G = 1$ ;2;3 respectively. The particle-hole sym m etry reduces these numbers to 25 = 7+15+3.

The excitation energy given by Eq. (6) ts quite well the excitation energies of our prototype example (N = 40, M = 20), as shown in Fig. 5. This also exhibits the linear behavior of the excitation energy for g ! 1, i.e. E<sub>exc</sub> N<sub>G</sub> as stated in Section II, and in fullagreem ent with the large g behavior of Eq. (6). Thus we can extend our conjecture to the whole range of g. N am ely, any excited state is composed by N<sub>G</sub> elementary excitations associated to the nite G audin energies. The H ilbert space spanned by these excitations has therefore a dimension  $d_{N_G} = \frac{N}{N_G} \frac{N}{N_G - 1}$ . Hence, it is reasonable to call this new type of excitations G audin pairs or gaudinos.

In order to compare our results with the BCS standard solution lets consider the excitation energy given by a real C coper pair in the B ogoliubov approach, which is

given by  $\frac{q}{j} + \frac{2}{2}$  (notice that  $2_{BCS}$ ), and span a H ilbert space of dimension  $\frac{N}{N_G}$ . The standard Bogoliubov quasiparticle with an energy  $\frac{q}{j} + \frac{2}{2} = 2$  would have to be compared with excitations involving broken C coper pairs. Since E in Eq. (6) lies between two energy levels, with  $\frac{q}{j+1} - \frac{q}{j} = 2d$  1=N (e.g. in Fig. 1b E  $_{20}$  (1) = 0 with  $\frac{q}{20} < E_{20} < \frac{q}{21}$ ), E =  $\frac{q}{j} + 0$  (1=N), and  $\frac{q}{N_G} = \frac{N}{N_G} [1 - \frac{N_G}{N - N_G + 1}]$ . Therefore, our theory is consistent within 0 (1=N) corrections, as it is well known from the existing relation between a canonical and a grand canonical ensemble form ulation in the statistical physics.

It is important to notice how the Bogoliubov excitations are uncorrelated with respect to the BCS ground state. We already pointed out that the correlation present in our formulation is lifted by choosing a shifted Ferm i level FL ('I). This Ferm i level is within a distance O (I=N) from the original one. The selection of a new Ferm i level leads a new Ferm i sea (with a di erent number of particles), allowing for a grand canonical form ulation in a natural way.

In sum m ary, our gaudinos will yield the same results as the BCS theory in the extrict N = 1 lim it, and will account for the exact corrections to the bulk results for the nite size superconducting grains for all the physical observables and therm odynam ic properties.

## V. CONCLUSIONS

We have shown in this paper that the elementary excitations of the exactly solvable BCS model in the canonicalensemble can be explained by the G audin model and have no counterpart in the Bogoliubov picture of quasiparticles. Their peculiar dispersion relation and the unexpected counting properties, which are due to the correlated behavior of pairs and holes around the Ferm i level, provide the exact nite size corrections to the BCS bulk results, valid for large systems in the g.c. ensem – ble. These excitations, together with those obtained by breaking C ooper pairs, supply the com plete spectrum of the canonical BCS model. A form ula to com pute the num ber of elementary excitations for any given state was also proposed.

We explained how the description in term s of gaudinos agrees with the Bogoliubov picture in the therm odynam ic lim it to leading order in N. In the case of broken pairs, which was not presented here, them echanism is identical. It is of interest to study how the phase of the superconducting order parameter emerges from this xed number of particles form ulation. It will be intimatelly related to the possibility of choosing a shifted Ferm i level in the large N lim it (which looses the correlation of the excitation), allowing the introduction of ground states with di erent number of pairs.

A lthough we used as an example a system of equally spaced levels, the results are more general, and apply to any distribution of levels. This assertion is based on numerical calculations considering broken C coper pairs. In this case bloked levels are removed, and we are left with a non-equally spaced spectrum, obtaining again the same general results. In the case of a non-constant pairing we also expect the qualitative picture presented here to hold.
