Two-level system with a therm ally uctuating transferm atrix element: Application to the problem of DNA charge transfer

Charge transfer along the base-pair stack in DNA is modeled in terms of them ally-assisted tunneling between adjacent base pairs. Central to our approach is the notion that tunneling between uctuating pairs is rate limited by the requirement of their optimal alignment. We focus on this aspect of the process by modeling two adjacent base pairs in terms of a classical dam ped oscillator subject to thermal uctuations as described by a Fokker-Planck equation. We not that the process is characterized by two time scales, a result that is in accord with experimental ndings.

I. IN TRODUCTION

In spite of the fact that a decade has passed since the rst de nitive observation of charge transfer along the DNA base-pair stack [1], the detailed properties of this process have not been de nitively elucidated. This is partly due to the inherent complexity of the molecular structure of DNA, and to the large number of externaland intrinsic factors that exert an in uence on DNA structure and behavior. The current unsettled situation also rejects the absence of an overall agreem ent on the precise mechanism by which this charge transport takes place. One of the key issues that awaits full illum ination is the role of disorder both static and dynamic on the propagation of charge along the base-pair stack. A related, and quite fundamental, question is whether charge transport is a coherent quantum mechanical process, like conduction of electronic charge against a static, ordeform able, background, orwhether it it takes place as fundam entally incoherent transport, as a variation of the random walk. The answers to these and other questions will have a signi cant impact on both our understanding of the biological in pact of charge transport in DNA and the developm ent of applications based on this phenom enon.

Despite the often contradictory results of experim ental investigations [2, 3, 4, 5, 6], a few conclusions seem inescapable. The rst is that long-range charge transport along the base-pair stack depends quite strongly on the sequence of the base pairs [7]. In addition, base-pair m ism atches can have a signi cant deleterious e ect on charge transport [8, 9] (see, how ever [10]). Furtherm ore, strands of DNA display considerable disorder, both static [11] and dynam ic [12, 13, 14, 15]. Finally, several sets of experiments on ensembles of short DNA strands have uncovered an unusual two-step charge transfer process [16, 17]. These studies focus on uorescent charge donors intercalated in DNA oligostrands. A sthe chargem igrates towards the acceptor, the uorescence is quenched and the rate of m igration is determ ined by the decaying uorescence pro le. The data reveals that this decay process occurs according to two characteristic tim e-scales

which are separated by more than an order of magnitude [16, 17]. Any model that purports to explain charge transport must take all this into account.

In this paper, we discuss a model for short range charge transport along a base pair stack that undergoes substantial structural uctuations. The process occurs via therm ally-assisted quantum mechanical tunneling of charge carriers from one base pair to the next, under the assumption that this tunneling is properly characterized as occurring in the presence of a dissipative environm ent. A key conjecture is that charge transfer takes place only when the neighboring pairs are in a state of optim al \alignm ent", and that this alignm ent is statistically unlikely in therm odynam ic equilibrium . A swewill see, this conjecture leads in a natural way to a model exhibiting the dual-tim e-scale feature described above. Additionally, the model generates predictions that can be readily tested. W e shall relate the problem at hand to the dynam ics of a simple two level system (TLS), realized by a donor and an acceptor state.

In Section II, we brie y recapitulate what is known about the tunneling process in the presence of friction for a TLS system . W e also quantify our notion of a coordiassociated with the \alignment" of adjacent base nate pairs and of the in uence of the dynamics of this new coordinate on charge transfer. Section III speci es the m odel for describing a generic collection of two-level system s (TLS), initially in the donor state and characterized by a uctuating alignment variable . The probability distribution of donor states, W (;-;t) obeys a K ram ers equation with a sink term due to charge transfer to the acceptor. The rate of charge transfer will be expressed by the uctuating rate (). This K ram ers expression is recast into the form of a Volterra equation with the use of a Lie-A lgebra approach de ned on the Hilbert space of the eigenstates of the K ram ers equation for () = 0. We will discuss limiting cases of the solution to obtain physical insight and to reveal the two-tim e-scale decay of the probability distribution due to the sink term . We conclude in Section IV with a discussion of the possible application of our results to charge transfer in strands of DNA consisting of several base pairs.

The key result of our calculations lies in the determ i-

nation of P (;t), the probability distribution of donor states evaluated at the optim alcon guration and with the -variable integrated out. Indeed, under the assum ption that the tunneling process ism ost e ective at , this quantity is directly related to the uorescence intensity I (t) of the base pair com plexes, as probed by J. Barton and A. Zewail [16, 17], through the follow ing:

The quantity I_0 of the above relationship is a proportionality constant and is the integrated rate of transfer to the acceptor. We shall determ ine the double exponential character of P (;t), and hence of I(t), in qualitative agreement with the experimental ndings. The conjectures made on the existence of an optimal and unlikely con guration will be crucial in obtaining the two stage decay process, a result that justi es the assumptions made.

The model we shall construct is obviously not restricted in application to DNA oligostrands. Using our results, we may conclude that in an ensemble of generic systems the migration of a particle from donor to acceptor proceeds statistically as a two-time scale process, provided the transfering process is of rare occurrence.

II. THE TUNNELING PROCESS

The process of charge transfer from a donor site to an acceptor site | a two-level system | is ubiquitous in biochem ical and physical phenom ena [18]. It occurs under a broad variety of spatio-tem poral conditions. Chem ical bond form ation or destruction, ATP production in photosynthetic reactions, or the operation of sem iconducting devices, all involve the transferring of charges to and from specic sites, via therm al activation or quantum mechanical tunneling through an energy barrier. Because of its intrinsic nature, charge transfer via quantum mechanical tunneling takes place on a length scale of up to tens of angstrom s [19]; larger distances are possible if other transport mechanisms are involved. These include therm all hopping am ong sites, which are typical in disordered system s, the creation of conduction bands in m etals, or of lattice distortions of polaronic type in speci c system s.

Q uantum -m echanical tunneling from a donor site to an acceptor site is quite simply represented by a twolevel system (TLS) [20]. In this description, the tunneling particle is limited to being in the donor or in the acceptor state, while the other degrees of freedom of the system, nuclear for instance, describe the charge potential energy.

The energetic pro le of the system is thus characterized by a multidim ensional surface of which the acceptor and the donor states constitute relative m inim a, separated by a barrier. Of the m any existing degrees of freedom, it is offen possible to identify a `reaction coordinate" y such




FIG. 1: This gure illustrates the nature of the tunneling transition. The two parabolic curves shown correspond to the two versions of the potential V (y; $_z$) in Eq. (2), one corresponding to the \donor" state in which the tunneling particle is on one site and the other to the \acceptor" state, in which the particle is on the other one. The two energies E_f and $E_b = E_f$ referred to in the text are the forward and backwards barrier energies respectively. The horizontal axis corresponds to the reaction coordinate, y.

that the energy barrier between donor and acceptor is m inim ized along this speci c direction. The progress of the reaction is then dom inated by the evolution along this coordinate and the potential energy surface can be reduced to an e ective one-dimensional curve.

In certain systems the physical interpretation of the reaction coordinate is immediate: it may be the relative bond length in two diatom icm olecules, or solvent polarization around the donors and acceptors [21]. It is not an easy task to give a physical interpretation of the reaction coordinate in the case of DNA base pairs because of the many possibilities involved - intra-base distance, mobile counter-ion concentration, solvent concentration, or a combination of all the above. A possibility is o ered by Ref. [22] where it is suggested that the most relevant quantity is the interaction of the charge with the polar water molecules of the solvent. In this paper we shall refer to the reaction coordinate y in most general terms.

A common representation of tunneling with dissipation is through the spin-boson form alism [20]. The donor and acceptor states are represented by means of a pseudo spin, which points up when the charge is in the donor state and down otherwise. The Ham iltonian of the system is given by:

and $_{x,z}$ are the Paulim atrices. The charge in the donor (up) state corresponds to the potential V (y;+) whose equilibrium reaction coordinate is y_0 , and the converse state corresponds to V (y;), whose stable minimum is at y_0 . The H_{bath} term represents contributions to the H am iltonian of a dissipative environment coupled to the reaction coordinate. Figure 1 illustrates the meaning of the potential V (y; $_z$) in the elective H am iltonian of Eq.(2). The curve marked A corresponds to the potential term in the donor state, while the curve marked B represents the potential function in the acceptor state.

This model has been thoroughly analyzed in the work by G arg et al. [23] based on earlier work by Leggett [24]. A similar analysis, but within a more chemical fram ework, is presented by M arcus et al. [25]. Energy conservation requires that charge transfer takes place only when the reaction coordinate is close to the degeneracy point y = y for which V (y ; +) = V (y ;); once the degeneracy point is reached, charge transfer is possible only because of the non zero o -diagonal tunneling m atrix elements .

The tunneling rate from donor to acceptor, is calculated in the above references. For moderate dissipation of the reaction coordinate, it is given by:

where the reorganization energy $E_{\rm r}$ and the energy barniers $E_{\rm f}$ and $E_{\rm b}$ depend on the details of the potential described by the reaction coordinate. In the lim it of high tem peratures $T_{\rm e}~$ reduces to the usual tem perature T, whereas in the opposite lim it the quantity is tem perature independent.

The novelty explored in this paper is the introduction and investigation of the e ect of a second reaction coordinate, , governing the charge transfer process and coupled not to the energy, but to the o -diagonal tunneling element , hitherto been treated as a constant, and which we now write ().

This new coordinate re ects the conjecture that in the case of DNA the tunneling matrix element is highly sensitive to the donor-acceptor relative con guration. Charge transport along DNA in fact occurs along the stacked base pairs by means of overlapping orbitals, and at room tem perature, these base pairs strongly uctuate with respect to each other through variations of the twist, tilt and roll parameters [26]. The existence of base pair uctuations for DNA in solution is very well established, and is corroborated by experim ental [12] and m olecular dynam ics studies [13, 14, 15]. For such a highly asym metric system such as DNA, uctuations in the relative orientation of donors and acceptors a ect the magnitude of the orbital overlap between pairs, and the new collective coordinate embodies the elects of these uctuations.

W e will also assume that the variable is slow ly varying compared to the motion of the reaction coordinate y, so as to de ne the low est energy scale of the system . W e m ay then separate the motion of the two reaction coordinates in a Born-O ppenheim er spirit. Charge transfer will be assumed to be instantaneous once the optim al = value is reached, and a purely classical fram ework will be utilized for the -dynamics. The new reaction coordinate

need not necessarily be pictured as a geom etrical one, although this is the fram ew ork we will be utilizing in this paper. Just as in the case of the y reaction coordinate, m ay be associated to the particular chem icalenvironm ent of the m olecule or to any other quantity in uencing the strength of the tunneling element between the donor and the acceptor sites.

The H am iltonian describing the system thus, is a modi ed version of the spin-boson H am iltonian introduced in Eq. (2) with a () $_x$ o -diagonal term, as also described in earlier work [27]. In order for charge transfer to take place, we will assume that the reaction coordinate coupled to the energy must be close to the degeneracy point y = y, and, also, that the coordinate must be in the neighborhood of an optim al value , which maxim izes the tunneling am plitude. The physical picture to associate to this requirem ent is that the relative \alignm ent", , does not favor charge transfer unless an optim al conguration is reached: () ' 0 unless ' . This conjecture will prove to be crucial in yielding the two tim e-scale charge transfer of references [16, 17].

In analogy to the experimental work cited above, we consider a collection of such two-level systems, with the charge initially located on the donor site. Each one of these systems is associated to a particular () and through Eq. (4) to a particular () rate. Our objective is to determ ine the mechanism s of charge transfer taking into account the time evolution and the () rates accordingly distributed. We shall assume the dynamics to be governed by sm all, Langevin type random uctuations. At t = 0, when the external charge is injected on the donor site, the distribution of values is the usual Boltzm ann distribution. If the occurrence of the optim al

con guration is relatively unlikely, we will indeed be able to show that the transfer process is characterized by a two time scalem igration of the initial donor population.

The emergence of two time scales in the transfer process can be physically explained as follows. The existence of an initial non-zero population of TLS presenting the optimal value , ensures that rapid tunneling to the acceptor. The distribution is thus depleted of population at the special value and other transitions are forbidden to take place. The other TLS will tunnel to the acceptor only after the system has re-equilibrated and repopulated the optim al con guration, a process which is slow, because of the assumption that the optim al con guration is a relatively unlikely one. Hence, the existence of a fast, initial decay followed by a slower decay process.

A. Themodel

Consider a collection of TLS which at the initial time t = 0 are all in the up-donor con guration, and characterized by the angular parameter . Let us denote by W (;-;t) the TLS population remaining in the up-donor state at time t and for which the collective angular variable and its velocity are specified.

The physical requirement that be randomly, classically, uctuating in time, translates into the fact that W (;-;t) must evolve according to a Fokker-Planck type equation as dictated by standard Langevin theory. To this probability evolution equation we must add an additional depleting term, that which represents tunneling to the donor site as given by the () term discussed above.

D i erent scenarios are possible for the dependence of and hence of . As discussed in the above section we shall focus on the particular situation in which tunneling is possible only for a very speci c subset of energetically values. In this picture, tunneling is alunfavorable low ed only if donors and acceptors reach an optim al but unlikely orientation one with respect to the other. By including the tunneling term in the time evolution equation for W (;-;t) we obtain a modi ed Fokker-Planck equation that m ay be used to approach any physical system in which the presence of a depleting term competes with the usual Langevin uctuations. The most natural choice for the motion, the one we shall discuss in the rem ainder of this paper, is that of a dam ped harm onic oscillator. We shall see that starting from an initially equilibrated system in which the distribution is the the Boltzm ann one, the insertion of the tunneling term will result in the emergence of the two time scales discussed above. W e will refer to the time derivative of the coordinate as u. The rotationalm om ent of inertia associated is denoted by I and its rotational frequency by . to

The goal of the next subsections will be to determ ine W (;u;t), and in particular its integration with respect to the u variable. As described in the introduction in fact, it is this quantity that is directly related to the experiments we wish to model by means of Eq.(1).

B. K ram ers equation with a sink term

The generic dam ped harm onic oscillator subject to random noise responds to the following Langevin-type equations:

where the stochastic force (t) is assumed to be a zeromean gaussian and whose correlation function is dictated by the uctuation-dissipation theorem for classical variables:

The corresponding Fokker-P lanck equation m ay be written by identifying [29] the proper coef cients in the K ram ers-M oyal expansion from Eq. (5) and is generally referred to as the K ram ers equation. This equation governs the time evolution of the distribution, W (;u;t), of an ensemble of system s obeying the equations of motion (5). It takes the form :

The above equation is thoroughly analyzed in [30], where assuming an initial probability distribution W (;u;0) = (0) (u 0), the probability W (;u;t), as well as other relevant statistical quantities, are obtained. At equilibrium K ramers equation is solved by the time independent Boltzm ann distribution, W (;u;t) = $_{0;0}$ (;u) with:

Under the assumptions discussed earlier, the probability distribution function W (;u;t) for a particle localized on the donor site and describing an elective angle with its neighbor, will be described by the time evolution equation for a collection of damped oscillators subject to a decay term , representing tunneling to the acceptor. The latter term is appreciable only for a speci c value of the coordinate :

The H term is the di erential operator that stem s from the right hand side of Eq. (7). We shall assume the decay term to be introduced at time t = 0, prior to which the system had attained its equilibration state. In other words, we choose the initial distribution W (;u;0) to be Boltzm ann-like, as expressed in Eq. (8). For sim plicity, we choose () to be independent of u and of t and to be a gaussian centered on and with width :

The coe cient contains the physical parameters of tem - perature and energy as expressed in Eq. (4). We also impose the constraint that at t = 0 the optimal value

carries a sm all Boltzm ann weight. This is equivalent to the physical assumption that the occurrence of particle tunneling is a rather unlikely event, and that the system tends to relax to values that are far from the tunneling point. We also in pose the width of the decay gaussian , to be sm all com pared to , so that () is highly paked around the optim al con guration value

In the following subsections we will solve Eq. (9) for the early and long time regimes. The general solution for arbitrary times is contained in the appendix. The coupling of the system to the orientational degree of freedom along the lines discussed above, manifests itself very clearly in the unusual time dependence of the probability distribution. Two di erent decay rates in fact arise, with a rapid initial decay of the donor population W (;u;t) followed by a slower transfer process. The ratio of these two time scales, and the main result of this analysis is succinctly expressed by Eq. (27) in term s of all the physical parameters of this system.

C. Short tim e regim e

In order to determ ine the asymptotic behavior of W (;u;t) in the early time regime, we consider Eq. (9) with the gaussian choice of () and we perform a multiple time scale analysis [31]. This is carried out by introducing a new ad-hoc variable = ()t, into the probability distribution, and by seeking solutions in the form W (;u;t) = W_0(;u;t;)+ ()W_1(;u;t;)+ :::. The Fokker-P lanck equation is thus expanded in powers of () and, for the zeroth and rst order terms, it yields:

Note that the partial derivative with respect to t in the above equations treats as an independent variable. The solution to the rst equation is expanded in term s of the complete set of functions m;n (;u;t) that solve Eq. (11) - obtained in Eq. (A1) and Eq. (A9) of the appendix - with coe cients A m;n that depend on , ie:

If this were the only term present on the right hand side of Eq. (12), then W_1 (;u;t;) would contain a secular term in its solution of the type:

Such a solution will eventually exceed the \leading order" one. We determ ine the coe cients A $_{\rm m,n}$ by requiring that there be no secular term in the solution to the equation. It is precisely this constraint that constitutes the underlying idea of multiple scale analysis. The above condition translates into requiring that the non-hom ogeneous term within parenthesis in Eq. (12) or equivalently in Eq. (15) vanish:

We now solve for $A_{m;n}$. In posing the initial condition W (;u;0) = $_{0;0}$ (;u) and reinserting = ()t the solution reads:

The above is a zero-th order approximation to the full problem presented in (12) to the extent that the e ect of H acting on t () can be neglected with respect to () itself. In other words, Eq. (17) is an approximate solution as long as:

This equation is valid only under the conditions expressed in (18) and up to t'¹ (). For this time limitation to be meaningful, it is necessary that the width of the decay term¹ be nite. In the limit that the width vanishes the above analysis fails, since the expansion parameter diverges. At time t 0 we cannot approximate () by a strict delta function. Note that for , the tunneling point, and for nite u the condition arising from the multiple scale analysis (t'² =) is the most stringent one, and the probability distribution is approximated by:

We now perform an integration over the u variable on both sides of Eq. (17) and obtain an approximation for the distribution probability function P (;t) = $1 \quad W$ (;u;t) du:

where $_0()$ is the Boltzmann distribution associated to the variable $_0() = \frac{1}{1} = \frac{0}{100} (;u)$ du. For small times, P(;t) retains its initial gaussian shape, with its amplitude decreasing exponentially.

D. Long tim e regim e

In this subsection we determ ine the long time asymptotic behavior of W (;u;t), utilizing some of the results obtained in the appendix for arbitrary times. In particular, we adapt the kernel expansion of Eq. (A 15) and Eq. (A 16) to the long time regime. Dierentiating Eq. (A 15) with respect to t and with the gaussian choice for () we obtain:

where the integrals in ⁰ and in u range from 1 to +1. The time-derivative of the kernel in the last integral can be obtained with the use of the expression obtained in Eq. (A16) but with the sum mation restricted to non-zero values of the integers m and n. The contribution to the kernel of the term associated with m = n = 0 is time-independent, and it has the form $_{0;0}(;u) _{0;0}(^{0};u^{0})$. We then replace $\mathcal{Q}_{t^{0}}K$ with $\mathcal{Q}_{t^{0}}K^{0}$ where K ⁰ is de ned as the kernel without the rst (m; n = 0) sum mand.

The function K⁰ and its time derivative contain exponentially vanishing terms in t. The time integrand in Eq. (21) will therefore be appreciable only for $t^0 = c_1^1$ where

c is a cuto frequency of the order of j_{1,0} j= . Fort c^{1} we can approximate W (0 ;u⁰;t t) ' W (0 ;u⁰;t) and restrict the time interval from the origin to c^{1} . Integrating by parts, and using the above approximation for W (0 ;u⁰;t), the time integral yields:

E. The two time scales

A santicipated, two di erent scenarios for P (;t) em erge from the analysis carried out in the previous subsections. From Eq. (20), at early times, the decay to the acceptor state is rapid, occurring at a rate $r_1 = \frac{p}{2}$, whereas at latter times the rate is as given above: $r_2 = 0$ (). The ratio between the two is

as follows from the assumptions made on the gaussian (). The initial decay is much faster than that at later times.

F. Num erical results

Based on the general solution of Eq. (A15), we present a numerical analysis of the distribution function W (;u;t) for di erent choices of its arguments. In this equation the probability distribution W (;u;t) is cast in a Volterra-type form ulation, for which solutions can be constructed iteratively in time. The probability distribution W (;u;t) as expressed in Eq. (A15) in fact, depends only on its previous history and on the known propagator function.

For a numerical approach, it is necessary to discretize the ;u;t variables and keep track of the value of W (;u;t) for every position and velocity at every tem poral iteration. W hile feasible, this approach is rather cum bersom e, since for every time step $t_k = k$ twe must create a new O (N²) matrix W ($_{i}$; u_{j} ; t_{k}); 1 i;j Ν, where N is the number of spacings for the position and velocity meshes. On the other hand, the evaluation at of W ($;u_i;t_k$) where represents the *i* interval centered is greatly sim pli ed if the correon the optim al value sponding m esh is chosen so that () m ay be replaced for all purposes by a delta function at non-zero times. The recursive equations now involve only the O (N) element vectorW ($;u_j;t_k$);1 јN.

At t = 0, when the propagator itself is a point source, the gaussian shape for () must be retained for niteness, but the iteration at a time that is far from zero does not involve values of the position that are signi cantly dierent from . The u mesh is chosen with u = 0.05and the time interval spacing is t = 0.01.




FIG.2: The probability distribution at the optim al con guration W (;u;t) for various time intervals. The top curve is evaluated at t = 0 and is the initial Boltzm ann distribution, evaluated at the unlikely con guration . The remaining curves are its time evolution, up to t = 5 of the lower curve.

In order to insure consistency with the constraint $P_{q=2}$ we choose the following parameters: = 10^{4} , $^{2} = 2q$, = 1:5. The parameter for the underdam ped case is chosen as = 0:02, whereas is xed at = 0:4. The resulting probability distribution W (;u;t) is plotted in Figure 2 as a function of u for various time intervals.

Two features of the evolving distribution are notew orthy. The rst is the depression around u = 0. The second is a clear asymmetry in the velocity distribution, in that the distribution for negative values of the velocity, u, is lower than for positive u values. The reason for the rst feature is the fact that when the velocity is low, a pair will remain in a nearly optim alcon guration longer, and hence a tunneling event, leading to depletion of the distribution, is more likely. The asym metry can be ascribed to the fact that the optim al orientation is at positive values of the parameter . The time evolution equation encapsulates two mechanisms, one pushing the distribution towards its Boltzm ann lim it, the other being the tunneling process that leads to depletion of the distribution at values of close to . In light of the trajectory of the underdam ped oscillation, a member of the ensemble with negative velocity, u, is likely to be within a half an oscillation period of having passed with a sm all velocity through , which is positive, while a representative with positive u is more likely to have spent more then half an oscillation period away from the optim al tunneling conguration. This latter, positive u con guration will have had more time to experience the \restorative" e ects of the mechanism that acts to generate the Boltzmann distribution.




FIG.3:P(;t) for the parameters chosen in the text (dotted curves). The inset pertains to early times. The solid curves are drawn for comparison and are exponential decays e^{rt}, with a rate $r_1 = \frac{1}{2}$ for the short times of the inset, and $r_2 = _0$ () for the long time regime. Note the two distinct time scales.

It is also possible to perform a u-variable integration and obtain the time dependence of P (;t). The param – eters are chosen as above, and the two time scale decay of P (;t) can be clearly seen to occur with rates r_1 and r_2 as described in Eq. (27). Also note that both at large and short times P (;t) is proportional to W (;0;t). The above results, and the expressions for r_1 and r_2 are not a ected by changes in the damping variable . As anticipated, Figure 3 clearly shows the double exponential decay of P (;t), in agreem ent with the experimental results of [16, 17].

IV. DISCUSSION

The model we have presented is expected to be of signi cant relevance to charge transfer in DNA. Therm al uctuations strongly a ect the structure of molecule, and an accurate description requires this motion to be taken into account.

N ot only has the existence of uctuations been experim entally docum ented [12], but it has also been suggested [15] that the m otion that m ost a ects the electronic coupling between base pairs - what we have referred to as

() - is their sliding one with respect to the other. It must be pointed out that both these studies focus on DNA in solution, not on dry strands of DNA.

On the other hand, charge transport with more than one rate has been reported in the literature [16]. For an oligomer with the ethedium molecule acting as the donor, charge transfer is found to occur along the sam e patterns as described by our model, with two time scales of 5 and 75 picoseconds. Two-time-scale decays are also observed in a series of measurements [17] performed on shorter strands of donor and acceptor complexes (Ap-G). In these experiments the Ap donor can be treated, for all practical purposes, as an intrinsic purine base, and the ambiguity related to the choice of an extraneous donor (the ethedium of the previous reference) is removed.

In both these experiments, an increase in the length results in a competition between the fast and slow exponential decays in favor of the slower time component. Increasing the length of the system diminishes the possibility that multiple base pairs simultaneously arrange in the con guration that facilitates rapid charge transfer. W hen the process of optim al alignment does occur (a relatively likely event only for a few base pairs), the tunneling m ight not even require localization of the charge on each base pair, and super-exchange can take place.

For long strands of DNA, thus, we expect the two intrinisic rates associated to a single charge transfer to be averaged out in favor of the slower component. Traces of this unusual two time scale migration mechanism however, may be found in the fact that DNA conductivity is enhanced upon increasing the tem perature [32], presum ably allowing for greater base pair motion. Charge transfer is also hindered by disruptions to the stacking, which alter the base pair's ability to nd optim al transfer con gurations, such as the insertion of bulges along the helix or of strong m ism atches within the base pair stacking [33, 34] which are poorly compatible with the intrinsic conform ation of the arom atic pairs. Lastly, it is noted that charge transfer e ectiveness seems to be inversely proportional to the measured hypochrom icity [35], a quantity that determ ines the ordering of base pairs along a certain direction and de ned as the reduction of absorption intensity due to interactions between neighboring electric dipoles. From this data it is apparent that the higher the disorder of the system, the more e cient charge transfer is. It would be interesting to see how different solvent environm ents a ect conduction along the molecule in relation to their e ect on structural uctuations. M ore tem perature-dependent experim entalm easures are desirable as well.

V. CONCLUSIONS

W e have presented a m odel for a spin boson TLS w hose tunneling m atrix elem ent depends on the structural conform ation of the donor with respect to the acceptor. In the lim it that the relative geom etry between the two uctuates in time de ning the lowest energy scale, we are led to a classical problem, that of a collection of dam ped harm onic oscillators obeying a modi ed Fokker-Planck equation. If charge transfer proceeds only for speci c orientations of the donor with respect to the acceptors, the resulting rate for charge transfer is divided into a fast component at short times and a subsequent slower one. These results agree with the experimental ndings of twotim e-scale charge transfer in the donor intercalated DNA com plexes of J.B arton and cow orkers [16, 17]. It must be noted that an implicit assumption of this work is that for long range DNA conduction mediated by thermal uctuations once the charge has undergone a transfer between base pairs it does not return to the pair at which it is originally localized. However, it is reasonable to assume that the transfer process will continue after this event has occurred and that subsequent events will, with som e

probability, deposit the charge at its point of origin at a later time. We have performed calculations on a twotime-scale hopping model based on the results obtained here [36]. In these calculations, the single set of two base pairs is replaced by a linear array. We have determ ined the probability that the charge carrier is at its point of origin as a function of time, t, after its having been placed there. We nd that this probability exhibits two-time-scale behavior, with an initial, brief, rapid, exponential decay followed by a much slower, power-law, decay at later times times. The long-time asymptotics of this process are those of a random walk.

In order to ensure integrability for Eq. (A15), some lim itations are posed on the form of the (${}^{0};u^{0};t^{0}$) function. For instance, the seem ingly most natural choice, a delta function centered around , yields a non integrable expression for W (;u;t) at small times, when the kernel is a product of delta functions itself. Instead, the gaussian choice introduced earlier, with its nite , ensures integrability at all time regimes.
