# A neutron scattering study of two-m agnon states in the quantum $m$ agnet copper $n$ itrate

#### Abstract

W e report $m$ easurem ents of the tw o-m agnon states in a dim erized antiferrom agnetic chain $m$ ate-  one and two m agnon excitation spectra in a large single crystal. The data are in excellent agree$m$ ent $w$ ith a pertunbative expansion of the altemating $H$ eisenberg $H$ am iltonian from the strongly dim erized lim it. The expansion predicts a two-m agnon bound state for $q(2 n+1) d$ which is consistent w ith the neutron scattering data.

## IN TRODUCTION

The basic physics of the elem entary one-m agnon excitations of low er-dim ensional quantum antiferrom agnets can now be regarded as well established, both theoretically and experim entally through studies of $m$ aterials that are reasonably accurate realizations of the spin H am iltonians. In contrast, higher excitations such as multim agnon continua and bound states have attracted relatively little attention. This topic $m$ ay prove to be a fascinating area for the application of few - and $m$ anybody techniques, and will involve interesting and nontrivial results in band structure, band mixing, bound state form ation, phase transitions through the form ation
 and other collective phenom ena.

A though som e aspects of the physics of low -lying m ultim agnon states can be in ferred from m odell H am iltonians using standard theoretical techniques, few experim ental studies of these higher excitations have been reported to date. E xperim ental di culties that have prechuded such w ork include relatively w eak couplings of probes to these higher excitations, dom inant contributions from the lowest one-m agnon excitations, and resolution requirem ents in energy and wavenum ber that are beyond the capabiltities ofm ost techniques.

High-resolution inelastic neutron scattering should prove to be an idealtechnique for observing som e of these higher $m$ agnetic excitations. O ne can controlboth energy and $m$ om entum transfer, so that the existence and spectral w eight of higher m agnetic excitations can be established and quanti ed. T he new generation of high-
intensity neutron sources com bined w ith high-resolution detectors should allow the observation of details of the multim agnon excitation spectrum such as band boundaries, quantitative determ ination of the dynam ical correlation function $S(Q ;!)$ and discontinuities $w$ thin a band $\left[\frac{[8]}{1} 1\right.$, and weakly bound states just below the band edge. The principle lim itation in this approach $m$ ay be the unavoidable $S=1$ selection rule ofm agnetic neutron scattering, so that one can only reach spin $S=1$ excitations given an $S=0$ ground state and an isotropic spin $H$ am irtonian. O ther techniques such as R am an scattering can be used to study certain of these higher excitations, al beit w ith strong constraints on the accessible spin and m om entum quantum numbers.

System s that appear especially interesting for studies of higher $m$ agnetic excitations at present are quasi-1D spin chains and spin ladders, since $m$ any of these have gaps and hence will have separated bands of higher excitations and perhaps bound states of $m$ agnons. The altemating $H$ eisenberg antiferrom agnetic chain (A HC) $w$ ith spin-1/2 is an exam ple of such a system ; w ith any am ount of altemation $0 \ll 1$ (where J2=J1) the AHC has an energy gap in its one-m agnon dispersion w ith a second gap to the multim agnon continuum, and $t w o-m$ agnon bound states $w$ th spin -0 and spin -1 are predicted [9] 1 . The A HC is also attractive because of its relative sim plicity and because of recent extensive theoreticalstudies of the low -energy excitations in thism odel.

In this paper we present results from an inelastic neutron scattering study of higher $m$ agnetic excitations in copper nitrate $\left(\mathrm{Cu}_{\left(\mathrm{NO}_{3}\right)}\right)_{2} \quad 2: 5 \mathrm{DO}$ ) , which was recently con m ed by neutron scattering $\left.[1]_{1}^{1}\right]$ to be an accurate realization of a strongly altemating $H$ eisenberg antifer-
rom agnetic chain. This $m$ aterial is especially attractive because the altemation param eter $0: 27$ is close to the value predicted to $m$ axim ize the separation of the spin -1 tw o-m agnon bound state from the continuum [1] $\overline{1}_{1}^{1}$. In addition it is relatively easy to prepare large single crystals of this $m$ aterial, which com pensates for the w eak neutron scattering intensity from the higherm agnetic excitations.

The two-m agnon continuum states are also show n; these have energies and wavevectors given by the sum of two independent one-m agnon excitations. A $S=1$ bound state is predicted to lie just below the two-m agnon continuum for sm all $w$ avevectors near $k==d$, where the continuum has $m$ inim um width.

The paper is arranged as follow s: Section (2) sum m arizes im portant results from the theory of the ground and excited states of the altemating H eisenberg chain. Section (3) review s the $m$ agnetic properties of $\mathrm{Cu}\left(\mathrm{NO}_{3}\right)_{2}$ $2: 5 \mathrm{D}_{2} \mathrm{O}$, orCN for short. Section (4) presents the results of our $m$ easurem ents, $w$ ith the analysis in term $s$ of the m odel given in section (5). A discussion of the results is given in (6), w ith conclusions in (7). A dditional theoretical results for tw o-m agnon excitations in this $m$ odel are given in the A ppendix.

THEORY

The spin $-1 / 2$ altemating $H$ eisenberg chain has received much attention in the theoretical literature. This sim ple model plays a central role in the study of the spinPeierls e ect, and is also know $n$ to provide an accurate

description of the $m$ agnetic properties of $m$ any realm aterials. T he m odel consists of antiferrom agnetically coupled H eisenberg spin pairs, \dim ers", which are them selves coupled by weaker antiferrom agnetic H eisenberg interactions in an altemating chain, as show $n$ in $F$ ig 2. The $H$ am iltonian for this $m$ odel is given by
where $N$ is the number of spins in the chain, $J>0$ (also called $J_{1}$ ) is the intradim er coupling, $J$ (also $J_{2}$ ) is the interdim er coupling, and is allow ed the range $0 \ll 1$. The index $m$ labels the dimers, and and + denote left and right spins. The position of each spin is given by $r_{m} ;=m d \quad=2$, where $d$ is the chain repeat vector, and is the intradim er separation.


FIG . 2: A ltemating chain layout show ing dim ers coupled together. Each dim er is labeled by an index $m$, is the separation betw een dim er spins, and $d$ is the chain repeat vector.

This $m$ odel has a nontrivial spin-0 ground state, and for all in the allowed range $0 \ll 1$ has a gap to the rst excitation, which is a band of spin-1 excitations (m agnons). In the \strong-coupling lim itl 1 the ground state approaches a system of uncoupled spin0 dim ers, and the one-m agnon excitations can be accurately described as a single dim er excited to spin-1 (an \exciton"), delocalized on the chain to give states of definite along-chain w avenum ber $k$. T he energies and som e $m$ atrix elem ents of these states have been evaluated as power series in the intradim er coupling $\left[11,1 \overline{1} \overline{2}_{1}\right]$.

To interpret experim entalresults approxim ate analytic form sof the $w$ avefiunctions and energies are usefuland we include calculations of w avefunctions expanded around the single dim er eigenstates in the A ppendix. The onem agnon $\mathrm{S}=1$ triplet has a gap energy $=\mathrm{J} \quad \mathrm{J}=2$

This m agnon wavefunction can be visualized as a localized w avepacket ofm agnetic polarization (excitons) along $x ; y$; or $z$ carrying total spin-1 travelling through a featureless singlet background w th the gap energy com ing from the e ort expended in breaking a dim er bond.

A pproxim ate $w$ avefunctions for the tw o-m agnon states are given in the Appendix. At large separations the $m$ agnons do not overlap and they behave as free particles, how ever when close they interfere and scatter o each other. In a one dim ensional geom etry such scattering conservesparticle num ber, energy, and $m$ om entum up to a lattice wavevector, and the scattering introduces a m om entum dependent phase shift in the scattered wavefiunction. The energy of these states (to order $0(1=\mathrm{N})$ ) is given by $!_{k_{1} ; k_{2}}(k)=!_{1 m}$ ag $\left(k_{1}\right)+!_{1 m}$ ag $\left(k_{2}\right)$, where $\mathrm{k}=\mathrm{k}_{1}+\mathrm{k}_{2}$ is the total wavevector. T he resulting continuum using equation (2) is illustrated in F ig. 1 [8].

A s well as elastic scattering ofm agnons, bound states also form. To appreciate their physical origin consider two dim ers, both in excited states, coupled by a single interdim er coupling $J$. In the absence of coupling all the double excited states $S=0 ; 1$; and 2 have the sam e energy 2 J . H ow ever, the interdim er coupling splits these states. There is an $S=2$ quintuplet of energy $2 J+J=4$ (this energy is higher because the interdim er coupling favours antiferrom agnetism whereas the $S=2$ states have all spins along the sam e direction - ferrom agnetic). There is also an $S=1$ triplet of energy $2 J \quad J=4$, this lowering of energy is purely quantum $m$ echanical and com es from resonance betw een the two excited dim ers. Finally there is an $S=0$ singlet of even low er energy, 2J J=2, which gains resonance and also antiferrom agnetic energy due to the spins in neighboring dim ers pointing in opposite directions.

As the $S=0$ and 1 states w ith excited dim ers neighboring each other have low er energy than tw o well separated excited dim ers (by $J=4$ and $J=2$ respectively) there is a short range attractive potential. M agnons can be con ned w thin the potential well (bound states) as long as the relative kinetic energy betw een the $m$ agnons is sm aller than the interaction energy.
$T$ his situation applies to the bound states in the A H C , the $S=0 \mathrm{~m}$ ode at all w avevectors and the $S=1 \mathrm{~m}$ ode over lim ited w avevectors around the node points. T hese are positions w here the kinetic energy is sm all com pared to the binding potential. The $S=1$ bound state is visible to neutron scattering and has a dispersion

The bound state is characterized by a probability am plitude for the separation betw een the tw $o m$ agnons that

drops exponentially w ith distance (see appendix form ore details). These $S=1$ bound states exist only over the range jn $\operatorname{kdj} 6=3$, where $n$ is an odd integer, see Fig. 1.

MAGNETICPROPERTIESOFCU(NO3) 2 2:5D2

The structural and $m$ agnetic properties of $C N$ have been thoroughly investigated and show $n$ to be near ideal. $T$ he structure of $\mathrm{Cu}\left(\mathrm{NO}_{3}\right)_{2} \quad 2: 5 \mathrm{HO}$ was investigated by $G$ araj $\left.[1]_{1}^{4}\right]$ and $M$ orosin $\left.[1]_{2}^{-1}\right]$, and was show $n$ to have a monoclinic crystal structure with space group $112=c 1$ [1] ]-] and the lattioe param eters and crystallographic copper positions given in Table II. T he deuterated form $\mathrm{Cu}\left(\mathrm{NO}_{3}\right)_{2} \quad 2: 5$ O we studied has low tem perature ( $\mathrm{T}=$ 3 K ) lattice param eters $a=16: 1, b=4: 9, c=15: 8 \mathrm{~A}$ and $=92: 9$ [10 $\left.{ }^{-1} \mathbf{O}_{1}^{\prime}\right]$.
Them agnetism of CN arises from the $\mathrm{Cu}^{2+}$ ions. C rystal electric elds from the oxygen ligands surrounding the $\mathrm{Cu}^{2+}$ ions quench their orbital mom ents, leaving a near-isotropic spin-1/2 m om ent $w$ th $g$-values that show a sm alleasy-ax is anisotropy along the crystallograph ic bdirection; the values are $g_{k b}=2: 33$ and $g_{? ~} b=2: 09$ [1] $\left.\overline{1}_{1}\right]$. $M$ agnetic superexchange in this $m$ aterial is $m$ ediated by long double $\mathrm{Cu}-\mathrm{O}-\mathrm{O}-\mathrm{Cu}$ exchange paths, which accounts for the rather weak exchange interaction observed in CN.

The exchange couplings of CN were studied by Eckert et al. in [1d] and are illustrated in $F$ ig. 3. T he dom inant $m$ agnetic exchange integral $J$ is between pairs of spins (copper positions $7 \& 8$, and equivalent pairs, c.f. Fig. 3) form ing dim ens w ith a separation of 5.3 A. These dim ers separated by crystalvector $u=\left[u_{1} ; u_{2} ; u_{3}\right] \quad u_{1} a+u_{2} b+$ $u_{3} C$ are coupled together by exchanges $J_{u}^{0}$; the only exchange paths of appreciable strength are $\left.J_{\left[\frac{1}{2} ;\right.}^{0} \frac{1}{2} ; \frac{1}{2}\right]$, connected via bonds between $1 \& 7$ and equivalent (bond length 62 A$)$. This results in two sets of $S=1=2$ altemating $H$ eisenberg chains running in the $[1 ; 1 ; 1]$ and $[1 ; \overline{1} ; 1]$ directions of the crystal $w$ ith repetition every
$d=[1 ; 1 ; 1]=2$ and $d^{0}=[1 ; \overline{1} ; 1]=2$ respectively (repeat distance $d=11: 3 \mathrm{~A})$; the corresponding intradim er vectors are $=[0: 252 ; 0: 027 ; 0: 228$ ] (where the $x ; y ; z$ positions from Table II have been used). Inelastic neutron scattering $m$ easurem ents $\left[\underline{1} \underline{0}_{1}^{-1}\right]$ have recently further conm ed the m odelaltemating $H$ eisenberg chain properties of CN and have shown that the dom inant collective excitations are indeed the gapped triplet of $m$ agnons expected for the A H C .

## A pproxim ate ground state energy

Bulk $m$ agnetic $m$ easurem ents give inform ation on the gap, exchange, and ground state energies of the spin chains in copper nitrate. $M$ easurem ents of the e ect of applied $m$ agnetic eld show that spin op (SF) ordering is induced in $C N$ above a critical eld $\mathrm{B}_{\mathrm{c} 1} \quad 2: 7 \mathrm{~T}, \mathrm{w}$ ith a transition to full alignm ent at $\mathrm{B}_{\mathrm{c} 2} \quad 4: 3 \mathrm{~T}$ and there are no dem agnetization e ects in the zero tem perature lim it [ $\left[19{ }^{\prime}\right]$. A s the orbitalm om ent on the $\mathrm{Cu}^{2+}$ ions is quenched by the crystal electric eld and dem agnetization e ects are negligible, the eld $\mathrm{B}_{\mathrm{cl}}$ can be used to directly give the excitation gap energy to the one-m agnon states, and D iederix et al. report a value of $=0: 378 \quad: 007 \mathrm{~m} \mathrm{eV}$ [19]

The gap can be inferred from the transition eld because the $m$ agnons carry spin quantum numbers $S^{z}=$ 1;0; 1 and are split into three dispersive $m$ odes shifted by a Zeem an energy w ith respect to each other. The ground state by virtue of its spin-0 quantum num ber is una ected by the eld and the transition occurs when the Zeem an energy of the low est $m$ ode closes the gap
and $m$ agnons condense into the ground state. $T$ he long range order itself is due to weak couplings betw een the chains.

Thehigh eld transition, $\mathrm{B}_{\mathrm{c} 2}$, yields further im portant in form ation. It is where all the low-lying $m$ agnons are com pletely condensed into the ground state and the spins are fully aligned along the eld. The fully aligned state is an exact eigenstate, and for an unfrustrated quantum $m$ agnet the transition eld gives the sum of exchange couplings $g_{\mathrm{B}} \mathrm{B}_{\mathrm{c} 2}=\mathrm{J}+{ }_{\mathrm{u}} \mathrm{J}_{\mathrm{u}}^{0}=0: 580 \quad: 007 \mathrm{meV}$ in the system [1] ${ }^{[1]}$. A n estim ate of the ground state energy of $C N$ can be $m$ ade using these num bers.
$U$ sing the low tem perature isotherm alm agnetization $\mathrm{M}(\mathrm{B})=\mathrm{g}_{\mathrm{B}} \mathrm{hS}^{\mathrm{z}} \mathrm{i}_{\mathrm{B}}$ as a measure of the work required to saturate the spin chains from the zero- eld quantum ground state, an energy-per-spin can be inferred. The zero-eld ground state energy-per-spin $e_{0}$ can be estim ated via the form ula $e_{0}$ e $\quad g_{B} S B C_{C 2}+$ $0_{0}^{R_{B 2}} M$ (B)dB where the fully-aligned energy-per-spin is $e_{f}=S^{2}=2 \quad\left(J+{ }_{u} J_{u}^{0}\right)=g_{B} B_{C 2}=8=0: 0725 \quad: 001 \mathrm{~m} \mathrm{eV}$ for a $S=1=2$ unfrustrated system . U tilizing the 270 m K data of $D$ iederix et al. in $F$ ig. 3 of $\left[\begin{array}{c}{[19}\end{array}\right]$ ( $m$ easured using proton resonance) to determ ine the integral overm agnetization gives an experim ental ground state energy-perspin $e_{0}=0: 174 \quad: 004 \mathrm{~m} \mathrm{eV} . \mathrm{T}$ his is essentially the $\mathrm{T}=0$ result, as the gap activation energy corresponds to 4.4 K .

To estim ate them odynam ic properties we approxi$m$ ate the sum of the interdim er exchanges by the single coupling $J={ }_{u} J_{u}^{0}$ of equation (1). U sing the O ( ${ }^{9}$ ) expansions [1] [1] for ( ) and e o gives $J=0: 455$ $: 002 \mathrm{meV}$ and $=0.277$ :006; in agreem ent w th the results of $[1]$ d $]$ and $[2 d], J=0: 45 \mathrm{meV}$ and $=0: 27$. O ur caloplated values of the them odynam ic param eters $J+{ }_{u} J_{u}^{0}=0: 581 \mathrm{meV}, \quad=0: 379 \mathrm{meV}$ and $e_{0}=0: 172 \mathrm{meV}$ agree w ithin error w ith the experi$m$ ental values.

is the Fourier transform ed spin creation operator.
$T$ he action of the neutron is to ip a spin and so create a localized spin-1 polarization in the chain, and the strength of scattering to particular states is determ ined by their overlap w ith this spin ip state. This means that the $m$ ultiparticle states $w i l l$ be sam pled $w$ ith particles created close together. T his is where interactions of the particle wavefunctions are $m$ ost im portant, $m$ aking neutrons a sensitive technique for looking at overlap effects. A $n$ interesting consequence of th is is that the short range interactions betw een particles can have a large inuence on $m$ easured correlation functions $w$ ith little effect on the therm odynam ics of the spin chain, an e ect noted for spinons in uniform chains [24]. Sim ilarly, the therm odynam ic in uence ofbound states at low tem peratures vanishes as $1=\mathrm{N}$ yet they have a nite scattering cross section as discussed below .

N eutron scattering m easurem ents

W e m ade our m easurem ents of the inelastic scattering cross-section of CN using the SP $\mathbb{I N} S$ cold neutron triple-ax is spectrom eter at the N IST C enter for $N$ eutron R esearch. The sam e high quality sam ple of copper nitrate used by $\mathrm{X} u$ et al. [10 [1] w as utilized. This 14.1 g sam ple consists of four coaligned single crystals of CN, w ith deuterium substituting for $92 \%$ ofhydrogen. T he substitution ofD for $H$ wasm ade as it reduces signi cantly the background from incoherent scattering of neutrons but does not change the $m$ agnetic properties of the $m$ aterial. The sam ple was m ounted with ( $h ; 0 ; 1$ ) as the scattering plane in a pum ped ${ }^{3} \mathrm{He}$ cryostat at a base tem perature of 300 m K . This tem perature is an order of m agnitude sm aller than the gap energy ( $4: 4 \mathrm{~K}$ ) and the collective
quantum ground state is alm ost entirely free of therm ally produced $m$ agnons, $w$ th a population of these num bering less than one per tw o $m$ illion dim er sites.

The two-m agnon scattering is expected to be weak as the neutron $m$ atrix elem ent to it is of $O\left({ }^{2}\right)$ from the ground state so the spectrom eter was set up in an open con guration to gain $m$ axim um scattered signal, and the only collim ator included in the setup was of $80^{\circ}$ betw een m onochrom ator and sample. A vertically focused pyrolytic graphite PG (002) array m onochrom ated the incident neutrons (energy $\mathrm{E}_{\mathrm{i}}$, wavevector $\mathrm{k}_{\mathrm{i}}$ ) and a horizontally focused array com posed of eleven independently ro! tatable P G (002) bladesw asem ployed to analyze the scattéred neutrons ( $E_{f}, \mathrm{k}_{\mathrm{f}}$ ). A cooled Be lterwasplaced in the incident beam before the sam ple to rem ove higherorder contam ination from the beam. The actualneutron energy transfer to the sample being $\hbar!=\mathrm{E}_{\mathrm{i}} \quad \mathrm{E}_{\mathrm{f}}$ and the $w$ avevector transfer is $Q=k_{i} \quad k_{f}$.
$M$ easurem ents of scattering cross-section were $m$ ade by xing the nal energy at $E_{f}=2: 5 \mathrm{meV} \quad \mathrm{k}_{\mathrm{f}}=1: 10$ $A^{1}$ ) and scanning incident energy $E_{i}$ at various xed w avenum ber transfers along the chain, $\mathrm{k}=\mathrm{Q}$ (i.e. the com ponent of the scattered wavevector along the im portant chain direction). A though there are actually two types of chain in $C N$ ( $w$ th repeats $b=[1 ; 1 ; 1]=2$ and $\left.\mathrm{b}^{0}=[1 ; \overline{1} ; 1]=2\right)$ this is not im portant in our case -we study the ( $\mathrm{h} ; 0$; l) scattering plane where the chains give identical contributions (see Fig. 3).
$W$ ith an open scattering con guration instrum ental resolution is an important consideration. The spectrom eter resolution represents the spread in coordinate space ( $Q ;!$ ) sampled by the instrum ent at each $m$ easured point. The energy resolution of the spectrom eter is of aussian pro lew ith a full-w idth-halfm axim um ( FW HM ) at $\mathrm{E}_{\mathrm{f}}=2: 5 \mathrm{meV}$ and $\hbar!=0: 8 \mathrm{meV}$ of $0: 10$ meV . The Q resolution is dom inated by the w ide angular acceptance (14) of the analyzer on the scattered side - it is highly elongated along a direction $w$ ithin the scattering plane that is perpendicular to the scattered wavevector - and approxim ating the $m$ easured angular dependence by a Gaussian pro le gíves a FW HM of $0: 2 \mathrm{~A}^{1}$. This resolution width is very considerable, how ever by using calculated scan trajectories that $m$ aintain the nal w avevector $\mathrm{k}_{\mathrm{f}}$ along the crystallographic $(1 ; 0 ; 1)$ direction, so as to integrate over the nondispersive directions betw een chains, good wavenum ber resolution in $k$ along the im portant quantum spin chain directions (estim ated at of order 0:02 $\mathrm{A}^{1}$ ) is m aintained.

## RESULTSAND ANALYSIS

Fig. 4 show s som e of the results of scans in energy perform ed on CN: Panel (a) shows a scan at the antiferrom agnetic zone-center, $\mathrm{k}=2=\mathrm{d}$, taken at $\mathrm{T}=$ 300 m K . This is the wavenum ber along the chain where

the $m$ agnon energy is a $m$ in $\dot{m} u m$, c.f. $F$ ig. 1. Strong elastic scattering from incoherent nuclear processes is clearly seen as well as a peak at 0.4 meV as expected for the one $m$ agnon $m$ ode [10 $1_{1}^{\prime}$, close to the dim er excitation energy $J=0: 45 \mathrm{~m} \mathrm{eV}$. A second m uch w eaker peak appears at roughly double the dimer energy at about 0.9 meV , which is where two-m agnon scattering is expected. On heating up the sample both the 0.4 meV and 0.9 meV peaks disappear identifying these as being $m$ agnetic in origin.

H eating up the sam ple also identi es the non-m agnetic background contribution (dashed line in the gure) which consists of the incoherent nuclear peak, m odelled by a G aussian centered at zero-energy, and a broad contribution from therm al di use scattering from the analyzer which is well-characterized by a pow er-tim es-Lorentzian (broad, quasielastic) component decaying from zeroenergy. A s the background is large com pared to the two $m$ agnon signal it $w$ as studied in depth at di erent tem peratures and w avevectors.

Panels (b) and (c) of Fig. 4 show this peak w th the m odelled nonm agnetic background subtracted at $\mathrm{k}=$ $2=\mathrm{d}$ and $\mathrm{k}=3=\mathrm{d}$, respectively. This feature is considerably weaker than the one-m agnon scattering. The FW HM of the peak narrows from $0.18(1) \mathrm{m} \mathrm{eV}$ at $2=\mathrm{d}$, panel (b), to 0.11 (1) meV at the zone-boundary ( 3 d ), panel (c); behavior indeed consistent w ith tw o-m agnon scattering.

Fig. 1 show s the energy corresponding to a weighted average of scattering as a thick grey line. It is notable that at $k=3=d$ to a good approxim ation the neutrons
couple only to the bound mode, so that nearly all the scattering weight is in it, not the continuum. T he calculated neutron scattering intensity from the bound state is $2 \%$ of the one-m agnon intensity which agrees $w$ ith the data in Fig. 4.

The one- and two-m agnon scattering at 300 m K was scanned from $k==d$ to $5=d$ in steps of $=4 \mathrm{~d}$. The background subtracted data are plotted in the upper panel of $F$ ig. 5. T he lower panel show $s$ the calculated $m$ agnetic scattering based on the 1D perturbation theory of the A ppendix w th the estim ated param eters $J=0: 45$ and $=0.27$. The calculation includes the correct dim er structure factor e ects and uses the true scan trajectories in conjunction $w$ th the dim er coordinates given in Table II. C orrections for the $\mathrm{Cu}^{2+} \mathrm{m}$ agnetic form factor [23-1] have also been m ade. Instrum ental line broadening has been included as well by convolving the theoretical calculations $w$ ith the estim ated instrum ental resolution and sam ple $m$ osaic spread. The calculation is directly com parable w ith the data in the upper panel of $F$ ig. 3, and at a qualitative level there is good agreem ent w ith experim ent.
$N$ ext we consider the $m$ easured one- and two-m agnon scattering in $m$ ore detail and relate this to the physical picture presented by perturbation theory. A quantitative com parison betw een theory and data is show $n$ in $F$ ig. 6 . The $m$ easured positions of one- and tw o-m agnon peaks are plotted in the left panel. Energies, widths and intensities for each peak were extracted by least-squares tting of $G$ aussians. In fact the w avevector and energy resolution w as not su ciently good in this experim ent to distinguish details of line shape and the energies, widths and intensities represent the $m$ eaningful content of the $m$ easured data. W e exam ine the one-m agnon scattering rst.

> O ne-m agnon scattering
$D$ ispersion: $T$ he $m$ easured dispersion of the one$m$ agnon states is show $n$ in the left hand panel of $F$ ig. 6. C onsiderable dispersion of the one-m agnon $m$ odes around the dim er energy ( 0.45 m eV ) is evident as expected. A though the one $m$ agnon dispersion has been calculated to high order $O$ ( ${ }^{5}$ ) [ [11] previously, the sm all value of in CN m eans that the one-m agnon dispersion should be well approxim ated by the 0 ( ) result, equation (2). In fact the dispersions in $C N \mathrm{~m}$ easured by $\mathrm{X} u$ et

weak interdim er couplings $\mathrm{J}_{[1=2 ; 0 ; 0]}^{0}=0: 012(2) \mathrm{m} \mathrm{eV}$ and $J_{[0 ; 0 ; 1=2]}^{0}=0: 018(2) \mathrm{m} \mathrm{eV}$. T he altemation ratio that X u et al consider $=J_{[111]=2}=J=0.240(5)$ is sm aller than that found from the $m$ agnetization data discussed above which is presum ably due to the neglect of interchain coupling e ects in the analysis of the latter.
$T$ he solid line through the one $m$ agnon dispersion in Fig. 6 is that calculated using the results of [1] and it gives a reasonable account of the data. T he sm all discrepancies from the peak-centers $m$ easured here are attributable due to the e ects of the instrum ental resolution which averages over a large sw athe of the interchain dispersion $m$ odulation.

Intensity: The lower right-hand panel of Fig. 6 shows the onemagnon intensities extracted from $t$ ting. The neutron scattering $m$ atrix elem ent $S^{+} \quad(Q)$

The leading order scattering process is from the bare dim er com ponent of the ground state, and the $=2$ $\cos (\mathrm{kd})$ com ponent in the one m agnon structure factor arises from an $O($ ) two-dim er excitation in the ground state. T he dynam ical structure factor then re ects both the com position of the ground and excited states leading to a com plex wavevector dependence.

An interesting aspect of the one-m agnon intensity $S_{1 \mathrm{~m} \text { ag }}^{+}(Q)$ noted in []$\left._{1}^{1}\right]$ is that the spin structure factor com es in only as a ( 1 cos(Q )) modulation. So where $\mathrm{Q} \quad=2 \mathrm{n}$ ( n integer) the m agnetic intensity should be zero. A though this situation occurs for the $m$ easurem ents at the w avenum ber $\mathrm{k}=3: 9=\mathrm{d}$, the scattering does not go to zero because of residual intensity from secondary elastic scattering from incoherent processes. Such residual scattering was also observed in CN by Xu et al. $\left[{ }^{-1} \underline{O}_{1}^{\prime}\right]$. T he solid line in the gure then is the scattering intensity predicted using equation (4) w ith $J=0: 45$ meV and $=0.27$ including secondary scattering, as well as instrum ental resolution and $m$ agnetic form factor. It is seen to account very well for the observed scattering intensity. W e now consider the two-m agnon scattering.

## Two-m agnon scattering

Integrated peak intensities, w idths and positions extracted using the tting $m$ ethod described above for the tw o-m agnon scattering are also plotted in F ig. 6. The peak positions are plotted in the left panelofF ig. 6 (lled circles). They are nearly dispersionless at an energy of
$0: 86 \mathrm{~m} \mathrm{eV}$. T he peak w idths are plotted in the top righthand panel. $T$ hese are largest around $k=2=d$ and $4=d$ where the continuum is expected to be widest, and are near resolution lim ted around $=\mathrm{d} ; 3=\mathrm{d}_{\mathrm{R}}$ and $5=\mathrm{d}$. A lso shown is the integrated peak intensity $d!I(!)$, where $I(!)$ is the intensity, which peaks around $k=2=d$.

Intensity: $T$ he integrated peak intensity of the m easured two magnon scattering includes a sum over the two-particle continuum and $S=1$ bound mode. Taking account of the density of $m$ om entum states $w$ ith energy transfer, the scattering intensities for the continuum (eqn. (17)) and bound (eqn. (18)) states as described in the Appendix were com puted. A s interchain e ects are e ectively integrated over in the two-m agnon scattering, and this results in line broadening rather than shifts in energy; we thus have im plicitly included interchain coupling e ects in ourde nition of $=0: 27$ for (1).

The energy integrated tw om agnon intensity, $d!I(!)$, (right m iddle panel) show s a m ore com plicated $k$ dependence than the one $m$ agnon scattering. The com parison with the $O\left({ }^{2}\right)$ calculation looks qualitatively sim ilar to the data, how ever it underestim ates the scattering at $\mathrm{k} \quad 9=2 \mathrm{~d}$ and overestim ates it at $2=\mathrm{d}$, which m ay indicate that higher order tem $s$ in the scattering am plitude are im portant. It is notable that the tw o-m agnon intensity is very strongly dependent on the spatial arrangem ent ofm agnetic ions.

C enter: the tted peak centers are com pared w th the com puted weighted center h! i = d! I (!) ! (gray band) for the $O$ ( ${ }^{2}$ ) perturbation theory in the left panel of F ig. 6. T he nearly dispersionless extracted positions (grey led circles) are located at the calculated weightedaverage energies (grey band) replotted from Fig. 1. T he fact that the w eighted center lies below the center of the continuum is a direct result of them ovem ent of scattering weight tow ards the low er boundary due to the $m$ agnonm agnon interaction.

W idth: the peak widths obtained from the ts are shown in the top right-hand panel. The solid line represents that calculated using the perturbation theory. It is the sum-in-quadrature of the instrum ental resolution w idth in energy and the variance of the theoretical intensity where ${ }^{2}=d!I(!) \quad(!\quad h!$ if . The calculation is seen to provide a good account of the data.

B ound $m$ ode: O ne of the $m$ ost interesting aspects of them ultiparticle states in the A H C is the existence of the bound m ode below the tw o-m agnon continuum. The predicted wavevector dependence of the intensity (see Appendix) is

and should be visible around $k=3=d$. The binding energy of the $S=1$ state, neglecting interchain coupling, is predicted to be [11'] $\mathrm{E}_{\mathrm{B}}=\mathrm{J} \frac{1}{4} \quad \frac{13}{32}{ }^{2}=0: 017$ meV for CN . The scattering in CN around $\mathrm{k}=3=\mathrm{d}$ is centered at $0: 852 \quad: 007 \mathrm{~m} \mathrm{eV}$, which gives a binding energy of $\mathrm{E}_{\mathrm{B}}=0: 03: 02 \mathrm{meV}$. In addition the scattering is near resolution lim ited, as expected for a wellde ned m ode. How ever, although the energy and intensity around $k=3=d$ lend support to binding around this bandw idth $m$ inim um, the experim ental error $m$ eans this does not constitute de nitive proof of the e ect in CN.

## D ISC U SSIO N

O ur m easurem ents establish the feasibility of studying weak multi-m agnon states using neutron scattering and raise a num ber of im portant issues. Firstly the introduction of experim ental data highlights the need for
practicaltechniques for calculating them ultiparticle excitation spectra and cross sections for realistic spin $m$ odels. O urperturbation theory, although usefiul for interpreting results, is of too low order to quantitatively account for ourm easurem ents and in addition does not include interchain coupling. Very powerfiul linked-cluster-expansion techniques have recently been introduced that allow m ultiparticle spectra to be calculated to high order[25 for the AHC and the extension of these to calculations of the neutron scattering cross-section w ould be a signi cant developm ent. A nalyticalapproachesbased on G reen function techniques $m$ ay also prove fruitful. Secondly, $m$ easurem ent of weak $m$ ultiparticle signals preludes the access of neutron scattering to $m$ easuring bound tw O m agnon states. Interactions such as next nearest neighbor coupling should further stabilize bound $m$ odes and $m$ ake $m$ easurem ent of these easier. A question which requires fiurther investigation is the stability of such bound m odes to them al uctuations and also interchain coupling. An altemative route for investigating the phenom enology of particle binding is through solitonic system s such as the 1D Ising chain w ith sm allX Y -like term s [ $\left.{ }_{2}^{2}\right]_{1}$. In this case the coupling of neutrons to pairs of $S=1=2$ solitons (also called spinons) is at zeroth order and therefore strong. B inding of solitons only occurs when extra term s are included in the $H$ am ittonian, such as exchange $m$ ixing [2], next-nearest neighbor coupling
 phenom enon in and Ising-like chain has been observed recently in neutron scattering experim ents [" p id].

Timeof ight (TOF) neutron spectrom eters give potentially $m$ uch better energy resolution than conventional triple-axis instrum entation and could provide de nitive proof of the bound state in the altemating chain by resolving the bound $m$ ode from the continuum . Previously, TOF techniques have proven successfiul in the study of sim ilarbinding e ects at the bandw idth $m$ inim um of the two-soliton continuum scattering of the $S=1=2 \times \mathrm{XX}$ Ising chain $m$ aterialC sC oC $l_{3}$ [2"]. A though lim ited neutron uxes $m$ ay $m$ ake such $m$ easurem ents di cult for $C N$ [ [101] these should be feasible and we plan to $m$ ake such $m$ easurem ents in the near fiuture.

## SUM M ARY

In sum $m$ ary, we have used inelastic neutron scattering to investigate the ground and excited states of the nearideal altemating H eisenberg chain m aterial $\mathrm{Cu}\left(\mathrm{NO}_{3}\right)_{2}$ $2: 5 \mathrm{D}_{2} \mathrm{O}$, and also derived the scattering analytically to low est order in perturbation theory. O ur m easurem ents are consistent $w$ th the predictions of this $m$ odel for several m agnetic properties of this system, including the ground state energy, one- and two-m agnon excitation spectra and intensities, and possibly the existence of a

tw o-m agnon bound state. M uch experim ental work re$m$ ains to be done to establish the phenom enology ofbinding in isotropic 1D system s .

An interesting feature of the bound state solution is that it only exists over the range jn $\mathrm{kdj} 6=3$, where n is an odd integer, and so there is an $S=1$ bound mode only for sm all wavevectors around the narrow est part of the continuum. U sing our wavefunction we calculate the neutron scattering strength from the bound state to be
