R esonant M agnetic Vortices

By using the complex angular momentum method, we provide a sem iclassical analysis of electron scattering by a magnetic vortex of A haronov-B ohm -type. Regge poles of the S-matrix are associated with surface waves orbiting around the vortex and supported by a magnetic eld discontinuity. Rapid variations of sharp characteristic shapes can be observed on scattering cross sections. They correspond to quasibound states which are Breit-W igner-type resonances associated with surface waves and which can be considered as quantum analogues of acoustic whispering-gallery modes. Such a resonant magnetic vortex could provide a new kind of articial atom while the sem iclassical approach developed here could be protably extended in various areas of the physics of vortices.

I. IN TRODUCTION

M odem electronic technology is based on the control of the current and, with this aim in view, arti cial structures such as quantum wires, dots and other nanoscaled devices have been developed (see, for example, R ef. 1 and references therein). In this context, the A haronov-B ohm (AB) e ect [2, 3, 4] is now adays often involved: a m agnetic ux threading a con ned region with leads is used to modify the electron transport behavior. With this in m ind, we study, in this paper, an arti cial structure which presents richer scattering properties than the ordinary ux lines usually considered. Such a system could provide a new kind of arti cial atom.

Here, we consider the scattering of a spinless electron (m ass M, charge e and total energy E) by the magnetic vortex de ned, in the cylindrical coordinate system (;';z), by the electrom agnetic potential

with $R_1 < R_2$. In Eq. (1), the scalar potential describes a hard core which prevents the electron from entering the region $< R_1$ while the vector potential describes, in the radial gauge, the magnetic eld $B = (=2)(() (R_2))e_z$: This eld consists of a ux line at = 0 (the usual AB ux line) and an in nitely thin magnetic eld shell localized at $= R_2$. Inside the region $< R_2$, the total ux is given by

while outside this region it vanishes. Such a vortex was rst suggested by Aharonov in order to avoid the am biguities of the incom ing wave function of the electron in the AB scattering, am biguities arising from the long range behavior of the vector potential. It was studied by Liang in Ref. 5.

In this article, the scattering of the electron is analyzed from a sem iclassical point of view by using the complex angularm om entum (CAM) method. It should be noted that this method has been extensively used in several domains of scattering theory since the pioneering work of W atson [6] dealing with the propagation and di raction of radio waves around the earth (see the monographs of Newton [7] and of Nussenzveig [8] and references therein for various applications in quantum mechanics, nuclear physics, electrom agnetism, optics, acoustics and seism ology). As far as we know, the CAM method has never been introduced in the context of the AB e ect (see, however, the end of Ref. 9 where Berry envisages the possibility of such an approach) or in order to study the electron scattering by a magnetic eld as well as its resonant aspects. As we shall show below, this sem iclassical approach perm its us to emphasize the aspects of scattering linked to tim e-reversal invariance breaking as well as the rich resonant properties of the magnetic vortex and m ore particularly the existence of quasibound states associated with surface waves orbiting around the vortex and supported by the magnetic eld shell.

II. EXACT S-MATRIX AND RESONANCES

From now on, we treat our problem in a twodimensional setting, ignoring the z coordinate. We denote by \hat{H} the Ham iltonian of the electron and we introduce its wave number k = 2M E = - as well as the quantum ux parameter = e = 2 - We are rst interested by the construction of the S-m atrix. Because of the cylindrical symmetry of the vortex, the S-m atrix is diagonal and its elements S $_{m}$ are given by S $_{m} = S$, $_{m}$. For a given angular momentum index '2 Z, the coe cient S \cdot is obtained from the partial wave \cdot solution of the following problem [10]:

In the region R $_1 < ~<$ R $_2$, $\hat{H}^{}$ is the standard A B H am iltonian given by

and the solution of (i) is expressible in terms of Bessel functions (see [11]) as a linear combination of J. (k) $e^{i''}$ and H.⁽¹⁾ (k) $e^{i''}$. Let us recall that in the usual AB scattering, the Bessel function indices are j' jwith '2 Z. Here, absolute values are unnecessary because we do not require the regularity of the modes at = 0. In the region > R₂, \hat{H} reduces to the free H am iltonian and the solution of (i) can be constructed from J. (k) $e^{i''}$ and H.⁽¹⁾ (k) $e^{i''}$. As a consequence, the partialwave \cdot solution of (i) and (ii) can be obtained exactly. Then, by using the standard asymptotic behavior of H ankel functions [11], we nd from (iii) the expression of the diagonal elements S. of the S-matrix:

The unitarity of the S-m atrix [7], which expresses the probability conservation, can be easily veri ed by using elementary properties of Bessel functions. The reciprocity property [7], which is associated with time-reversal invariance, is not satis ed because $S \cdot is$ not an even function of '. Furthermore, the S-m atrix is not invariant under the change ! + 1. Here, and by contrast to the case of the ordinary AB scattering, the electron can distinguish between two uxes which di er by an integer multiple of $2 \sim = e$.




FIG .1: The norm alized total cross section $\ _{\rm T}$.




FIG .2: Scattering resonances in the complex kR_1 -plane.

From the S-matrix, one can construct the scattering amplitude

while the total scattering cross section can be obtained by using the optical theorem :

In Fig.1, we present the total cross section as a function of kR_1 . As far as the num erical aspects of our work are concerned, we restrict ourselves to the particular con guration = 9 and $R_2 = 3R_1$ (we note, how ever, that the results emphasized num erically are very general) and we furtherm ore use the reduced wave num ber kR_1 instead of the wave num ber k. Rapid variations of sharp characteristic shapes can be observed. This strongly uctuating behavior is due to scattering resonances. These resonances are the poles of the S-m atrix lying in the fourth quadrant of the com plex k-plane and they are determ ined by solving

The solutions of (7) are denoted by $k_{p} = k_{p}^{(o)}$ i p=2where $k_{p}^{(o)} > 0$ and p > 0, the index p perm itting us to distinguish between the di erent roots of (7) for a given '. In the immediate neighborhood of the resonance k_{p} , S (k) has the B reit-W igner form, i.e., is proportional to

As a consequence, when a pole of the S-m atrix is suciently close to the real axis in the complex k-plane, it has an appreciable in uence on the total cross section. In Fig. 2, resonances are exhibited. A one-to-one correspondence between the peaks of $_{\rm T}$ in Fig. 1 and the resonances near the real kR $_{\rm I}$ -axis can be clearly observed. In the scattering of an electron with wave number $k_{\rm 'p}^{(o)}$, a decaying state of the electron-vortex system is form ed. It has a nite lifetime proportional to $1 = _{\rm 'p}$ and which increases with . When the corresponding scattering resonance can be observed on the total cross section, it is a long-lived state. Because of these quasibound states, the m agnetic vortex behaves as a kind of arti cial atom.

III. SEM IC LA SSIC A L A N A LY SIS

U sing the CAM method, we can provide a physical picture of the scattering process in term of di raction by surface waves and a physical explanation of the mechanism of resonance excitation valid for high wave num bers. We shall work from the scattering am plitude but we are fully aware of the fact that a more rigorous (but also more longer) analysis could be done from the trace of the Green function. We rst apply the Poisson sum mation form ula to the scattering am plitude (5). We have

We now go over the complex -plane. is then called the CAM and S (k) is then an analytical extension of S (k) into the CAM plane. We can then deform the path of integration in (9) taking into account the possible singularities. The only singularities that are met are the poles of the S-matrix lying in the CAM plane. They are known as Regge poles [7, 8] and are determined by solving

The solutions of (10) are denoted by $_{\rm p}$, the index p perm itting us to distinguish between the di erent roots.




FIG.3: Regge poles in the com plex angularm om entum plane.

W e can then extract from (9) the contribution of a residue series over R egge poles given by

where $r_p(k) = residue(S(k)) = r_p(k)$. Here the + and signs are associated with the Regge poles lying respectively in the rst and in the third quadrant of the CAM plane. It should be noted that f di ers from f_S by contour integrals which provide an uniform approximation valid in a large range around ' = 0. We are not interested by such a contribution which does not play any role in the resonance phenom enon. In Eq. (11), term s like exp(i p(k)(' m 2)) are surface wave contributions. A Regge pole lying in the rst (resp. the third) quadrant of the CAM plane corresponds to a surface wave propagating counterclockwise (resp. clockwise) around the m agnetic vortex and Re $_{\rm p}$ (k) represents its azim uthal propagation constant while Im p (k) is its dam ping constant. In (11), we take into account the multiple circum navigations around the magnetic vortex. Fig. 3 exhibits the distribution of R egge poles for a given wave num ber. The Regge poles in the rst and third quadrants are not symm etrically distributed as a consequence of the breaking of time-reversal invariance. The Regge pole RP0+ is very close to the real axis in the complex -plane. It then corresponds to a surface wave which is slightly attenuate during its propagation and which contributes signi cantly to the scattering process and to the resonance mechanism. The Regge pole RP1+ is not so close to the realaxis but it could have an appreciable in uence on the resonance mechanism while the other Regge poles are too far to contribute so signi cantly.

R esonance phenom enons (and the resonant behavior of f_S and therefore of $_T$) can now be understood in terms of surface waves. As k varies, each Regge pole $_p(k)$ describes a trajectory (usually designed as a Regge trajectory [7]) in the CAM plane. When the quantity Re $_p(k)$




FIG.4: Regge trajectories.

coincides with an integer, a resonance occurs. Indeed, it is produced by a constructive interference between the di erent components of the pth surface wave, each com ponent corresponding to a di erent number of circum navigations. Resonance wave numbers are therefore obtained from the Bohr-Som m erfeld quantization condition

By assuming that k is in the neighborhood of $k_{p}^{(o)}$ and using Re $_{p}$ (k) Im $_{p}$ (k) (which can be numerically veried, except for very low frequencies), we can expand $_{p}$ (k) in a Taylor series about $k_{p}^{(o)}$, and obtain

Then, after sum mation over m in (11), we nd, by using (13), that f_s (k;') presents a resonant behavior given by the Breit-W igner form ula (8) with




FIG.5: Sem iclassical resonances in the complex kR_1 -plane.




FIG.6: Identi cation of resonances on the total cross section.

Eqs. (12) and (14) are sem iclassical form ulas which perm it us to determ ine the location of the resonances from Regge trajectories. Fig. 5 exhibits the resonance distribution obtained from the sem iclassical form ulas (12) and (14) by using the Regge trajectories num erically calculated (see Fig. 4). A comparison of Fig. 5 and Fig. 2 (or a num erical com parison between the exact and the sem iclassical spectra) shows a very good agreem ent, except for low values of the wave number k. Furtherm ore, as indicated in Fig. 5, the sem iclassical theory perm its us to classify the resonances in distinct fam ilies, each fam ily being associated with one Regge pole and therefore to understand the meaning of the index p introduced to denote the solutions of (7). In Fig. 6, a zoom in on Fig. 1 is realized and the peaks are associated with the sem iclassical resonances linked to the Regge poles RPO+ and RP1+ .

A deeper understanding of the scattering process as well as its dependence on the quantum ux parameter

can be obtained by solving perturbatively Eq. (10). W ait [12] presents a method in order to study acoustic whispering-gallery phenom ena in circular cylinders. Such a method is equally valid, mutatis mutandis, for nding the solutions of (10). By using in (4) the appropriate asymptotic expansions [11] (D ebye expansions and uniform expansions in terms of the A iry function) for B essel functions, we can obtain an asymptotic approximation for the R egge poles $_{\rm p}$ (k):

In Table I, we present some results for Regge poles. A comparison between the \exact" and the asymptotic values shows a rather good agreem ent. It could be possible to greatly in prove the imaginary parts of the asymptotic results by taking into account higher orders of the perturbative series (15).

By replacing (15) in (11), it is obvious that all the surface waves are supported by the in nitely thin magnetic eld shell localized at $= R_2$. Furtherm ore, because of the term which appears in (15), surface wave

propagating around the magnetic vortex acquire a geom etrical phase ' m 2 (the + and - signs correspond respectively to surface waves propagating counterclockwise and clockwise) reminiscent of the Aharonov-Bohm e ect. Resonances are therefore associated with whispering-gallery modes mainly concentrated at the inside surface of the magnetic eld discontinuity at = R_2 . Here we have encountered, in the context of quantum mechanics, the whispering-gallery phenom ena described long tim e ago by Rayleigh [13, 14] in acoustics.

IV. CONCLUSION AND PERSPECTIVES

To conclude, we would like rst to comment on some aspects of our work and then to consider some possible directions which are suggested by our results:

- W e have investigated the resonant properties of a rather specialm agnetic vortex for which the Schrodinger equation can be solved exactly in terms of Bessel functions. As a consequence, we have been able to perform the exact as well as the asym ptotic calculations involved. W e think that scattering by such a vortex cannot be considered as a thought experiment. Such a vortex could be realized and experimentally studied because, in the domain of the AB e ect, experimentalists have developed ingenious techniques (see, for example, Ref. 4). At any rate, even if that is not possible, we think that resonant properties as well as surface waves could be experimentally observed from more generalm agnetic vortices.

- The CAM method could be naturally used in many other areas of the physics of vortices and in particular in order to study, from a sem iclassical point of view, scattering by vortices in super uids and Bose-E instein condensates or in superconductors. However, it seems to us that our approach could be above all protably extended in all the dom ains where analogs of the AB e ect have been recently developed, extending the pioneering contribution of Berry et al [15] (see Refs. 16, 17, 18 for the acoustical AB e ect, Refs. 19, 20, 21, 22 for the hydrodynam ical AB e ect and Ref. 23 for the optical AB e ect). In the particular case of the scattering of ultrasonic waves by hydrodynam ic vortices, the CAM method could provide new interpretations of sound and ow interactions in connection with the geometrical theory of di raction.

-Finally, applications in the dom ain of electronics and m esoscopic physics could be envisaged and the resonant m agnetic vortex used to m odify the electron transport behavior. Surface waves as well as the associated resonances could not only contribute signi cantly to conductance oscillations, but also lead to new e ects.
