\M adeling m odel prediction for dependence of lattice parameter on nanocrystal size.

A bstract

The competition between the long range Coulomb attractive and the short range repulsive interaction in ionic nanocrystals creates an elective negative pressure, which causes the lattice parameter a to increase with decreasing nanoparticle size d. A simple \M adelung model" is used to predict the dependence of the lattice parameter for CeO₂ and BaTiO₃ on d, a=a = =d, for = 0.22 A and 0.18 A respectively. The model predictions are compared with experimental results.

How properties of ionic crystals change when their surface to volume ratio becomes large is an active area of research [1{7]. The ceria nanoparticles $C \in O_2$ have been studied experimentally using Raman, X-ray diraction, photoabsorption, high resolution transmission electron microscopy (HRTEM) [1,2], and transmission electron microscopy [3{5]. The fascinating property of ionic nanoparticles is the lattice parameter increase with nanoparticle decreasing size [1,4,5]. Intuitively one would expect the lattice parameter to decrease as a result of surface stress as was observed in gold nanoparticles [8].

N anocrystal properties are signicantly dierent from their bulk counterparts. Previous theoretical treatments [6,7] used realistic potentials for small Ce_0O_{2n}

cluster calculations. It was shown that our ite structure for ceria was not achieved for n smaller than 50. In the present work we investigate lattice parameter dependence on a cluster size for d=4 20 nm or $n=10^3$ 10^5 . Charge neutral octahedra nanocrystals are surface term inated with oxygen anion layers along the eight f111g faces. The balance between the long range Coulomb and the short range atom ic interactions leads to the optimal lattice parameter a_0 dependent on the size of the cluster. The volume energy per formula unit in the bulk material is usually modeled as

where B is the bulk modulus and E $_{\rm v}=$ N $_{\rm v}$ is the volume energy of N form ula units of CeO $_2$, each lling volume space $V_0=a_0^3=4$. In the in nite crystal Eq. (1) is the total free energy which is minimum at the bulk lattice parameter a_0 . In the nanocrystal the balance between the Coulomb and short range forces is altered due to the surface. The surface Coulomb energy creates a negative pressure which leads to the lattice parameter expansion in the nanocrystal in accord with observation [1].




Fig. 1. C losed circles are model calculations of the M adelung energy on ionic (a) $C ext{ eO }_2$ and (b) $B ext{ aT iO }_3$ nanocrystals. The $C ext{ eO }_2$ nanocrystal was term inated by eighth (111) planes and $B ext{ aT iO }_3$ by six (100) planes. The solid lines are the best ts using Eq. (2).

To calculate the Coulomb energy in ionic nanoparticles we use the same procedure as M adelung energy calculation in bulk material [9]. In the uorite (CaF₂) structure the Ce^{4+} ions occupy a fcc sublattice and O^2 ions occupy the tetrahedral interstitial sites forming a simple cubic sublattice of length $a_0=2.T$ his gives a M adelung energy per formula unit "M ad = bulke²=a, where bulk = 46.55. The value of $= M z_i z_i = r_0$ is related to the M adeling constant M = 2.52 for the CaF₂ crystal structure [10], where ionic charges are $z_i = 2$, $z_i = 4$ and the nearest neighbor distance is $r_0 = \overline{3} = 4$ in units of a. To calculate the surface M adeling energy we use a nite size cluster of Cet+ and 0² ions term inated by the oxygen layers along the eight (111) planes. The surface energy is proportional to the area of nanoparticle $N^{2=3}$. The diam eter $d = (3N = 2)^{1=3} a_0$ is related to the number of Ce atom s N such that the sphere of equal diam eter contains an equal volume N Vo. The M adelung energy of a cluster (with a uniform lattice parameter) can be calculated for di erent diam eters. The results are shown on Fig. 1 (a), which are well tted by

with two parameters $_{\text{bulk}} = 46.55 \text{ and } _{\text{sur}} = 4.13 \text{ nm}$.

The uniform lattice param eter expansion reduces the surface M adelung energy creating the stress in the nanocrystal estim ated with Eq. (1). The total energy per Ce atom on the nanoparticle is

Here the rst term is the volume contribution, which includes the Madelung energy of the in nite crystal, and the second term is the surface Coulomb energy from Eq.2.M in imization of the total energy with respect to the lattice parameter for xed N gives




Fig. 2. Filled circles are experimental lattice parameters versus inverse diameter of CeO_2 nanoparticle. Dashed line is the best—t for the experimental data [1]. Solid line is a M adelung model prediction—a=a=0.22 A=d.

The bulk m odulus B = 23010 GPA has been measured by high-pressure x-ray di raction [11]. Taking $a_0 = 5:409$ A we obtain the relation $a=a_0 = 0:22$ A=d for the lattice parameter expansion shown on Fig. 2. The experimental lattice parameter (also shown on Fig. 2) expands with a larger slope = 0.37 A.Ourmodelpredicts 60% of the measured value of . The missing 40% of the lattice parameter expansion might be assigned to the formation of point defects. These defects are oxygen vacancies and simultaneous reduction of two ions of Ce^{4+} to Ce^{3+} for each oxygen vacancy formed, maintaining charge neutrality. Electron spectroscopy [12] and X-ray photoelectron spectroscopy β] show the presence of a Ce^{3+} component in nanocrystals. Since Ce^{3+} has a larger radius com pared to Ce^{4+} there m ay be a lattice expansion accom panying the replacement of $(Ce^{4+})_2O^2$ by $Ce^{3+}V$ where V is a neutraloxygen vacancy. An upper $\lim it$ in the Ce^{3+} contribution to expansion was estimated [1] by interpolation of published results of the variation in ceria lattice parameter with RE³⁺ radii from doping with dierent rare earth oxides (RE₂O₃) [13,14]. Recent neutron di raction measurements on nano-scale powder of CeO₂ [15]

suggest associated oxygen defect formation (involving oxygen vacancies and self-interstitials) in the uorite structure. Such defects are not included in our model and may alter the surface Madelung energy estimation.

The M adelung m odel is valid for any ionic nanocrystal. We apply it for the BaT iO $_3$ nanoparticles to calculate the competition between the long range C oulomb and the short range atom ic interactions. The results are shown on Fig.1 (b). Ionic charges Ba $^{2+}$, Ti $^{4+}$ and O 2 were used to calculate the surface energy of the nanoparticle. To preserve charge neutrality the cubic nanocrystal with size d was term inated by the three BaO and three TiO $_2$ f100g planes. The calculated value of $_{\rm sur}=3:6$ nm along with the experimental lattice parameter $a_0=3:996$ A and bulk modulus B=196 GPa [16] predicts $a=a_0=0:18$ A=d.Existing data [5] on BaT iO $_3$ nanoparticles are not su cient to verify the relationship Eq. (4) and further experiments are needed.

In conclusion we propose a mechanism for lattice parameter expansion of ionic nanocrystals due to the elective negative M adelung pressure. Using the experimental bulk modulus we quantitatively explain a lattice parameter expansion in ionic materials. A discrepancy between the model prediction and observed elect in CeO_2 can be attributed to the Ce^{3+} component [3,4] and other defects not included in our model. The Ce^{3+} concentration deduced from magnetic measurements [4] suggests a much smaller value than expected from lattice expansion measurements in accord with our theory. A non-uniform lattice parameter expansion and structural defect formation [15] would change the quantitative answer, but not the conclusion that an elective negative M adelung pressure is signicant in ionic nanocrystals.
