M easuring the transm ission of a quantum dot using A haronov-B ohm Interferom eters

The conductance G through a closed A haronov-Bohm mesoscopic solid-state interferom eter (which conserves the electron current), with a quantum dot (Q D) on one of the paths, depends on ly on cos , where = hc =e is the magnetic ux through the ring. The absence of a phase shift in the dependence led to the conclusion that closed interferom eters do not yield the phase of the \intrinsic" transmission amplitude $t_D = j_D \dot{p}^i$ through the QD, and led to studies of open interferom eters. Here we show that (a) for single channel leads, can be deduced from $j_D j$ with no need for interferom etery; (b) the explicit dependence of G () on cos (in the closed case) allows a determ ination of both j_D j and ; (c) in the open case, results depend on the details of the opening, but optim ization of these details can yield the two-slit conditions which relate the measured phase shift to .

I. IN TRODUCTION

Recent advances in nanoscience raised much interest in quantum dots (QDs), which represent arti cial atom s with experimentally controllable properties [1,2]. The quantum nature of the QD is rejected by resonant tunneling through it, as measured when the QD is connected via m etallic leads to electron reservoirs. The m easured conductance G shows peaks whenever the Ferm i energy of the electrons crosses a resonance on the QD. Experin entally, the energies of these resonances are varied by controlling the plunger gate voltage on the QD, V. Quantum mechanically, the information on the tunneling is contained in the complex transm ission amplitude, $\overline{T_D} e^i$. It is thus of great interest to measure = both the magnitude $T_{\text{D}}\,$ and the phase $\,$, and study their dependence on V. Although the former can be deduced from measuring G, via the Landauer formula [3], $G = \frac{2e^2}{h}T$, experimental information on the latter has only become accessible since 1995 [4,5], using the A haronov-Bohm (AB) interferom eter [6].




FIG.1. Model for the AB interferom eter: (a) C losed two-term inal case, (b) schem atic picture of the six-term inal open interferom eter, (c) model for the open interferom eter.

In the AB interferom eter, an incoming electronic waveguide is split into two branches, which pin again into the outgoing waveguide. A haronov and Bohm [7] predicted that a magnetic ux through the ring would add a dierence = e = hc between the phases of the wave functions in the two branches of the ring, yielding a periodic dependence of the overall transmission T on . Placing a QD on one of the branches, as in Fig. 1a, and using the other path as a \reference path", with a transm ission amplitude t_B , one expects T also to depend on the \intrinsic" amplitude t_D . In the two-slit lim it, one has $T = \frac{1}{2}e^{i} + t_B f = A + B \cos(+), with = +$, where the reference phase is independent of the QD param eters, and thus set at zero. How ever, for the \closed" two-term inalgeom etry, as shown in Fig. 1a and used by Yacoby et al. [4], the two-slit expectation that was clearly wrong: Unitarity (conservation of current)

[8,9], which state that G () = G (), and therefore
m ust be equal to zero or . Indeed, a t of the the experim ental data [4] to the above two-slit form ula, with
B > 0, gives a phase shift which \jumps" from 0 to
near each resonance of the QD, and then exhibits an
a priori unexpected abrupt \phase lapse" back to 0, betw een every pair of resonances.

A im ing to measure a non-trivial AB phase shift then led to experiments with six-term inal \open" interferom – eters (Fig. 1b) [5,10], where the additional four \leaky" channels lead to absorbing reservoirs. These interferom eters break the O nsager symmetry, and yield a non-trivial phase shift which increases gradually from zero to through each resonance, and then jumps back to zero between resonances. Much of the early literature assum ed that the measured is equal to the \intrinsic" . Recently [11] we showed that this assumption is not necessarily always valid: the detailed V -dependence of depends on the strength of the coupling to the additional term inals. Thus, we posed the challenge of nding clear criteria as to when the measured equals .

In the present paper we review three aspects of this problem . In Sec. 2 we show that in some cases one has $T_D = \frac{2}{D} \sin^2$, where D is a constant measuring the asym m etry of the QD. In these cases, is determ ined by $T_{\mbox{\scriptsize D}}$, and there is no need to build special interferom eters to measure . We also show that in many cases the detailed ux-dependence of the measured conductance of the closed interferom eter contains inform ation which allows the deduction of both $T_{\text{D}}\,$ and $\,$, eliminating the need to open the interferom eter. In Sec. 3 we then review recent work [12] in which we showed that an opening like that shown in Fig. 1c, with \forks" of \lossy" channels on each segment of the AB ring, can be tuned so that one reproduces the two-slit conditions. In those cases, one indeed has = . However, this tuning requires som e optim ization of the param eters, and cannot be guaranteed for an arbitrary open interferom eter.

II.CLOSED AB INTERFEROMETER

A.M odelwith one QD resonance




FIG.2. M odel for the closed interferom eter.

Our model is shown in Fig. 2: We start with an isolated quantum dot, with a single localized level (of single particle energy $_{\rm D}$, representing the gate voltage V) and on-site Hubbard interaction U, and with a onedim ensional tight-binding chain, with sites at integer coordinates, with zero on-site energies and with nearestneighbor (nn) hopping matrix elements equal to J.We next connect the dot to the sites 1 on the chain, via matrix elements J to the left, and J_r to the right, and also modify the lower branch of the resulting triangle: site 0 becom es the \reference" site, with on-site energy 0, with no interactions and with nn hopping energies I (replacing the original J). Experimentally, the reference site can represent a simple point contact, tunnel junction, etc. The triangle so form ed contains an A haronov-B ohm phase, = + r, where (for sim plicity), the phase (r) is attached to the bond with the hopping matrix element J, (J_r) (we choose J; I; J, and

 $J_{\rm r}$ to be real). Hence, the Ham iltonian of the system reads

where the operator c_k^y creates single particle eigenstates (with spin) on the unperturbed chain (with I = J, J, = $p_r = 0$) p_k^w ith eigenenergy $_k = 2J \cos k$, while $q_p = J_k c_k = N$, and $V_k = (J e^{i \ \cdot ik} + J_r e^{i \ r + ik}) = N$. The operators on the dot are denoted by d and d^y , and they anti-com mute with the band operators c_k ; c_k^y . The dot H am iltonian is

with $n_d = d^y d$, and - denotes the spin opposite to . The Ham iltonian (1) is a simple generalization of that used by Ng and Lee [13], to which we added the reference path.

B. Transm ission

For simplicity, we discuss only zero temperature, so that $_{k}$ is set equal to the Ferm i energy in the leads. The 2 2 scattering matrix is easily related to the matrix of retarded single-particle G reen functions, $G_{kk^{0}}(!)$, evaluated on the energy shell, $! = _{k}$. [14] We use the equation-ofm otion method to express $G_{kk^{0}}(!)$ and $G_{kd}(!)$ in term softhe G reen function on the dot, $G_{dd}(!)$ [15]. The equation-ofm otion for the latter has the form

The last term on the RHS represents the e ect of the interactions, with $d_{dd;d}$ (!) being the tem poral Fourier

transform of $_{ddd;d}(t) = i$ (t)h $d^{\underline{y}}(t)d-(t)d$ (t); $d^{\underline{y}}$ i. The second term on the RHS of Eq. (3) can be written as $_{k}V_{k}G_{kd}(!) = A(!)G_{dd}(!)$, in plying that A(!) contains the full contribution of the non-interacting H am iltonian to the self-energy on the dot. Thus we write

where $_{int}$ (!) represents the self energy due to the interactions, which vanishes when U = 0. At ! = $_k$ we have

where the -dependent quantities Y and Z are de ned in this equation, while $_{\rm D} = 2J_{\rm v}J_{\rm r} = (J_{\rm v}^2 + J_{\rm r}^2)$ is the asym - m etry factor for the dot, and

is the transm ission amplitude of the <code>\background"</code> path (when $J_{\cdot} = J_r = 0$), with the elective hopping energy $V_B = I^2 = (k_{-0})$.

The other equations of motion [15] then yield the other G reen functions, and we end up with

Equation (7) is one of our main results. It expressest in terms of the fully dressed single particle QD G reen function, which depends on both paths of the interferom eter and therefore also on the AB phase . The remaining discussion aims to see if one can extract inform ation on the \intrinsic" QD transmission from measurements of $T = \frac{1}{2} \cdot \frac{1}{2}$.

The Onsager relations require that the conductance, and therefore also $T = \pm \hat{f}$, must be an even function of . It is clear from Eq. (7) that this holds only if

Indeed, we found the same condition to follow from the unitarity of the scattering matrix. The same sort of relation appears for the single in purity scattering, in connection with the Friedel sum rule [16]. Equation (8) in – plies that the interaction self-energy $_{int}(k)$ is real, and is an even function of . It also in plies that = $G_{dd}(k)^{1}$ is fully determ ined by the non-interacting self-energy = A(k).

It is now convenient to rewrite $G_{dd}(k)$ in terms of its phase, . Writing $[G_{dd}(k) \sin jkj(J_x^2 + J_r^2)=J]^1 = (1 + Y)(i \mod)$, we nd

Interestingly, the second term in the square brackets is of the Fano form [17]. At = 0, it re ects the possibility for a complete destructive interference, with T = 0. A similar expression for T was derived by H ofstetter et al [18], but their approximations ignore the explicit dependence of some parameters (e.g. Y) on

W hen one cuts o the reference path, $V_B = 0, Eq. (7)$ reduces to the \intrinsic" QD transmission amplitude, $t_D = i_D \sin e^i$, with

where $_{D;int}(k) = _{int}(k)\dot{y}_{B} = 0$. It is interesting to note that for our single-channel (one-dimensional) leads, we have $T_{D} = _{D}^{2} \sin^{2}$ (as already noted by Ng and Lee [13]). Since $_{D}$ does not depend on the energy $_{k}$ or on the gate voltage V = $_{D}$, it follows that a measurem ent of $T_{D} = \frac{\text{im m ediately}}{T_{D} = \text{max}(T_{D})!}$ In many cases, the measurem ent of T_{D} already yields , eliminating the need to perform complicated interferom eterm easurem ents. It would be very interesting to test this, for cases where is measured independently (e.g. with an open interferom eter, see below).

The phase $ofG_{dd}(k)$ is now given by

where X = $(_{int}(_k))_{D,int}(_k) = [\sin \frac{1}{2} i (C_r^2 + J_r^2) = J]$ contains only the e ects of the reference path on the interaction self-energy of the dot. One way to proceed is to calculate X, e.g. using a perturbative expansion in V_B or using a full solution of the interacting case. Even without calculating X, we expect it to be an even function of . Although does not depend on , usually depends on (via X; Y and Z).

Equations (9,10,11) represent our second main result: they relate the -dependence of the measured T with the QD parameters. We are not aware of earlier discussions which separate between the roles played by and

C.Possible m easurem ents

We now discuss a few lim its in which a measurement of T , Eq. (9), can yield information on the \intrinsic" phase and thus on the full \intrinsic" transmission t_D . First, consider a relatively open dot, with smallbarriers at its contacts with the leads. In such circum stances, the

electron wave function spreads over the leads, and it has only a sm all am plitude on the dot itself, thus reducing the e ects of interactions. This, and the related better screening [19], im ply that $\chi j \neq Z j$. In this lim it, Eq. (11) (with X = 0) gives the detailed dependence of on . Equation (9) then has the form




FIG.3. Dependence of the AB transmission T on the AB phase and the gate voltage V for a single non-interacting resonance.

with coe cients which depend on $_{\rm D}$; $_{\rm B}$; jkjand . For the closed interferom eter, K is real. The cos in the denom inator, which results from the self energy in the dot Green function, is due to interference within the ring, between clockwise and counterclockwise motions of the electron. In the lim it of small $V_{\rm B}$ one has z / $t_{\rm D}$. Fitting data to Eq. (12) would con m that one is in this noninteracting limit, and would yield the V-dependence of the \intrinsic" phase (as well as the V -independent param eters $_{\rm D}$; $_{\rm B}$ and k). Note that a t to the explicit -dependence in Eq. (12) is much preferred over a t to a harm onic expansion of the form T =an cosn . Figure 3 shows an example of the V - and -dependence of T for this lim it. The denom inator in Eq. (12), which contains the information on via z (and thus determines the higher harm onics in T), is mostly visible near the resonance at V = 0. Far away from the resonance this denominator is small, and T can be approximated by $A + B \cos(+)$, where is zero or below or above the point V = 0.

Second, note that all the -dependent functions X ; Y

and Z become smallwhen V_B (and therefore $_B$ V_B =J) is small. Except very close to the QD resonance, where = =2, we conclude that = + O ($_B$). Thus, at least away from resonances one can study the transmission for several values of V_B (which can be varied via the point contact voltage $_0$), estimate (V) (as some average over) for each V_B and extrapolate V_B to zero to obtain , without explicit know ledge of X ().

The situation becomes even more interesting in the K ondo regime, when and/or remain close to =2over a wide range of V. Hofstetter et al. [18] assum ed that = =2, and deduced the -dependence of T . As seen from Eq. (11), one cannot have = = 2 without neglecting the -dependence of X; Y and Z. Alternatively, if the K ondo condition implies that = =2 then the measurement of the -dependence of T could give information on the $-dependence of X \cdot If V_B$ is su ciently smallthen will show small -dependent deviations from =2 within the K ondo plateau, and rem ain very close the elsewhere. For larger V_B , a resonance on the QD (i.e. = =2) may result in signi cant deviation of from =2. The question whether this deviation relates to the variety of plateau values observed by Jiet al. [10] deserves further study.

In any case, the above discussion dem onstrates that although a measurement of the transmission of the closed AB interferom eter does not yield a non-trivial AB phase shift , the data still contain much information on the properties of the <code>\intrinsic" QD</code>.

III.OPEN AB INTERFEROMETER

A.M odel for multi-resonances




FIG.4. M odel for a QD with four resonances (to replace the single dot in Fig. 2).

W e next discuss the conditions for obtaining the equality = in an open AB interferom eter. In principle, we could repeat the above discussion for the open case; as seen below, this simply amounts to replacing each \lossy" channel by a com plex self-energy at its \base", and then proceeding as in the closed case. However, for the present purpose it su ces to discuss an e ectively non-interacting case. [12] O byiously, if one cannot achieve this aim in that case then there will be problem s also in the more complicated interacting cases. We thus restrict this discussion to an approxim ate treatm ent of the Coulom b blockade (and not the K ondo) region, and treat the interaction term in the Hartree approximation, replacing $n_d n_d$ - by hn_d - in_d . We further simplify this by replacing hnd-i by a constant which increases for consecutive resonances. Thus, we replace the single QD by a set of sm aller dots, each containing a single resonant state, with energy $D = E_R$ (n) V + U (n 1); n = 1; ...; N g. Each such state is connected to its left and right nearest neighbors (nn's) on the leads (denoted by L and R) via

bonds with hopping am plitudes f $\frac{1}{4}$ (n); $\frac{1}{4}$ (n); n = 1; ...; N g (see Fig. 4). The problem now reduces to a simple tight-binding model, and for the \intrinsic" QD we nd




FIG.5. Intrinsic" transmission T_D and phase , for N=4 resonances, with U=20J, J_L $(n)=J_R$ (n)=J and k= =2. The gate voltage V is measured in units of J.

Figure 5 shows typical results for the \intrinsic" transm ission $T_{\mbox{\scriptsize D}}$ and phase , where the zero of $% T_{\mbox{\scriptsize D}}$ is set at its (k-dependent) value at large negative V. Here and below, we choose k = -2, so that k = 0 and the resonances of the transm ission, where $T_D = 1$, occur exactly when E_R (n) = k = 0, i.e. when V = U (n 1).We also use the simple symmetric case, $J_L(n) = J_R(n)$ J, and m easure all energies in units of J. Interestingly, this m odel reproduces the behavior apparently observed by Schuster et al. [5]: grows smoothly from 0 to as $_k$ crosses E_R (n), and exhibits a sharp \phase lapse" from to 0 between neighboring resonances, at points where $T_D = 0$. These latter points, associated with zeroes of S_{LR}, represent Fano-like destructive interference between the states on the OD [17,20,21]. These zeroes in T are m issed, and the corresponding \phase lapses" are super-

uously sm eared, when one replaces the exact Eq. (13) by a sum of B reit-W igner resonances [22].

It is interesting to note that, although there are several resonances, the upper part of Fig. 5 is fully reproduced when one takes from the lower part, and plots \sin^2 . This emphasizes again the possibility to measure directly from T.

B.M odel for the open AB interferom eter

P lacing the above QD model on one branch of the closed AB interferom eter, one can easily solve for T. In the absence of interactions, we again nd the form (12), which is thus also valid for many resonances. Near each resonance, results are similar to those shown in Fig. 3. A sexpected, Eq. (12) is still an even function of , with no phase shift (except for the apparent jumps between zero and).




FIG.6. Transm ission (thick line) and re ection (thin line) through a $\mod b$ ", (a) versus k at $J_x = :7J$ and (b) versus J_x (in units of J) at k = :=2. The number on each frame gives the number of \teeth", M.

Before we discuss the open interferom eter, it is useful to understand the criteria for having the two-slit situation. A crucial condition for having $t = t_D e^i + t_B$ is that the electron go through each branch only once. Equivalently, there should be no re ections from the \forks", which connect the ring with the external leads, back into the ring [11]. We achieve this by the construction shown in Fig. 1c: each of the four \lossy" channels in Fig. 1b is now replaced by a \com b" of M channels. An analysis of each such \com b" shows that (a) the transm ission T and re ection R through the \com b" is only weakly dependent on the energy $_k$ near the band center k = = 2 (Fig. 6a) and (b) the transm ission T decreases and the re ection R increases with the coupling of each \lossy" channel in the \com b" to its \base", J_x (Fig. 6b) and

with the num ber M . [12] Note that T + R < 1, due to the loss into the \teeth" of the \com b". Ideally, one would like to have T; R 1, so that in practice the electron crosses each \com b" only once, and is not relected from the \com b" back into the QD. Given Fig. 6b, we expect to have optimal two-slit conditions for interm ediate values of J_x , e.g. J_x 0:9J for M = 6.






FIG.7. A; B; C and for transmission through (a) the closed AB ring $(J_x = 0)$, and for the open interferom eter with (b) $J_x = :15J$, (c) $J_x = :9J$ and (d) 1:5J. The thin line in the lowest frames shows the exact intrinsic phase (from Fig. 5). The QD parameters are the same as in Fig. 5.

We next present results for the open interferom eter shown in Fig. 1c. The algebra is similar to that for the closed case: each \tooth" of the \com bs" can be elim inated from the equations, at the cost of adding a self energy on the site of its \base", equal to $J_x^2 e^{ik} = J$. The result is again of the form of the rst expression in Eq. (12), except that now K becomes com plex and therefore the num erator in the second expression contains $\cos(+)$ instead of \cos . To demonstrate qualitative results, we chose four identical \com bs", with M = 6 \teeth" on each and with the same hopping matrix elem ents; all the hopping energies were set to J, except for the bonds connecting each \tooth" to its base, denoted J_x . Figure 7 shows exact results for A; B; C and in ts of T to the form

with the conventions B; C > 0, as used in the analysis of experiments. Note the decreasing magnitude of the amplitudes as J_x increases, due to the large losses to the lossy channels. Note also that for $J_x = 0$ the results reproduce those for the closed interferom eter, with

jumping discontinuously between 0 and . As J_x increases, the \data" for become smoother, and they approach the \intrinsic" values of for intermediate values of J_x 0.9J. However, as J_x increases further, \retracts" towards a more steep variation near each resonance. A lthough the electron crosses each \com b" only once, due to the small values of the com b transmission T, it is rejected several times from the \com bs" back towards the QD, due to the increasing \com b" rejection. Therefore, the electron visits the QD several times, and the nalAB transmission does not reject the correct desired t_D .




FIG.8. Same as Fig. 7, but with a \lossy" channel attached to the QD, with coupling $J_x^0 = J_x = :9J$.

Finally, we allow also a lossy channel connected directly to the dot. As seen in Fig. 8, this eliminates the Fano zeroes of B and causes a sm earing" of the sharp Fano $\phase lapses"$ in . Technically, the losses from the QD introduce com plex self-energies on the dot, which m ove the zeroes of T away from the real energy axis. Interestingly, Fig. 8 resembles the experiments of Schuster et al. [5]

IV.CONCLUSIONS

Basically, we have made three explicit predictions:

For single channel leads, the QD transm ission and its phase are related via T_D = $^2_B\,\sin^2$. In such cases, the measurement of T_D also yields .

M easurements of the transmission T in a closed interferom eter contain much information on both the magnitude T_D and the phase of the <code>\bare"QD</code>.

Open interferom eters do not usually obey the twoslit criteria. Therefore, the phase measured via a t to Eq. (14) will usually not yield the intrinsic QD phase . However, optimization of the losses can achieve the two-slit conditions, and yield = .

In principle, the con guration of F ig. 1c allows a full study of all the cases discussed here: setting the voltage on the reference site $_0$! 1 sends $V_{\rm B}$ to zero, and yields the \intrinsic" transm ission through the QD, $T_{\rm D}$. Setting the gate voltage on the QD V = $_{\rm D}$! 1 yields the reference transm ission $T_{\rm B}$ = \sin^2 $_{\rm B}$. Setting the coupling to the \lossy" channels (J_x) to zero, by som e m anipulations of the relevant gates, yields the \cbsed" case. In this case, variation of $_0$ allows variation of $V_{\rm B}$, and extrapolation of to . Finally, varying J_x allows optim ization of the \intrinsic" phase . We hope that this review will stim ulate the buildup of such exible experimental system s.
