# D ynam ics of bright $m$ atter $w$ ave solitons in a quasi 1D 

 B ose E instein condensate w ith a rapidly vary ing trapF K h. #### Abstract

The dynam ics of a bright $m$ atter wave soliton in a quasi 1D Boseモ instein condensate with periodically rapidly varying trap is considered. The goveming equation is derived based on averaging over fast $m$ odulations of the $G$ ross $P$ itaevskii (GP) equation. This equation has the form of $G P$ equation w ith e ective potentialofm ore com plicated structure than unperturbed trap. For the case of inverted (expulsive) quadratic trap corresponding to unstable GP equation, the e ective potential can be stable. For the bounded in space trap potential it is showed that the bifurcation exists, i.e.,the single well potentialbifurcates to the triple welle ective potential. Stabilization of BEC cloud on-site state in the tem porary $m$ odulated optical lattioe is found. (analogous to the K apitza stabilization of the pendulum ). The predictions of the averaged GP equation are con $m$ ed by the num erical sim ulations of $G P$ equation $w$ ith rapid perturbations.

## I. IN TRODUCTION

Recently bright $m$ atter wave solitons has been observed in a B ose E instein condensate

 of 5000 atom $s$ into expulsive harm onic potential. The soliton was observed propagating without changing of the form for distances is order of 1 mm . The expulsive harm onic trap used, in the experim ent, corresponds to an unstable potential for the GP equation and a
 the dynam ics of a bright $m$ atter wave soliton in inhom ogeneous tim e dependent system $s$, in particular possible stabilization of unstable dynam ics or com plicated dynam ics of solitons in $B E C$.

A $n$ interesting exam ple of such a trap is an optical trap which is indeed rapidly varied in time. It is realized for instance for a condensate in dipole trap form ed by a strong - resonant laser eld Wi.l. A typicalm odel is a trap form ed by a harm onic potentialw ith different frequencies which is cutting at an energy $\mathrm{V}_{\mathrm{C}}$. N um erical sim ulations of the condensate dynam ics and splits in 1D BEC w ith a positive scattering length under periodically shaken trap has been perform ed in Ref. ['넉. The sam e form of wave equation leads to the propagation of spatial solitons in periodically m odulated parabolic waveguides. This problem appears in investigation of intense light beam s in a nonlinear w aveguide w ith inhom ogeneous distribution of transverse refractive index. A typical distribution can be approxim ated by a quadratic pro le. The rapid variation of this pro le along the longitudinal direction leads to a rapidly varying quadratic potential in the NLS equation.

The general $m$ athem atical problem is to investigate localized states for the nonlinear wave equation $w$ ith cubic nonlinearity and $w$ ith rapidly varying (not sm all) potential of the form $V_{0}=f(x)(t=)$; $\quad$. A lso it is of interest to investigate possibilities of stabilization of a solton by rapid perturbations. For multi dim ensional NLS equation under rapidly varying in space periodic potential such a problem is discussed in [-ब $\overline{-1}]$.

The paper is organized as follow s:
In section 2 we describe the procedure of obtaining the averaged equation for the GP equation $w$ ith an extemal potential, that is rapidly varying in time and inhom ogeneous in space, with the form $f(x) \cos (t)$, where $=1=$. In Section 3, we considered some im portant potentials for applications, which have the form s given by $f(x)=x^{2} ; 1=\cosh (b x)$, and $\cos (\mathrm{kx})$.

The dynam ics of BEC is described by the tim e dependent GP equation

where $m$ is the atom $m$ ass, $g=4 h^{2} a_{s}=m$, with $a_{s}$ the atom ic scattering length. $a_{s}>$ 0 corresponds to the BEC w ith repulsive interaction between atom $s$ and $a_{s}<0$ to the attractive interaction. This result show sthat the soliton dynam ics can have $m$ ore com plicated character than in the case of BEC w th slow ly varying param eters. W e can expect here the stabilization of the unstable dynam ics of a soliton by rapidly varying perturbation. It is a direct analogy $w$ ith the stabilization of system $s w$ ith a few degrees of freedom under rapidly varying in tim e param eters.
III. DYNAM ICS OF DIFFERENTMODELSOFTRAP POTENTIALS
A. A quadratic potential

A s an exam ple, we will consider the attractive BEC with a quadratic trap potential. In this case we have a perturbed trap potential [ $\left.0+{ }_{1} \sin (t)\right] f(x)$ with $f(x)=x^{2}$ and $=1$. An averaged e ective potential is given by

where $={ }_{1}=$. The case when $0>0$ corresponds to the inverted (repulsive) harm onic potential case which is well known to be unstable [倍]. A s seen that when $2^{2}>j$ juthe sign of the e ective potential is reversed and the solitary wave dynam ics becom es stable. The frequency of oscillations of the soliton center now is

W e point out that the set $(\overline{2} \overline{3} \overline{1})$ is exact. $N o$ additional assum ption $w$ as $m$ ade in obtaining this set of equations, and it is valid for any solitary solution of the goveming equation ( $\overrightarrow{3}_{-1}$ ). A lso, it should be noted two rem arkable facts connected w ith the dynam ics of a solitary solution of NLS equation in the presence of a quadratic potential (or dynam ics of BEC in a quadratic trap) : i) .In this case the equations ofm otion $(\overline{2} \overline{3})$ for the soliton center, are exact, ii) after averaging, the initially quadratic potential rem ains to be quadratic but its sign may be reversed.

$T$ he results of num erical sim ulation of the full $G$ ross $P$ itaevskiiequation $w$ ith the $m$ odulated in tim e expulsive (inverted) harm onic potential are shown in Fig. 'ili. Two cases with $1_{1}=$ 4:7124 and $1=3: 1415$ were considered. For both cases $0=0: 0493$ and $=10$. The results of com putation are the follow ing : a) $1_{1}=4: 7124, \quad=1: 309$; $(T=4: 8)$ C alculation
 C aloulation by Eq. (2- $\overline{2} \overline{1})$ gives cal $=0: 7695$; ( $\mathrm{T}_{\text {cal }}=8: 165$ ).

In both cases we observe the appearance of stable oscillations of the soliton position. W e obtain good agreem ent betw een the full sim ulations and the averaged equation. A s seen, the greater is the value of , the discrepancy we found between results of calculation of Eq. (2 $\overline{4} \overline{4})$ and the ones offullnum ericalsim ulations ofN LS equation. W e can expect this since the ratio ${ }_{1}=$ is not sm all for these values of param eters. Let us estim ate the values of param eters for the experim ental situation. In the experim ent [ī1] the longitudinal frequency was $!_{1}=4 \mathrm{~Hz}$ so, at the tem poralm odulations of this potential, w ith the frequency $=40 \mathrm{~Hz}$ we should observe a stable bright $m$ atter w ave soliton.

> B. The case of a bounded potential

To describe sm all oscillations of the soliton solution center and to obtain equations of $m$ otion in general case, we will have to $m$ ake som e approxim ations. As the ansatz, we suppose the solution to take the form $u(x ; t)=u(x \quad X(t) ; t)$. H ere and after, for the sake
of sim plicity, we also suppose the position of the $m$ inim um at $X_{0}=0$ and a sym $m$ etrical form for the soliton solution (dynam ics of which we are investigating)

Here $X_{0}{ }^{W}$ is the position of a given $m$ inim um of the potentialw $(\mathrm{x}) ; \mathrm{X}_{0}{ }^{\text {st }}$ is the stationary point (about which oscillations occur); $X$ is the shift of a stationary point; ! and $T$ are the frequency and period of oscillations.

From the present analysis we conclude that the theory of averaging of $P$ equation over rapidly varying perturbations w orks well in the case ofbounded perturbation potentialeven when the expansion param eter is su cient large (in our case $=0: 9$ ). The e ective trap potentialbifurcates from the one well form to the triple w ell structure. T his can lead to the splitting of single attractive BEC into three parts.

## C. A periodic potential

Let $f(x)=\cos (k x)$. Then the averaged equation coincide $w$ ith the unperturbed one but w th the another potential:

This potential has a m ore com plicated structure and, as a result, the m otion of the soliton center has new properties. Let us consider the $m$ otion of one soliton in such a potential. The single soliton solution is

A s seen the $m$ otion of the soliton center occurs under the action of two harm onic e ective perturbation. It represents a close analogy w th the stabilization of a pendulum w th the rapidly oscillating support point (the K apitza pendulum). As it is well known [G] oscillations of the pendulum at the point $\mathrm{k}=$ are unstable. The rapid perturbation stabilize this xed point. The stabilization condition follows from the e ective potential for the soliton in the periodic eld ( $\overline{3} \overline{4} \overline{1})$ and it is given by

The results of num erical sim ulation of the full G P equation are presented in $F$ ig ' $\overline{4} \mathbf{1} \cdot \mathrm{I}$. T he param eters 0 and ! are the sam e as for the above considered bounded potential. Fig. . depicts the dynam ics of a soliton center in a periodic potential $0 \cos (\mathrm{kx}) \mathrm{w}$ ith its initial position $==k$ corresponding to the unstable point when $1=0$ (the fast perturbation is tumed $O$ ). As seen the motion is in nite. $F$ ig. A $\overline{1} \mathrm{p}$ show s the case when $1=9$ (the fast perturbation is tumed on). In this case the $m$ otion of the soliton becom es nite and it oscillates $w$ ith the frequency $\quad 1=0: 303$ whereas the predicted value by Eq. ( $\overline{3} \overline{\bar{\sigma}})$ is $0: 308$. O ne can see that the agreem ent $w$ ith the theory is rem arkable.
IV. C O N C LU S IO N

W e have investigated the propagation ofbright $m$ atter $w$ ave soliton in the B ose $E$ instein condensate $w$ ith trap potential rapidly varying in tim e.

The cases of $m$ odulated in tim e quadratic, bounded and periodic trap potentials have been analyzed. For the repulsive (unstable) trap potential it is shown that there exists a
critical value ofm odulation param eters, when the $m$ atter w ave soliton is stabilized. A nalogous phenom enon of stabilization of unstable xed points is found for periodic modulations (optical lattioes). For the bounded potential it is shown that the e ective trap potential can bifurcate from the one well to the triplewell structure; and so, $m$ ay give rise to the splilting of single attractive BEC into three parts.
