Dynamics of bright matter wave solitons in a quasi 1D Bose-Einstein condensate with a rapidly varying trap

A bstract

The dynam ics of a bright matter wave soliton in a quasi 1D Bose-E instein condensate with periodically rapidly varying trap is considered. The governing equation is derived based on averaging over fast modulations of the Gross-P itaevskii (GP) equation. This equation has the form of GP equation with elective potential of more complicated structure than unperturbed trap. For the case of inverted (expulsive) quadratic trap corresponding to unstable GP equation, the elective potential can be stable. For the bounded in space trap potential it is showed that the bifurcation exists, i.e., the single well potential bifurcates to the triple well elective potential. Stabilization of BEC cloud on-site state in the temporary modulated optical lattice is found. (analogous to the Kapitza stabilization of the pendulum). The predictions of the averaged GP equation are conomical by the numerical simulations of GP equation with rapid perturbations.

I. IN TRODUCTION

Recently bright matter wave solitons has been observed in a Bose-Einstein condensate [1,2]. In the experiment described in Ref. [1] propagation in anisotropic BEC with cigar type geometry was considered. In Ref. [2] the soliton is monitored by projecting the bound state of 5000 atoms into expulsive harmonic potential. The soliton was observed propagating without changing of the form for distances is order of 1mm. The expulsive harmonic trap used, in the experiment, corresponds to an unstable potential for the GP equation and a soliton can exists only as a metastable state in BEC [3,4]. It is of interest to investigate the dynamics of a bright matter wave soliton in inhomogeneous time dependent systems, in particular possible stabilization of unstable dynamics or complicated dynamics of solitons in BEC.

An interesting example of such a trap is an optical trap which is indeed rapidly varied in time. It is realized for instance for a condensate in dipole trap formed by a strong or resonant laser eld [5]. A typical model is a trap formed by a harmonic potential with different frequencies which is cutting at an energy V_c . Numerical simulations of the condensate dynamics and splits in 1D BEC with a positive scattering length under periodically shaken trap has been performed in Ref. [5]. The same form of wave equation leads to the propagation of spatial solitons in periodically modulated parabolic waveguides. This problem appears in investigation of intense light beams in a nonlinear waveguide with inhomogeneous distribution of transverse refractive index. A typical distribution can be approximated by a quadratic prole. The rapid variation of this prole along the longitudinal direction leads to a rapidly varying quadratic potential in the NLS equation.

The general mathematical problem is to investigate localized states for the nonlinear wave equation with cubic nonlinearity and with rapidly varying (not small) potential of the form $V_0 = f(x)$ (t=); 1. Also it is of interest to investigate possibilities of stabilization of a soliton by rapid perturbations. For multi-dimensional NLS equation under rapidly varying in space periodic potential such a problem is discussed in [6].

The paper is organized as follows:

In section 2 we describe the procedure of obtaining the averaged equation for the GP equation with an external potential, that is rapidly varying in time and inhomogeneous in space, with the form $f(x)\cos(t)$, where = 1 = 1. In Section 3, we considered some important potentials for applications, which have the form s given by $f(x) = x^2$; $1 = \cosh(bx)$, and $\cos(kx)$.

II. AVERAGED GROSS-PITAEVSKII EQUATION

The dynam ics of BEC is described by the time dependent GP equation

where m is the atom mass, $g = 4 h^2 a_s = m$, with a_s the atom ic scattering length. $a_s > 0$ corresponds to the BEC with repulsive interaction between atoms and $a_s < 0$ to the attractive interaction. The trap potential is given by $V = m \cdot !^2 (y^2 + z^2) = 2 + (t) (m \cdot !^2 x^2 = 2 + V_1(x;t))$, where $V_1(x;t)$ is bounded potential or the optical lattice potential, (t) describes the time dependence of the potential. We will specify the form of V_1 later. where we will assume a periodic modulation of the trap

For example for $V = m!_1^2 x^2 = 2$; $_0 f(x) = (!_1 = !)^2 x^2 : A lso = 1$ are the attractive and repulsive two body interactions respectively. We introduce the parameter = 1 to have possibility to use the results for optical beam propagation. For BEC system = 1.

The eld u(x;t) can be represented in the form of sum of slowly and rapidly varying parts U(x;t) and (x;t)

For obtaining the equation for an averaged eld we will apply the asymptotic procedure suggested in [6], namely we will present the rapidly varying part of the eld as expansion on Fourier series

where A; B; C; D are functions of (x,t) that are slowly varying in the scale O (1) functions. By substituting the equations (5), (6) into (3) we obtain the next set of equations for the slowly varying eld and the coe cients of the expansion for the rapidly varying component

The averaged equation has the form of a modied NLS equation with a slowly varying potential

This result shows that the soliton dynam ics can have more complicated character than in the case of BEC with slow ly varying parameters. We can expect here the stabilization of the unstable dynamics of a soliton by rapidly varying perturbation. It is a direct analogy with the stabilization of systems with a few degrees of freedom under rapidly varying in time parameters.

III. DYNAM ICS OF DIFFERENT MODELS OF TRAP POTENTIALS

A.A quadratic potential

As an example, we will consider the attractive BEC with a quadratic trap potential. In this case we have a perturbed trap potential $[0 + 1 \sin(t)] f(x)$ with $f(x) = x^2$ and f(x) = 1. An averaged elective potential is given by

where = $_1$ =. The case when $_0$ > 0 corresponds to the inverted (repulsive) harmonic potential case which is well known to be unstable [4]. As seen that when 2 2 > j $_0$ jthe sign of the elective potential is reversed and the solitary wave dynamics becomes stable. The frequency of oscillations of the soliton center now is

This result can be also obtained by using the moments method. It is useful to introduce two new variables: a position of a solitary solution of the governing equation (3)

By using governing equation (3) we come to the following set of integro-dierential equations:

In the case of a quadratic e ective potential (W $(x) = x^2$) the set of equations (23) is closed and we get the equation of motion for the soliton solution center, X (t), in the form

We point out that the set (23) is exact. No additional assumption was made in obtaining this set of equations, and it is valid for any solitary solution of the governing equation (3). Also, it should be noted two remarkable facts connected with the dynamics of a solitary solution of NLS equation in the presence of a quadratic potential (or dynamics of BEC in a quadratic trap): i) In this case the equations of motion (23) for the soliton center, are exact, ii) after averaging, the initially quadratic potential remains to be quadratic but its sign may be reversed.




Fig. 1. Num erical simulations of the full GP equation for f(x) = x^2 with ! = 10, 0 = 0:0493 and values of the perturbation parameter 1 providing reversing of the initially inverted harm onic potential. Two cases are presented: a) $_1 = 4:7124$ and b) $_1 = 3:1415$.

The results of numerical simulation of the full Gross-Pitaevskii equation with the modulated in time expulsive (inverted) harmonic potential are shown in Fig. 1. Two cases with $_1=4.7124$ and $_1=3.1415$ were considered. For both cases $_0=0.9493$ and $_1=10$. The results of computation are the following: a) $_1=4.7124$, $_1=1.309$; (T = 4.8) Calculation by Eq. (24) gives $_{\rm cal}=1.257$; (T_{cal}=5.9). b) $_1=3.1415$, $_1=0.7705$; (T = 8.155) Calculation by Eq. (24) gives $_{\rm cal}=0.7695$; (T_{cal}=8.165).

In both cases we observe the appearance of stable oscillations of the soliton position. We obtain good agreem ent between the full simulations and the averaged equation. As seen, the greater is the value of , the discrepancy we found between results of calculation of Eq.(24) and the ones of full numerical simulations of NLS equation. We can expect this since the ratio $_1$ = is not small for these values of parameters. Let us estimate the values of parameters for the experimental situation. In the experiment [2] the longitudinal frequency was $!_1$ = 4Hz, so, at the temporal modulations of this potential, with the frequency = 40Hz we should observe a stable bright matter wave soliton.

B. The case of a bounded potential

Let us consider a bounded in the space trap potential for the atom ic Bose-E instein condensate [5] under fast temporal perturbations ($_{0}+_{1}\sin(t))f(x)$ with $f(x) = 1=\cosh(bx)$ and = 1.

A fler averaging over the period of fast perturbations, the e ective potential \mathbb{W} (x) has the form




Fig. 2. E extive potential for $f(x) = 1 = \cosh(bx)$ after tem poral averaging. The parameters of perturbation ! = 10, $_0 = 0.05$ and $_1 = 9$. D ashed line is for the case with $_1 = 0$ when tem poral perturbation is turned o .

this e ective potential takes a triple well structure having a central m in in um and two lateral m in in a. In Fig. 2, a typical form of the potential is presented, where $_0 = 0.05$; $_1 = 9$;! = 10 and b = 0.6. (As seen, the condition (26) m akes one to take large ratio of parameters $_1$ and $_0$.)




Fig. 3. Numerical simulations of the full GP equation for the bounded potential with $f(x) = 1 = \cosh(bx)$. The case a) corresponds to the nite motion of the soliton center in the central minimum with $X_0 = 0$. The case b) corresponds to the motion in one of the lateral minima with $X_0 = 3.96$. For both cases ! = 10, $_0 = 0.05$ and $_1 = 9$.

The two lateralm in im a are positioned at x = 3.96 and the central one at the point x = 0. The results of num erical simulations of the Gross-Pitaevskii equation are shown in Fig. 3.

To describe small oscillations of the soliton solution center and to obtain equations of motion in general case, we will have to make some approximations. As the ansatz, we suppose the solution to take the form $u(x;t) = u(x \times X(t);t)$. Here and after, for the sake

of sim plicity, we also suppose the position of the m in im um at $X_0 = 0$ and a sym m etrical form for the soliton solution (dynamics of which we are investigating)

Now we can consider the second term of the equation (23). At isst we rewrite the elective potential as a sum of antisym m etric and sym m etric parts $W(x) = W^A(x) + W^S(x)$, where $W^A(x) = \frac{1}{2}(W(x))$ W(x) and $W^S(x) = \frac{1}{2}(W(x) + W(x))$. Then, substituting W(x)into the second term of Eq. (23) expanding ju (x X (t);t) in term s of X (t) and by holding the rst two terms,

Calculation of the parameters $\, X \,$ and $\, ! \,$ $^2 \,$ for our case ($_0 = \,$ 0.05; $_1 = \,$ 9; $! = \,$ 10 and b = 0.6 with $f(x) = 1 = \cosh(bx)$) gives

- 1) central m in im um : $X_0^W = 0$, ! = 0.2539 (T = 24.74), X = 0, $X_0^{st} = 0$. Results of num erical simulation: ! = 0.251 (or T = 25.0), X = 0.
- 2) a lateral m in im um : $X_0^W = 3.96$, ! = 0.00599 (T = 104.73), X = 0.321, $X^{st} =$ $X_0^W + X = 4:18$. Results of num erical simulation: ! = 0:0539 (or T = 116:8), $X_0^{st} = 4:3$. Here X_0^W is the position of a given m in im um of the potential W(x); X_0^{st} is the stationary point (about which oscillations occur); X is the shift of a stationary point; ! and T are the frequency and period of oscillations.

From the present analysis we conclude that the theory of averaging of GP equation over rapidly varying perturbations works well in the case of bounded perturbation potential even when the expansion parameter is su cient large (in our case = 0.9). The elective trap potential bifurcates from the one well form to the triple well structure. This can lead to the splitting of single attractive BEC into three parts.

C.A periodic potential

Let $f(x) = \cos(kx)$. Then the averaged equation coincide with the unperturbed one but with the another potential:

This potential has a more complicated structure and, as a result, the motion of the soliton center has new properties. Let us consider the motion of one soliton in such a potential. The single soliton solution is

As seen the motion of the soliton center occurs under the action of two harmonic elective perturbation. It represents a close analogy with the stabilization of a pendulum with the rapidly oscillating support point (the Kapitza pendulum). As it is well known [8], the oscillations of the pendulum at the point k = are unstable. The rapid perturbation stabilize this xed point. The stabilization condition follows from the elective potential for the soliton in the periodic eld (34) and it is given by




Fig. 4. Numerical simulations of the full GP equation for a spatial periodic potential $f(x) = \cos(bx)$ with the initial soliton position at an unstable point $X_0 = -b$. The case a) (dashed line) corresponds to in nite motion of the soliton center when $_1 = 0$ with the fast perturbation turned o. The case b) corresponds to $_1 = 9$ when the fast perturbation stabilizes the motion of the soliton center. The parameters of perturbation are ! = 10, $_0 = 0.05$, as in the case of a bounded potential.

The results of numerical simulation of the full GP equation are presented in Fig.4. The parameters $_0$ and ! are the same as for the above considered bounded potential. Fig. 4a depicts the dynamics of a soliton center in a periodic potential $_0$ cos(kx) with its initial position = =k corresponding to the unstable point when $_1$ = 0 (the fast perturbation is turned o). As seen the motion is in nite. Fig. 4b shows the case when $_1$ = 9 (the fast perturbation is turned on). In this case the motion of the soliton becomes nite and it oscillates with the frequency $_1$ = 0:303 whereas the predicted value by Eq. (36) is 0:308. One can see that the agreement with the theory is remarkable.

IV.CONCLUSION

We have investigated the propagation of bright matter wave soliton in the Bose-Einstein condensate with trap potential rapidly varying in time.

The cases of modulated in time quadratic, bounded and periodic trap potentials have been analyzed. For the repulsive (unstable) trap potential it is shown that there exists a

critical value of m odulation parameters, when the matter wave soliton is stabilized. A nalogous phenomenon of stabilization of unstable exed points is found for periodic modulations (optical lattices). For the bounded potential it is shown that the exctive trap potential can bifurcate from the one well to the triple-well structure; and so, may give rise to the splitting of single attractive BEC into three parts.
