Quantum tunneling between param agnetic and superconducting states of a nanom eter-scale superconducting grain placed in a magnetic eld.

We consider the process of quantum tunneling between the superconducting and param agnetic states of a nanom eter-scale superconducting grain placed in a magnetic eld. The grain is supposed to be coupled via tunneling junction to a normal metallic contact that plays a role of the spin reservoir. Using the instanton method we not the probability of the quantum tunneling process and express it in terms of the applied magnetic eld, order parameter of the superconducting grain and conductance of the tunneling junction between the grain and metallic contact.

Recent advances in manufacturing of small electronic devices posed several questions in the theory of nanom eter-size superconductors related to their prospective applications [1]. One of the key issues is the behavior of ultra-small superconductors, of the dimensions much less than the coherence length in the presence of a magnetic eld. Of a special interest from both fundamental and practical point of view are the dynamical processes of switching between the superconducting and paramagnetic states. Small grains can experience spontaneous transitions due to quantum uctuations. In this Letter we investigate the process of quantum tunneling between the superconducting and paramagnetic states of an ultra-small superconductor.

In geometrically restricted superconductors the Zeem an e ect suppresses superconductivity at magnetic elds exceeding H $_{\rm spin}$ = $\frac{1}{2}$ $_{\rm B}$ where is the order parameter [2{4]. The orbitale ect in small superconductors, which usually plays a major role, was discussed in a pioneering work by Larkin [5]: In a dirty spherical grain,

1, is the normal excitation relaxation time, the orbital e ect leads to suppression of superconductivity at H $_{\rm orb}$ $_{\rm 0}$ = (r $_{\rm 0}$ =), where $_{\rm 0}$ = hc=2e, D is the di usion coe cient, and r is the radius of the grain.

Tunneling switching e ects appear in the param agnetic lim it H $_{\rm spin}$ =H $_{\rm orb}$ =d l=r 1; where l = $v_{\rm F}$ is the m ean free path, and d is the m ean energy level spacing. In the ballistic case (l'r) this lim it is achieved only if < d corresponding to the strongly uctuating regim e [6]. However in a platelet geometry with magnetic eld applied along the lm H $_{\rm spin}$ =H $_{\rm orb}$ =d lb=S, where b is the thickness and S is the area of the sample; thus the param agnetic lim it can be easily achieved along with condition deven in the ballistic case if the ratio b= $\overline{\rm S}$ is su ciently small.

We focus on the case where the Zeem an elect dominates the orbital one while the order parameter is larger than the mean level spacing d and investigate the process of quantum tunneling between superconducting and paramagnetic states. Since these two states are characterized by dierent values of the total spin, such quantical spin, such quanti

tum tunneling process can occur only in presence of processes allowing for non-conservation of the total spin. We consider the grain weakly coupled with a normal metallic lead (plate) that plays a role of a spin bath. Our nal result for the probability of the quantum tunneling between the superconducting and param agnetic states is

where the num erical coe cient 1:1; the factor N is the number of polarized electrons in the paramagnetic state of the grain, G is the conductance of the tunneling junction between the grain and the metallic lead measured in units $e^2=h$, 0 is the order parameter of the grain in the superconducting state and N E is the total energy di erence between the grain's superconducting and param agnetic states. The factor N is related to the applied magnetic led H and the average density of states as N = 2 _B H with _B = $je_1h=2m$ c. The energy di erence per one state E is related to the magnetic eld deviation H from the magnitude at which the the therm odynam ic phase transition occurs via $E = _{B} H$. The result (1) is valid as long as E =1, the general E is more complicated and we leave it for future study. The meaning of our answer (1) can be understood as follows. The probability of a single tunneling process is $(E = _{0})G$, then the probability of having N of them simultaneously in order to transit to param agnetic state is $sim ply [(E = _0)G]^N$.

The model. We consider a system of a superconducting grain and a metallic plate coupled via weak tunneling

where \hat{H}_g and \hat{H}_M are the H am iltonians of the grain and m etallic plate, \hat{P}_g (\hat{P}_g) are the creation (annihilation) operators of electrons of the grain and of the m etal respectively and t_{kk^0} is the electron tunneling m atrix element between the grain and m etal. Electrons of m etallic plate are described by the free-ferm ion H am iltonian

where $_k$ are the exact eigenvalues (m easured with respect to the chemical potential) of the noninteracting H am iltonian, is the coupling constant, and the magnetic eldh, pointing along the z axis, is measured in the energy units h = $_B$ H:

Quantum tunneling. The amplitude of the tunneling process between the initial and nal states is

where the Hamiltonian H (t) is written in the interaction representation: the noninteracting part includes the m etal H am iltonian H $_{\rm M}$ and the rst (free-ferm ion) term of grain Hamiltonian (3) while the interaction part includes the BCS interaction and electron tunneling between the grain and metal. We will consider a process of quantum tunneling from pure superconducting state (initial state) to the param agnetic state with order param eter = 0. The electron tunneling between the grain and m etalwillbe treated as a perturbation assuming that the tunneling matrix elements t_{kk0} are small. The paramagnetic state has a nonzero total spin S which is form ed by the polarized electrons with $j_k j < \infty$ such that $S = \infty$: During the quantum tunneling process the spin of the grain increases from zero to S; thus there must be 2S electron tunneling processes between the grain and m etal and rst nonzero contribution in expansion of Eq.(4) in tunneling element emerges only in N = 2S order. It is clear that the paired states which are destroyed by the electron tunneling are those with j j < ~: Expanding Eq.(4) #twe have

In the absence of coupling between the grain and m etal the initial and nal states of the system are the products of the corresponding initial and nal states of the grain and m etal ji >= ji_G > ji_M >; jf >= jf_G > jf_M >; thus in the leading order in tunneling m atrix elem ent the quantum m echanical average of operators \hat{d} in (5) can be directly in plem ented. Since the total spin of the m etallic plate decreases during the quantum tunneling process the only relevant m atrix elem ents are those that correspond to creation of electrons w ith spin down and annihilation of electrons w ith spin up

where the sum goes over all excitation permutations p(k): Since we consider only the case E << we can simplify the problem assuming that the energy of a typical excitation in the metal is much less than : In this case we can neglect the energies $^{\rm fpg}_{k0}$ in (6) and using the Heisenberg representation we write the amplitude (6) as

where a speci c permutation p(k) was chosen.

The probability P of the tunneling process is obtained by integrating of A over all possible quantum states of the m etal




FIG.1. Dependence of the order parameter on time: The region > 0 is the mirror rejection of the \physical region < 0: The superconducting state corresponds to the regions j j> T while the parameter one to j j< T:

To nd the value of A we shall use the instanton method turning to use the Euclidean timet! i: Taking initial and naltimes as $_{\rm i}$ = 1; $_{\rm f}$ = 0 we present the amplitude A as

where it was used that by construction the Euclidean evolution operator S brings the grain from initial $j_G > to$ the nal $j_G > state$: S $j_G > = j_G > :N$ ow the instanton process has the following structure (see Fig.1.): the evolution begins at = 1 from the superconducting state, then at T the system turns into the paramagnetic state and stays there till it turns back to the superconducting state at T:The articial part of the process (> 0) is the mirror rejection of the `physical" process with < 0:The advantage of this representation is that now the new initial (= 1) and nal (= 1) states are identical and therefore we can use the convenient functional representation for A

The integration over the ferm ionic elds in (10) should be implemented exactly while the assumed integration over () will be done with the saddle point accuracy. Now taking integrals in (8) for the probability we obtain

In the absence of tunneling the physical G reen function \hat{g} would coincide with \hat{g}_1 that obeys equations (20,21) conserving the quasiparticle spin. Therefore the function \hat{g}_1 in the paramagnetic state obeys the boundary condition (28) for any while in the superconducting state it obeys the boundary conditions (26), so that \hat{g}_2 ! 0 in the superconducting phase.

Numerical solution. Solution of Eqs.(20) satisfying the necessary boundary conditions for a given con guration of the order parameter () can be easily found numerically. To not the components of the function \hat{g}_2 one rst




FIG .2. The norm alized order parameter ()= $_0$ (dashed line) and the norm alized total spin 2S ()=N of the grain as functions of on 0 = T at the boundary T between the superconducting (left) and paramagnetic (right) states.

needs to solve Eqs.(24) num erically and then $\,$ nd the components ${\bf \hat{g}_2}$ according to Eq.(25). Knowing the functions ${\bf \hat{g}_1}$ and ${\bf \hat{g}_2}$ for a given conguration () one cannot the self-consistent conguration of () satisfying Eq.(16). This self-consistent solution () along with the total spin of the grain S() at the right instanton boundary is presented on Fig.2 (solution at the left boundary can be obtained as the mirror rejection of that on the right one). Substituting the functions () and ${\bf g}^{\rm I}; {\bf g}^{\rm II}$ into Eq.(12) and calculating the term Trlh [${\bf e}$ + H $_{\rm k}$] by the method described in [8] one obtains the result (1).

Conclusions. In conclusion, we have found the probability of the quantum transition between superconducting and param agnetic states of a nanom eter size superconducting grain weakly coupled to a normal metallic plate. Our result (1) obtained formally in the limit of T ! O is general and remain valid at nite temperatures as long as T E. At higher temperatures, E T , the characteristic energy E in the exponent of Eq.(1) has to be substituted by temperature T. However, nding numerical coecient in this case requires a more advanced study.
