Fluctuations of Fluctuation { Induced \C asim ir" Forces

The force experienced by objects embedded in a correlated medium undergoing thermal uctuations the so-called uctuation {induced force is actually itself a uctuating quantity. We compute the corresponding probability distribution and show that it is a Gaussian centered on the well-known Casim ir force, with a non-universal standard deviation that can be typically as large as the mean force itself. The relevance of these results to the experimental measurement of uctuation-induced forces is discussed, as well as the in uence of the nite temporal resolution of the measuring apparatus.

In 1948, Casim ir predicted that two uncharged conducting plates facing each other in vacuum are subject to a long-range universal attraction [1]. The latter is due to the modi cation of the quantum electrom agnetic

uctuation spectrum due to the boundary conditions im – posed by the conducting plates. In the last fieen years, the concept of C asim ir force has been extended to therm ally excited elastic forces between objects embedded in a medium with scale-free uctuations altered by the presence of the objects [2]. Soft matter examples comprise inclusions in complex uids undergoing thermal uctuations [2], e.g. uid membranes [3, 4] and critical mixtures [5], or interfaces bounding complex uids, e.g., liquid crystals [6, 7] and super uids [8, 9]. One of the main features of these C asim ir interactions is their universality. In a given geometry and at a given temperature, the

uctuation {induced forces depend only on the universality class of the uctuating medium and on the nature of the imposed boundary conditions (the material's elastic constants and the coupling strength of the boundaries are irrelevant).

W hile the developm ent of micro-and nanoscale experim ents has allow ed precise direct veri cations of the originalvacuum 's C asim ir force [10, 11], experim entalcharacterization of thermal uctuation { induced forces in softmatter has been scarce [13, 15]. The main di culty with m easuring these forces is usually in puted to the presence of stronger background elastic and van der W aals forces. Another important point which has been overlooked, is that the uctuation-induced force is itself a uctuating quantity: what is comm only referred to as the \C asim ir force" is only its ensemble average. The uctuating nature of this force should be taken into proper account before their complete characterization can be achieved. Sim ilar consideration hold for the experim entalm easurem ent of quantum C asim ir forces [10, 11, 12], but we focus here only on the classical regime.

In this Letter we fully characterize the uctuations of




FIG.1: Two identical macroscopic plates norm alto the x axis immersed in a uctuating correlated medium .

these thermally excited elastic forces. Generically, we consider in a space of dimension d, a uctuating medium described by a scalar eld with an elastic energy density proportional to $(\tilde{r})^2$. For instance, could represent the deviation of the director of a nem atic liquid crystal [16] from a uniform orientation (in the one-elasticconstant approximation) [6] or the composition of a mixture at its critical point [9]. We consider two plates of lateral extension L separated by a distance H (see Fig. 1) that im pose = 0 on their boundary. We show that the uctuating force is characterized by a Gaussian distribution for d > 1 centered on the usual Casim ir force $k_{\rm B} T L^{d 1} = H^{d}$. We characterize the corresponding hFi dispersion by the \noise-over-signal ratio," i.e. the width F of the distribution over the m ean hF i. By calculating

F we show that this ratio scales as

$$\frac{F}{hFi} = \frac{H}{L} = \frac{\frac{d-1}{2}}{a} + \frac{\frac{d+1}{2}}{a} : \qquad (1)$$

In the above result a corresponds to a m icroscopic length scale at which either the continuum description breaks down or the boundary conditions are not e ciently set by the plates [14]. We also consider the dynamics of the eld and the role of the nite tem poral resolution of a m easurem ent apparatus. If $_{a}$ is the m icroscopic timescale associated with the m icroscopic length a, we show that the noise to signal ratio is signicantly reduced if the apparatus' resolution induces some additional averaging (i.e. > $_{a}$). More precisely, the average is still hF i, but the noise to signal ratio now scales as:

$$\frac{F}{hFi} = \frac{H}{L} = \frac{\frac{d-1}{2}}{a} + \frac{H}{a} = \frac{\frac{d+1}{2}r}{a} = \frac{a}{a}; \quad (2)$$

The relevance of the above results to experimental situations is discussed at the end of the paper.

W e consider an elastic H am iltonian of the form

with $\tilde{R} = (x;r)$, and x the coordinate in the direction norm al to the plates. We assume that the plates in pose Dirichlet boundary conditions, i.e., (x = 0;r) =

(x = H; r) = 0. The whole system is in contact with a heat bath in posing the tem perature T. For this m inim al model, the free energy F (H) of the system can be exactly calculated as a function of the interplate distance H [B]. The C asim inforce hF (H) i (PF = QH), i.e. the ensem ble average of the uctuation-induced force, is given by the universal form ula

$$hF i = k_B T A_d \frac{L^{d 1}}{H^{d}}; \qquad (4)$$

where the prefactor $A_d = (d=2)$ (d)=(4 $d^{d=2}$ depends only on the spatial dimension d.

W e shallpursue another route to calculate the C asim ir interaction, which yields a clear intuitive picture of the origin of the uctuation { induced force, and perm its evaluation of its uctuations. We use the stress tensor associated with the eld [17]: $T_{ij} = E_{ij}$ (Q) [QE=Q (Q_j)], where $E = \frac{1}{2}K$ (f)² is the energy density associated with Eq. (3). We extract our attention to the effect of the interplate medium on the plate located at x = H. For a given conformation of the eld, the projection F < (H) on the x-axis of the elastic force exerted on the inner side of this plate is given by the integral of T_{xx} , which reduces to

since vanishes all along the plate. Note that this quantity is always positive, therefore the eld always pushes on the plate. Fourier transforming the eld in the transverse direction: $_{q}(x) = \frac{d^{d}}{p}r(x;r)e^{iq r}$ yields $H = \frac{R^{q}}{R^{q}}E_{q}$ and $F^{<}(H) = \frac{d^{d}}{p}r(x;r)e^{iq r}$ with $E_{q} = \frac{1}{2}L^{1d}K dx [_{q}(x)(\frac{q^{2}}{x} + q^{2})_{q}] and f_{q}(H) = \frac{1}{2}L^{1d}K f_{x q}(H)f$. These expressions suggest an interesting picture: each E_{q} can be understood as the energy of a three-dimensional string parameterized by




FIG.2: Typical con guration of a uctuating string pinned at x = 0 and x = H. The dashed cylinder sketches the e ective cage in posed by the con ning quadratic potential of curvature K q²=L^{d 1}.

[x;Re($_q$);Im($_q$)]; each of these virtual strings has a line tension proportional to the rigidity K of the medium and is conned around the x-axis by a harmonic potential of stiness proportional to \hat{q} . These lines are pinned at x = 0 and x = H as a consequence of the D irichlet boundary conditions (see Fig. 2) and the force they exert on the plate located at x = H is precisely f_q (H). The total partition function of the medium between the plates is the product $Z = \frac{1}{H \times 1=a} Z_q$ of those of the independent strings

where a^1 is the high wavevector cuto . The number of non-interacting strings describing our system is from simple mode counting:

Determ ining the distribution of the elementary forces $f_q(H)$ is straightforward. Since the free energy associated with the string elds $_q$ is quadratic, the distribution of (0, q(H)) is a Gaussian with zero mean and variance (0, q(H)), where $G_q(x;y) = h_q(x)_q(y)$ is the two-point correlation function [18]:

$$G_{q}(x;y) = L^{d_{1}} \frac{k_{B}T}{K} \frac{\sinh [q(H \ u)]\sinh(qv)}{q\sinh(qH)}; \quad (8)$$

where u = m ax(x;y) and v = m in(x;y). Since the distribution of $@_{x q}$ is G aussian, the uctuating elementary forces follow a ²-distribution:

where is the Heaviside step function, and

$$hf_{q}(H)i = \frac{k_{B}T}{2} \frac{2}{a} q \operatorname{coth}(qH); \quad (10)$$

The cuto a^1 appears in Eq. (10) because of the discontinuity of the derivative of $G_q(x;y)$ [19], as a manifestation of the importance of the short wavelength uctuations. From Eq. 8 follows that the elementary forces undergo large uctuations: their standard deviation, given by

com pares with their average value.

We can now consider the whole space consisting of three independent subsystems delimited by the plates. The instantaneous force F (H) experienced by the plate at x = H is the di erence between two independent stochastic variables F[<] (H) F[<] (1), where F[<] (1) obviously describes the contribution of the outer medium x > H.W ithin the string picture F (H) = $_{\rm q}$ [f_q(H) f_q(1)] thus appears as the sum of N_a independent variables.

Mean Casim ir force: From Eq. (10), the mean force hF i experienced by each plate is given by (replacing the discrete sum by an integral and disregarding the cute as the integral converges): hF i = $\frac{1}{2}k_BT$ (L=2)^{d1} d^{d1} q [q qcoth(qH)], which yields the result quoted in Eq. (4) above. We thus recover the usual expression of the Casim ir force, classically obtained by di erentiation of the free energy.

The cancellation of the non-universal cuto contribution in the form ersum is easily understood in term softhe strings picture: since a string with label q has a correlation length ' q¹, the strings with q H¹ do not feel the presence of the second plate and their average contributions on both sides of the plate cancelexactly. C onversely, the force in balance for each string with q < 1=H scales as $k_B T=H$, and there are (L=H)^{d1} such strings, the product yielding the scaling form of the C asim ir force in Eq. (4).

D istribution of the uctuation-induced force: The variance of the force, (F)² hF^2i hF^2i , is the sum of the 2N a elementary contributions (f_q)² from both sides of the plate:

where the integral must be limited to $jq j < a^1$ to be de-

ned.W hen H a, the leading behavior is given by the lim it H ! 1, i.e., $(F)^2 (k_B T)^2 L^{d 1}_{q< 1=a} [(a)^1 q^2 q^{d 2} dq$, which yields

$$F \qquad p = \frac{p_{a}}{N_{a}} \frac{k_{B}T}{a}; \qquad (13)$$

where again N_a is the number of transverse Fourier m odes de ned in Eq. (7) above. Contrary to the Casim ir (average) force, the variance of the uctuation { induced force is not universal and is intrinsically related to the physics ruling the interaction between the elastic medium and the immersed plates (through the cuto). Since the short wavelength uctuations of the q strings are mainly responsible for the force uctuations, the scaling behavior of Eq. (13) is expected to hold for any macroscopic external object with smooth shape at the scale a. The force uctuations also include a subdom inant universal part $^{\circ}F$, which can be exactly calculated as

This cuto independent part of the dispersion originates from the N $_{\rm H}$ = (L=H)^{d 1} strings with q . H 1 , as in the case of the m ean C asim ir force.

The $\overline{N_a}$ factor in Eq. (13) can easily be understood from the central limit theorem applied to the extensive system of $2N_a$ non-interacting strings (for d > 1), generating a force with m ean and standard deviation of order $k_B T = a$. The central limit theorem holds since for all the strings $f_q(H) = F ! 0 as N_a ! 1$. As a consequence, the distribution P_F of the force experienced by the plate at x = H is a G aussian:

$$P_{F}(F = f) = \frac{1}{\frac{p}{2}} \exp \left(\frac{(f + F)^{2}}{2(F)^{2}}\right)^{\#};$$

with its mean and variance being given by Eqs. (4) and (12), respectively. Only the average force felt by the macroscopic objects is universal, and the dispersion of the force is essentially controlled by the plates-medium m icroscopic interactions.

Estimation of the Casimir force dispersion: Assuming that the instantaneous uctuation-induced force can be measured with a perfect precision, the noise over signal ratio is thus given by Eq. (1), obtained from Eqs. (4) and (13) using $N_a = (L=a)^{d 1}$. Let us estimate it in a typical experimental situation, e.g., a nematic liquid crystal with a director strongly anchored normal to the plates. In this case, we have d = 3 and a ' 1nm. If the typical size of the plates is L ' 10 m and their separation is H ' 100 nm, then the amplitude of the uctuations is a hundred times larger than the mean force hF i' 1pN. In order to lower the noise over signal ratio to 1, the size of the plates must reach 1mm!

In all the previous discussions we have in plicitly assum ed d > 1. It is interesting to notice the singularity of the one dimensional (1D) case. The net force experienced by the plate can no longer be interpreted as the result of a large number of independent contributions. A 1D elastic medium is indeed equivalent to the sole q = 0string. Consequently the distribution of forces F (H) and F (1) are directly given by Eq. (9) taking the limit q ! 0. However, even if the distribution is no longer G aussian, the scaling of the noise over signal ratio in Eq. (1) still holds in the limit d ! 1.

M easurement of uctuation {induced forces and tem poral resolution: It has just been shown that the equilibrium distribution of uctuation {induced forces may be extremely broad. Any experimental measurement will how ever provide a Itered signal which is averaged over the temporal resolution of the apparatus. In order to estimate to what extent the uctuating nature of uctuation { induced forces m ay be experimentally revealed, a dynamical description is required. A precise description of the motion of the plates is beyond the scope of this tentative approach. In a sim ple picture, the measurem ent apparatus provides a signalF (t) = \int_{1}^{L} $(t t^0)F(t^0)dt^0$. Its response function has a typical decay time and is causal and norm alized $\int_{0}^{1} dt^{0} (t^{0}) = 1$). The limit ! 0 would correspond to a perfect apparatus which provides a signal com pletely described by Eq. (15).

The short wavelength excitations of the strings dom in nate the uctuations of the net force as it has been previously shown. When measuring the force, the apparatus averages over N' = a independent processes, in which a is the microscopic correlation time of the uctuations associated to the modes with wavevector ' a^1 in the x direction. Consequently, we expect the force dispersion F to be lowered by a factor of $1 = \frac{1}{N}$, which leads to

F to be lowered by a factor of I = N, which leads to the result reported above in Eq. (2).

In order to check this analysis, we have studied the simplest case of a local and dissipative dynam ics for the $_{\rm q}$ elds described by the Langevin equations

subject to $_q(0;t) = _q(H;t) = 0$. In the above equation $_q$ is a Gaussian white noise with zero mean and correlations chosen so as to insure therm al equilibrium, i.e. $h_q(x;t)_{q^0}(x^0;t^0)i=2 k_BT(2)^{d1} d^1 (q+q^0)$ (x x^0) (t Φ). This set of N_a equations correspond to the Rouse dynam ical equations for the N_a prinned elastic stings undergoing therm al uctuations [20]. The linearity of the Langevin equations above [Eq. (16)] ensures that the $_q$'s are Gaussian elds, so that it is straightforw ard to determ ine the statistical properties of the measured force.

The nite temporal resolution does not modify the mean force which remains given by Eq. (4), hF i = hF i. The dispersion of the measured forces can be expressed as the product of the ideal expressions calculated previously by an attenuation factor:

where for this dynam ics $_a$ is given by $_a = a^2 = K$. The asymptotic scaling behavior of $(=_a)$ does not depend on the speci c form of the response function : we have

(0) = 1 and (s) $1 \stackrel{P}{=} \overline{s}$ in the limits 1. This simple model of a di usive dynamics thus clearly corroborates the qualitative analysis that lead to Eq. (2) above.

Let us determ ine the e ect of the nite temporal resolution for the experimental example quoted above (L = 10 m, H = 100 nm, a = 1 nm). The order of magnitude of the relaxation time $_a$ in an experiment involving a nematic liquid crystals is around 0.1 s at T = 300K. Using a measurement device characterized by 1 m s such as an optical tweezer [21], the noise over signal ratio is lowered from 100 to 1.

G enerally, Eq.2 quanti es to what extend a slow m easurem ent device is best suited for experim ental observation of the universal part of uctuation { induced forces. From the above analysis it also follow s that replacing the

uctuation { induced force between sm all objects by the simple C asim ir average when studying their interactions and collective behavior m ay not be justi ed if these objects are fast m overs.
