## Local excitations of a spin glass in a magnetic eld

We study the minimum energy clusters (mec) above the ground state for the 3 d Edwards-Anderson Ising spin glass in a magnetic eld. For elds B below 0.4, we nd that the eld has almost no e ect on the excitations that we can probe, of volum e V 64. As found previously for B = 0, their energies decrease with V, and their magnetization remains very small (even slightly negative). For larger elds, both the mec energy and magnetization grow with V, as expected in a paramagnetic phase. How ever, all results appear to scale as BV (instead of B V as expected from droplet arguments), suggesting that the spin glass phase is destroyed by any small eld. Finally, the geometry of the mec is completely insensitive to the eld, giving further credence that they are lattice animals, in the presence or the absence of a eld.

Introduction | Strong disorder or frustration in a system can lead to a low temperature phase with frozen order". This is believed to be the case for spin glasses, the archetypes of such system  $s^{1,2}$ . Does such a frozen phase persist under generic perturbations? Here we consider that question in the context of the Edwards-Anderson<sup>3</sup> Ising spin glass when the perturbation is an external magnetic eld. The e ect of the eld is to align the spins in one direction and this bias may break up the spin glass ordering. Do arbitrarily small elds destroy the frozen order, or can the ordering co-exist with a eld as long as it is not too large? This is a long-standing question that has been surprisingly di cult to answer.

From an experim ental point of view, this question has been addressed only twice for systems of Ising spins. In the rst study<sup>4</sup>, the (non-equilibrium) properties were interpreted to suggest the presence of spin glass ordering at low elds. Several years later the same sample was re-analyzed and the lines of constant relaxation time determ ined<sup>5</sup>. From that, a scaling analysis was perform ed, leading to the conclusion that the relaxation time is – nite for non-zero elds, and thus the system is param – agnetic. On the theoretical size, the situation remains very controversial. In the mean eld picture, where one is quided by the Sherrington-K irkpatrick<sup>6</sup> or other mean

eld models, the de A lm eida-Thouless line<sup>2</sup> B<sub>AT</sub> (T) separates the paramagnetic and spin glass phases, and one has  $B_{AT} > 0$  if  $T < T_c$  ( $T_c$  is the critical temperature in zero eld). Thus spin glass ordering continues in the presence of a su ciently smallmagnetic eld in the mean eld picture. At present, there is no consensus whether this picture correctly describes what happens in the d = 3 Ising spin glass, nor even when d is large but nite. Indeed it has been argued by F isher and Huse<sup>8</sup> that the magnetic eld is always relevant, driving the system at large scales towards paramagnetism <sup>9</sup>. Then any non-zero magnetic eld will destroy the spin glass ordering and will render the system paramagnetic beyond a length scale 'B. In the droplet<sup>8</sup> or scaling<sup>10</sup> pictures, 'B diverges as B vanishes like

where is the spin sti ness exponent. Because of this divergence as B decreases, the relaxation times also diverge. The disculty is thus to determ ine whether these relaxation times diverge only as B ! 0 or at some positive value  $B_c > 0$ . Such a question is nearly in possible to address from simulations because the time scales that can be reached always remain quite small, while equilibrium studies are conned to small system s for the same reason. In view of such hurdles, much numerical ort<sup>11,12</sup> in the last few years has focused instead on the zero temperature limit.

In this paper we also use zero temperature, but we study how m in im um energy clusters<sup>13</sup> above the ground state are a ected by a magnetic eld. Essentially, we search for a putative critical eld  $B_c$ ; if there is an ATline,  $B_c$  is then simply  $B_{AT}$  (T = 0). Our investigation reduces to nding whether there is a phase transition in B at T = 0, and for that we need an order param eter. Since the eld breaks the up-down symmetry, the E dw ards-Anderson order param eter that gives the spatial average of the square magnetization at equilibrium is not of use. It is thus necessary to characterize the spin glass ordering otherwise, for instance by an in nite (spin glass) susceptibility or by the presence of irreversibility on all time scales. However these quantities are not accessible at T = 0, and so other m easures of ordering are necessary. One characteristic of a spin glass order is sensitivity to external perturbations; one can thus see whether the ground state evolves chaotically with B up to a critical value B<sub>c</sub>. The study in<sup>11</sup> showed that there was no sign of chaos when the lattice size was increased for values 1, suggesting that 0  $B_c < 1:0.$  This should of B be compared to the mean eld value for connectivity 6 random graphs for which  $B_{AT}$  (T = 0) ' 2:1. Another study<sup>12</sup> considered how the ground state responded to a dom ain wall twist; this gave som e evidence that the system had frozen order for B  $B_c \prime 0.6$ , although  $B_c = 0$ could not be excluded. Our approach here probes the spin glass ordering through its local excitations; the energy to ip a cluster of spins behaves di erently in a spin glass phase and in a param agnetic phase, and we use this to test for spin glass ordering. First we shall

describe what these minimum energy clusters are; then we shall consider how their energies and magnetizations depend on the external magnetic eld.

M in im um energy clusters | W e start with the 3 d E dwards-Anderson (EA) model with periodic boundary conditions. The Ham iltonian is de ned on a cubic lattice of N =  $L^3$  spins,

The spins are Ising, i.e.,  $S_i = 1$ , and the nearestneighbor interactions  $fJ_{ij}g$  are quenched random variables distributed according to a Gaussian law with zero m ean and unit variance.

In this model, when B is set to 0, there is numerical evidence<sup>14</sup> of an ordered phase at low temperature where each spin i is frozen in a random direction  $hS_{i1} \notin 0$ . We are interested in local excitations in the putative frozen phase, so following previous work<sup>13</sup>, we de ne a M inimum Energy C luster or mec as the connected cluster of spins of low est energy that contains a speci ed number of spins and a given, arbitrarily chosen site. The study of such mec in zero eld show ed<sup>13</sup> that they are, perhaps surprisingly, fractals whose typical energy decreases with their size, in contrast with the properties expected for the F isher-H use droplets. This result is striking and we take it to be a signature of the spin glass phase, allowing us to probe now the case where B > 0.

Numerical method | Our measurements are performed on lattices with L = 6 and L = 10 with di erent values of the eld taken in the range 0 B 1:5; in all cases, we generated 100 disorder samples which was enough to obtain reasonably sm all statistical errors on our observables.

For each disorder sample, we rst compute the ground state of the system using a genetic renorm alization algorithm  $^{15}$ . Then, we choose an arbitrary \reference" spin and ip it along with a cluster containing V 1 other spins connected to it. The goal is to nd the mec of size V, with the constraint that the reference spin is held

ipped and the cluster is always connected. To nd that mec, we use non-local Kawasaki dynamics as in<sup>13</sup> and exchange M onte Carlo<sup>16</sup> with a set of 30 tem peratures (between  $T_1 = 0.5$  and  $T_{30} = 3.0$ ). This search for the mec is repeated ve independent times to check whether the same cluster is found. (Since our algorithm is heuristic, we obtain an upper bound rather than the true energy of the mec.) In practice, we nd the mec quite reliably for V 32 as shown by our tests. Note that our optim ization procedure has been in proved since the analysis m ade  $in^{13}$  in zero eld; for instance, we have been able to nd, for V = 64, low erexcitations than before. W ith thisimprovement, we con mour earlier conclusions but also we have been able to go to larger mec sizes. In all that follows, we take  $V_n = 2^n$ ; 1 n 6; even though the true mec are not always found at V = 64, we present the results also for that size as we believe the corresponding bias is sm all.




FIG.1: Radius of gyration versus the volume of mec at different values of the eld B when L = 10. Insert: Mean end-to-end extension versus the volume. Note the log-log scale in both cases. The plain line has a slope 1=2, corresponding to  $d_f = 2$ .

Geometry of mec | Let us look at two geometric properties of mec. Consider rst the extension of mec as a function of their volum eV; our data for the mean end-to-end extensions are displayed in the insert of Fig.1. Given these values, we conclude that mec span the whole system when V 15 if L = 6 and when V 30 if L = 10.

Second, consider the fractal dimension of the mec. W hen B = 0, we argued<sup>13</sup> that congurational entropy is su cient to drive mec towards the lattice animal phase in which they are stringy objects with a fractal dimension d<sub>f</sub> = 2. This excitation branch is thus distinct from the F isher-H use droplets which are compact objects with a fractal boundary. W hat happens in the presence of a

ekd? It is useful to think of the large B limit which is strongly param agnetic. The surface energy of a cluster is a random variable  $J_{ij}$  that is symmetric about zero, while its bulk energy is BV. Clearly, energy minimization in a random environment will drive the clusters to extend their surface, leading to the lattice anim alphase. We can see in Fig. 1 that this geometrical property, just like the extension, is nearly independent of the strength of the magnetic eld. This shows that geometrical properties of mec are not relevant to distinguish between a param – agnet and a spin glass, but it also gives further support to the claim that mec are lattice anim als even when B = 0.

Energies of mec | Consider nst the typical excitation energy  $\overline{E}$  of a mec, where () denotes the average over disorder. In the param agnetic phase, i.e., for large B,  $\overline{E}$  is expected to be self-averaging as V ! 1. Since there is a non zero magnetization per spin, that energy should grow as  $\overline{E}(V) / BV$ , leading therefore to = 3. Note how ever that because of the self-averaging property, the probability to nd  $\overline{E} = O(1)$  should go to zero m uch faster than any power of V for large V; there are thus no low energy excitations at large scales. Follow ing an Im ry-M a argument, F isher and H use<sup>8</sup> argued that this should actually occur for any  $B \notin 0$  for su ciently large V's. The param agnetic behavior should set in beyond a cross-over volum e V<sub>B</sub>, obtained by com paring the Zeeman energy  $B^{p}\overline{V}$  of a B = 0 droplet with its excitation energy  $V = d_f$ . The result is the cross-over volum e  $V_B$  / B  $^{\rm 2d_{\,f}\,=\,(d_{\rm f}\,\,2\,\,)}$  , with the corresponding length being given in Eq. 1. Note that df is the (possibly fractal) dimension of the excitation. In the usual picture of com pact droplets<sup>17</sup>, one has  $d_f = 3$  and 02. In the num erical investigation of  $mec^{13}$ , it was found that the excitation clusters were instead fractal, df 2:0, and that the e ective was small and negative. Since is small compared to df in all cases, we expect roughly  $V_{\rm B}$  / (=B)<sup>2</sup>. U sing the value 6 from our num erical results, we obtain a rather large value  $V_{\rm B}$ 36=B<sup>2</sup>.




FIG.2: M ean energy per spin versus volum e at di erent values of B when L = 10. Insert: Scaling curve. B = 1:5(), 1:0(2), 0:7(3), 0:5(4), 0:4(), 0:3(5), 0:2(), 0:1(+), 0())

Let us focus on the volume dependence of the mean mec energy at di erent elds B. For allour B values, this m ean initially decreases with volum e; furtherm ore, this decay is compatible with a power law, E (V) V f=df 0:13 as found in zero  $eld^3$ . From the point with <sub>f</sub> of view of the mean eld picture, the behavior observed in our data is qualitatively as expected: below  $B_c = 0.5$ , the spin glass ordering leads to a decreasing E (V) at all V, while for B > B<sub>c</sub> we recover the param agnetic behavior of an increasing energy when V is su ciently large. Note how ever that the estim ate  $B_c = 0.5$  is far below the mean eld value<sup>1</sup> associated with random graphs of connectivity 6, B<sub>M F</sub> 2:1. The important issue is therefore whether the curves eventually bend upwards at large V for all values of B > 0. In order to be m ore quantitative, we have attempted to scale the data, looking for a collapse when plotting E (V )=E (V  $_{\rm B}$  ) as a function of V=V  $_{\rm B}$  . Surprisingly, the data does not collapse well at all when  $V_B$  / B <sup>2</sup> but m erges m uch better if we take  $V_B$  / B <sup>1</sup> as shown by the  $\scaling curve$ " in the insert of Fig. 2. This result suggests that even the low B curves might eventually bend upwards for large enough V; that could be interpreted as signaling the instability of the spin-glass phase in a eld. W e will return to this point later.




FIG.3: M ean m agnetization per site (upper panel) and m ean energy (lower panel) of the ground state of a N =  $10^3$  spins E dwards-Anderson system, versus the m agnetic eld.

N ote that the BV scaling obtained above is rather unexpected since it means that the in uence of a smallm agnetic eld on low energy excitations is actually stronger than anticipated by the Fisher-Huse argument. A lthough we do not have a clear understanding of this result, one could slightly alter the argument as follows. For B = 0 the ground state has a zero magnetization per spin, which means, as recalled above, that the magnetization of a region of volume '<sup>3</sup> is typically of order '<sup>3=2</sup>. For  $B \notin 0$ , a non zero magnetization per spin B (see Fig. 3) appears; this means that the spatial correlations in the ground state change for distances larger than '<sub>B</sub> such that '<sup>3</sup><sub>B</sub> B '<sup>3=2</sup><sub>B</sub>, leading to '<sub>B</sub> (B) <sup>2=3</sup>. Since the mec are fractal, the excitations built at  $B \notin 0$  are expected to be a ected as soon as V  $d_{f}^{fr}$ , or, using  $d_{f} = 2$ , at V (B) <sup>4=3</sup>, a result that is closer to the scaling reported in Fig. 2.




FIG. 4: H istogram of energies for V = 32 mec, at di erent values of B. The lines are there to guide the eye.

We have also studied the distribution of energies of mec, for a given volume; the case V = 32 is given in Fig.4.A sexpected, for large elds (B = 1:0 and 1:5), the distributions become symmetric around their maximum, and their weights for small excitation energies rapidly tend to zero. However for low elds, B 0:5, we nd that these distributions hardly change at all with B.

M agnetization of  $m \in C$  | A nother observable of interest is the mean magnetization per site m (V;B) of mec of volum e V in the presence of the magnetic eld B. (The mec'smagnetization is de ned before it is ipped.) In the droplet picture, the system is driven to the large B lim it




FIG.5: M ean magnetization per site versus V when L = 10, for di erent magnetic elds B.

when V grows as soon as B 6 0. Thus, beyond the crossover scale V<sub>B</sub> discussed above, m (V;B) should converge to a function m (B) that is non-zero for all B  $\pm$  0. The situation is di erent in the mean eld picture. Mean eld predicts that the equilibrium magnetization is independent of the tem perature T at low enough T. Now since the low T properties follow from those of the low est-lying excitations, we see that these excitations cannot have a non-zero m ean m agnetization. The m ean eld picture then consists in having the large V lim it ofm (V;B) van- $B_c$  and grow for  $B > B_c$ . In both pictures of ish for B the spin glassphase, m (B) acts as an order parameter for the param agnetic phase. Fig. 5 show sm (V; B) as a function of  ${\tt V}$  . W e see that the magnetizations for  ${\tt B}$ 0:5 are indeed very sm alland in fact are negative rather than positive. A lso, we see a clear upturn to positive m for V = 32, B > 0.4; this upturn seems to be present even for smaller elds, suggesting that  $B_c < 0.4$ . This bound is more stringent than what we found from the energies

of the mec. Finally, just like the energy, the magnetization appears to approximately rescale as a function of B V .

Conclusions | Our results show that when B < 0:4, the system behaves qualitatively just as in the case B = 0(at least for the sizes studied here), whereas signi cant changes arise when B 0:4. If there is a critical eld, which appears to us rather unplausible, it must obey  $B_{c} < 0.4$ , a bound that is stronger than that most recently obtained  $^{12}\,.$  This value is small compared to the value arising in the mean eld approximation for which B<sub>c</sub> 2:1. A lthough we cannot completely rule out the eld picture, the possibility of rescaling the difm ean ferent curves as a function of BV points towards the destruction of the spin-glass phase for B 6 0. On the other hand, our data are also unexpected from the point of view of the droplet model. First, as emphasized before<sup>13</sup>, mec appear as fractal, rather than com pact, objects. Second, the Fisher-Huse prediction of a crossover volume  $V_{\rm B}$  / B<sup>2</sup> appears not to be correct. We nd that the magnetic eld has a much stronger e ect, since we obtain  $V_{\rm B}$  / B  $^1$  , which m ight be a consequence of the fractal nature of the mec. Finally, the geometric properties of the mec appear to be B independent, and most probably they are lattice animals for all B. Many of the points raised by the present study would be clari-

ed if the corresponding results in d = 4 were available. Note that recent work<sup>18</sup> on Bethe lattices reveals a non zero value of the critical eld  $B_c$  as expected.
