Expansion of an interacting Ferm i gas

We study the expansion of a dilute ultracold sample of ferm ions initially trapped in a anisotropic harm onic trap. The expansion of the cloud provides valuable information about the state of the system and the role of interactions. In particular the time evolution of the deformation of the expanding cloud behaves quite di erently depending on whether the system is in the normal or in the super uid phase. For the super uid phase, we predict an inversion of the deformation of the sample, similarly to what happens with Bose-E instein condensates. V iceversa, in the normal phase, the inversion of the aspect ratio is never achieved, if the mean eld interaction is attractive and collisions are negligible.

Since the st experiments on trapped Bose-Einstein condensates the imaging of the expanding cloud, following the sudden switching o of the con ning potential, has provided crucial information on the novel features exhibited by atom ic gases in conditions of quantum degeneracy. These include, in particular, the bimodal structure of an expanding Bose gas at nite tem perature and the anisotropy of the asymptotic pro le of the condensate [1,2]. In the Thom as Ferm i lim it, where the Gross-Pitaevskii equations coincide with the hydrodynam ic theory of super uids, the anisotropy of the expanded gas re ects the anisotropy of the pressure force which is stronger in the direction of tighter con nem ent [3]. The predictions of the hydrodynam ic equations and of the consequent scaling behaviour exhibited by Bose-E instein condensates during the expansion have been investigated by several authors ([4], [5], [6]), providing excellent agreem ent with experim ents [7,8] and pointing out the di erence with respect to the expansion of a non condensed gas. In the latter case, in the collision less regime, the density pro le approaches an isotropic shape, independent of the initial deform ation of the gas.

In this letter we study the problem of the expansion of an ultracold sample of fermions initially trapped in an anisotropic harm onic trap. We will show that also in the case of fermions the expansion of the gas provides valuable information about the state of the system and the role of interactions. We will consider a gas of atom s interacting with attractive forces. This is a natural requirement for the realization of Cooper-pairs and hence for the achievement of the super uid phase [9]. Such interactions are naturally present in some fermion species like ⁶Li and can otherwise be obtained by changing the scattering length proting of the presence of a Feshbach resonance.

The description of the expansion of a cold ferm ionic gas in the normal and super uid phase requires di erent theoretical approaches. For the norm alphase we use the form alism of the Landau-V lasov equations, while in the super uid phase we study the expansion using the hydrodynam ic theory of super uids.

W e consider the case of two di erent ferm ionic states, hereafter called 1 and 2, initially con ned in a harmonic trap. W e assume that the two species are present in the same am ount and feel the same trapping potential, so that the densities of the two species are equal at equilibrium as well as during the expansion: $n_1(r;t) = n_2(r;t) = n(r;t)=2$. The trapping potential will be chosen of harmonic type

describing a cilyndrically simmetric trap with deform ation = $!_z=!_2$. The interaction between the two fermionic species is xed by the coupling constant g = $4 h^2 a=m$, where a is the s-wave scattering length.

In this paper we will use the equation of state

to describe the uniform phase of the gas where the rst term is the kinetic energy evaluated at zero tem peraure while the second one is the interaction energy evaluated in the mean eld approximation. Equation (2) neglects the e ects of correlations which become important for large values of the scattering length and a ect in a different way the equation of state of the norm al and super uid phase. The form alism developed in this paper can be easily generalized to include a more accurate description of the equation of state. It is how ever worth pointing out that, even using the same equation of state for the norm al and super uid phases, the expansion of the gas behaves quite di erently in the two cases being described by di erent kinetic equations. In the presence of the external potential (1), the equilibrium condition in the local density approximation is determined by the equation

where is the chem ical potential of the sample xed by the norm alization condition.

The relevant parameter characterizing the interaction in the ferm ionic system is the ratio

In the perturbative regim e the integrals (5,6) can be evaluated using the non interacting density pro lewhich, in Thom as Fem i approximation (3), takes the simple form

After integration of (5) and (6) one nds [10]

where $k_F = (3^{2}n(0))^{1=3}$ is the Ferm imomentum evaluated at the central value of the density. In order to go beyond the perturbative regime, one determ ines num erically the ground state density by m inimizing the energy of the system




FIG.1. Ratio = $E_{int}=E_{ho}$ as a function of the universal parameter aN $^{1=6}=a_{ho}$ calculated with the mean eld functional (9) up to the collapse point aN $^{1=6}=a_{ho}$ = 0:61 (full line); the dashed line is the linear prediction (8).

O ne easily nds that the equilibrium value of the ratio $E_{\rm int}=E_{\rm ho}$ depends on the dimensionless combination an $^{1=6}=a_{\rm ho}$ also in the non perturbative regime [9], as reported in Fig1. U sing (9) one predicts that the com – pressibility of the gas becomes negative in the center of the trap if ja N $^{1=6}=a_{\rm ho} > 0.61$. For large values of ja the resulting predictions should be how ever taken with care since the functional (9) ignores correlation elects beyond mean eld.

Let us now discuss the expansion of a ferm ionic sam – ple trapped in an elongated harm onic trap (< 1). We describe rst the expansion of the norm al uid and afterwards the one of the super uid. In the ideal case, using the sem iclassical description, one nds that the ratio of the square radii evolves according to the classical law

The ratio (10) approaches unity for large times, re ecting the isotropy of the momentum distribution. This result ignores the elects of collisions which are however expected to play a minor role at low temperature, due to Pauliblocking, unless the scattering length is very large.

In order to take into account the e ects of the interactions, we consider the mean eld description based on the Landau-V lasov equation

where f (r;v;t) is the distribution function, $n = \int_{-\infty}^{\infty} f d^3 v$ is the atom ic density. Eq.(11) describes the dynam ics of a norm alweakly interacting gas in the collision less regime.

An approximate solution of Eq.(11), is obtained by m aking a scaling ansatz for the distribution function

where f_0 is the equilibrium distribution, $r_i(t) = r_i = b_i$ and $v_i(t) = b_i v_i$ $b_i r_i$. Under the scaling assumption the velocity eld $u(r;t) = vfd^3v=n$ takes the simple form $u_i = b_i r_i = b_i$. This ansatz has been recently used by Guery-O delin [11] to investigate the elect of the interaction on the collective oscillation of a classical gas in the collision less regime.

The equations for the scaling param eters b_i can be obtained by multiplying (11) by r_i and v_i and integrating in phase space. Making use of the equilibrium properties of the distribution function, after some straigthforward algebra one nds

where is the ratio (4) evaluated at equilibrium. The second term in (13) describes the restoring force of the external oscillator potential, the third one originates from the kinetic energy, while the last term, linear in , accounts for the e ects of mean eld interaction.

An immediate application of Eq.(13) concerns the study of the oscillations of the gas. By linearizing the equations around equilibrium ($b_i = 1$) one nds, in the presence of isotropic harm onic trapping (!₂ = !_z = !₀), the result:

for the frequencies of the monopole and quadrupole oscillations which coincide with the results already derived in [10] using a sum -rule approach.




FIG.2. A spect ratio as a function of time for the expansion of the norm al (lower curves) and super uid phase (upper curves) for = 0.1 and two di erent values of the parameter : = 0 (full line) and = 0.4 (dashed line).

The equations describing the expansion are obtained by suddenly removing the second term of Eq.(13), originating from the trapping potential. In the study of the expansion we are interested in the case of anisotropic trapping. In particular we will consider the case of cigar shaped traps. For high deform ations ($= !_z = !_2 = 1$) Eq.(13) yields the asymptotic result

showing that the aspect ratio

approaches a value smaller than 1 if the interaction is attractive (< 0). In Eq.(17), $R_{?}$ and R_{z} are the radii where the atom ic density vanishes (I hom as Ferm i radii).




FIG.3. A spect ratio as a function of time for the expansion of the norm al (low er curves) and super uid phase (upper curves) for = 0.3 and di erent values of the parameters : = 0 (full line) and = 0.4 (dashed line).

The results of the num eric integration of the equations of motion (13) are reported in Fig.2 and 3 as a function of time for the choices = 0 and = 0.4.

W e address now the problem of the expansion of a super uid Ferm i gas. As already anticipated we will make use of the hydrodynam ic equations of super uids. Those equations have been already used to describe the collective oscillations of a superluid trapped Ferm igas [12] including its rotational behaviour [13]. The hydrodynam ic equations are applicable if the healing length is much smaller than the size of the sample, which implies that the energy gap should be larger than the oscillator energiesh! z, h! ? . This non trivial condition in plies that the whole system behaves like super uid. Furtherm ore the hydrodynam ic equations are applicable up to excitation energies of the order of the energy gap. In the problem of the expansion it is crucial that the system remains super uid in the rst instants when the hydrodynam ic forces provide the relevant acceleration to the expanding atom s. O ne expects that this condition be satis ed if the initial tem perature is sm all enough.

The hydrodynam ic description is based on the equation of continuity

where $v_e(n)$ is the chemical potential of a uniform gas calculated at the density n and u is the velocity eld.

If the equation of state is a power law ($_{\rm ve}$ / n) these equations adm it the simple scaling solution

and the T hom as Ferm i radii evolve according to the law $R_i(t) = R_i(0)b_i(t)$. In this case, it is immediate to show that, during the expansion, the scaling parameters obey the coupled di erential equations

for highly elongated con gurations (1). For = 1 (corresponding to a Bose-E instein condensed gas) the equation for the radial motion is integrable analytically and one nds the result b_2 (t) = $(1 + \frac{12}{2}t^2)^{1-2}$ [5].

To describe the expansion of super uid Fem i gas we will use the same equation of state (2) as for the normal phase. The case of a very dilute gas is also described by a power law with = 2=3 (rst term in (2)). For = 0:1 and 0:3 the solution is given by the full upper line in Fig2 and 3 respectively which show that the deformation of the trap is inverted in time and the aspect ratio R₂ = R_z reaches asymptotically a value signi cantly larger than 1 [14]. Super uidity has hence the e ect of distributing the release energy in a strongly asymmetric way along the axial and radial directions. It is worth noticing that the same escaling equations (22), with = 2=3, are obtained for a classic gas in the collisional regime [15].

In the m ore general case (2), a useful approximation to the solution of the hydrodynamic equations, based on the scaling ansatz (20,21), is obtained by multiplying the Euler's equation (19) by $r_in(r)$ and integrating over the spatial coordinates. Using the equation of state (2), one nally obtains the following set of di erential equations

with de ned by Eq.(4). Equations (24) di er from the anlalogous equations (13) holding in the norm al phase. By linearizing Eqs.(24) around $b_i = 1$ one gets, in the case of a spherical trap, the result $!_Q = \frac{1}{2}!_0$ for the quadrupole frequency [12], which, contrary to (14), is independent of the interaction term in .

The predictions of Eqs.(24) for the expansion of the gas are reported in Figs2,3 and show that the inclusion of the interaction term in the equation of state a ects the expansion of the super uid only in a m inor way.

In conclusion we have shown that the expansion of a super uid Ferm igas, being governed by the equations of hydrodynamics, diers in a crucial way from the one of a norm algas in the collisionless regime. From a theoreticalpoint of view several questions remain to be investigated: am ong them, the e ect of large scattering lengths [16] on the equation of state and the role of collisions which, under certain conditions, m ight give rise to a hydrodynam ic regime, and hence to an isotropic expansion, also in the norm alphase. Finally one should develop the form alism at nite tem perature where both the norm al and super uid components are present. The resulting bin odal structure in the expanding cloud is expected to be a ected by the transfer of atom s from the super uid to the norm al component during the stage of the expansion.
