## QC-DMRG study of the ionic {neutral curve crossing of LiF

We have studied the ionic{neutral curve crossing between the two lowest<sup>1</sup> + states of LiF in order to dem onstrate the e ciency of the quantum chem istry version of the density matrix renormalization group method (Q C -D M RG). We show that Q C -D M RG is capable to calculate the ground and several low -lying excited state energies within the error margin set up in advance of the calculation, while with standard quantum chem ical methods it is di cult to obtain a good approximation to Full C I property values at the point of the avoided crossing. We have calculated the dipole moment as a function of bond length, which in fact provides a smooth and continuous curve even close to the avoided crossing, in contrast to other standard num erical treatments.

## I. IN TRODUCTION

The development of the complete active space selfconsistent eld (CASSCF) method by Bjorn Roos' group [1] was a milestone in the development of electronicstructure m ethods e ecting a rigorous treatm ent of electron correlation in molecules. In particular in the case of nearly degenerate states, i.e., in regions of the potential curve, where static correlation prevails, a CASSCF is almost indispensable for a good zero-order description of the electronic wave function, which usually is subsequently rened by methods like MRCI (multireference CI) or CASPT2 (second order perturbation theory based on a CAS reference state) [2, 3]. The latter methods focus on dynamic correlation and are mandatory for achieving quantitative agreement with experiment. A frequently studied test system for the quantitative calculation of electron correlation e ects in m olecules is the ionic { neutral avoided crossing in the potential curves of a kaline habgenides, in particular of LF [4, 5, 6, 7, 8, 9, 10, 11, 12]. The goal of these benchm ark studies is the developm ent of a com putational protocol which provides a globally accurate description of the system even though the wave functions change dram atically transversing the avoided crossing. New ab initio methods for the treatm ent of correlation should prove to provide a satisfactory description of the two states in question, and the present paper is devoted to the application of the quantum -chem istry density matrix renormalization group (QC-DMRG) to calculate the potential energy curve and the dipole-m om ent functions in the vicinity of the ionic (covalent avoided crossing in LF.

Since its rst application on the waterm olecule [13, 14]the QC-DMRG algorithm has become an alternative candidate to treat the electron {electron correlation in atoms and m olecules in a rigorous way. The method has already been applied successfully to calculate the ground state energy of various molecules containing up to 57 orbitals [15, 16, 17], demonstrating the capability of the method to provide the Full-CI results. The general trend of the accuracy of the rst and second excited states calculated by the method and its strong connection to the structure of the reduced subsystem density matrix has also been studied in detail on molecules with various fraction of lling and orbitals [17]. Although results of DM RG calculations seem promising, it is still an open question to determ ine the stability and performance of the new method for systems in which the wave function character changes as a function of bond length, especially in the region of an avoided crossing.

In order to provide a benchm ark test of the QC-DMRG algorithm for an ionic {neutral potential curve crossing, we have calculated the two lowest  $1^{+}$  states of LF. This system has been subject of various earlier theoretical studies [4, 5, 6]. Kahn, Hay and Shavitt [4] calculated the four low est 1 + states using the con gurationinteraction (CI) m ethods. The dipole m om ent function for the lowest  $^{1}$  + states was studied by W emer and M eyer [6] using M C SC F wave functions. The remaining discrepancy between their results and the empirical estim ate of Grice and Herschbach [18] was nally resolved by Bauschlicher and Langho who have employed full con guration interaction calculations to de ne a protocol using an MRCI approach based on carefully constructed CASSCF orbitals, which was found to satisfactorily represent the FCI potential and dipole moment curves for the two lowest 1 + states of LiF. Problem s encountered in the application of CASPT2 [7, 8] have been recently resolved on occasion of the developm ent of multi-state CASPT2 [11, 12].

Our aim in this paper is to assess the stability of the QC-DMRG method in the region of an avoided crossing and show that QC-DMRG provides the FCI energy within an error set up in advance of the calculation for all bond lengths. Taking the dipole moment as an example, we present a generalQC-DMRG procedure to obtain expectation values of rst order-properties for the ground and excited states in molecules using the DMRG method. To the best of our know ledge, this is the rst time that excited-state data and properties have been calculated

for a molecule in the framework of ab initio  ${\tt QC-DMRG}$  .

The setup of the paper is as follows. In Sec. II we brie y describe the main steps of DMRG and the details of the num erical procedure used to determ ine the appropriate ordering and target state. Sec. III contains the num erical results and analysis of the observed trends of the num erical error. The sum mary of our conclusions is presented in Sec. IV.

## II. NUMERICAL PROCEDURE

Detailed description of the DMRG algorithm can be found in the original papers [19, 20, 21, 22] and its application in the context of quantum chem istry is sum – m arized in three recently published papers [15, 16, 17]. Therefore, we present only the most important form ulas and de nitions that are relevant to the question of current interest.

## A. Ham ilton operator

In the context of quantum chem istry a one-dimensional chain that is studied by DMRG is built up from the m olecular orbitals that were obtained, e.g., in a suitable m ean-eld or MCSCF calculation. The electron {electron correlation is taken into account by an iterative procedure that m inim izes the Rayleigh quotient corresponding to the Ham iltonian describing the electronic structure of the m olecule, given by

and thus determ ines the fullCIwavefunction. In Eq. (1),  $T_{ij}$  denotes the matrix elements between orthogonal molecular orbitals f ig of the one-particle H am iltonian comprising kinetic energy and the external electric eld of the nuclei, while  $V_{ijkl}$  stands for the matrix elements of the electron repulsion operator and is de ned as

#### B. Target state

The desired eigenstate of the Ham iltonian that one wants to calculate is called the the target state in the context of DMRG. The representation of such state in the DMRG procedure is derived from an arrangement of m olecular orbitals in a linear chain, which in turn is divided into smaller subsystems and the wave function of the m olecule is built up from the linear combination of basis states representing these subsystems.




FIG.1: The decomposition of the wavefunction to subsystem s.

According to Fig.1 the structure of the subsystems that is called superblock con guration is de ned as B  $_{\rm L}$ 

 $B_R$ , where  $B_L$  and  $B_R$  represents a block containing l and r m olecular orbitals, respectively, and the denotes an orbital, in DM RG term inology a quantum site with q degrees of freedom. In our case q is equal to four, enum erating the doubly occupied, spin up, spin down and empty orbital situation. Since the num ber of m olecular orbitals (N) is constant, it can be expressed as l+r+2=N. The  $B_L$  block is represented by M $_L$  so-called renorm alized block basis states (M $_L$ q<sup>l</sup>), and each block state represents a special distribution of a given number of electrons with up and down spins on the lorbitals. The same holds for  $B_R$  with M $_R$  block states.

In order to recover interactions of electrons in orbitals that are far away from each other in the chain and include their contribution to the correlation energy, the size of the left block is increased as long as 1 N 3 and the length of the right block is decreased so that r + 1 + 2 = N always holds. This iterative procedure is repeated in the reverse way as well, until r = N3 and l = 1 as is shown in Fig. 1. This sweeping procedure implies that in each DMRG iteration step the Ham ilton operator is constructed on a given superblock con guration and the wave function of the molecule is built up from the linear combination of the subsystem basis states with coe cients determ ined by diagonalizing the superblock Ham ilton operator. If Ji and Ji denote basis states for B<sub>L</sub> and B<sub>r</sub> subsystem s, respectively, then the theigenstate is written as

where  $_{I;J}$  is determined by diagonalization of the superblock H am iltonian. In the sim plest situation, the target state of the DMRG m ethod that we want to calculate is one of the eigenstates of the H am ilton operator and can be usually determined with a good accuracy if the eigenstates are well separated.

As second key ingredient of the DMRG method is the selection of the block states for a subsequent iteration step. The M  $_{\rm L}^{\rm new}$  M  $_{\rm L}$  q block states are chosen from the eigenstates (!) of the reduced density matrix of the

The error of the truncation procedure is measured by means of the deviation of the total weight of the selected states from unity which is de ned as

As is was shown in Ref. 17 the accuracy of the DMRG calculation can be controlled by keeping the truncation error below a given treshold  $TRE_{max}$  and the number of block states above a minimum value  $M_{min}$  which avoids the iterative procedure being trapped by local attractors.

It is thus evident, that the construction of the target state has strong e ect on the structure of the subsystem density matrix, on the block states used during all the subsequent iteration steps and on the converging properites of the DMRG method. If the target state does not contain those basis states that are in portant to represent the desired electronic con guration at a given bond length, the method can converge to a wrong state by loosing the optimum structure of the target state. This has long been con rm ed by various DMRG studies and the problem can be solved by constructing target states by coherent superposition of more eigenstates, in which case

The weights are usually taken as ! = 1 for all .

A nother possibility to construct block states for the subsequent iteration step is rst constructing the reduced subsystem density matrices for all eigenstates independently and than add them up, in which case the density matrix for an incoherent target states is de ned as

where again, ! = 1 could be introduced. The construction of coherent or incoherent superpositions for targeting several excited states simultaneously is the the DM RG counterpart of the construction of averaged-states orbitals in a CASSCF calculation in order to obtain an optim aldescription of severalm any-particle states at the same time.

#### C. Identifying the energy levels

In the QC-DMRG algorithm block states representing a given number of electron with up and down spins are 3

identi ed with N  $_{\rm up}$  and N  $_{\rm dow\,n}$  quantum numbers. These are used in order to select out the proper combination of block basis states for the total system described in a given m  $_{\rm s}$  = N  $_{\rm up}^{\rm TOT}$  $N_{down}^{TOT}$  spin sector. In a straightforward application of the DMRG method the rst few eigenvalues of each m s spin sector are determ ined and the classi cation of the singlet, triplet, quintet etc. levels can be accomplished based on the degeneracy of the levels. It is, however, often di cult to determ ine whether two close-lying energy calculated in two di erent m s sectors are two components of the same level or not. This can be resolved by classifying the block states with respect to the irreducible representations of as m any sym m etry groups as possible in order to make use of their direct product in targeting the right quantum states.

In our present in plem entation we use apart from the particle number operator and the  $\hat{S}_z$  operator also the spin re ection operator, which enables us to separate the triplet m anifold from the singlet m anifold by targetting the states of appropriate parity of their spin part. Obvious extensions in future work would be the implem entation of the point-group symmetry of the molecule and the  $\hat{S}^2$  operator.

#### D. Dipole m om ent function

In the DMRG procedure the expectation value of the one electron operators can be calculated from the oneparticle density m atrix according to

where A is an N by N matrix of the operator for a rstorder property, in the same one-particle basis that was used to construct the original  $T_{ij}$  and  $V_{ijkl}$ .

Once the target state was obtained, the one particle subsystem reduced density matrix can be formed for any B  $_{\rm L}$  conguration as

where i, j denote sites in the left block. The one-particle density matrix for the right block is determined in a sim – ilar way. If i is in the left block and j in the right block, then  $_{ij}$  is constructed from the one-particle operators of the two blocks.

#### E. Basis states

C om paring with the benchm ark full-C I calculation of B auschlicher and Langho [9] we have correlated six electrons of the LiF m olecule by the QC-DMRG method on a chain built up from 25 CASSCF orbitals. The active space used to determ ine the latter contains two  $a_1$  orbitals and no  $b_1$ ; $b_2$  or  $a_2$  orbitals. The MOLPRO program [23] was used to prepare the  $T_{ij}$  and  $V_{ijk1}$  m atrix elem ents in this basis.

The G aussian basis set used for lithium was derived from the (9s) primitive set of Huzinaga [24], supplemented by the (4p) functions optimized for the  ${}^{2}P$  state as in Ref. 25. The s and p primitives are contracted (5211) and (31), respectively. The F basis set is the D unning [26] [4s2p] contraction of the Huzinaga [24] (9s5p) primitive set. To describe F , a di use 2p and a 3d polarization function are added; the exponents are 0.08 and 1.4, respectively.

#### F. Ordering m olecular orbitals

It has become evident that the e ciency and accuracy of the QC-DM RG method depends strongly on the ordering of the orbitals [16, 17, 22]. Since this question is still an open eld of research, we have repeated our previous calculations on  $H_2O$ ,  $CH_2$  and  $F_2$  molecules in order to determ ine a strategy for the best ordering for LiF.


W e have applied various algorithm s which reorder the row and colum n indices of a sparse matrix in a way such that o -diagonal elements are moved closer to the diagonal or to one corner of the matrix. Extending the work of C han and H ead-G ordon [16], we have included a criterion based on the Fock operator as well as their originally proposed criterion based on  $T_{ij}$ . Thus we applied the reordering algorithm s to the

matrix in order to include some components of the electron (electron interaction term as well. In the reordering process, we have neglected term s of  $F_{ij}$  below a certain threshold in order to pick up only the most im – portant components. Of course, this procedure is useful only in the case of orbitals di ering from H artree (Fock orbitals, because for the latter  $F_{ij}$  is diagonal.

In agreem ent with the work of C han and H ead-G ordon we have found that a particularly satisfactory ordering can be achieved by using the Cuthill-M cK ee method [27, 28]. As a benchmark test, in case of  $F_2$  molecule with TRE  $_{\rm m\,\,ax}$  = 10  $^{10}\,$  and M  $_{\rm m\,\,in}$  = 64 parameter sets a 10  $^{6}$  in absolute error of the ground state energy was reached with M  $_{max} = 950\{1100 \text{ states, in contrast to our}$ previous results [17] when the sam e accuracy was reached with 1700{1800 block states. In addition, the number of sweeps was reduced by a factor of two. Sim ilar results were found in the other test cases as well. Thus we can conclude that moving the o -diagonal elements closer to the diagonal with the Cuthill-M cK ee algorithm reduces the number of block states and accelerates the speed of convergence. It is worth to note, that this protocol is only expected to give good results if a mean-eld description of the system is reasonable, i.e., in weakly correlated cases.

Based on our observations, we have applied the Cuthill-M cK ee m ethod on the one-electron  $F_{ij}$  interaction m atrix to determ ine the ordering con guration for

LiF for all the di erent bond lengths. We have found the same ordering at both sides of the avoided crossing; the orbital ordering which we used in our calculations is detailed in Table I.

## G. Controlling num erical accuracy

It has been shown in Ref. 17 that the accuracy of the QC-DMRG method can be controlled by method which we called dynamic block state selection (DBSS) approach, whereby the desired accuracy can be predetermined in advance of the calculations. Based on the Full-CI energies calculated at several points on the potential curve we can infer that the smallest value of the energy gap close to the avoided crossing is in the order of 10<sup>3</sup>, thus it is su cient to obtain an accuracy of 10<sup>4</sup> in the absolute error of the energy levels. In case of the LiF m olecule represented with the given basis states this means a relative error of 10<sup>6</sup>, thus the parameter that controls the maximum value of the truncation error has been set to 10<sup>7</sup>. For the minimum number of block states (M<sub>min</sub>) a few hundred states would be su cient.

W e have m ade several test calculations with the above parameter set and found that the relative error indeed converged to 10  $^6$ . As an example of the linear relationship between the relative error and the truncation error we have plotted our results obtained for various values of TRE<sub>m ax</sub> parameter close to the avoided crossing (R = 11.5 a.u.) in Fig.2.

O n the other hand, in order to provide a better benchmark test, we have also used a smaller value of TRE  $_{\rm max}$  for most of our calculations. We have set TRE  $_{\rm max}$  to 10  $^9$  which ensures an absolute error of 10  $^7$  for the low – est energy state of a given m  $_{\rm s}$  spin sector. The accuracy of the excited state energies, on the other hand, can depend strongly on other parameters and the construction of the target state which will be examined in detail in




FIG. 3: The relative error of the ground state energies a function of iteration steps at various bond lengths

the next section.

## III. NUMERICAL RESULTS

We have carried out a detailed DMRG study of the absolute error of the ground and several excited state energies and the dipole moment as a function of bond length, focusing on the avoided crossing, where the wavefunction and also the convergence properties of DMRG is expected to change rapidly.

## A. Ground state

A coording to our previous study [17] rst we ran a calculation with M  $_{\rm m \ in}$  = 164 block states and repeated the same calculation with M  $_{\rm m \ in}$  = 64. We have found that using the Cuthill-M cK experimentation of guration the desired accuracy was achieved with the sm aller M  $_{\rm m \ in}$  value as well, thus we have carried out all of our calculations with the latter value. This in fact sped up the calculation signi cantly reducing the computational time to an order of an hour on a standard PC running at 1.5 G Hz.

W e have found that the desired accuracy of the ground state was achieved for all bond lengths, even close to the avoided crossing. A san exam plewe have plotted in Fig.3 the relative error of the ground state energy as a function of the DM RG iteration steps at various bond lengths. It can be seen that the relative error of the ground state energy converges to 10<sup>9</sup> in all cases. The speed of convergence, how ever, is slow er closer to the avoided crossing as expected be because of the smaller gap and longer coherence length. W e have also found that the largest num bers of the block states (M<sub>m ax</sub>) generated dynam i-cally fell in the range of 150{200 at the equilibrium point,




FIG.4: The calculated potential curve in the vicinity of the avoided crossing. The DMRG results agree up to six digits with the FullCI results.

while it was slightly larger (400 $\{500\}$  close to the avoided crossing.

## B. Excited states

In order to determ ine higher-lying excited states, we have used the spin  $\,$  ip operator to separate the singlet and triplet components. We have found that the rst excited state ( $^3$ ) is the lowest state of the even spin symmetry sector at small bond distances and exhibits the same convergence property as the ground state. Targeting the second level of the odd spin symmetry sector provided the  $^1$  level at the equilibrium point at  $R=3.05\,\mathrm{up}$  to six digits, as expected. We have also targeted higher-lying levels to obtain the second  $^1$   $^+$  state, but the convergence of the method was much slower.

Targeting the second level of the even spin sector for increasing bond lengths, we have found that the target state can be lost when R is close to the avoided crossing. This is, in fact, not unexpected, and we made use of coherent and incoherent target states in order to resolve the problem . In addition, to provide better stability of DMRG it is advantageous to use larger values of M  $_{\rm m \ in}$  , thus we have set it to 200{300. Using the incoherent target states m ethod, the 1 + s tate w as also determ ined within an accuracy of 10<sup>7</sup> for all bond lengths. Our result for the obtained potential curve is plotted on Fig. 4, which agrees up to six digits with the Full-CI result, also given in Table II. Bauschlicher and Langho have pointed out that a careful selection of the CASSCF space used in the determ ination of the orbitals for the MRCI treatment is mandatory in order to get close agreement with FCI results. By contrast, we have found that routine m ethods for the determ ination of the orbital basis are adequate in our DMRG treatment. Indeed, Hartree {Fock orbitals yielded practically the sam e results, corroborat-




FIG.5: The ground and excited states dipole moment as a functions of the bond length.

ing the view that DMRG treatments can be electively converged to the FullCI result. We have also calculated the energy levels of the m<sub>s</sub> = 1;2 sectors and found that the the residual splitting of the m<sub>s</sub> = 0;1; 1 com - ponents of the triplet level was as low as 10<sup>10</sup> a.u.

#### C. Dipole m om ent function

W e have calculated the one-particle density m atrix and the dipole moment for the various bond lengths. The dipole moment function is obtained as a smooth curve close to the Full-CI result. Note that especially the determ ination of the dipole m om ent curve in the vicinity of the avoided crossing proved very di cult in case of approximate methods of standard quantum chemistry. No special parameters are used in the DMRG calculation, ie., it may be used as a black box' method, whereas considerable skill is required to choose the appropriate CASSCF param eters necessary to obtain satisfactory orbitals for an MRCI treatment. The absolute error of the dipole moment function was 10  $^5$  at the equilibrium point and the largest error of the order of  $10^{-3}$  was found at R = 11.5 a.u. 0 ur results for the ground and excited states are shown in Fig. 5 and detailed in Table III.

## D. The stability of structure of the wavefunction

W ithin the framework of the conguration interaction method the number of Slater determ inants included in the treatment is increased systematically in order to achieve a better accuracy. Thus the wavefunction is in proved by adding in turn single, double and higher excitations. On the other hand, the coupled cluster procedure includes higher excitations in a di erent fashion, adding excitations of a very limited kind (namely the




FIG.6: The ground state dipole moment as a function of the bond length calculated for the dimension of TR  $E_{m\ ax}$  parameter.

unlinked clusters) at a very early stage of approxim ation. By contrast, DMRG takes into account excitations even of higher excitation classes at the very beginning, picking up the most important ones by minim izing the energy. This means that if the accuracy of the calculation is lowered, the structure of the wave function is retained in essence. To dem onstrate this, we have recalculated the ground state energies and the dipole m om ent with TRE  $_{\rm m~ax}$  = 10  $^6\,$  and found that the dipole m om ent function is still a continuous function even close to the avoided crossing. The relative error of the ground state energy was found to converge to  $10^{5}$  and the dipole m om ent to 10  $^4$  at R = 11.5 a.u. Repeating the same calculation by cutting the param eters drastically and using M  $_{\rm m \ in}$  = 32 and TRE  $_{\rm m \ ax}$  = 10  $^4$  , the dipole moment is still a continuous curve but it deviates more signi cantly from the FC I results especially close to the avoided crossing (Fig. 6). This simply means that some of the im portant components of the wave function are lost at the very beginning, which is of particular in portance at the avoided crossing.

#### IV. SUMMARY

We have studied the low-lying energy spectrum of LiF m olecule by the quantum chem istry version of DMRG in order to demonstrate the e ciency of the method in the vicinity of an avoided crossing. Besides calculating the ground and several excited states energies, we have obtained the dipole moment function as well. Several technical aspects of the QC-DMRG method were further studied. We have extended the application of the dynam ic block state approach and the study of optim al ordering con guration of molecular orbitals.

W e have found that reordering the molecular orbitals with the Cuthill-M cK ee algorithm applied on the  $\rm T_{ij}$  m a-

trix elements or the Fock matrix the same accuracy compared to an ordering based on the orbital energy can be achieved with a smaller minimum number of block states (M m in). The QC-DMRG procedure selects out a significantly smaller number of block states, M m ax, and the number of iteration steps is reduced. In addition, we have shown the e ciency and stability of the dynamic block state selection approach which in fact reduces the computational time signi cantly.

It turns out that the desired accuracy of the lowest states of each spin symmetry sector can be achieved for all bond lengths by targeting that particular state. On the other hand, calculating higher-lying levels close to the avoided crossing, coherent or incoherent superpositions of target states have to be constructed in order to provide stability and convergence. Since this has no signi cant e ect on calculations far away from the avoided crossing where the energy gap is large, this method can be used for the whole range of bond lengths.

The dipole moment calculated by DMRG can also be determined with good accuracy for all bond lengths and in fact it is a continuous curve even close to the avoided crossing. We have found that adjusting the desired accuracy of the calculation a ects the accuracy the dipole moment, but the dipole moment function remains a continuous curve. This dem onstrates the power of DM RG in quantum chem istry, since the structure of wavefunction does not change signi cantly for lower accuracy, namely the most important con gurations are picked up even with lower accuracy.

As far as the technical questions are considered, using reordered orbitals and the DBSS approach QC-DMRG calculation time was found to be within the order of magnitude of the FCI calculation if point-group symmetry is not used. Although the point group symmetry is not built in our present implementation of the DMRG method, the structure of the  $V_{ijkl}$  matrix rejects the symmetry, and the number of nonzero matrix elements is reduced signi cantly.
