## The P seudogap C hallenge: U nderstanding the ab P lane AC C onductivity below $T_c$

W e establish that the cuprate pseudogap plays a crucial role in the ab-plane optical conductivity (!;T) for tem peratures T T<sub>c</sub>. The pseudogap signatures in (!;T) associated with competing proposals of a hidden order" and \superconducting" origin for the  $d_{x^2 \ y^2}$  pseudogap are found to di er in their qualitative !;T dependences. For the latter case, as T increases from 0, excess low ! weight appears; m oreover, a much wider range of ! contributes to form the condensate. W e discuss these theories in light of current experiments.

W hile a major fraction of the cuprate phase diagram has been found to be associated with a pseudogap there is still no de nitive explanation for the origin of this anom alous phase. Here norm alstate therm odynam ic and transport properties exhibit an excitation gap of d-wave symmetry (with onset at temperature T) which appears to be continuous with the excitation gap of the superconducting phase (with onset at T<sub>c</sub> T). Theoretical schools for addressing this phenom enon fall roughly into two camps in which this pseudogap derives from (i.e., is \intrinsic") or is independent of (i.e., \extrinsic" to) the superconductivity. Despite its clear presence in therm odynam ical and transport data, mysteriously, experiments<sup>1</sup> on the in-plane electrodynamics show few conspicuous signatures of the pseudogap. In this paper we dem onstrate how, in both theoretical schools, the pseudogap enters as a rearrangem ent, relative to BCS predictions, of spectral weight in Re  $(!) = _1(!)$ . Moreover, we suggest that it is the width of the range of frequencies contributing to form the condensate which provides a most e ective criterion, both for descrim inating between theoretical approaches, and for direct com parison with the data. The experim ental observation<sup>2,3</sup> that (in the underdoped regim e), relatively high ! participate in the condensate poses a serious challenge for both strict. BCS theory and the extrinsic school.

Strict BCS theory is overly constrained because it contains a single energy scale. Nevertheless, we argue here that a mean eld theoretic approach is appropriate because of (1) the notable similarity of many (but not all) measured properties to their BCS predictions. (2) the very narrow critical regime, and (3) the large separation between T and T<sub>c</sub> (which appears to be too big to derive from uctuations around strict BCS theory). Moreover, the electrom agnetic response of the superconducting state can be readily form ulated at this generalized mean eld level. In the standard form ulation, the imaginary axis conductivity is written as  $_{ab}(Q) = \frac{e^2}{i(i!, n)} \mathbb{P}_{ab}(Q) \quad n_{ab}]$  where Q = (q = 0; i!, n). We de ne G reen's functions

Here  $_k$  refers to a generalized \band structure", which may dier from the bare hopping dispersion  $_k$  =

2t( $\cos k_x + \cos k_y$ ), whereas  $_k$  refers to a generalized \gap" parameter, whose k-dependence we separate as  $_k = \prime_k \text{ with } \prime_k = \cos(k_x) \cos(k_y)$  for d-wave pairing.

The quasiparticle velocity  $v_a = Q_{a,k}$  leads to

BCS theory predicts the response  $P_{ab}^{BCS}(Q) = 2 P_{Ab}(G_{A} + F_{A} + F_{A})$  (where  $G = G(K), G_{A} = G(K + Q)$ , and similarly for  $F_{A}$ ) so that the general expression for the super und density  $(n_{S})_{ab} = n_{ab} P_{ab}(0)$  reduces in the BCS case (om itting tensor indices) to

Since in BCS theory there is only one energy scale, one identi es as  $_{\rm sc}$  = , and n  $_{\rm s}$  vanishes only when the excitation gap vanishes. M ore correctly, it should be clear that the super uid density m ust necessarily re ect the superconducting order parameter  $_{\rm sc}$  which m ay be distinguished from the total excitation gap , so that  $n_{\rm s}(T) / (_{\rm sc}(T))^2$ . This serves to underline a major shortcom ing<sup>4</sup> of strict BCS theory.

The simplest mean eld pseudogap approach (case (i)) is referred to as \rescaled BCS theory "<sup>5</sup>. Here, the single energy scale fram ework of BCS theory sc = is preserved while modifying the response by a frequency-independent factor as  $P_{ab} = (T)P_{ab}^{BCS}$ . This enhancement causes  $n_s$  to vanish at  $T_c$  lower than T. The factor (T) is related to the suppression of the super-uid  $n_s = f(T)n_s^{BCS}$  by the sum rule constraint (T) =  $\frac{n}{n - n_s^{BCS}(T)}(1 - f(T)) + f(T)$ , with f(T) chosen to vanish at  $T_c$  and tted to  $n_s(T)$ . The microscopic physics of this otherw ise phenom enological scheme e is presum ably connected to the approach of Lee and W en<sup>6</sup>; may also re ect the renorm alization of electron charge as can occur

in Ferm i-liquid based approaches to the superconducting state  $^7$ . In overdoped samples with  $T_{\rm c}$  = T  $\,$  , BCS theory works well, i.e., f (T) = 1.

A lternatively, one may argue that  $_{\rm sc}$  6 , so that at the mean eld level, the gap and the order param eter are distinct. The extrinsic school introduces a pseudogap  $p_{pq}$  directly into the quasi-particle bandstructure kand defines  $_{sc}$  in the above mean eld form alism, yielding  $n_s$  /  $_{sc}^2$  via Eq. (4). Below  $T_c$ , Eq. (2) and de nes shows that in this school the dispersion of the ferm ionic quasi-particles has no simply de ned BCS-like excitation gap. However, in this paper (as elsewhere<sup>8</sup>) we will assum e that one can de ne a meaningful excitation gap for  $\frac{pg}{(k)^2 + (k)^2}$ . We im the extrinsic case as k plem ent this picture by introducing an additional order param eter which breaks translation symmetry, leading to  $\frac{p}{k} = \frac{2}{k} + \left(\frac{pg}{k}\right)^2$ . The precise super uid twobands <sub>k</sub> = density expression is slightly more complicated than Eq. (4) due to interband e ects.<sup>9</sup> W hile we calculate  $P_{ab}$  for a d-density wave<sup>10,11</sup> (DDW) here, we argue that our results are generic, applying to other extrinsic pseudogap theories.<sup>8,12</sup> The Green's functions F;G for the two bands are obtained from Eq. (1), (2) by replacing  $_k$ with k. For the d-density-wave/superconducting coexistent state, we nd

is the band index,  $v_a^{(1)} = Q_{a \ k}$ , and  $v_a^{(2)} = ({}_k Q_a {}_k^{pg} Q_{a \ k}) = {}_k$ .

Finally, we consider a third mean eld alternative (iii) in which the pseudogap is intrinsically connected with the superconductivity<sup>13</sup>. In this picture  $_{pg}$  is associated with a stronger-than-BCS attractive interaction, so that (nite momentum) pairs form at a higher temperature T than that at which they Bose condense ( $T_c$ ). Here the pseudogap enters on the same footing as the superconducting order parameter, and the fermionic dispersion is given by Eq. (2) with the value of  $_k$  assigned to be  $_k$ , and  $_k = _k$ . In this last approach, which has a detailed m icroscopic basis<sup>13</sup>, the super uid density has the form

The corresponding electrom agnetic response is the sum of ferm ionic (BCS, with full gap (T)) and bosonic contributions

Here we have approximated<sup>14</sup> the second bosonic term, which originates from an A slam zov-Larkin diagram s)<sup>15</sup>.

It represents the coupling of radiation to uncondensed pairs of charge-2e responsible for suppressing  $n_s$  relative to  $n_s^{B\,C\,S}$ . The pairs have a propagator  $t_{pg}(P)$ , which at small P can be parameterized as  $t_{pg}^{-1}(p;!) = !(1 + i)_{p}$  (after continuation to real frequency !.) Here  $_{p} = p^2 = 2M$  and the pair chemical potential is zero for T  $_{T_c}$ . W hile our microsopic theory  $^{16}$  yields the pairm assM and lifetim e parameter associated with , the diagram matic calculations can be avoided by borrowing from general TDGL form ulations  $^{17}$  which describe the hydrodynamics of non-condensed bosons. In particular, the optical sum rule constrains the conductivity spectral weight of this boson contribution to be  $n_s^{boson} = [\frac{2}{pg} = {}^2]n_s^{B\,C\,S}$ , determining the prefactor A.

In the intrinsic school the condensate ( $_{sc}$ ) grows with decreasing T at the expense of  $_{pg}$  as the fraction of (quasi-idealBose gas) nite momentum pair excitations decreases. Precisely at T = 0,  $_{pg}$  vanishes and the ground state is given by the BCS generalization rst proposed in Ref. 18. By contrast, in the extrinsic model  $_{pg}$  is relatively T independent below T<sub>c</sub> in the underdoped regime. One can summarize: to a good approximation, for the intrinsic model<sup>13</sup> (case (iii))  $_{pg}^{2}$  (T)  $_{c}^{2}$  (T<sub>c</sub>) (T=T<sub>c</sub>)<sup>3=2</sup>, whereas for the extrinsic model (case (iii)) at low doping  $_{pg}^{2}$  (T)  $_{pg}^{2}$  (T<sub>c</sub>).

The following calculations for  $_1(!)$  address an underdoped (UD) and a slightly over-doped (OD) cuprate with hole concentration x quanti ed by excitation gap ratio  $(T_c) = (0)$  which assumes the values 0.99 and 0.5 respectively. This corresponds roughly to x 0:06 and :17. The two quantities  $n_s(0) = (0)$  and  $T_c=T$  were Х computed within each microscopic theory and roughly t to experim ent. W e presum e that the tem perature dependence of the full excitation gap for T T<sub>c</sub> is given by the BCS d-wave result, so that (0)=T is a universal number, as seems to be the case experimentally  $1^{9}$ . W e include scattering from random non-magnetic im purities by renorm alizing F and G in the above form  $u \ln e_r^{20}$ and, for simplicity, compute the bosonic term in Eq(7)using standard TDGL results<sup>17</sup>. Following conventional  $procedures_{r}^{21}$  we pre-calculate a table of self-energies on the real frequency axis. We handle the complicated behavior of energy and k integrands using autom atic 1d or 2d adaptive quadrature, determining 1 to 1% relative accuracy. W hile we have explored both Born and unitary limits, the computations are more tractible in the unitary limit, which we consider here with scattering potentialu (r), u=2t! 1, and with 0.01 im purities per unit cell. Our num erical calculations (1) conserve the integrated density of states, (2) conserve conductivity spectral weight, and (3) yield<sup>22</sup>  $_1$  (T = 0; ! = 0) = (2= )2t= . Here and throughout we use conductance units  $e^2 = h = 1$ .

In the insets of F igures 1a and 2a are plotted the normalized super uid densities for the intrinsic (iii) and extrinsic cases (ii) in the underdoped regime. The strict \BCS" curves for each case are chosen to have the same excitation gap parameter, so that  $n_s^{BCS}$  vanishes at T .




FIG.1: Realpart of ac conductivity for the intrinsic (solid), rescaled BCS (dotted) and strict BCS (dashed) models at underdoped (UD) and slightly overdoped (OD) x at T = 0 (la, lc) and T =  $T_c$  (lb,ld). Insets plot the corresponding  $n_s$  compared to  $n_s^{BCS}$  (la) and the bosonic contribution to  $_1$  (lb).




FIG.2: \_1 (!) for the extrinsic psudogap at underdoped (UD) and slightly overdoped (OD) x at T = 0 (2a,2c) and T =  $T_c$  (2b,2d). The arrow indicates (0) pg ( $T_c$ )

It is clear from the above discussion that the calculated super uid density is depressed and vanishes at a lower temperature  $(T_c)$  than its BCS counterpart. Sum rule




FIG. 3: Partial integral of condensing spectral weight, norm alized by the total, for the three pseudogap m odels (underdoped).

considerations thus indicate that there must be excess spectralweight in  $_1(!;T)$  at !  $\in$  0 associated with pseudogap e ects.

The frequency distribution of this excess spectral weight can be inferred from the plots in Figures 1 and 2 which show 1 (!) for the UD and OD hole concentrations at T = 0 and  $T = T_c$  in the intrinsic (solid lines) and extrinsic cases respectively. In Figures 1a, and 1c the rescaled BCS model (dotted lines) coincides with the solid curves at T = 0 due to the complete condensation of the pseudogap. It is clear that in the intrinsic case the added pseudogap weight (present at any T  $\in$  0) appears at very low !, varying as<sup>17</sup> 1= $\frac{P}{!}$ , as well as at very high ! where it introduces a long tail associated with the ferm ion induced dam ping of non-condensed pairs. Interactions with the ferm ionic two particle continuum (which itself is gapped) constrains the bosonic lifetime. By contrast, in the extrinsic case the pseudogap is associated with a secondary maximum which appears at the energy scale pg (Tc) (0). This arises from interband e  $ects^{11}$  with threshold at ! = 2.

It should be noted that a direct comparison of  $_1 (!)$  between theory and experiment is complicated because the origin of the so-called mid-infrared spectral weight is uncertain<sup>23</sup>, and because the ratio of the T = 0 condensate to the total integrated spectral weight (at  $T_c$ ) is anomalously small (20% or less)<sup>23</sup>. Thus, we focus on the di erence curves, and their associated integrals. We introduce the partially integrated spectral weight N () =  $\frac{1}{2} \begin{bmatrix} 1 & (!;T_c) & 1 & (!;0) \end{bmatrix} d!$ , which is plotted in Figure 3 for the underdoped regime. This plot indicates which frequencies are required to account for the super uid density in both the extrinsic and intrinsic cases.

Strikingly, the intrinsic pseudogap and rescaled BCS theories both show substantial contributions to the condensate up to relatively high frequencies of order 4 (0) 960cm  $^1$  or more. By contrast, in the extrin-

sic school, the condensate derives from a much narrower range of frequencies. Since interband conductivity terms s make a negligible condensate contribution, this observation holds even for extrinsic theories which lack interband e ects<sup>8,12</sup>. An analogous narrowing of condensate frequencies occurs in strict BCS theory at low x when

(T) is properly chosen to be T independent, so that the only relevant energy scales are the much lower  $T_{\rm c}$  and scattering rate.

For T  $T_{\rm c}$ , inelastic scattering, which has been ignored in the above calculations, may a ect any direct comparison between theory and experiment. This leads to non-monotonic ! dependences and is expected to be most important in the optimal and over-doped regime, where inelastic e ects are strongly T dependent below  $T_{\rm c}$ , rejecting the T dependence of (T). It follows, similarly, that in the underdoped regime where (T) is constant, inelastic e ects should not contribute appreciably to N .

Finally, it can be noted that the only, nevertheless am biguous<sup>24</sup>, evidence for a pseudogap appears in the experimental literature<sup>1</sup> via D rude ts to (!), where the resulting 1= (!) is suppressed at frequency !<sub>o</sub> 600 cm<sup>1</sup>. Because of its x independence we speculate that !<sub>o</sub> m ay relect a phonon or other boson<sup>1</sup> with coupling modulated by the opening of an excitation gap. A lthough these secondary pseudogap elects are beyond the scope of this paper, we ind here that D rude its are quite generally problem atic for cases (ii) and (iii) discussed here.

In summary, in this paper (i) we have investigated competing proposals for the pseudogap origin and have presented theoretical (and rather generic) mean eld expressions for (!). (ii) Both major mean eld pseudogap schools lead to the prediction that pseudogap ef-

fects must enter as a rearrangem ent of excess spectral weight (relative to strict BCS theory predictions) in the ac conductivity. For the intrinsic school, there is a rapid growth in 1 with increasing low T, at xed low frequencies (which may have been observed experimentally $^{25}$ ), as well as long high ! tails, (possibly also observed<sup>2,3</sup>) which tails become more pronounced with increasing T. W hile for the extrinsic school, there is a transfer of spectralweight from low to high !. However, here the resulting secondary maximum is present at all T T and does not participate in the condensation. Direct com parison with experim ental data is made complex by the sm all integrated spectral weight in the condensate and our neglect of inelastic scattering<sup>23</sup>. Therefore, we have focused on the condensing portion of the spectral weight by considering the change in  $_1(!)$  from 0 to  $T_c$ . (iv) We nd that when (T) const, strict BCS theory cannot account for the relatively high ( 4 (0)) frequency scale associated with the condensate. The extrinsic approach su ers from a sim ilar problem. In an arti cialway rescaled BCS theory rem edies this weakness. However, the observed high frequency contributions arise naturally in an intrinsic model; their presence re ects the underlying scattering of non-condensed bosons from the two particle ferm ionic states.
