Strategies for High-Throughput, Tem plated Zeolite

A bstract

How best to design and redesign high-throughput experiments for zeolite synthesis is addressed. A model that relates materials function to chemical composition of the zeolite and the structure directing agent is introduced. Using this model, several M onte C arb-like design protocols are evaluated. Multi-round protocols are found to be elective, and strategies that use a priori information about the structure-directing libraries are found to be the best.

1 Introduction

Zeolites have found wide industrial applications in processes such as catalysis, molecular sieving, gas separation, and ion exchange. The signi cant catalytic activity and selectivity of zeolite materials are attributed to the large internal surface area and highly distributed active sites that are accessible through uniform ly-sized pores. However, due to the desire to in prove the quality of known zeolites that are sm all or faulted and the continuing quest for new zeolites with di erent functionalities, novel syntheses of zeolites with various fram eworks and chem ical compositions have drawn heavy research attention. To date, roughly 150 fram ework structures have been reported. New structures are added at the pace of roughly 6 per year. The use of organo-cation tem plate m olecules to provide structure direction has given rise to breakthroughs in zeolite science and provides much of the impetus for current synthetice orts [1,2]. The addition of organic tem plates such as am ines and alky lam monium ions to zeolite synthesis gels can a ect the rate at which a particular material is form ed and can make new structures or fram ework chem ical compositions accessible. In some cases, a strong correlation between the geom etry of the structure directing organic m olecule and the zeolite pore architecture is found. The nature and extent of interactions between the organic tem plates and the inorganic components of a zeolite synthesis gel are key param eters that determ ine the nal zeolite pore architecture [3, 4].

W e are interested in high-throughput synthesis of zeolites. High-throughput, or com binatorial, m ethods allow for simultaneous creation of a large number of structurally diverse and com plex com pounds, generalizing the traditional techniques of single com pound synthesis. M onte C arlo m ethods have been proposed and shown to be e cient m ethods for library design and re-design in both m aterial discovery [5, 6] and sm all m olecule design [7]. M aterial discovery deals with continuous variables, such as composition variables and noncomposition variables. Sm all molecule design deals with discrete variables, such as the identities of template and ligand. For templated zeolite synthesis, we have both the continuous zeolite composition and non-composition variables and the discrete identity variables of the component parts of the organic structure-directing molecules. All of these variables a ect the nal zeolite material in an interrelated way.

We here propose several strategies for tem plated, high-throughput zeolite synthesis. In section 2 we introduce a new random energy model that serves as a surrogate for experimental measurement of the gure of merit. This random energy model is based upon models used in material discovery and small molecule design. The random energy model is not fundamental to the protocols; it is introduced as a simple way to test, parameterize, and validate the various searching methods. In an experimental in plementation, the random energy model will be replaced by the value returned by the screen. In section 3, we introduce several protocols for experimentation. In section 4, we compare results of each protocol and discuss some implications. Finally, we conclude in section 5.

2 Random Energy M odel

To test proposed protocols in an e cient fashion, we need a model in lieu of the real experimental screening process. That is, we need a model that relates the chemical composition of the zeolite and structure directing agent to the function, or gure of merit, of the material. This model is not essential to the protocols. It is simply a fast and cheap means to test proposed protocols. This model will capture the essence of the physical system and provide validation for the protocols. R andom energy models have proven useful for the study of several complex elds, including protein folding [8, 9], protein molecular evolution [10], material discovery [5], and small molecule design [7].

To consider tem plate-assisted zeolite synthesis, we use a model that combines ideas from both material discovery [5] and small molecule design [7]. The value of the gure of merit is naturally a sum of a zeolite energy and a well-chosen organic molecular energy:

The zeolite fram ework composition variables x_i , d in number, are certainly key variables in E zeolite. The composition variables are specified by the mole fractions x_i , with 0 x_i 1, and $P_{i=1}^{p} x_i = 1$. Typical elemental compositions in zeolite fram eworks include silicon, oxygen, alum inum, phosphorus, boron, and germanium, among others. As discussed in the Appendix, the allowed compositions are constrained to lie within a simplex in d 1 dimensions. Several phases will exist for dimensions of the material. The gure of merit will be dramatically dimensions are grouped in the R andom Phase Volume M odel into phases centered around N x points x random ly placed within the allowed composition range. The phases form a Voronoi diagram, see Figure 1. The model is demed for any number of composition variables, and the number of phase points is demed by requiring the average spacing between phase points to be = 0.25. To avoid edge empositions. Moreover, within each phase , the gure of merit should also vary with x x due to crystallinity e ects such as crystallite size, intergrowths, defects, and faulting. Non-composition variables should also a ect the measured gure of merit. The non-composition variables are denoted by the b variables q. W ithout boss of generality, each variable ranges 1 z_i 1. How the gure of merit changes with the non-composition variables should depend on the value of the composition variables. The non-composition variables fall within N_z non-composition phases. There are a factor of 10 fewer non-composition phases than composition phases. W hen x is in composition phase and non-composition phase , the zeolite energy is given by

where fG g and fG g are phase-dependent random G aussian variables with zero m ean and unit variance. The fG g are di erent in each composition phase, and the fG g are di erent in each non-composition phase. The form of the function H is

The degree of the polynomial is chosen as q = 6. The set of coe cients fG g includes G₀ and G_{i₁ ..., i_n}. The constant symmetry factors $f_{i_1 ..., i_n}$, are given by

The scale factor $_{\rm H}$ is chosen so that each term in the multinom ial contributes roughly the same amount in the root-mean-square sense. For the composition variables $_{\rm H} = =2$, and for the non-composition variables $_{\rm H} = (hz^6 i=hz^2 i)^{1=4} = (3=7)^{1=4}$. The $_{\rm H}$ are chosen so that the multinom ial term s contribute 40% as much as the corresponding constant, phase term s, G₀ in eq 3, in the root-mean-square sense.

The organic structure-directing molecules are uniquely characterized by composition, such as the identity of the template and ligands, as shown in Figure 1. Note that template here denotes the fram ework of the structure-directing molecule, onto which ligands are attached, not the entire structure-directing molecule. For simplicity, we consider the small molecule to consist of one template and six binding ligands, each drawn from a fragment library. To quantitatively describe each template and ligand, six weakly correlated descriptors are used. Their num eric values specify the characteristics of each template or ligand.

We again use a random energy model for the molecules to account for the contributions to structure direction arising from interactions between the zeolite and template and from interactions between the zeolite and each of the ligands. In addition, synergistic e ects between the ligands and template are incorporated. Consider, for example, a molecule made from template number m from the template library and ligands number s_1 ;:::; s_6 from the ligand library. The template is characterized by six descriptors, $D_1^{(m)}$;:::; $D_6^{(m)}$. Sim ilarly, each ligand is characterized by six descriptors, $d_1^{(l_i)}$;:::; $d_6^{(l_i)}$. We denote the template contribution to binding by E_T and the ligand contributions by E_L . We denote the contribution due to synergistic ligand-ligand interactions by E_{LL} and the contribution due to synergistic template-ligand interactions by E_{TL} . The total molecular contribution to the gure of merit is, then,

Each of these terms is given in the form of a random polynom ial:

where individual descriptors from each template and ligand are given in corresponding libraries. The building block for our random energy model as a function of those descriptors is

The fG g, again, will be composed of a composition and a non-composition piece, as indicated in eqs 6{9. We use q = 6 and n = 6. Since the values of the descriptors, w_i , will be drawn from a G aussian random distribution of zero mean and unit variance, we set the scaling factor, F, by

In general the polynom ial coe cients, fGg in eq (6-9), are functions of both zeolite variables

x and z. However, for simplicity, we assume that the coe cients are phase-dependent only. Both types of zeolite phases have a signi cant in pact on the energy function. The variables $fG_Lg; fG_Lg; fG_Tg, fG_Tg; fG_{LL}g; fG_{LL}^{ij}g; fG_{LL}^{ij}g; fG_{TL}^{ij}g, and fG_{TL}^{ij}g are xed random G aussian variables with zero mean and unit variance. These coe cients are di erent in each phase. The structural constant <math>h_i$ indicates the strength of the interaction at structure directing site i. This interaction function depends on the zeolite variables x and z as

As before fG₁g and fG₁g are sets of phase-dependent xed random Gaussian variables with zero mean and unit variance. The parameter _H is adjusted so that the multinomial term s contribute roughly the same as the constant, phase term s on average. In E_{LL}, only synergistic interactions between neighboring ligands are considered, and it is understood that l_r refers to l_i in eq.8. In principle, the polynomial in eq.8 could be a function of all 12 descriptors of both ligands. We assume, however, that in portant contributions come from interactions among three random ly chosen distinct descriptors of ligand $l_{ir}d_{j_i}^{(l_i)};d_{j_s}^{(l_i)};$ and $d_{j_i}^{(l_i)};$ and another three random ly chosen distinct descriptors of ligand $l_{ir}d_{j_s}^{(l_i-1)};d_{j_s}^{(l_{i-1})};$ and $d_{j_b}^{(l_{i-1})}$. Sim ilarly, we assume that tem plate-ligand contributions come from interactions between three random ly chosen distinct descriptors of the ligand, $d_{k_1}^{(l_i)};d_{k_2}^{(l_i)};$ and $D_{k_3}^{(l_i)};$ and $D_{k_4}^{(l_i)}$; $D_{k_5}^{(l_i)};$ and $D_{k_6}^{(l_i)}$. Sim ilarly, we assume that tem plate-ligand contributions come from interactions between three random ly chosen distinct descriptors of the tem plate, $D_{k_4}^{(l_i)}; D_{k_5}^{(l_i)};$ and $D_{k_6}^{(l_i)}$. Both j_i and k_i are descriptor indices ranging from 1 to 6. We assume that these indices depend only on the tem plate, since the molecular details of the zeolite have been suppressed. The constants x_{ji} are adjusted so that the synergistic term s in compositional phases will contribute on average as $E_L : E_T : E_{LL} : E_{TL} = 1 : 1 : 2 : 12$. Furtherm ore, we adjust the _{x;i} so that the totalm olecular contribution from the interaction with the compositional variables accounts for roughly 15% of the constant, compositional phase term in E_{zeolite} in the root-m ean-square sense. We similarly adjust the values of _{z;i} in non-compositional phases so that the contribution from the interaction with the non-composition variables is also 15%.

Finally, we minim ize the energy returned by the model. That is, we sample the gure of merit, E, by exp (E).

3 Protocols for high-throughput experim entation

As in the small molecule case [7], we rst build the template and ligand libraries. We denote the size of the template library by $N_T = 15$ and the size of the ligand library by $N_L = 1000$. In a real experiment, the six descriptors would then be calculated for each template and ligand. In the simulated experiment, the values of the six descriptors of each ligand and template are extracted from a Gaussian random distribution with zero mean and unit variance. In the simulated experiment, we also associate two sets of random interaction descriptor indices to each template for the interaction terms in eq 8 and 9.

For comparison, we x the total number of samples to be synthesized at 100000 for all protocols. That is, we keep roughly the same experimental cost.

We consider several single pass protocols. Current high-throughput experiments uniform ly tend to perform a single-pass, grid search on all continuous variables. To minic current experiments, we use such a grid search on the composition and non-composition variables. For the discrete molecular variables, we instead random ly pick one template and six ligands from the corresponding libraries. In another single-pass protocol, which we call random, we search random ly over all variables, i.e. we choose the composition variables and non-composition variables at random as well.

We also consider several multi-pass protocols. Unlike single-pass protocols, multi-pass protocols allow us to learn about the system as the experiment proceeds. In analogy to M onte C arb m ethods, each round of combinatorial chemistry experiments corresponds to a move in a M onte C arb simulation. Instead of tracking one system with m any congurational degrees of freedom, however, m any samples are tracked. This results in a rather diverse population of samples and increases the opportunity for a few zeolite samples to survive m ore elaborate tests for application perform ance, tests that are only roughly correlated with the primary screen. The existence of these secondary and primary screens is the reason why sampling the gure of merit to nd several promising compounds is so in portant. We use a M onte C arb protocol so as to m aintain diversity in the samples. G enetic algorithm s, while powerful at local optimization, reduce the diversity of the population in the cross-over step and tend to fail diversity tests [7]. To be consistent with current experiments, we prefer to synthesize 1000 samples simultaneously and perform M onte C arb m oves on every sample for 100 rounds. The initial sample congurations are assigned by the random protocol.

We change the zeolite variables as well as the components of the structure directing agent at each round of the M onte C arlo protocol. In the sim plest approach, we perturb both the composition variables and the non-composition variables of the zeolite part around the original value using the traditional M etropolis-type m ethod. For the non-composition variables, z, periodic boundary conditions are used. For the composition variables, x, re ecting boundary conditions are used, as discussed in the Appendix. For the m olecular part, either

the tem plate is changed with probability p_{tem plate}, or one of the six ligands is picked random ly to change in each M onte C arlo m ove. The new con gurations are updated according to the acceptance rule at , the inverse of the protocol tem perature. All the sam ples are sequentially updated in one M onte C arlo round. For the m olecular part, either a sim ple M etropolis m ethod or a biased M onte C arlo m ethod can be incorporated. In the sim ple M etropolis m ethod, the new tem plate or ligand is selected at random with a uniform probability from the corresponding libraries. The nal acceptance rule for an unbiased protocol, which is applied after the zeolite and m olecular variables have been m odi ed, is

The biased M onte C arb schem es allow us to generate a trial con guration with a probability that depends on the potential energy of that con guration. These schem es have been proven to be highly successful in sm all m olecule high-throughput experiment design [7], where biased energy forms are constructed from either theory or pre-experiments. In the present case, since the total m olecular energy is a function of both the composition and non-composition variables, it is not feasible to construct the bias from pre-experiments. W e, therefore, use the theoretical bias directly from the random energy m odel. For a zeolite at compositional phase and non-compositional phase, the bias energy form for template m is

These biases tend to exhibit a large gap between a few dominant templates and ligands and the rest. To ensure the participation of more ligands and templates in the strategy, we introduce cuto energies for the ligand and template, $e_{\rm c}$ and $E_{\rm c}$. We choose $e_{\rm c}$ to be the 21st lowest ligand energy and $E_{\rm c}$ to be the 4th lowest template energy. With this cuto energy, the biased energy, $e_{\rm b}^{(i)}$, for the ith ligand becomes

In one M onte C arlo m ove, if the i^{th} ligand in the m olecule is to be changed at new zeolite values x^0 and z^0 , the biased probability for selecting another ligand l_1^0 from the ligand library is

Parallel tem pering is known to be a powerful tool for searching rugged energy landscapes [11, 12, 13]. Parallel tem pering can be combined with both M etropolis M onte C arlo and biased M onte C arlo. In parallel tem pering, the sam ples are divided into k groups. The rst group of sam ples is simulated at 1, the second group is at 2, and so on, with 1 < 2 < ::: < k. At the end of each round, sam ples in group i < k are allowed to exchange con gurations with sam ples in group i + 1 with probability p_x . The acceptance rule for a parallel tem pering exchange m ove is

where $=_{i}_{i+1}$ and E is the di erence in energy between the sample in group i and the sample in group i+ 1 before the exchange is made. It is important to notice that this exchange step is experimentally cost-free. Nonetheless, this step can be dramatically e ective at facilitating the protocol to escape from local minimum. The number of groups, the number of samples in each group, the value of $_{i}$, and the exchange probability, p_{ex} , are experimental parameters to be tuned.

4 Results and Discussion

The size of the library is xed at $N_T = 15$ and $N_L = 1000$. We adjust $_{x,i}$ and $_{z,i}$ so that the synergistic term swill contribute on average as $E_L : E_T : E_{LL} : E_{TL} = 1 : 1 : 2 : 12$ in the composition and non-composition phases. We also want a model in which the contribution from zeolite and molecule will be roughly of the same order for the optimal congurations obtained by grid or random protocols. Due to the complicated molecular term s, we not the parameters so that this occurs by trial and error. We not adjust all the $_{\rm H}$ values, then we adjust the $_{x,i}$ and $_{z,i}$ in eqs 6{9. As mentioned, we adjust the $_{x,i}$ and $_{z,i}$ so that the total molecular contribution from either type of phase accounts for roughly 15% of the corresponding constant phase term in $E_{zeolite}$.

To locate optim alparam eters for the protocols, we perform a few short pre-experim ents.

Since the size of the tem plate library is relatively small, the optim alvalue for the probability of changing a tem plate is $p_{tem plate} = 0.02$. The maximum random displacements are j x j= 0.1 = p d - 1 and j z j= 0.2 in the composition space and non-composition space, respectively. For simple M etropolis M onte C arlo, the optim al inverse protocol tem perature is = 50 for X 3 and X 4 and = 20 for X 5. For the biased M onte C arlo schemes, the optim al inverse protocol tem perature is $_{\rm b} = 500$ for X 3 and X 4 and $_{\rm b} = 200$ for X 5. For the biased M onte C arlo schemes, the optim al inverse protocol tem perature is $_{\rm b} = 500$ for X 3 and X 4 and $_{\rm b} = 200$ for X 5. For biased M onte C arlo combined with parallel tem pering, it is optimal to have the samples divided into three subsets, with 25% of the population at $_{1} = \frac{1}{2}$ b, 50% at $_{2} = _{\rm b}$, and 25% at $_{3} = 2$ b. The switching probability, $p_{\rm ex}$, is 0.1. D eterm ination of these parameter values corresponds experimentally to gaining familiarity with the protocol on a new system.

A llthe protocols are tested with increasing num bers of composition and non-composition variables. Results are shown in g 2. From this gure, one can see that all multi-round M onte C arb protocols are better than the single-pass protocols such as grid and random. The simple M etropolism ethod can ind optimum samples that are twice as superior as those from the grid or random protocols. M ost in portantly, the biased M onte C arb is especially e cient. The optimum sample energies from biased M onte C arb far exceed the optimum sample energies from simple M etropolism if even 1000 rounds. Biased M onte C arb is able to indirecting agent. Parallel tempering is noticeably e ective only for the more complicated X 4 and X 5 system s. For the relatively simple system s, such as X 3, it is more in portant to keep all 1000 of the samples at the optimum temperature.

5 Conclusion

We have presented a model for high-throughput zeolite synthesis. As in previous studies, multi-pass M onte C arlo m ethods work better than do single-pass protocols. Sophisticated biased M onte C arlo schem es are highly e cient and much better than simple M etropolis M onte C arlo. P arallel tem pering is the best m ethod for com plicated system s with 5 or m ore fram ework chem ical com positional variables.

Appendix: re ecting boundary conditions

The valid region of composition variables form a simplex, since they are non-negative and sum to unity. For those points near the corner of the allowed simplex, a high percentage of proposed m oves will go beyond the allowed region. If those m oves are simply rejected, the composition point will get stuck in the corner for a long time, and the limited sampling chances will be wasted. We want an algorithm that satis es detail balance while avoiding getting stuck in the corners.

The scheme we have chosen ensures that all moves from any point in the simplex lead

to new valid points in the simplex. The scheme basically involves many relections over the d 2 dimensional hyper-planes that de ne the boundaries of the simplex. Figure 3 shows how this works in the case of d = 3 for a single relection. We is not the unit normals, n_i , to each of the faces of the simplex. We also ind the constants q that de ne the faces by the equation $x = n_i$. In the case of gure 3, there are three such unit normals and three such constants. We initially de ne y = x (o). The algorithm consists of the following steps:

- 1. Test whether the proposed new point, x, is in the allowed region. If so, de ne the new point x (n) to be x and stop.
- 2. If not, nd the face i for which the quantity $t = (c_i \quad y \quad p_i) = [(x \quad y) \quad p_i]$ is minimal, taking into account only those faces for which both t_i and $(x \quad y) \quad p_i$ are positive.

3. De ney $y + \frac{1}{2}(x - y)$.

4. Re exist the point through this face by the equation $x = x = 2(x + n + c_i)n_i$.

5. Continue with step 1.

This algorithm converges, because it decreases the magnitude of x at each step, until x is within the allowed region. The algorithm is also reversible. That is, for each forward move x(0)! x that maps to the new position x(n), there is always a reverse move x(n)! x^{0} that maps to the original position x(0). Furthermore, when the original move is in the allowed move sphere, $j_{x}(0) = x_{j} < x$, the reverse move is as well, $j_{x}(n) = x^{0}j < x$. Given that we in pose the detailed balance condition, then, these rejecting boundary conditions provide a valid M onte C arb move from an old point in the allowed simplex to a new point in the allowed simplex.




These relecting boundary conditions can be interpreted in a geometrical way. Essentially, the relections perform a type of billiards in the d 1 dimensional simplex. In each attempted move, we chose a displacement x = x (o). We can interpret the composition variable as a small ball that moves at a constant speed along this trajectory. The motion is continued until either a boundary is encountered or the entire length of the trajectory has been traveled. If a boundary of the simplex is encountered, the ball relects on the hyper-plane by New tonian mechanics, and the trajectory continues along the new, relected direction. The motion, including possible additional relections, is continued until the ball has traveled a distance equal to the chosen length of the displacement, jx = x (o) j. The location of the ball at the end of the trajectory then gives the new point x (n). The reverse move is given by exactly the reverse motion, which has the same total displacement.




Figure 2: The minimum gure of merit found by di erent protocols with di erent number of composition (x) and non-composition (z) variables. The complexity of the structuredirecting agent libraries is the same in all cases. The results are scaled to the minimum found by the grid searching method. Each value is averaged over scaled results on 10 di erent instances.




Figure 3: Schematic of the re ecting boundary conditions used to obtain valid composition variables.
