## 0 rb ital-singlet pairing and order param eter sym m etry in $Sr_2RuO_4$

Based on the degeneracy of the  $d_{zx}$  and  $d_{yz}$  orbitals in  $Sr_2RuO_4$  it is argued that the Cooper pairs condense in orbital singlets. Together with the spin-triplet wave functions the real-space wave function then is symmetric. Considering interaction elects the order parameter is found to have  $A_{1g}$  symmetry consistent with a number of experimental observations. The sensitivity of the material on non-magnetic impurities follows in a straightforward manner from the orbital-singlet con guration.

W ith the discovery of the high tem perature superconductors a whole class of transition m etal oxides became a focal point in condensed m atter research. These m aterials exhibit m any unconventional properties whose interpretation has so far generally proved controversial. An example that attracted a lot of attention is  $\rm Sr_2RuO_4$ . Its normal state properties are Fermi liquid like in the temperature range  $\rm T_c < T < 30~K~[1,2]$  but below  $\rm T_c - 1.5~K~$  the material is an unconventional superconductor [3] since a number of experimental probes [4{6} show that the paired electrons carry a magnetic moment. In spite of the large interest that the superconductivity in  $\rm Sr_2RuO_4$  has attracted an unambiguous understanding of the electronic correlations has not yet evolved.

R ice and Sigrist [7] proposed that the superconducting order parameter has p-w ave sym metry promoted by ferrom agnetic correlations by analogy with  $^3\mathrm{H\,e.}$  This idea is supported by experiments that show that the static magnetic properties of  $\mathrm{Sr_2R\,uO_4}$  are the same in the normal and the superconducting phase [4,6]. However, there is no conclusive experimental proof [8{10] for the p-w ave sym metry of the superconducting order parameter and no indications of ferromagnetic correlations have been found either in neutron scattering investigations [11] or other approaches [12{14}.

Furtherm ore, the special cheat [15], nuclear quadrupole resonance (NQR) [2], and therm all conductivity [16] are consistent with two-dimensional gapless auctuations in the superconducting phase of  $Sr_2RuO_4$ , which are incompatible with the analogy to super uid He. One possible scenario is the existence of line nodes similar to those in the superconducting cuprates [17]. Since vertical line nodes have been ruled out by therm all conductivity measurements [9,10] horizontal line nodes in the subsystem of the  $d_{zx}$  and  $d_{yz}$  electrons have been proposed [18]. One weakness of the latter picture is that it requires the netuning of various interaction strengths [19], while no

double gap structures have been observed in Andreev reection spectroscopy data [8].

In this letter it is shown how the degeneracy of the Ru $^{4+}$  d<sub>zx</sub> and d<sub>yz</sub> orbitals allows for a straightforward description of the unconventional superconductivity in Sr<sub>2</sub>RuO $_4$  that is consistent with the experimental observations. The possibility of mixed orbital pairing leading to S = 1 spin-triplet Cooper pairs through Hund's rule coupling has been raised in plicitly by Baskaran [20]. The \active" d<sub>zx</sub> and d<sub>yz</sub> orbitals drive the superconducting instability because they have the larger inter-plane electronic overlap [21]. This is supported by the recently in plied increase of T<sub>c</sub> upon uniaxial pressure [22] along the crystallographic c axis since the inter-plane coupling is increased. Such pairing is um klapp scattering enhanced by the body centered tetragonal lattice [23].

The results of the approach can be sum marized as follows. The Cooper pairs form orbital singlets allowing for an even parity real-space wavefunction in spite of the spin-triplet con guration. Taking into account the relatively strong interaction e ects in the system [3] this allows for an almost homogeneous gap function, consistent with the experim ental observations [8{10,24]. Any im purity or defect [25,26] locally breaks the sym m etry of the  $d_{zx}$  and  $d_{yz}$  orbitals and thus acts as a pair breaker in strict analogy to magnetic impurities in a spin-singlet superconductor [27]. The quadratic tem perature dependence of the speci c heat [15] follows from of the internal degrees of freedom of the order param eter [23]. On the other hand, the pair correlations for the  $d_{x\,y}$  electrons are induced by the interband proxim ity effect. Since this e ect is usually strong [18] a single gap is assum ed leading to consistency with Andreev re ection experim ents [8].

In the subspace of the degenerate  $d_{zx}$  and  $d_{yz}$  orbitals the possible order parameters can be classied in standard notation [28] as orbital-singlet spin-triplet components

and orbital-triplet spin-singlet components

Here = x;y;z labels the triplet components, are Paulim atrices, and  $c_n^{\gamma}$ ; are the usual electron creation operators on site n in orbital  $d_{zx}$  ( = x) or  $d_{yz}$  ( = y) with spin .




FIG. 1. Product of the angular components  $d_{zx}$  (r=r) $d_{yz}$  (r=r) =  $d_{zx}$  (k=k) $d_{yz}$  (k=k) in the real or Fourier space projection of the pair wave function Eq. (3).

In the presence of Hund's rule coupling the spintriplet states are energetically favored over the spin-singlet states and thus form the ground state of the Cooper pair condensate. Possible e ects from spin-orbit coupling 0:1 eV [29] are over-compensated by the larger Hund's rule coupling  $J_{\rm H}$  0:2 0:4 eV [30] since  $< J_{\rm H}$  [23].

Following Eq. (1) the condensate wavefunction j  ${}^s$  i =  $P_t^s$ ,  ${}^y$ Di can be factorized into spatial, spin-triplet, and orbital-singlet (jx;yis) contributions. Since the orbital singlet is odd and the spin triplet is even under electron exchange the real space projection of the wave function has to be even. This requirement is satisfied for electrons in the  $d_{zx}$  and  $d_{yz}$  orbitals, for which the total wavefunction is [31]:

R  $_n$  are the real-space coordinates of the n  $^{\rm th}$  Ru ion, r are the coordinates relative to R  $_n$ . The product of the angular components  $d_{zx}$  (r=r) $d_{yz}$  (r=r) has even parity as shown in Fig. 1.

The most striking evidence for orbital-singlet pairing in Sr<sub>2</sub>RuO<sub>4</sub> is the sensitivity of the superconductivity to im purities [25] and crystal defects [26], which can be understood by analogy to the e ect of magnetic impurities in a spin-singlet superconductor. In the latter the magnetic impurities locally break spin-rotational invariance and thus act as pair breakers for spin-singlet Cooperpairs [27]. Sim ilarly, any impurity magnetic, non-magnetic, or crystal defect | locally breaks the rotational sym m etry of the lattice and thus the symmetry between the  $d_{zx}$  and  $d_{vz}$  orbitals. Consequently impurities are pair breaking in the orbital-singlet superconductor described by Eq. (3) in strict analogy to magnetic impurities in a spin-singlet superconductor. The resulting quantitative applicability of the theory of Abrikosov and Gor'kov to Sr<sub>2</sub>RuO<sub>4</sub> is in pressively demonstrated in Refs. [25,26].

As a next step it is necessary to study the superconducting gap function in order to interpret the numerous directionally dependent experimental probes. The gap function  $_{k}$  = ( $_{k,x}$ ;  $_{k,y}$ ;  $_{k,z}$ ) is given in the Fourier

self-consistently.  $V_{0,2}$  is the electrive pairing potential. The action  $S_{SG}\left[ \begin{array}{c} i \end{array} \right]$  has been derived using the quasionedim ensionality of the kinetic energy of the  $d_{zx}$  and  $d_{yz}$  electrons and includes the intermediate coupling on-site interaction non-perturbatively [32]. It depends on the four Bose elds, which can be considered as charge, avor, spin and spin-avor elds in analogy to the two-channel K ondo problem [33], and includes mass generating terms in the superconducting state [23]. The treatment of such a four-component, two-dimensional sine-G ordon action is quite involved and is only possible using approximations.

However, to investigate the gap function in  $\rm Sr_2RuO_4$  it is su cient to apply qualitative physical arguments. Starting with the investigation of the wavefunction symmetry within the non-interacting, local picture and then analysing the expected in the uniteractions it turns out that a rather homogenous gap function must be expected.

To establish the wavefunction sym m etry in m om entum space it is useful to write [34]

so that the angular com ponents in real and Fourier space factorize.  $F_1(kr)$  is a regular spherical B essel function and does not depend on the magnetization quantum number m. Since the  $d_{zx}$  and  $d_{yz}$  orbitals are linear combinations of the orthogonal spherical harmonics  $Y_{2-1}$  the angular part of the pair wavefunction projection onto Fourier space,  $k_j$  i, has the same symmetry as in real space, i.e.,  $d_{zx}(r=r)d_{yz}(r=r) = d_{zx}(k=k)d_{yz}(k=k)$  [Fig. 1]. Introducing the rotation operator  $R_{=2}$ :  $k_x$ !  $k_y$ ;  $k_y$ !  $k_x$  one has

In other words the wavefunction is even under a rotation of 90 since both angular and orbital-singlet contributions are odd under that rotation. We therefore expect the gap function to be of extended s-wave symmetry.




FIG. 2. Representation of the Ferm i surfaces formed by the  $d_{z\,x}$  and  $d_{y\,z}$  bands [36]. Dashed lines: idealized one-dimensional band. Full lines: hybridized bands. Dots: points at the Ferm i surface where electrons can pair with opposite momentum. Small black dots: idealized 1D, larger dots: hybridized.

In a group theoretical context the six possible pairing states described by the pair operators in Eqs. (1) and (2) nd their analogies in the possible pairing states of the tetragonal point group D  $_{4h}$  [35]. Since the angular Fourier space part  $d_{zx}$  (k=k) $d_{yz}$  (k=k) has even parity and the pair wavefunction is invariant under rotation of 90 the state with either A  $_{1g}$  or A  $_{2g}$  symmetry must be realized. It is usefull to dene the mirror operators M  $_{x}$ : y! y and M  $_{y}$ : x! x as well as M  $_{p\overline{x}}$ :  $\overline{y}$ !  $\overline{y}$  and  $pM_{-\overline{y}}$ :  $\overline{x}$ ! x with  $\overline{x}$  = (x + y)= 2 and  $\overline{y}$  = (x y)= 2. Note that  $\overline{x}$  and  $\overline{y}$  dene a reference frame rotated by =4. Applying these to  $d_{zx}$  (k=k) $d_{yz}$  (k=k) and jx; yis reveals the A  $_{2g}$  symmetry of hkj  $^{s}$  i.

However, in the real system the symmetry of the gap function will be signi cantly altered by hybridization and more importantly interaction e ects. Starting out by considering the non-interacting case the orbitalsinglet superconducting instability can be form ulated following BCS [23] and electrons with opposite momentum can only pair at the four points (small black dots in Fig. 2) of the Brillouin zone where the idealized, one $dim ensionalFerm isurfaces [36] of the <math>d_{zx}$  and  $d_{vz}$  bands cross (dashed lines in Fig. 2). In a more realistic picture the  $d_{zx}$  and  $d_{vz}$  bands are weakly hybridized [36,32] and form the and sheets of the Fermi surface (full lines in Fig. 2). It can be shown that then only the eight points on the and sheets indicated by the larger dots in Fig. 2 contribute to the pair form ation. Such a small phase space for the pairing is consistent with the  $A_{2q}$  sym metry discussed above but would be inconsistent with the large speci cheat anomaly at the superconducting phase transition [15].

That the neglect of the interaction clearly represents an unjusti ed oversimpli cation of Eq. (5) becomes obvious from the signi cance of the on-site interactions [32] for the observed [11,37] strong magnetic in-plane correlations. An estimate of how the interactions increase the pairing phase space is possible by noting that the dom-




FIG. 3. Representation of the idealized one-dimensional Ferm isurfaces formed by the  $d_{zx}$  and  $d_{yz}$  bands [36] (dashed lines). (a) M agnetic momentum transfer  $(2k_{\rm F}\,;2k_{\rm F}\,)$  and three combinations with reciprocal lattice vectors. (b) and (c) show the resulting momentum transfer (double arrows) that allows for mixed orbital pairing on many points of the Fermi surfaces. The corresponding momenta of the electrons forming a pair are illustrated by the black arrows starting from the zone center in panel (b). (d) shows the momentum transfer for  $(4k_{\rm F}\,;4k_{\rm F}\,)$ .

inant m agnetic correlations can be described as gapless, quasi one-dimensional uctuations at momentum transfer  $q_i = (2k_F; 2k_F)$  modulus a reciprocal lattice vector [32]. The arrows in Fig. 3(a) show the momentum transfer of  $q_1 = (2k_F; 2k_F)$  and three combinations with reciprocal lattice vectors  $G_0 = (0; 2)$ ,  $G_1 = (2; 2)$ , and  $G_2 = (2; 0)$  in units of the reciprocal lattice spacing 1=a.

The back-scattering term s in the action of Eq. (5) couple magnetic and charge degrees of freedom [32]. The Cooper pairs can thus scatter elastically on the gapless magnetic excitations modulus any reciprocal lattice vector  $G_i$ , i.e.,  $hc_{k,\gamma}$ ,  $\circ Q_{k-q_i-G_j,\gamma_k}$ ,  $i \in 0$  as indicated by the black arrows in Fig. 3(b). The resulting momentum transfer allows for mixed orbital pairing on many points of the Fermi surfaces formed by the idealized one-dimensional  $d_{zx}$  and  $d_{yz}$  bands as indicated in Fig. 3(b) and (c). Including also higher order contributions allows for an even more homogeneous distribution of paired electrons across the Fermi surfaces as indicated for ( $4k_F$ ;  $4k_F$ ) in Fig 3(d).

This qualitative discussion shows that interactions can be held accountable for a rather hom ogeneous gap function in  $\mathrm{Sr_2RuO_4}$ . M oreover, the action  $\mathrm{S}_{\mathrm{SG}}$  [  $_{\mathrm{i}}$ ] in Eq. (5) as a function of the charge, avor, spin, and spin—avor Bose elds is manifestly invariant under the mirror operations M [32]. The action including the interaction thus points towards a A  $_{\mathrm{1g}}$  symmetry of the gap function.

This results from the fact that the charge, avor, spin, and spin-avor elds are linear combinations of the elds of the  $d_{zx}$  and  $d_{yz}$  orbitals. The  $A_{1g}$  sym metry is consistent with thermal conductivity measurements [9,10] as well as with the geometry of the upper critical elds [24]. Point contact experiments also do not reveal any significant in-plane anisotropy of the superconducting order parameter [8,38].

Finally, from the back-scattering terms in the action  $S_{SG}$  [  $_{i}$ ] the existence of two degenerate superconducting saddle points leading to two degenerate order parameter components can be deduced [23]. Each component has a two-fold symmetry axis. Indeed, the existence of such two order parameter components with a slight spatial anisotropy in  $Sr_{2}RuO$  is implied by the existence of two upper critical elds [24,39]. Comparison with the critical eld measurements suggests [40] that the components are 93% isotropic. The two components are classified as avor components  $_{fx}$  and  $_{fy}$  [23].

Since  $_{f;x}$  and  $_{f;y}$  are degenerate in the absence of elds breaking the  $\frac{1}{2}$ -rotational symmetry the system can uctuate between the two components in the ordered phase giving rise to a Goldstone mode [41]. This mode accounts for [23] the gapless quasitwo-dimensional excitations observed in the superconducting phase in various experiments [2,15,16]. The presence of such a mode in the superconducting state nds support in the softening of the in-plane elastic constants recently observed in ultrasonic measurements [22].

In sum m ary the notion of spin-triplet, orbital-singlet pairing in  $Sr_2RuO_4$  leads to a straightforward physical picture that is consistent with fundam ental experimental observations such as the sensivity to impurities, the symmetry of the two upper critical elds and the uctuations in the ordered phase. Unlike previous theories predicting pwave symmetry the two-component order parameter can be considered as an extended swave with  $A_{1g}$  symmetry and only slight anisotropy. The interactions play a crucial role in the in-plane correlations. Details of the non-perturbative approach and comparisons to experiments as well as the p-wave approach [35] are given in Refs. [32,23,40].
