In-plane dipole coupling anisotropy of a square ferrom agnetic H eisenberg m onolayer

In this study we calculate the dipole-coupling-induced quartic in-plane anisotropy of a square ferrom agnetic H eisenberg m onolayer. This anisotropy increases with an increasing temperature, reaching its maximum value close to the C urie temperature of the system. At T = 0 the system is isotropic, besides a sm all remaining anisotropy due to the zero-point motion of quantum m echanical spins. The reason for the dipole-coupling-induced anisotropy is the disturbance of the square spin lattice due to therm al uctuations ('order-by-disorder' e ect). For usual ferrom agnets its strength is sm all as compared to other anisotropic contributions, and decreases by application of an external m agnetic eld. The results are obtained from a H eisenberg H am iltonian by application of a m ean eld approach for a spin cluster, as well as from a many-body G reen's function theory within the T yablikov-decoupling (R PA).

I. IN TRODUCTION

The investigation of the magnetic properties of ferrom agnetic ultrathin lm s is a eld of intense current interest¹. In this contribution we determ ine the magnetic in-plane anisotropy of a square two-dimensional (2D) Heisenberg ferrom agnet in presence of the magnetic dipole interaction. In 2D m agnets the action of m agnetic anisotropies is twofold. First, they induce a long range m agnetization^{2,3,4} with a Curie tem perature of the order of the exchange coupling⁵, whereas a strictly isotropic 2D Heisenberg magnet does not exhibit any long range magnetic order at nite tem peratures (Mermin-Wagnertheorem)⁶. Moreover, the long range character of the dipole interaction itself is su cient to stabilize the magnetization in a 2D m agnet. Secondly, the anisotropies determ ine the easy and hard axes of the magnetization with respect to the lattice fram e¹. For a ferrom agnetic thin Im the dipole coupling prefers an in-plane direction of the magnetization (shape an isotropy, demagnetizing eld). Except for very small thicknesses thin lm s are usually in-plane magnetized. The corresponding in-plane

easy axis depends on the lattice symmetry of the lm face. For a rectangular (110) monolayer the dipole interaction induces a uniaxial in-plane anisotropy, the easy axis being the in-plane axial direction with the sm aller lattice constant, as can easily be shown by calculating the corresponding lattice sum s.

On the other hand, for a square monolayer the dipole coupling, although itself not rotational invariant, exhibits a continuous energy degeneracy for classical spins at T = 0. Thus, due to the M em in-W agner theorem a long range magnetic order is not expected at nite tem – peratures. However, as has been shown by M onte C arlo calculations and interacting spin wave theory, a magnetic ordering and a critical tem perature exists for dipole coupled spins on a square lattice⁷, since the magnetic excitations are not continuously degenerate. In this case a quartic in-plane anisotropy is present, the corresponding easy axes being the edges of the square lattice. In other words, the density of states and thus the entropy depends on the magnetic direction within the lattice. This phenom enon is an example of the 'order-by-disorder' e ect in frustrated magnets⁸. In these systems thermal uctuations or lattice disturbances partly remove frustrations, and a collective magnetic ordering emerges at nite temperatures.

W hereas the existence of a nite magnetization and a quartic anisotropy at nite temperatures for dipole coupled spins on a square lattice has been proven, the strength and the tem perature behavior of this an isotropy has not been determined yet. Of particular interest is whether the dipole-coupling-induced quartic anisotropy can be measured, and how this anisotropy compares with the single-ion quartic lattice an isotropy due to the spinorbit coupling. In this study we will adress these questions with the help of a mean eld approximation, taking into account a square spin cluster with di erent num bers of spins (O guchi-theory)^{9,10}, as outlined in Sec.II. Furthermore, we apply a many-body G reen's function theory within the Tyablikov-decoupling (RPA) by considering collective magnetic excitations (spin waves) and interactions between them ^{11,12}, which are in particular in portant for 2D m agnetic system s. O ur results are sum marized and discussed in Sec.III.

II. THEORY

The free energy F(T;) is determined within a H eisenberg-type H am iltonian as a function of the tem – perature T and the in-plane angle . A square (001) ferrom agnetic m onolayer is considered, which is spanned by the xz-plane, the z-direction refers to = 0. The isotropic nearest neighbor H eisenberg exchange coupling J, the m agnetic dipole-dipole interaction, and an external m agnetic eld B between localized H eisenberg spins

with g the Lande factor and $_B$ the B ohrm agneton. The spin quantum number is assumed to be S = 1=2. The lattice vector between sites i and j is given by r_{ij} , with $r_{ij} = jr_{ij}j$ the distance. All spins are assumed to be aligned parallely (ferrom agnetic order), the m agnetization m $_i(T) = m(T) = (0;0;m(T))$ is directed along the m agnetic eld B = (0;0;B).

To account for a varying angle of the magnetization with respect to the lattice frame, the lattice is rotated by the in-plane angle with respect to the z-axis, yielding the rotated lattice vectors:

C learly, the only source in Eq.(1) for a possible in-plane anisotropy is the double scalar product of the dipole interaction. W ithin the single-spin (Bragg-W illiam s-) mean eld approximation¹⁰ the dipole coupling yields an additional contribution to the molecular eld. The resulting single-spin H am iltonian reads

with q = 4 the number of nearest neighbors (coordination number), w = (g $_{\rm B}$)²=a_0^3 the strength of the dipole interaction, a_o the lattice constant, S (0;0) 4:51681 the corresponding lattice sum 13 , and m (T) = hS_1^{\, z} i the m agnetization. O ur approach will now be improved by applying the so-called O guchim ethod^{9,10}. A number N > 1 of neighboring spins is considered, the interactions between the N spins in this cluster are treated exactly. The remaining lattice is coupled to the spin cluster by a molecular

ekl. To conserve the sym metry of the square lattice, we take into account only square-shaped spin clusters, the three smallest possible clusters are characterized by N = 4; 9, and 16. Note that the resulting cluster H am iltonians H ^(N) are usually non-diagonal, i.e. contributions proportional to the S^x-and S^y-spin components may be present. Therefore, as a further approximation we consider only the diagonal elements. This approach guarantees that the magnetization is directed along the external magnetic eld. As an example, the Ham iltonian for the four-spin cluster (N = 4) reads:

with $= 1=k_B T$ and k_B the Boltzm ann constant. The

corresponding expressions for the other investigated sizes are rather lengthy and not shown here. The di erence of the free energy F (T;B;) = $k_B T \ln Z$ (T;B;) between the diagonal (= =4) and the axial directions (= 0) yields the in-plane anisotropy K_{4,dip} (T;B), which will be calculated as a function of the temperature T and the externalm agnetic eld B.

It is important to mention that the mean eld theory as described in the preceeding subsection does not ful ll the M emmin-W agner-theorem for the isotropic 2D H eisenberg m agnet. In this case the long range m agnetic order becom es unstable against collective m agnetic excitations with long wavelengths^{2,3,5}. Thus, the consideration of these spin waves is very important for the magnetic behavior of a ferrom agnetic m on olayer. For the determ ination of the dipole-coupling-induced in-plane anisotropy we apply in addition a many-body G reen's function theory to the H am iltonian Eq.(1), after the lattice is rotated by the in-plane angle , Eq.(2). We consider the G reen's functions $G_{ij} = hhS_i; S_j ii,$ = +;;;z, which aresolved within the Tyablikov-decoupling¹¹. Since interactions between spin waves are partly taken into account, the magnetic properties can be determined up to the Curie tem perature by this method. The respective formalism is described in detail in^4 , thus we outline merely necessary extensions in the Appendix. The magnetization m (T;B;), the internal energy E (T;B;), and the free energy F (T;B;) are calculated. For comparison, we determ ine the corresponding quantities also by considering the Holstein-Primako approximation¹⁴, which is valid at low tem peratures.

III. RESULTS AND DISCUSSION

By application of the described methods we calculate the e ective dipole-coupling-induced in-plane m agnetic anisotropy K_{4;dip} (T;B) for a square ferrom agnetic monolayer as a function of the temperature T and the applied magnetic eld B. A nite value indicates that this anisotropy is caused by the magnetic dipole coupling, since other sources of magnetic anisotropies are not present in the Ham iltonian Eq.(1). For the strength of the dipole interaction we choose $(g_B)^2 = a_0^3 = w = 0.01 \text{ J}$, which is appropriate for 3dtransition m etal ferrom agnets. K_{4;dip} (T;B) is given in units of the energy di erence between the perpendicular and the in-plane magnetization (demagnetizing energy) $E_{dem aq}(0) = (3=2) \le (0;0) \le (0)$ 2 w S² for a ferromagnetic monolayer at T = 0.




FIG.1: E ective dipole-coupling-induced quartic in-plane m agnetic anisotropy $K_{4;dip}$ (T;B) for a square m onolayer as a function of the temperature T, calculated within the O guchi mean eld method for spin cluster sizes N = 4; 9; 16. Two di erent magnetic eld strengths B are considered (g $_{\rm B}$ B = E $_{\rm dem \ ag}$ (0) = 0; 1:5). The eld energy and $K_{4;dip}$ (T;B) are given in units of the dem agnetizing energy E $_{\rm dem \ ag}$ (0). The dot-dashed line show s K $_{4;dip}$ (T;B) for B = 0 and N = 4 by considering non-diagonal matrix elements of the H am iltonian, cf. Sec.II. For com parison, also the e ective single-ion quartic anisotropy K $_{4;so}$ (T) resulting from the spin-orbit interaction is show n, calculated within a therm odynamic perturbation theory by assuming K $_{4;so}$ (0) = 0:01E $_{\rm dem \ ag}$ (0) (dotted line).

The free energy F (T;) exhibits a four-fold sym m etry as a function of the in-plane angle . The easy magnetic axes are directed along the edges (=0;=2,etc.), and the hard axes along the diagonals (= =4;3=4,etc.) of the square lattice as obtained in⁷. The quartic anisotropy K_{4;dip} (T;B) is depicted in Fig.1 as a function of the tem perature, calculated by the O guchi approach. Three di erent sizes of the spin cluster are considered (N = 4; 9; 16), as well as di erent m agnetic eld strengths B . The Curie temperature $T_{\rm C}$ (N) decreases with an increasing N, since additional spin correlations are considered. As can be seen, $K_{4;dip}$ (T;B) increases with an increasing tem perature, reaching a maximum at T_c. This tem perature behavior is in striking contrast to the corresponding behavior of other anisotropic contributions. U sually the e ective anisotropies decrease with an increasing tem perature, and vanish at $T_{\rm C}$ for B = 0. $K_{4;dip}$ (T;B) exhibits a cusp at T_C and decreases for tem peratures $T > T_C$. By increasing the size N of the spin cluster, K_{4;dip} (T;B) becom es larger. An application of a magnetic eld reduces K 4;dip (T; B), and the cusp near

 $T_{\rm C}$ changes to a maximum. For comparison, in Fig.1 we show $K_{4;{\rm dip}}(T;B)$ for B=0 and N=4 by considering also non-diagonal elements in the cluster H am iltonian H $^{(4)}$, cf. Sec.II. A decrease of $T_{\rm C}$ and an increase of $K_{4;{\rm dip}}(T;B)$ by 10% is obtained with respect to the calculations which consider diagonal elements only.




FIG. 2: M agnetization m (T;B) (a) and e ective quartic in-plane m agnetic anisotropy K $_{4;\rm dip}$ (T;B) (b) for a square m onolayer as functions of the temperature T and the m agnetic eld B, calculated by application of the G reen's function m ethod within the Tyablikov-decoupling (RPA). The Curie temperature is calculated to be $k_{\rm B} \, T_{\rm C}^{\rm R\,P\,A} = 0.373 \, J$. The eld energy and K $_{4;\rm dip}$ (T;B) are given in units of the dem agnetizing energy E $_{\rm dem \, ag}$ (0). In addition, the results as obtained from the H olstein-P rim ako approximation (HP) for B = 0 are depicted (dashed lines). For com parison, the dotted line shows the e ective single-ion quartic anisotropy K $_{4;\rm so}$ (T), with K $_{4;\rm so}$ (0) = 0:01E dem ag (0).

In addition, we have calculated $K_{\,4;\text{dip}}\left(T\,;B\,\right)$ by application of the many-body G reen's function theory as outlined in⁴ and in the Appendix. For w = 0.01 Jthe Curie temperature is calculated to be $k_B T_C^{RPA}$ = 0:373 J. In Fig 2 (a,b) we present the resulting m agnetization m (T;B) and anisotropy K $_{4;dip}$ (T;B) as functions of the temperature and the magnetic eld. In accordance with the results obtained from the O guchi approach, K_{4;dip} (T;B) increases with an increasing temperature. Due to the consideration of quantum mechanical spins a nite value of K_{4;dip} (T;B) is already present at T = 0, resulting from the zero-point spin motion (quantum uctuations). Note that the presence of the dipole coupling causes a non-saturated magnetization m (T = 0) < S = $1=2^{3,14}$. In Fig 2 also the results as obtained from the Holstein-Primako approximation are shown, which neglects interactions between spin waves. The corresponding magnetization m (T;B) and an isotropy K_{4;dip} (T;B) at low tem peratures are close to the results as obtained from the RPA. At elevated tem peratures T & T_c = 3 the Holstein-Primako approxima-

tion is no longer valid.

As has already been obtained from M onte Carlo calculations and interacting spin wave theory', the dipolecoupling-induced in-plane anisotropy is caused by magnetic uctuations. This order-by-disorder e ect is thus controlled by the magnetic entropy of the system 8 . An energetic in uence should become apparent at T = 0 already within a mean eld approximation. Besides the e ects resulting from the zero-point motion, the terms of the dipole interaction dependent on the in-plane anale cancel for a strictly square magnetic lattice, i.e. for a fully saturated ferrom agnetic state. At nite tem peratures therm al uctuations disturb this square periodicity, causing an e ective quartic in-plane magnetic anisotropy, which re ects the underlying spatial lattice symmetry. The single-spinmean eld theory conserves the periodicity of the square magnetic lattice, since all other spin operators are replaced by uniform expectation values. Thus, within this approximation one obtains $K_{4;dip}$ (T; B) = 0 for all tem peratures. On the other hand, within the O quchi approach the interactions between a num ber of spins are treated exactly, considering a few collective m agnetic excitations with short wavelengths ranging over several lattice constants, and resulting in a nite value for K_{4;dip} (T; B) for T > 0. The many-body G reen's

function theory takes into account spin waves with all possible wavelengths. Since $K_{4;dip}$ (T;B) is maximal at elevated temperatures, $K_{4;dip}$ (T;B) is caused by magnetic uctuations in particular with short wavelengths, which become excited in this temperature range.

W ithin the O guchi approach we calculate a maxim um value ofK 4;dip (T;B) of the order of 0.1% of the dem agnetizing energy $E_{dem aq}$ (0). On the other hand, $K_{4;dip}$ (T;B) as calculated from the Green's function method is m ore than a magnitude larger, namely K $_{\rm 4;dip}$ (T ;B) $0.01 E_{dem ag}$ (0) near T_C . Sim ilarly, the action of a m agnetic eld B on the anisotropy K $_{4;dip}$ (T;B) is calculated to be much more pronounced within the Green's function theory than within the O guchi approach, cf. Figs.1 and 2. The reason for the strong di erences between the results obtained from the two methods is that the form er one considers collective magnetic excitations with long wavelengths. These are known to have strong e ects on the magnetic properties of ultrathin $\ln s^{3,5}$. In this case the magnetic eld acts merely on spin blocks, i.e. correlated regions of neighboring spins characterized by the short range order param eter¹⁵, resulting in a much larger m agnetic response. For instance, the induced m agnetization in a ferrom agnetic trilayer has been determ ined to be an order of m agnitude larger by consideration of spin waves¹⁶. The collective magnetic excitations are most pronounced for a single magnetic layer3, the zero-point motion is strongest for the spin number S = 1=2. Note that the theoretical methods applied in the present study are much less dem anding than M onte C arlo simulations'.

dipole-coupling-induced The obtained in-plane anisotropy is small as compared to other (e ective) anisotropies, since we have considered interaction strengths appropriate for 3d-transition m etal ferrom agnets. A sm all value for K_{4:dip} (T; B) has been conjectured in⁷. If a ten times larger ratio w=J between the dipole coupling strength and the exchange interaction is assumed, the ratio K_{4;dip} (T;B)=E_{dem ag} (0) increases roughly by the same factor. Since usually the e ective anisotropies decrease with an increasing temperature, K_{4;dip} (T;B) m ight become observable at elevated tem peratures. For comparison, we show in Figs.1 and 2 also the e ective single-ion quartic in-plane anisotropy K_{4;so} (T) resulting from the spin-orbit interaction. This quantity is calculated with the help of a therm odynam ic perturbation theory¹⁷. By assuming its strength to be $K_{4;so}(0) = 0.01 E_{dem ag}(0)$, and adapting corresponding Curie tem peratures, $K_{4;so}$ (T) becomes comparable to $K_{4;dip}$ (T; B) at T=T_C 0**:**8 0:9. In this tem perature range the total quartic in-plane anisotropy should increase again, or exhibit an in-plane magnetic reorientation. As mentioned, this dipole-coupling-induced anisotropy should be more apparent for ferrom agnetic (001) thin $\lim s w$ it ha large w = J - ratio.

W e like to comment on the fact that a nite anisotropy is obtained for $T \, > \, T_C$. U sually the e ective anisotropy as observed for a collectively ordered ferrom agnetic state vanishes above T_C . However, a vanishing e ec-

tive anisotropy for $T > T_C$ does not indicate that the anisotropy as present in the H eisenberg H am iltonian disappears. A single (param agnetic) spin is still subject to e.g. the single-ion uniaxial anisotropy K₂ also if the net magnetization is zero. The resulting free energy di erence between the easy and the hard magnetic directions ('param agnetic anisotropy') behaves as / K $_2^2$ =k_B T for $k_{\rm B}$ T, and is rather sm all if K ₂ is sm all as compared K 2 to the exchange interaction J / $k_B T_C$. W ith regard to the present study, a nite value of K $_{4;dip}$ (T; B = 0) for $T > T_c$ rejects the dipole-coupling-induced an isotropy of a spin block¹⁵.

Note that the free energy F (T; B) as obtained from the G reen's function m ethod yields unphysical results for tem peratures near and above $T_{\rm C}$. As can be show n^{18} , for large tem peratures the free energy F (T;B) as calculated by this method does not approach the value

 $k_B T \ln 2$, which is the free energy of a single, noninteracting S = 1=2-spin. This unphysical behavior results in a still increasing $K_{4;dip}$ (T;B) for T > T_C, cf. Fig.2 (b). Nevertheless, we expect that the G reen's function approach re ects the correct behavior of K $_{4;dip}$ (T;B) for $T < T_C$, since its behavior is corroborated by the O guchim ethod and the Holstein-Prim ako approach.

W e have considered a square m ono layer on ly. A sim ilar e ect is expected also for thicker lm swith a square (001) face, or for a hexagonal (111) thin Im. In addition, a corresponding e ect m ay em erge for a three-dim ensional cubic lattice, for which the dipole interaction cancels exactly. At elevated tem peratures, how ever, caused by thermal uctuations the frustration due to this periodicity will be lifted. The dipole coupling then induces a cubic magnetic anisotropy with easy axes directed along e.g. the edges of the cubic lattice. A lso is this case an increasing an isotropy with an increasing tem perature is expected. To obtain an anisotropic contribution caused by the magnetic dipole interaction via the order-by-disorder e ect, we emphasize that the lattice symmetry must be strictly cubic or square. A lattice distortion e.g. due to m agnetostrictive e ects will probably blur this e ect.

By considering the Ham iltonian Eq.(1), these Green's functions are solved in the usual way by the equation of $motion^{4,11,12}$. The higher order Green's functions are approximated by the Tyablikov-decoupling (RPA)¹¹, e.g. $hS_k^z S_i^+$; S_i^{\pm} ii ' $hS^{z}ihhS_{i}^{+};S_{j}ii$, resulting in a system of linear equations

for the G_{ii} (!). By application of a Fourier transform ation into the 2D wave vector space k_k k, one obtains $G^{z}(k;!) = 0$, if $hS^{+}i = hS$ i = 0. The remaining two G reen's functions G (k;!) are easily evaluated⁴:
