A nom alous di usion, nonlinear fractional Fokker-P lanck equation and solutions

#### Abstract

W e obtain new exact classes of solutions for the nonlinear fractionalFokker $P$ lanck-like equation $\varrho_{t}=\varrho_{x} D(x) \Theta_{x}{ }^{1} \quad F(x)$ by considering a di usion coe cient $D=D j j \quad(2 R$ and $D>0$ ) and a driff force $F=k_{1} x+\bar{k} \times \dot{k}_{j}{ }^{1}\left(k_{1} ; \overline{\mathrm{k}} ; 2 R\right)$. Connection with nonextensive statisticalm echanics based on $T$ sallis entropy is also discussed.

## I. INTRODUCTION

The nonlinear or fractional Fokker $P$ lanck-like equa-
 physical situations that present anom alous di usion. A typical nonlinear di usion equation is $@_{t}=D @_{x x}^{2}$, usually denom inated as porous m edium equation. It has been em ployed in the analysis of percolation of gases through porous media ( 2) [ $[6]$, thin saturated regions in porous m edia $(=2)\left[\begin{array}{l}{[1]}\end{array}\right]$, a standard solid-onsolid $m$ odel for surface grow th $(=3)$, thin liquid $\mathrm{lm} s$ spreading under gravity $(=4)$ [ $[\underline{[g}]$, am ong others $\left[\begin{array}{l}{[0]}\end{array}\right]$. In the presence of an extemal driff force, a drift term is inconporated to the porousm edium equation. For exam ple, such situation has been considered in the study of escape tim e, or $m$ ean rst passage tim e, by considering a nonlinear Fokker-P lanck-like equation, leading eventually to a generalization of the A rmenius law [1d]. On the other hand, the fractional diusion equations are frequently considered as altemative approaches to continuous tim e random walk models, generalized Langevin equations, or generalized $m$ aster equations. For instance, we can $m$ ention that a generalized $m$ aster equation, related to a fractional FokkerP lanck equation, has been used in the $m$ odelling of nonm arkovian dynam ical processes in protein folding [1] 1 In, describe relaxation to equilibrium in system (such as polym ers chains and $m$ em branes) w ith long tem poralm em ory [ $\overline{1} \overline{2}^{-1}$, and in anom alous transport in disordered system s [131]. A nother class of anom alous di usion can be obtained using a spatial dependent di usion coe cient $D=D(x)$. For instance, in $\left[1 \bar{L}_{1}^{\prime}\right] D / \dot{j} j$ has been em ployed to analyse the diffusion in a fractalm edium .

Typical physical situations where these kinds of equations are applied concem anom alous di usion of the correlated type (both sub-and superdi usion; see [i1 던) and references therein) and of the Levy type (superdi usion; see [1] $\left.{ }^{-1}\right]$ and references therein). The anom alous correlated di usion, when it has a nite second moment $h x^{2}$ i / $t$, corresponds to superdiusion, norm al diusion and subdi usion for $>1$, $=1$ and $0 \ll 1$, respectively; $=0$ basically indicates a localization. For Levy diusion (Levy distributions), there is no nite
second $m$ om ent, i.e., $h x^{2} i$ diverges.
W e dedicate the present work to investigate the features that em erge from considering a $m$ ixing between fractional derivative, nonlinear aspects and spatial dependent di usion coe cient. M ore precisely, we focus the nonlinear fractionalFokker-P lanck-like equation:

where ; $2 R, D(x) / j x j$ is a (dimensionless) diusion coe cient ( $2 R$ ), and $F(x) \quad d V(x)=d x$ is a (di$m$ ensionless) extemal force (drift) associated w th the potentialV ( x ). W e use the R iem ann- i iouville operator [1] for the fractional derivative, and we also work w th the positive x axis and, later on, we em ploy sym $m$ etry to extend the results to the entire real axis (in other words, we are working with @ $\left.{ }^{1}=@ j j^{1}\right)$. In addition, the initial condition $(x ; 0)=(x)$ and the boundary condition ( $1 ; \mathrm{t})$ ! 0 are used. $N$ otige that the nom alization of is tim e independent. Indeed, if we write the equation in the form $\varrho_{t}=\varrho_{\mathrm{x}} J$ and assum e the bowndary conditions J ( $1 ; t)!0$, it can be show $n$ that ${ }_{1}^{1} d x(x ; t)$ is a constant of $m$ otion.

A s indicated above, Eq. (11) can be used to describe a large class of anom alous di usion processes since it contains, as a particular case, the porous m edium equation, Levy superdi usion, as well as a m ix of them. For $=2$ and $=1$, Eq. (1] $\overline{1}_{1}^{1}$ ) recovers the standard Fokker $P$ lanck equation $w$ ith a drift term . $T$ he particular case $F(x)=0$ (no drift), $D(x)=$ constant, $=2$, and arbitrary has been considered by Spohn [1d]. The case $=2$ has also been considered in $[201,121,122]$ w ith sim ple drifts. T he case $<2 \mathrm{wth} \mathrm{F}(\mathrm{x})^{-}=\overline{0}$ and $\mathrm{D}=$ constant has been addressed in [23]. O ur present analysis involves several extensions of these cases, in particular, by em ploying the extemal force $F=k_{1} x+\bar{k} \times j \times j{ }^{1}$. Indeed, a variety of system s , which presents anom alous di usion, can be described by short or long-range forces when the previous one is em ployed. This analysis is presented in Sec. II for the case $=2$; the solution is obtained in a closed form. In Sec. III, we also obtain exact results for the case 2 , i.e., for the extemal drift $F=k_{1} \times$ we ob-
tain solutions for $2 R$ ，and for $F=k_{1} x+k x \dot{x} j^{1}$ we nd solutions for $=0$ and $=1$ ．Finally，in Sec． IV we present our conclusions．

## II．$\quad \mathrm{NONLINEAR} \mathrm{FOKKERPLANCK}$ EQUATION

B efore starting our discussion，it is interesting to note
 be essentially obtained by using nom alized scaled solu－ tions of the type

in Eq．（III）．Sim ilar approach has been em ployed，for in－ stance，in $\left.\overline{3}_{1,1}^{1}, 2_{1}^{1}\right]$ ．To illustrate this procedure let us insert Eq．$(\overline{2})$ into Eq．$(\overline{1} \overline{1})$ w ith $=2, F(x)=0$ and D $(\mathrm{x})=\mathrm{D}=$ constant．Thus，

 $\mathrm{R}_{1}$ ．nstant k can be xed from the nom alization condition ${ }_{1} \mathrm{dx}(\mathrm{x} ; \mathrm{t})=1$.
Let us now go back to Eq．（［1］）with $F=k_{1} x+$ $\overline{\mathrm{k}} \times \mathrm{j} \mathrm{xj}^{1}\left(\mathrm{k}_{1} \mathrm{k}_{\mathrm{k}}\right)$ and $\mathrm{D}(\mathrm{x})=\mathrm{D} \dot{\mathrm{x} j}(2 \mathrm{R})$ ． $F$ irstly，we address our discussion to case $=2$ ．In th is case，Eq．（［1］）reduces to

when $(x ; t)$ ，given by Eq．（Z⿹\zh13一），is em ployed．W e are interested in situations for which the scaled solution of the type indicated in Eq．（2，）is still valid，i．e．，we would like to uncouple the $t$ and $z$ dependence in Eq．（i，）as perform ed in Eq．（3）via Eq．（4， $\mathbf{L}^{\mathbf{1}}$ ）．This can be accom plished when $\quad+\quad+\quad=0$ ．If this condition is satis ed，we obtain

where $\mathrm{k}^{0}$ is a constant that plays a role analogous to k in Eq．（4），and it is to be determ ined through the norm alization． From the solutions of Eq．（ $(\underline{q})$ and Eq．（1 $\left.\mathbf{1}_{1}^{\prime}\right)$ ，which generalize the results of the previous exam ple，we have

where $\ln _{\mathrm{q}} \mathrm{x} \quad\left(\begin{array}{lll}\mathrm{x}^{1} & \mathrm{q} & 1\end{array}\right)=\left(\begin{array}{ll}1 & \mathrm{q}\end{array}\right)$ is the q －logarithm func－tion（that is the inverse fiunction of the $q$－exponential）．

In the previous study for the case $=2$, we notice that the analytical solution (12) takes fractal and nonlinear aspects into account, since there is a spatial dependence on the di usion coe cient $(\leqslant 0)$ and a nonlinear term ( € 1). In fact, it contains results obtained in 14, 1did, '21 $1,122,2,24^{\prime}, 22_{1}^{\prime}, 27_{1}^{\prime} 1$ as particu lar case. $M$ oreover, it reduces to the R ay leigh process[2d] case in the lim it q! 1 and $=0$.

## III. NONLINEAR FRACTIONAL

FOKKER PLANCK EQUATION

In order to give an extension for the previous discussion ( = 2), we address our investigation conceming Eq. [1]) by considering 6 . W thout loss of generality we are considering $D=1 . W$ e follow the procedure em ployed in [24, $\left.2 Z_{1}\right]$ taking the generic property

w th $\overline{\mathrm{z}}=$ ax into account. T his basic property holds not only for the ordinary derivative but also for all fractional operators that we are considering here. Thus, substituting Eq. $\overline{(\underline{1})}$ ) into Eq. (11) and im posing

By considering $\overline{\mathrm{k}}_{2}=0$ corresponds $(\mathrm{x} ; 0) /(\mathrm{x})$. On the other hand, em ploying $\overline{\mathrm{k}}_{2} \in 0$ leads to $(\mathrm{x} ; 0)$ less concentrated than
(x). A m ore tractable equation to $\sim(z)$ is obtained after an integration ofEq. (1-G), i. e.,

where C is another arbitrary constant. In the follow ing, we address our discussion focusing tw o situations of Eq. (1]-1). The rst one is characterized by a linear drift, $F=k_{1} x$. In the second one, we consider the drift $\mathrm{F}=\mathrm{k}_{1} \mathrm{x}+\mathrm{kxj} \mathrm{x} j^{1}$ for particular values of .

Let us start our discussion by considering Eq. $\mathbf{1}_{1}^{\left(\bar{T}_{1}\right)}$ w ith $\mathrm{k}_{1} \in 0$ and $\mathrm{k}_{\mathrm{E}}=0$. To solve it, we can use the procedure em ployed in [3] w th $C=0$ and

Let us nally indicate a connection betw een the results obtained here and the solutions that arise from the opti$m$ ization of the nonextensive entropy $\left[\frac{1}{}\right]$. These distributions do not coincide for arbitrary value of $x$. H ow ever, the com parison betw een the asym ptotic behaviors (large (xi) enables us to identify the type of tails. For instance,
 $w$ th the asym ptotic behavior $\left.1=\dot{x} \mathcal{j}^{f=(q} 1\right)$ into account, which appears in $\left[\underline{l}_{1}^{1}\right]$ for the entropic problem, we obtain

$T$ his relation is the sam e obtained in []$\left._{1}^{-1}\right]$ in the absence ofdrift. It also recovers that one already established in [231] for $=0$.

IV . CONCLUSIONS

In sum $m$ ary, we have considered the one-dim ensional nonlinear fractional Fokker $P$ lanck equation (Eq. (III) for
som e space-dependent (power-law) classes of extemal drift and di usion coe cient. W e have shown that it adm its exact solutions w here space scales $w$ ith a (usually simple) function of time (as indicated in Eq. $\overline{\underline{Z}})$ ), and have fully and explicitly worked out som e of those. In particular, we rst consider the case $=2$ in the presence of the drift, $F=k_{1} x+\bar{k} \times \mathrm{j}_{\mathrm{x}}{ }^{1}$, w th $\mathrm{k}_{1} ; \overline{\mathrm{k}} \in 0$. A fter, we analyse the case 2 in the presence of the sam e drift for som e situations. W e have also discussed the connection $w$ ith nonextensive statistics, $w$ hen appropriated, providing the relation betw een the entropic index $q$ and the exponents appearing in the Fokker $P$ lanck equation. Thus, by extending here results such as those discussed in $\left.123_{1}^{\prime}, 24_{1}^{\prime \prime}, 25_{1}^{\prime}, 2 T_{1}\right]$, we hope to $m$ ake possible further applications to physical system s exhibiting suitable m ix of di erent form s (nonlinear $\in 1$, fractional derivative 2 and fractal $\approx 0$ ) of anom alous diusion.
