A nom alous di usion, nonlinear fractional Fokker-Planck equation and solutions

We obtain new exact classes of solutions for the nonlinear fractional Fokker-P lanck-like equation $\theta_t = \theta_x \ D(x)\theta_x^{-1} \ F(x)$ by considering a direction coefficient $D = D_j x j$ (2 R and D > 0) and a drift force $F = k_1 x + \overline{k} x j x j^{-1} (k_1; \overline{k}; 2 R)$. Connection with nonextensive statistical mechanics based on T sallis entropy is also discussed.

I. INTRODUCTION

The nonlinear or fractional Fokker-Planck-like equations [1, 2, 3, 4, 5] have been used to analyze several physical situations that present anom alous di usion. A typical nonlinear di usion equation is $\theta_t = D \theta_{xx}^2$ usually denominated as porous medium equation. It has been employed in the analysis of percolation of gases 2) [6], thin saturated rethrough porous media (gions in porous media (= 2) [7], a standard solid-onsolid model for surface growth (= 3), thin liquid lms spreading under gravity (=4) [8], among others [9]. In the presence of an external drift force, a drift term is incorporated to the porous medium equation. For exam ple, such situation has been considered in the study of escape time, or mean rst passage time, by considering a nonlinear Fokker-P lanck-like equation, leading eventually to a generalization of the Arrhenius law [10]. On the other hand, the fractional di usion equations are frequently considered as alternative approaches to continuous time random walk models, generalized Langevin equations, or generalized master equations. For instance, we can mention that a generalized master equation, related to a fractional Fokker-Planck equation, has been used in the modelling of nonmarkovian dynamical processes in protein folding [11], describe relaxation to equilibrium in system (such as polymers chains and membranes) with long temporalmemory [12], and in anomalous transport in disordered system s[13]. A nother class of anom alous diusion can be obtained using a spatial dependent di usion coe cient D = D(x). For instance, in [14] D / jxj has been employed to analyse the diffusion in a fractal medium.

Typical physical situations where these kinds of equations are applied concern anom alous di usion of the correlated type (both sub- and superdi usion; see [15] and references therein) and of the Levy type (superdi usion; see [16] and references therein). The anom alous correlated di usion, when it has a nite second moment $l\kappa^2i\ /\ t$, corresponds to superdi usion, norm aldiusion and subdiusion for >1, = 1 and 0 < < 1, respectively; = 0 basically indicates a localization. For Levy di usion (Levy distributions), there is no nite

second m om ent, i.e., hx2 i diverges.

We dedicate the present work to investigate the features that emerge from considering a mixing between fractional derivative, nonlinear aspects and spatial dependent diusion coecient. More precisely, we focus the nonlinear fractional Fokker-Planck-like equation:

where ; 2 R, D (x) / $\dot{x}j$ is a (dimensionless) diusion coe cient (2 R), and F (x) dV (x)=dx is a (dimensionless) external force (driff) associated with the potential V (x). We use the Riemann-Liouville operator [18] for the fractional derivative, and we also work with the positive x axis and, later on, we employ symmetry to extend the results to the entire real axis (in other words, we are working with $e^{-1}=e^{ix}j^{-1}$). In addition, the initial condition (x;0) = (x) and the boundary condition (1;t)! 0 are used. Notice that the normalization of is time independent. Indeed, if we write the equation in the form $e^{-1}=e^{-1}v$ and assume the boundary conditions v (1;t)! 0, it can be shown that v (x;t) is a constant of motion.

As indicated above, Eq.(1) can be used to describe a large class of anom alous di usion processes since it contains, as a particular case, the porous medium equation, Levy superdiusion, as well as a m ix of them . For = 2= 1, Eq.(1) recovers the standard Fokker-Planck equation with a drift term. The particular case F(x) = 0(no drift), D (x) = constant, = 2, and arbitrary has been considered by Spohn [19]. The case = 2 has also been considered in [20, 21, 22] with simple drifts. The case < 2 with F(x) = 0 and D = constant has beenaddressed in [23]. Our present analysis involves several extensions of these cases, in particular, by employing the external force $F = k_1 x + k_2 x + k_3 x + k_4 x + k_5 x + k_5 x + k_6 x + k$ of systems, which presents anomalous diusion, can be described by short or long-range forces when the previous one is employed. This analysis is presented in Sec. II for the case = 2; the solution is obtained in a closed form. In Sec. III, we also obtain exact results for the case $\{0, ie., for the external drift F = k_1 x we ob-$ tain solutions for 2 R, and for $F = k_1x + k x j x j^{-1}$ we not solutions for = 0 and = 1. Finally, in Sec. IV we present our conclusions.

II. NONLINEAR FOKKER-PLANCK EQUATION

B efore starting our discussion, it is interesting to note that the results presented in [20, 21, 22, 23, 24, 25] m ay be essentially obtained by using normalized scaled solutions of the type

in Eq.(1). Sim ilar approach has been employed, for instance, in [3, 24]. To illustrate this procedure let us insert Eq.(2) into Eq.(1) with = 2, F(x) = 0 and D(x) = D = constant. Thus,

In the following, we elim in ate the explicitly time dependence on Eq. (3) choosing

where k is a constant. Thus, Eq. (4) replaced into Eq. (3) gives us

From Eq. (4) we obtain

where we have adopted the solution which satisfies (0) = 0 for > 1. Finally, the solution of Eq. (5) leads to

Let us now go back to Eq. (1) with $F=k_1x+k_1x$ is $k_1 \notin k_2$ and D $k_1 \in k_3$ (2 R). Firstly, we address our discussion to case = 2. In this case, Eq.(1) reduces to

when (x;t), given by Eq. (2), is employed. We are interested in situations for which the scaled solution of the type indicated in Eq. (2) is still valid, i.e., we would like to uncouple the t and z dependence in Eq. (8) as performed in Eq. (3) via Eq. (4). This can be accomplished when + + = 0. If this condition is satisfied, we obtain

where k^0 is a constant that plays a role analogous to k in Eq. (4), and it is to be determined through the normalization. From the solutions of Eq. (9) and Eq. (10), which generalize the results of the previous example, we have

where $\ln_q x$ $(x^1 q) = (1 q)$ is the q-logarithm function (that is the inverse function of the q-exponential).

In the previous study for the case = 2, we notice that the analytical solution (12) takes fractal and nonlinear aspects into account, since there is a spatial dependence on the diusion coe cient ($\mbox{\ensuremath{\mathfrak{e}}}$ 0) and a nonlinear term (€ 1). In fact, it contains results obtained in [14, 19, 20, 21, 22, 24, 25, 27] as particular case. M oreover, it reduces to the Rayleigh process [28] case in the limit q! 1 and

III. NONLINEAR FRACTIONAL FOKKER-PLANCK EQUATION

In order to give an extension for the previous discussion (=2), we address our investigation concerning Eq. (1)by considering 6 2. Without loss of generality we are considering D = 1. W e follow the procedure employed in [24, 27] taking the generic property

with \overline{z} = ax into account. This basic property holds not only for the ordinary derivative but also for all fractional operators that we are considering here. Thus, substituting Eq. (2) into Eq. (1) and imposing

in order to uncouple t and z dependence, where $\overline{k}^{\scriptscriptstyle 0}$ is an arbitrary constant. Therefore, we obtain

+ 2 and \overline{k}_2 being an arbitrary constant. If $\overline{k}_2 = 0$ we have (0) = 0 for + $\frac{1}{k_2}$, recovering Eq. (11) when $\phantom{\frac{1}{k_2}}$! 2. By considering $\phantom{\frac{1}{k_2}}$ = 0 corresponds (x;0) / (x). On the other hand, em ploying $k_2 \in 0$ leads to (x;0) less concentrated than (x). A m ore tractable equation to \sim (z) is obtained after an integration of Eq. (16), i. e.,

where C is another arbitrary constant. In the following, we address our discussion focusing two situations of Eq.(17). The rst one is characterized by a linear drift, $F = k_1 x$. In the second one, we consider the drift $F = k_1x + k x \dot{x} \dot{x} \dot{j}^{-1}$ for particular values of .

A. The drift

Let us start our discussion by considering Eq.(17) with $k_1 \in 0$ and k = 0. To solve it, we can use the procedure em ployed in [23] with C = 0 and

B. The drift $F = k_1 x + k x \dot{x} \dot{y}^{-1}$

Now, we consider other particular cases, namely = 0 and = 1. Let us start with = 0 and arbitrary. The corresponding equation is

To solve it let us go back to Eq. (17) with = 0 and C = 0, i.e.,

where C is a constant.

Let us now address our analysis to the case = 1. It corresponds to investigate the equation

To obtain the solution of this equation employing the ansatz (2) we use Eq.(17). It follows that

The solution corresponding to C = 0 is

Let us nally indicate a connection between the results obtained here and the solutions that arise from the optimization of the nonextensive entropy [4]. These distributions do not coincide for arbitrary value of x. However, the comparison between the asymptotic behaviors (large jx) enables us to identify the type of tails. For instance, by taking the behavior exhibited in Eq.(19) for large jx with the asymptotic behavior 1=jx $j^{2}=(q-1)$ into account, which appears in [4] for the entropic problem, we obtain

This relation is the same obtained in [27] in the absence of drift. It also recovers that one already established in [23] for = 0.

IV. CONCLUSIONS

In sum m ary, we have considered the one-dimensional nonlinear fractional Fokker-P lanck equation (Eq.(1) for

som e space-dependent (power-law) classes of external drift and diusion coe cient. We have shown that it adm its exact solutions where space scales with a (usually simple) function of time (as indicated in Eq.(2)), and have fully and explicitly worked out some of those. In particular, we rst consider the case = 2 in the presence of the drift, $F = k_1x + \overline{k} x \dot{x} \dot{x} \dot{j}^{-1}$, with $k_1 \dot{k} = 0$. After, we analyse the case 6 2 in the presence of the sam e drift for som e situations. W e have also discussed the connection with nonextensive statistics, when appropriated, providing the relation between the entropic index q and the exponents appearing in the Fokker-P lanck equation. Thus, by extending here results such as those discussed in [23, 24, 25, 27], we hope to make possible further applications to physical systems exhibiting suitable m ix of dierent forms (nonlinear & 1, fractional derivative 6 2 and fractal 6 0) of anom alous diusion.
