## Spin reorientation transition in the incommensurate stripe-ordered phase of $La_{3=2}Sr_{1=2}N$ iO $_4$

The spin ordering of  $La_{3=2} Sr_{1=2}N$  iO 4 was investigated by magnetization measurements, and by unpolarized-and polarized-neutron di raction. Spin ordering with an incommensurability 0.445 is observed below  $T_{SO}$  80 K.On cooling, a spin reorientation is observed at 57 1 K, with the spin axes rotating from 52 4 to 78 3. This is the rst time a spin reorientation has been observed in a  $La_{2 \times} Sr_{x}N$  iO 4+ compound having incommensurate stripe order.

Incommensuratem agnetic uctuations observed in superconducting  $La_2 \ sr_x CuO_4 (LSCO)^1$  are widely believed to be associated with charge stripe correlations.<sup>2</sup> A ssum ing this to be the case, it has been concluded that charge stripes in LSCO lie parallel to the Cu(O bonds in the CuO planes for x 0.053,<sup>3</sup> but are aligned at 45 to the Cu(O bond for x 0.07.<sup>3,4</sup> G iven that the critical doping level for superconductivity in LSCO is x = 0.053{0.056,<sup>3</sup> these observations suggest a strong link between spin-charge stripe ordering and high temperature superconductivity.

D iagonal charge stripes have also been observed in  $La_2 \times Sr_x N iD_{4+}$  (LSNO),<sup>5</sup> and have been studied by neutron<sup>6,7,8,9,10</sup> and x-ray<sup>11,12</sup> di raction for doping levels in the range 0.135 x 0.5. The charge stripes are found to be ordered over a long range, with correlation lengths in excess of 100A for certain levels of doping<sup>7,12</sup>. LSNO with x = 1/3 has stripe order that is particularly stable owing to a commensurability e ect that pins the charges to the lattice.<sup>7,9,13</sup> Having charge stripes that are static and well correlated, LSNO is a good system for studying the basic properties of spin-charge stripes.

Recently, Lee et al.<sup>8</sup> m easured the direction of the ordered N i m om ents in the spin-ordered phase of compounds with x = 0.275 and 1/3. The angle between the spin axes and the stripe direction was found to be larger at x = 1/3 than x = 0.275. Furthermore, a transition was observed at 50K in the x = 1/3 sample such that on cooling the spins rotate away from the stripe direction and a further localization of the charge ordering occurs. Lee et al. concluded from this that an intim ate connection exists between the local spin order and the stability of the charge order.

Early work on  $La_{3=2}Sr_{1=2}NiO_{4+}$  by electron di raction<sup>14</sup> suggested that the case of half-doping is another very stable charge-ordering phase. This charge ordering has a 2-D checkerboard-like pattern as shown in gure 1(a). Recently, Kajin oto et al<sup>10</sup> studied the spin and charge order in a single crystal of (00l) (00l) (1) (1) (1) (1) (2) (2) (2) (2) (2) (2) (3) (2) (2) (3) (1) (2) (1)

 $\rm La_{3=2}Sr_{1=2}N$  iO  $_4$  by neutron di raction. They observed checkerboard ordering below  $480\,\rm K$ , but they also found an incommensurate charge-stripe ordering phase below  $T_{\rm ICO}$   $180\,\rm K$  coexisting with the checkerboard ordering. Spin ordering was reported to be found only in association with the incommensurate component of the charge ordering.

Here we describe a study of spin-ordering in  $La_{3=2}Sr_{1=2}NiO_{4+}$  employing magnetometry and polarized- and unpolarized-neutron di raction. Our results are consistent with those of K a jim oto et al,<sup>10</sup> but in addition we observed a spin reorientation




FIG. 2: FC and ZFC magnetization data for  $La_{3=2}\,Sr_{1=2}\,N$  iD  $_{4+}$  . A rrow s indicate the spin-ordering tem perature,  $T_{\rm SO}$ , and the spin-reorientation tem perature,  $T_{\rm SR}$ .

transition similar to, but more pronounced than that observed in  $La_{5=3}Sr_{1=3}NiO_4$ . This is the rst time a spin reorientation associated with an incommensurate spin ordering has been observed in a LSNO material. The spin reorientation is signalled by a sharp anomaly in the magnetization at 57K, and an analysis of polarized-neutron di raction data shows that on cooling through 57K the Ni spins rotate away from the stripe direction.

Two single crystals of  $La_{3=2}Sr_{1=2}NiD_{4+}$  were used for these experiments. The crystal used for the magnetization measurements had dimensions 7 5 2 mm<sup>3</sup> and that for neutron di raction was a rod of 7{8 mm diameter and 35 mm in length. Both these samples were grown from the same starting powder by the oating-zone technique.<sup>15</sup> The oxygen excess was determined by therm ogravimetric analysis to be = 0.02 0.01.

M agnetization data were collected with a SQUID m agnetom eter (Quantum Design) with the eld applied parallel to the ab plane of the crystal. We carried out DC measurements by cooling in an applied eld of 5000 e (FC) and also by cooling in zero eld and measuring while warming in a eld of 5000 e (ZFC). Figure 2 shows the tem perature variation of the FC and ZFC m agnetization. A small change in slope at 90 5K marks the spin ordering tem perature, in agreem ent with previous observations.<sup>7</sup> A clearer anom aly is seen at  $T_{SR} = 57 \text{ K}$ , where the FC and ZFC curves sharply separate. Below 5K both the FC and ZFC curves begin to rise for reasons that are not yet understood, but could be due to a small amount of param agnetic impurity in the crystal. W e m easured the FC m agnetization parallel to the crystalc direction (not shown) and found no anomaly

around  $T_{\rm SR}$  , thus indicating that the transition involves the in-plane components of the spins.

In what follows we describe neutron di raction studies aim ed at identifying the nature of the transition at  $T_{SR}$  . Referred to the tetragonal unit cell of LSNO, with unit cell param eters a 3.8A, c 12.7A, charge ordering peaks due to structural distortions are located at (h ", k ", 1) positions in reciprocal space. The spin order peaks are located at (h+1/2 "/2, k+1/2 "/2, 1), the strongest being when l is odd.<sup>8</sup> To a rst approximation the relationship between the incommensurability, ", and the hole concentration,  $n_h = x + 2$  , is simply " = n<sub>h</sub>. In general, how ever, com petition between apparently di erent wavevectors for the spin and charge ordering? and the separate issue of oxygen non-stoichiom  ${\rm etry}^{14,16,17}$ causes small deviations from the " =  $n_h$  rule.

The neutron experim ents were perform ed on the tripleaxis spectrom eter IN 20 at the Institut Laue-Langevin. The energies of the incident and elastically-scattered neutrons were selected by B ragg re ection from an array of either pyrolytic graphite (PG) or H eusler alloy crystals, for unpolarized-and polarized-neutron scattering respectively. A PG liter was present after the sam ple and before the analyzer to suppress higher-order harm onic scattering. M ost of the data were obtained with initial and

nalneutron w avevectors of 2.66  $^1$ , with some further data taken with a neutron wavevector of 3.54  $^1$ . We mounted the sample with the [001] and [110] crystal directions in the horizontal scattering plane, and perform ed scans in reciprocal space either parallel to the (h, h, 0) direction at constant l, or parallel to the (0, 0, 1) direction at constant h.

We began by performing polarized-neutron di raction m easurements with the neutron polarization P parallel to the scattering vector Q, maintained by adjusting currents in a Helm holtz coil mounted around the sample. In this con guration a neutron's spin is ipped during a magnetic scattering process, but remains unchanged when scattered by a non-magnetic process, e.g. from a distortion of the lattice. Thus, by measuring the spin-

ip (SF) and non-spin- ip (NSF) channels one can identify whether the origin of the scattering is  ${\tt m}$  agnetic or not.

We observed charge-order di raction in the vicinity of the (1.5, 1.5, 1) line in reciprocal space. At T = 10K the peak shape observed in (h, h, 0) scans was consistent with that observed by K a jim oto et al., with a central peak at h = 1.5 and two satellites at h 1.45 and 1.55. We observed no variation of this scattering with lover a single B rillouin zone, showing that both the commensurate and incommensurate components of charge ordering are completely two-dimensional.




FIG. 3: Spin- ip (SF) and non-spin- ip (NSF) diraction from  $La_{3=2}Sr_{1=2}N$  iO<sub>4</sub> at T = 10 K. The scan is parallel to (0, 0, 1) and passes through the magnetic order peak (0.275, 0.275, 1). No correction has been made for the imperfect polarization of the neutron beam. The sharp peaks in the NSF channel at 1 5.3 and 6.2 are due to diraction from the Al sample mount.

We observed spin-order di raction peaks at  $(h+1/2 \ "/2, h+1/2 \ "/2, l)$  positions with l odd and " = 0.445 0.005. Figure 3 shows a scan parallel to (0, 0, l). The widths of the peaks in this scan convert to a correlation length along the c axis of 16.4 0.3A. For comparison, the in-plane correlation length in the

direction perpendicular to the stripes is 78.3 1.3A. There were no peaks at l = even positions, as can be seen in gure 3. There were also no spin-order peaks at (h 1/4, h 1/4, l) positions, con rm ing the lack of any com m ensurate Fourier component in the spin ordering, in agreem ent with the observations of K a jim oto et al.<sup>10</sup>




FIG. 4: (a) The peak intensities of the spin peaks  $Q_1 = (0.275; 0.275; 5)$  and  $Q_2 = (0.725; 0.725; 1)$  see gure 1 (b). C incle symbols represent data taken with a neutron wavevector of  $3.54 \text{ A}^{-1}$  and triangles represent 2.66 A<sup>-1</sup>. Filled symbols are data taken at  $Q_2$  and unled symbols at  $Q_1$ , with the arrow s indicating the relevant scales for each Q. (b) The temperature dependence of the angle between the spin axis and the stripe direction obtained from polarized-neutron analysis.

Figure 4a show the temperature dependence of the integrated intensity of two magnetic relections,  $Q_1 = (0.275, 0.275, 5)$  and  $Q_2 = (0.725, 0.725, 1)$ , measured in scans parallel to (h;h;0). The spin ordering transition is seen to be rather sluggish, but a sharpening of the peaks below  $T_{SO}$  ' 80K (not shown) suggests that this is where long-range ordering extending over m any unit cells sets in. How ever short-range correlations persist above 100K. On cooling below  $T_{SO}$ , the peak at  $Q_1$  increases m onotonically, while that at  $Q_2$  rst increases, then reaches a maximum at 60K, then decreases again. This anom alous behaviour correlates with the transition observed in the magnetization, Fig. 2. To understand this behaviour we must recall that magnetic neutron di raction is sensitive to spin com ponents perpendicular to Q. As shown in

gure 1 (b),  $Q_1$  is approximately parallel to (0;0;1) while  $Q_2$  is approximately parallel to (h;h;0). Therefore, to a good approximation, the scattering at  $Q_1$  is from the total in-plane spin moment, irrespective of its direction, while that at  $Q_2$  comes mainly from the spin components parallel to the stripes and along the caxis. The data in g. 4a therefore imply that below 57K the spins rotate

away from the stripe direction.

To fully analyze the direction of the spins over this

tem perature range we varied the direction of the neutron polarization P relative to the scattering vector Q. Three conguration were used: 1) P kQ, 2) P? Q but in the scattering plane, and 3) P? Q but out of the scattering plane. (Recall that [110] and [001] are the crystal directions in the scattering plane.) As mentioned before, neutrons scatter via magnetic interactions from spin com – ponents perpendicular to Q, and SF scattering is due to spin com ponents perpendicular to P. Therefore, analysis of congurations 1), 2) and 3) leads to the direction of the ordered moment.<sup>18</sup> Table 1 sum marizes the relations between the observed intensities at Q<sub>1</sub> and Q<sub>2</sub> and the ordered spin components parallel ( $_k$ ) and perpendicular ( $_2$ ) to the stripe direction (seegure 1(a)), and parallel to the c axis ( $_c$ ).

W e corrected the data to take into account the di erent background count rates in the SF and the NSF channels, and to correct for the imperfect spin polarization of neutron beam. The latter was calculated from the ipping ratio 18.5 1.8 m easured on a magnetic B ragg peak.

A full analysis of the intensities at the Q<sub>1</sub> and Q<sub>2</sub> points determ ined the spin orientations at T = 10 K and T = 65 K. These analyses showed that the non-m agnetic (NM) and  $_{\rm c}$  count rates were zero, to within error for

both tem peratures. Thus, it is reasonable to assume that the spins lie within the ab plane over the whole tem perature range, consistent with the lack of any anom aly observed at  $T_{SR}$  in the magnetization data measured with H k c. At the other tem peratures we deduced the spin orientation within the ab plane from one Q position (T = 55K from Q<sub>1</sub>, T = 50 and 75K from Q<sub>2</sub>.) From these data we nd that the spins reorientate from an angle of 52 4 to the stripe direction at T = 75K, to 78 3 at T = 10K, as shown in gure 4 (b). The transition is seen to occur quite rapidly between 50 and 65K, although the reorientation is not com plete at 50K.

How does the spin reorientation described here in the x = 1/2 crystal compare with that reported by Lee et al.<sup>8</sup> for x = 1/3? In both compositions the spin reorientations occur at similar temperatures ( 50 K for x = 1/3, 57 K for x = 1/2) and the spins rotate in the same sense, namely away from the stripe direction, on cooling. On the other hand, the angle through which the spins rotate is greater for x = 1/2 ( 26 ) than for x = 1/3 ( 13 ), and the nallow temperature spin direction in x = 1/2 is almost perpendicular to the stripes ( = 78 ) compared with 53 for x = 1/3. Considering also the spin direction = 27 observed for x = 0.275,<sup>8</sup> for which there is no reorientation transition, we nd that as the doping level increases the angle from the stripe

direction increases. However, the trend in the spin orientation also correlates with the increasing stability of the charge ordering as measured by the charge-ordering tem peratures<sup>7,8,10</sup> ( $T_{CO}$  (x = 0.275) 200K,  $T_{CO}$  (x = 1/3) 240K,  $T_{CO}$  (x = 1/2) 480K). Therefore, measurem ents on more compositions of La<sub>2 x</sub> Sr<sub>x</sub>N  $\dot{D}_{4+}$  are needed to establish whether it is the doping level or the stability of the charge order that is more important in determ ining the spin orientation.

The occurrence of spin reorientation transitions in the x = 1/3 and x = 1/2 but not in x = 0.275 m ight suggest that these transitions are linked to the stability of the charge order. Inrespective of this, what the present study has shown is that the occurrence of a spin reorientation transition does not depend on the stripe order being commensurate with lattice. Indeed, the spin reorientation transition is even m ore striking in the x = 1/2 composition, forwhich the spin order is incommensurate, than in x = 1/3, for which it is commensurate.

These observations emphasize the importance of couplings between spin and charge degrees of freedom in stripe-ordered systems, and suggest that this coupling is particularly strong in  $La_{3=2}Sr_{1=2}N$  iD<sub>4</sub>.
