A nom alous di usion on dynam ical networks: A model for interacting epithelial cell m igration

Abstract

W e propose a model for cell migration where epithelial cells are able to detect trajectories of other cells and try to follow them. As cells move along in 2D cell culture, they mark their paths by loosing tiny parts of cytoplasm. Any cell moving on a surface where other cells have moved before faces a network of cell trajectories, which it tries to restrict its motion onto. W ith the T sallis modil cation of classical therm odynamics one can solve the relevant Fokker-P lanck like equation and obtain experimentally testable distribution functions. W e compare the model to experimental data of norm al mammary epithelial cells and cells which have been genetically manipulated to change their degree of cell-cell interaction.

A generalization of classical B oltzm ann therm odynam ics as recently introduced by T sallis [1, 2, 3] has o ered a beautiful way of describing the statistics of a multitude of physical system s, which generally involve some sort of long-range interactions, ranging from astro-physics [4, 5] to low dimensional dissipative chaotic system s [6]. System s described by this therm odynam ics are often referred to as "non-extensive". This same modil cation of classical therm odynam ics also seem s to o er a natural understanding of the subject of anom abus di usion. A nom alous di usion can be thought of the propagation of particles which are restricted to move on a certain subspace of full two or three space, such as for example the propagation of water molecules in a sponge, or the ow of crude oil in porous soil. In this work we argue that the motion of living and interacting epithelial cells can be seen as a variant of anom alous di usion on a network which changes over time. We support the idea by experimental evidence. Our experimental indings moreover strongly support very recent work on movem ents of interacting Hydra cells [7].

A living epithelial celleg. in two-dimensional cell culture is not a static object but moves continuously, a process which is called cellular migration [8, 9]. Cell migration is of vital in portance in physiological processes such as wound healing or understanding cancerogenesis. For example, intact mammary gland tissue is stable during phases of milk secretion. In residual phases of fem ale estrous cycle, however, it is subject to structural remodeling where cells become dynamic entities. They proliferate and migrate, eventually forming new functional secretory units [10, 11, 12]. Dysregulation of these events is believed to contribute to cancerogenesis [13, 14, 15]. In-vitro experiments preserve in portant aspects of this epithelial biology [16, 17], and migration of single cells has been studied in cell culture system s on molecular and mechanical levels [8, 9, 18].

Single cells are by no means passive movers and governed by chance, but in uence and control their movements them selves. For these movements to occur morphological changes are necessary which are realized in the formation of distinct subcellular domains. In Fig. 1a a single cell is shown during movement. A first the formation of a so-called lamellipodium, (a V-shaped protrusion) this part of the cell attaches to the cell culture surface. The cell body is then pulled towards the front part ("leading edge") via the activation of mechanical intracellular linkages. Eventually the "trailing" edge, a thin, elongated structure at the

opposite side of the cell with respect to the lam ellipodium, detaches from the surface which allows a net translocation of the cell. In this "polarized" fashion the cell apparently craw ls on the surface of the cell culture substrate, continuously readjusting its direction. During m ovem ent cells loose tiny parts of their cytoplasm, m arking at least parts of their trajectories. It is known that cells change their m ovem ent patterns when the activity of proteins involved in cell adhesion is regulated up or down ward. W hen these proteins for exam ple are suppressed, cells loose their ability to m igrate in a polarized fashion [19, 20]. As several recent works on velocity distributions of cells show, it seems very likely that cellm ovem ent depends strongly on the surrounding of individual cells. Experim ental results range from norm all di usion [21] to exponential velocity distributions [22]. It is the aim of this paper to show that an anom alous di usion approach, already discussed in [7], m ight be general enough to explain the di erent experim ental results on a common theoretical ground.

THEORY

To describe the dynam ics of a single cell which has the ability to detect the presence of trajectories of other cells, we propose the follow ing model. Im agine each cells paints its trail onto the surface. The paint slow ly fades, and can not be seen after a certain time. A nother cell which detects the line of paint tries to follow it as good as possible. From time to time the cell will be distracted from strict path following by random ("therm al") events. At the same time this cell also marks its trajectory with paint. As many cells move across the same surface there will evolve a network of paths. Since paint fades and new trajectories are added to the network, the network will undergo slow dynam ical changes. Any cell equipped with a trail following mode will try to restrict its movements onto the network of trails of former cells. The situation here is much alike di usion in porous media where particle trajectories are restricted onto certain pathways, and can not propagate through full two-or three-dimensional space. In the case of cell migration an individual cell tries to follow the dynam ical "web" of trajectories other cells have taken before.

M odeling cell m igration as a stochastic di usion process of this kind clearly involves non-linearities in the associated Fokker-P lanck like equations

To incorporate the idea that cells follow the gradient of m etabolites em itted by other cells along their trajectories, a non-linear ow-term of the form F $[p] = \frac{\theta}{\theta \cdot x} p$ would be reasonable. However, we neglect the ow-term in the following, since a posteriori we nd almost no experimental evidence for it. To incorporate the anom abus di usion idea, we decide the functional dependence of the di usion parameter to be D $[p]p = p \cdot W$ ith this choice equation (1) can be solved by following the entropy approach by T sallis [1, 3]. Here the the classical entropy de nition S = ${}^{R} p(u) \ln p(u) du$ is modiled to

By maxim izing S_q while keeping energy xed it can be shown that the resulting p(u), i.e.

also solves Eq. (1) without the ow-term [2, 23]. Here Z_q (t) is the generalized q partition function. The relation of the T sallis entropy factor q, and in Eq. (1) is given by q = 2[2]. Note that this distribution is a power law, and only in the limit q ! 1 the classical G aussian $p_1(x;t) = \frac{\exp^{-\frac{(t)(x - hxi(t))^2}{Z_1(t)}}{Z_1(t)}$ is recovered. It is relatively straight forward to derive the corresponding velocity distributions of the associated particles

which has been derived for the set time in [24], and which reduces to the usual M axwell-Boltzm ann result $p(v) = \frac{m}{2 kT} e^{\frac{3}{2}} \exp \frac{-m v^2}{2}$ in the limit q ! 1. Here $\frac{m}{2}$ can be seen as an inverse m obility factor, m eaning that large values of $\frac{m}{2}$ are associated with sm all average cell velocities. If cell m igration is in fact describable as anom alous di usion governed by a Fokker-P lanck equation like Eq. (1) with the special choice of D [p], the cell velocity distribution function should follow the form of Eq. (4).

To further characterize the nature of the di usion process we will also bok at norm alized tem poralautocorrelation functions AC () = $\frac{1}{2}$ () h (t) (t) i_t, and at two-point correlation functions C () = h[(t+) (t)]² i_t, of an underlying process (t), where h:i_t denotes the average over time t. For (fractional) B rownian motion, the correlator scales as C () ^{2H}, where H is sometimes called the Hurst exponent. For H = 1=2 the classical di usion result is obtained (B rownian motion), H > 1=2 indicates correlated di usion, which we expect in our case.

EXPERIM ENTAL DATA

To record the trajectory of an individual mouse mammary gland epithelial cell over long time periods of up to 72 hours, epithelial cells [25] were seeded sparsely onto a 2D plastic culture dish. The dish was then placed into a mini-chamber mounted on an inverted phase contrast video-microscope. This provided incubator conditions and periodic image acquisition in 90 seconds intervals was performed [26]. About 900 to 1000 (video) frames were taken per measurement. For our purposes we only take the set 25 hours of the recording since after that cell density becomes high, and motion of individual cells restricted, see video (http://is2.kph.tuwien.ac.at/thumer/CELLMOVE). As seen in the videos, cells move within limited regions for many timesteps, crossing and following its own and other cell's trajectories.

From the video sequences the motion of individual cells was extracted sem i-autom atically by a commercial motion tracking routine [27]. Cell nuclei were tracked based on a convolution kernel of a 100 square pixel eld (about half the size of the cell nucleus at the given resolution). These extracted cell trajectories, see lines in Fig. 1b and c, were recorded as the x_t and y_t positions in two dimensions (the subscript indicating discrete time).

Due to the limited data length it is more useful to study velocity distributions rather than spatial distributions directly. We work in polar coordinates and transform the trajectories $(x_t; y_t)$ to a velocity (length-increment v_x (t) = $x_t - x_{t-1}$) process $v_t = \frac{q}{v_x} \frac{1}{(t)^2 + v_y} \frac{1}{(t)^2}$ and a direction process $t_t = \arctan(x_t - x_{t-1}; y_t - y_{t-1}) 2$ [;].

A s a control for the plausibility of our model we genetically modiled cells from the same cell line in two virus experiments [28, 29, 30]. The basic idea here is to alter the cell's motion program such that its interaction with other cells and hence its ability to follow other cell trajectories becomes electively reduced. In the case of non-interacting cells one should expect the model bose its validity, i.e. that cell movement would approach classical di usion, i.e. q ! 1. In the rst experiment, we infected cells with a virus carrying the coding sequence of enhanced green uprotein (GFP). Since viral infection has been reported to signil cantly in uence morphology and molecular hom eostasis of mammary epithelial cells [31, 32, 33, 34], we expected alterations on cellular migration patterns as well. This condition will be referred to as "infected" in the following. In a second experiment we inserted the coding sequence of gene TPA-Inducible Sequence 7 (TIS7) instead of GFP into

the cells. T IS7, a co-repressor of gene transcription and functionally associated with loss of epithelial characteristics like cell-to-cell adhesion was chosen to additionally test for eventual alterations in cell m obility [29]. This experimental condition will be called "T IS7" in the remainder of the paper and contains consequences of the viral infection itself and the e ects of over-expressed T IS7.

R E SU LT S

For a rst demonstration of correlated motion to be present, we compute C () for the individual x_t and y_t components of cell trajectories. We nd a Hurst exponent of about H 0:7 0:02 for all the experimental conditions (normal, infected, and TIS7), indicating correlated motion, see Tab. 1.

We nd the direction process t practically equally distributed over the interval [;]. By looking at normalized autocorrelations AC of t, signi cant (99% signi cance level) coe cients are found which decay as a power law. The situation is shown in Fig. 2a for all three experimental conditions. Power decay exponents were t by a least square routine in the region indicated by the straight lines; the corresponding values are collected in Tab. 1. Errors (standard mean errors over 5 independently moving cells) in the t-regions are som ewhat larger than symbol-size and were om itted for clarity of the plot. Normal cells show lower correlations, which decay slightly faster than those of the manipulated cells.

The normalized autocorrelations for the velocity process v_t are given in Fig. 2b. Correlation coe cients are statistically signi cant and in the same order of magnitude as the direction series'. Again, the tails of the correlations follow a power law; for the corresponding exponents, see Tab. 1. Here normal cells have higher correlations than infected ones. Infected and TIS7 cells show a slower decay than normals. Errors here are about twice symbol size.

In Fig. 3 we show the velocity distribution (histogram) of the norm al cells in a log-log plot. The solid line is a three parameter t to Eq. 4; t-parameters for q and $\frac{m}{2}$ for all conditions are listed in Tab. 1. At the low lim it of v the distribution approaches a constant, while the right tail clearly decays in a power law fashion v . We not infected and T IS7 cells to move faster on average, as seen in the mobility factor or directly in hv_ti, see Tab. 1.

We provide clear evidence that cell m igration of interacting cells is a correlated di usion process. This inding is supported by several facts found in our experimental data. Correlated motion is shown by the presence of a Hurst exponent signing cantly larger than 0.5 and by non-vanishing autocorrelation functions in the velocity and direction processes. This inding is in nice agreement with a recent and similar experiment [7], where an H of 0.62 0.05 was found. The direction autocorrelation functions are found to decay in a power like manner, with exponents consistently smaller than 1, opening the possibility for superdi usion. This obviously excludes naive autoregressive or moving average models (ARMA) to be realistic candidates for interacting cell m igration since these models have exponential decays of autocorrelation functions. This inding means that the direction of cells is a "long memory" process. For velocity autocorrelation functions the power decay is smaller but still present for the norm al cells. The value of the correlation coelling at the size as for the transmission.

The virus e ect is seen in the following way. The most obvious di erence of norm al and manipulated cells is seen in their mobility, which is drastically enhanced for manipulated cells. This is expected because we believe that there is less e ective adhesion proteins present in the infected and especially in the TIS7 cells. Very similar results have been reported in [7], however, with a di erent experimental strategy: There cells propagated in di erent aggregates of cell types with di erent adhesion properties to Hydra cells.

Infected and T IS7 cells show larger correlations in the direction process, meaning that directions are changed less frequently than norm al cells do. This is expected since these cells detect trails less well and lose their ability to follow other cells. Once moving they keep their direction more strictly than norm al cells. For the velocity process we observe the opposite e ect: norm al cells have larger autocorrelations, i.e. norm al cells change their velocities less frequently than infected and T IS7 ones. We attribute this e ect to a more controlled movem ent of norm al cells when follow ing a path, or equally, a stronger in uence of random e ects on infected or T IS7 cells with dam aged movem ent control.

We now turn to the main result of this paper. The velocity distribution follows the general form of the anom abus di usion model. Maybe most importantly this model allows to naturally understand the presence of the power tail to the right of the distribution. The

power can be related (via q) to the exponent in Eq. (1). For normal cells we nd q 1:35 which goes down to q 1:20 for the infected, and to q 1:11 for the T IS7 cells. In the T sallis therm odynam ics fram ework this m eans, that infected cells approach the classical therm odynamic regime, while norm al cells with their complex motion control system are governed by non-extensive statistics. In this fram ework it is clear that for non-interacting cells ordinary di usion and Gaussian or exponential velocity distributions were observed in [21, 22], being extrem e cases of the present model. If we accept that in our experiments infection diminishes the degree of interaction between cells and their trajectories, we see that the q value should serve as a sensible quanti er of the degree of interaction. A gain, in [7] very similar behavior of 2D moving patterns of Hydra cells were found. They reported 1:5, or a power decay in the velocity distributions of about q 4 and suggest a di erent way of explaining the movement patterns based on granular ow models. Furthermore, these and our ndings clearly exclude a Levy ight interpretation of cell m ovem ents, and led by the observation of trail-following tendencies of cells we believe that cell migration is governed by a realization of anom alous di usion.

In conclusion, we think that the presented m ethod provides a useful tool to qualitatively understand di erent m ovem ent patterns of realistic cell m igration, and to quantify the degree of interaction by the value of the T sallis q. Since epithelial cell m igration plays such an important role in situations like wound healing of skin epidem is or cancer m etastasis we speculate that the above way of quantication could even be a practical pathological characterization of cells, regarding diverse biological dignities and pham acological responses, in addition to m olecular and m echanical param eters. F inally, we note that the basic idea behind the presented m odel could also be applicable to other elds, like electrical ow through networks of biological neurons. There the electrice network topology is also subject to constant changes due to synaptic plasticity (H ebb or other type of learning). Electrical current will ow on excitable m edia restricted to a given network and by doing so, will re-shape it by changing synaptic weights. Here we would predict power law distributions of electrical current changes, in analogy to the v distributions presented here.

- [25] Generation of the cell line (c-JunER) has been described in [17]. Media, tissue culture reagents, and FCS (Fetal Calf Serum) were purchased from GIBCO BRL and Boehringer Mannheim. Cells were routinely cultured in High Glucose DMEM supplemented with 5% FCS, 10m M Hepes, pH 7.3, 50 IU/mlpenicillin and 50mg/ml streptomycin. As infection medium High

G hucose DMEM supplemented with 2% FCS and 10mM Hepes was used. The generation of the viral vector and the protocol of infection have been described in [28, 29] and have followed except that 9000 viral particles per cell have been used in order to achieve maximum infection e ciency.

FIG. 1: Norm almouse mammary gland epithelial cells migrating on a two-dimensional culture surface. Large magnication of a single cell (a). The leading edge can be recognized as a fanshaped lamellipodium (small arrows) at the bottom of the panel. The trailing edge is marked by a star. The direction of migration is indicated by the fat arrow. (b) Extracted trajectory of a single norm alcell over 1000 timesteps (25 h).

FIG. 2: A utocorrelation function of the direction process $_{t}$ of cell m igration for normal, infected, and T IS7 cells (a). Infected and T IS7 cells have somewhat higher values in the correlations and show a softer decay. (b) A utocorrelations for the velocity process v_{t} . For infected and T IS7 cells the coe cients are lower and the curves are nearly constant, while normal cells again show a power decay.

FIG. 3: Cell velocity distribution (histogram) for normal cells. For small v the distribution approaches a constant and decays for larger v in a clear power law. The line represents a t to the T sallis velocity distribution. The virus experiments are not shown for clarity; their t parameters are gathered, how ever, in Tab. 1.


