# Quantum HallSkyrm ions in the fram ework of O (4) Non-linear Sigm a M odel

A new fram ework for quantum Hall skyrm ions in O (4) nonlinear sigm a model is studied here. The size and energy of the skyrm ions are determ ined incorporating the quartic stability term in the Lagrangian. Moreover, the introduction of a -term determ ines the spin and statistics of these skyrm ions.

#### I. IN TRODUCTION

Skyrm ions are generally described by nonlinear sigm a model. A smooth texturing of the spins can be described by an electric nonlinear sigm a model where the spin is described as a unit vector n(r). This spin vector n lies on a sphere  $S^2$  where we may consider a magnetic monopole located at the centre. Skyrm ions are characterized by the topological charge Z = drq(r) where  $q = n:(\mathfrak{g}_x n - \mathfrak{g}_n)=4$  is the Pontryagin density. Z is the winding number of the mapping n(r) from the compactified space  $S^2$  to the target space of the sigm a model ( $S^2$ ) and is given by the homotopy  $_2(S^2) = Z$ . The topological density is proportional to the deviation of the electron density from its uniform value  $_0$ .

In analogy to the G inzburg-Landau description of superconductivity, the Chem-Sim ons theory of quantum H all system s was derived by Zhang, H ansson and K ivelson [1] which was subsequently extended by Lee and K ane [2] to describe the spin unpolarized quantum H all liquid. In a quantum H all uid, the ground state has been found to be a fully spin polarized quantum ferrom agnet. By noticing that the dynam ics of quantum H all system with a spin polarized ground state will follow that of a quantum ferrom agnet and that the skyrm ion is a charged object of the system, Sondhi et al. [3, 4] proposed a phenom enological action which is valid for the long wave length and sm all frequency limit. In this scheme, the com petition between the Zeem an and C oulom b term s sets the size and energy of the skyrm ions and m odi es the detailed form of their pro les. In case the Zeem an energy and C oulom b energy are taken to be vanishing, analytic expressions are available for the skyrm ions and their energy is independent of their size. This scale invariance is broken by the Zeem an and C oulom b term s in the Lagrangian.

To study low energy excitations for partially polarized states a nonlinear -m odel has been developed [5] considering a two component quantum H all system within a Landau-G inzberg theory with two C hem-Sim ons gauge elds. It has been found that these excitations have nite energy due to the presence of the C hem-Sim ons gauge eld and closely resemble the skyrm ions in the usual nonlinear -m odel. Skyrm ions in arbitrary polarized quantum H all states are studied [6] em ploying a doublet m odel taking into account two elds carrying the spin index in C hem-Sim ons term with a matrix valued coupling strength.

Skyrm ion excitations in quantum Hall systems at = 1, using nite size calculations [7], is studied in spherical geom etry where electrons reside on the surface of a sphere with a monopole at the centre. For a monopole of total magnetic ux N = 2 the lowest Landau level degeneracy is 2 + 1. All single particle states in lowest Landau level have xed angular momentum value . At lling factor = 1 corresponding to the electron number N = 2 + 1 the ground state is spin polarized independent of the strength of the Zeem an splitting. When an additional ux is added or removed from the system, the ground state is a skyrm ion (antiskyrm ion) with topological charge Q = +1(1). The energy gap is determined by the interplay of the Zeem an energy and electron-electron interaction.

In this note, we shall study the static properties of skyrm ions in spherical geometry considering a

O (4) nonlinear -m odel in 3 + 1 dimensional manifold. In some earlier papers [8, 9] we have analyzed the hierarchy of quantum Hall states in spherical geometry from the view point of chiral anomaly and Berry phase. In this fram ework it is shown that the M agnus force acting on vortices and skyrm ions in the quantum Hall system is generated by the background eld associated with the chirality of the system [10]. The various polarization states of quantum Hall uid is also studied and their low energy excitations are exam ined using a hom otopic analysis [11]. The O (4) nonlinear -m odel helps us to have two independent subalgebras each isom orphic to a SU (2) algebra so that the left and right group can be taken to be associated with two mutually opposite orientations of the magnetization vector which resides on the 2D surface of the sphere. The hom otopic analysis then suggests that for fully polarized states the low energy excitations are skyrm ions. It is here shown that the addition of the quartic stability term introduced by Skyrm e, known as the Skyrm e term in the literature, will determ ine the size of the quantum Hall skyrm ions in this fram ework. This also helps us to determ ine the spin and statistics of the skyrm ion through the introduction of the topological -term in the Lagrangian.

In sec2 we recapitulate the study of skyrm ion excitations in quantum Hall uid when the system is described by means of the Zhang-Hansson-Kivelson model and modi ed by Lee and Kane to take into account the e ect of spin. In sec3 we shall describe quantum Hall skyrm ions in spherical geometry considering a O (4) nonlinear -m odel taking into account the Skyrm eterm and -term. In sec4 we shall determ ine the size and energy of the skyrm ion in this form alism.

## II. QUANTUM HALL SKYRM IONS IN PLANAR GEOMETRY

We here recapitulate the works on quantum Hall skyrm ions on the basis of the bosonic theory of an electron which is viewed as a composite object of a boson and a ux tube carrying an odd multiple of ux quanta  $_0 = h=e$  attached via a Chem-Sim ons term. We begin with the Landau-G inzburg theory of the Halle ect introduced by Zhang, Hansson and Kivelson [1] and modi ed by Lee and Kane [2] to incorporate the elect of the spin. We consider the Lagrangian [12]

Here =  $(_1;_2)$  is a two component complex scalar eld. is the statistics parameter which takes the values = (2n + 1) so that the boson eld represents a fermion, A the external electrom agnetic eld and m is the electron ass of the electron. To determ ine the size and energy of the skyrmions Zeem an and C oulom b interactions should be included. However, to study the topological features we can ignore them for the moment. We consider a solution with uniform density =  $(j_1 \hat{j} + j_2 \hat{j}) = _0$  at lling fraction =  $\frac{1}{2n+1}$ . In order to separate the amplitude and spin degrees of freedom we introduce the CP<sup>1</sup> eld z and we write

The Lagrangian (1) now takes the form

Here z is a two component complex eld with the constraint  $z^y z = \dot{z}_1 \dot{f} + \dot{z}_2 \dot{f} = 1$ .

and  $r n = (@_1n; @_2n)$ . The term  $\frac{1}{8m}$   $(r n)^2$  corresponds to the static nonlinear sigm a model. Now introducing Hubbard-Stratanovich transform ation J with the relation  $J_0 = -\infty$  that the current 3-vector  $(J^0; J^1; J^2)$  is promoted to the status of an independent dynamical variable, the Lagrangian can be written as

Integrating over the U (1) phase degree of freedom in z we arrive at the current conservation law  $\emptyset$  J = 0 and we have current 3-vector ( =  $J^0; J^1; J^2$ ) as the curl of a three dimensional vector eld. One can set  $J_{[0]} = (_0;0;0)$  equal to  $( A^{[0]} and$

Integrating out the Chem-Sim ons eld a and using the relation 2  $_0 = eB_z$ , we can nally arrive at the relation

absence of magnetic eld becom es unity, we can write

It is noted that the skyrm ion num ber current acts as a source for a topologically massive gauge eld A [12] and also sees the background eld A  $^{[0]}$ .

Incorporating Zeem an and C oulom b term s Sondhiet.al.  $\beta$  considered the following m odi ed form of the Lagrangian (1).

Here  $V = e^2 = r$  is the interparticle C oulom b potential and <sub>B</sub> is the B ohrm agneton.

Noting that = p - z where z yz = 1 and using the mapping  $n^a = z^y a z$ , we can replace the CP<sup>1</sup> eld by an O (3) sigm a model eld. Indeed, by observing that at the ground state the dynamics of the system is that of a ferrom agnet with a long range interaction arising from the Coulomb interaction between the underlying electrons, we take into account the necessary terms and consider the Lagrangian [12]

Here A is the vector potential of a unit magnetic monopole, <sup>s</sup> is the spin stiness ( $^{s} = e^{2}=16^{\frac{p}{2}}$  1 for = 1), is the dielectric constant and 1 is the magnetic length.  $q(r) = n:(Q_{r} \cap Q_{r})=4$  is the topological density. This topological density is proportional to the deviation of the electron density from its uniform value; q = (0). The topological charge is Z = drq(r). For r = 1, skyrm ions with topological charge Z carry electric charge Z jej.

The Zeem an and C oulom b term s break the scale invariance. Their prodes now depend on the dimensionless ratio  $g = (g_B B) = (e^2 = \hat{1})$  of the Zeem an energy to C oulom b energy. For Z = 1 skyrm ions the scale invariant solution yields a Zeem an energy that diverges logarithm ically with system size for any

. This can be xed by matching the scale invariant solution onto the exact asymptotic solution in the outer region. This suggest for Z = 1 the size [13]

Indeed at large g the quasiparticles are single particle-like and m ay carry charge and spin  $S_z = 1=2$ and have size l. At small g, they still carry charge e but diverge in size and have nontrivial spin with a divergent z-component of spin  $S_z$  (the number of reversed spin) as well as divergent total spin.

## III. QUANTUM HALL SKYRM IONS IN 3+1DIM ENSIONAL MANIFOLD

W e want to study the low energy topological excitations of the quantum H all uid within the fram ework of 0 (4) nonlinear -m odel in 3 + 1 dim ensional manifold. In this geometry, electrons are placed on the surface of a sphere under the in uence of an uniform radial magnetic eld. The magnetic eld is produced by a magnetic monopole of strength placed at the centre of the sphere. As we know, the angular momentum in the eld of a magnetic monopole is given by

where can take the values 0; 1=2; 1; 3=2; ..... Evidently, eigenvalues of J can take the values j j j + 1, j j + 2,...... In this geometry the quantum H all states can be depicted by a two-component spinor

is the spin polarized ground state at = 1.

The generalized state for = 1 = m, m being an odd integer, is written as  $[\beta, 15]$

However it should be added that at = 1 we have a non-interacting spectrum which is never a correspondence for = 1=m, with m being an odd integer. Indeed FQH states correspond to interacting system s.

The skym ion state can be written as

where the spin texture is included within the components  $v_k$  and  $u_k$  and 0 1.

A ctually, if a sm ooth and m onotonical function g() is defined with g(0) = 0 and g() = 0 then the skyrm ion state can be written as [7]

where  $e_r^{\circ}$  and  $e^{\circ}$  are the basis vectors. The size of a skyrm ion is determined by the function g() and g() = describes the hedgehog skyrm ion with spin in the radial direction  $\hat{r}$ .

This is the skyrm ion state with the constraint  $j^{(j)} = 1$ .

The quantum state for the classical skyrm ion  $\hat{}$  () can be written as

where C is the normalization constant, P is the projection operator to the lowest Landau level and g() controls the size of the skyrm ion [7]. From eqns. (19) and (21) it is seen that 0 1 is determined from g() and it controls the size of the skyrm ion.

The size of the skyrm ion can be de ned by the position where spin direction is perpendicular to the radial (and spin) direction at either pole. W ith this convention, the skyrm ion size is

Bychkov et. al. have shown [16] that the quantum Hall skym ions consist of a core whose size is de ned by the interplay between the Zeem an and Coulomb energies and an additional length scale  $l_{sk}$  which determ ines the tail of the spin distribution. This characteristic length is given by

where g is the electric g factor,  $a_B = 2^2 = m e^2$  is the Bohr radius, being the dielectric constant and l is the magnetic length. It is noted that as g ! 0,  $l_{sk} ! 1$ , we can take

where x and  $x_0$  are two dimensionless parameters given by  $x = r=l_{sk}$  and  $R = x_0 l_{sk}$ , R being the size of the skyrm ion core region.

stability tem, known as the Skym e tem. Indeed, taking the spin variable  $z = Uz_0$  where  $z_0 = \begin{bmatrix} 1 \\ 0 \end{bmatrix}$ and U 2 SU (2), we may write the nonlinear sigm a model Lagrangian in terms of the SU (2) matrices U as [17]

where M is a constant of dimension of mass and is a dimensionless coupling parameter. The dependence may be incorporated through M and where these parameters are taken as functions of  $\cdot$ .

To have a geom etrical interpretation of the Skyrm e term (eqn.(25)), we note that it e ectively corresponds to the vorticity of the system which prevents it from shrinking it to zero size. In fact in an axisym m etric system where the anisotropy is introduced along a particular direction through the introduction of a magnetic monopole at the centre, the components of the linear momentum satisfy a commutation relation of the form

W hen the position space is a 3-sphere S $^3$  with a monopole at the centre, we can have a commutation relation of the form

where R is proportional to the radius of the S<sup>3</sup>. For a distorted sphere we can consider R as a functional form R (; ) corresponding to the core radius of the skyrm ion. We can de ne the core size of the skyrm ion such that  $R = R_0 (1)$  where  $R_0$  is the size of the skyrm ion having m inim alenergy.

In view of this, in 3 + 1 dimensions we can generalize the Lagrangian (11) incorporating the Skym e term in the form

and A  $[A^{[0]}]$  is a four vector. It is to be mentioned that we have taken the kinem atic term (second term in equation (28)) which takes into account spin waves, the G oldstone modes associated with a ferrom agnetic ground state. The SU (2) matrix U is here de ned as

where the chiral elds  $n_0, n_1, n_2$  and  $n_3$  satisfy the relation  $n_i^2 = 1$ .

It may be noted that in 2+1 dimension, we have the normalized 3-vector eld n with  $n_i^2 = 1$  where  $n_i$  corresponds to the local spin direction. In the O (4) model  $n_i$  (i = 1;2;3) corresponds to this spin direction

which live on the 2-dimensional surface of the sphere where the extra eld  $n_0$  helps us to consider three "boost" generators in  $(n_0; n_i)$  planes. In view of this, we can consider two types of generators such that the generator M <sub>k</sub> rotates the 3-vector n (x) to any chosen axis and the boost generators N <sub>k</sub> would m ix  $n_0$  with the components of n. We can now construct the following algebra

Thus the algebra has split into two independent subalgebras each isom orphic to a SU (2) algebra and corresponds to the chiral group SU (2)<sub>L</sub> SU (2)<sub>k</sub>. The left and right chiral group can now be taken to be associated with two mutually opposite orientations of the magnetization vector which resides on the 2D surface of the sphere.

It may be mentioned that the P and T violating -term ( $\frac{16^{-2}}{16^{-2}}$  F F) in 3 + 1 dimensions corresponds to the Chern-Sim ons term in 2 + 1 dimension. This term is related to chiral anomaly and we have the Pontryagin index given by [18]

Evidently this relates to the H opf invariant which can be explicitly written in term s of SU (2) m atrix U (x) which rotates the vector n to the chosen (third) axis  $n \approx = U^{1}_{3}U$  and the H opf invariant is given by

which is given by the hom otopy  $_{3}(S^{3}) = Z$  and the electric charge is given by  $eZ \cdot W = observe here that the Pontryagin index given by <math>q = 2$  in eqn.(35) introduces the Berry phase for quantum Hall states as represents magnetic monopole strength. Indeed, the ux through the sphere is 2 and the phase is given by  $e^{i_{B}}$  where  $_{B} = 2$  (number of ux quanta enclosed by the loop). When a Z = 1 skyrm ion is moved around a closed loop it acquires a Berry phase 2. N where N is the number of skyrm ions enclosed by the loop. To nd the spin and statistics, we consider a process which exchanges two skyrm ions in the rest frame of one of the skyrm ions. This exchange electively corresponds to the other skyrm ion moving around the rst in a half circle and hence it picks up a phase which is the statistical phase of a skyrm ion. For = 1 it is a ferm ion and = 1=m, m being an odd integer it corresponds to an anyon in planar geom etry. In general, the spin of the skyrm ion having charge eZ is given by Z=2.

#### IV. SKYRM ION SIZE AND ENERGY

From our above discussions, we now observe that the energy of a free skyrm ion depends on the following two terms in the Lagrangian (28)

The static nonlinear sigm a model Lagrangian corresponding to eqn. (42) gives rise to the energy integral as

where (i; j = 1; 2; 3)

To com pute the energy, we take the Skyrm e ansatz [17]

where <sup>!</sup> are Pauli matrices,  $\mathbf{\hat{x}} = \frac{\mathbf{x}_1}{\mathbf{r}}$  and F (0) = and F (r) ! 0 as r ! 1; r is the spherical radius in 3-dimensional manifold. We explicitly write U = cosF (r) + i<sup>!</sup>  $\mathbf{\hat{x}} \sin F$  (r) with cosF (r) =  $\frac{1}{1+(r=R)^2}$ , sin F (r) =  $\frac{2(r=R)}{1+(r=R)^2}$ . The energy integral becomes

It is to be noted that the coupling parameters M and are functions of such that in the lim it ! 0, M () ! 0 and () ! 0 but M = is xed.

We may compare  $E_{m in}$  with the scale invariant energy

which is obtained from eqn. (15) with g = 0; V = 0, in the Lagrangian (13). In this case energy is given by the pure nonlinear sign a model: the size of the skyrm ion is in nite and the energy is independent of the size. So we may write

Away from g = 0, skyrm ions acquire a size. Now matching this value for g = 1 so that the form of the solution in the core region is determined by the scale invariant term alone, we take  $R = R_0 (1)$  and we have

W e can compare this with the standard result for energy with Z = 1, [13]

where  $g = (g_B B) = (e^2 = 1)$  so that we can equate




FIG.1: The dependence of skyrm ion energy on size with respect to the variation of the parameter (eqn.(52))




FIG.2: The relationship of  $(gjlngj)^{1=3}$  with as given by the eqn.(55)

We must mention here that though the value of is constrained in the region 0 1 and = 1 corresponds to the hedgehog skym ion with spin in the radial direction but eqn. (52) suggests that = 1 is a singularity point. Indeed, the relation  $R = R_0 (1)$  gives a nonzero size for = 1 when  $R_0$  is in nite. So in this case matching the minimum energy for g = 0, V = 0 and away from g = 0 with g 1 will not be meaningful. Indeed the solution  $\cot = 2 = x = x_0$  is valid except for a very narrow region around  $x = x_0$  [16]. This im plies that a sm all region around = 1 will not give meaningful result for size and energy of the skyrm ion. For comparison we have computed the energies of skyrm ions in terms of

and it is found that up to = 0.7 we have reasonable values of g beyond which g becomes large enough to be compatible with quantum Hall skyrm ions [Fig. 1].

This suggests that in spherical geom etry within the fram ework of 0 (4) nonlinear sigm a model in 3+1 dimensional manifold we can determ ine the size of the skyrm ion incorporating the Skyrm e term in the Lagrangian. The ratio of the Zeem an energy and C oulom b energy can be encoded in it [Fig. 2].

It m ay be added here that very recently W o's and Quinn [19] presented the num erical results for the spin excitation spectra of integral and fractional H all system s in spherical geom etry.

## V. DISCUSSION

M any authors have considered quantum H all skyrm ions in spherical geometry and studied di erent aspects of the system in terms of 0 (3) nonlinear sigma model with success. In all these approaches, the electrons and hence the 3 (constrained) order parameter elds reside on the 2-dimensional surface of the 2 + 1-dim ensional 0 (3) m odel. To study the static properties of the skyrm ions we have used here the 3 + 1-dim ensional O (4) nonlinear sigm a model which actually builds on a di erent manifold and possesses di erent num ber of order param eter elds. The extra order param eter eld helps us to consider two independent SU (2) algebras depicting two mutually opposite orientations of the magnetization vector which lives on the 2-dimensional surface. In this framework with the hom otopic analysis we have shown the existence/non-existence of skym ions in fully polarized, unpolarized and partially polarized quantum Hall states [11]. The Skyme term which gives rise to the stability of the soliton determines the size of quantum Hall skyrm ions. Indeed, the distortion of the spherical shape can be incorporated through the angular dependence which can be conveniently introduced through a parameter with 0 1. Excepting a small region around = 1, we can compare the result with the conventional 2D form alism when the size is determined by the Zeem an energy and Coulomb energy for small g. This helps us to encode the e ect of the Zeem an energy and Coulom b energy in the parameter and the size can be determined from the relation  $R = R_0$  (1 ) where  $R_0$  corresponds to the size which is characteristic of the minimum energy E ( $R_0$ ). In 2D formalism this minimum energy corresponds to g 1 which may be m atched with the scale invariant value when the energy is contributed by the spin sti ness term for g = 0; V = 0.

We have also shown that the spin and statistics of the skyrm ion is given by the -term. The skyrm ion charge is given by eZ where Z is the winding number associated with the hom otopy  $_3$  (S<sup>3</sup>) = Z and the spin is given by Z=2. For Z = 1, the skyrm ion, when moving around a closed loop picks up a phase 2 N where N is the number of skyrm ions enclosed by the loop. In a process which exchanges two skyrm ions in the rest fram e of one of the skyrm ions, the exchange corresponds to the other skyrm ion moving about the rst in a half circle and hence it picks up a phase which is the statistical phase.
